[57] **CLAIM**

The ornamental design for a side portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a side portion of a shoe upper showing a first preferred embodiment of my new design;

FIG. 2 is a front elevational view of the side portion of a shoe upper shown in FIG. 1;

FIG. 3 is a rear elevational view of the side portion of a shoe upper shown in FIG. 1;

FIG. 4 is a top plan view of the side portion of a shoe upper shown in FIG. 1;

FIG. 5 is a side elevational view of a side portion of a shoe upper showing a second preferred embodiment of my new design;

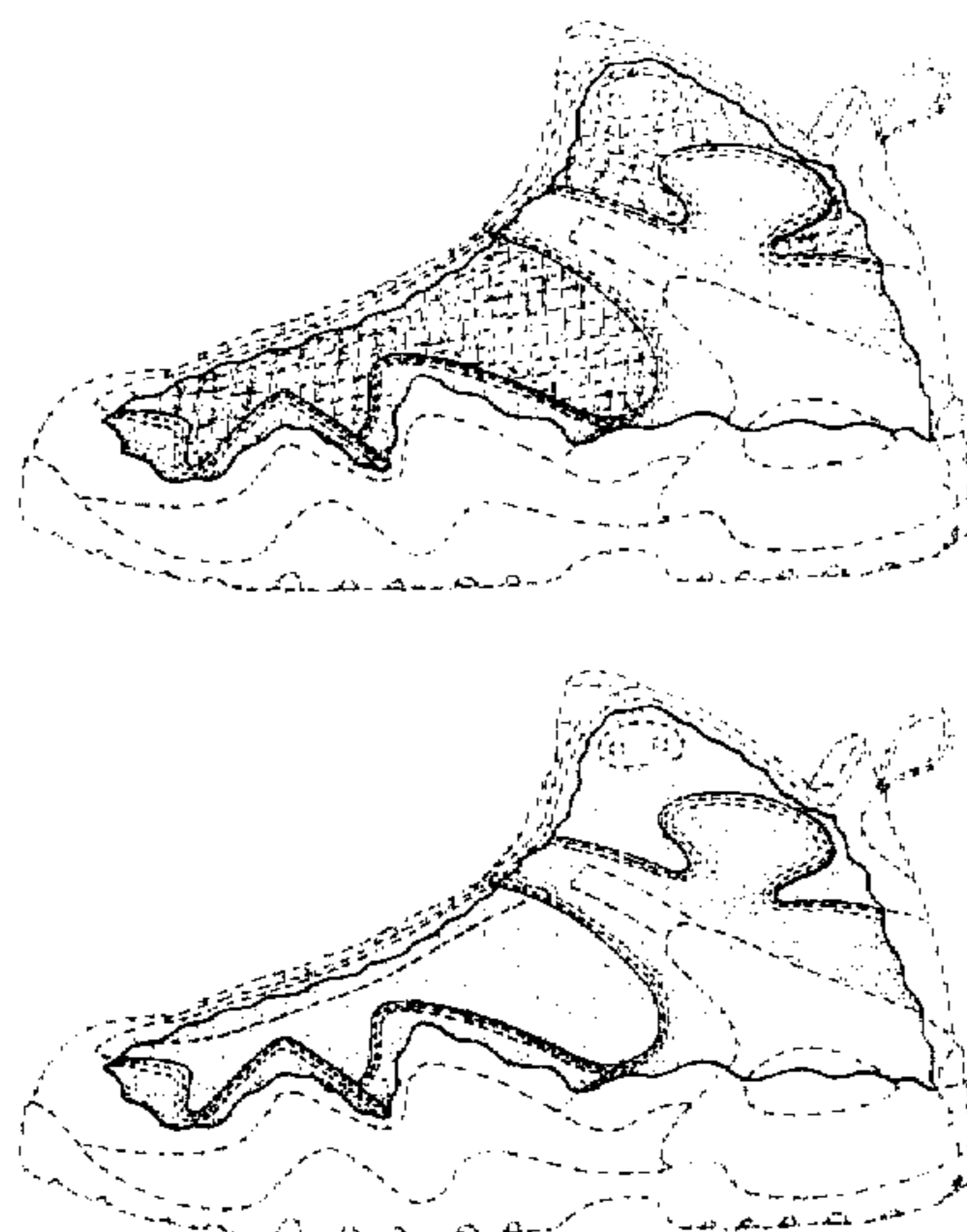
FIG. 6 is a front elevational view of the side portion of a shoe upper shown in FIG. 5;

FIG. 7 is a rear elevational view of the side portion of a shoe upper shown in FIG. 5; and,

FIG. 8 is a top plan view of the side portion of a shoe upper shown in FIG. 5.

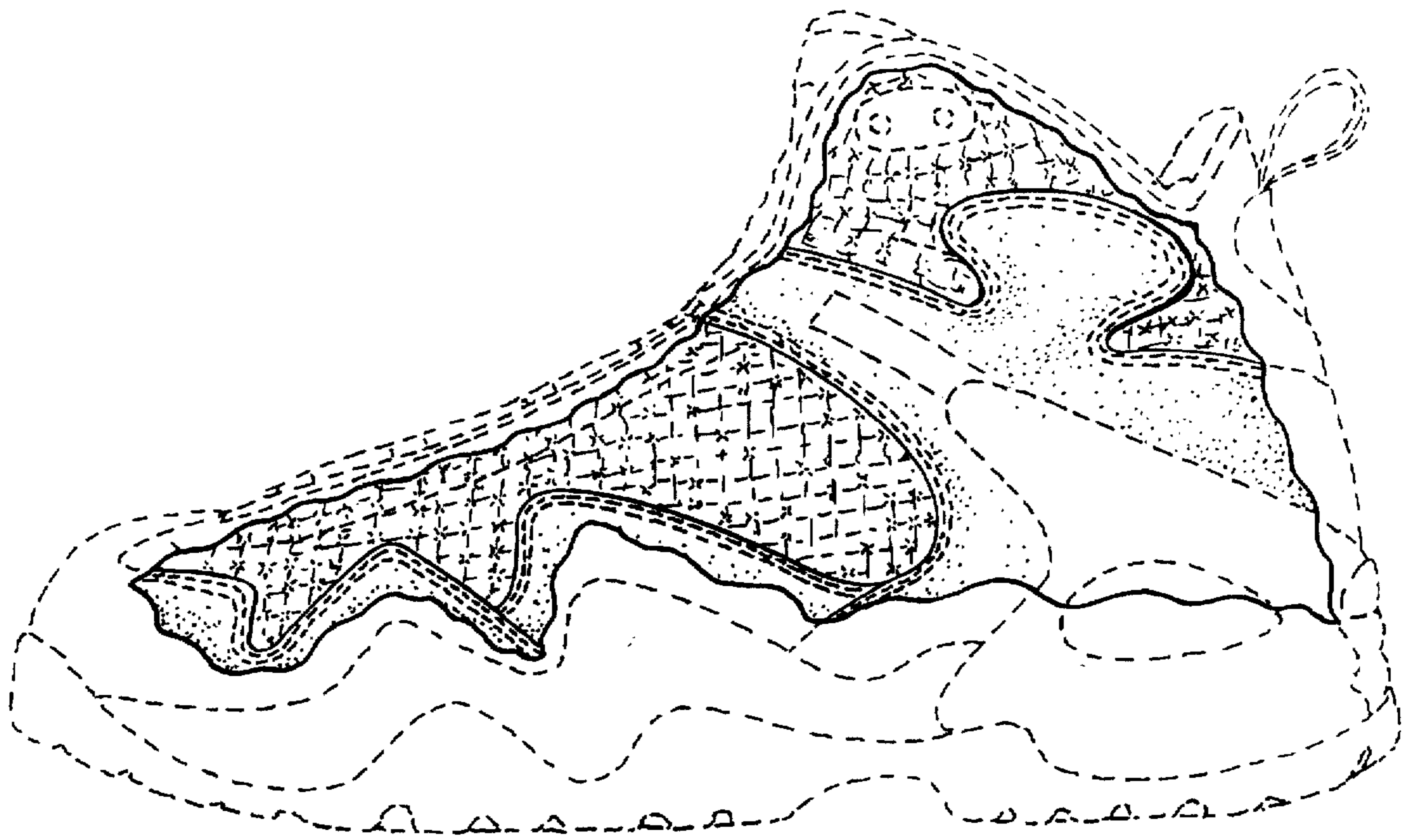

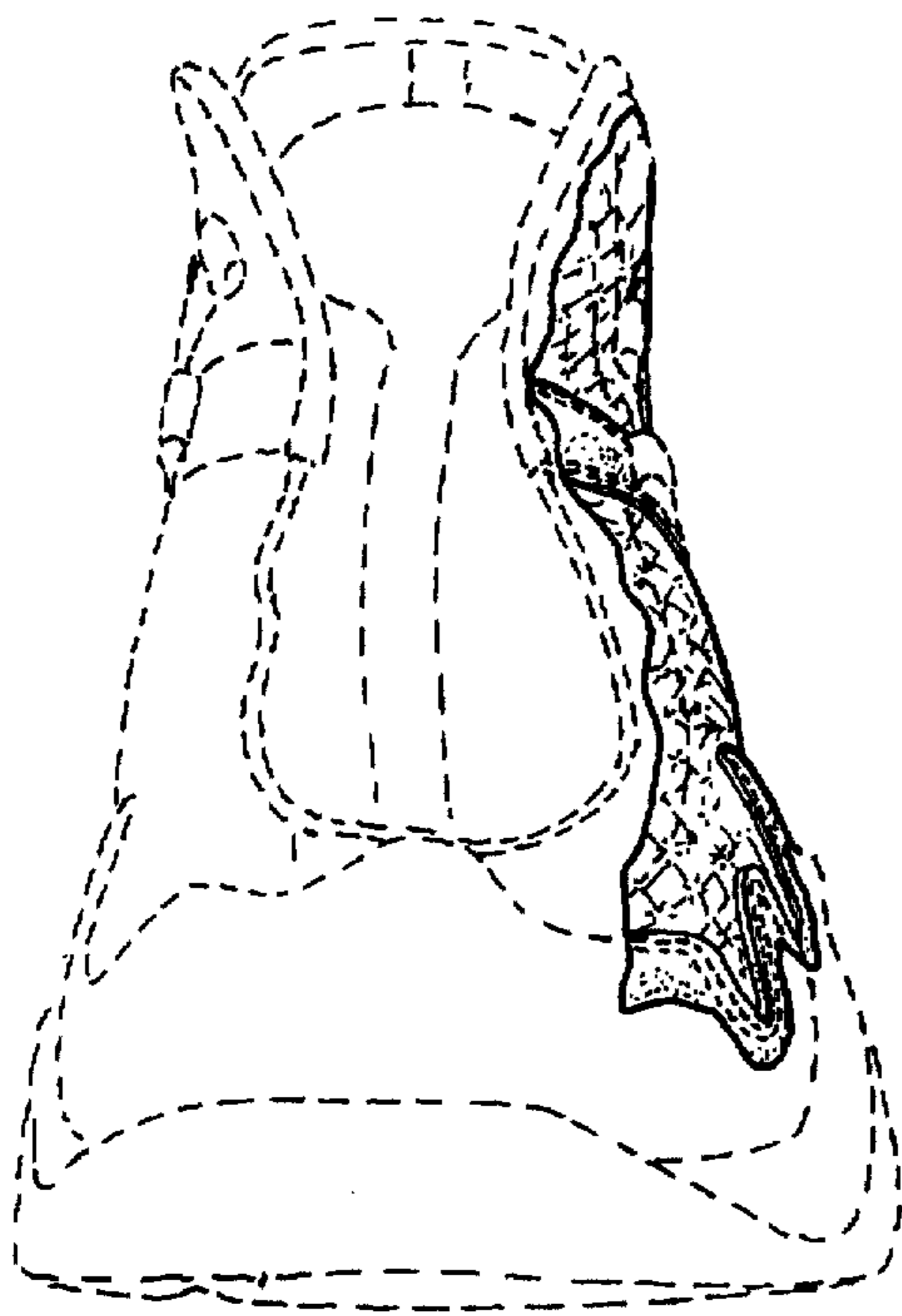

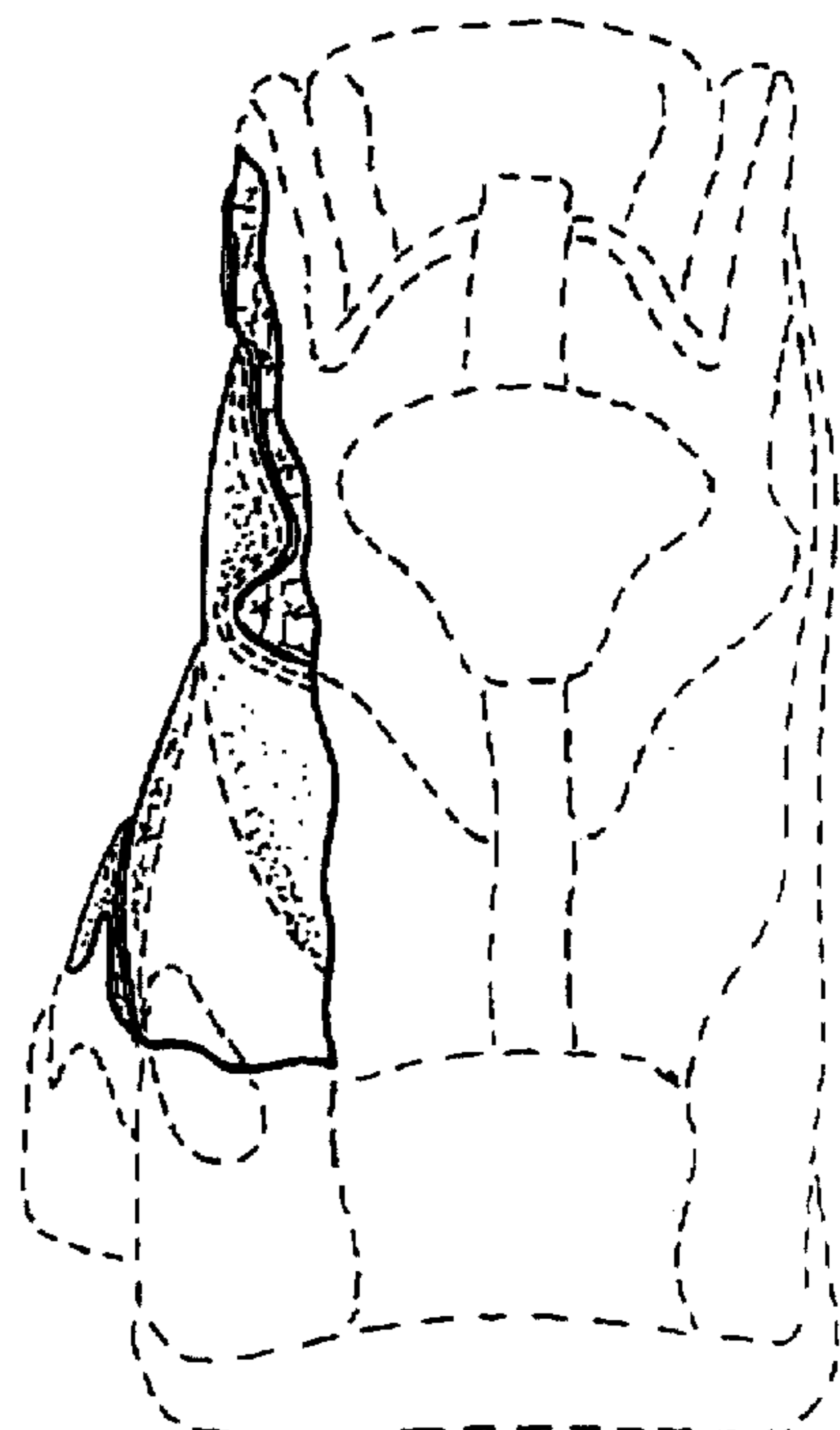

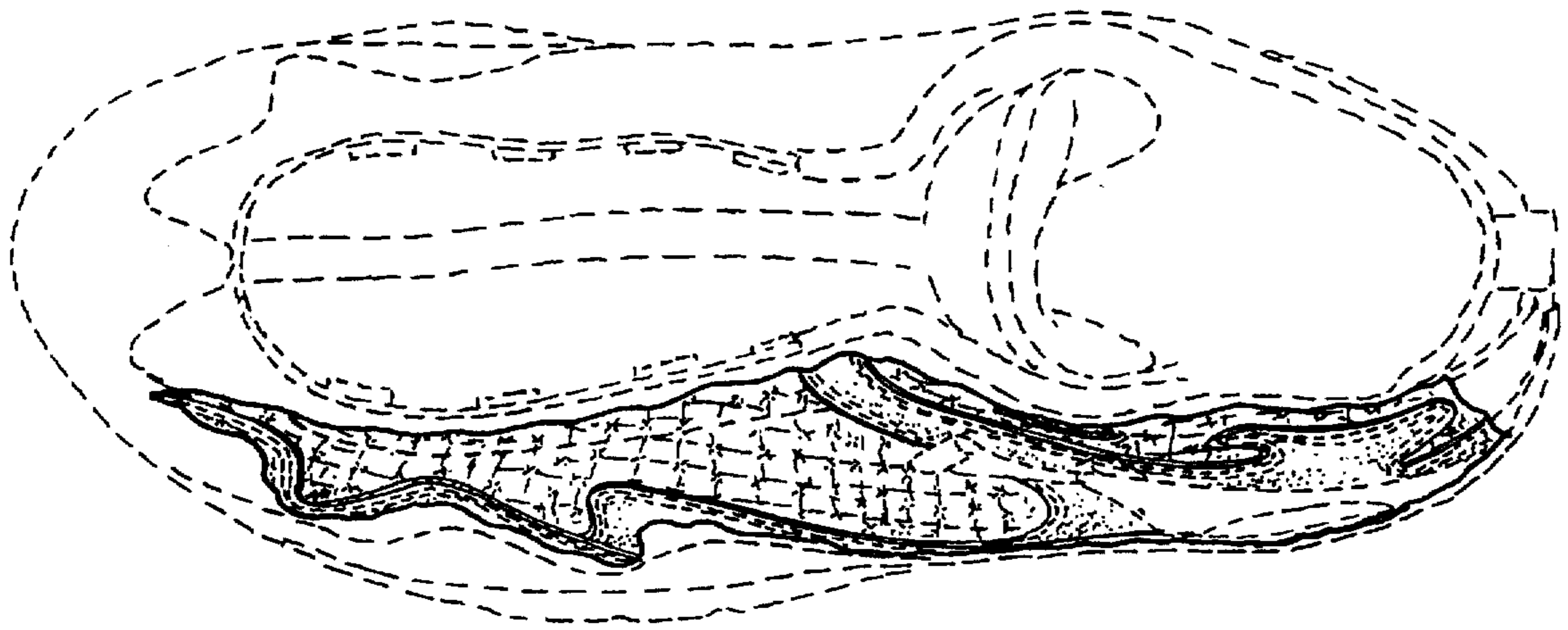

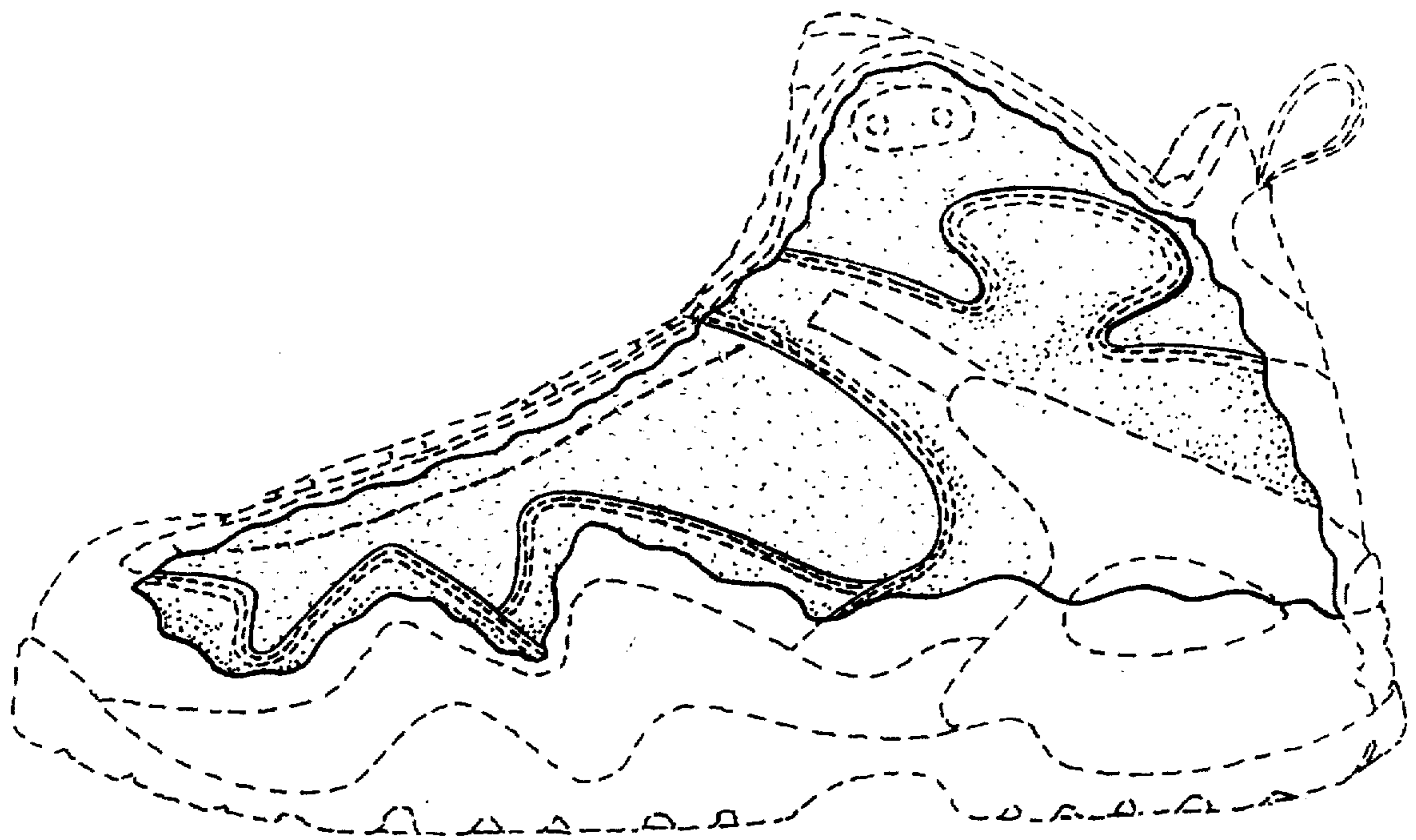

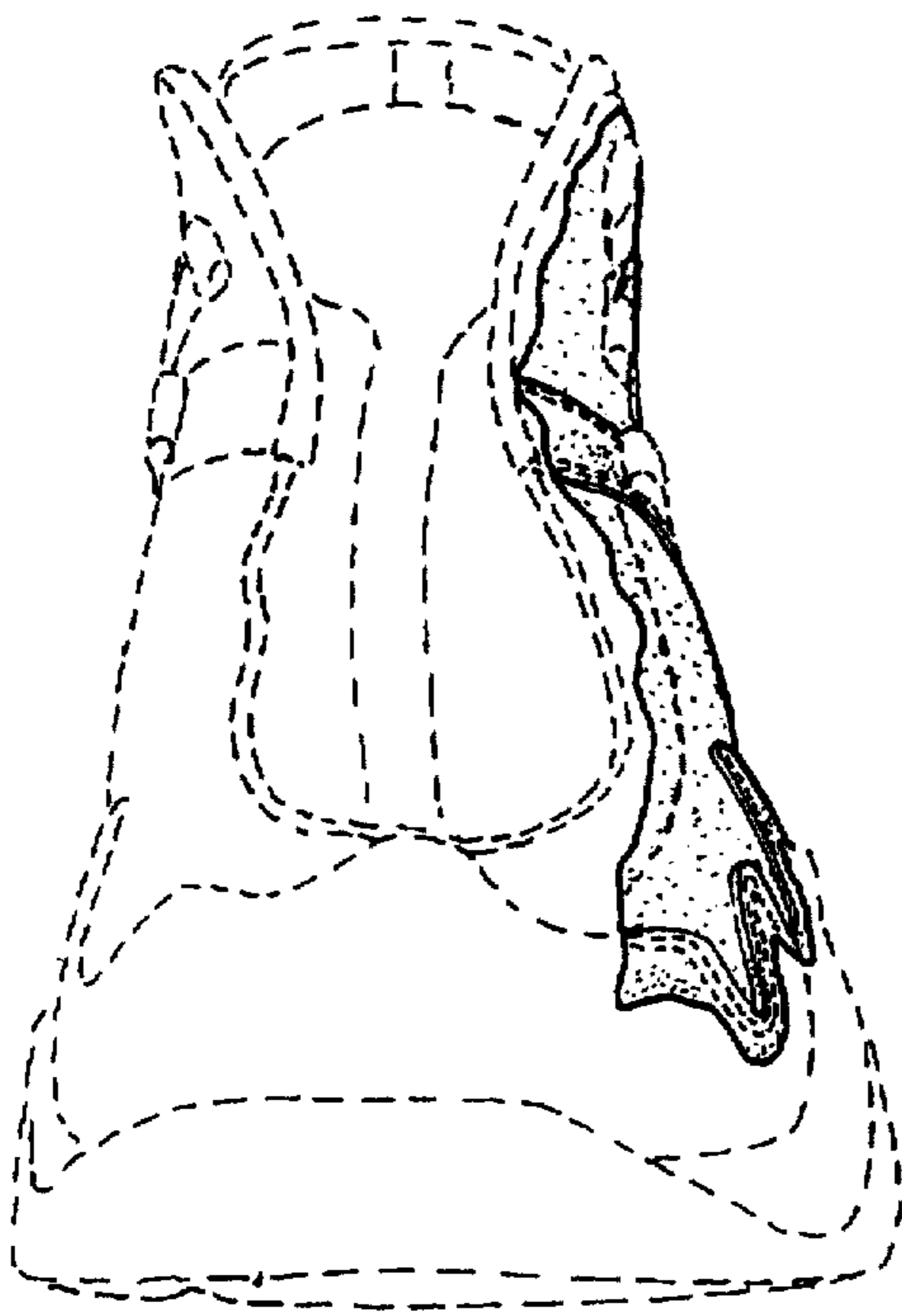

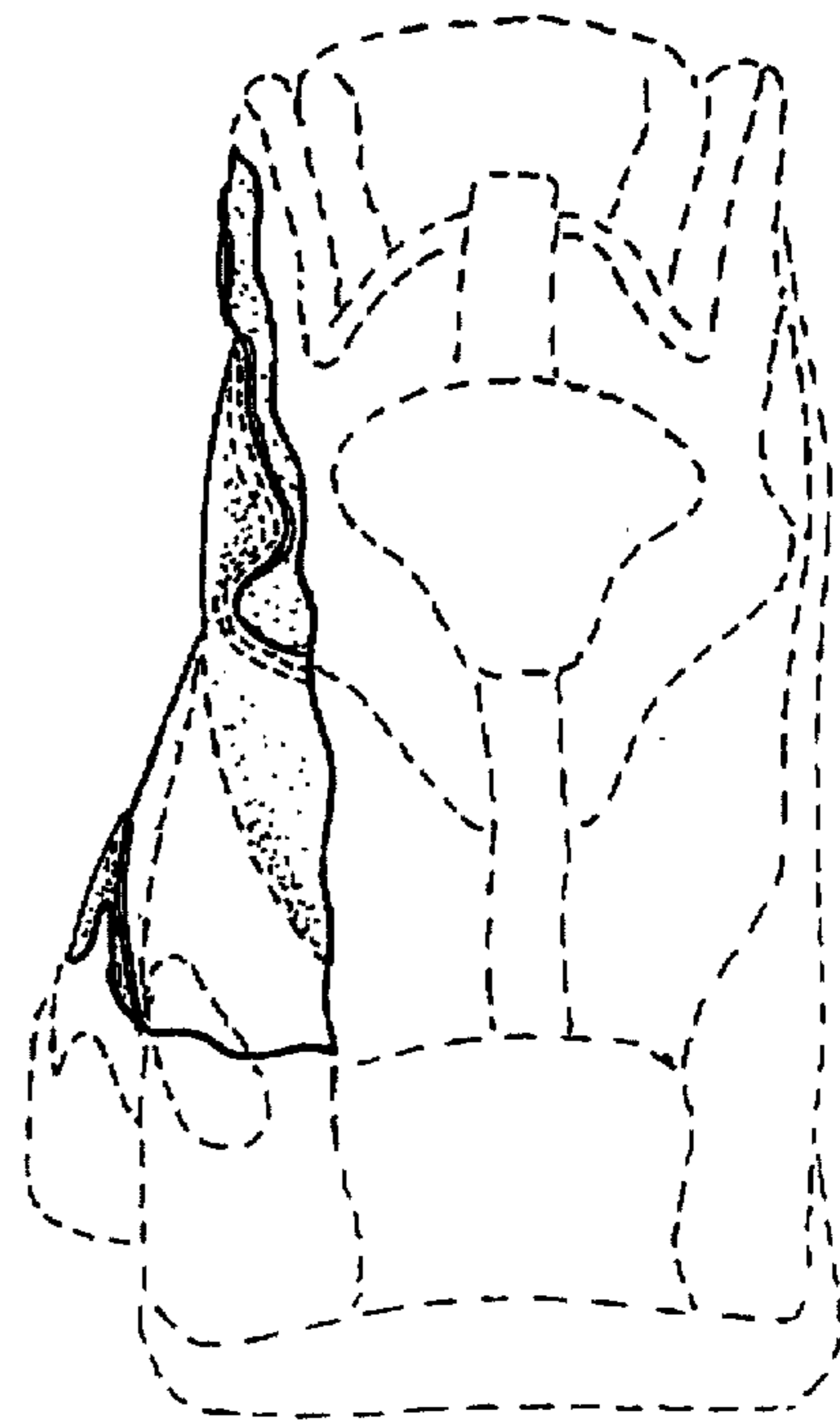

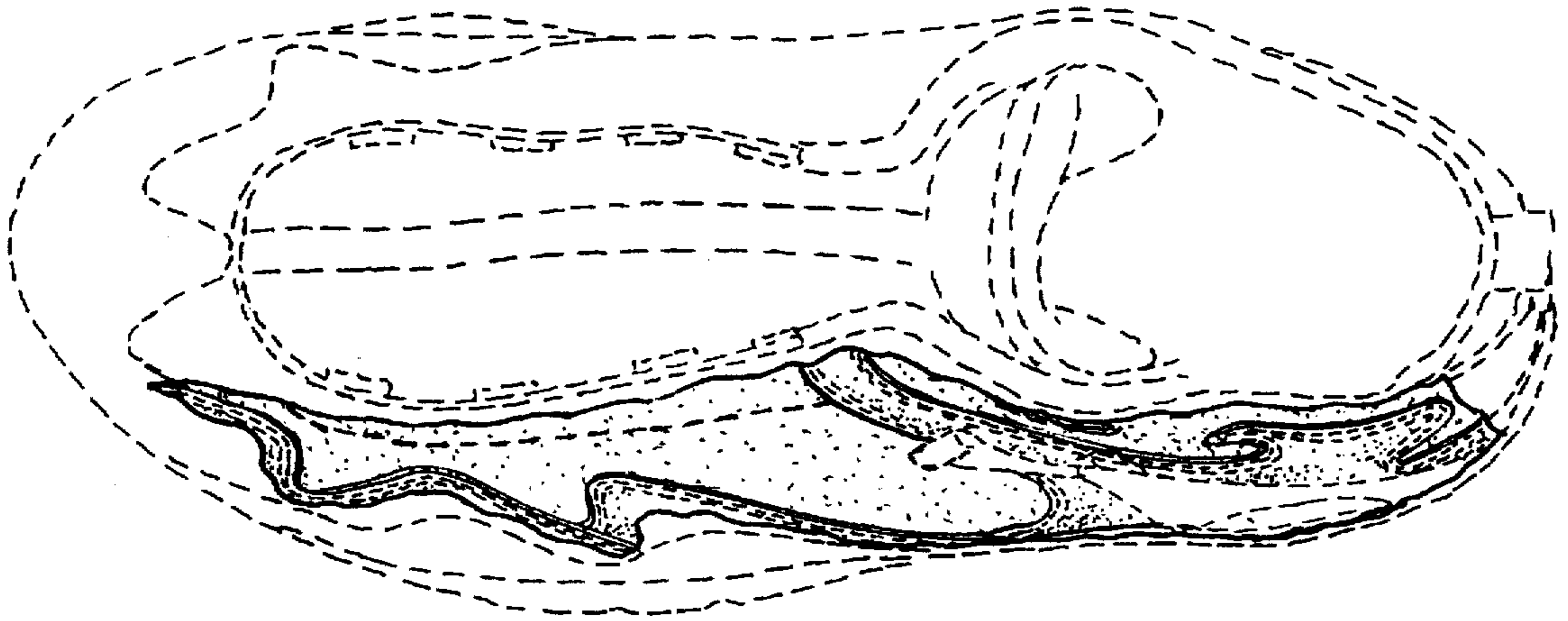
