DESCRIPTION

FIG. 1 is a top right front perspective view of a container with lid showing my new design;

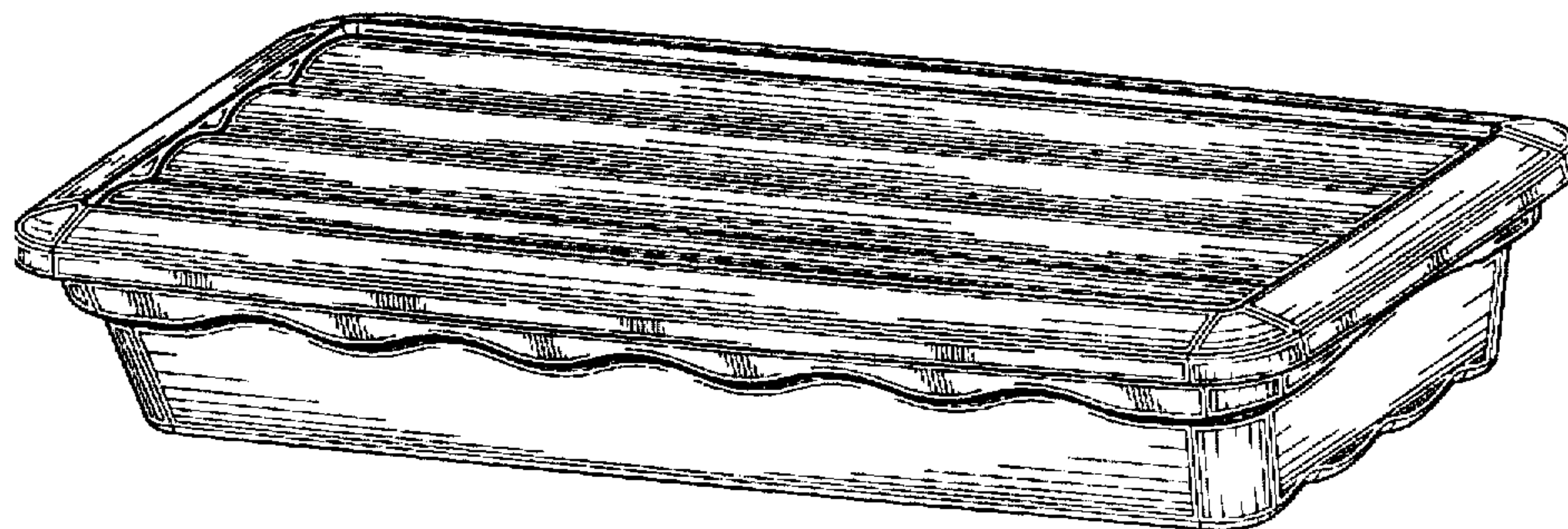
FIG. 2 is a right side elevational view thereof; the left side elevational view being a mirror image;

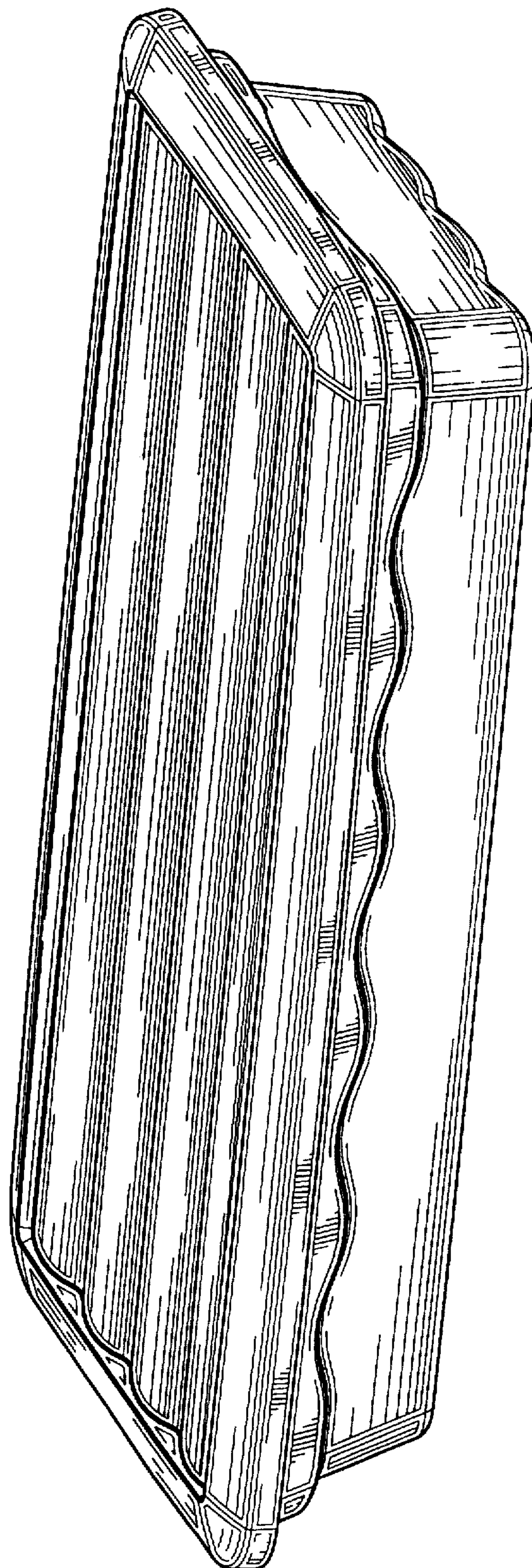

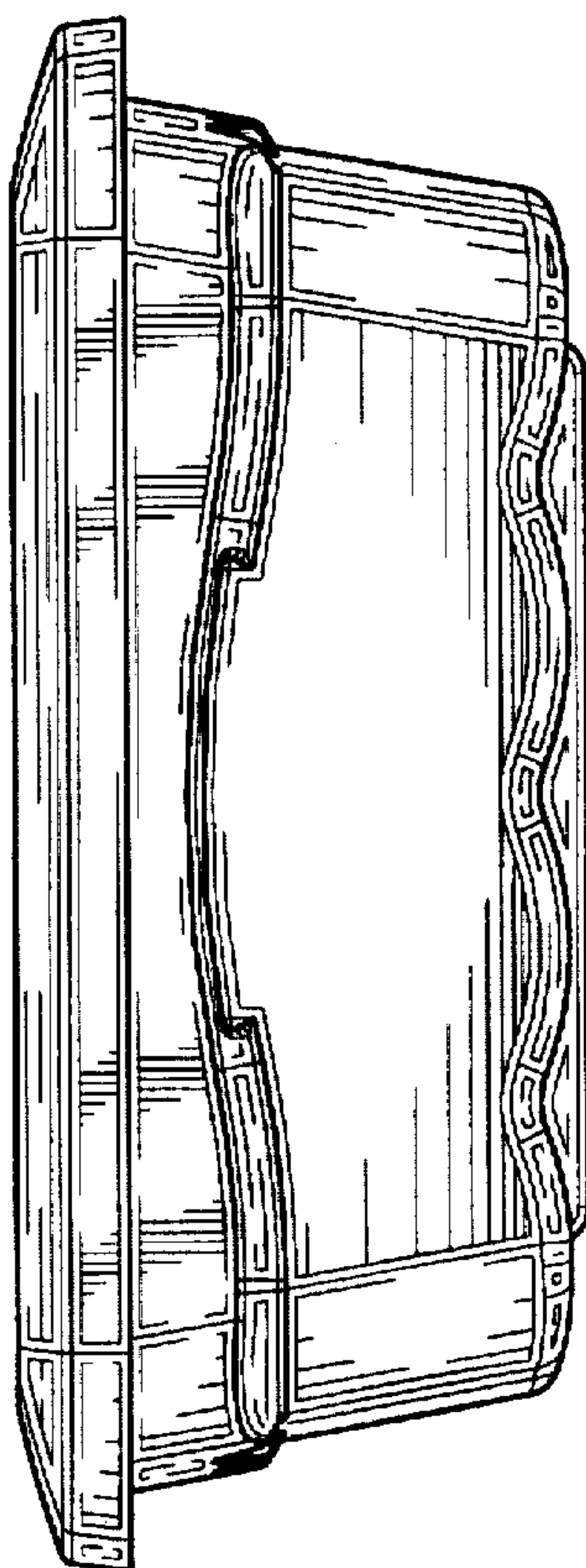

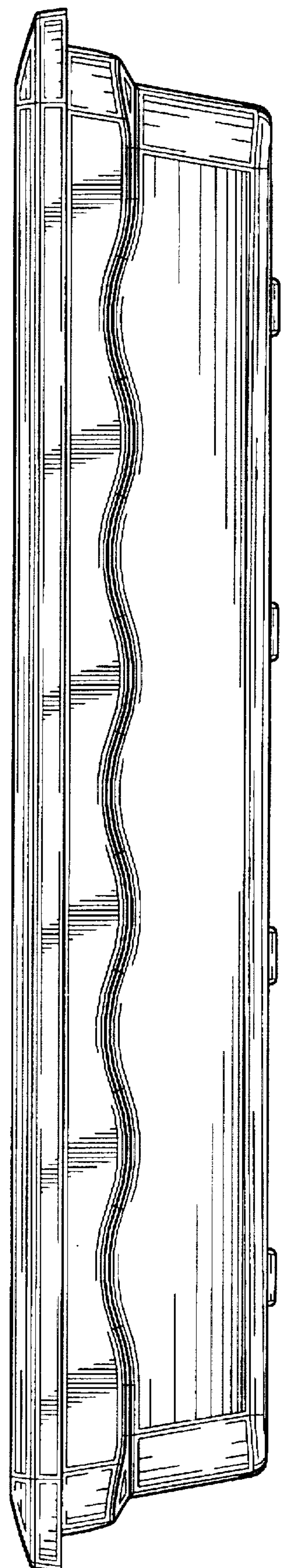

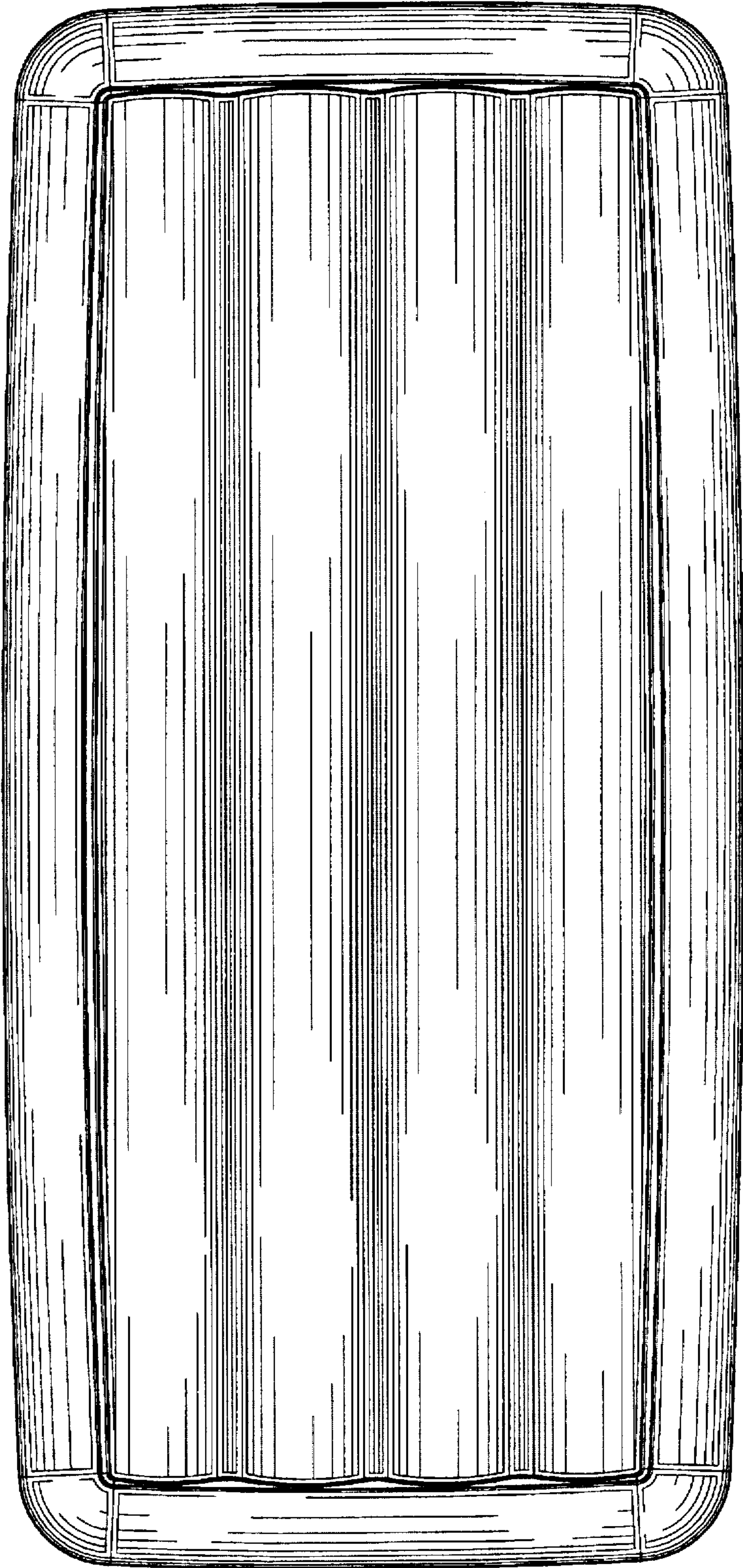

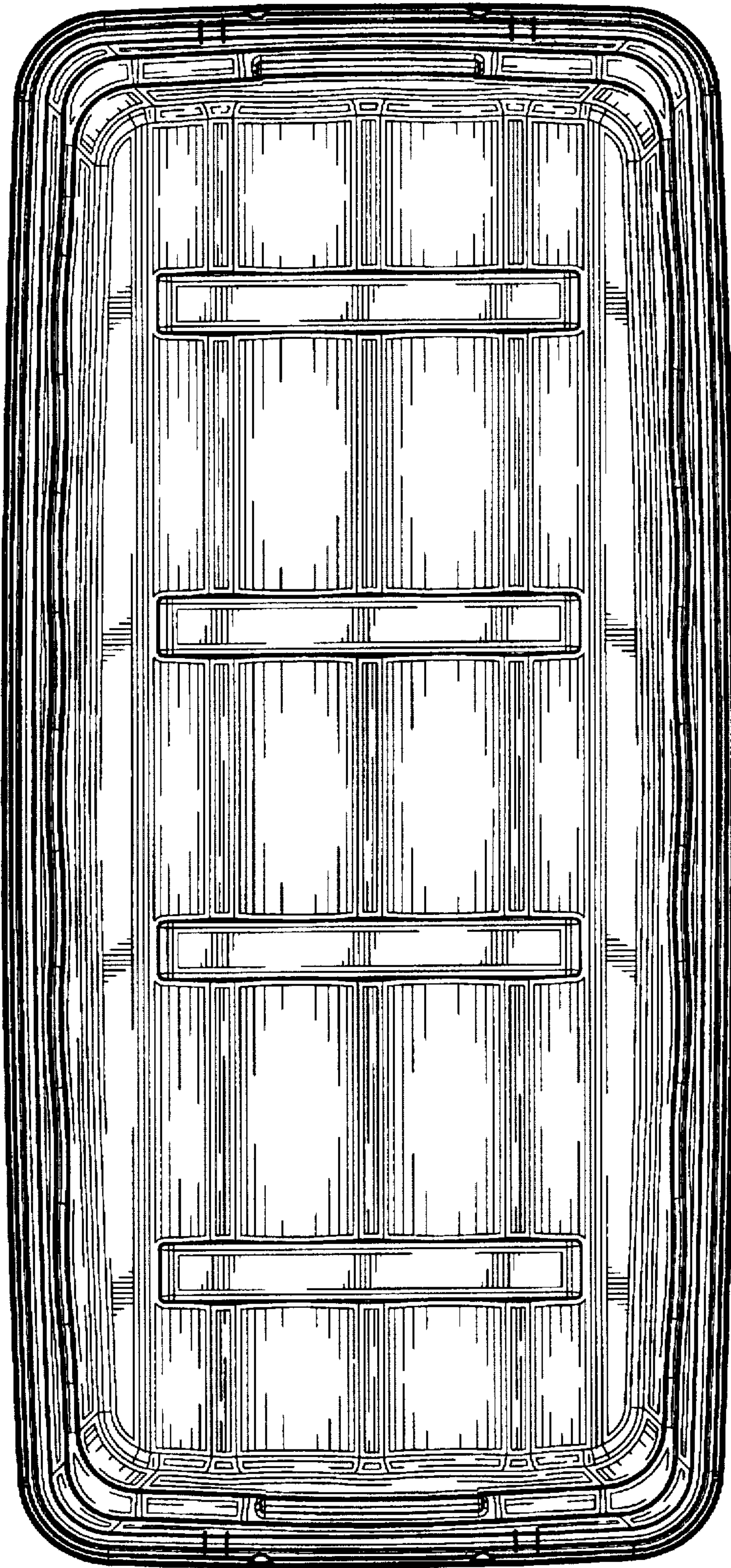
