FIG. 1 is an end view of of my new design of a snap hook; FIG. 2 is a first side view showing my new design of a snap hook;

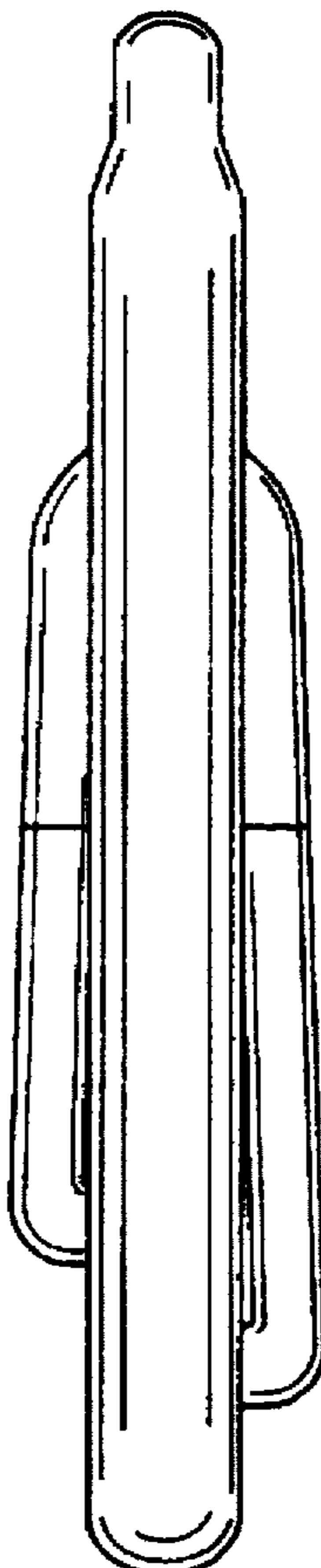
FIG. 3 is a front view of my new design of a snap hook;

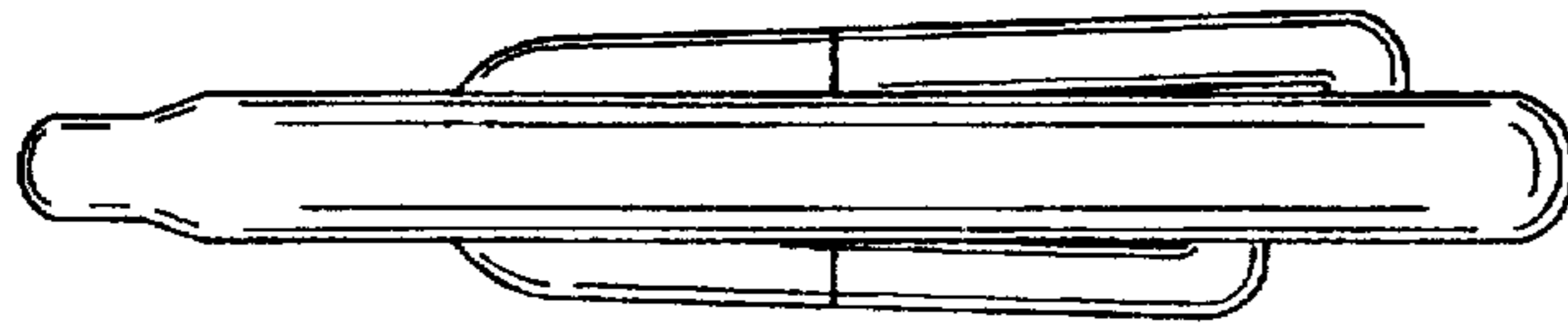

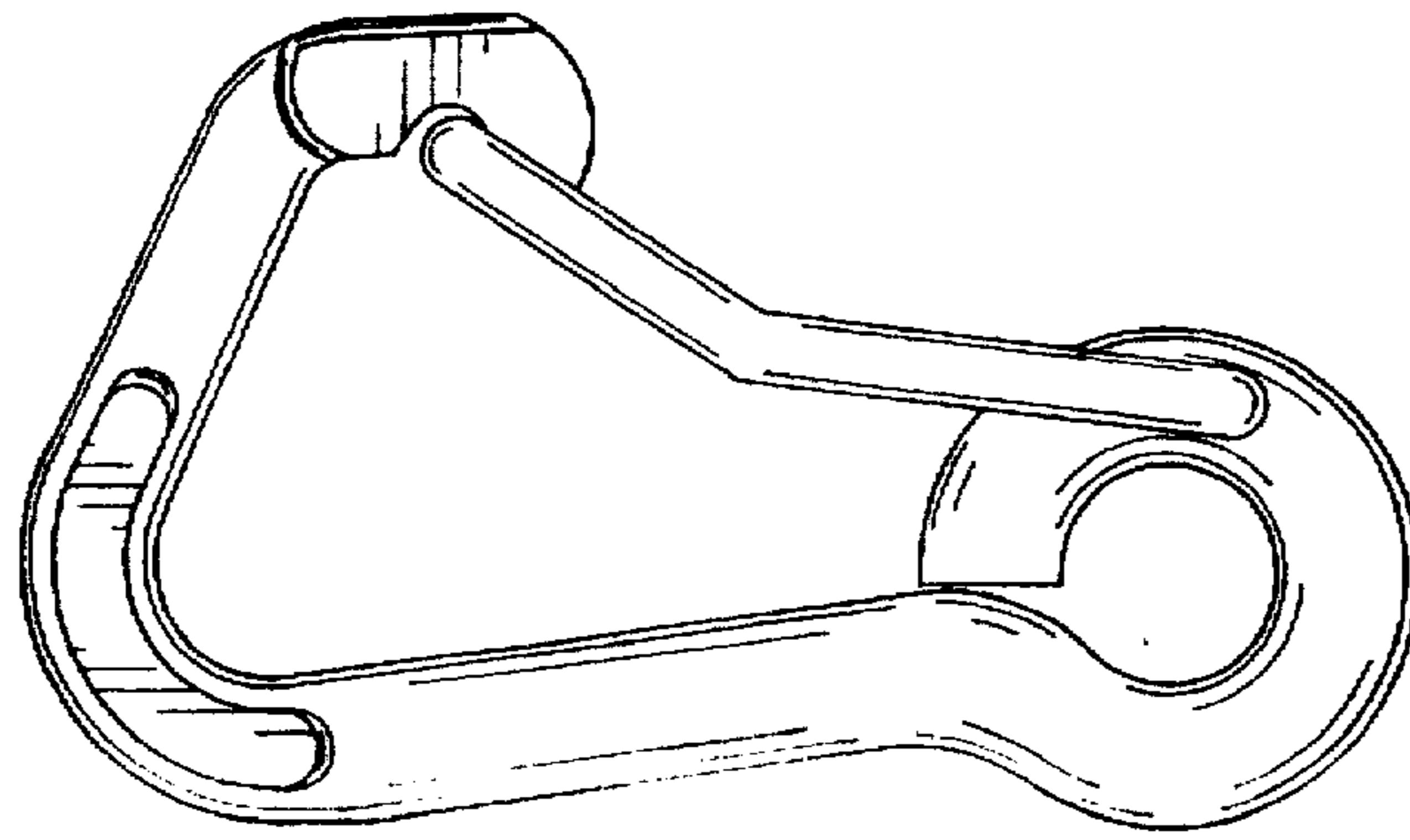

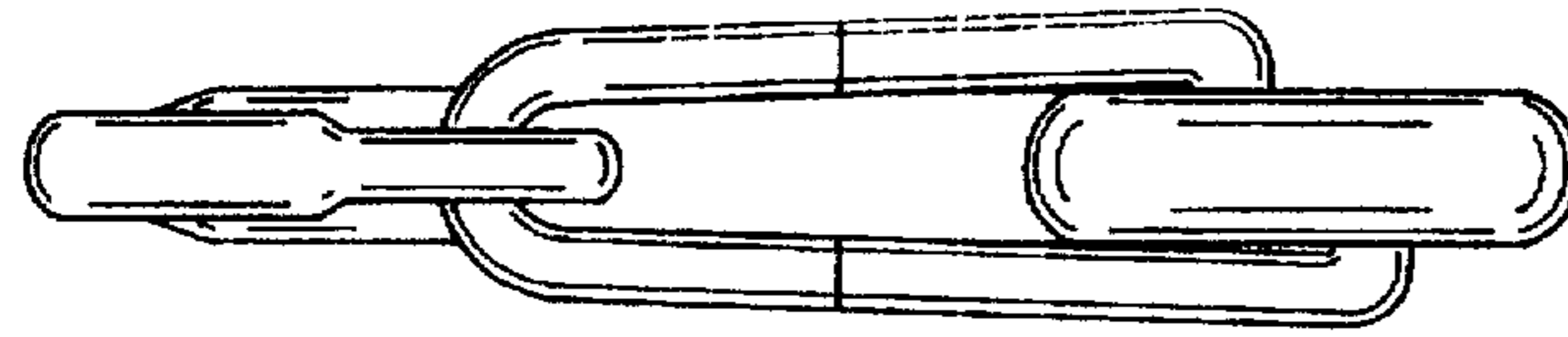

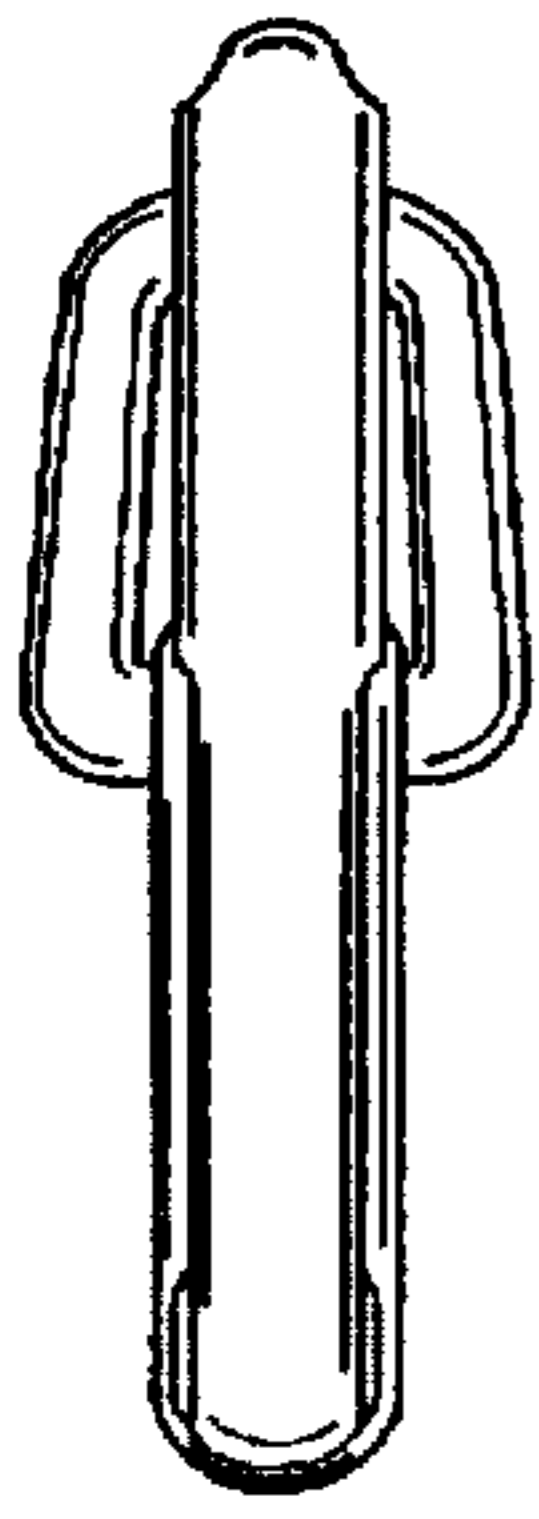

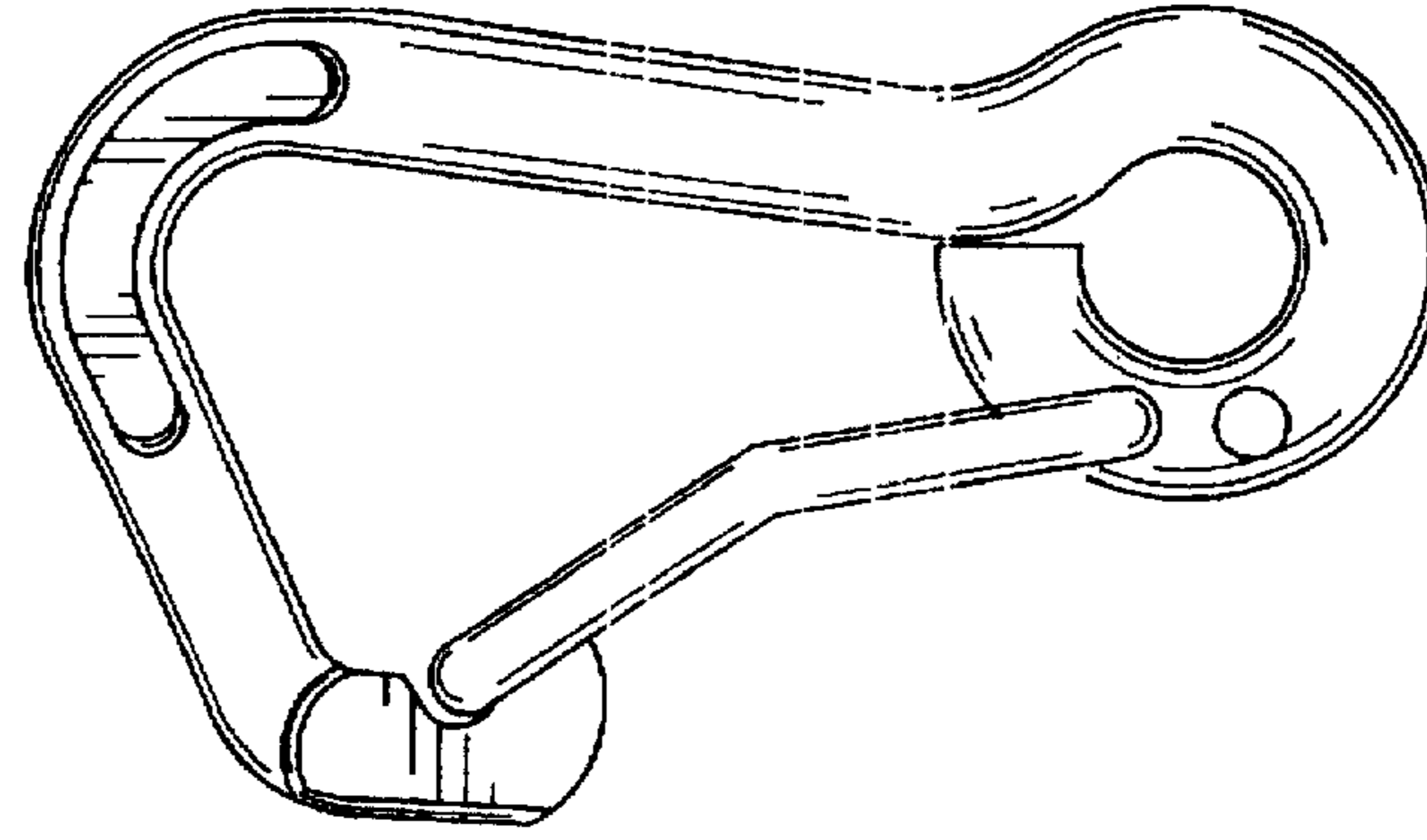

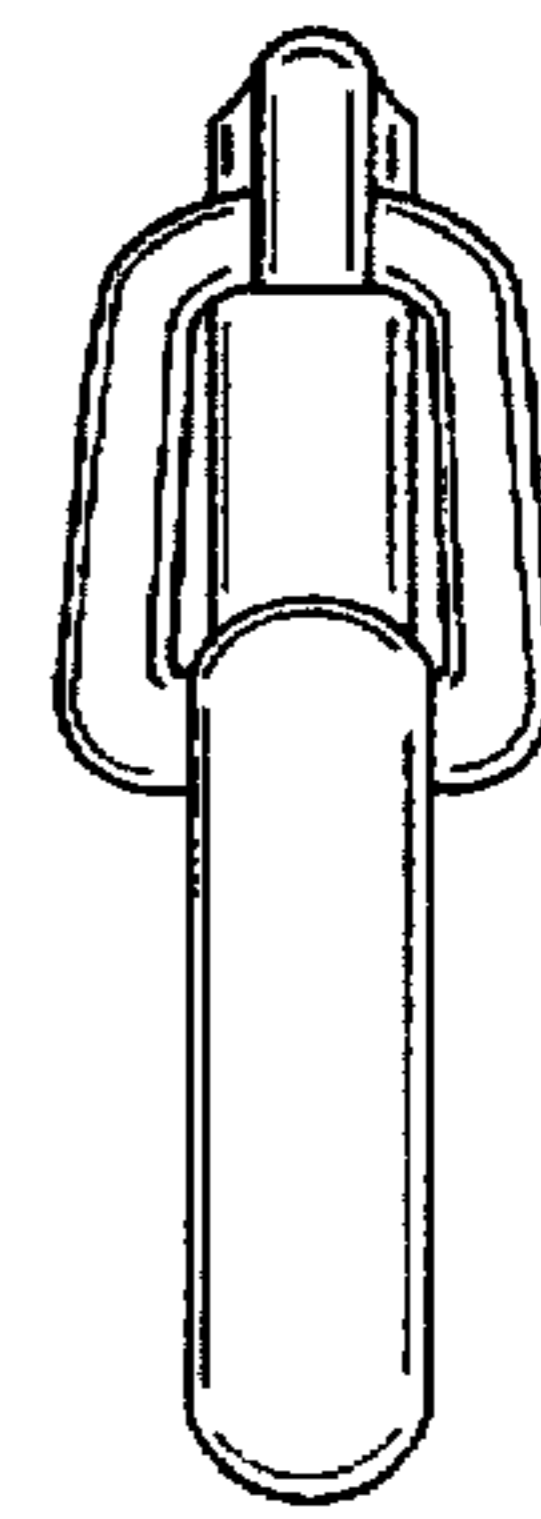
