## DESCRIPTION

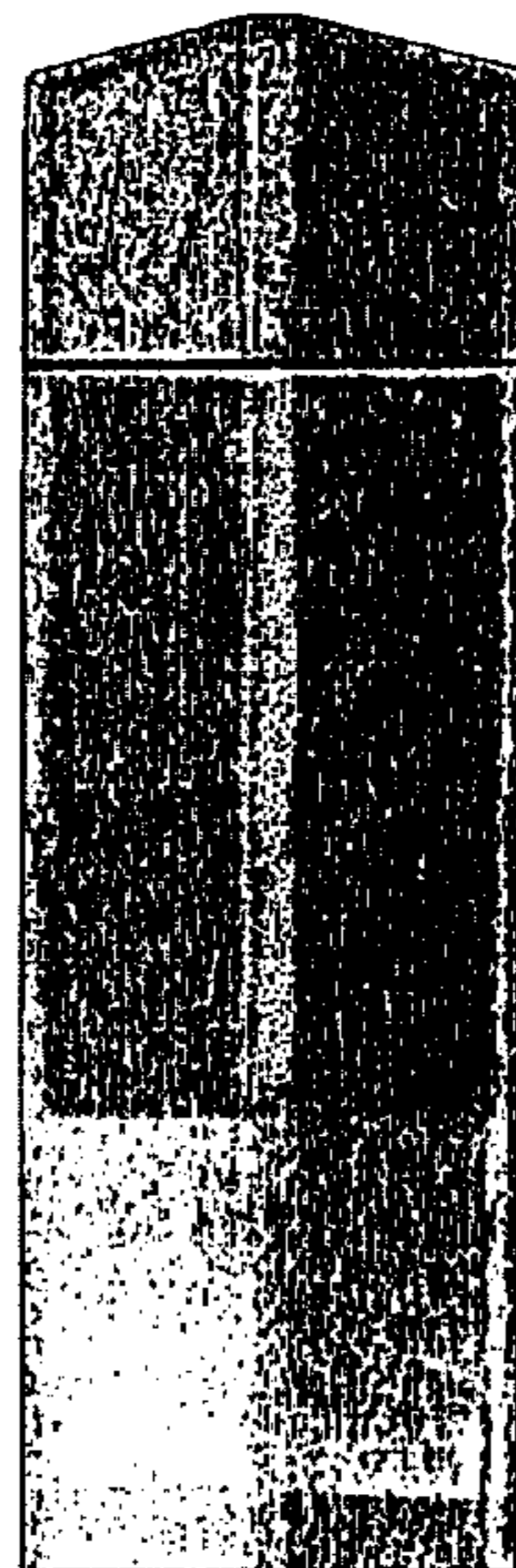
FIG. 1 is a front elevation of a combined container and cap showing my new design, the rear elevation is the same;

FIG. 2 is a left side elevation of the combined container and cap, the right side elevation is the same; and,

FIG. 3 is a top plan view thereof.

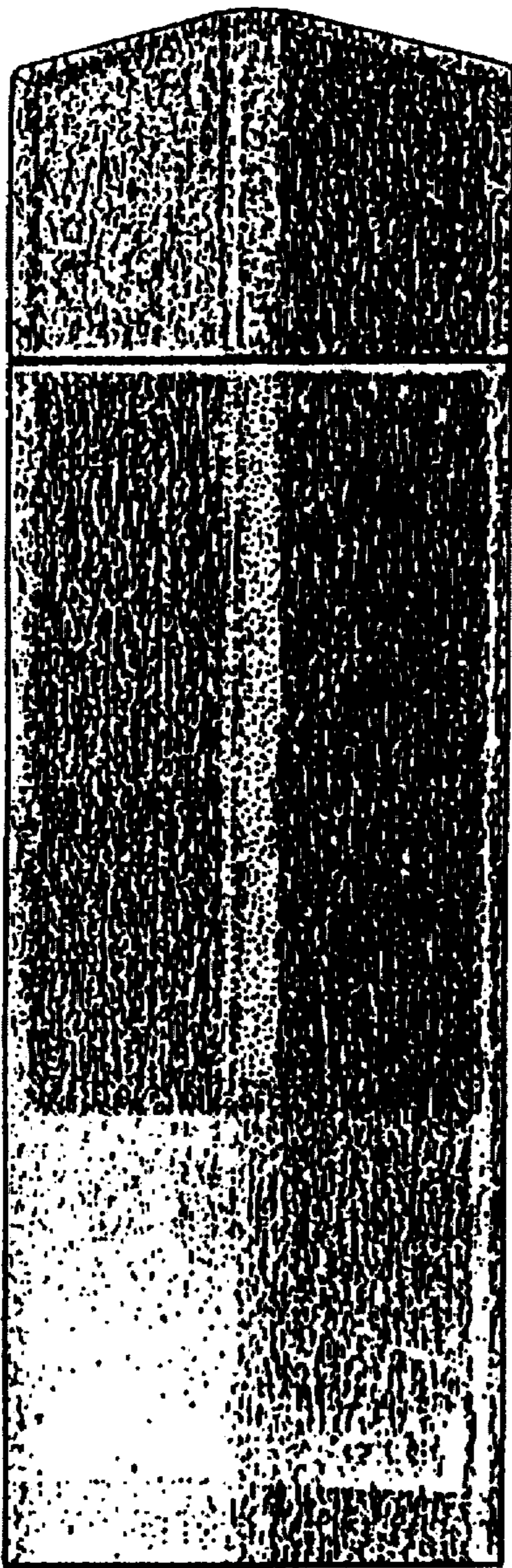

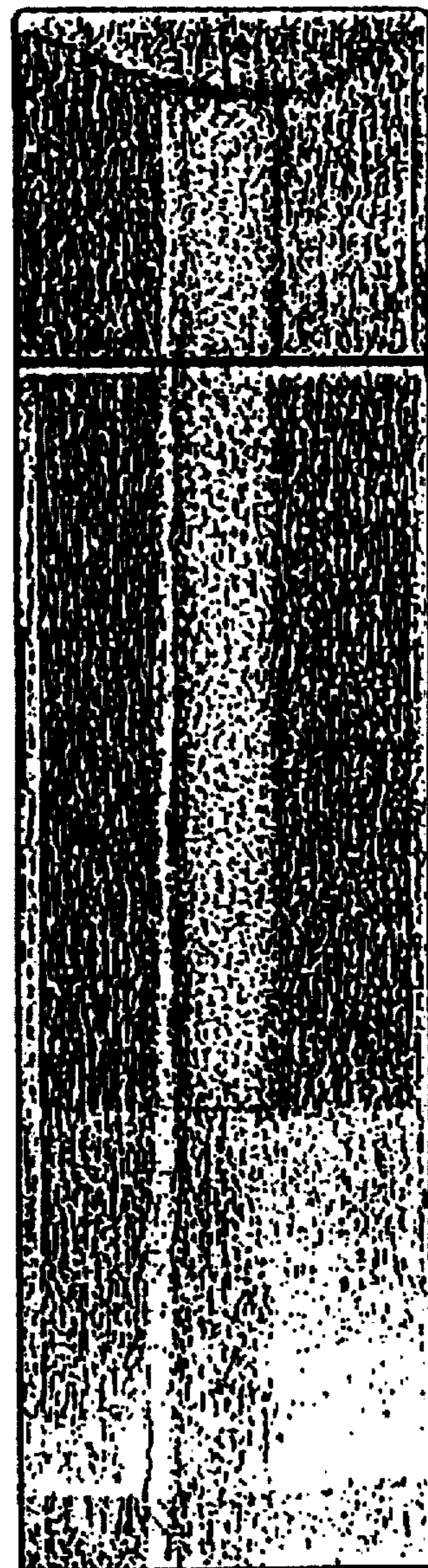

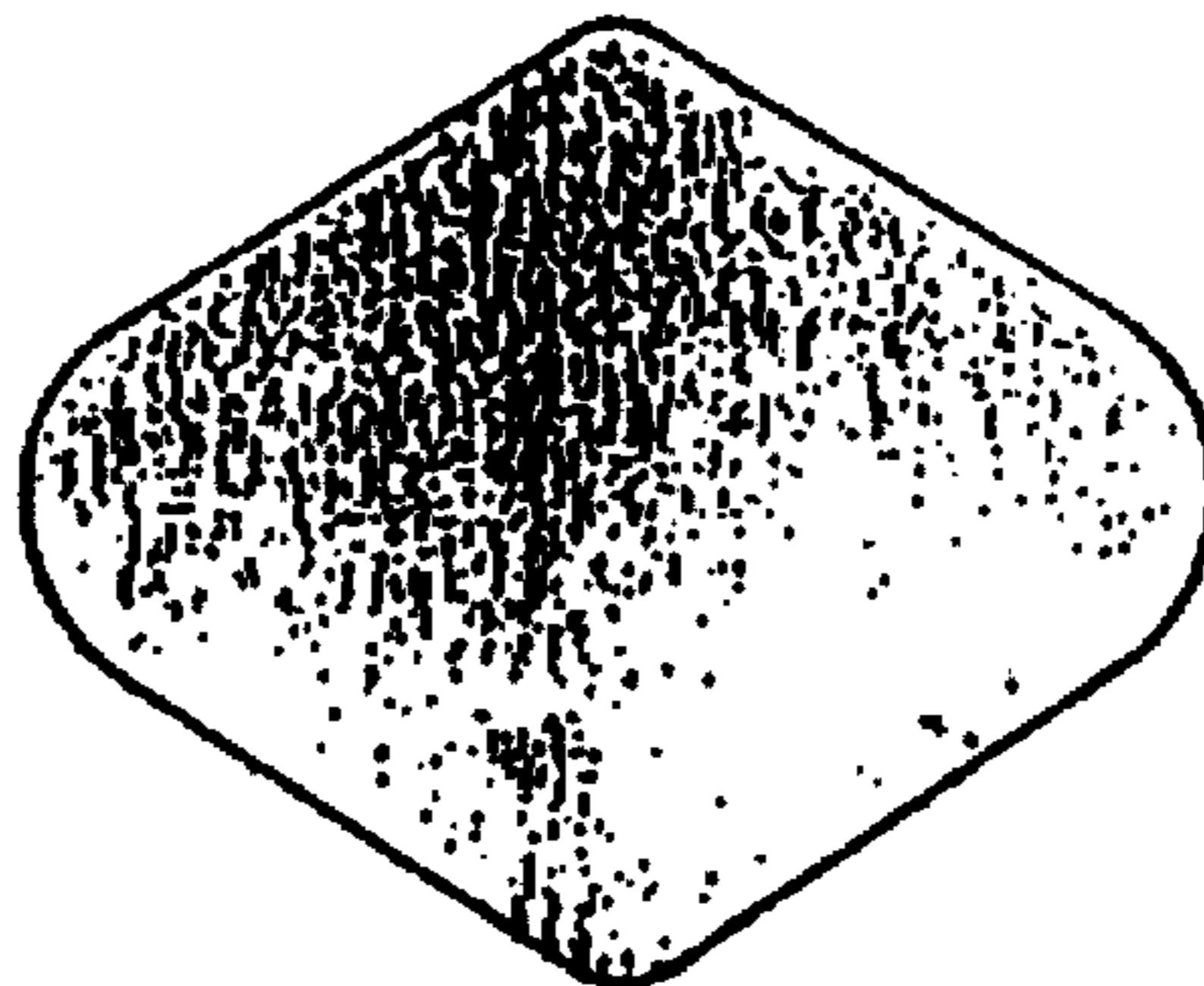
