DESCRIPTION

FIG. 1 is a top plan view of a control device showing my new design;

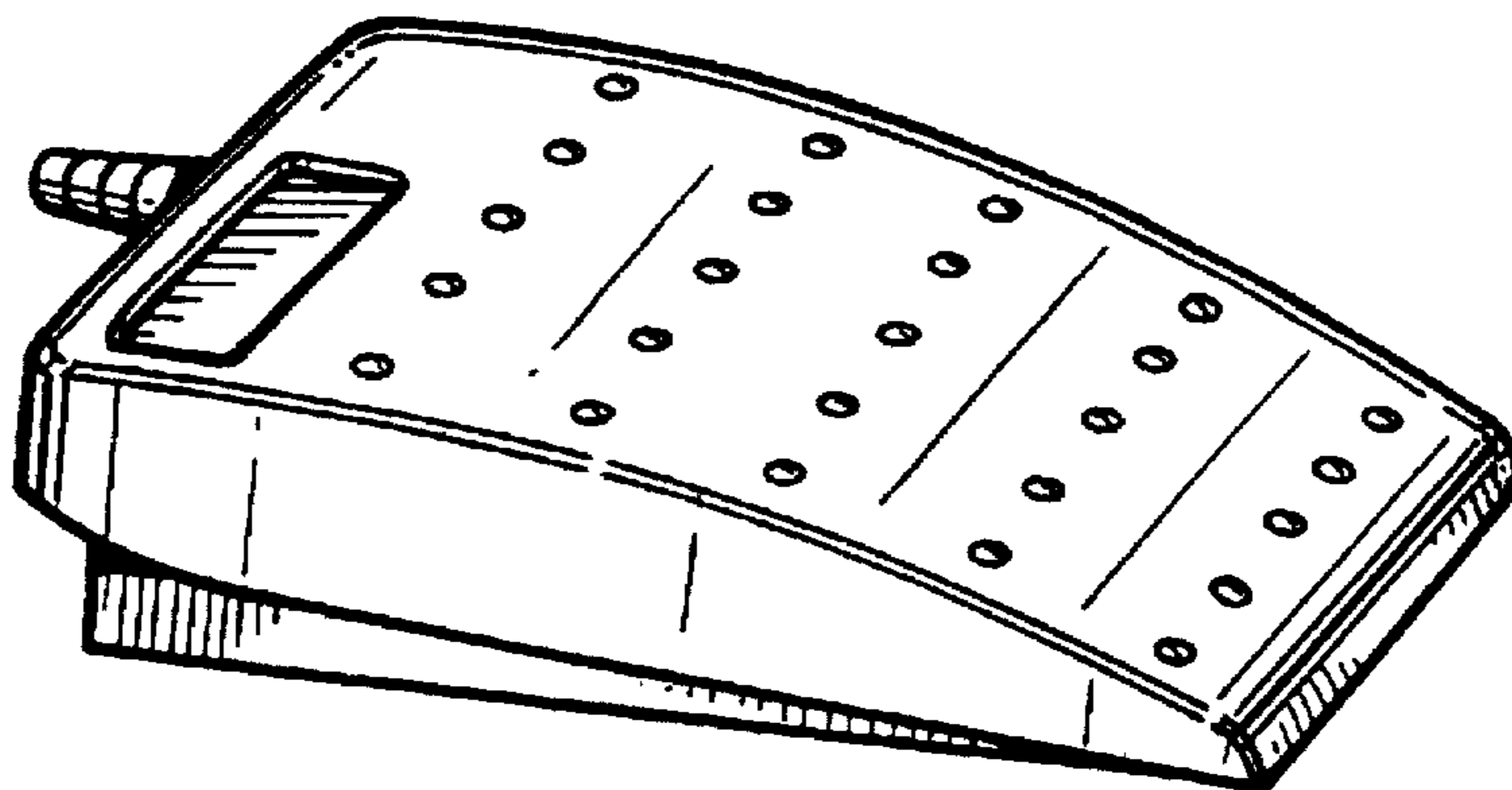
FIG. 2 is a left side elevational view thereof as seen from the lower edge of FIG. 1; the right side, not shown, is the mirror image thereof;

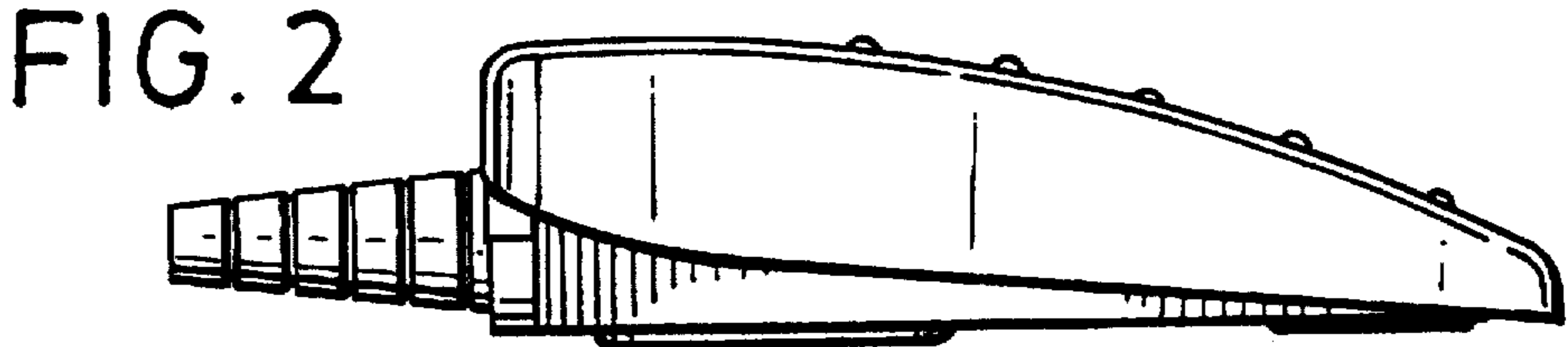
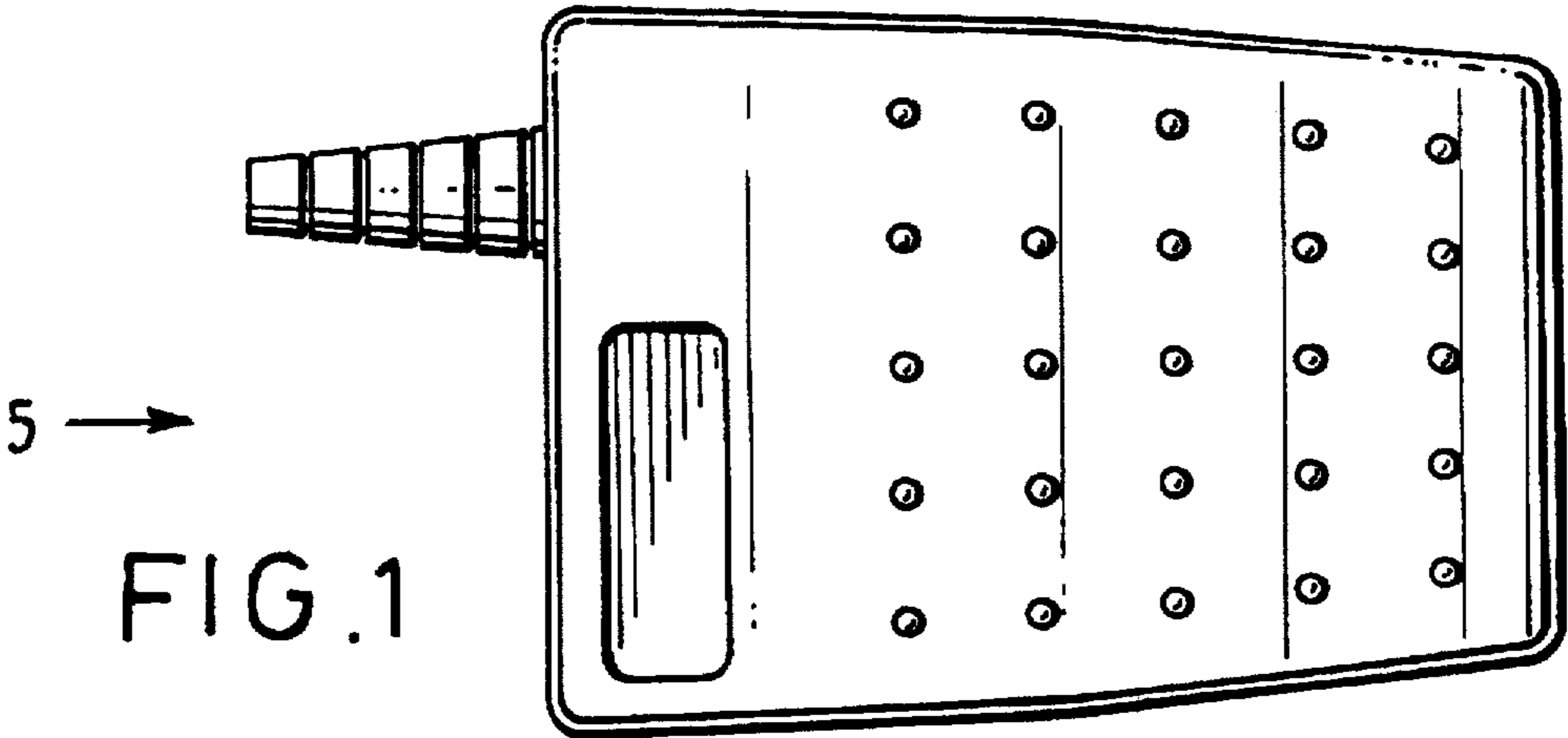

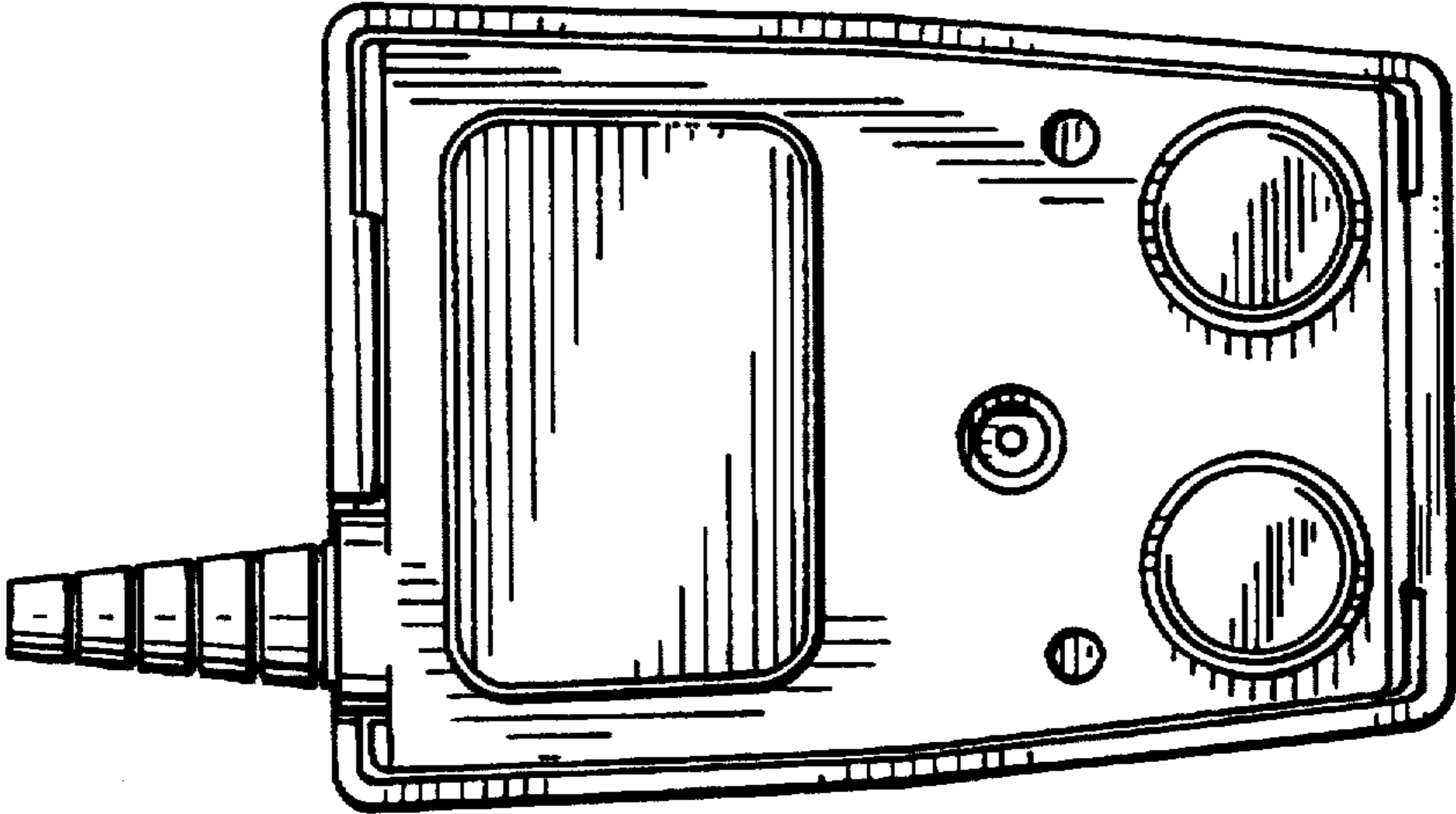

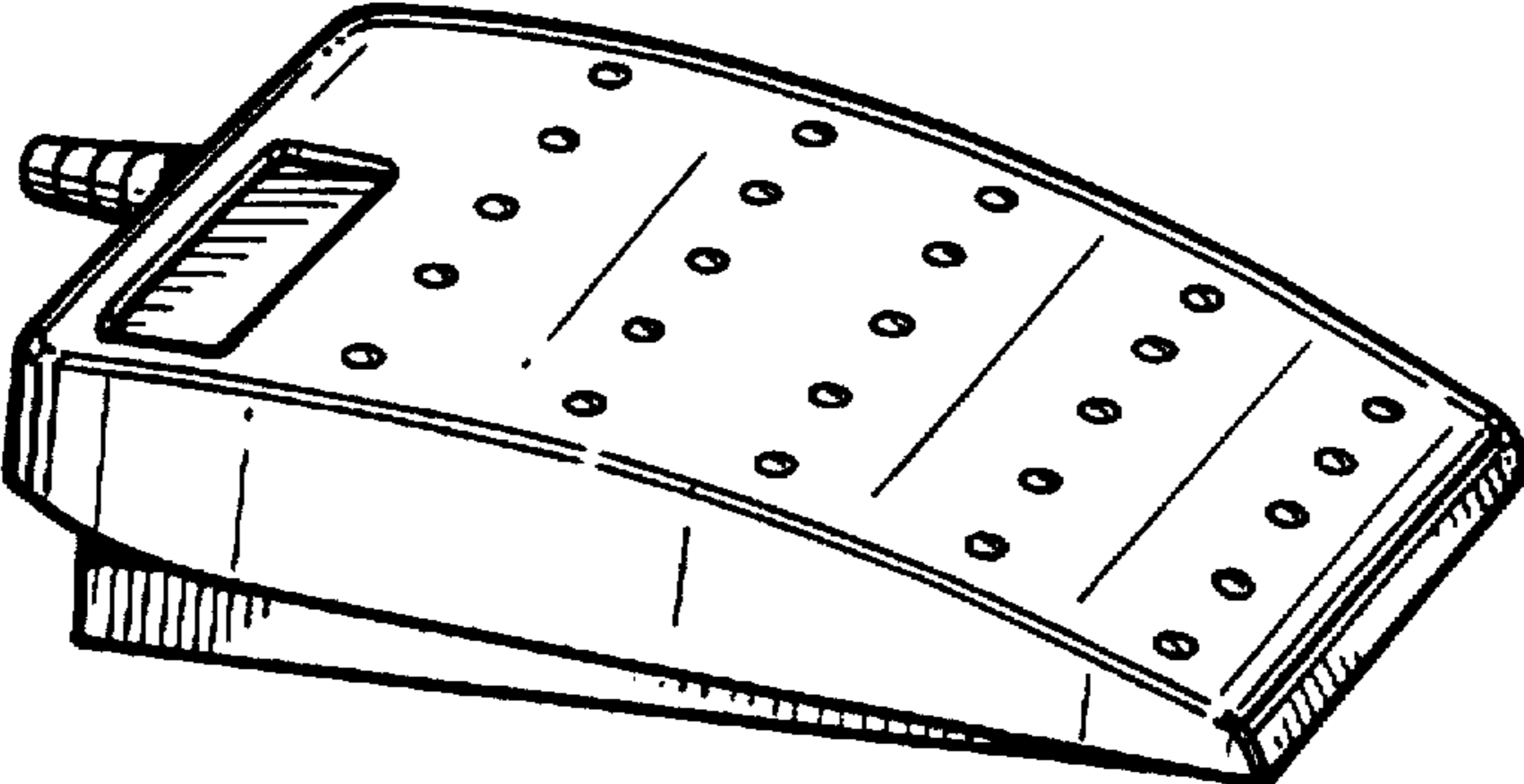
