[57] CLAIM

The ornamental design for a modular base for a cordless portable telephone, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, front perspective view of a modular base for a cordless portable telephone showing our new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a rear elevational view thereof; and, FIG. 4 is a right elevational view thereof.

The broken lines shown in FIGS. 1, 2, 4 are for illustrative purposes only and form no part of the claimed design.

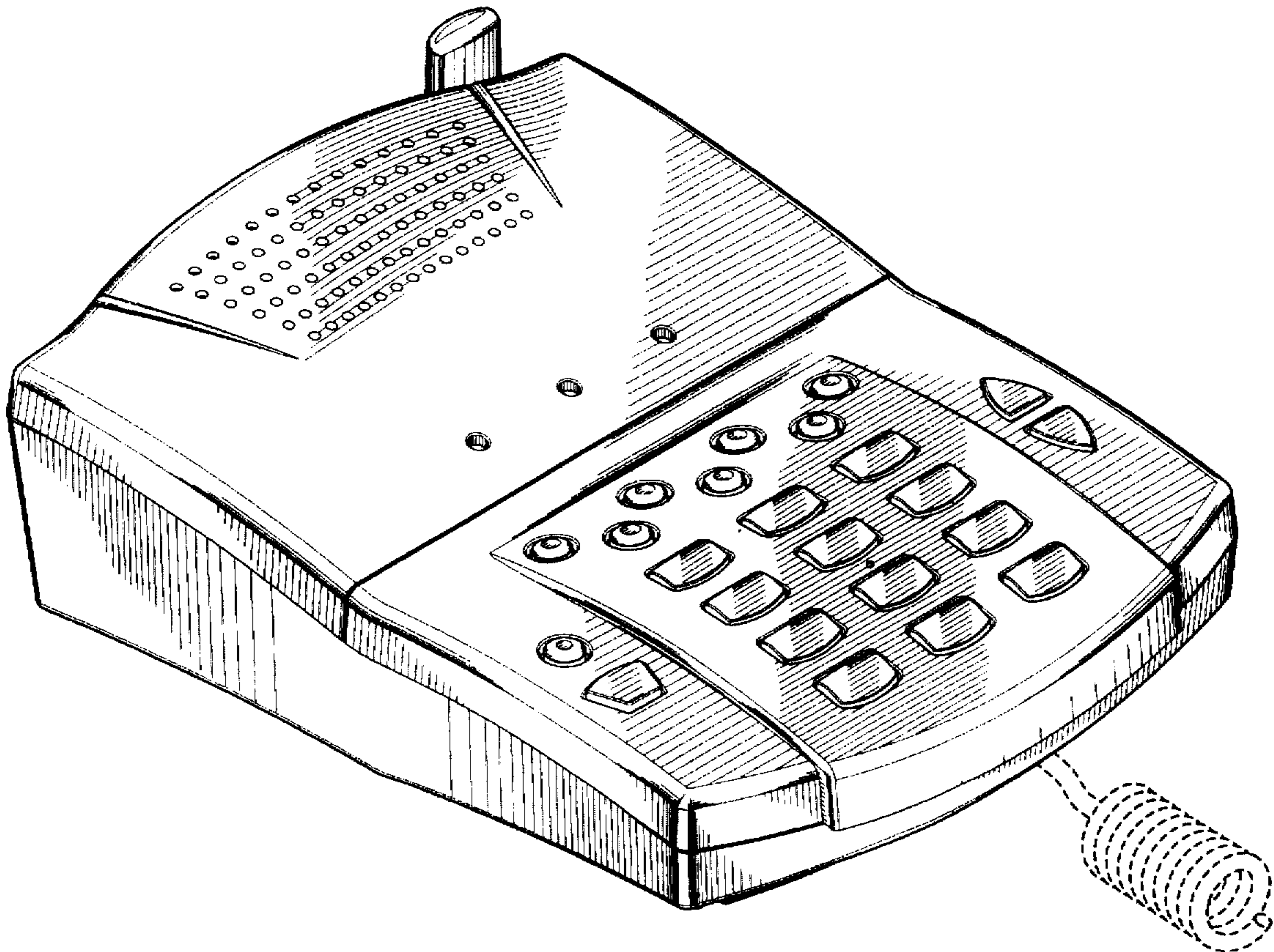
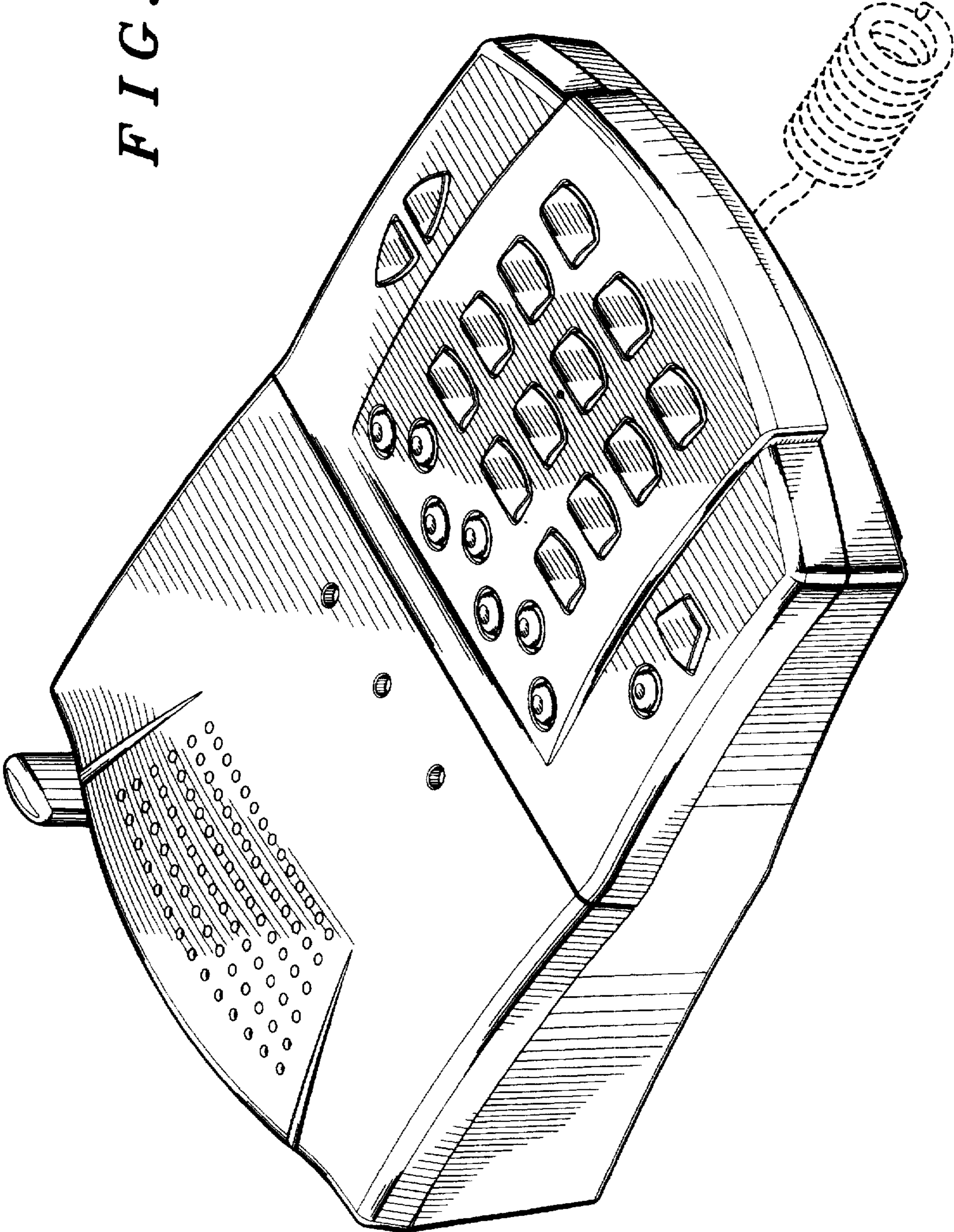

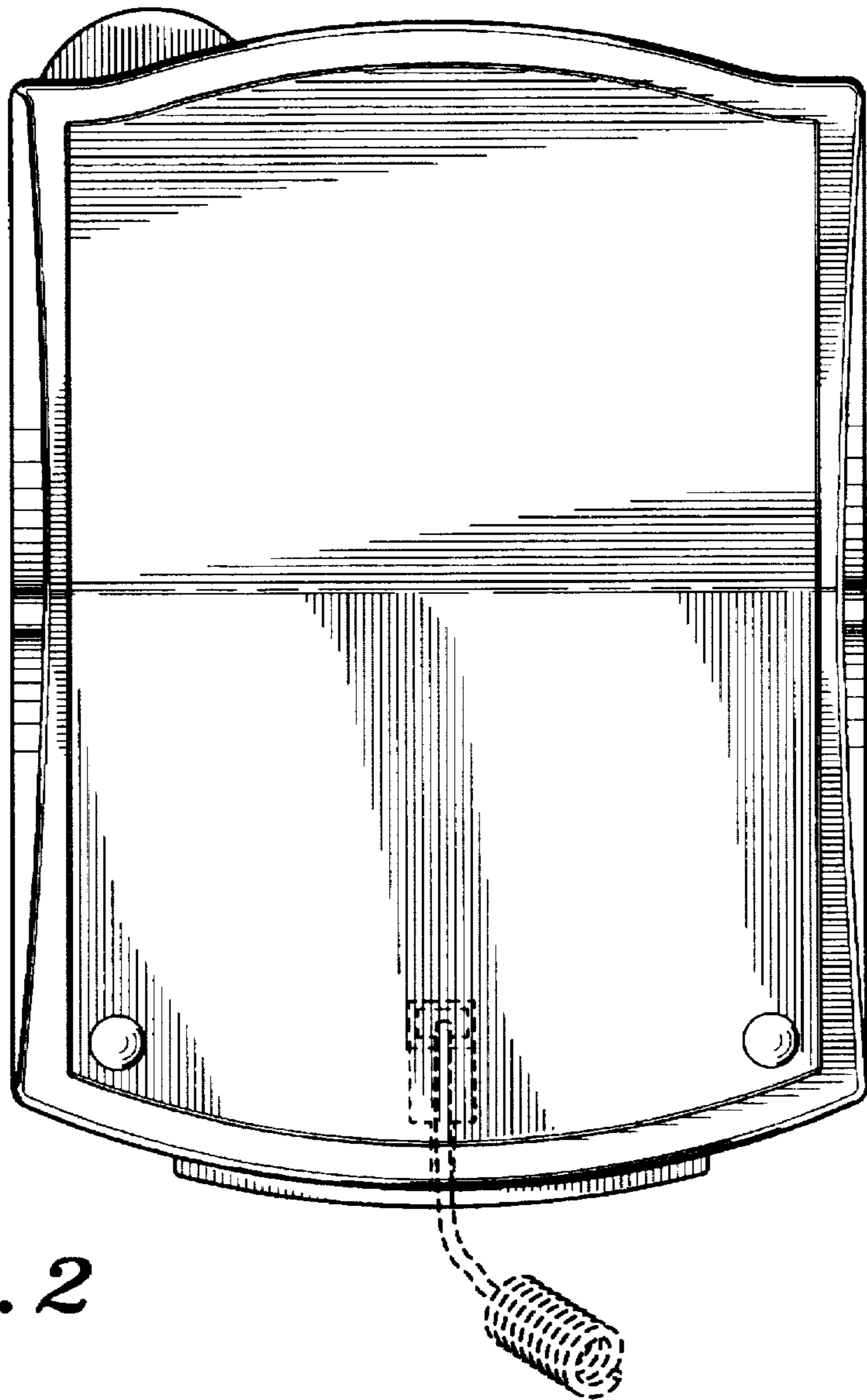

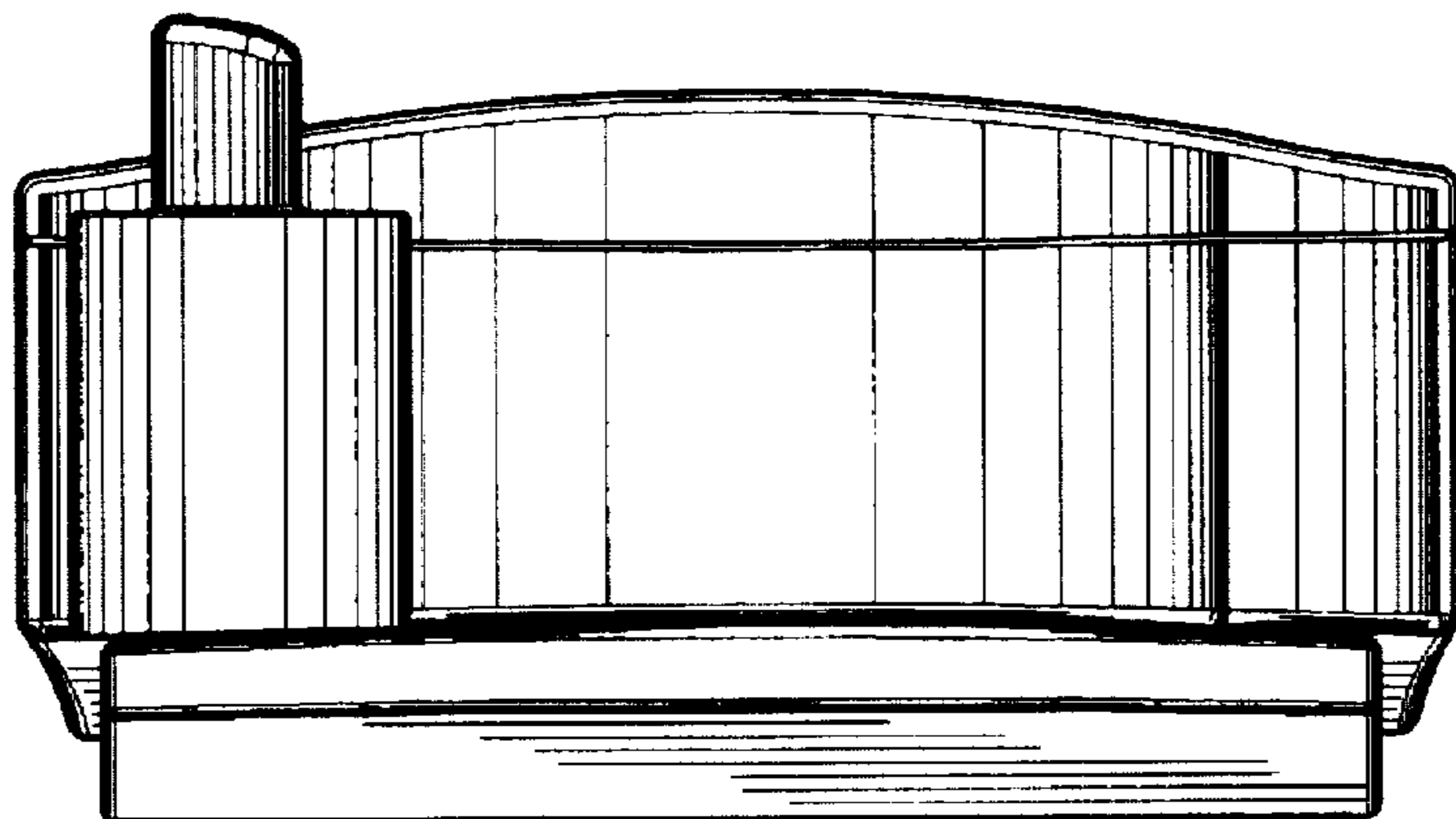

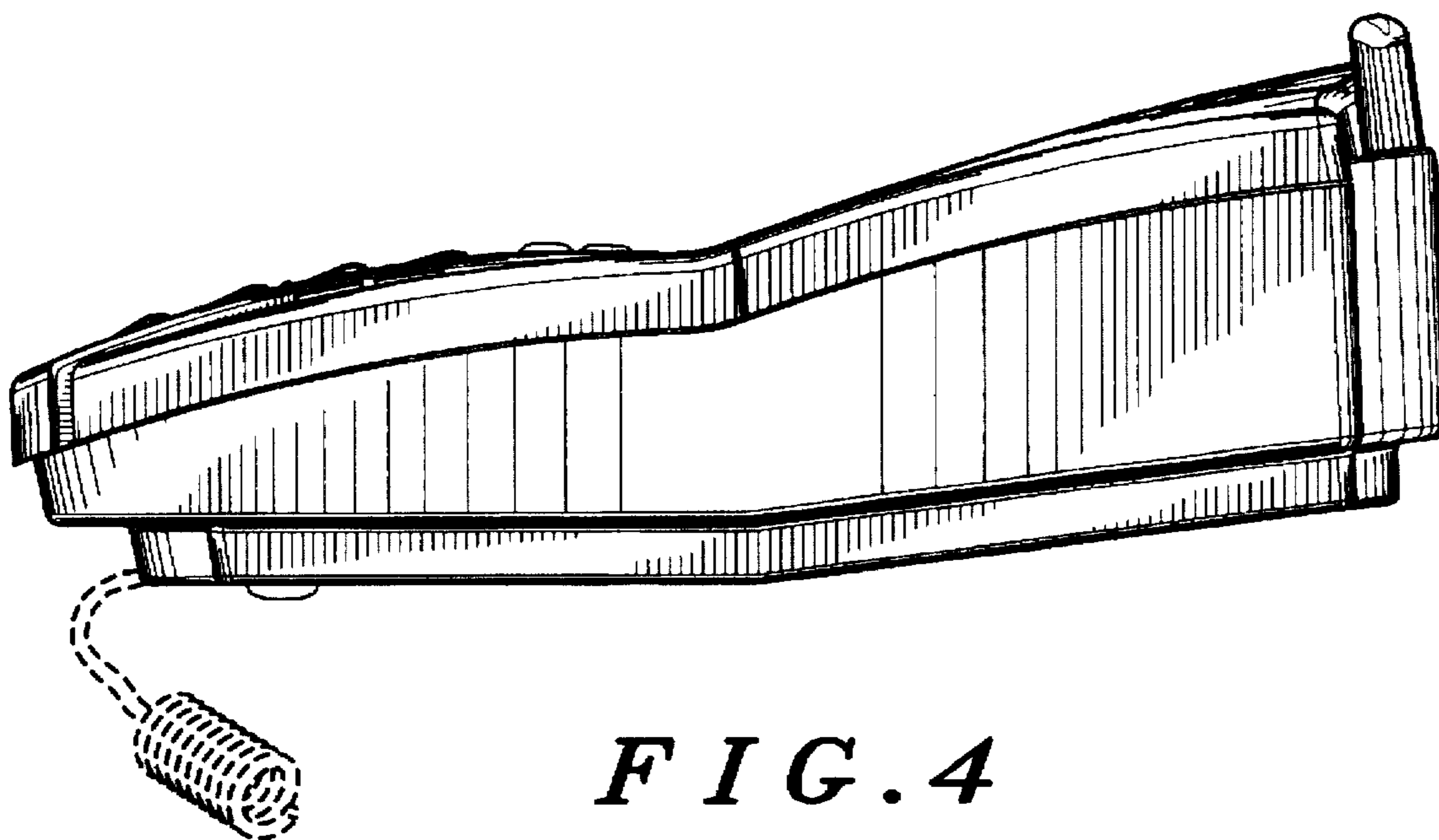
