[57] CLAIM

The ornamental design for a pair of speakers for personal computer monitor, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the right speaker of a pair of speakers for personal computer monitor showing our new design, the right speaker is shown separately for clarity of illustration;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a front elevational view of the left speaker of a pair of speakers for personal computer monitor, the left speaker is shown separately for clarity of illustration;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a left side elevational view thereof;

FIG. 9 is a top plan view of FIG. 5;

FIG. 10 is a top plan view of FIG. 1;

FIG. 11 is a bottom plan view of FIG. 1;

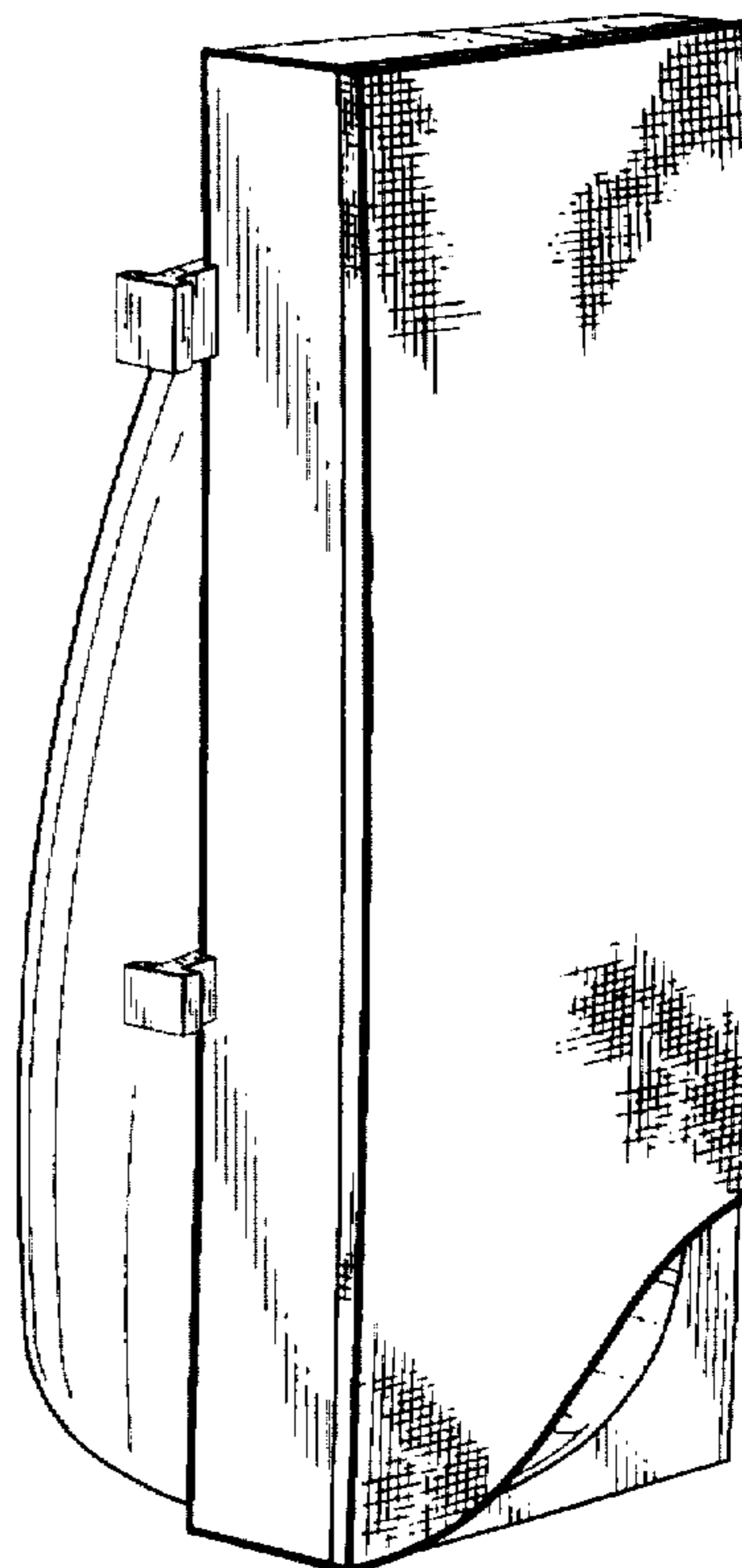
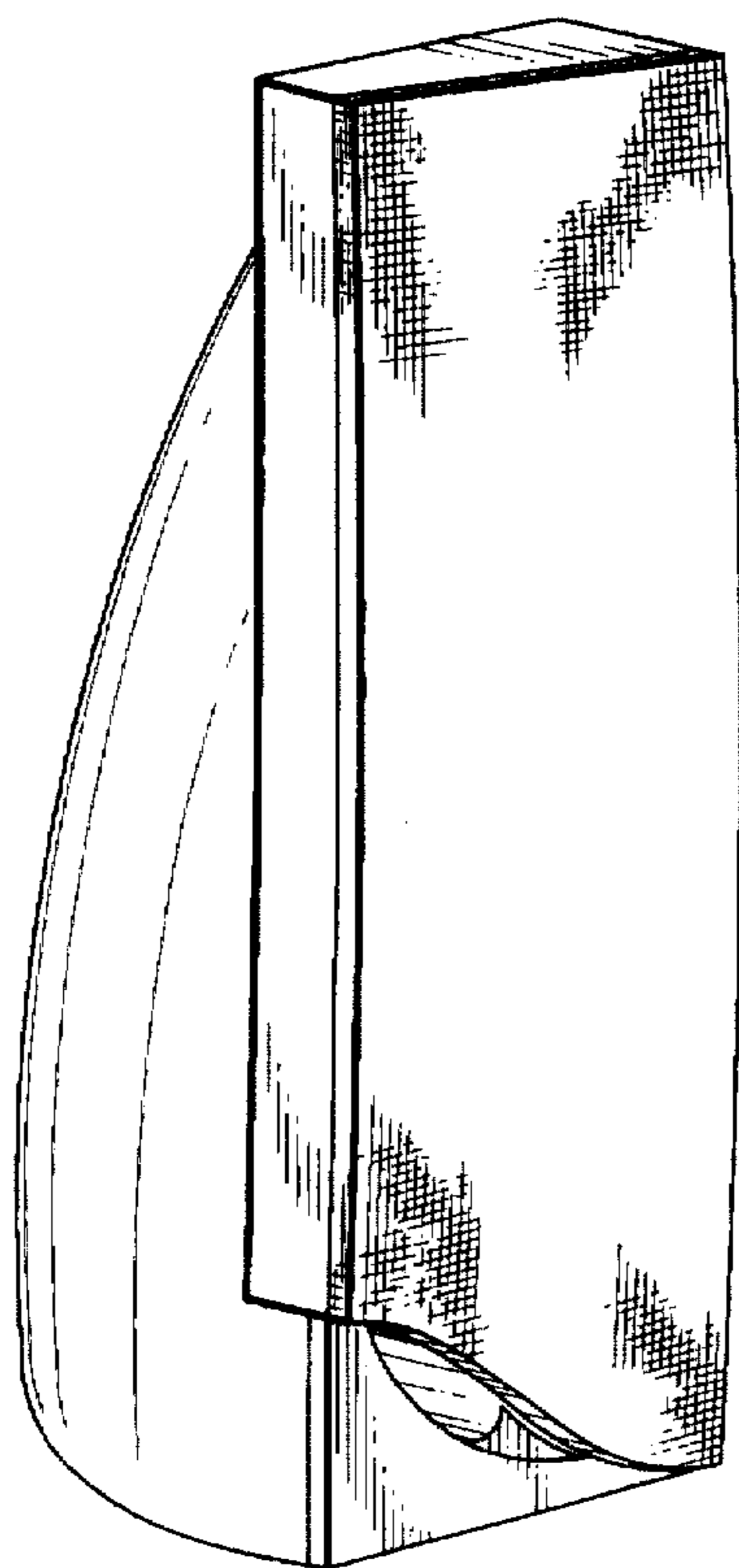
FIG. 12 is a bottom plan view of FIG. 5;

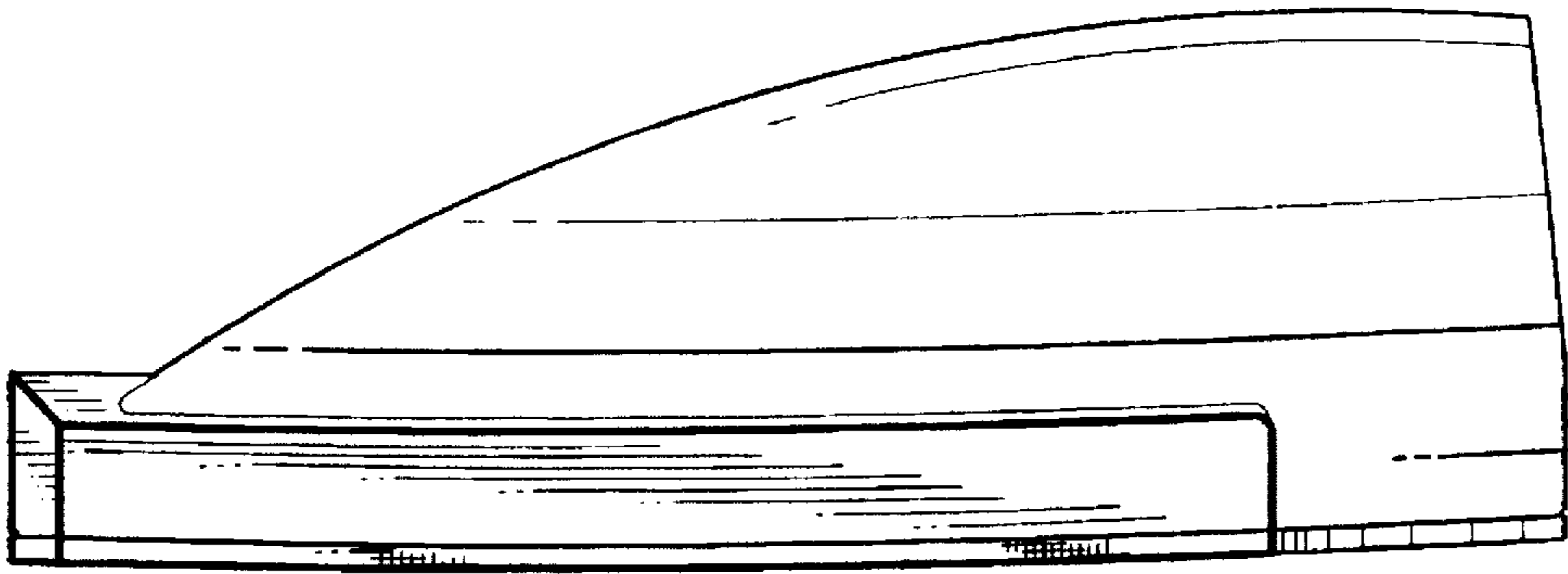

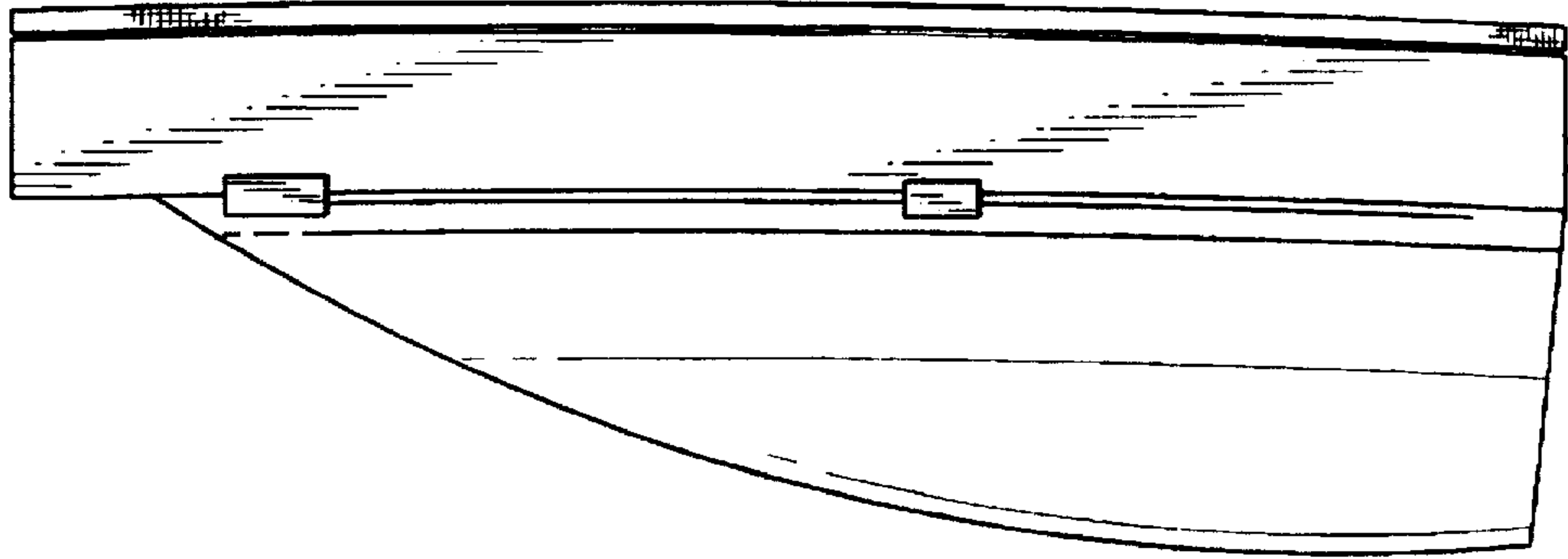

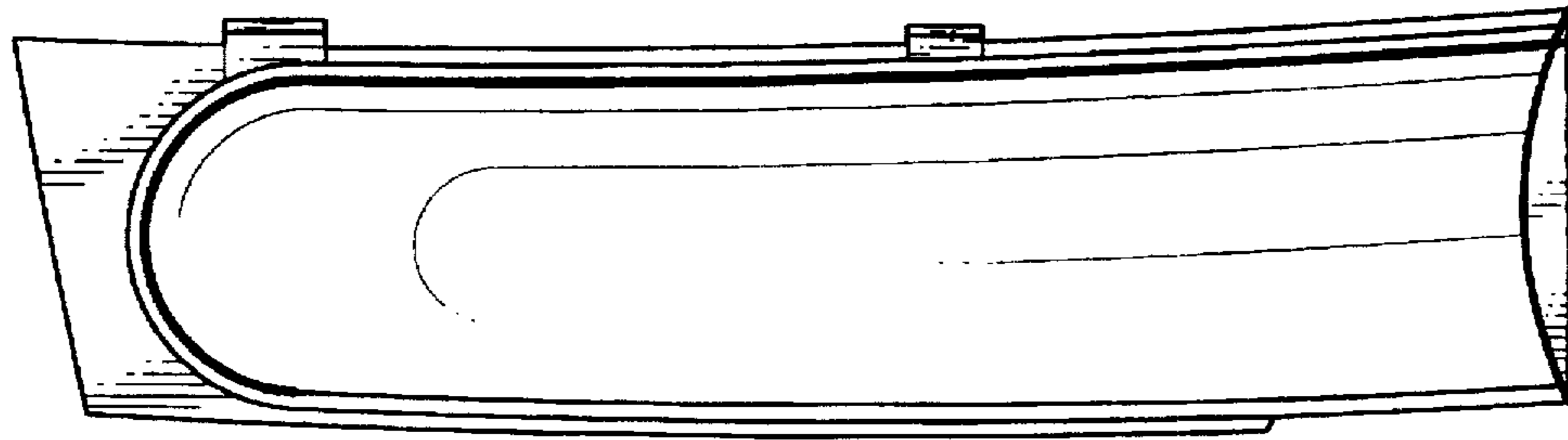

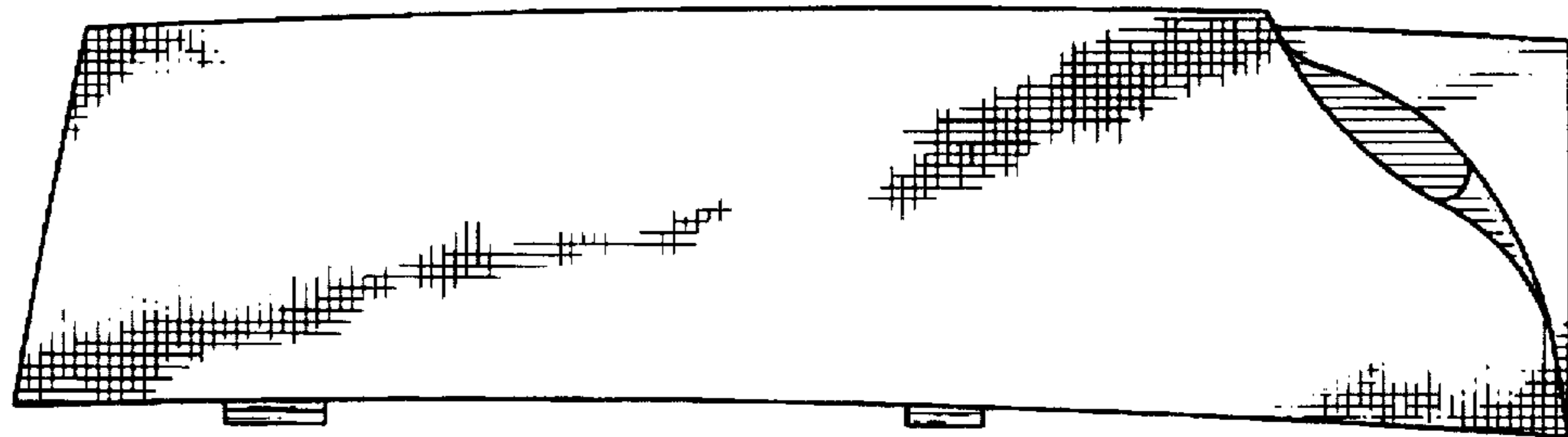

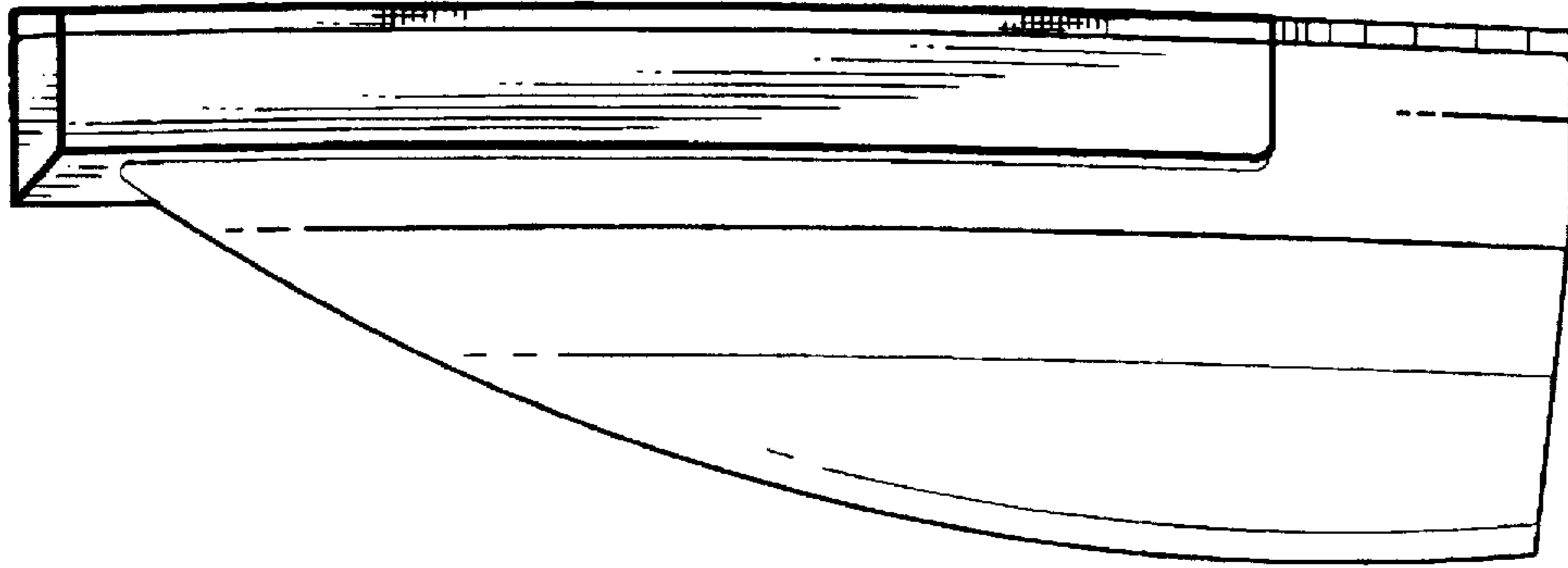

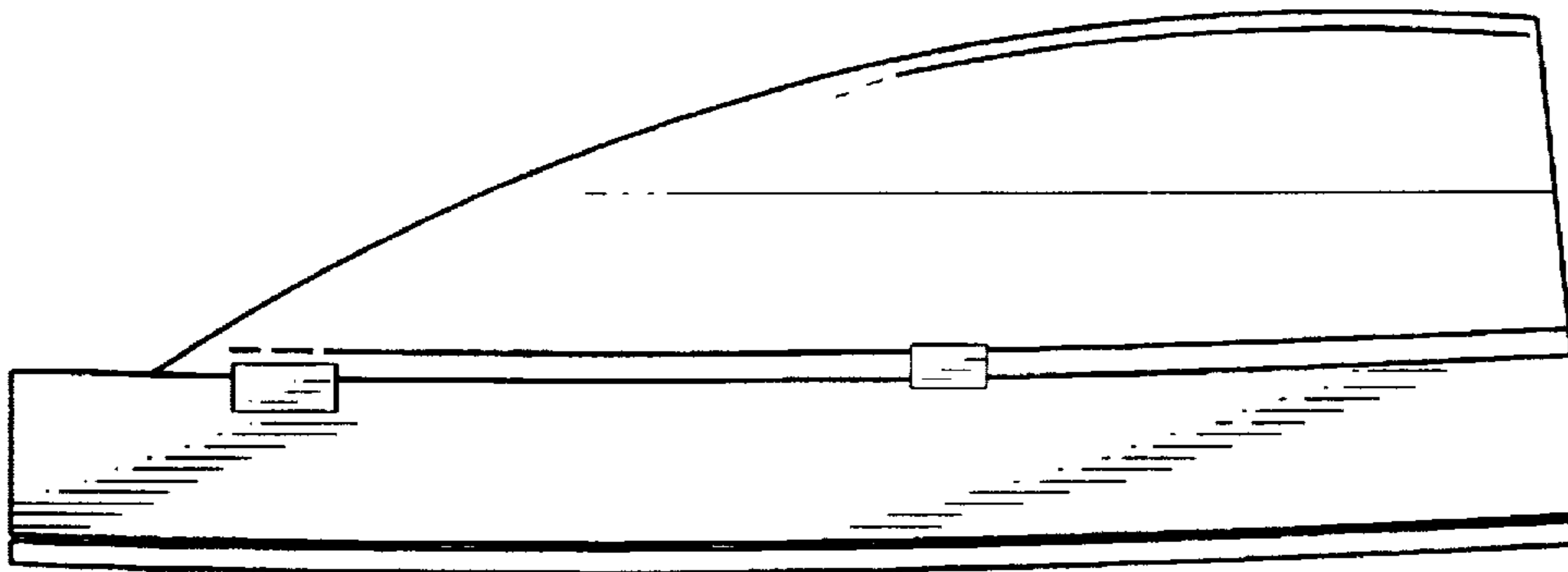

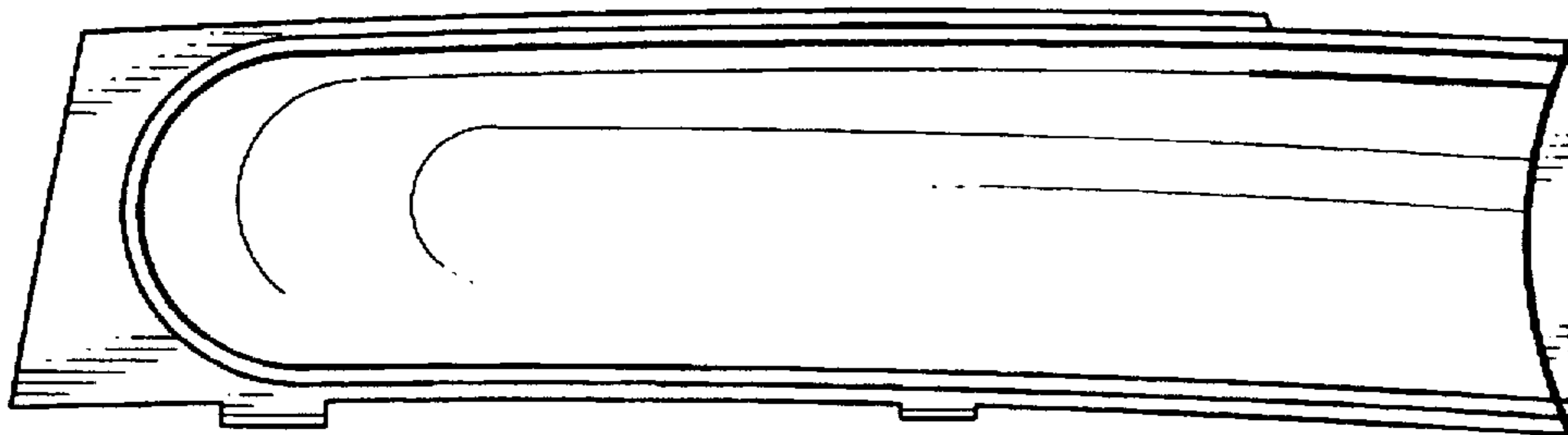

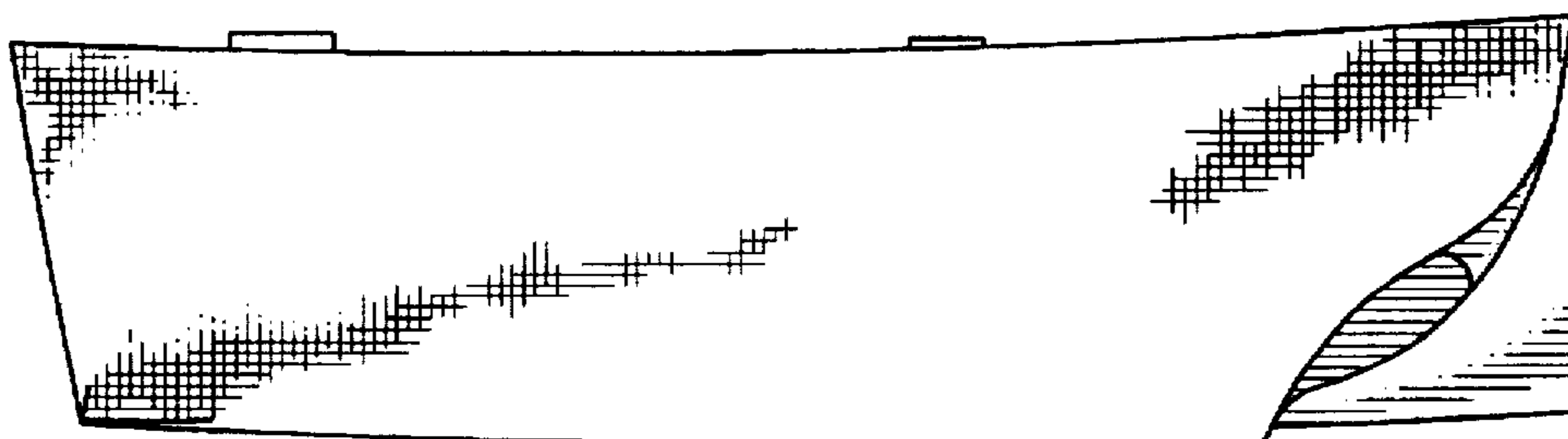

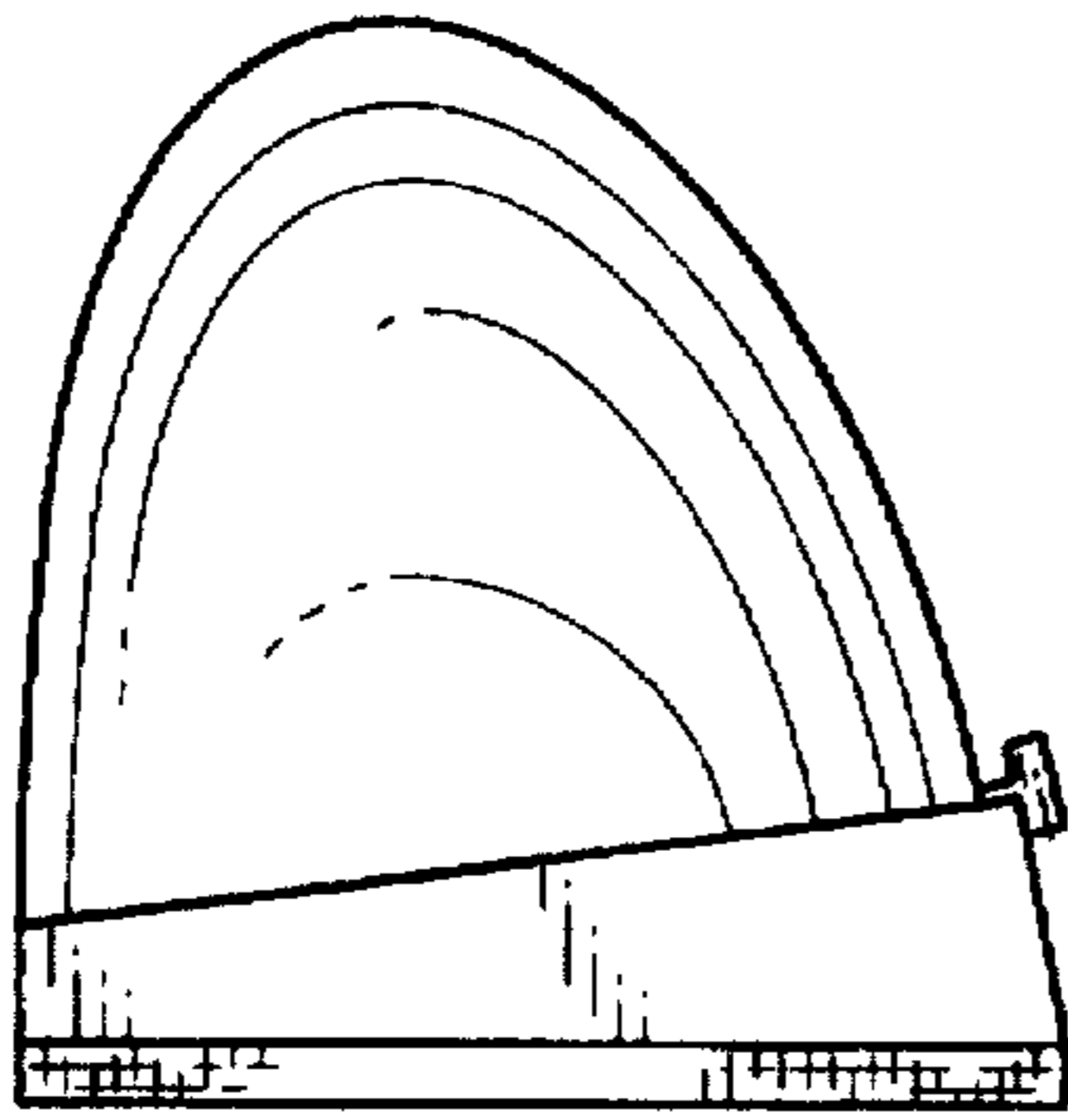

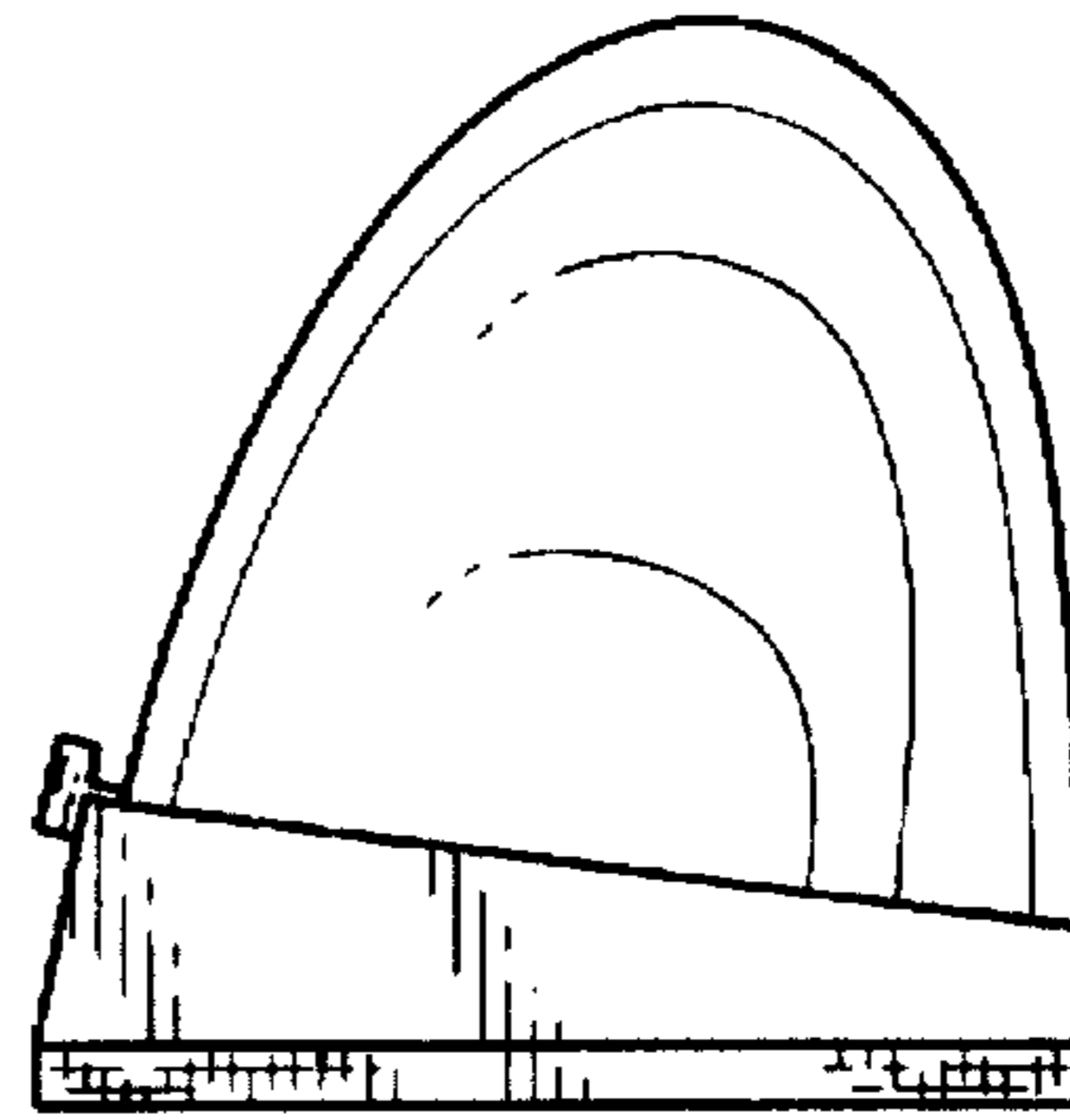

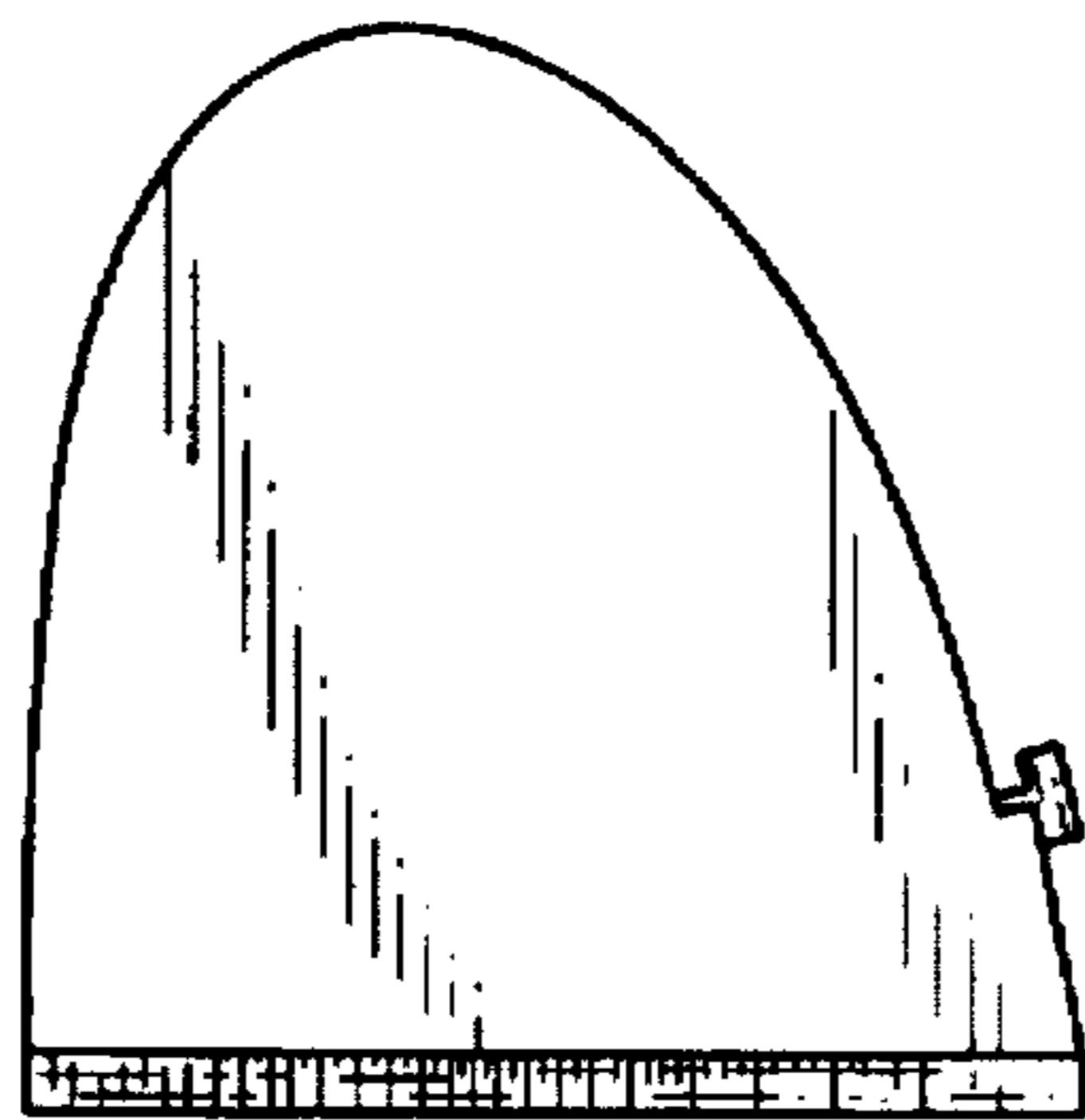

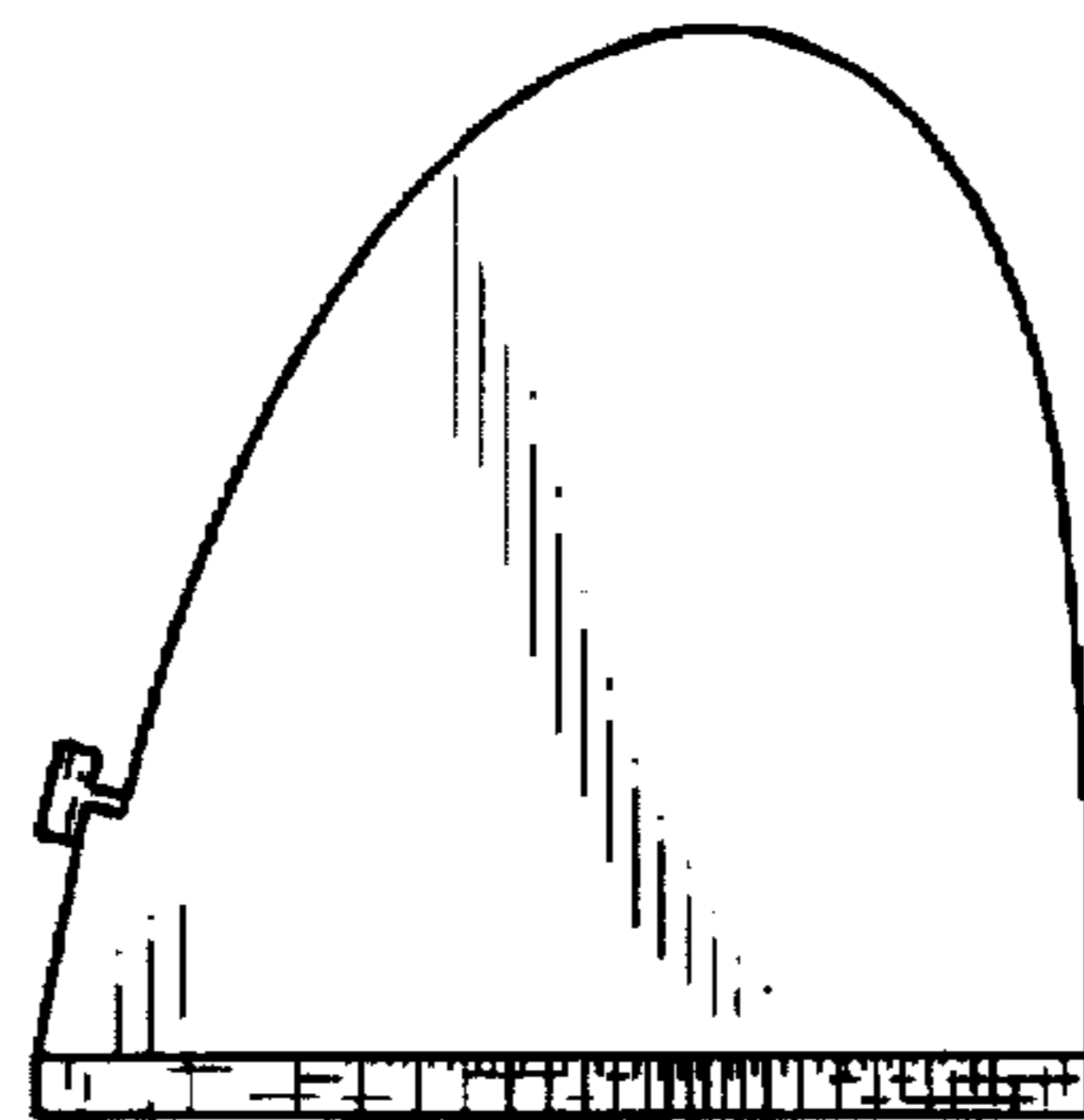

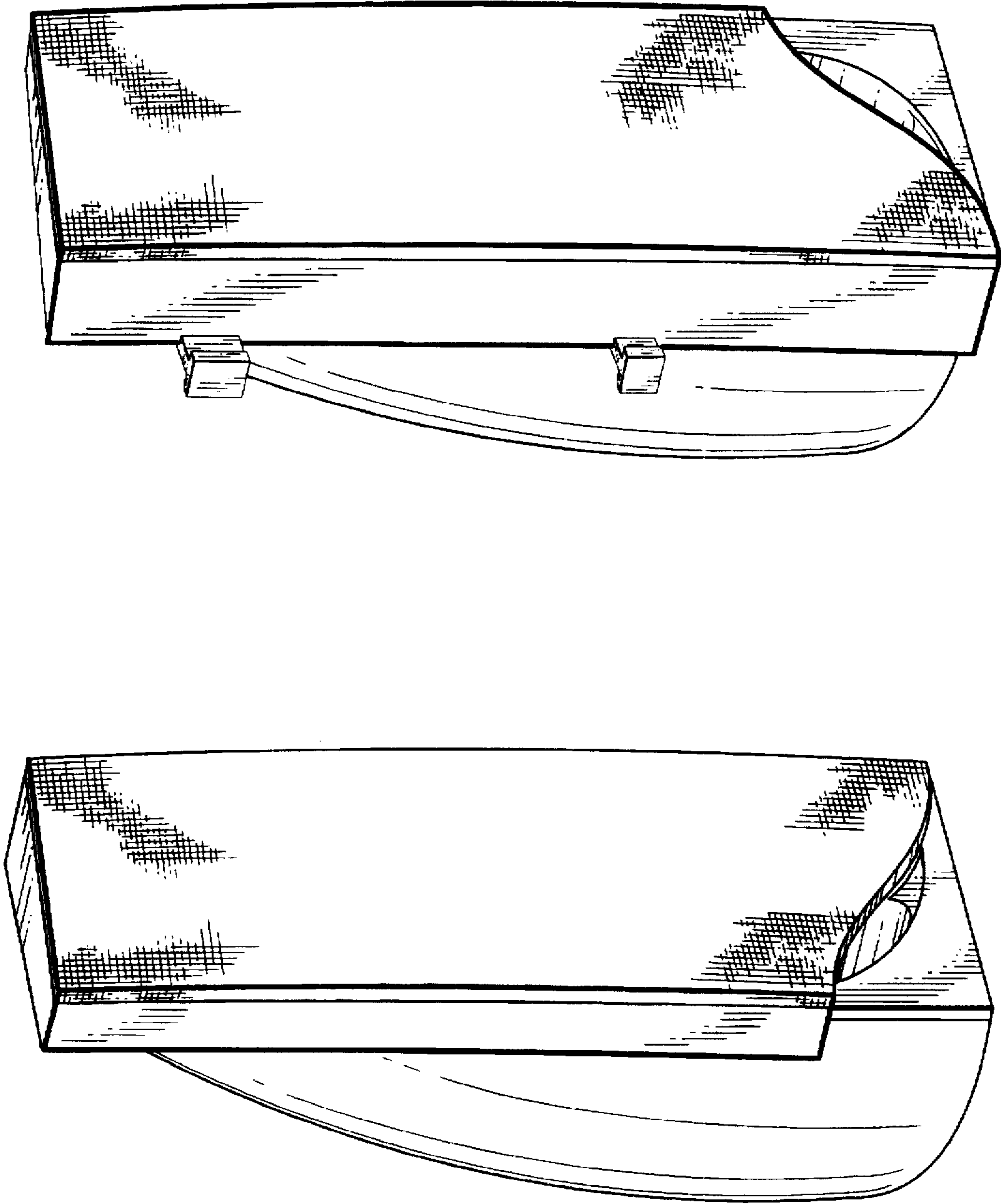
