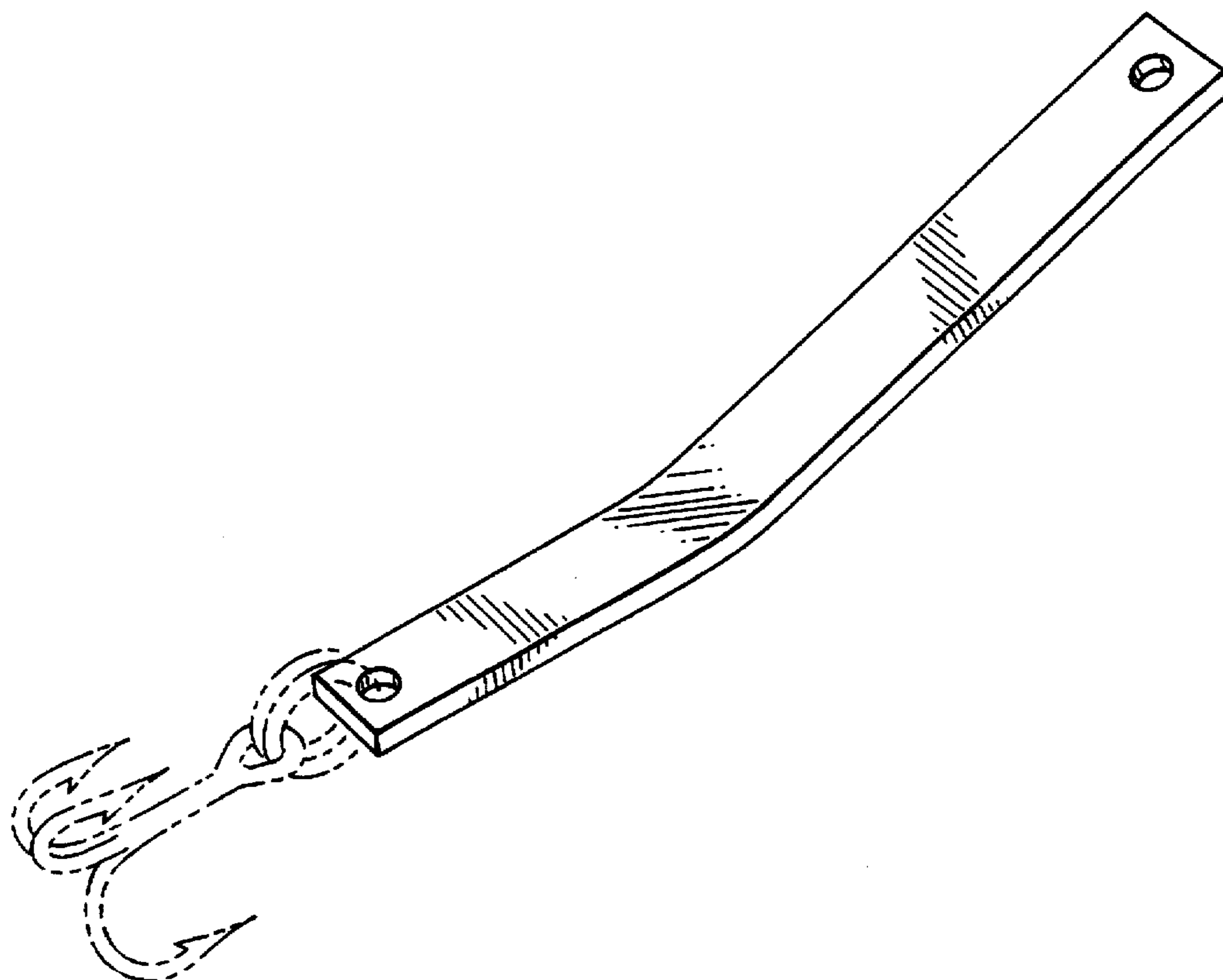
[57] **CLAIM**

The ornamental design for a fishing spoon, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a fishing spoon, showing our new design;  
FIG. 2 is a bottom perspective view of the fishing spoon illustrated in FIG. 1;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a front end elevational view thereof; and,  
FIG. 6 is a rear end elevational view thereof;  
FIG. 7 is a left side elevational view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken line disclosure of a fish hook and ring to which the present fishing spoon is attached, is for illustration purposes only and forms no part of the present design.

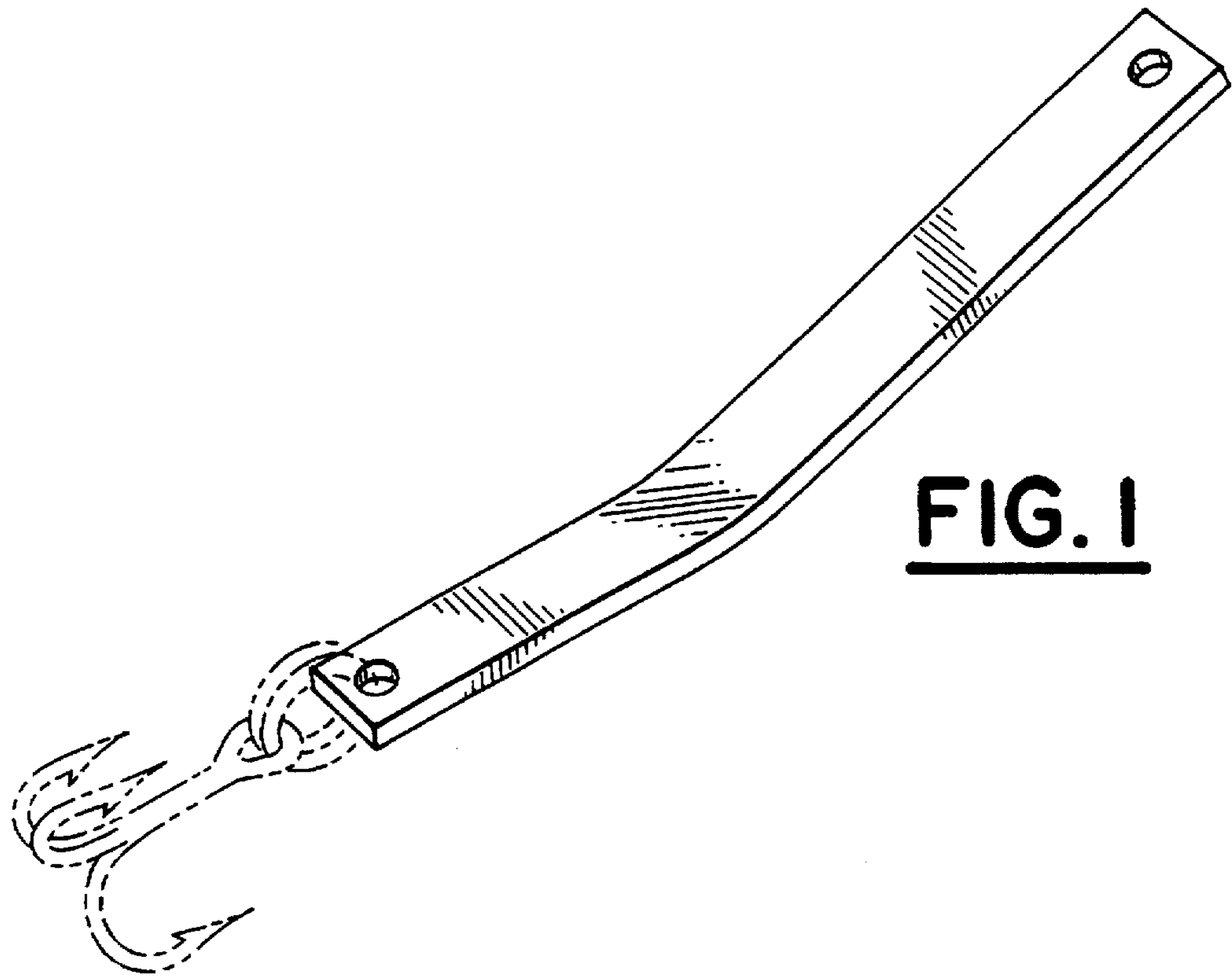

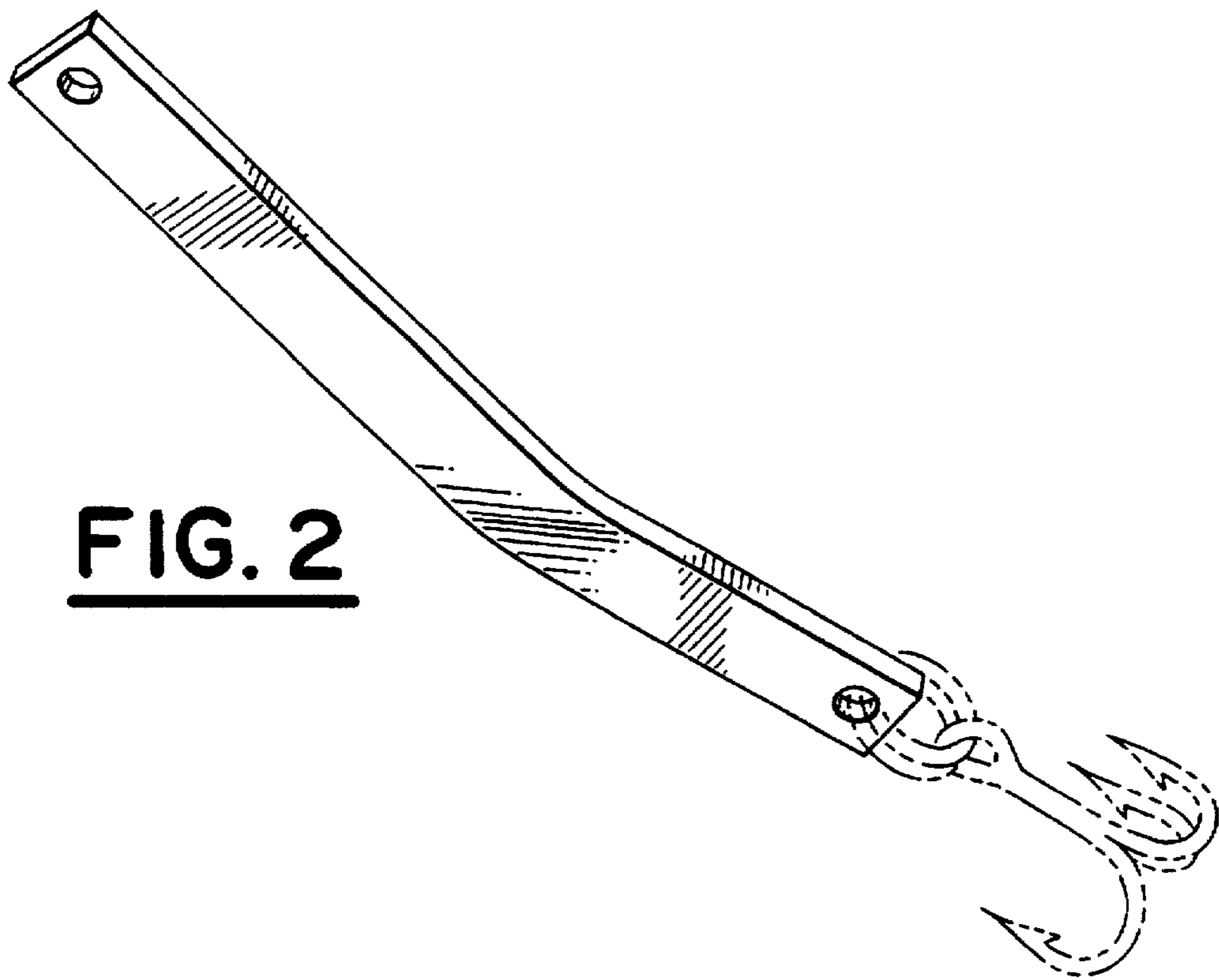
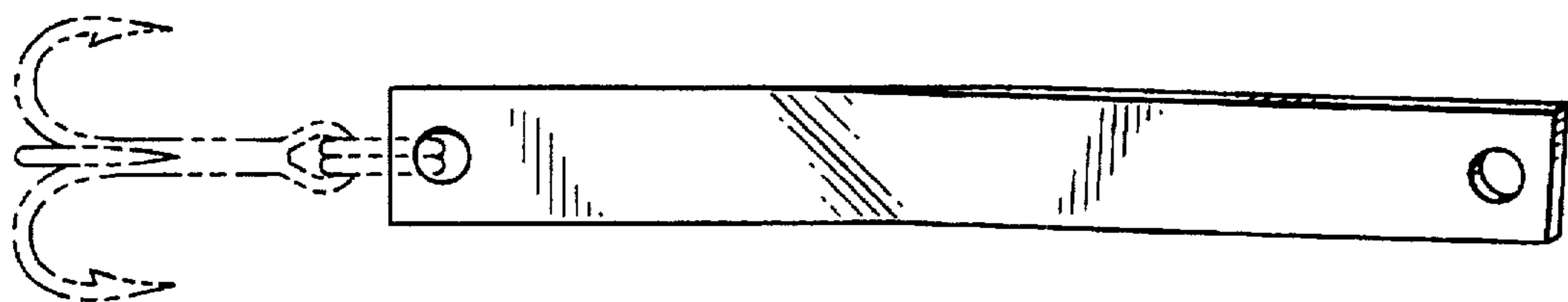


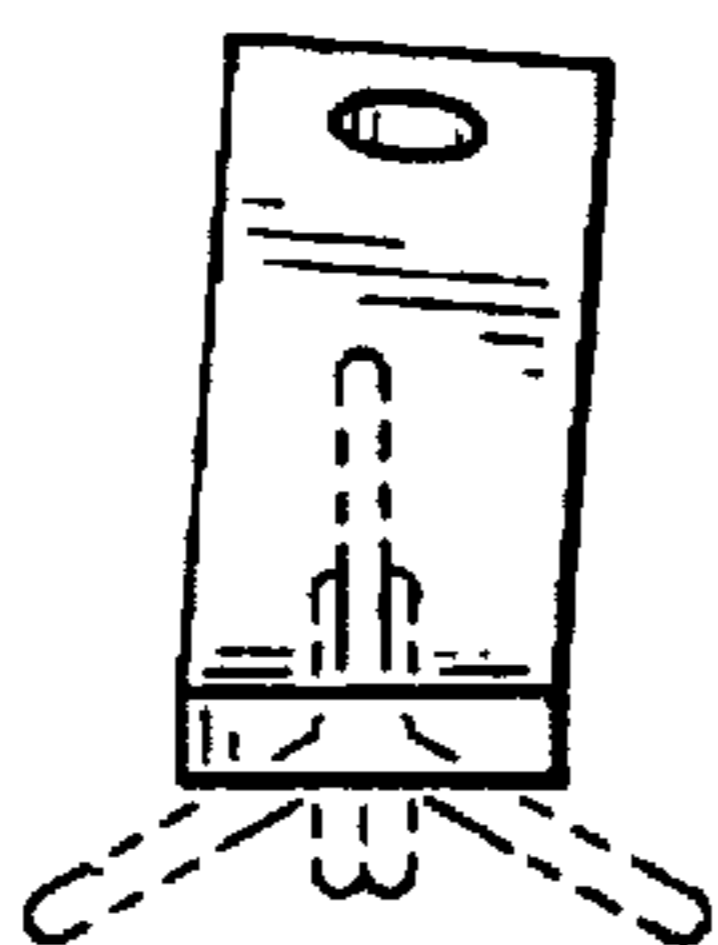

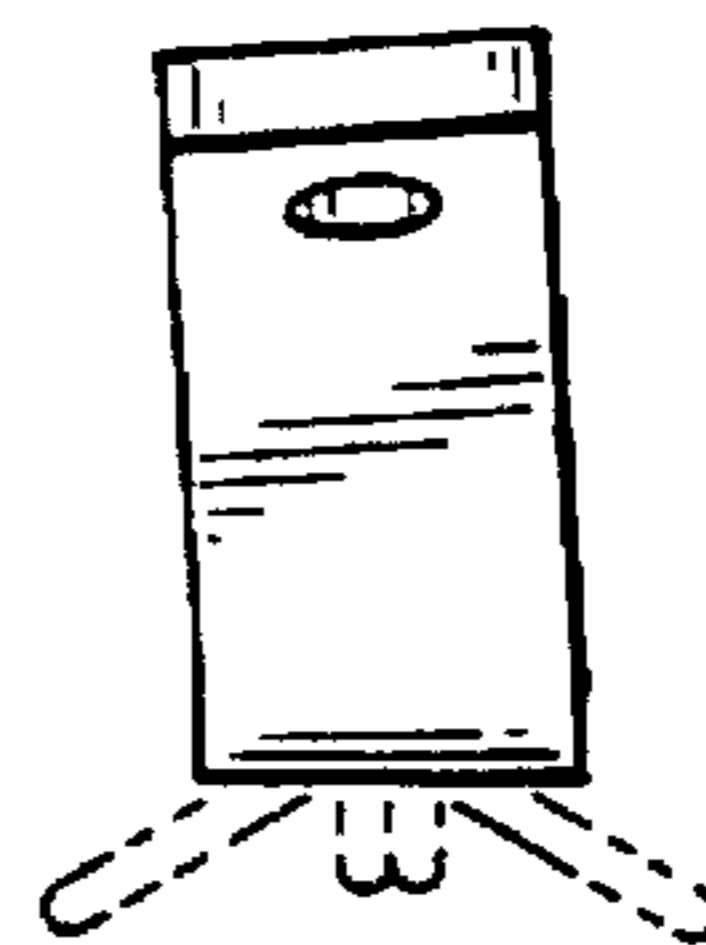

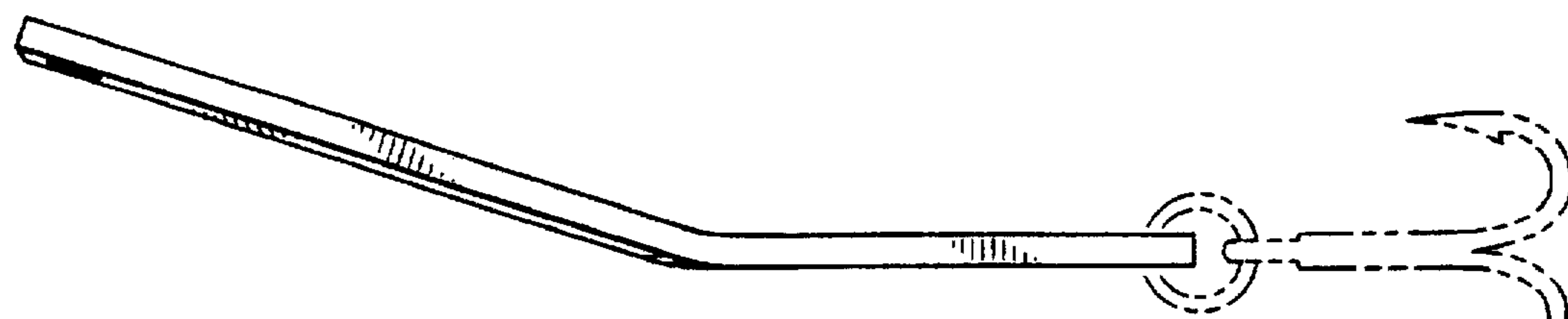

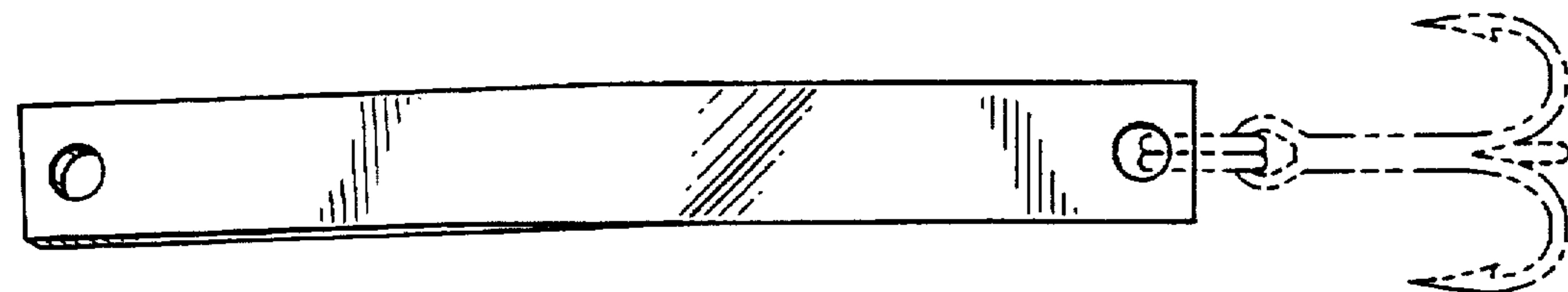
