[57] **CLAIM**

The ornamental design for a combined breathable gas container and carrying harness for a self-contained breathing apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the combined breathable gas container and carrying harness for a self-contained breathing apparatus embodying my new design;

FIG. 2 is a rear perspective view of the combined breathable gas container and carrying harness for a self-contained breathing apparatus shown in FIG. 1;

FIG. 3 is a rear view of the combined breathable gas container and carrying harness a self-contained breathing apparatus shown in FIG. 1;

FIG. 4 is a top view of the combined breathable gas container and carrying harness for a self-contained breathing apparatus shown in FIG. 1;

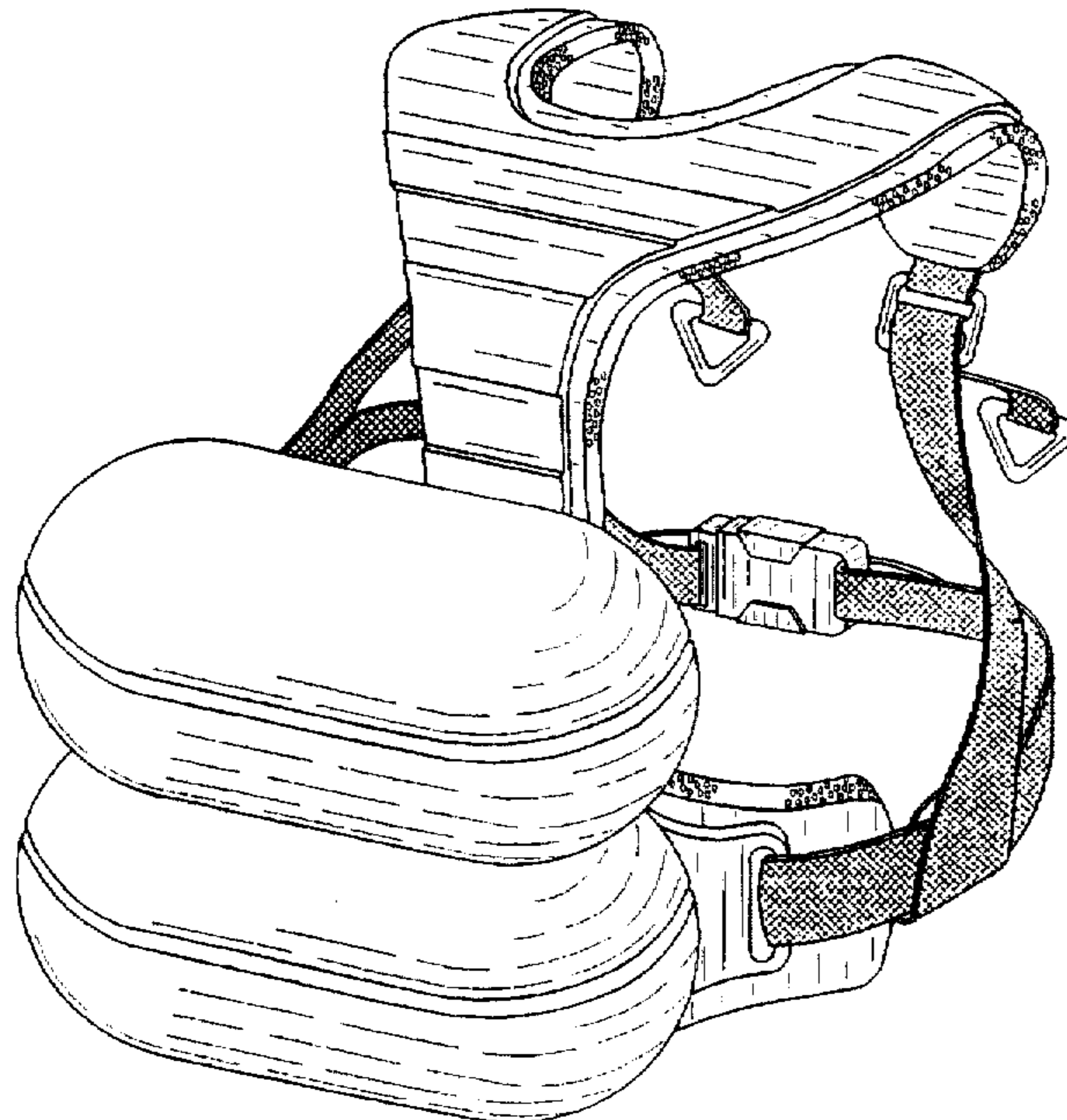
FIG. 5 is a side view of the combined breathable gas container and carrying harness for a self-contained breathing apparatus shown in FIG. 1;

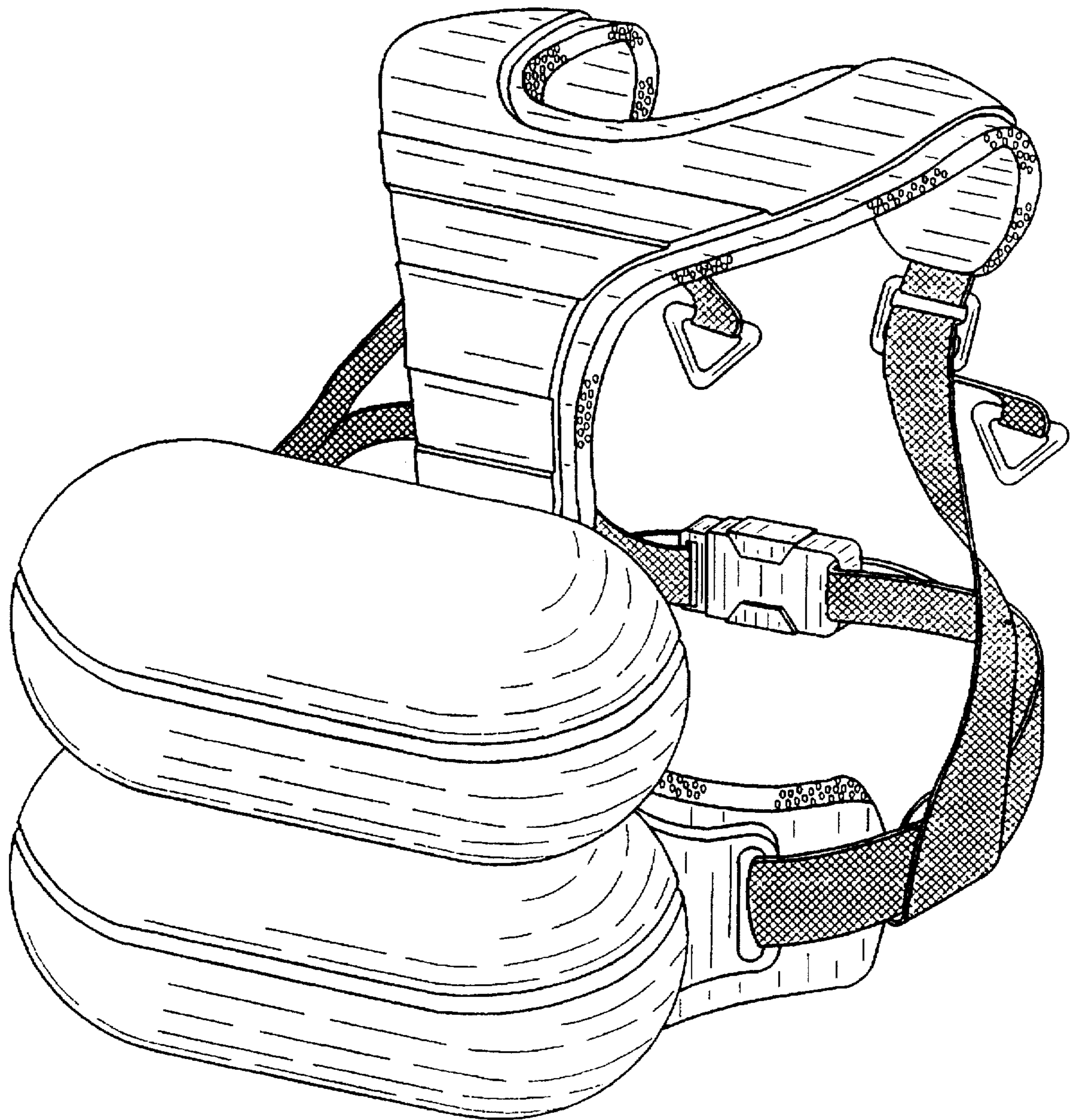
FIG. 6 is a front view of the combined breathable gas container and carrying harness for a self-contained breathing apparatus shown in FIG. 1;

FIG. 7 is a bottom view of the combined breathable gas container and carrying harness for a self-contained breathing apparatus shown in FIG. 1; and,

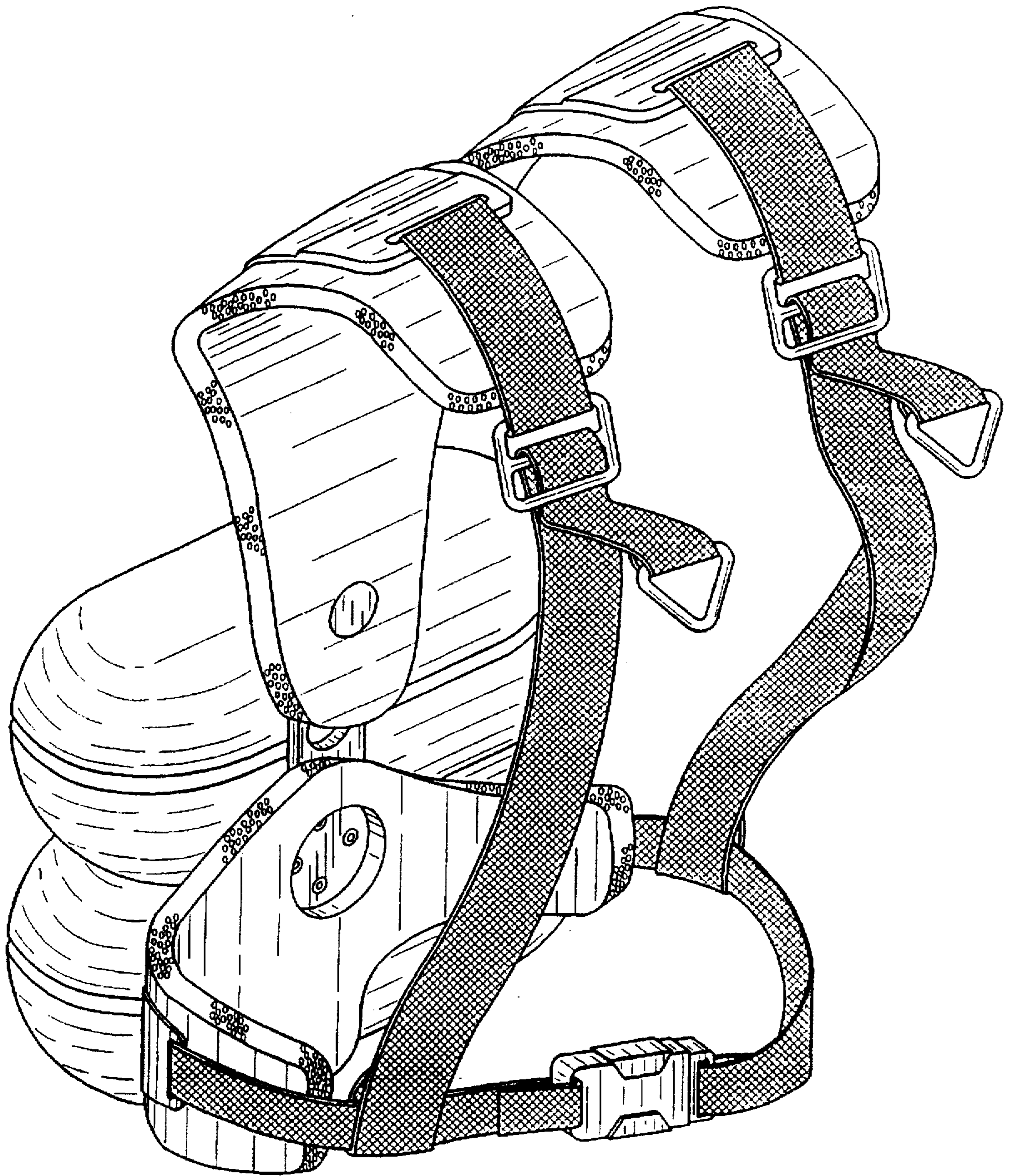

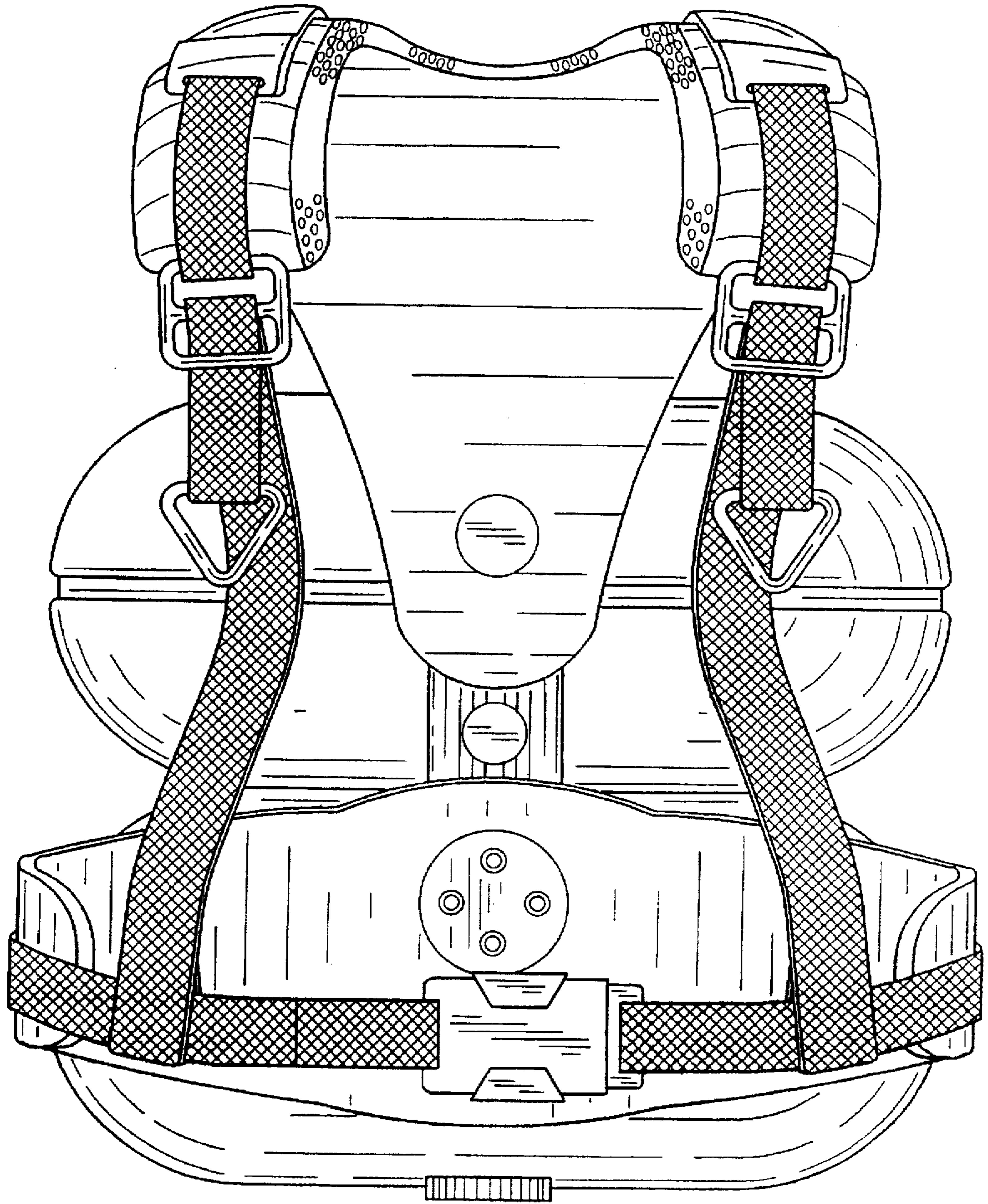




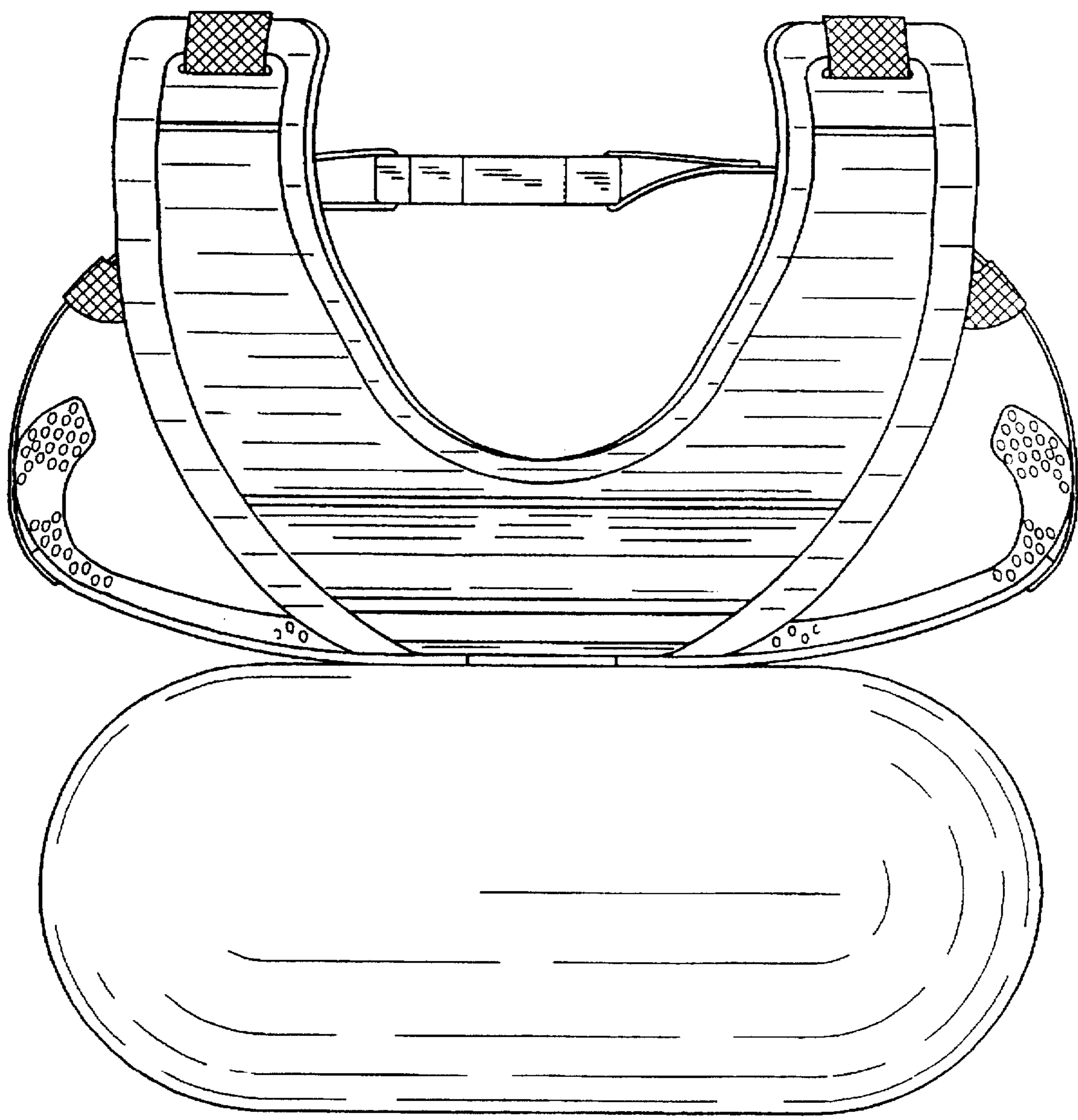

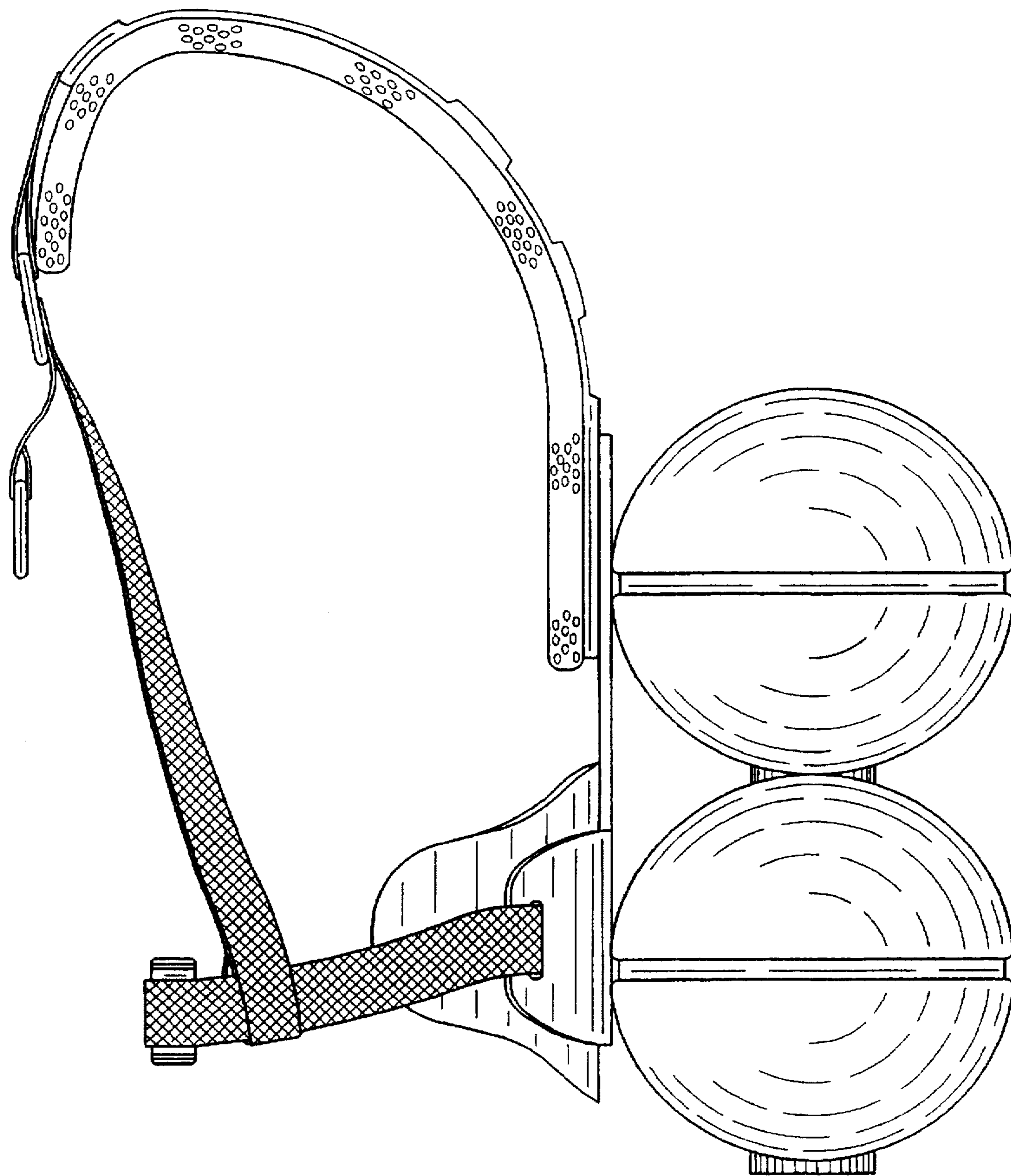
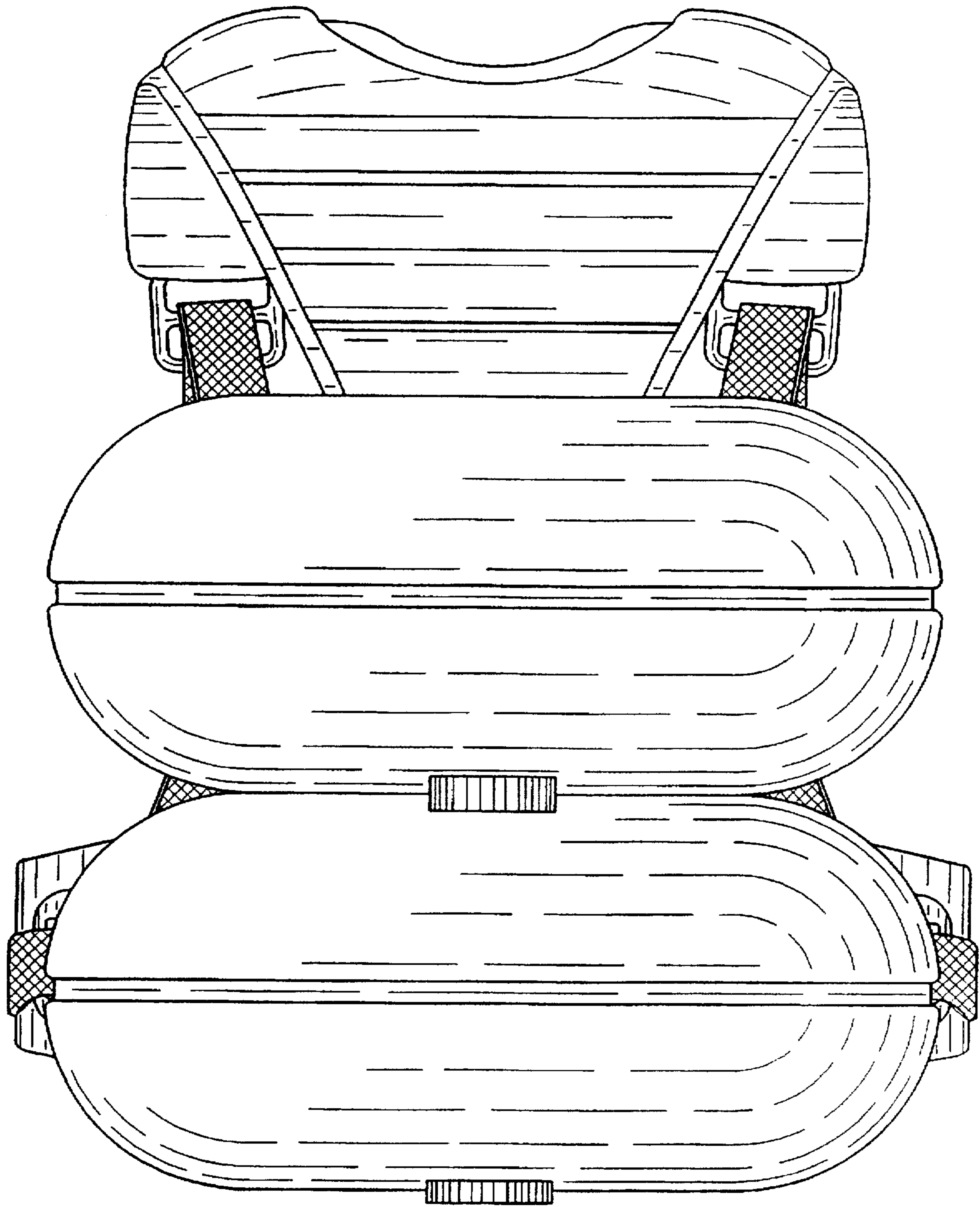

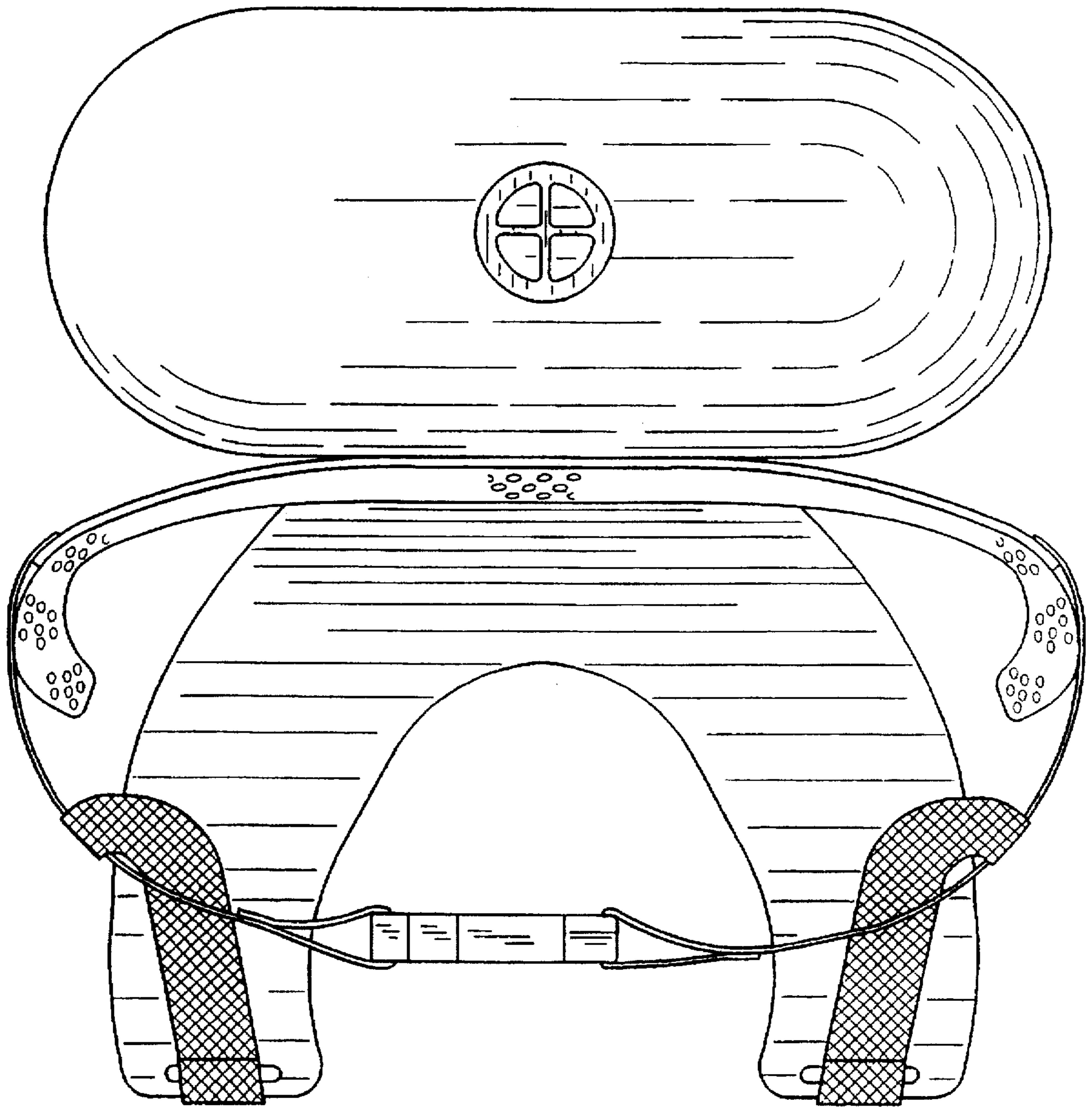
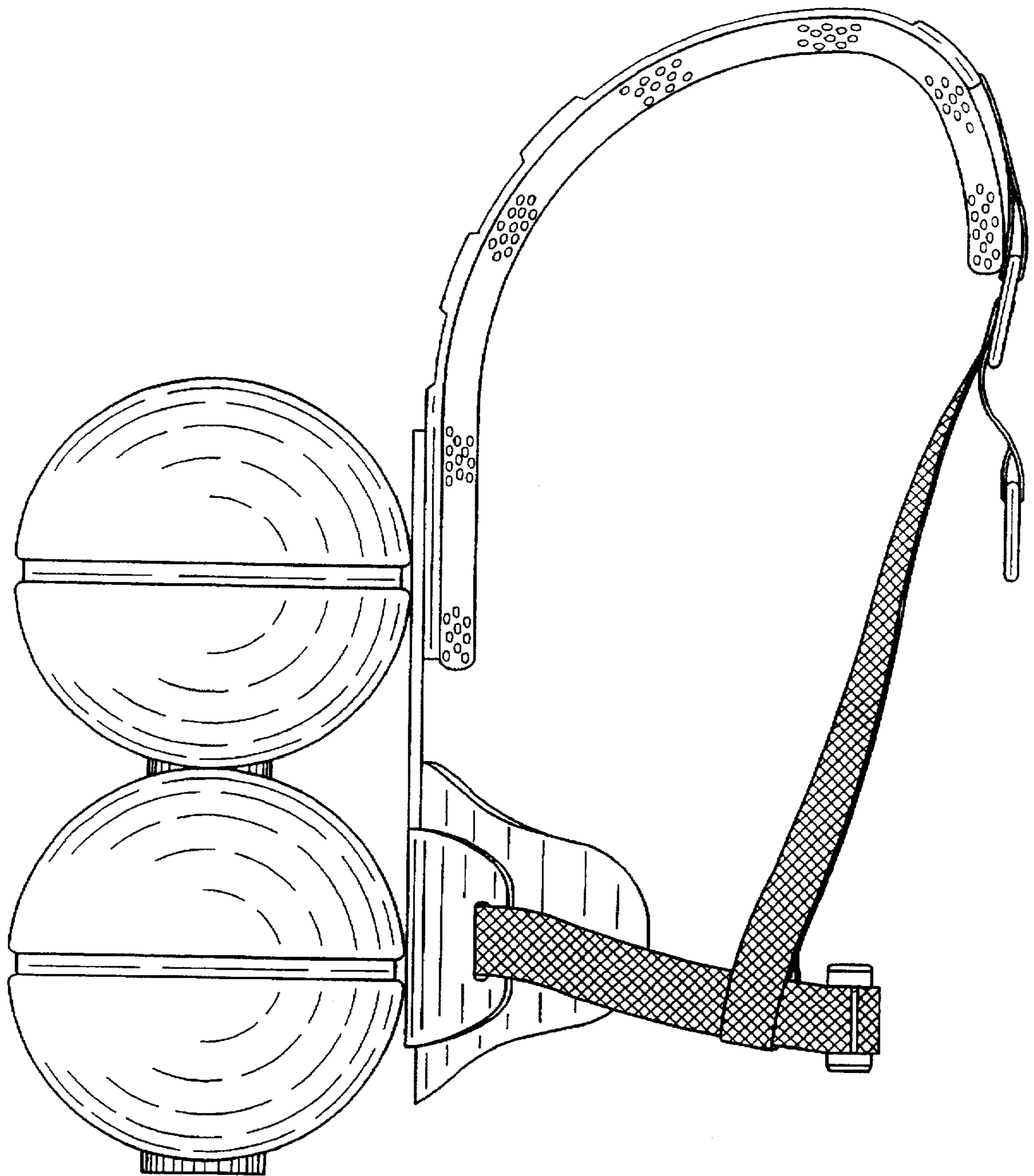
