The ornamental design for a cup dispenser, as shown and  
described.

### DESCRIPTION

FIG. 1 is a front elevational view of a cup dispenser showing  
our new design;  
FIG. 2 is a right side elevational view thereof, the undis-  
closed left side being a mirror image;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.

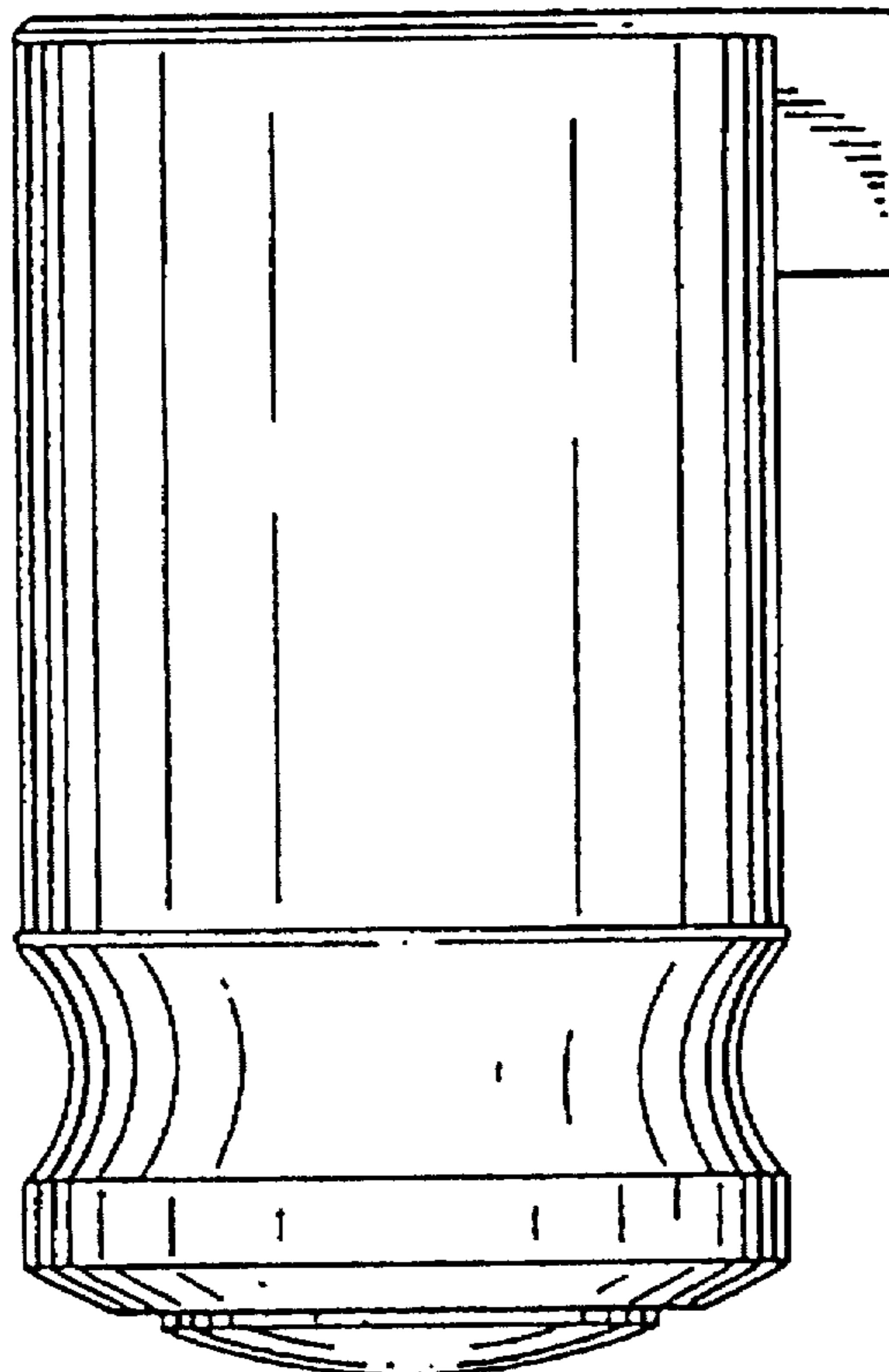

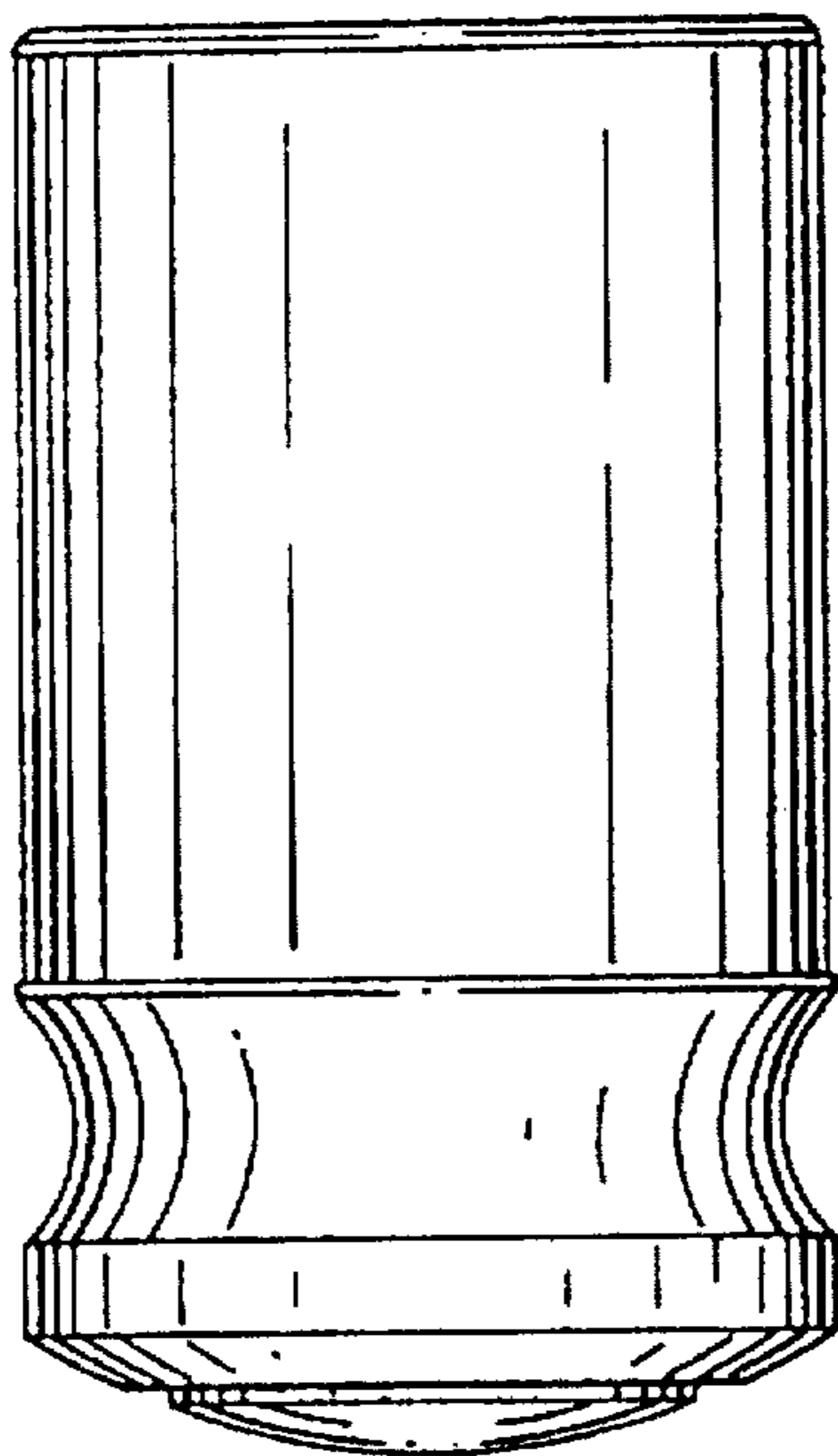

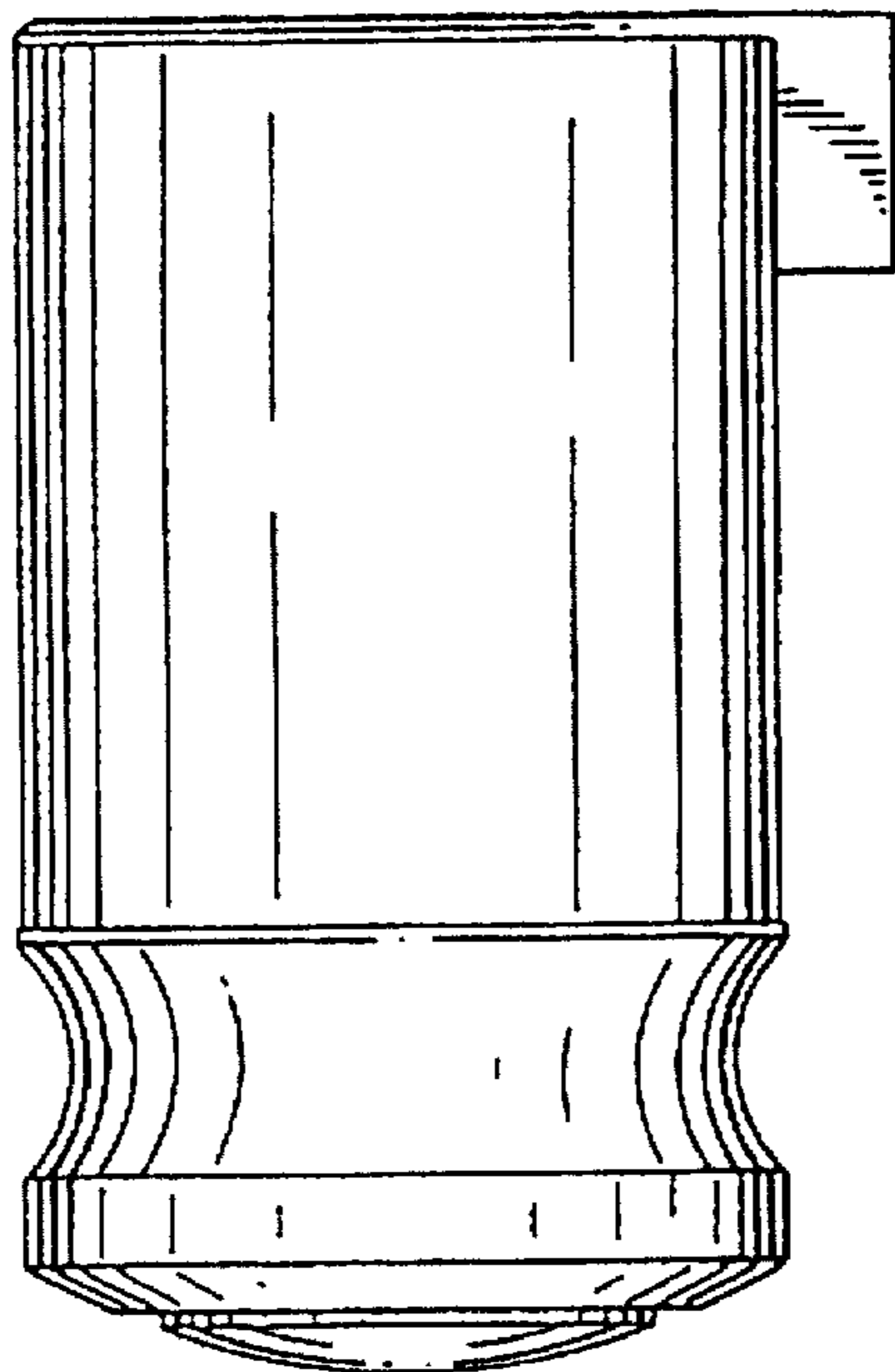

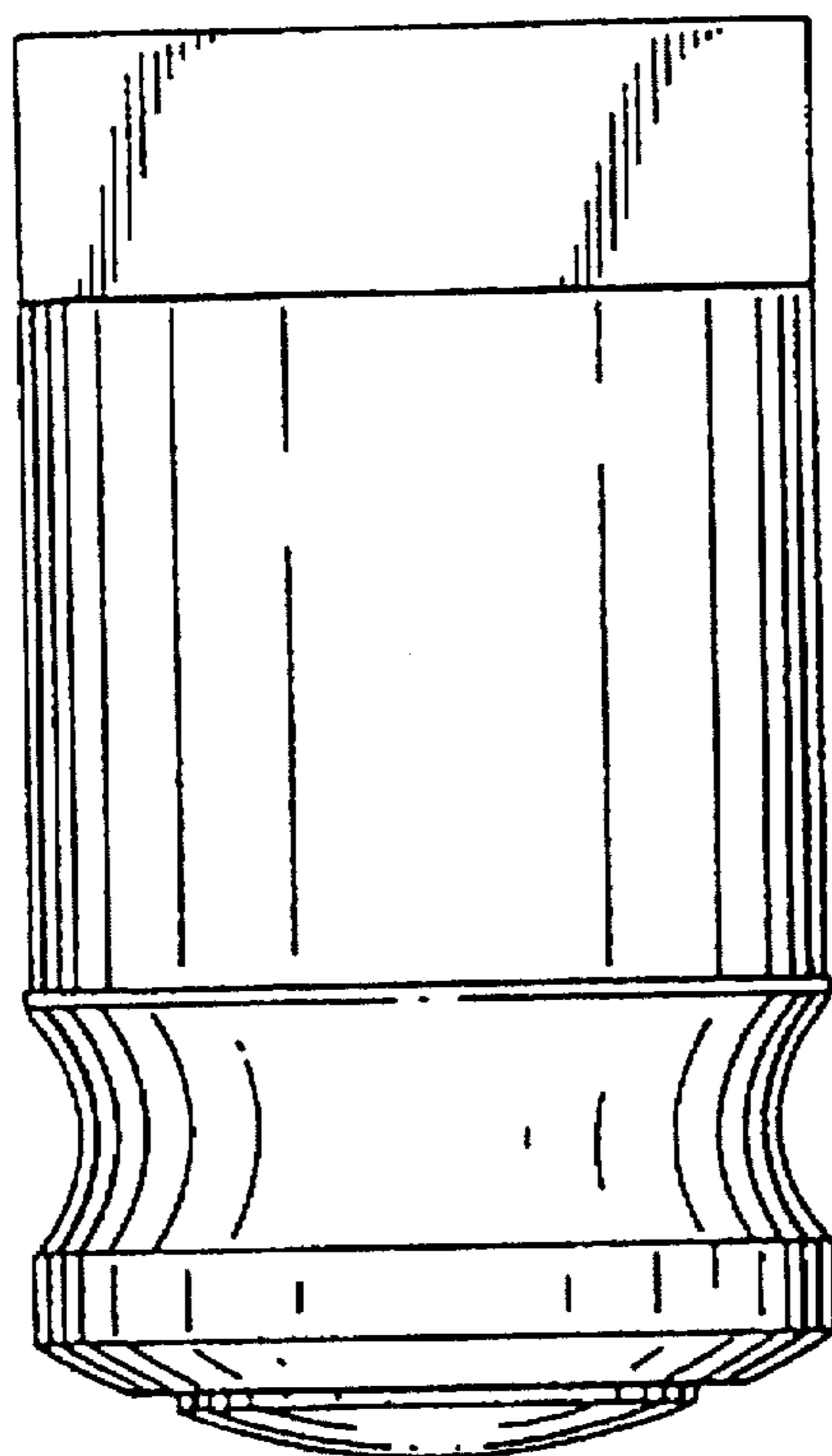

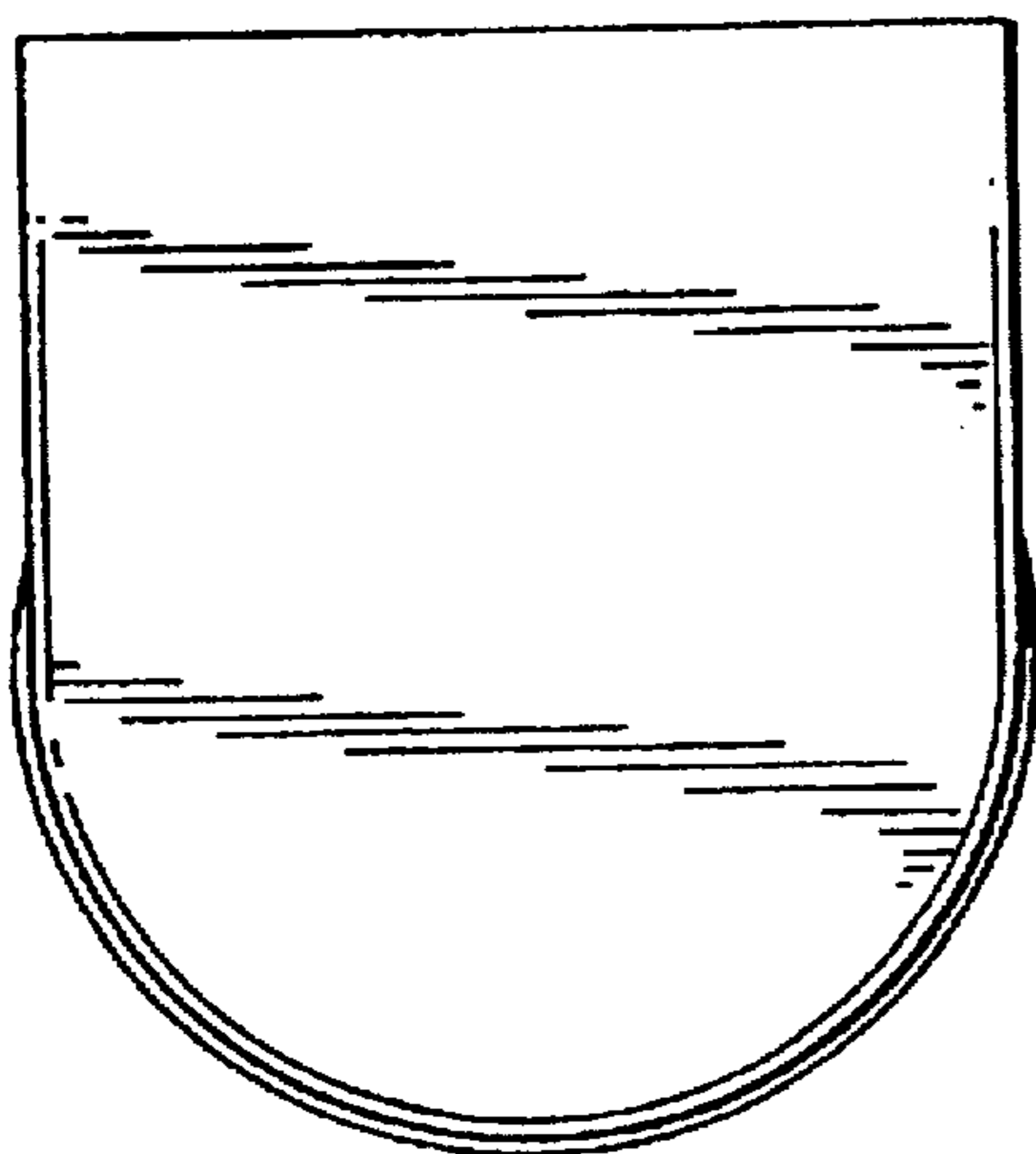
