The ornamental design for a coffee/tea mug, as shown and described.

DESCRIPTION

FIG. 1 is an oblique perspective view of the coffee/tea mug; FIG. 2 is a right side view of the coffee/tea mug, as shown in FIG. 1;

FIG. 3 is a left side view of the coffee/tea mug;

FIG. 4 is a front side view of the coffee/tea mug;

FIG. 5 is a back side view of the coffee/tea mug;

FIG. 6 is a top view of the coffee/tea mug; and,

FIG. 7 is a bottom view of the coffee/tea mug.

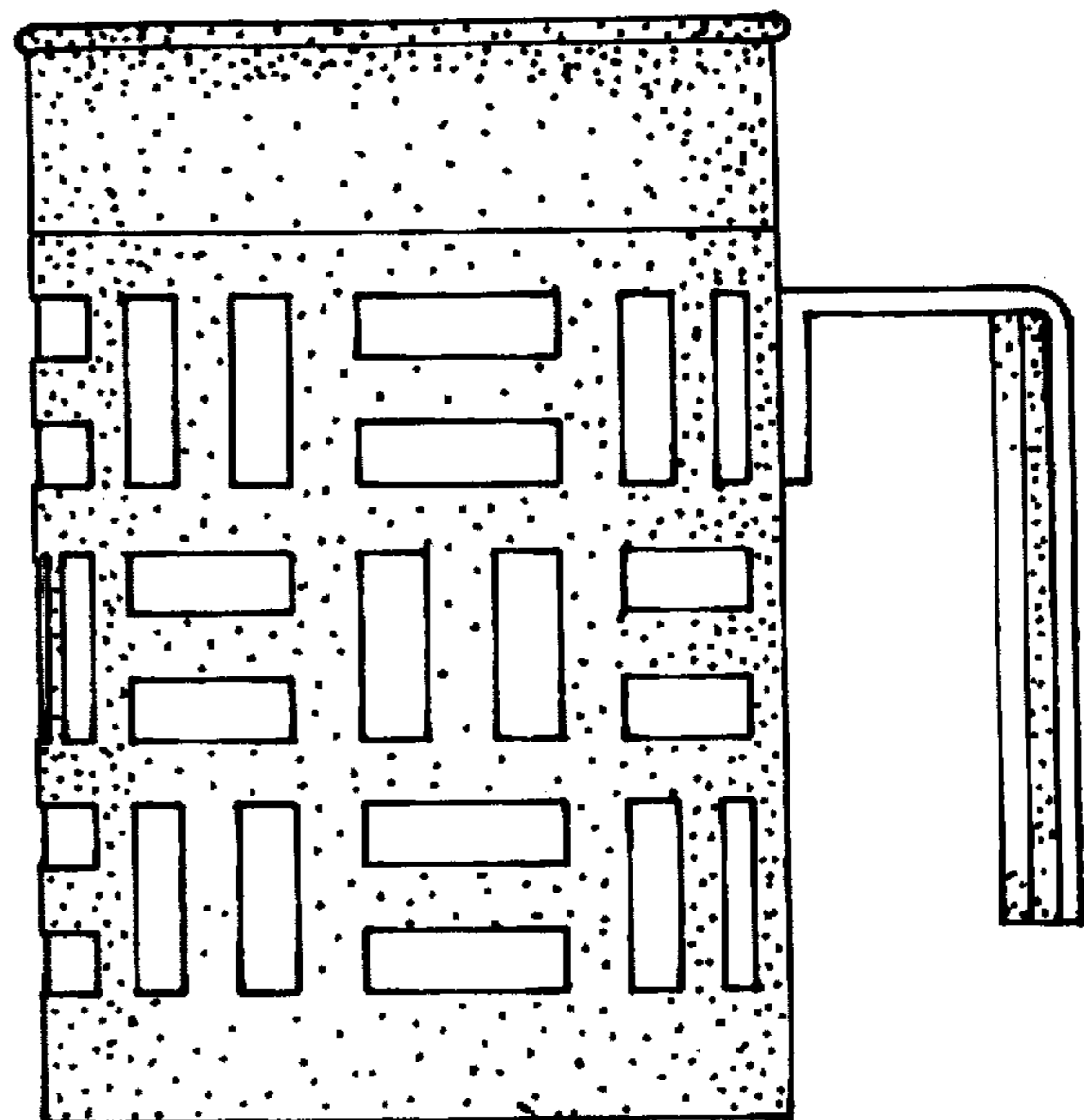
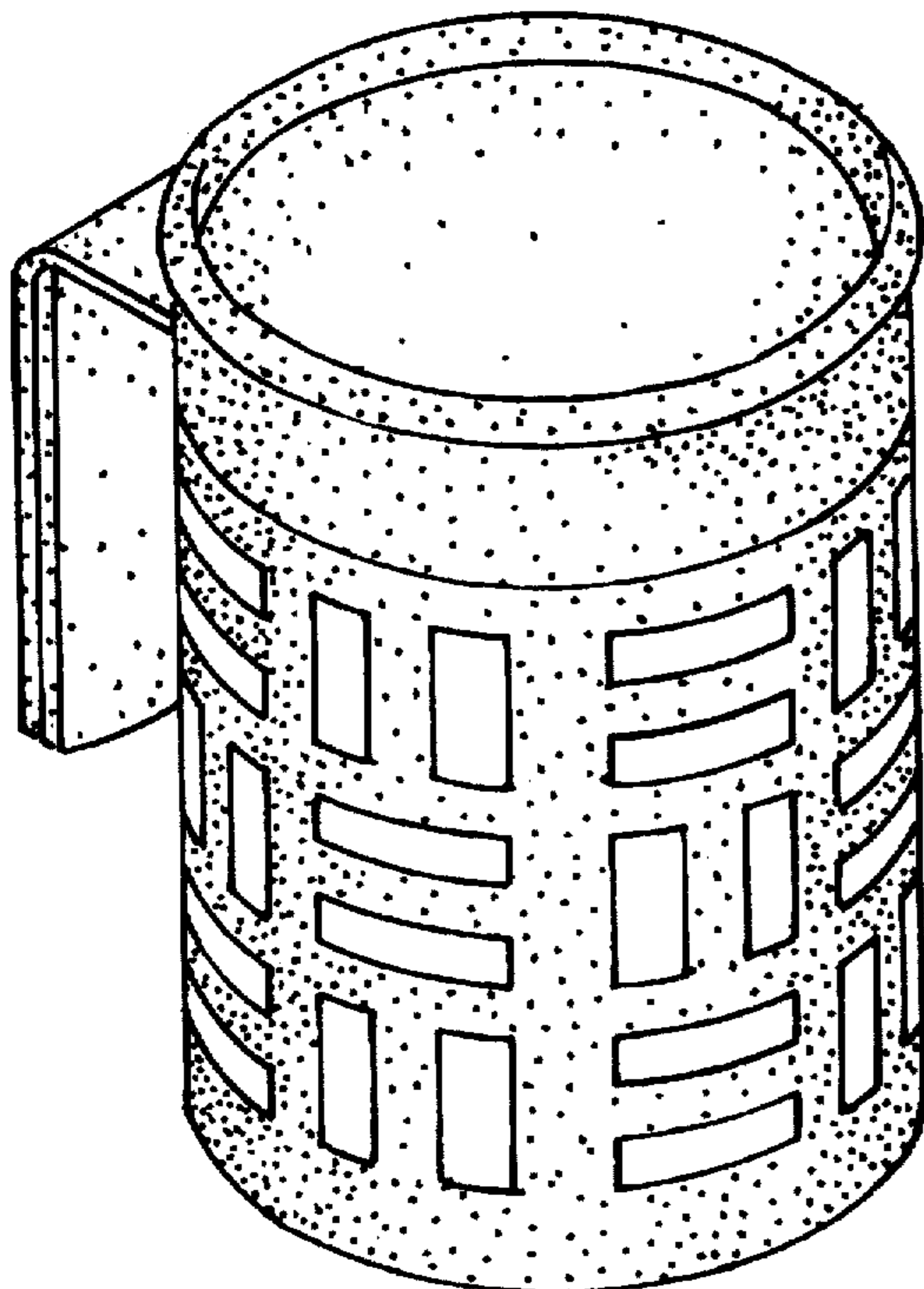

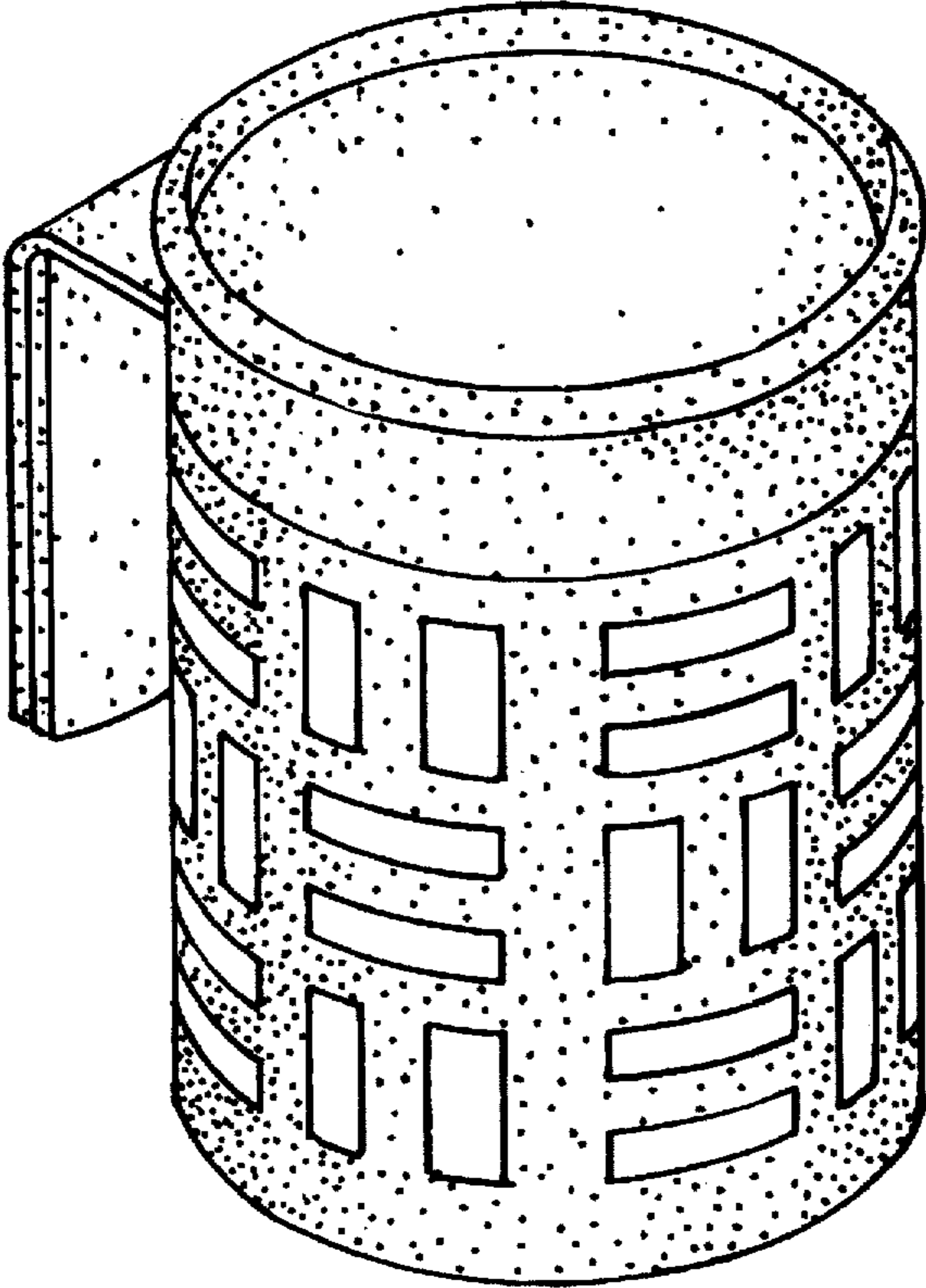
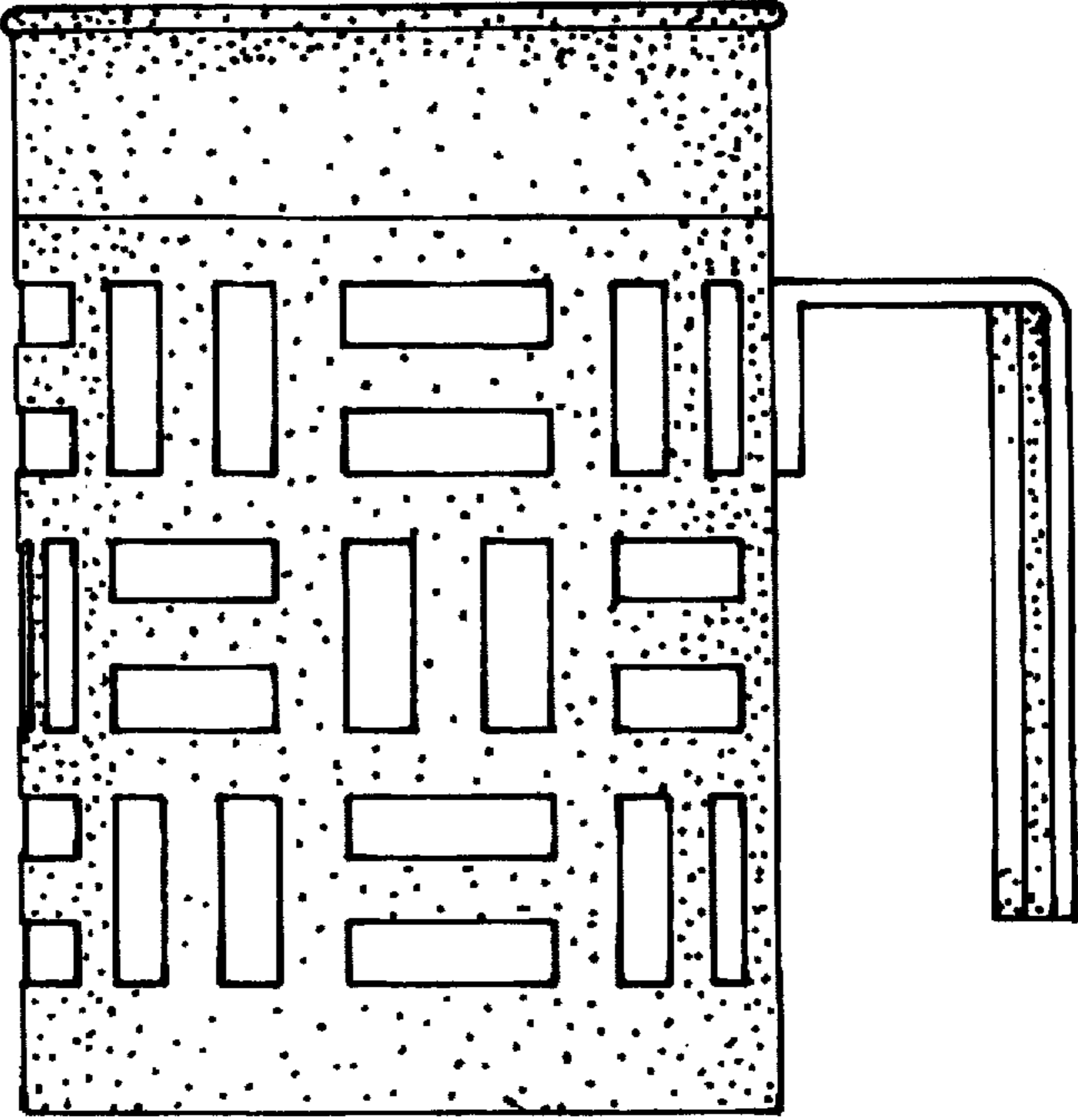

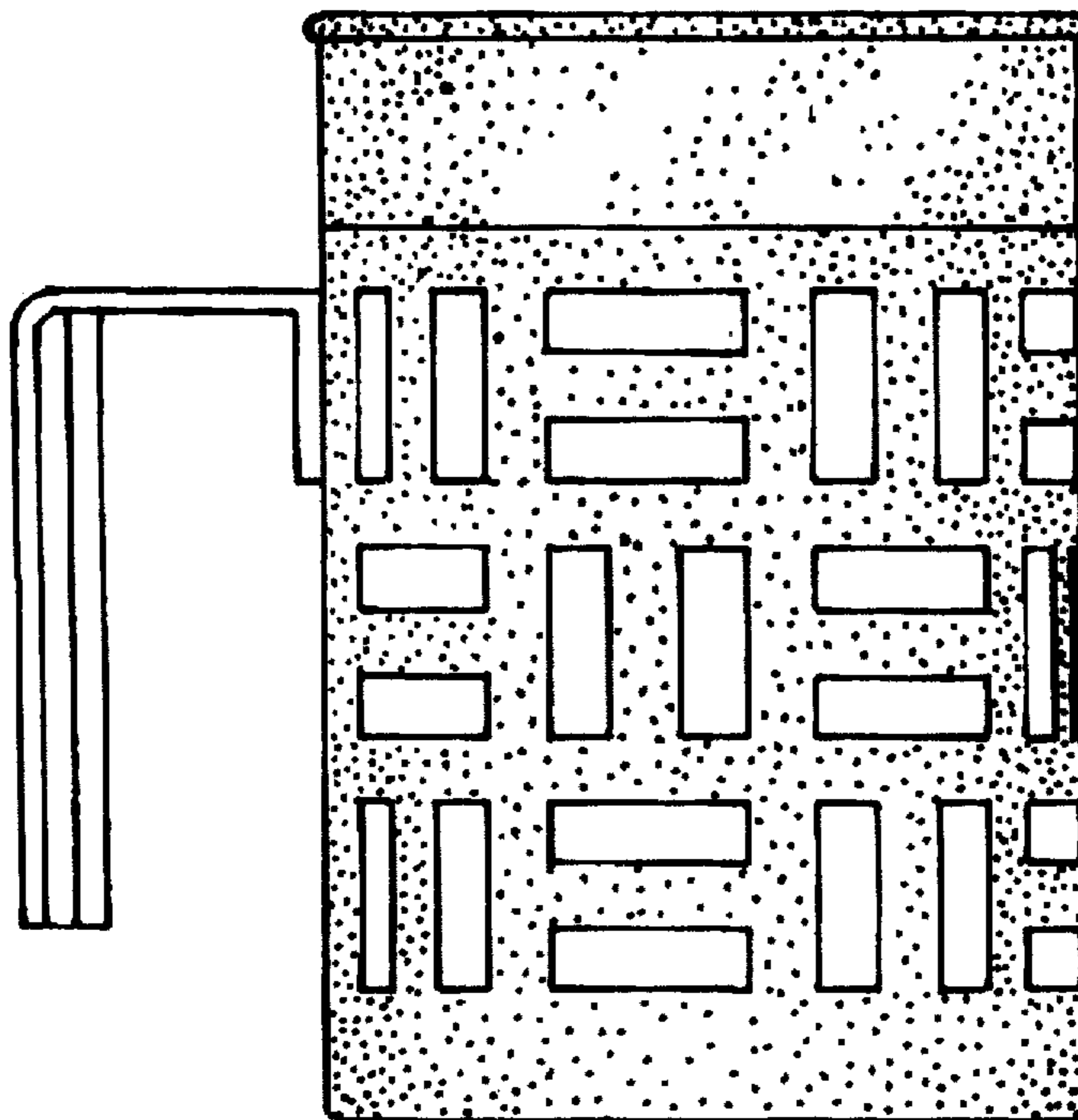

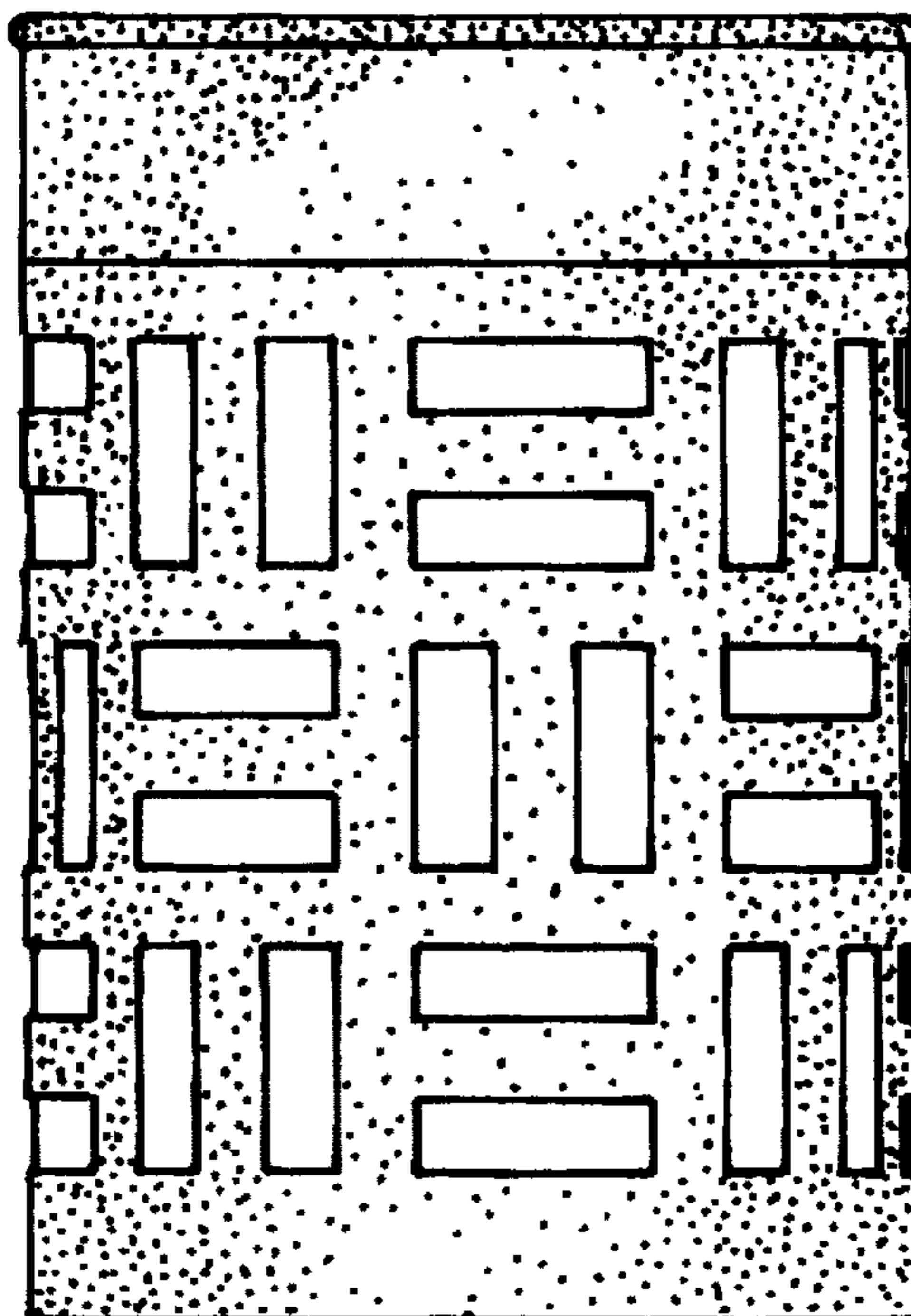

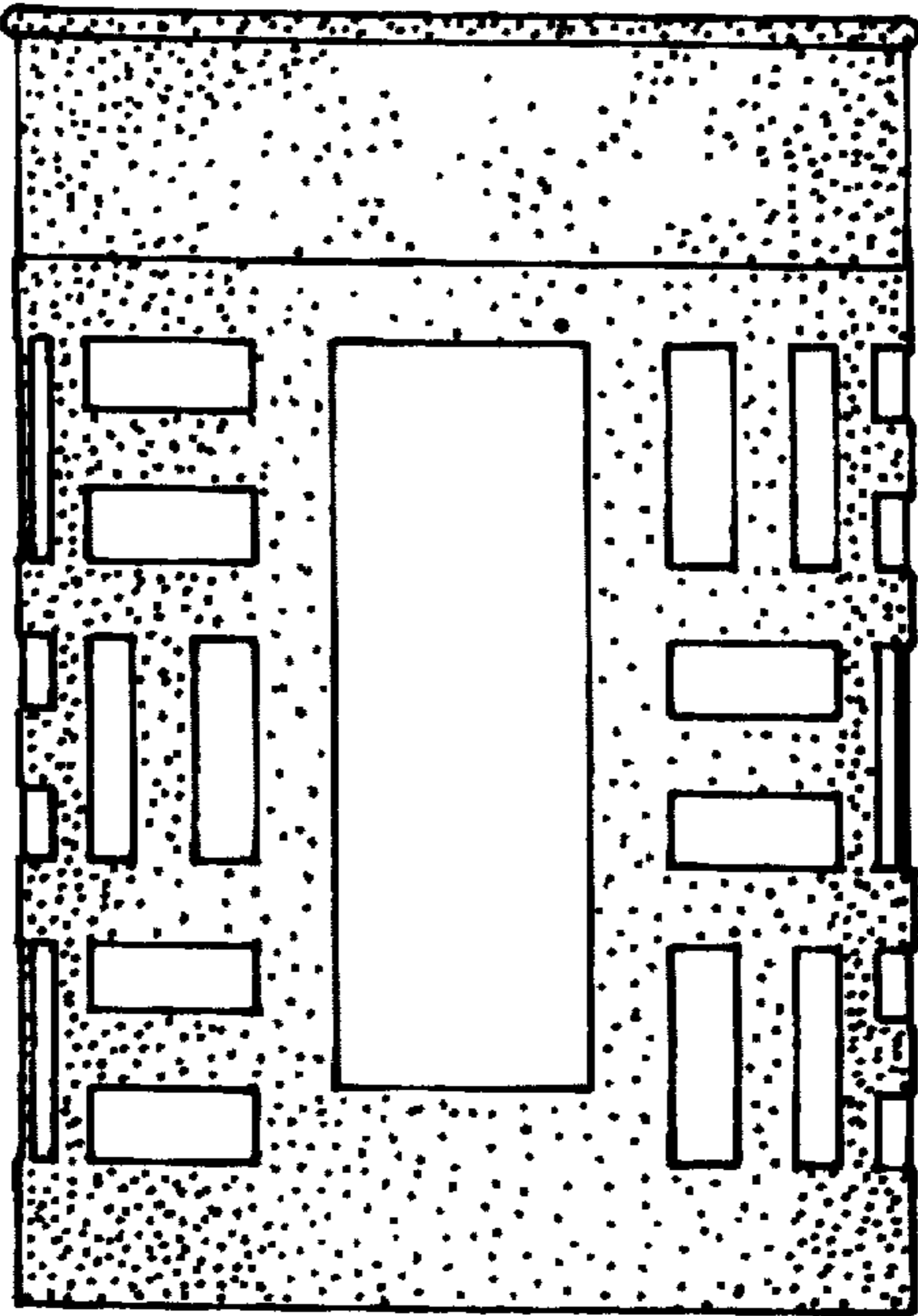

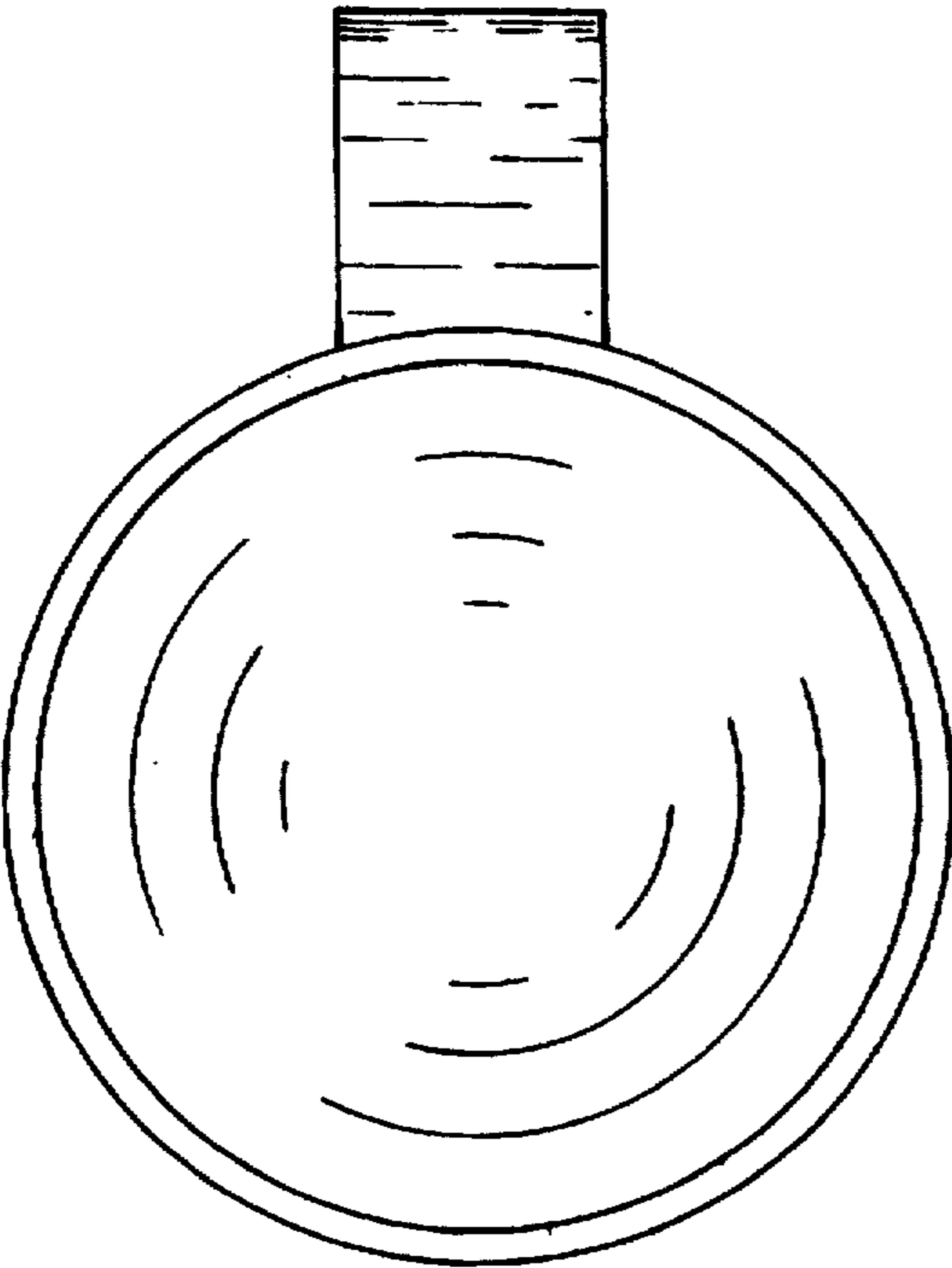
