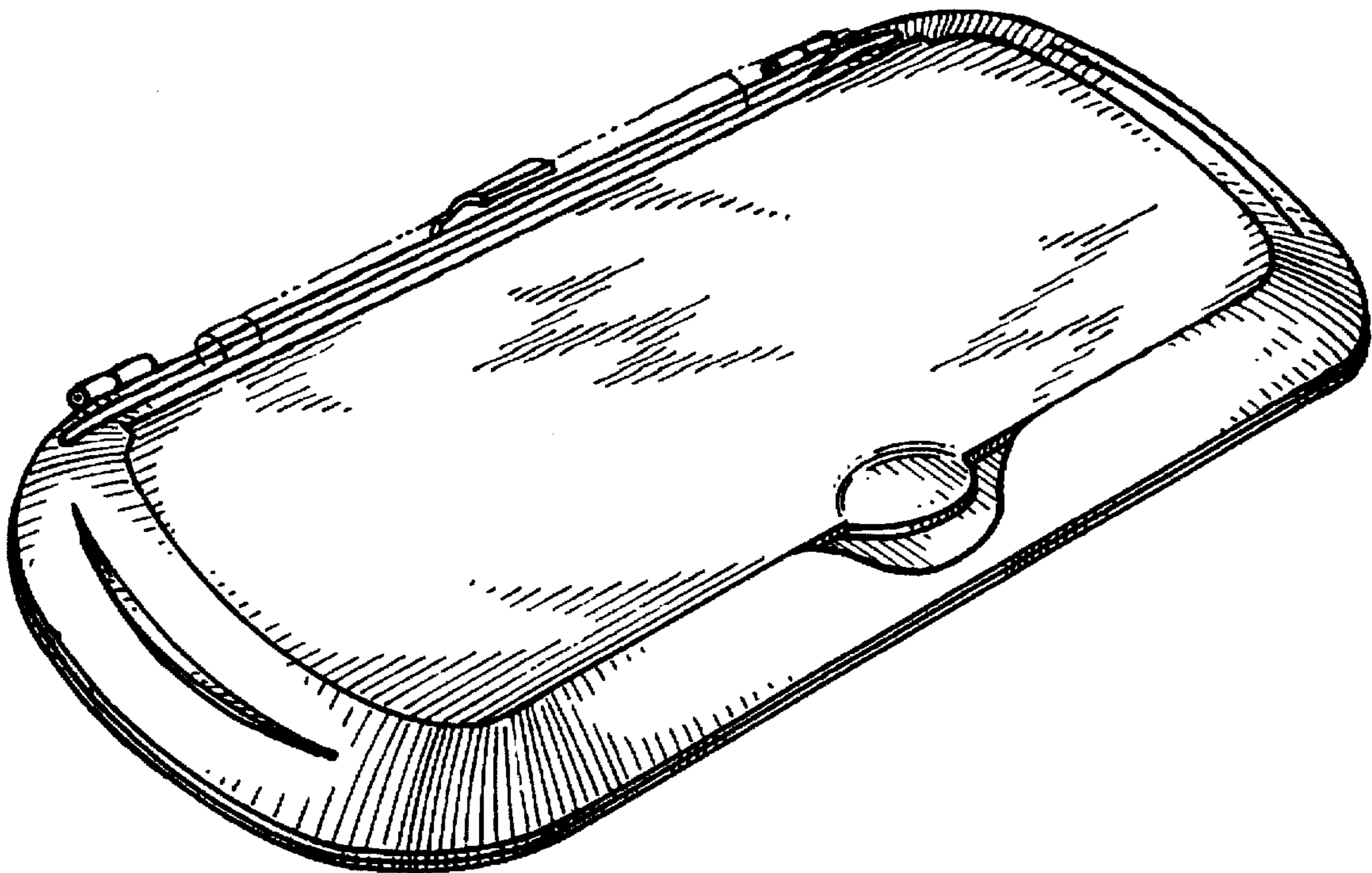
[57] **CLAIM**

The ornamental design for an lighted visor mirror, as shown and described.

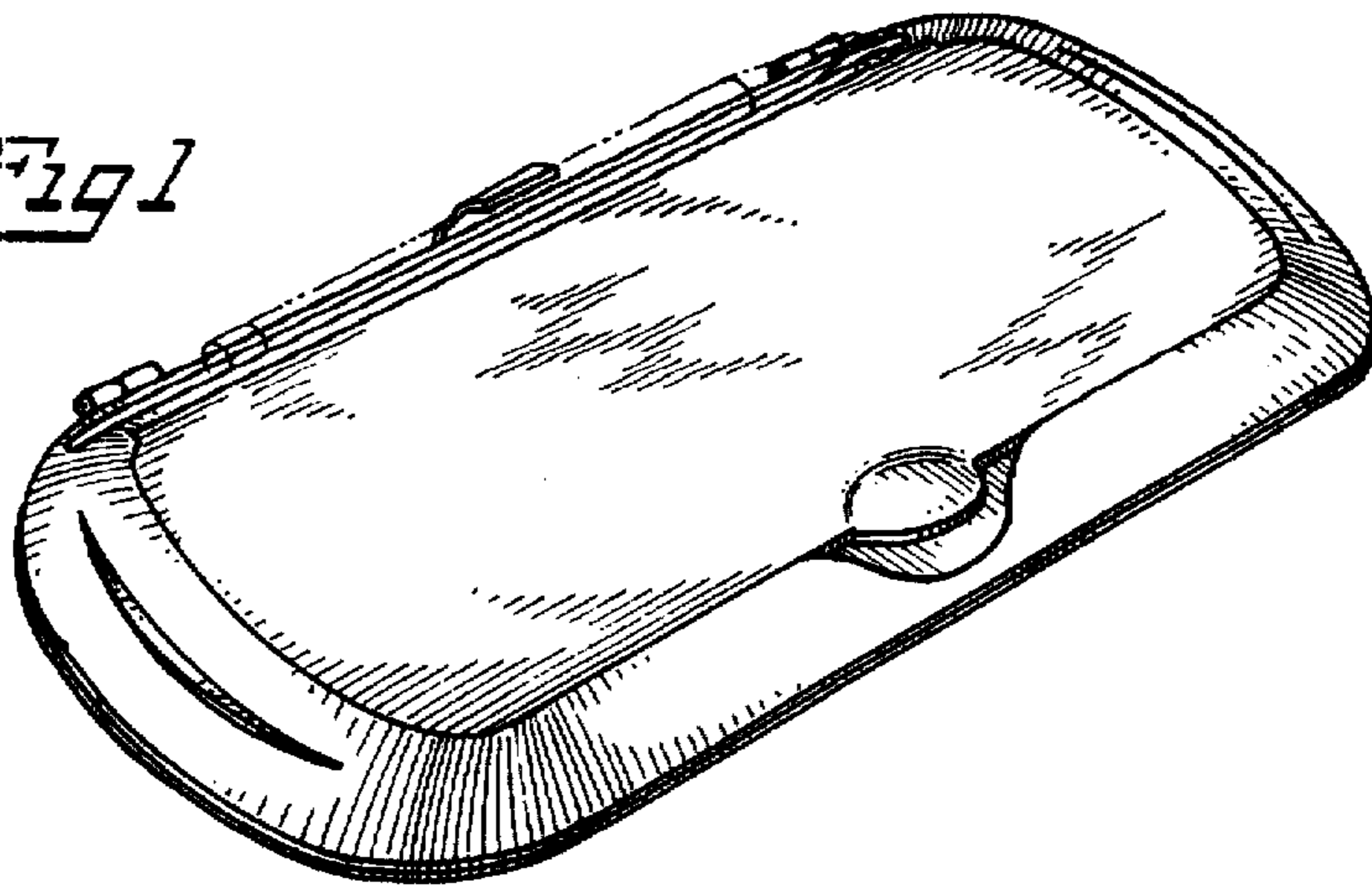
**DESCRIPTION**

FIG. 1 is a perspective view of the lighted visor mirror showing a new ornamental design therefor;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a back elevational view thereof;  
FIG. 7 is a top perspective view thereof, showing the cover in the open position;  
FIG. 8 is a top plan view thereof, showing the cover in the open position;  
FIG. 9 is a front elevational view thereof, showing the cover in the open position; and,  
FIG. 10 is a right side elevational view thereof, showing the cover in the open position.  
The broken line showing of a writing instrument in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

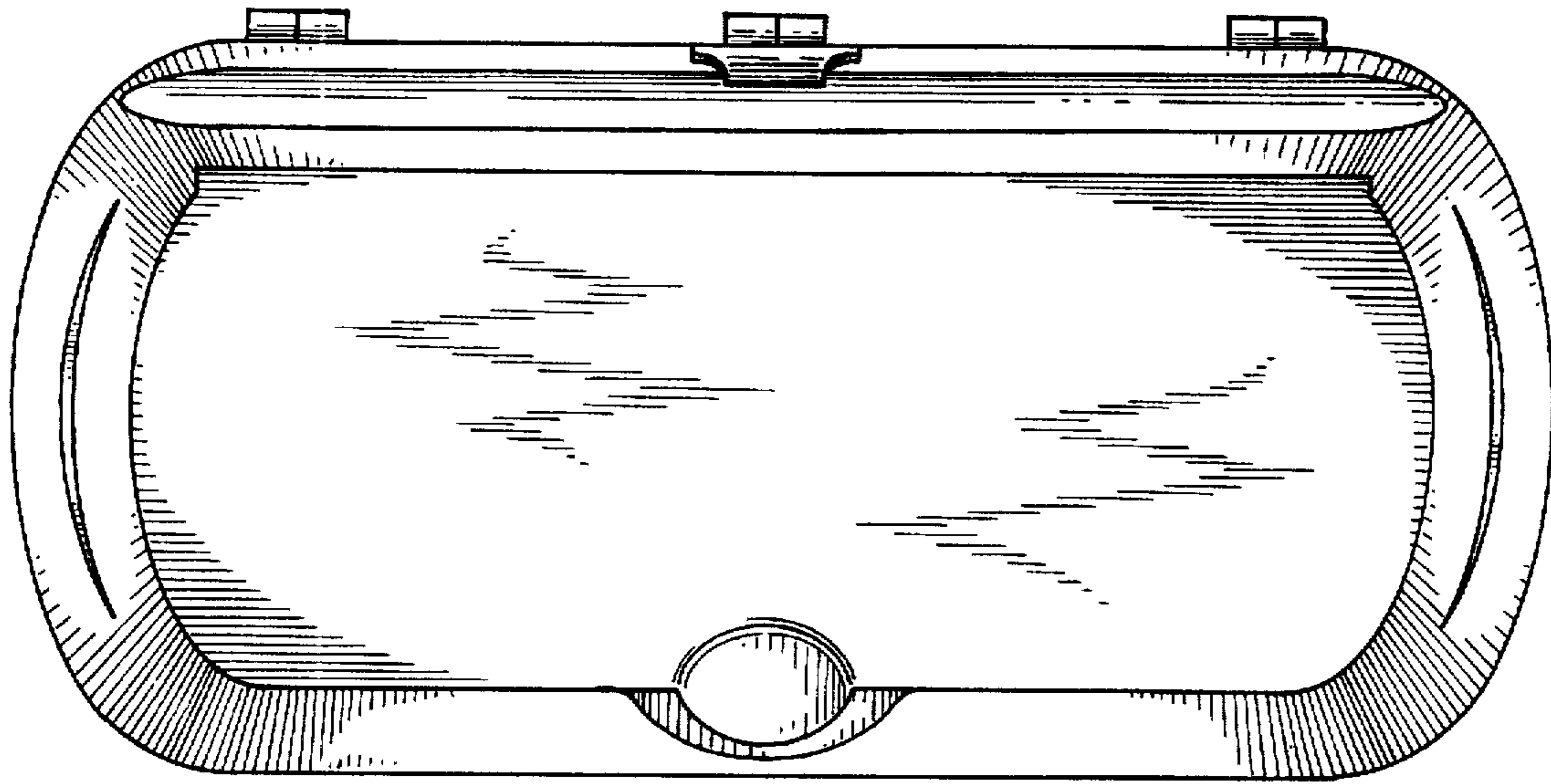

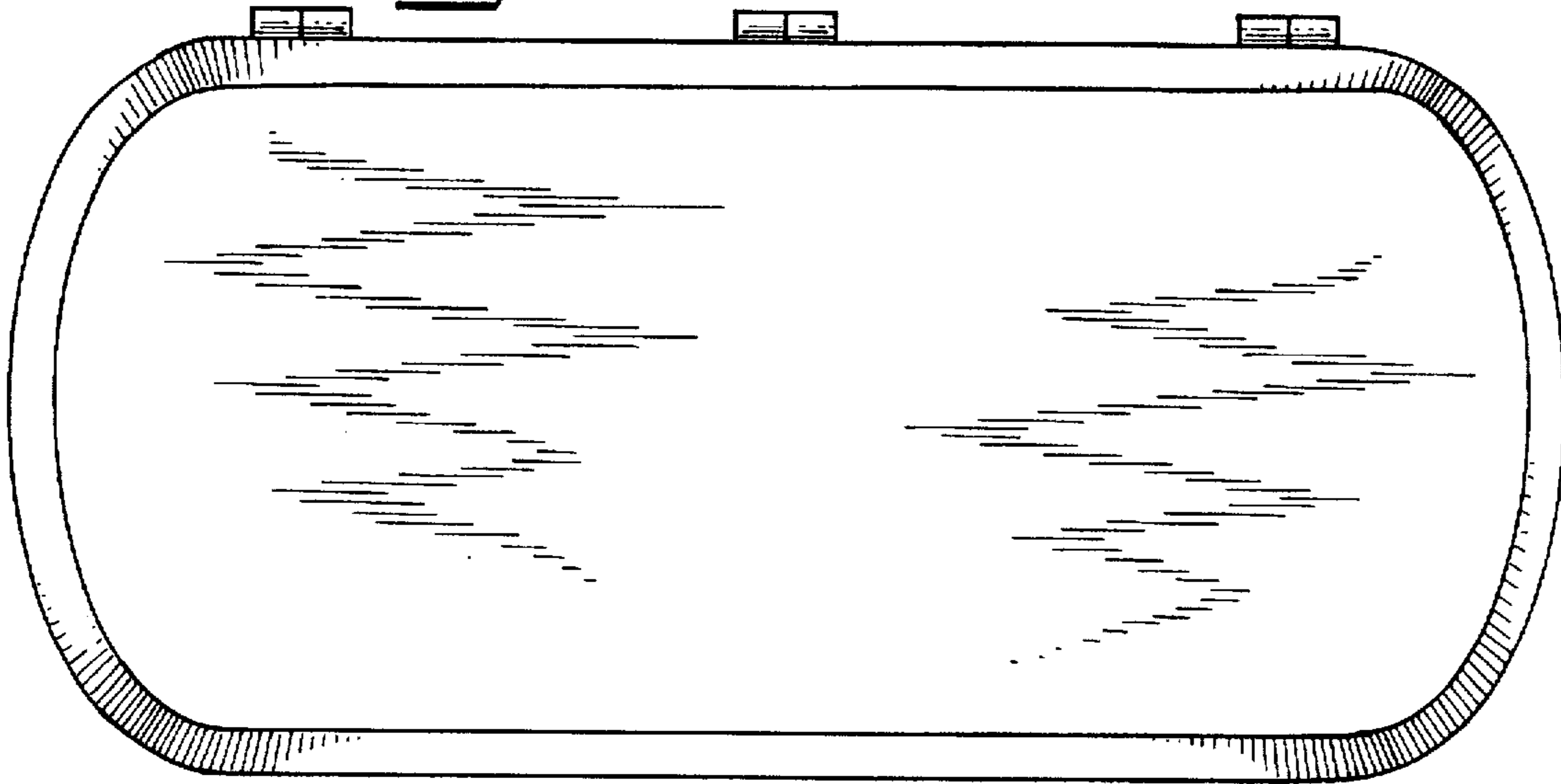

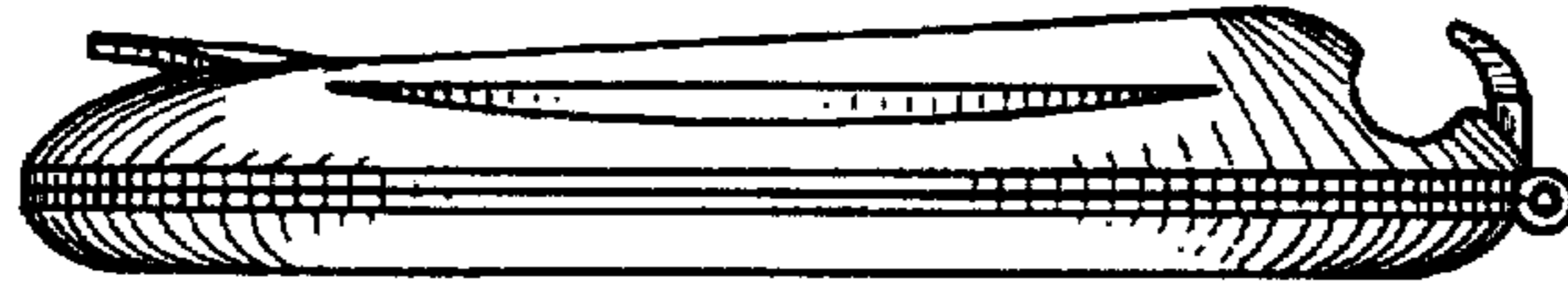

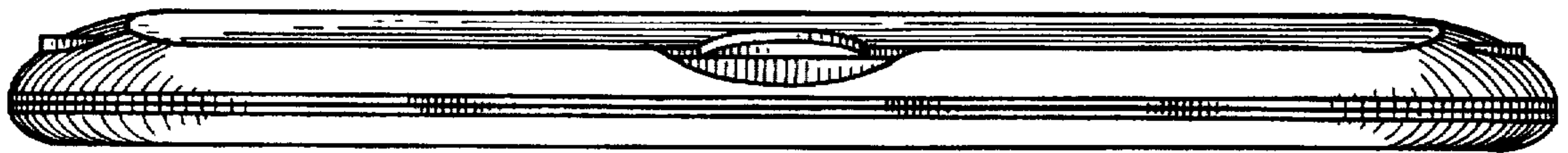

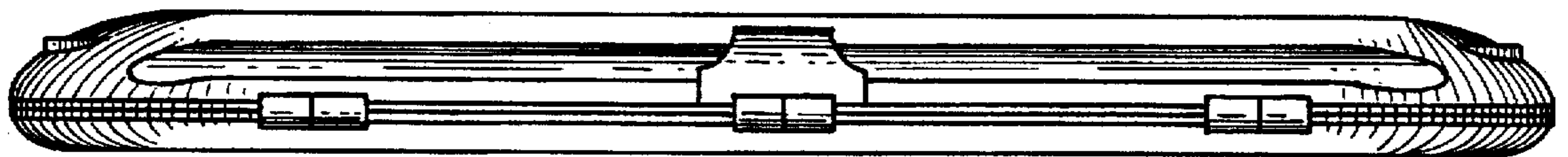
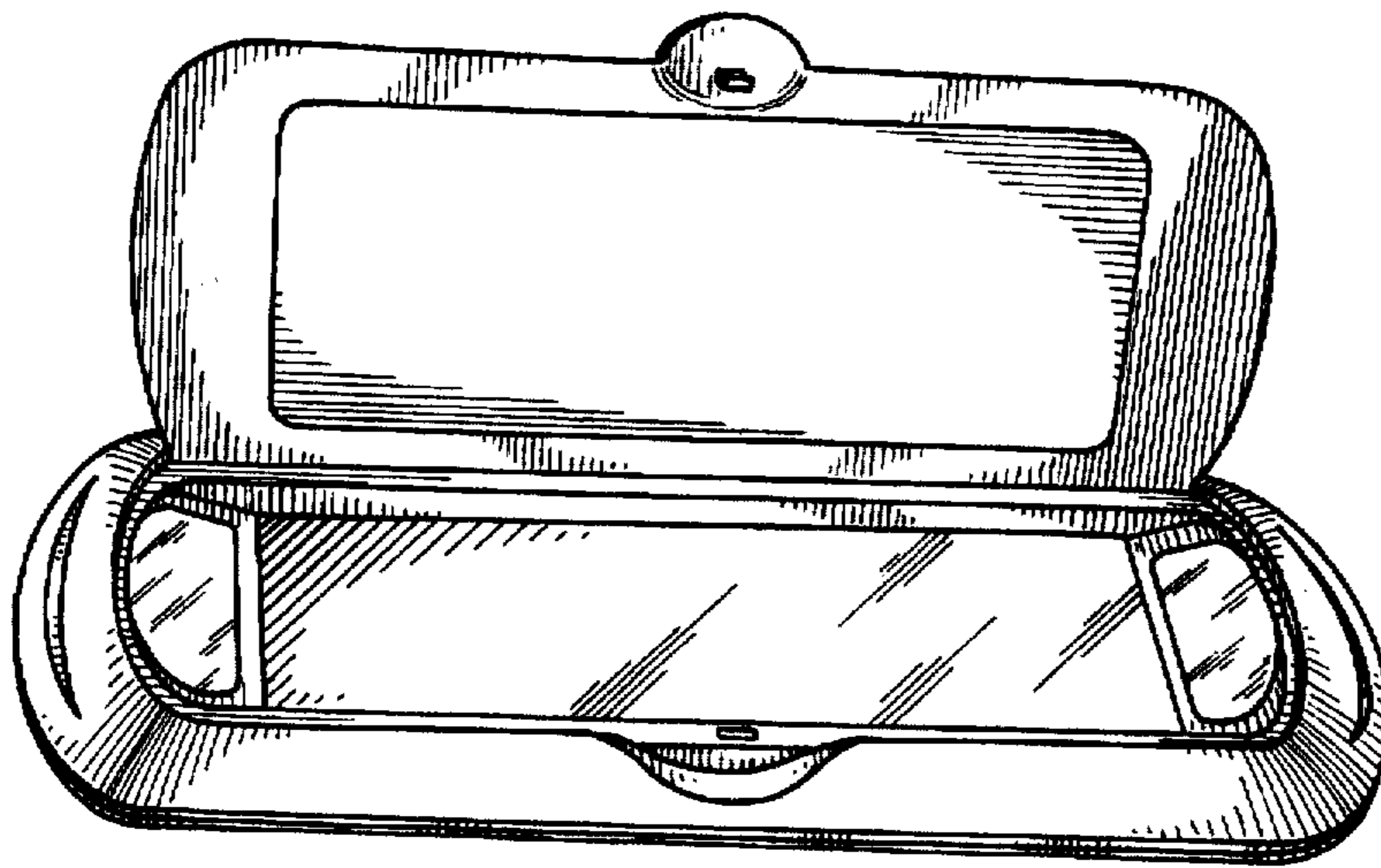
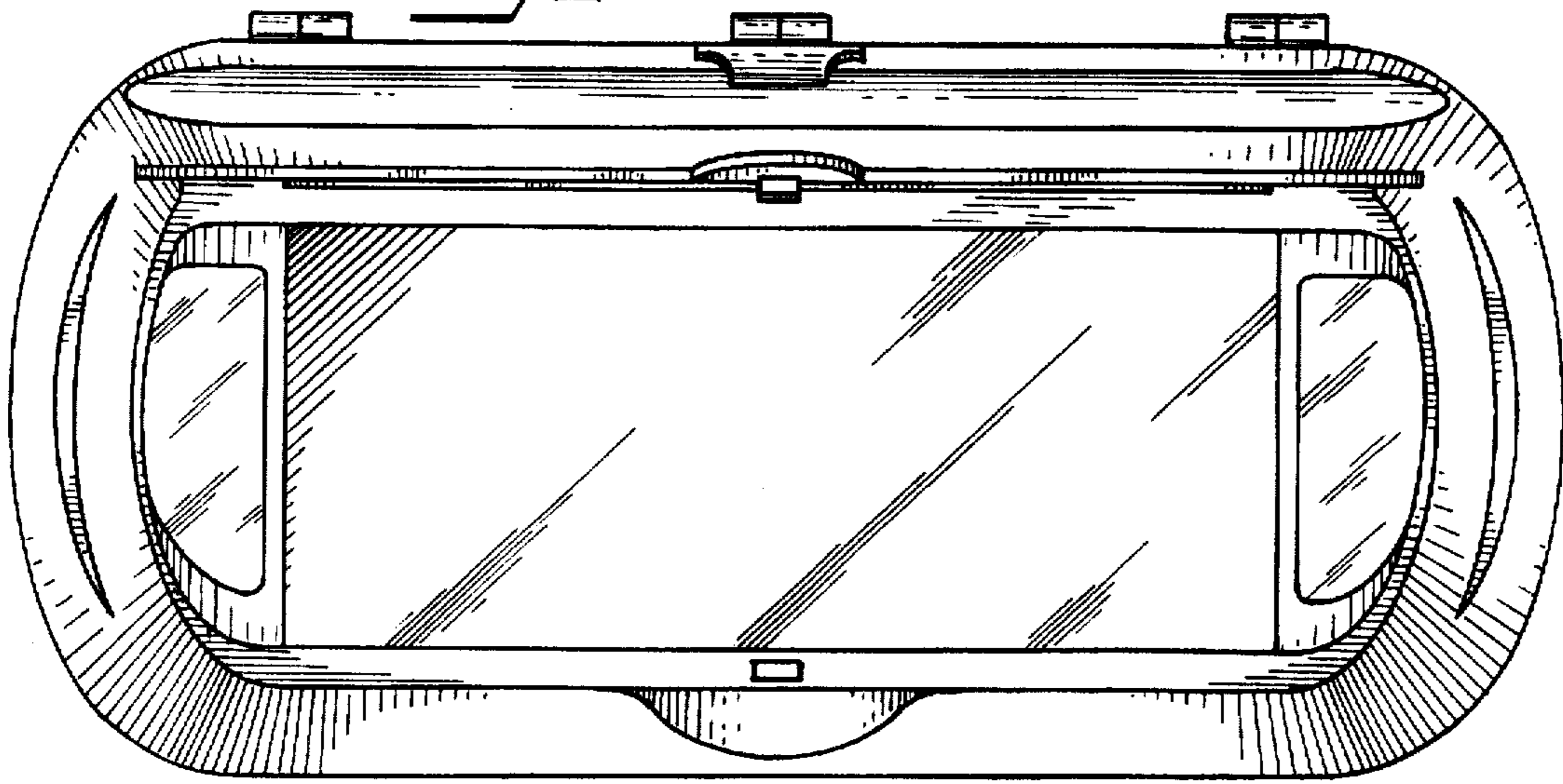

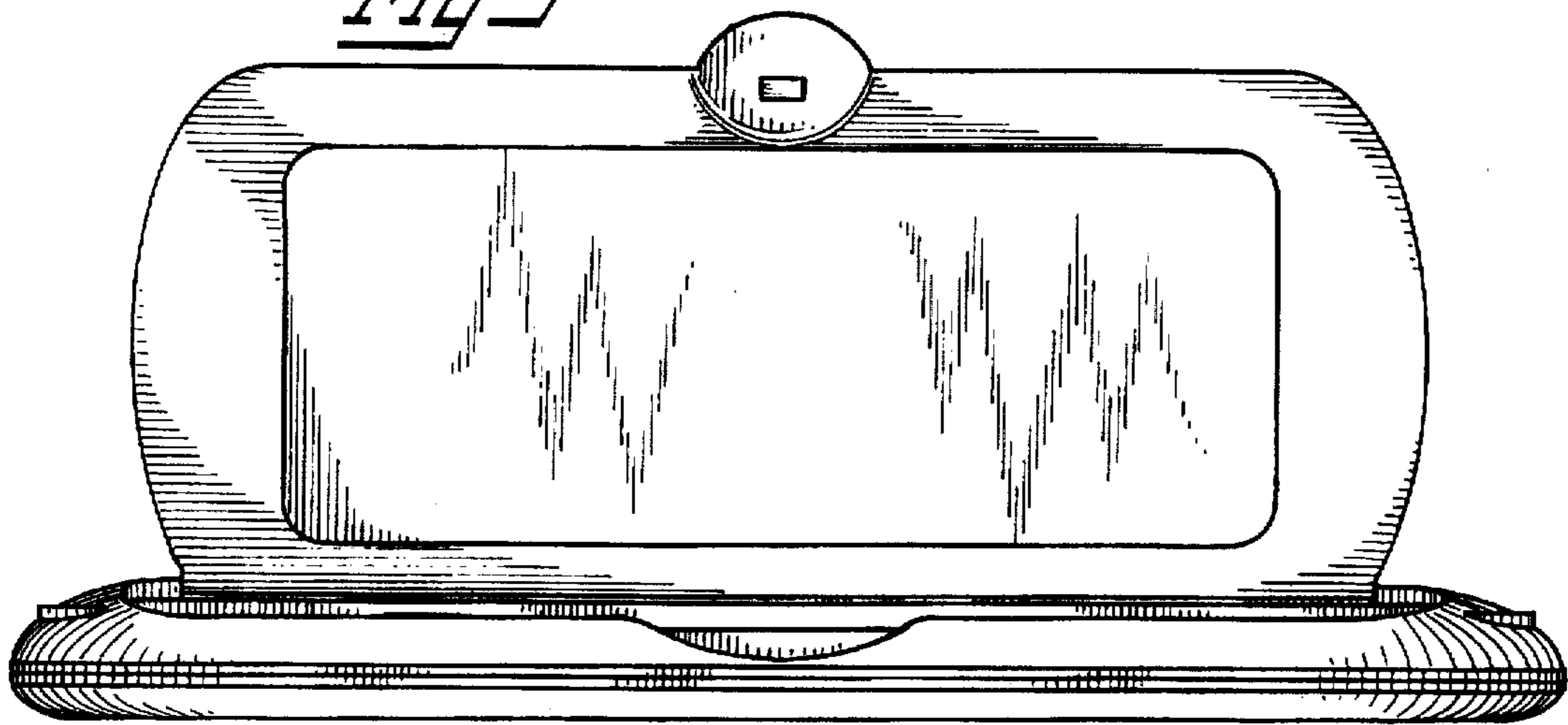
