[57] CLAIM

The ornamental design for a combined boom microphone headset and stand, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a combined boom microphone headset and stand showing my new design; and, FIG. 2 is a right side elevational view thereof. The rear and bottom views of the combined boom microphone headset and stand form no part of the claimed design.

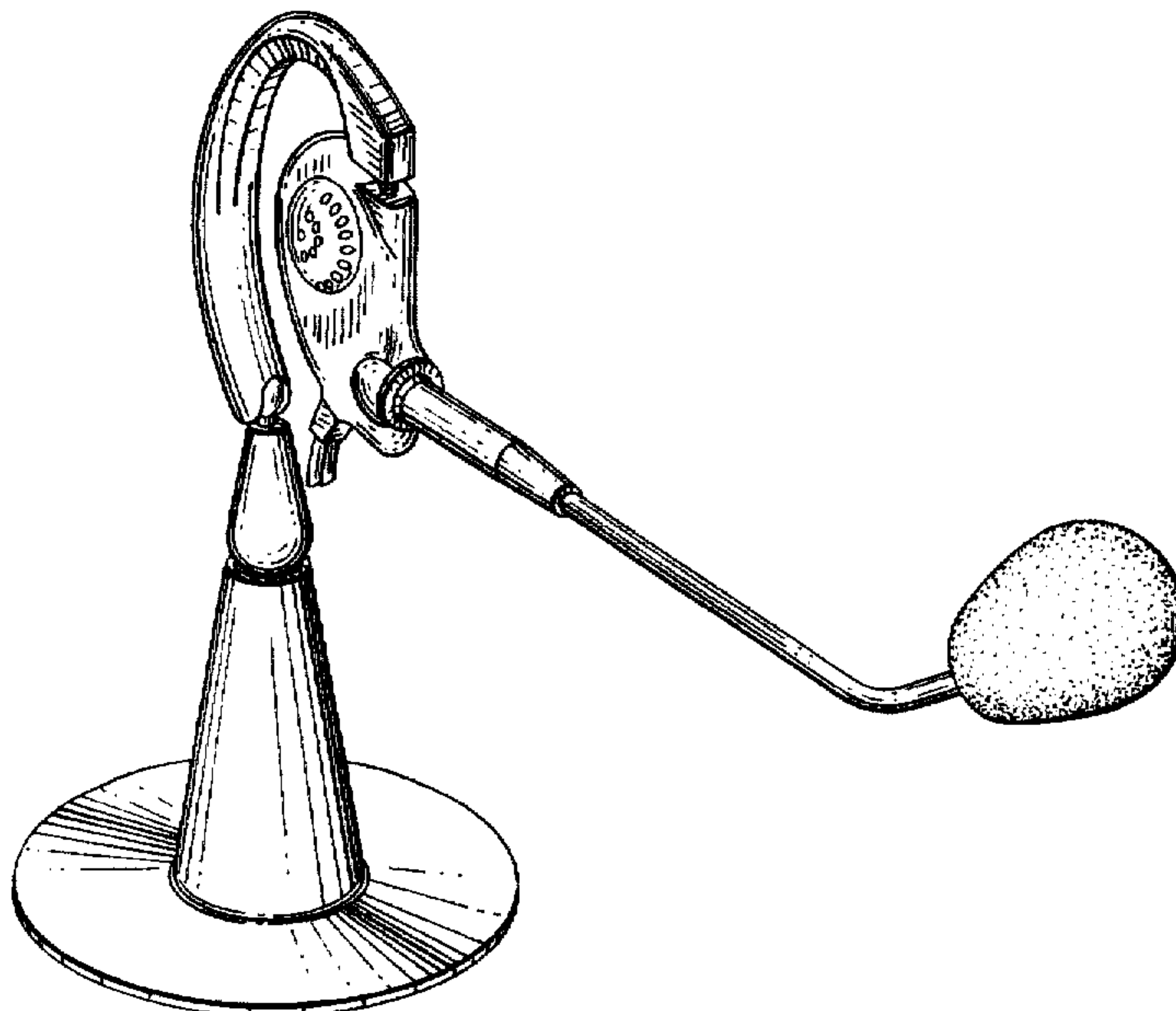
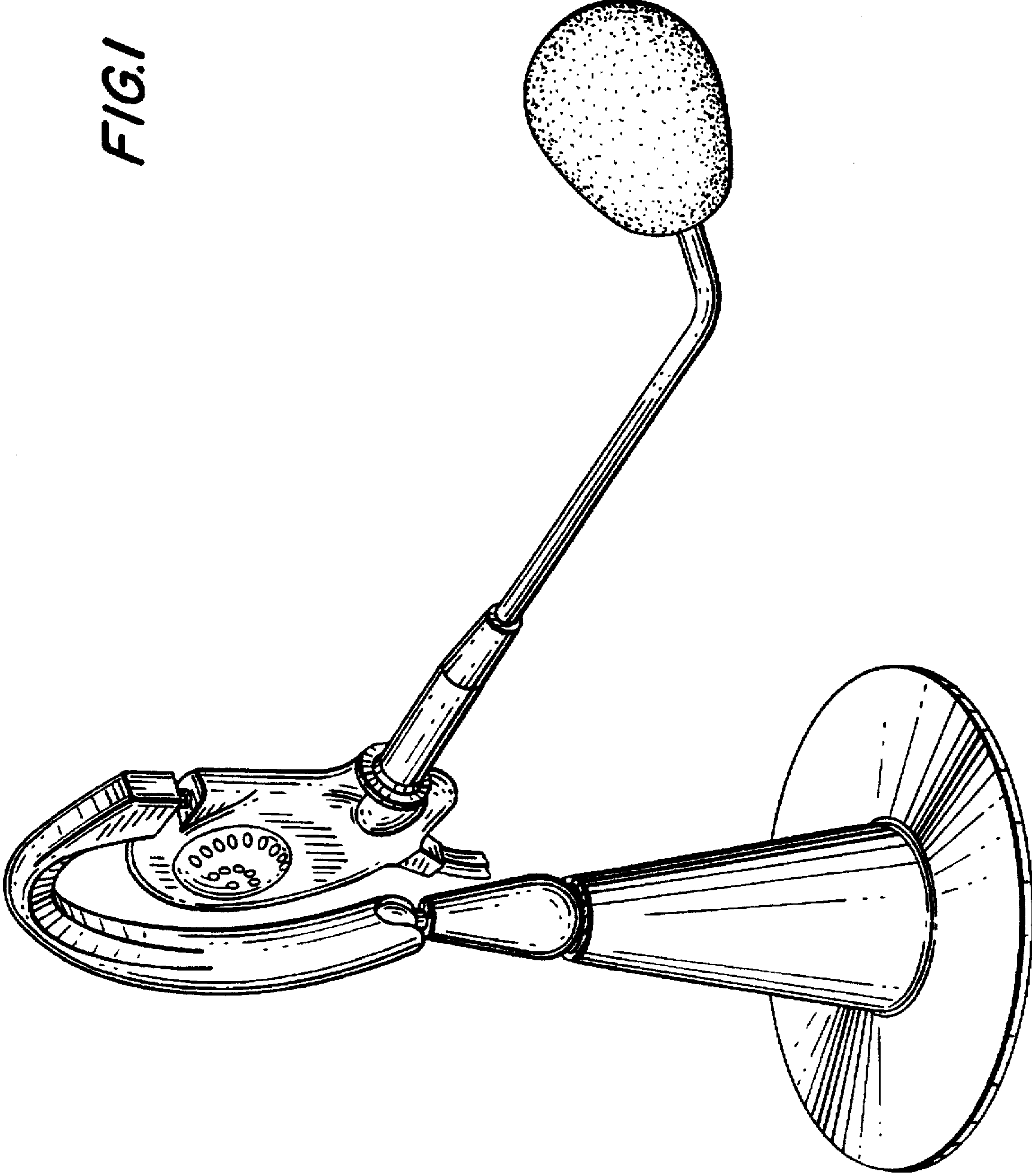

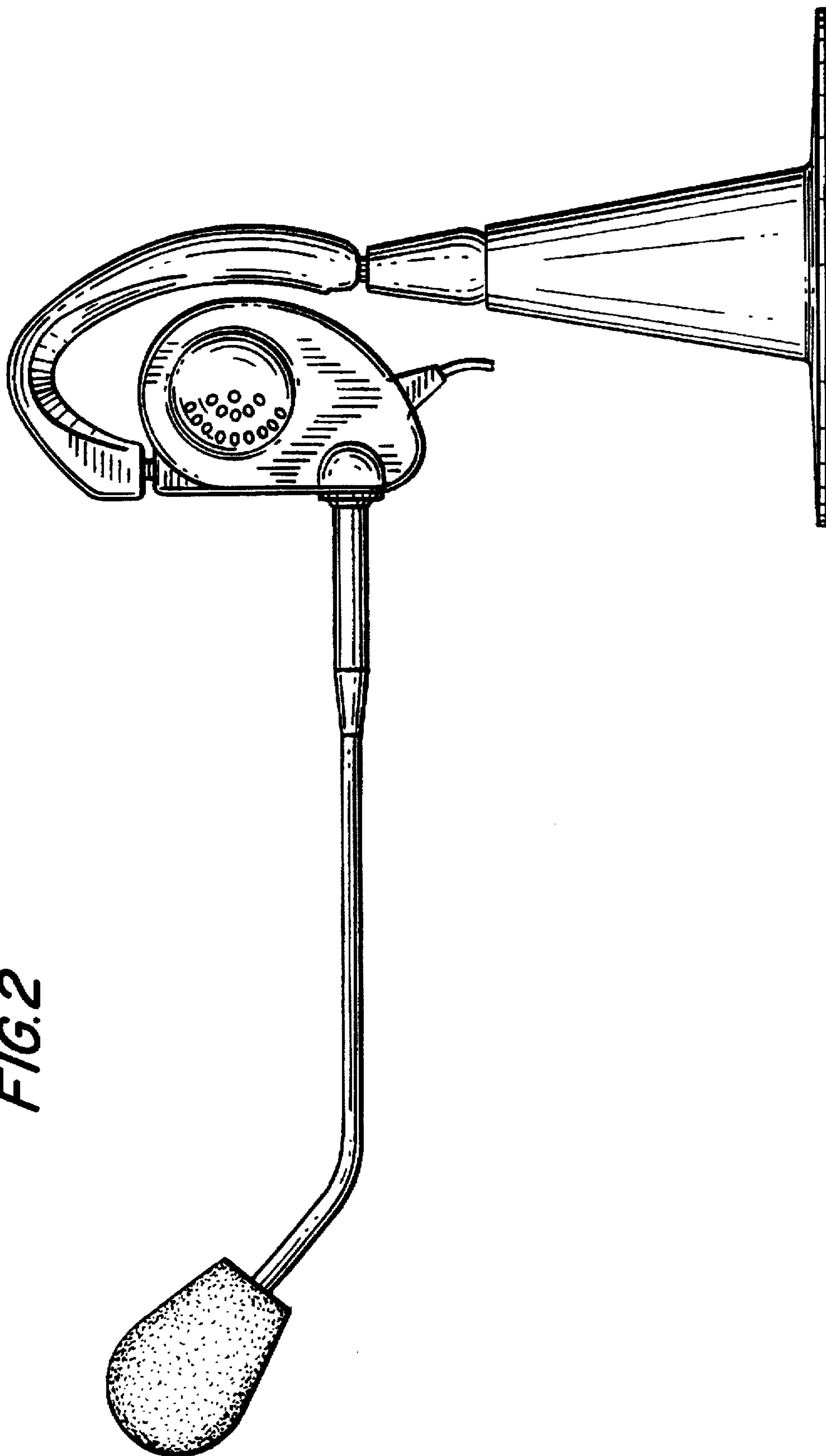
