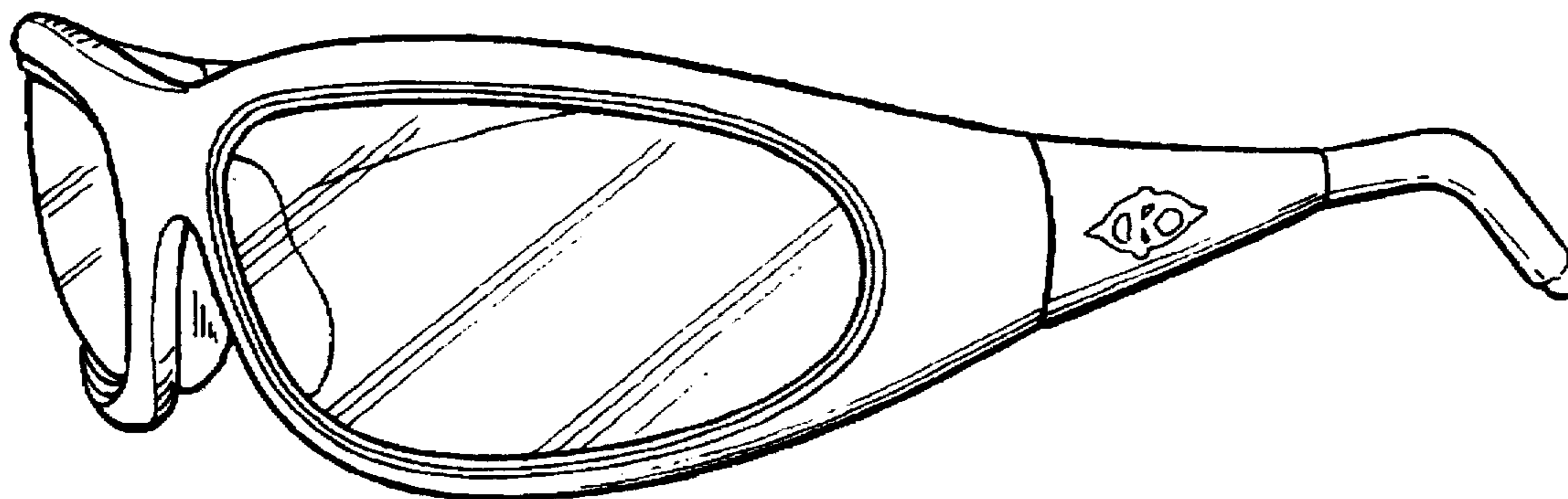

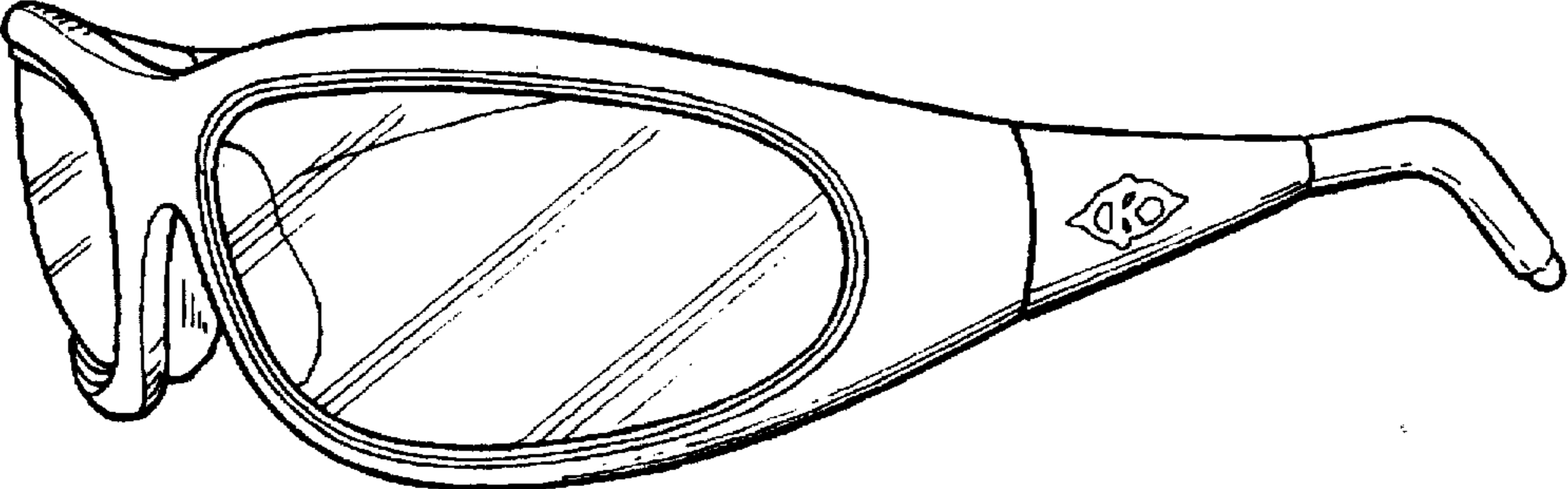
The ornamental design for sunglasses, as shown and described.

**DESCRIPTION**

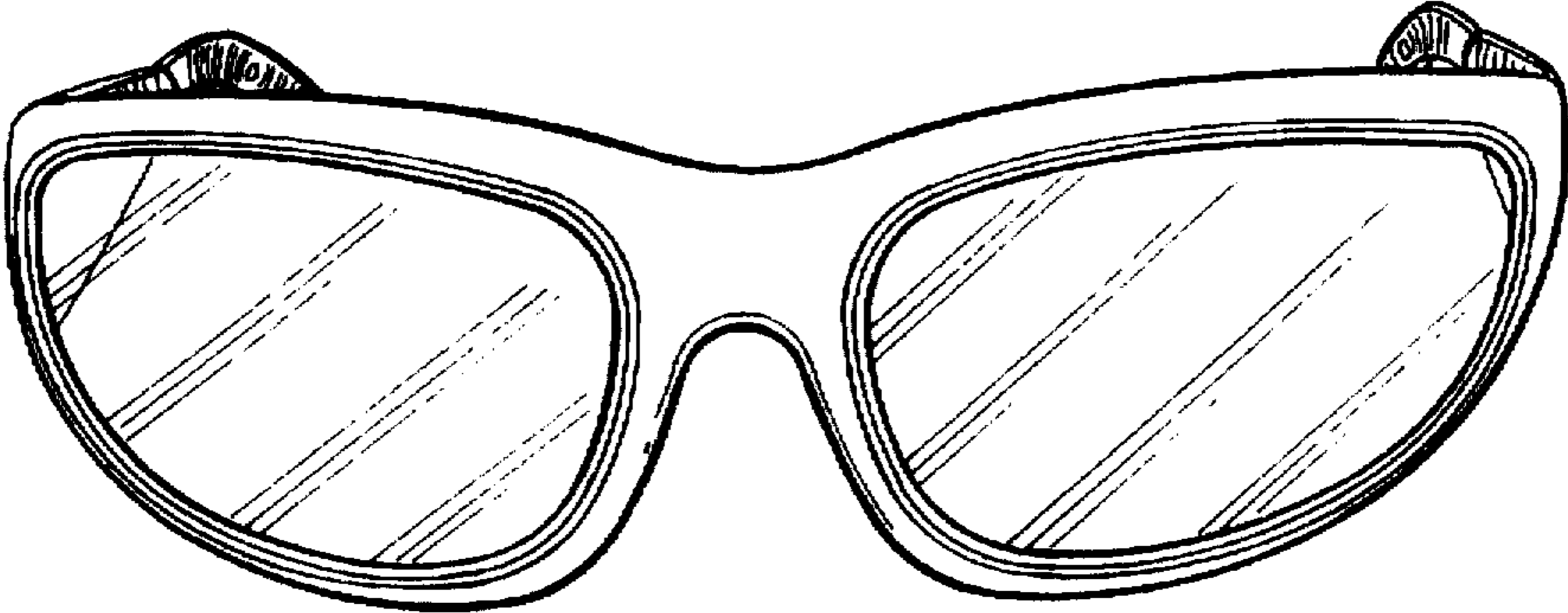
FIG. 1 is a perspective view of the sunglasses showing my new design;

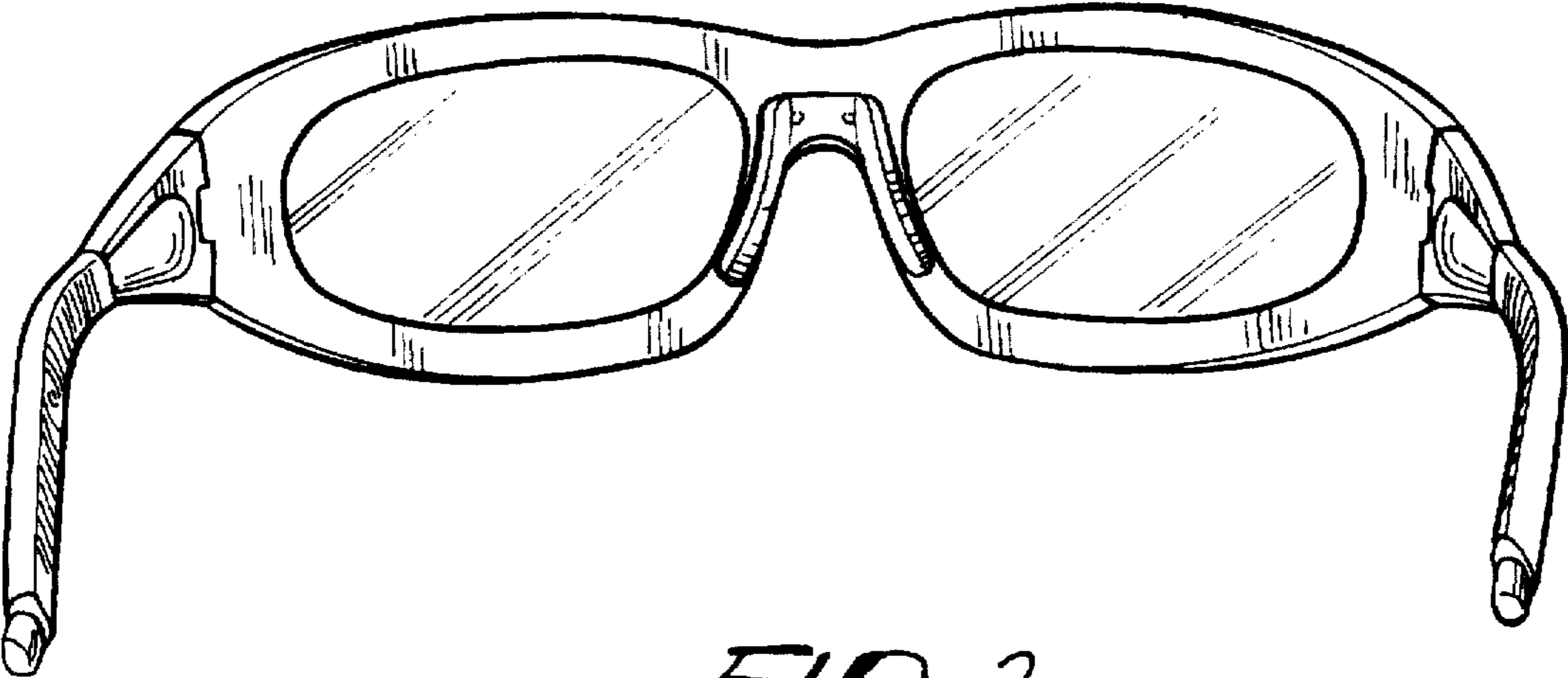

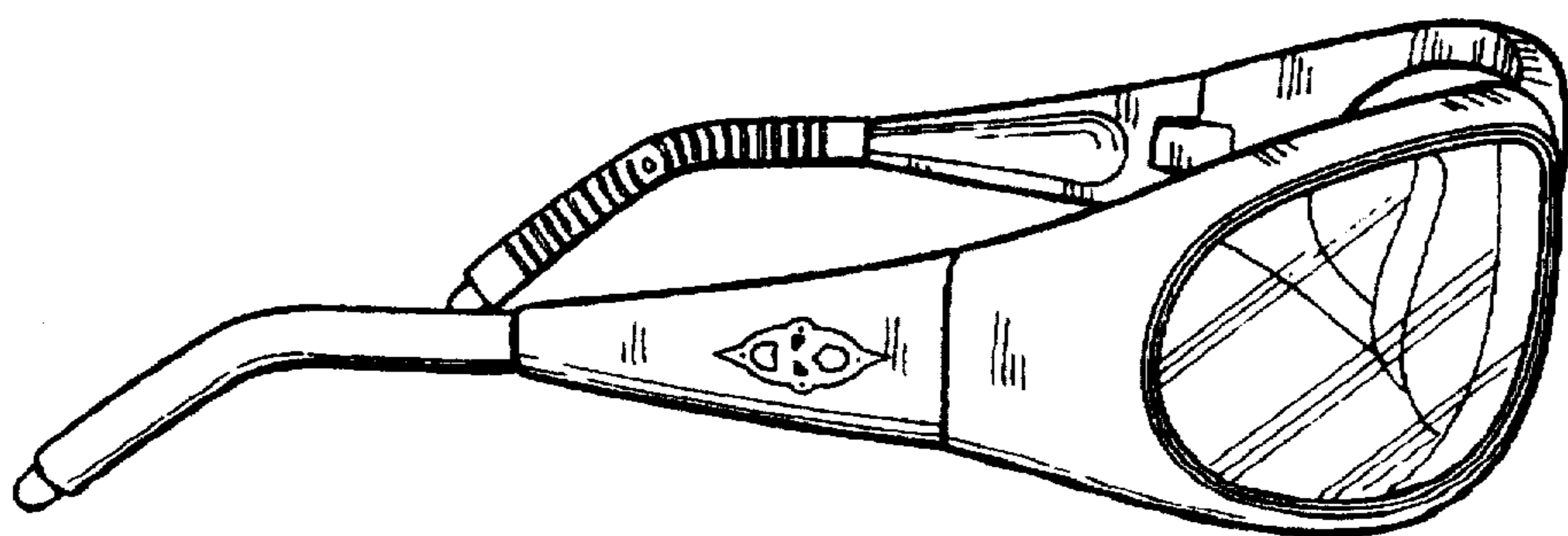

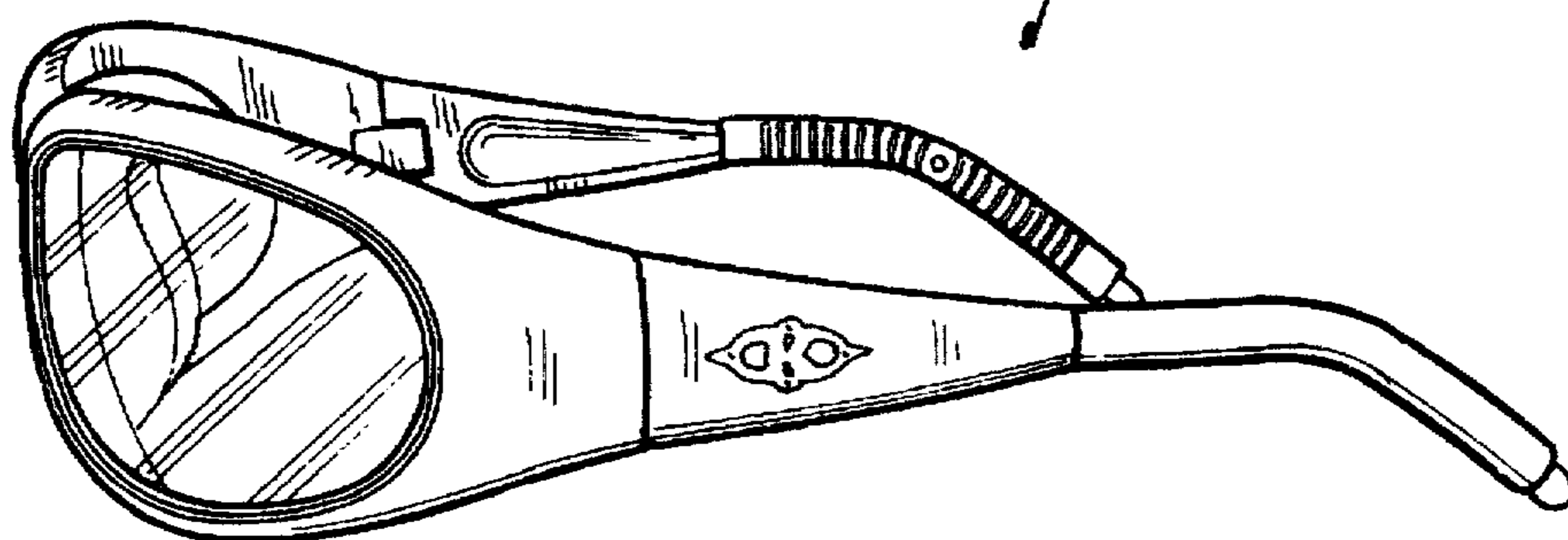

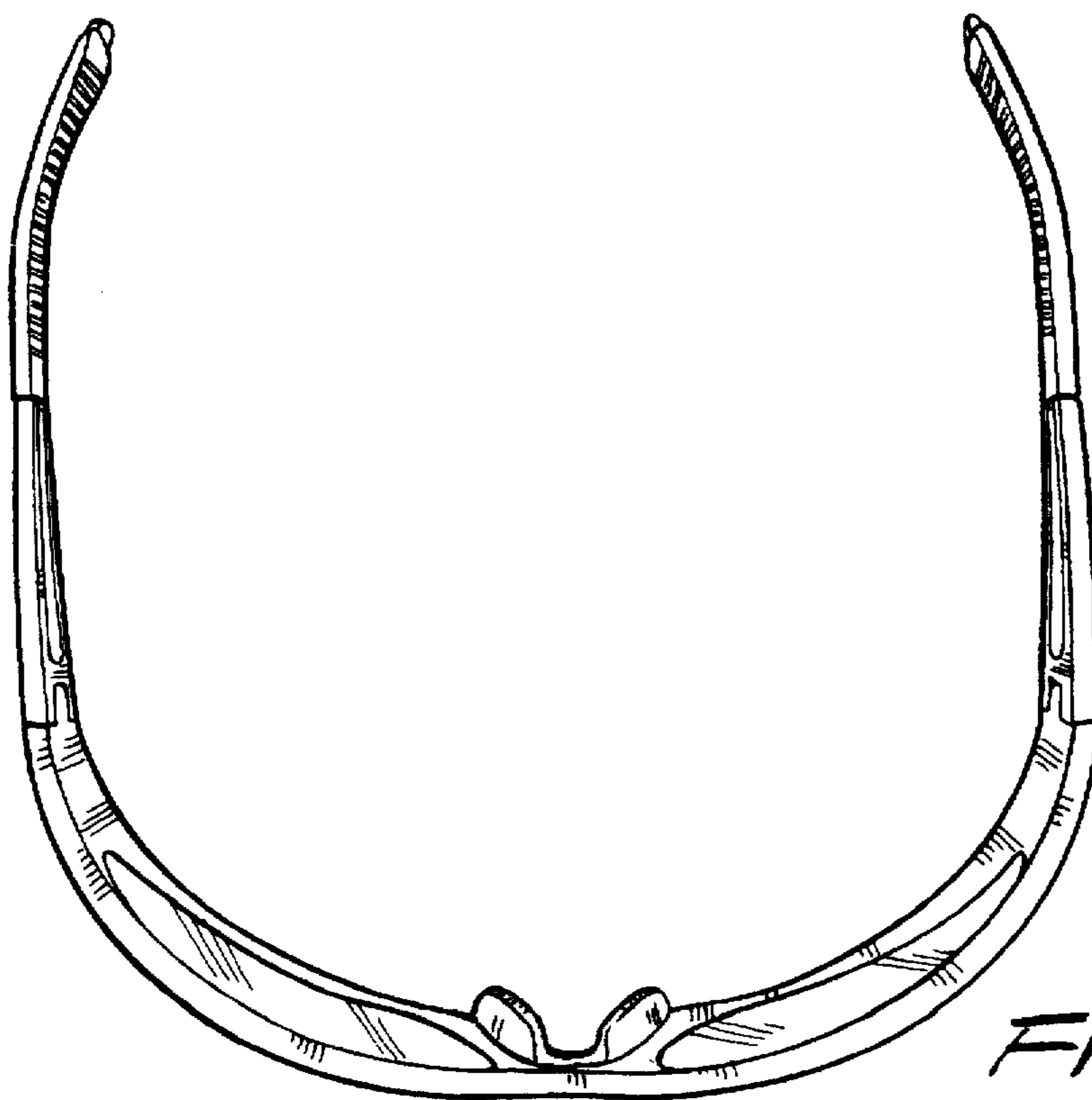
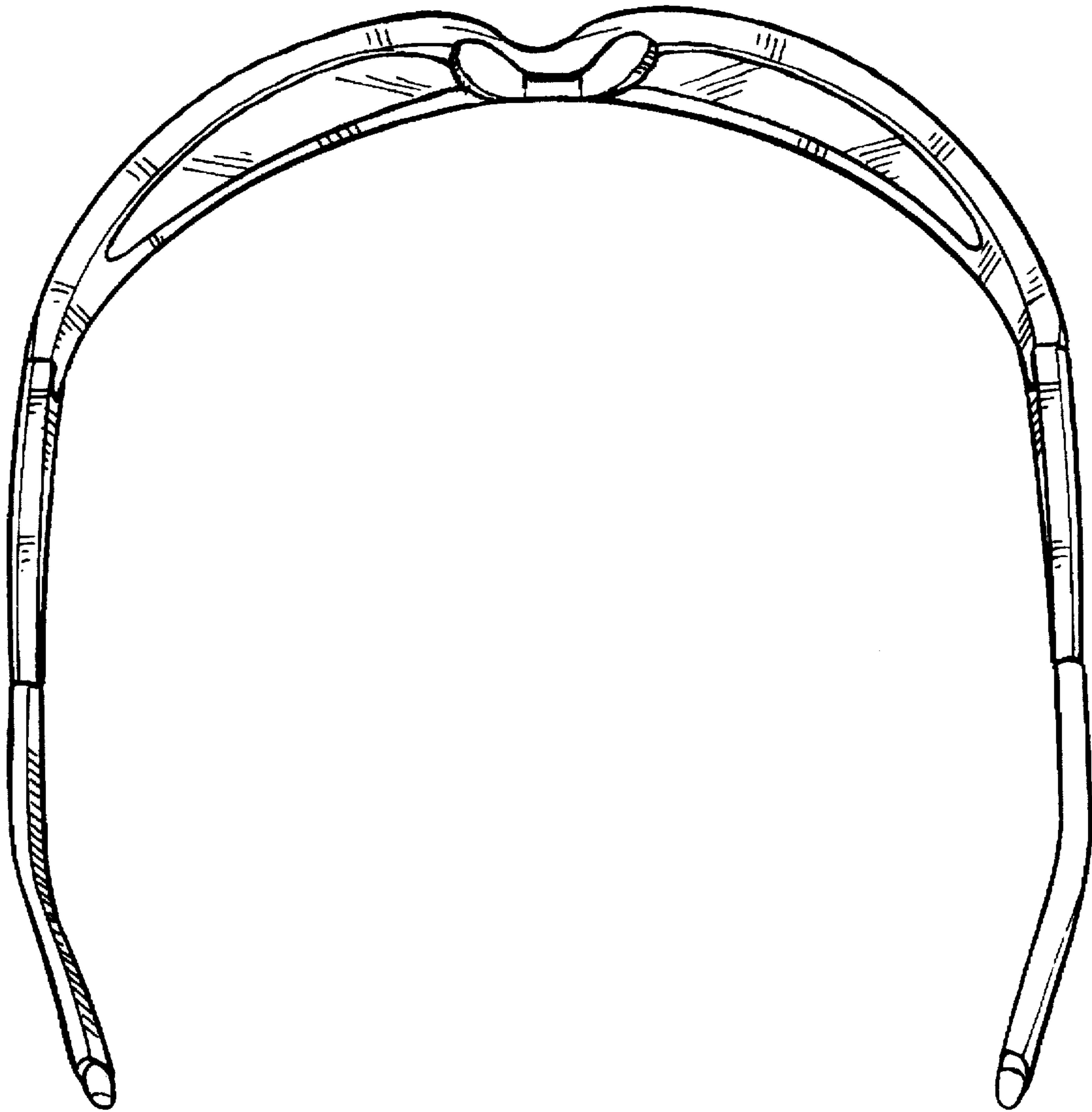
