The indicia depicted by means of broken lines in FIGS. 1, 7, 8, and 9 has been illustrative purposes only and forms no part of the claimed design.

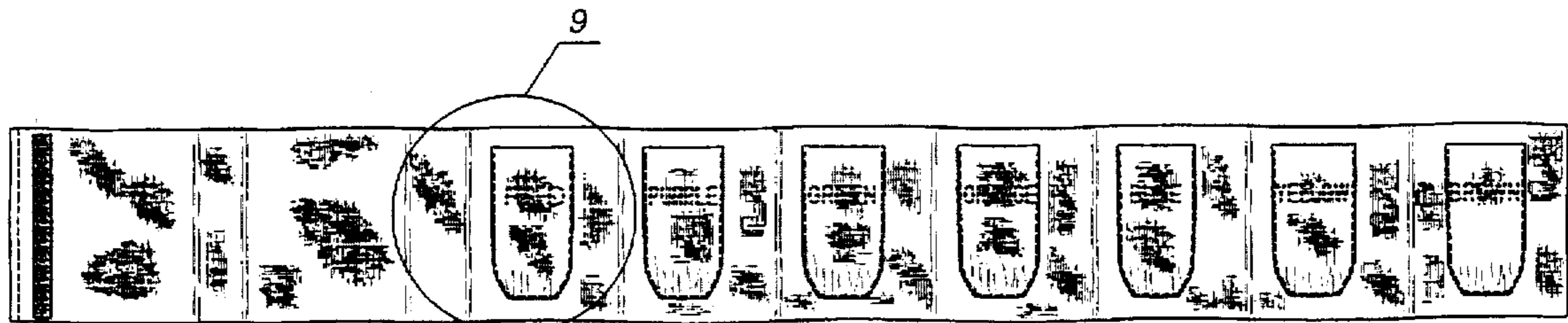
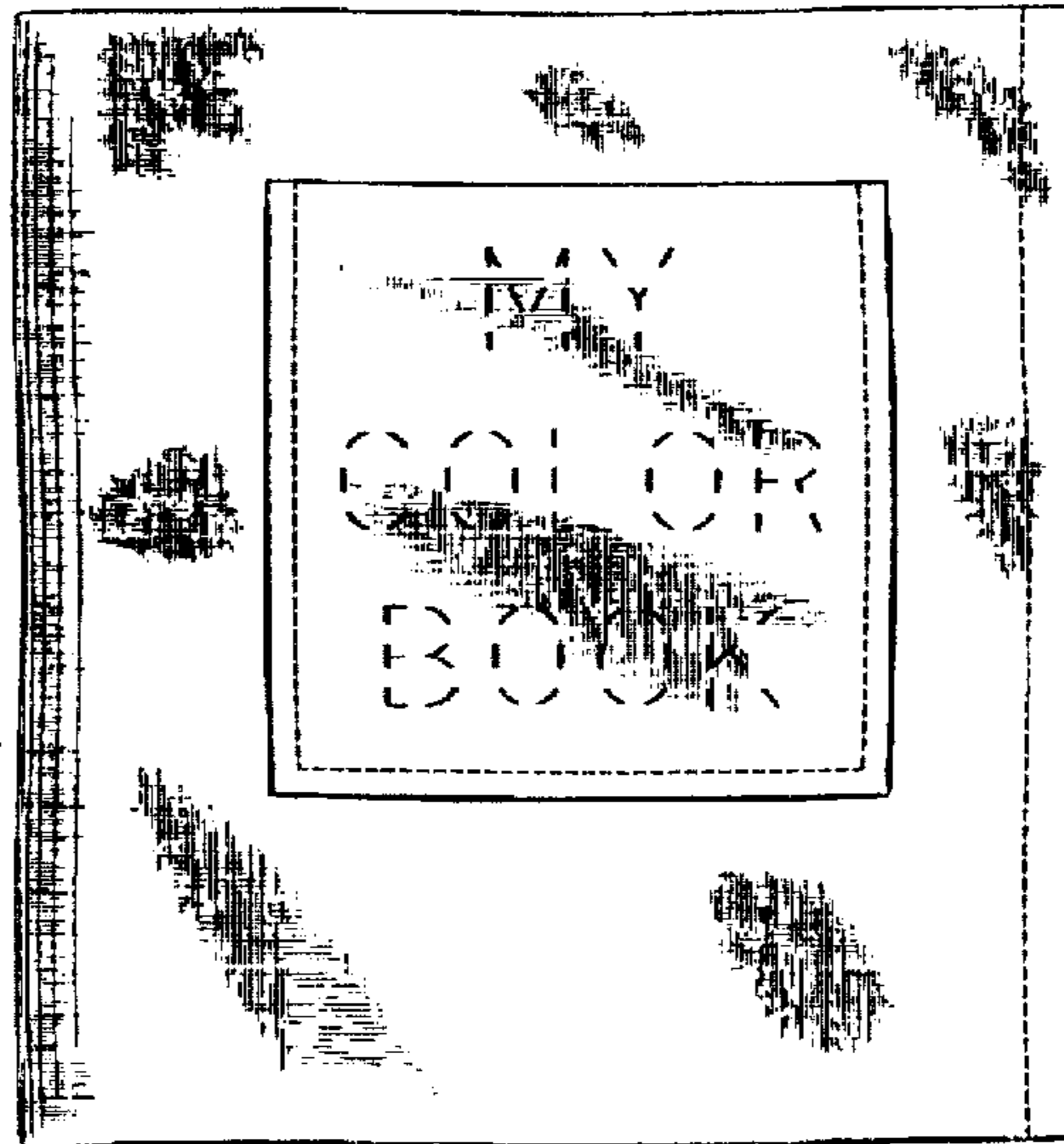

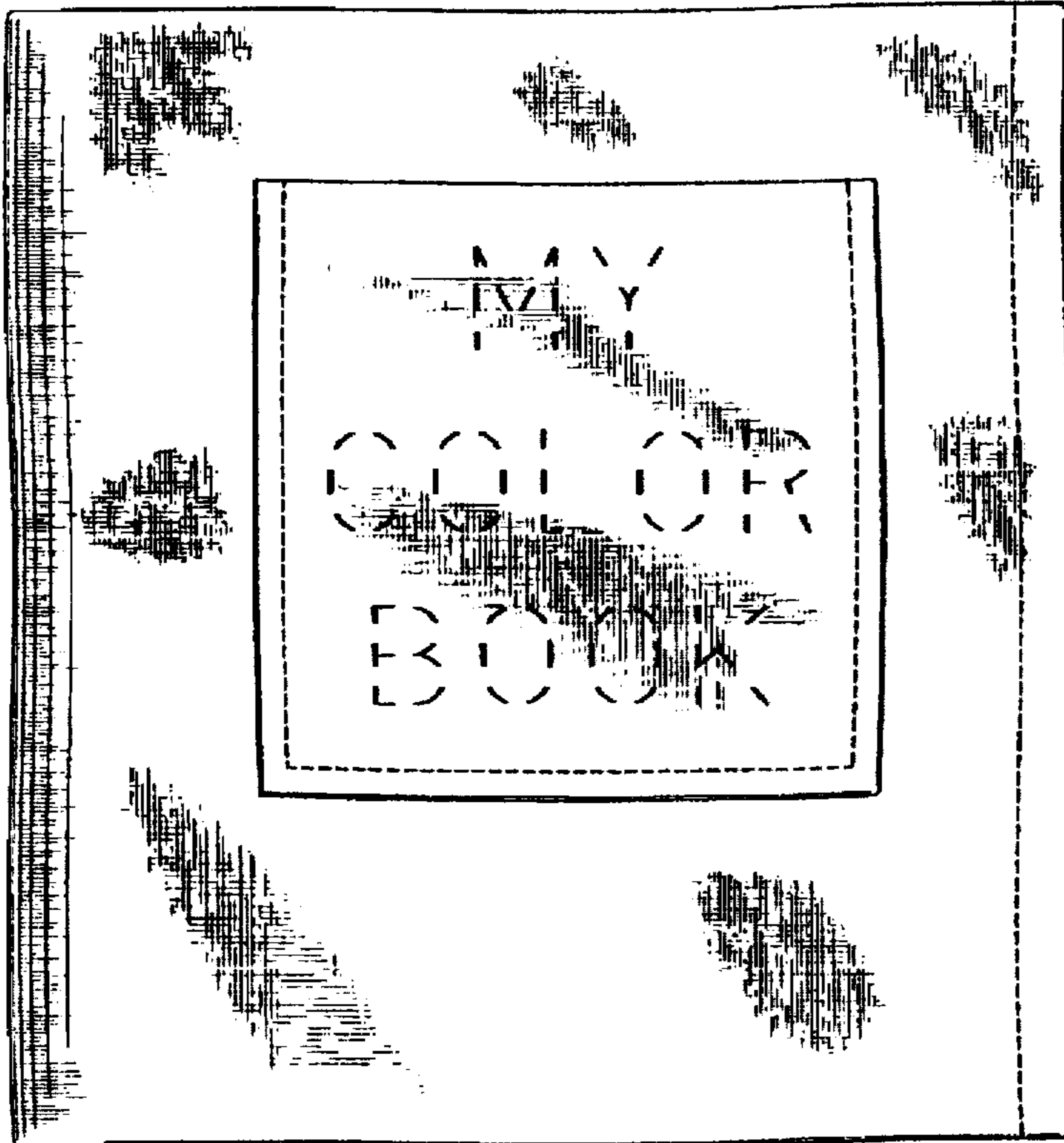

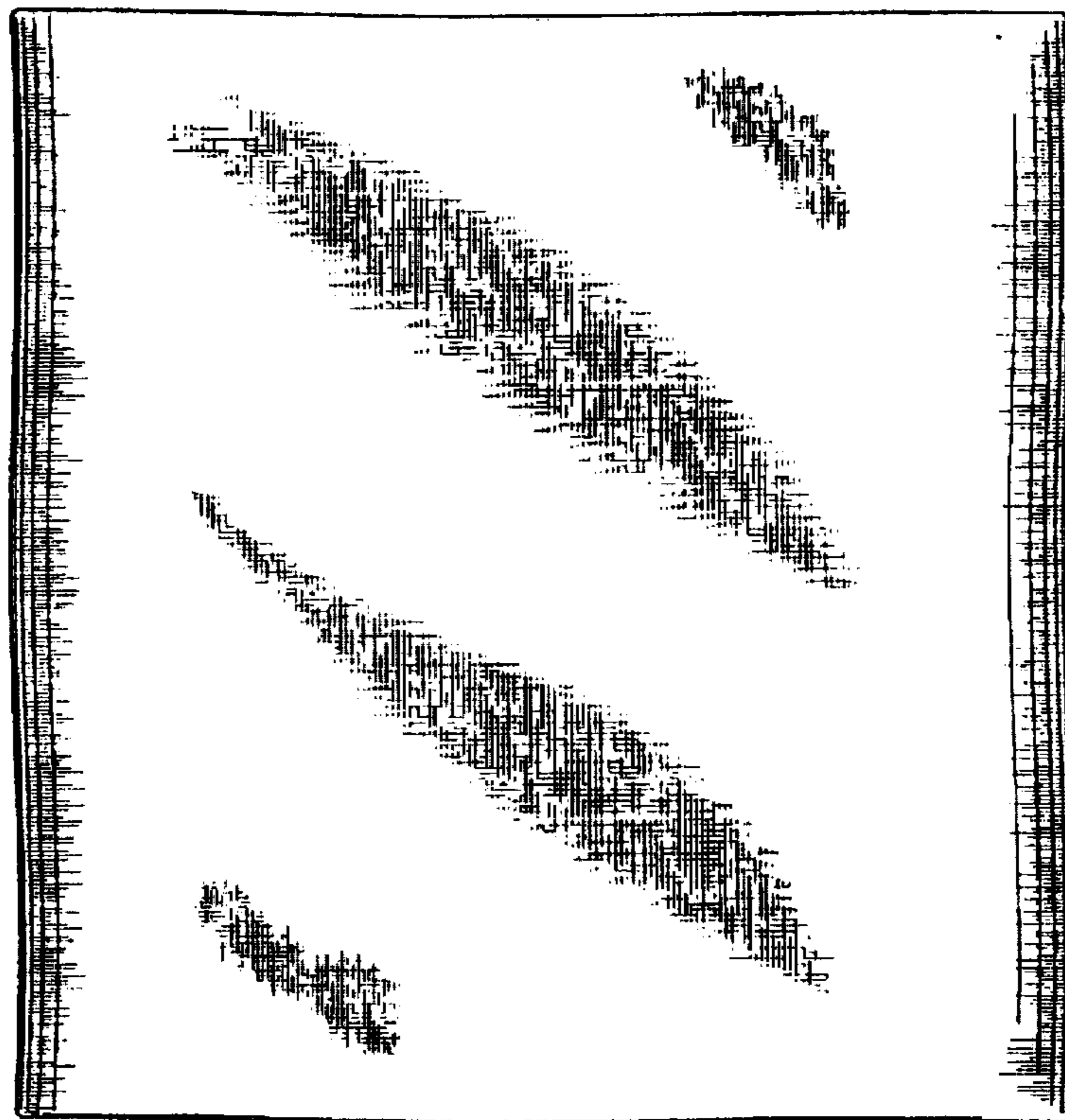

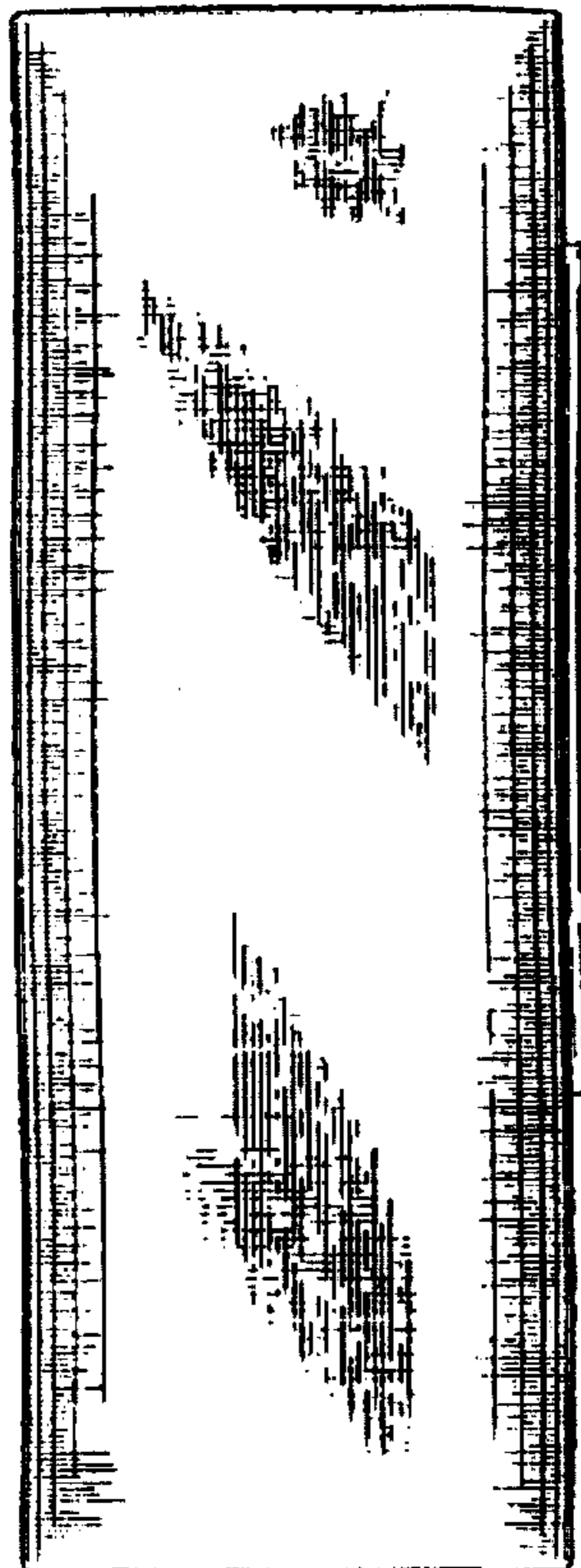

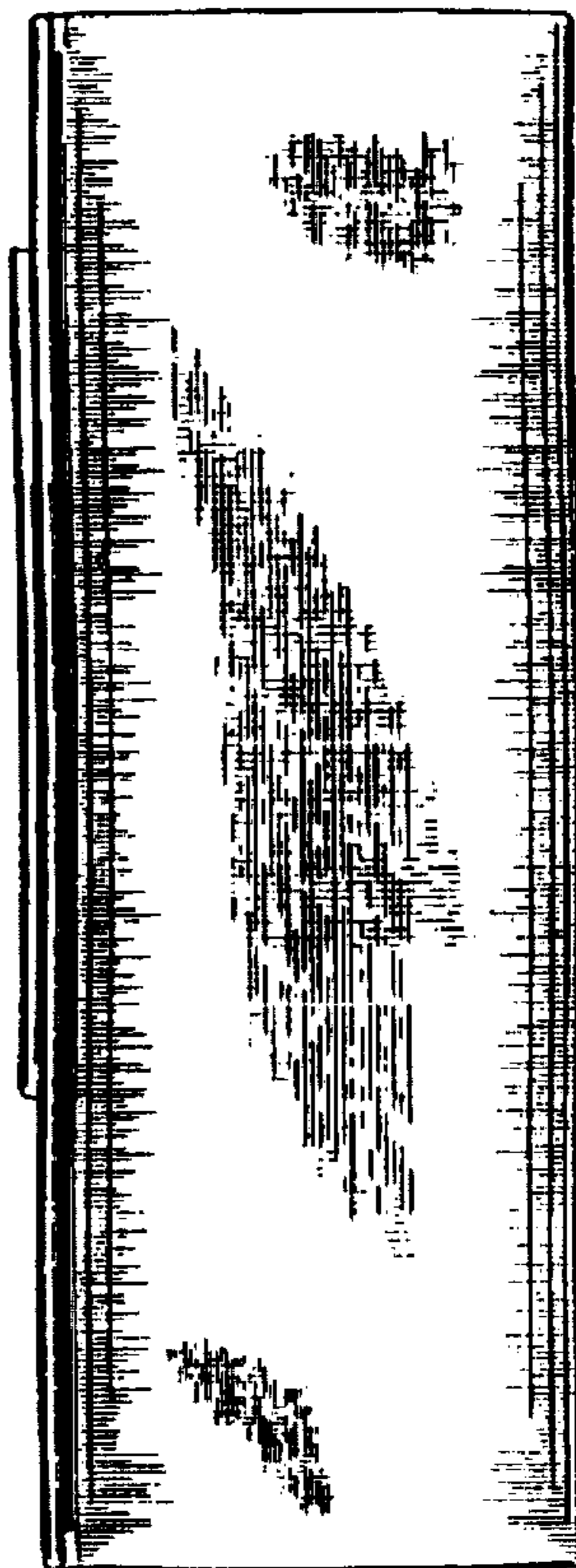

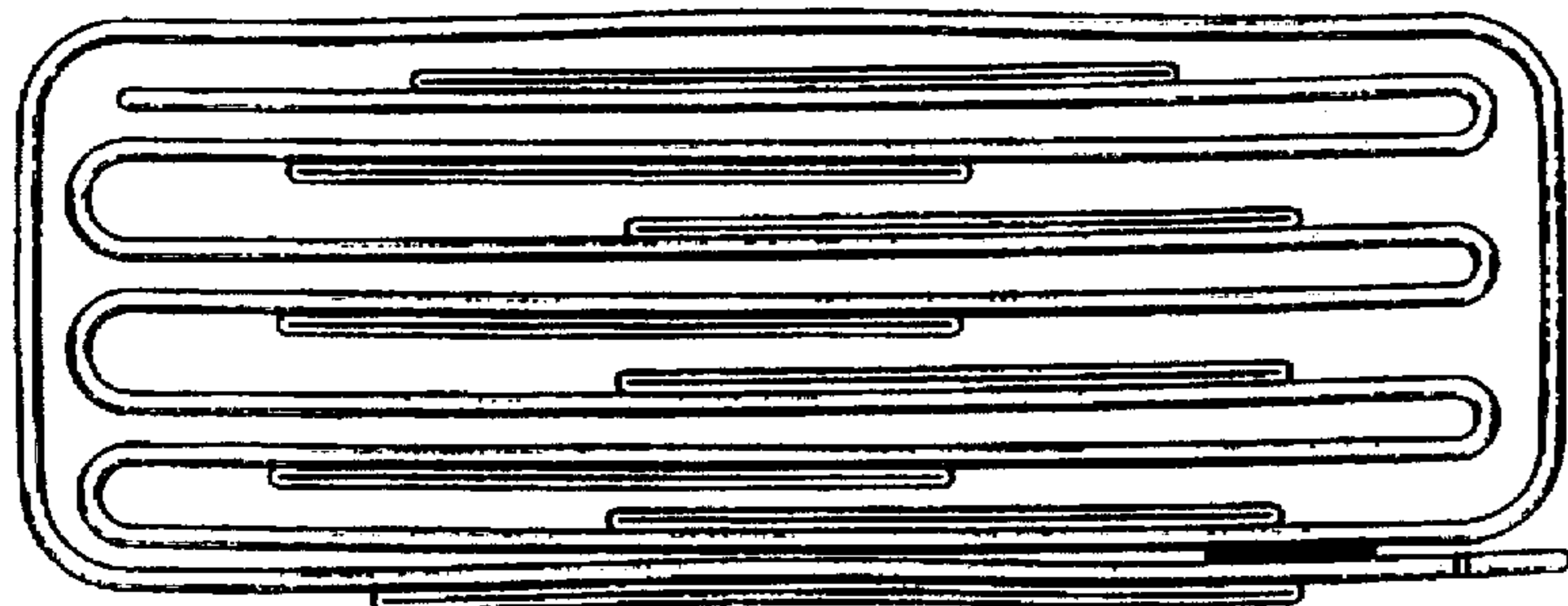
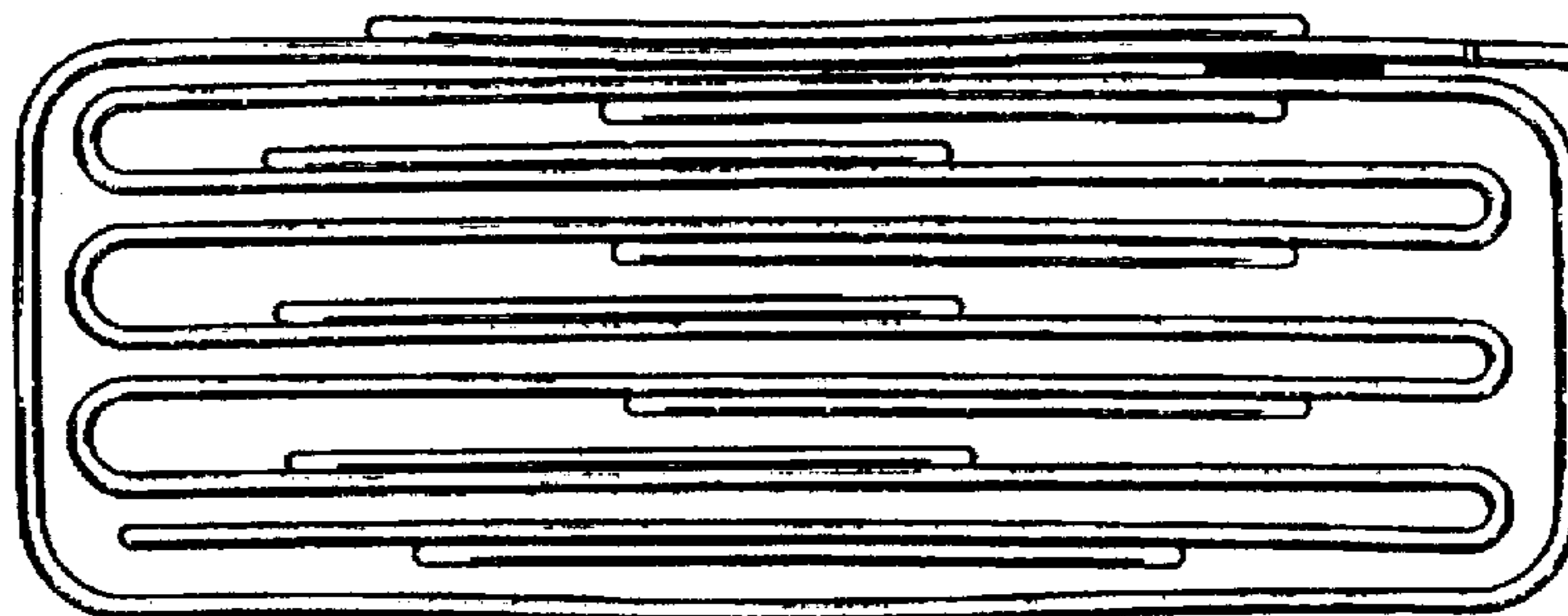

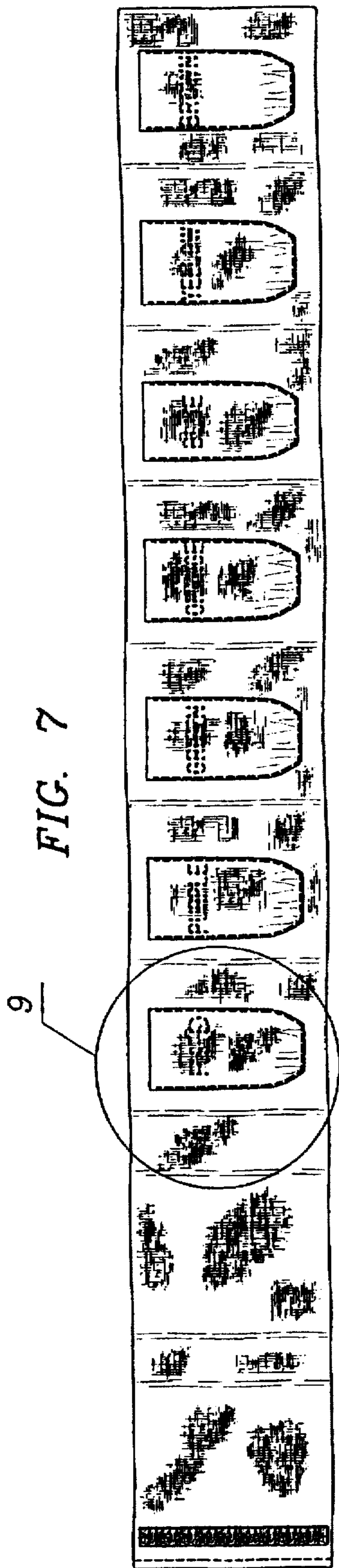

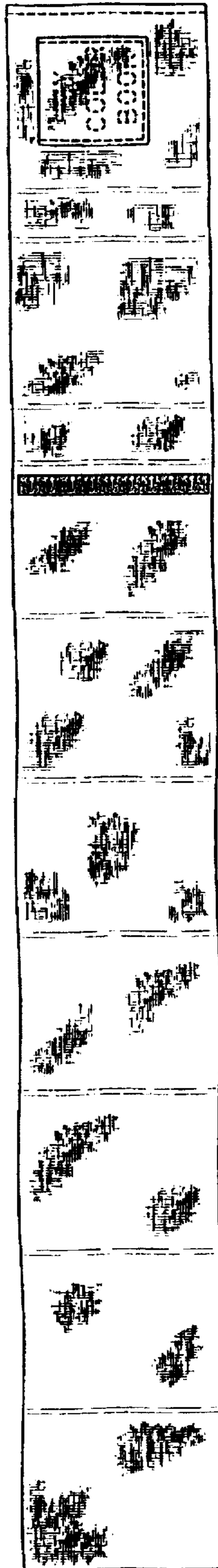
