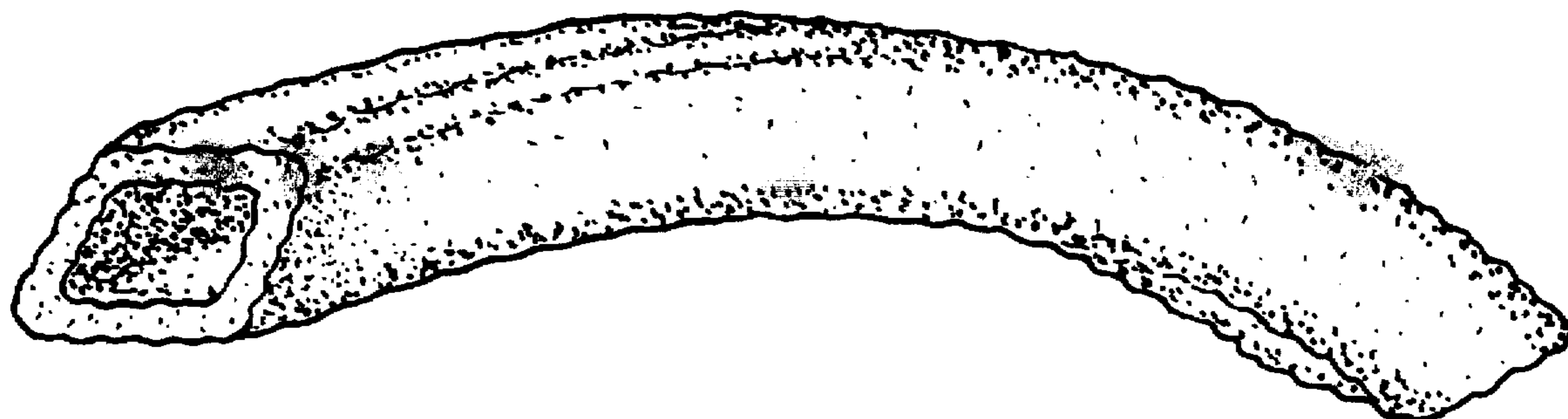
[57] CLAIM

The ornamental design for a tubular food product, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tubular food product illustrating our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a side elevational view thereof, as viewed from the left of FIG. 2;  
FIG. 4 is a side elevational view thereof, as viewed from the right of FIG. 2;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a rear elevational view thereof;  
FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 5;  
FIG. 9 is a cross-sectional view taken along line 9—9 of FIG. 2;  
FIG. 10 is a perspective view of a food product which illustrates another embodiment of our new design;  
FIG. 11 is a front elevational view thereof;  
FIG. 12 is a side elevational view thereof, as viewed from the left of FIG. 11;  
FIG. 13 is a side elevational view thereof, as viewed from the right of FIG. 11;  
FIG. 14 is a top plan view thereof;  
FIG. 15 is a rear elevational view thereof;  
FIG. 16 is a bottom plan view thereof; and,  
FIG. 17 is a cross-sectional view taken along line 17—17 of FIG. 14.

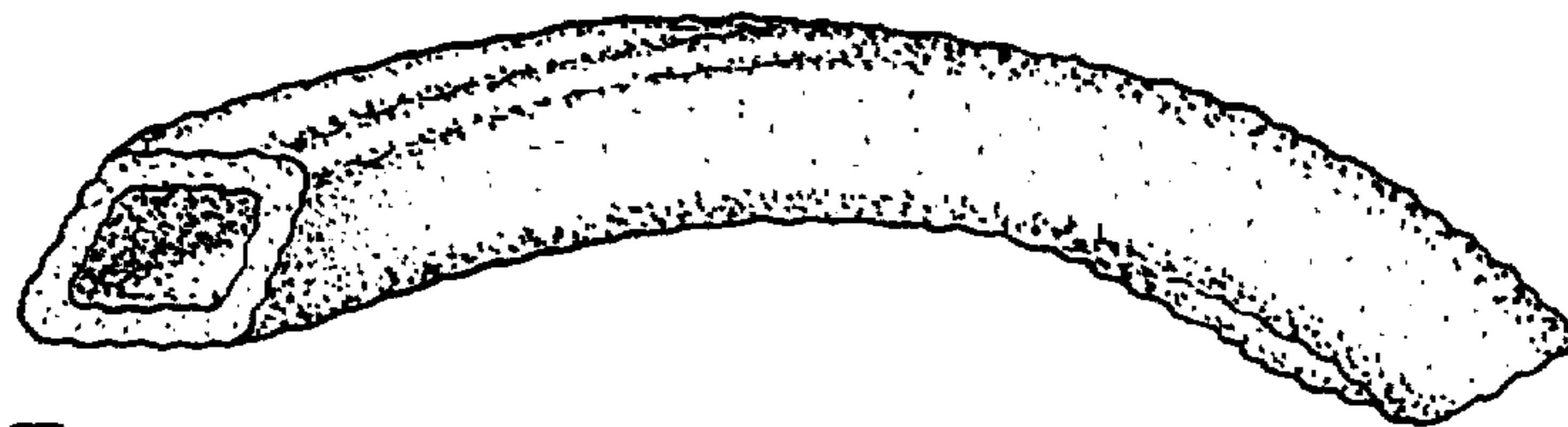

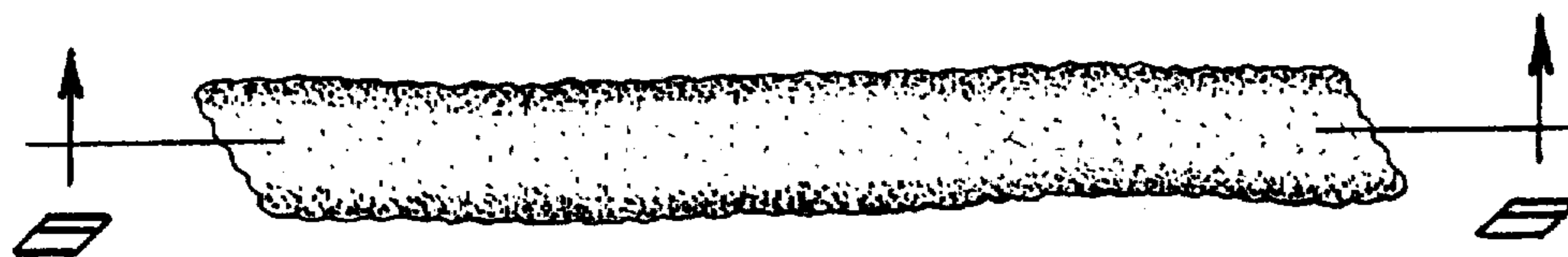

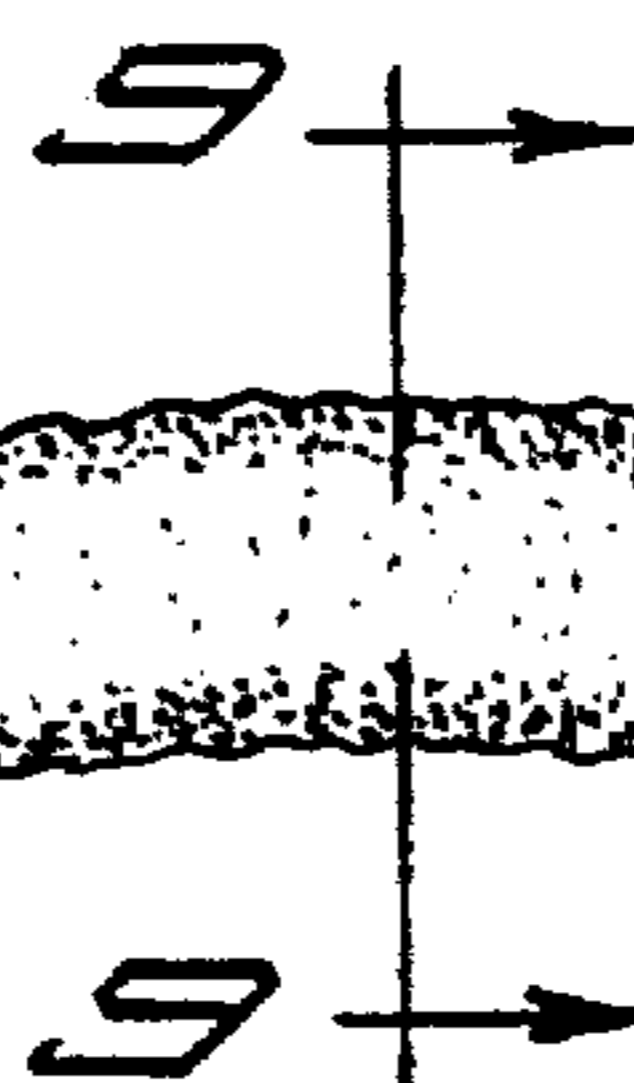

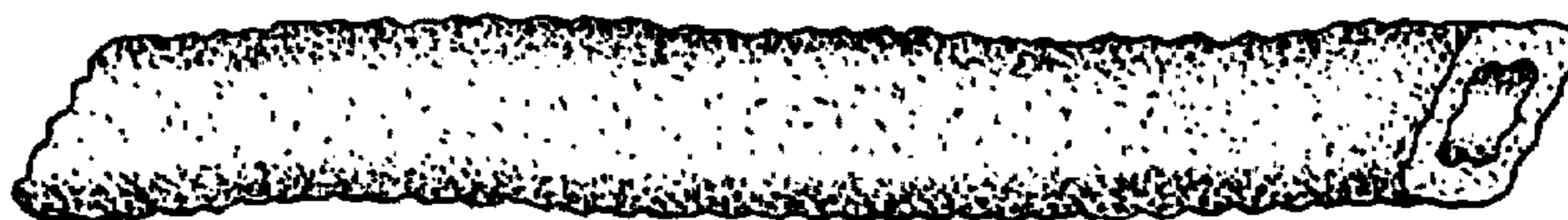

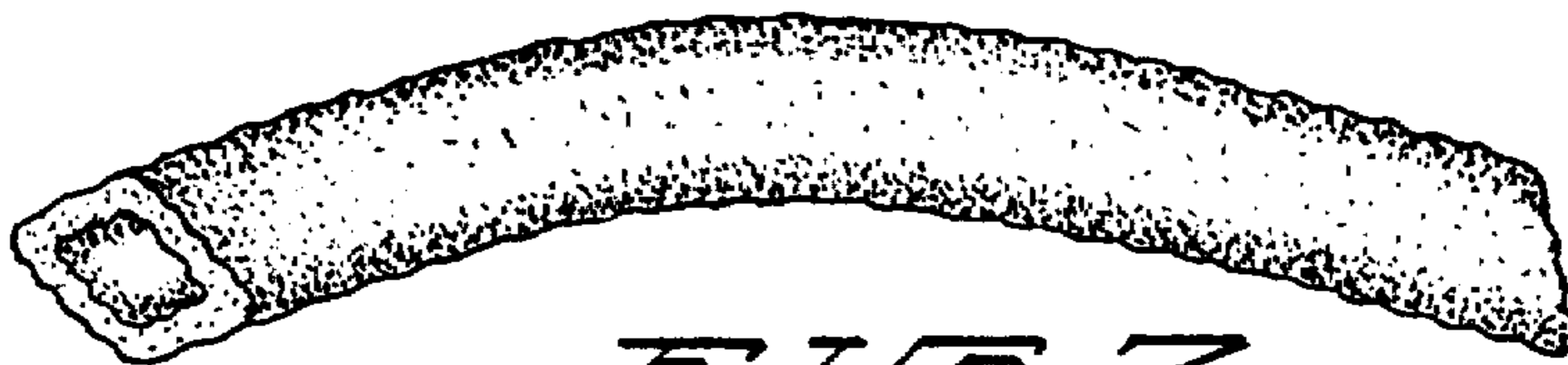

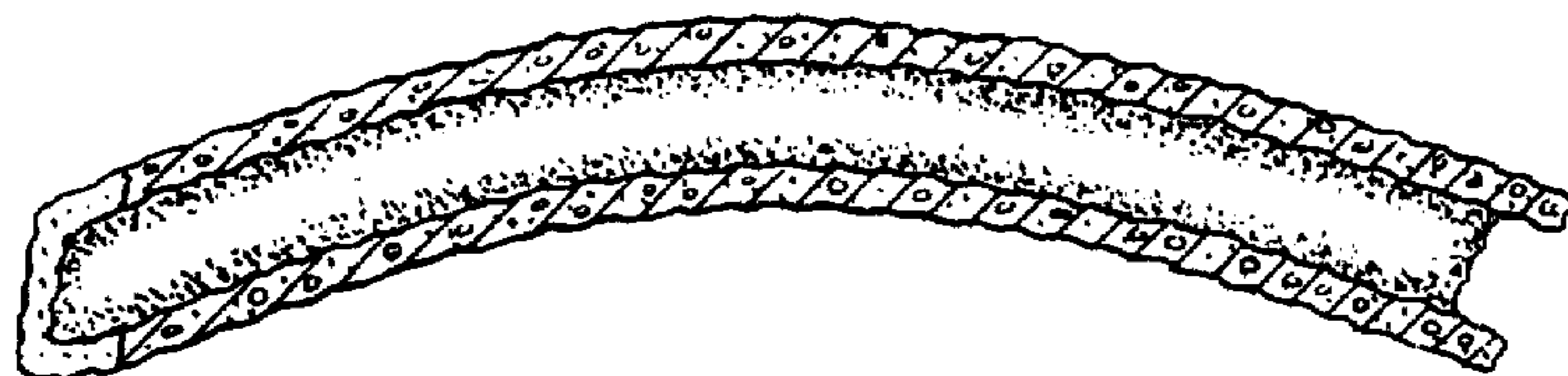
