[57] **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a shoe outsole showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a cross-sectional view taken along the line 3—3 of FIG. 2;

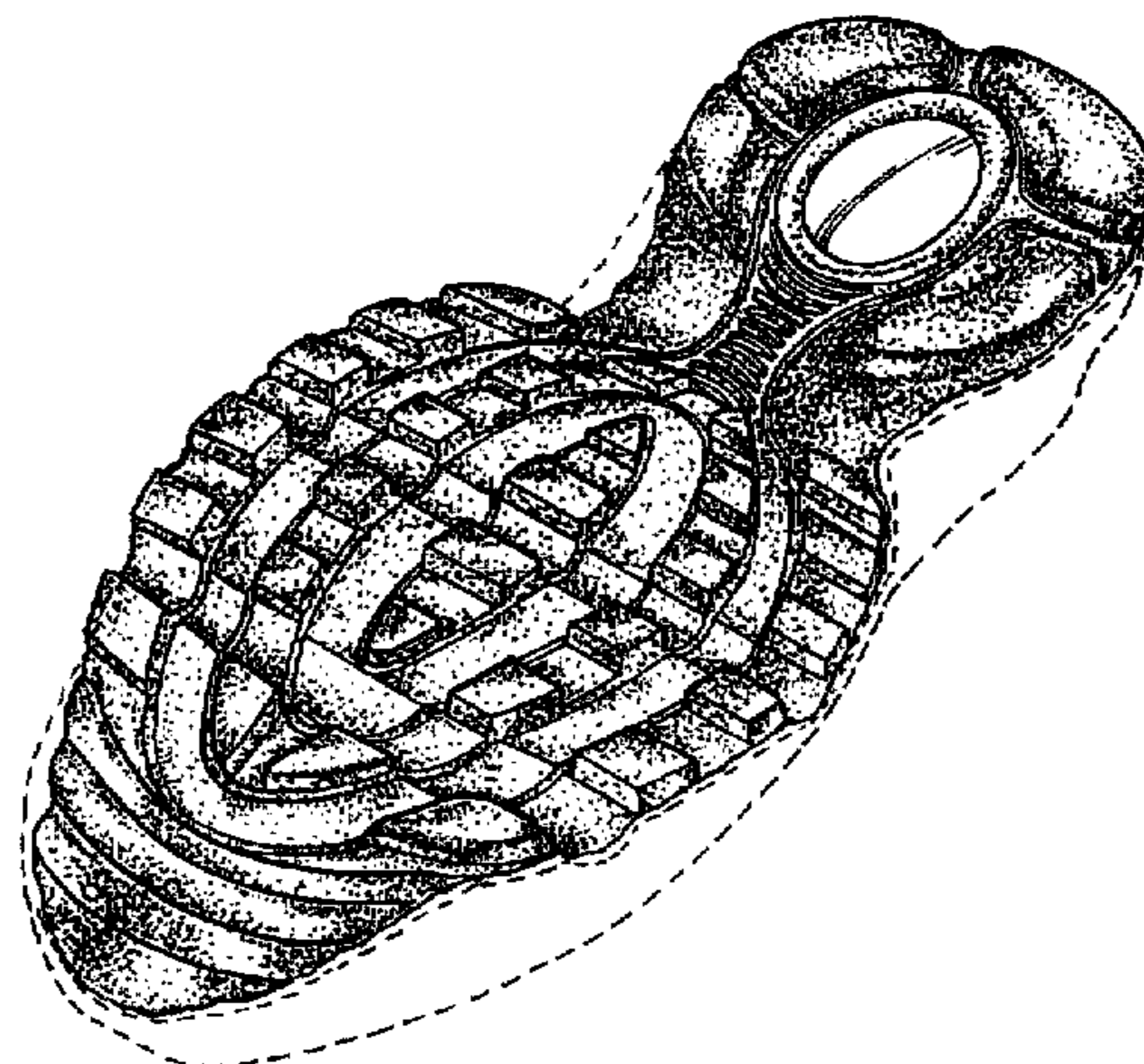
FIG. 4 is a cross-sectional view taken along the line 4—4 of FIG. 2;

FIG. 5 is a cross-sectional view taken along the line 5—5 of FIG. 2; and,

FIG. 6 is a cross-sectional view taken along the line 6—6 of FIG. 2.

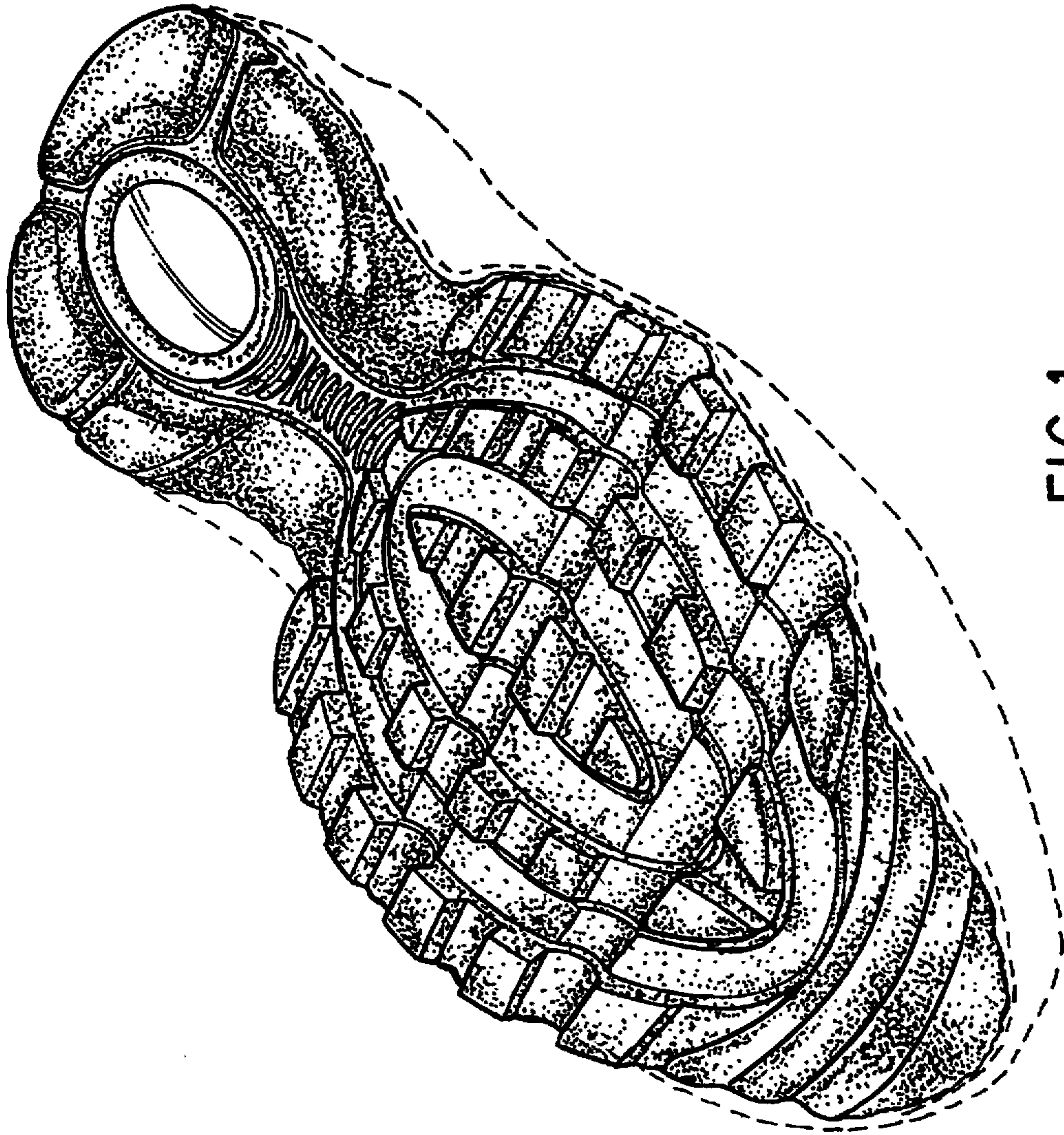

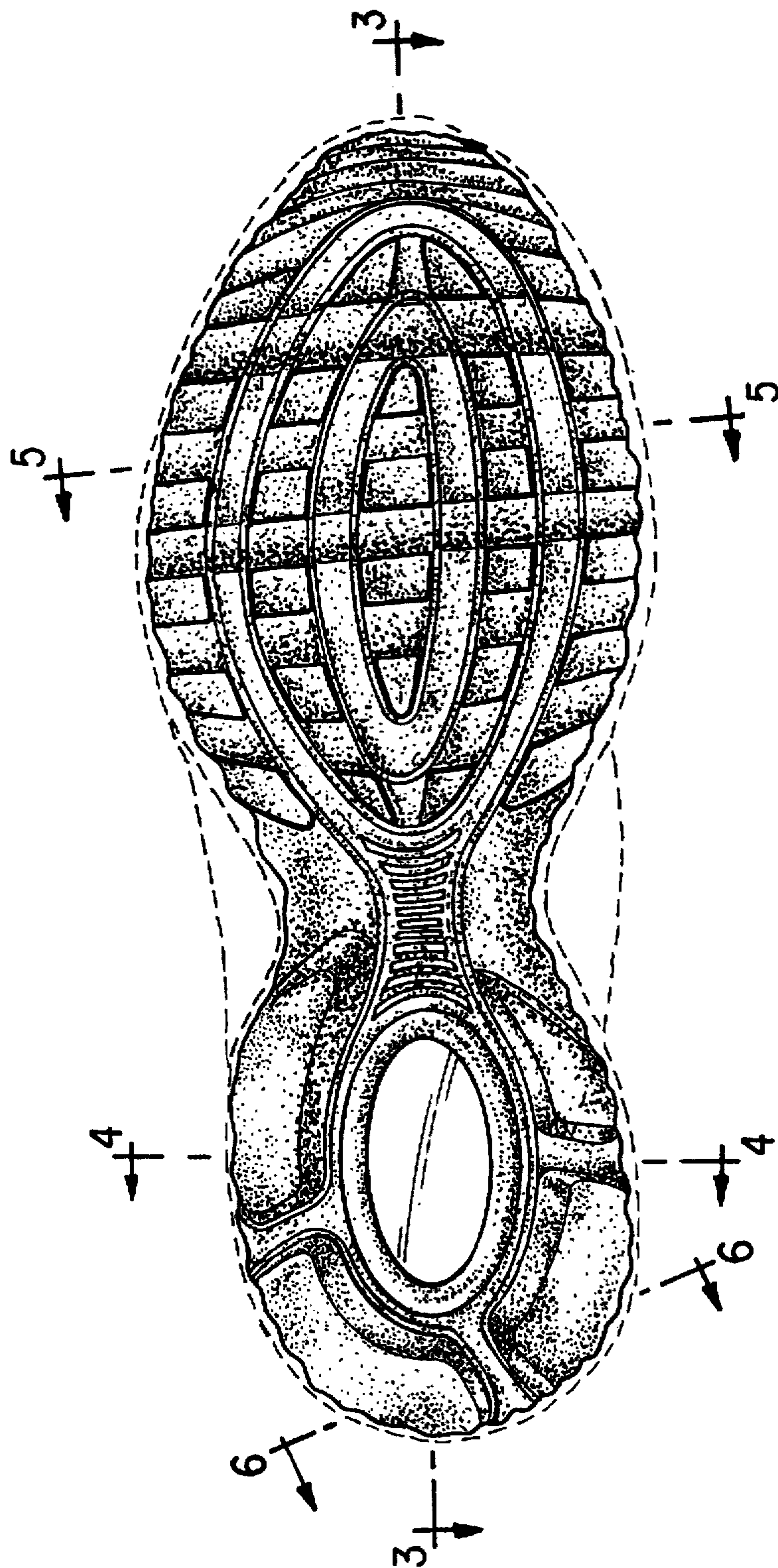

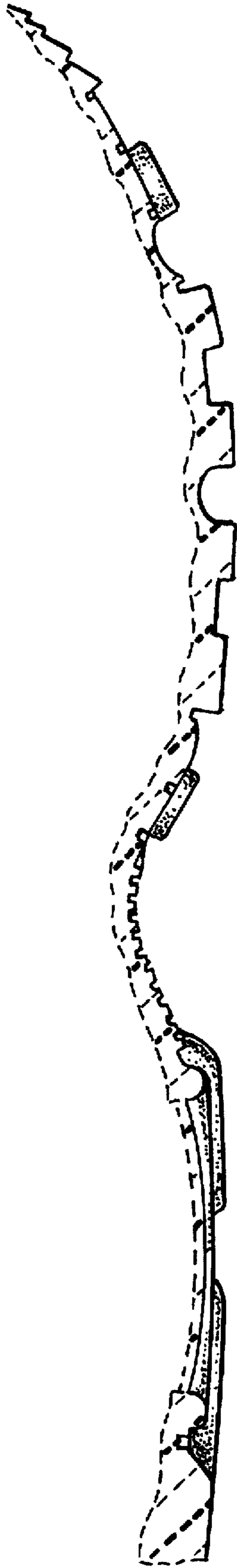
