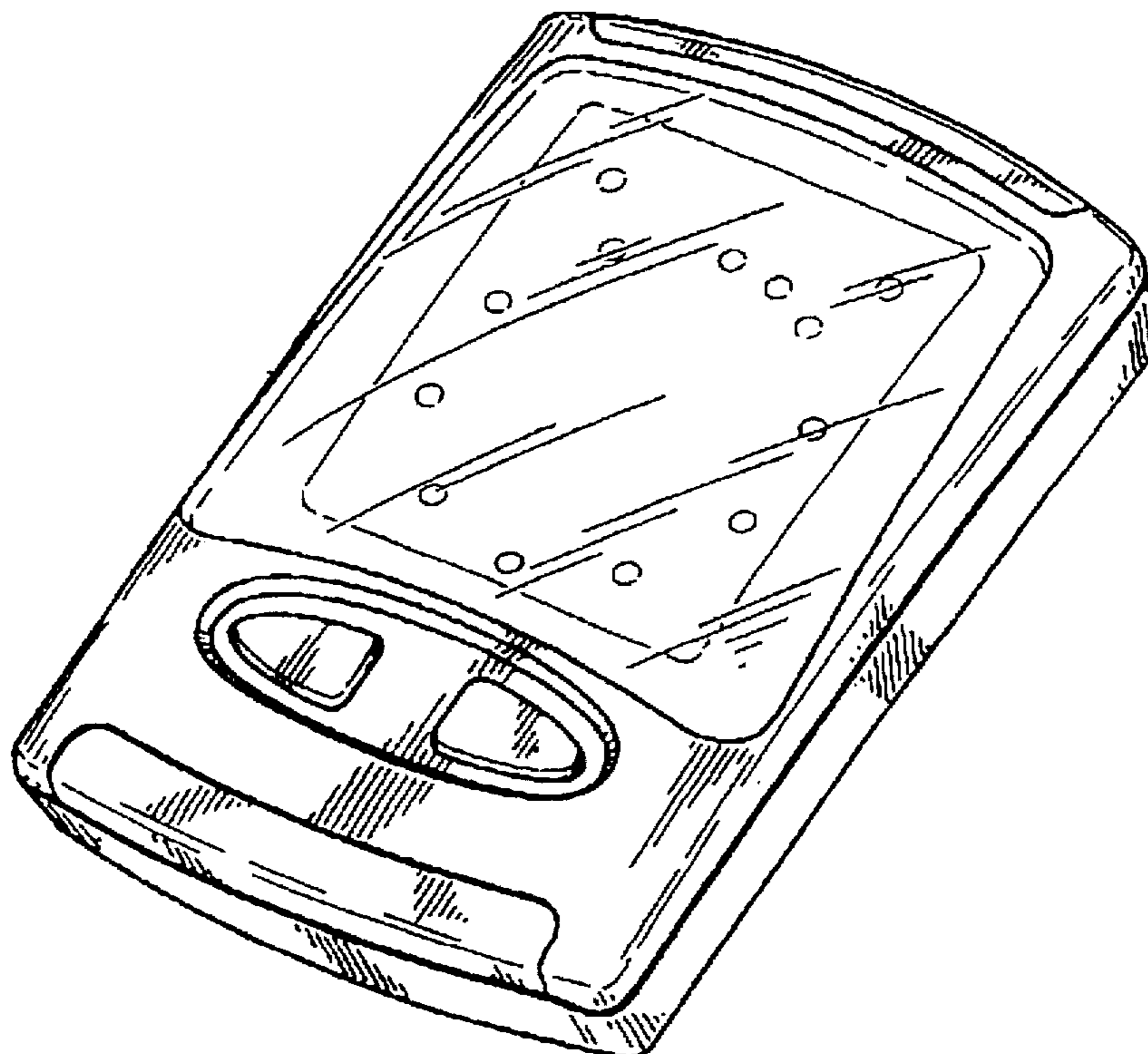
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of the automatic timer and altimeter;
FIG. 2 is a bottom perspective view thereof;

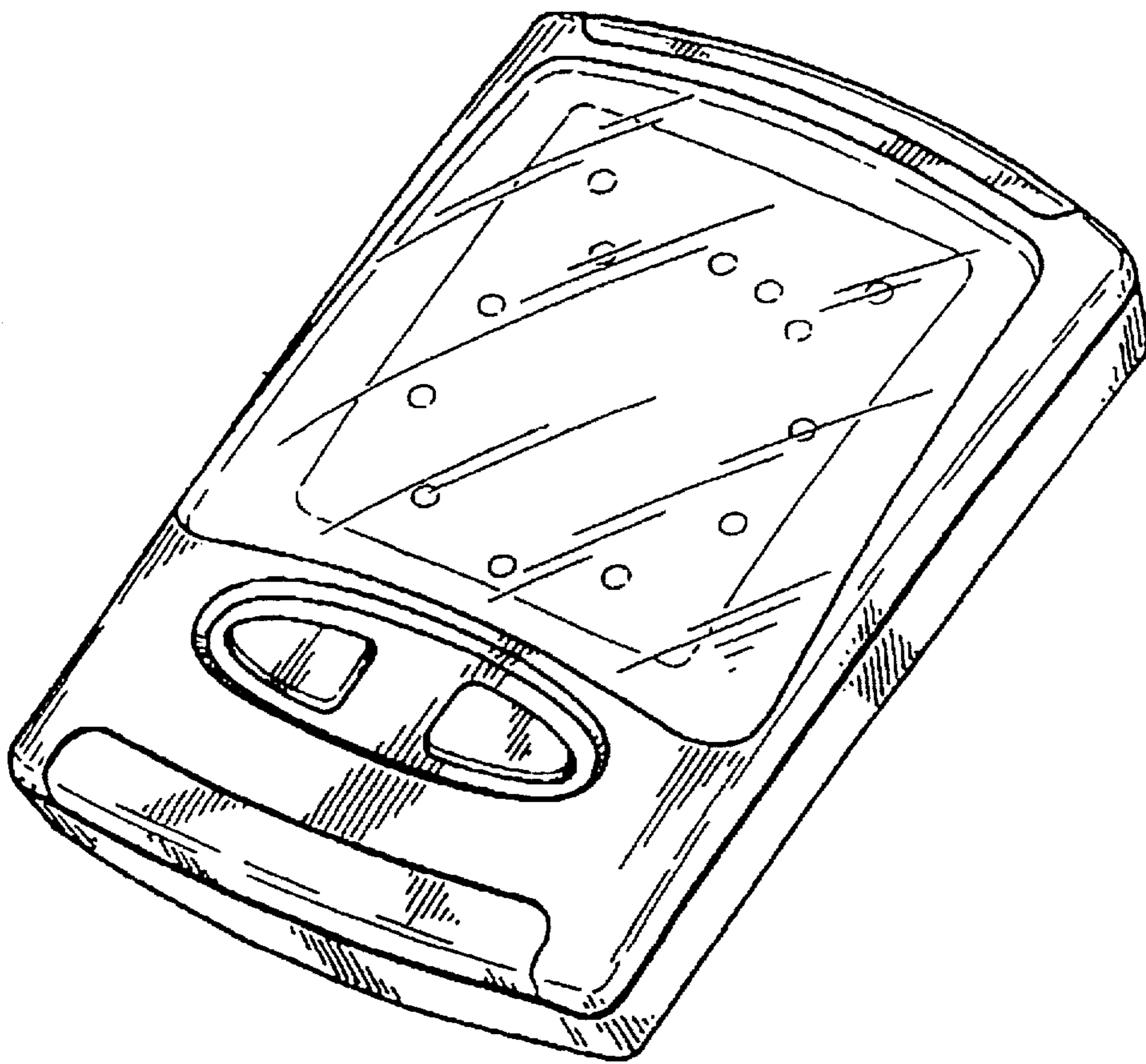

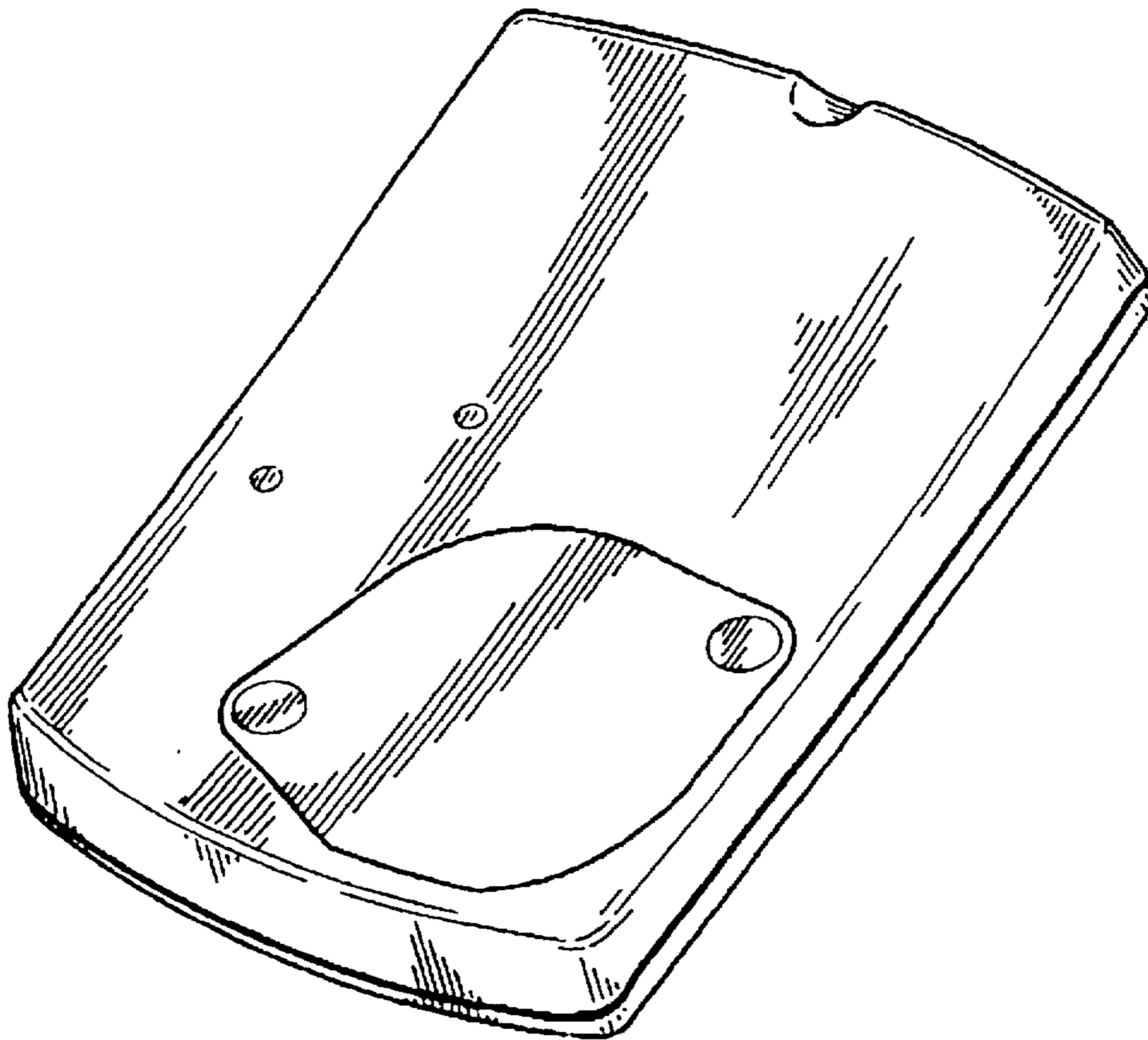

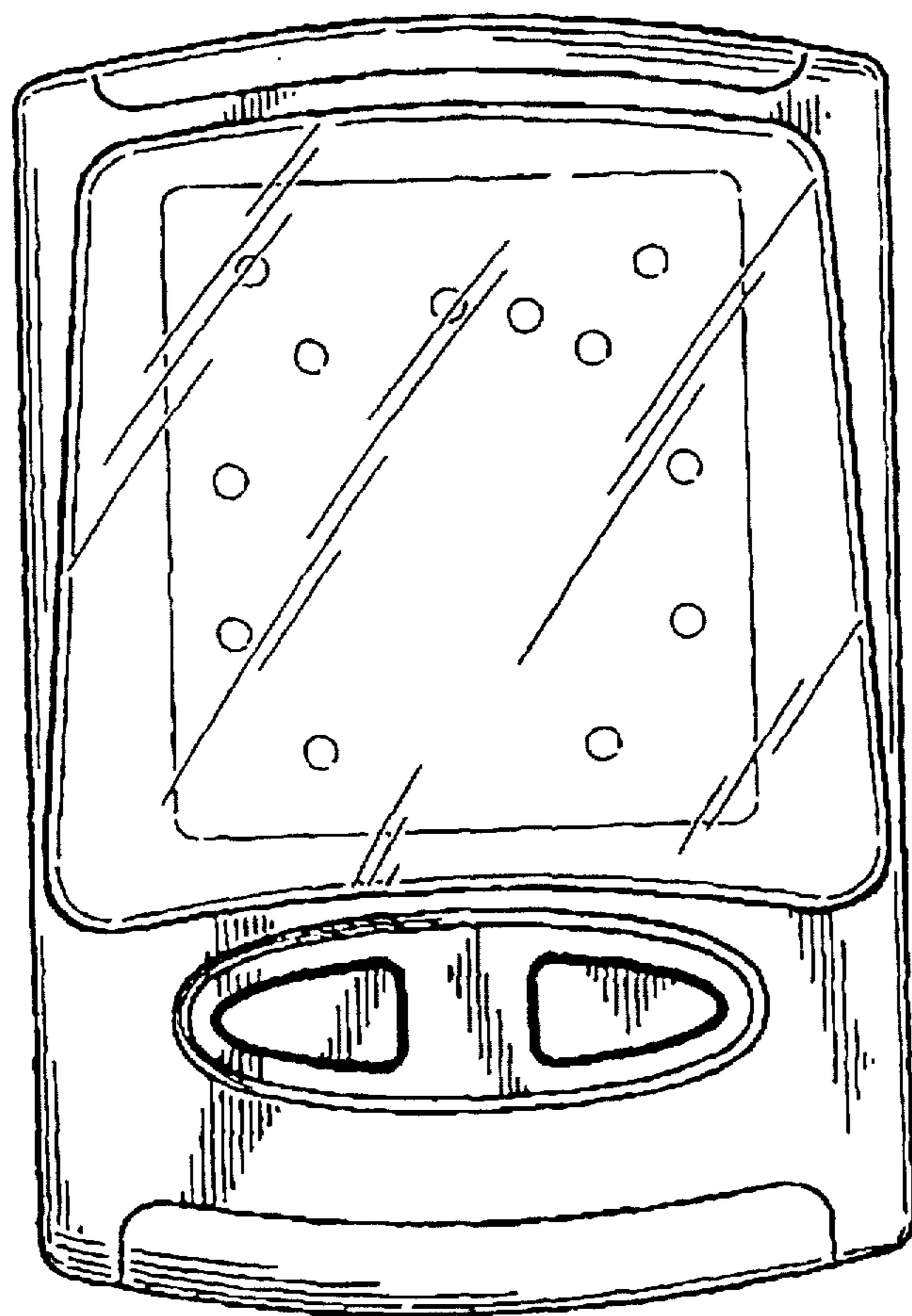

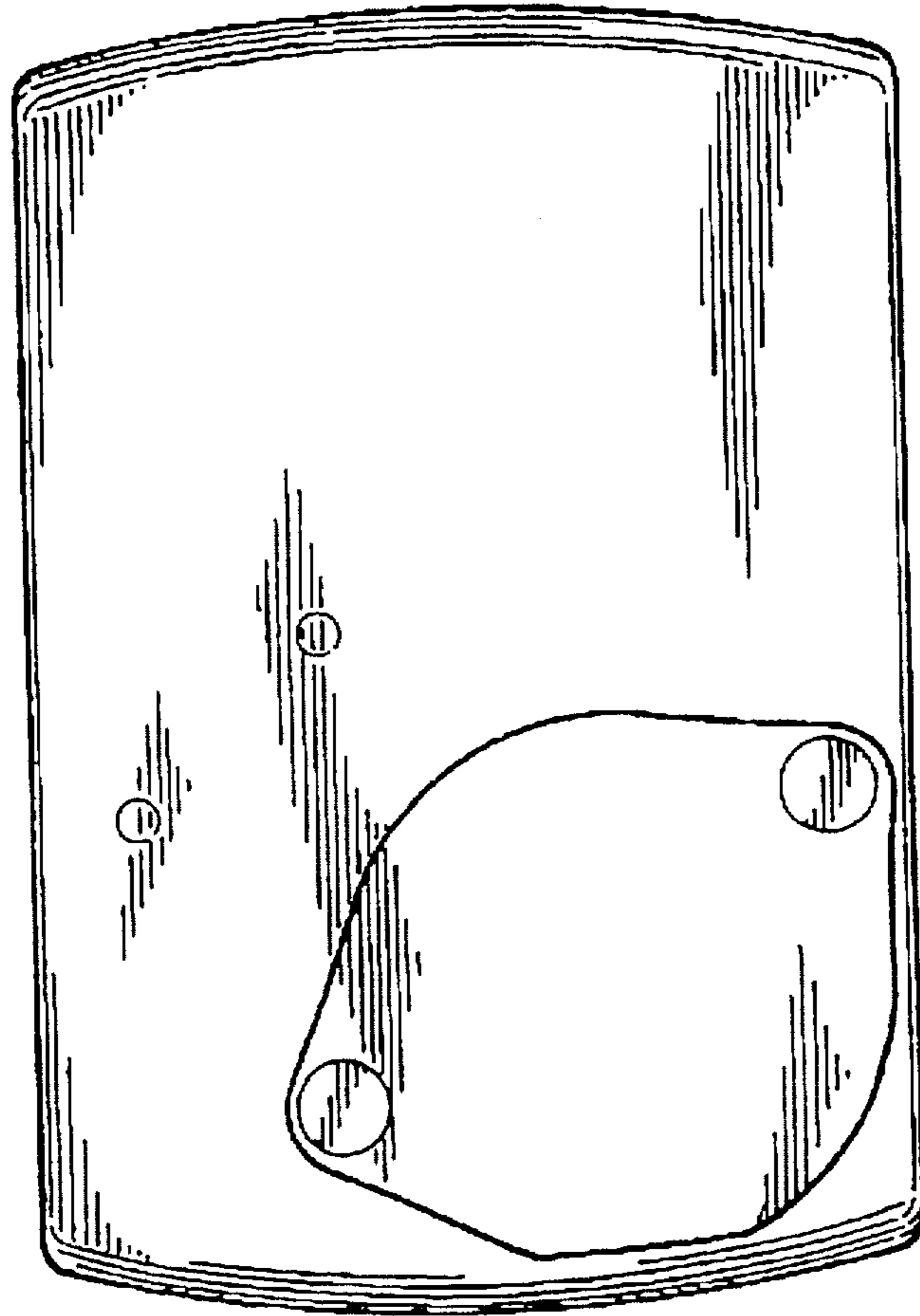

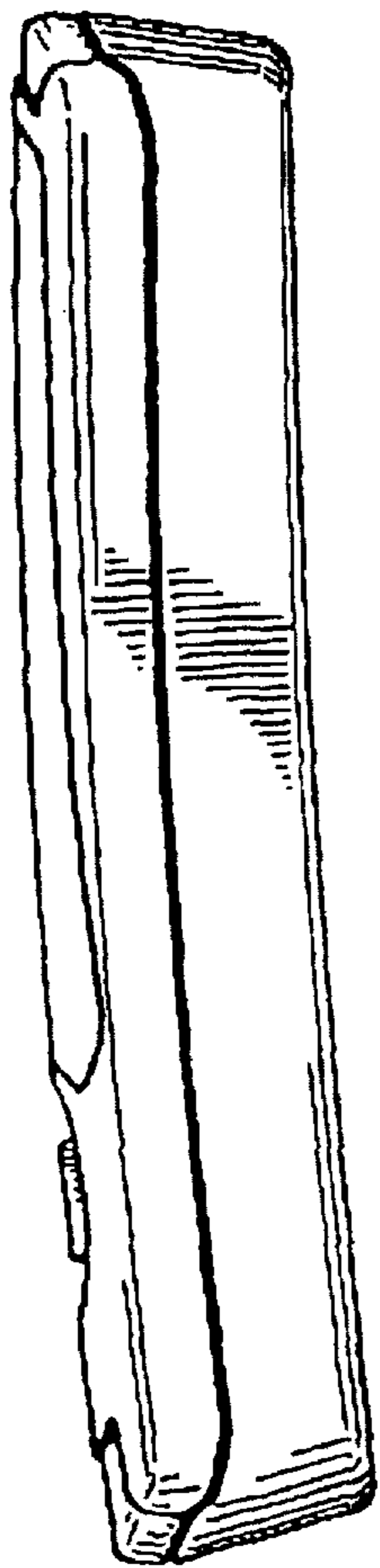

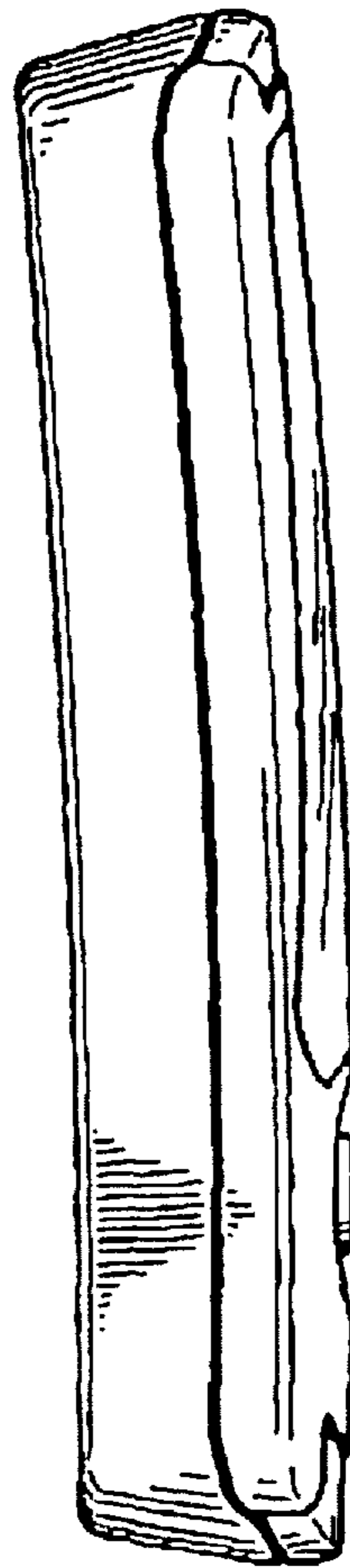

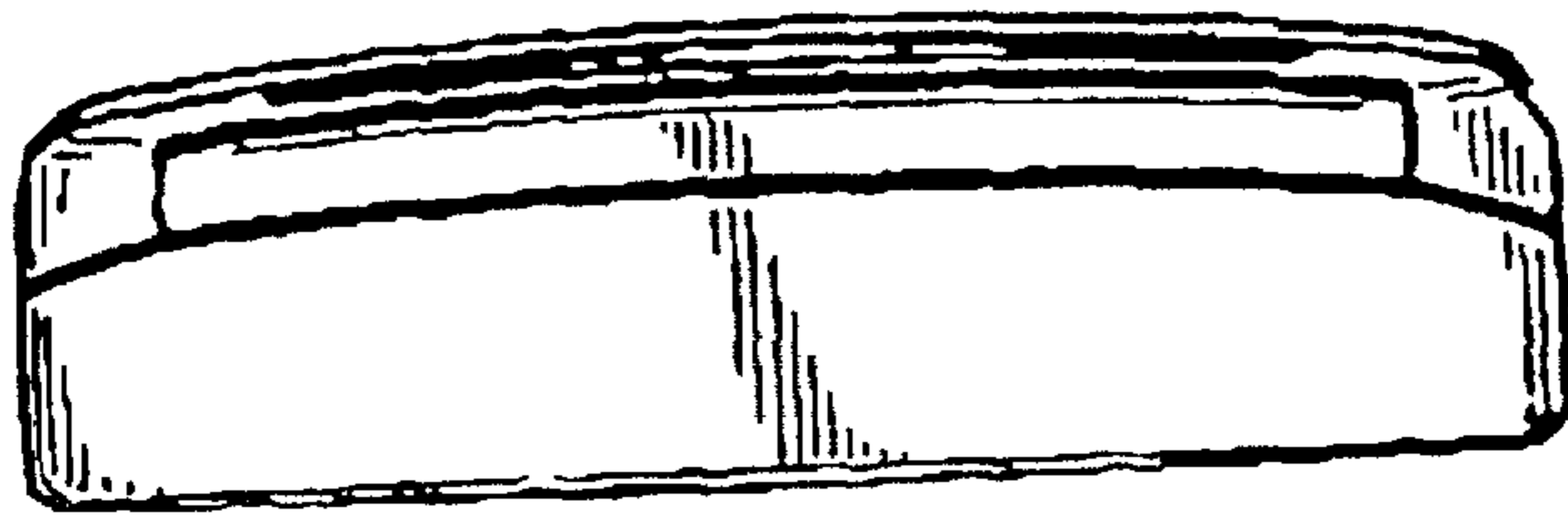

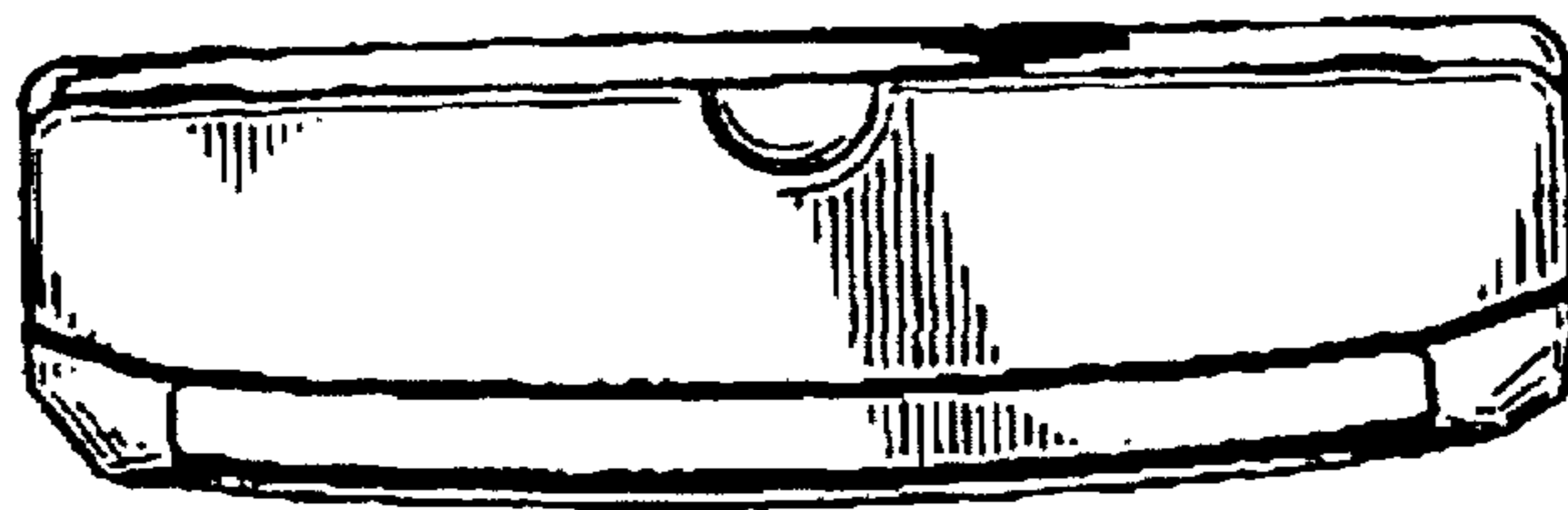
