The ornamental design for a soap bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a soap bar showing our new design;

FIG. 2 is a front end elevational view thereof, the opposite end being a mirror image;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof, the opposite side being a mirror image; and,

FIG. 5 is a bottom plan view thereof.

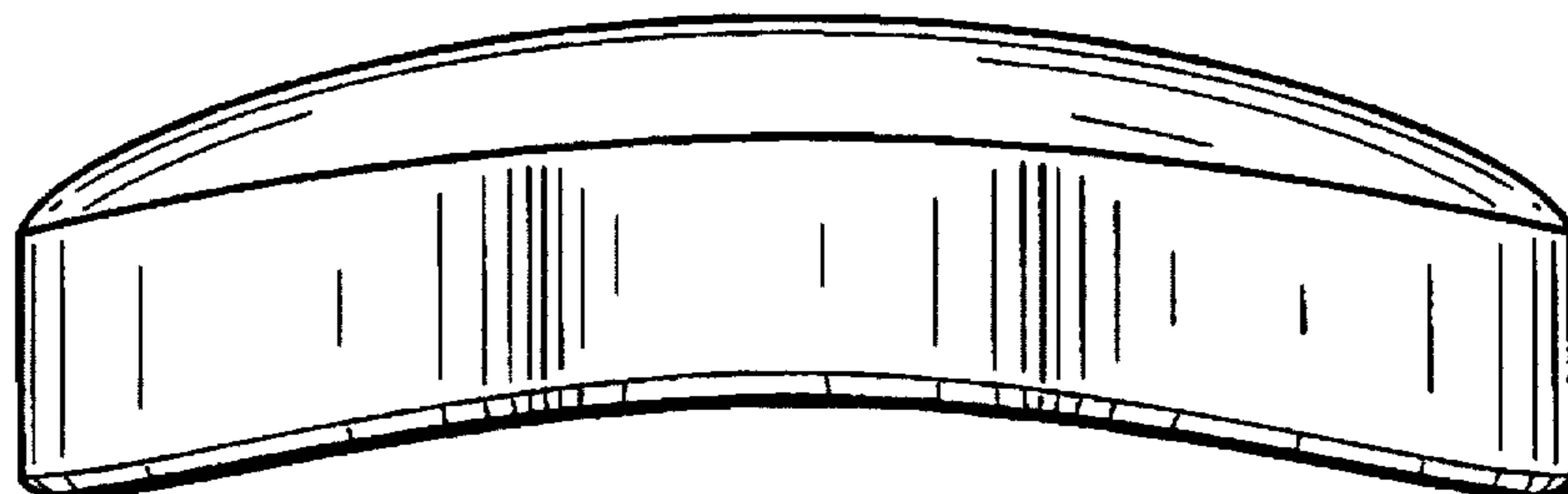
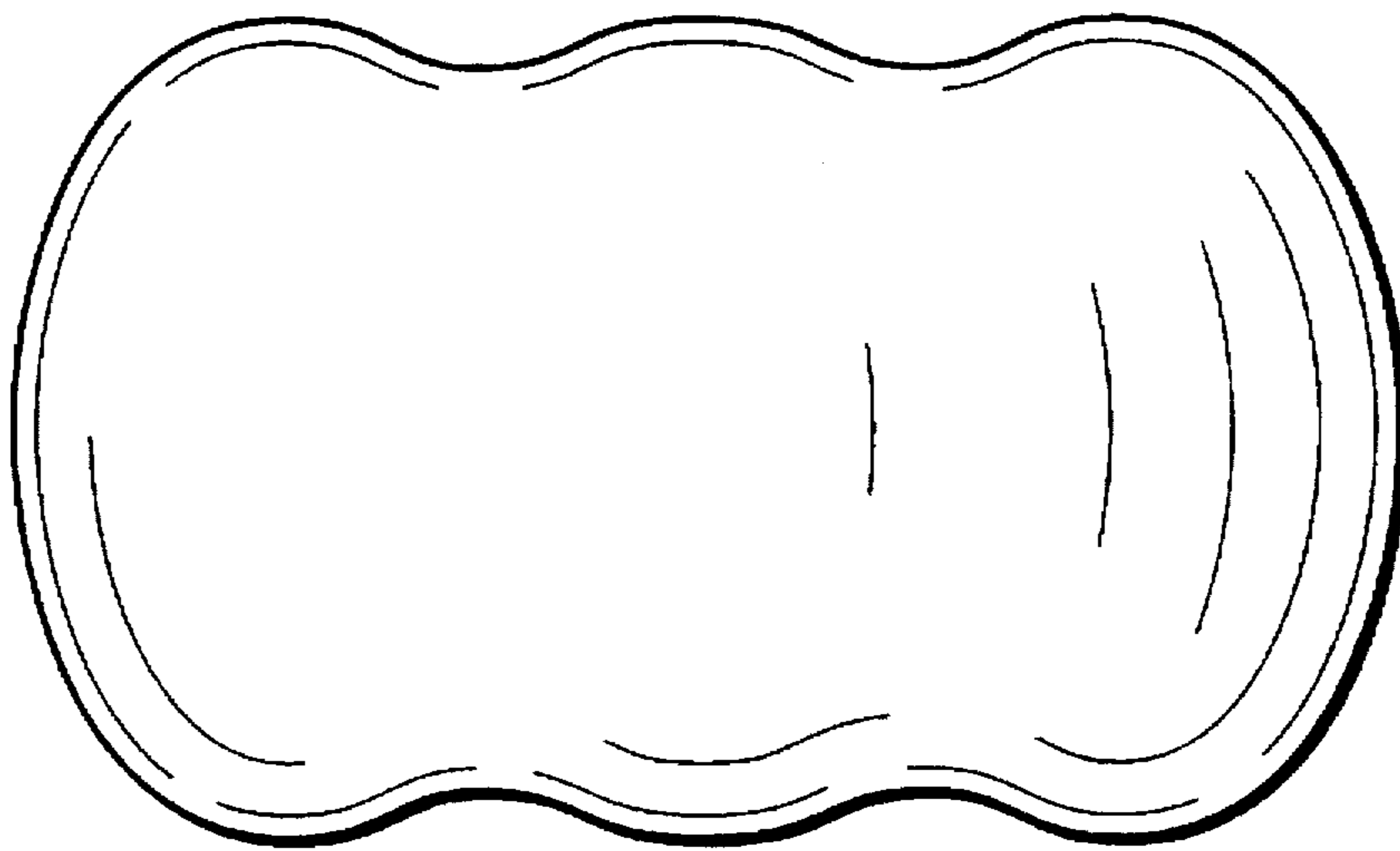

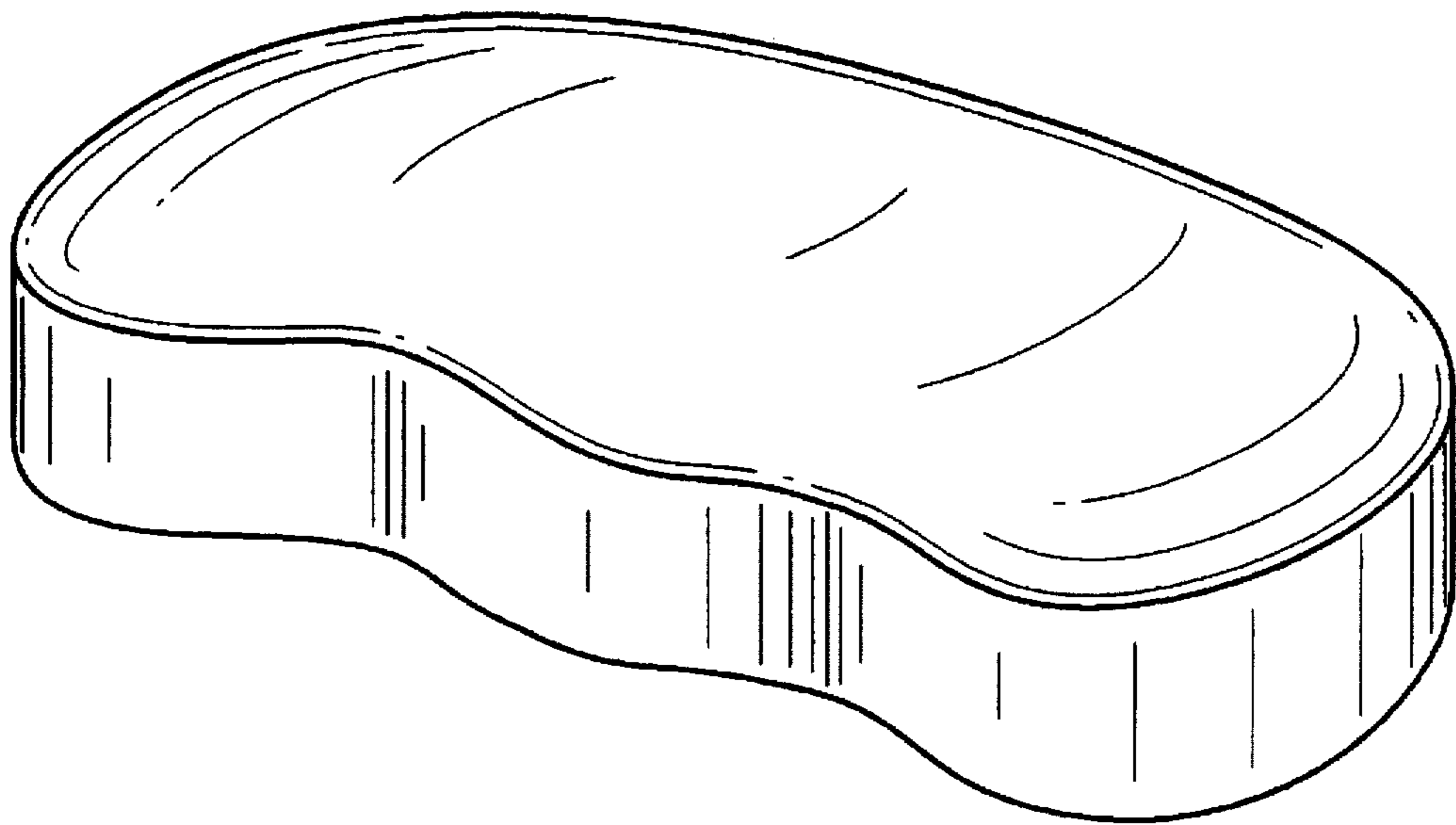

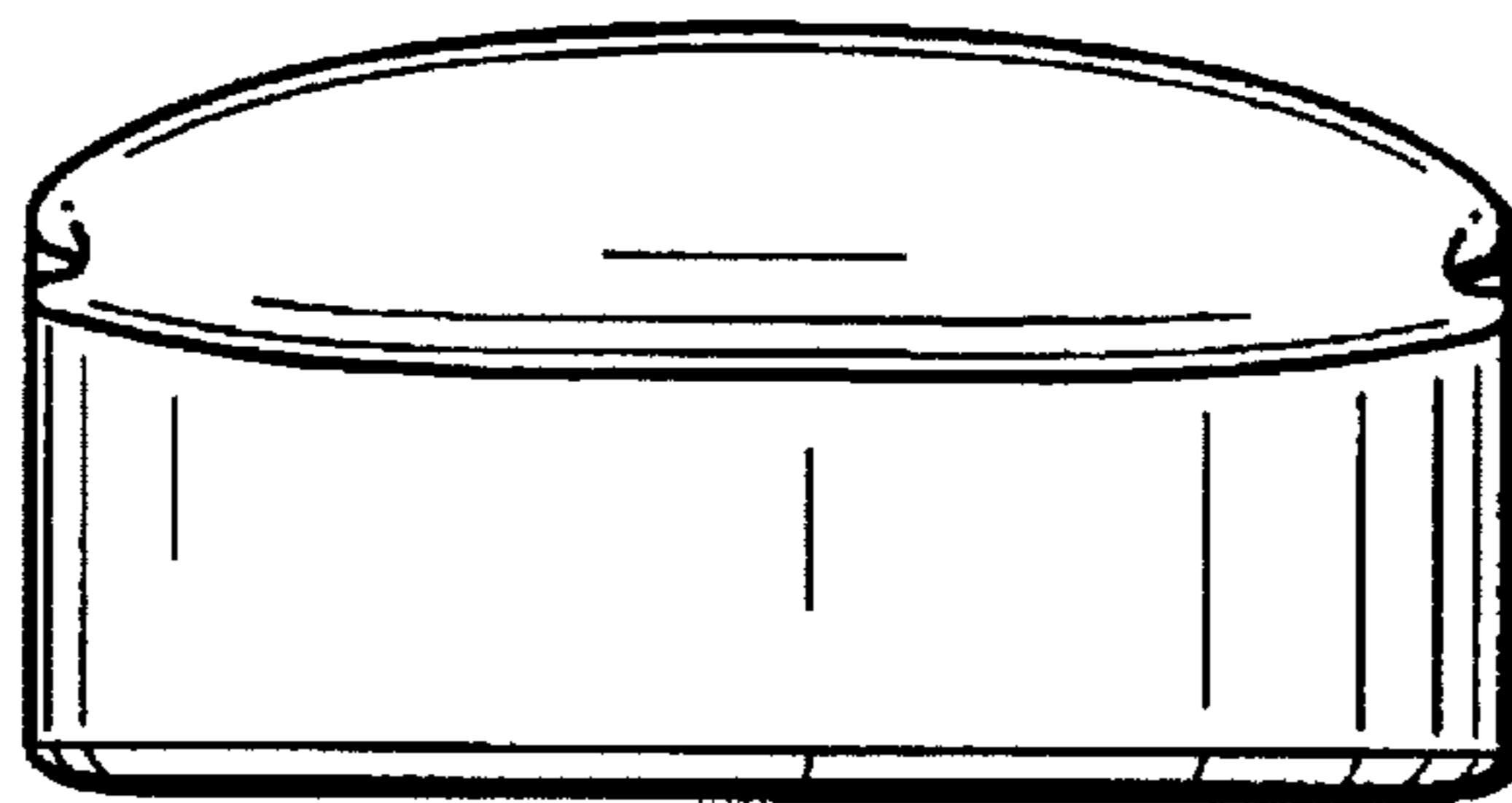

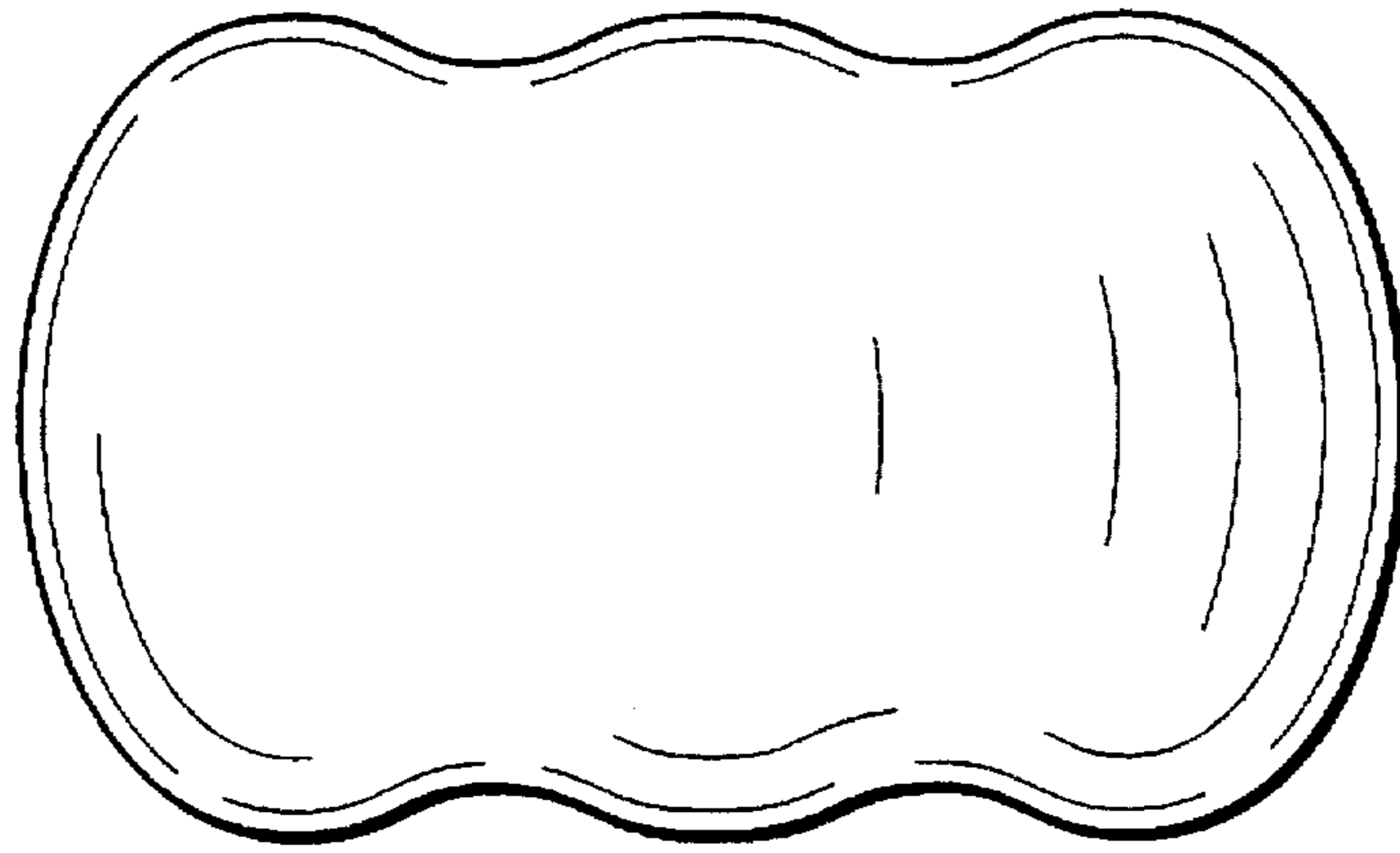

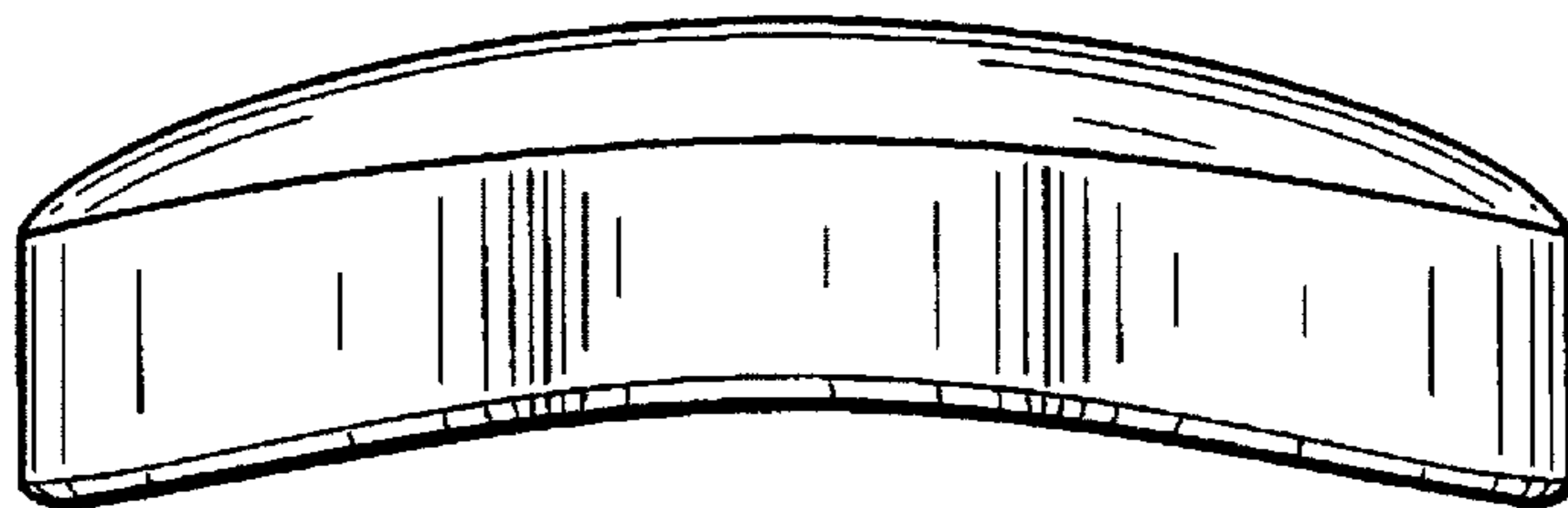
