[57] **CLAIM**

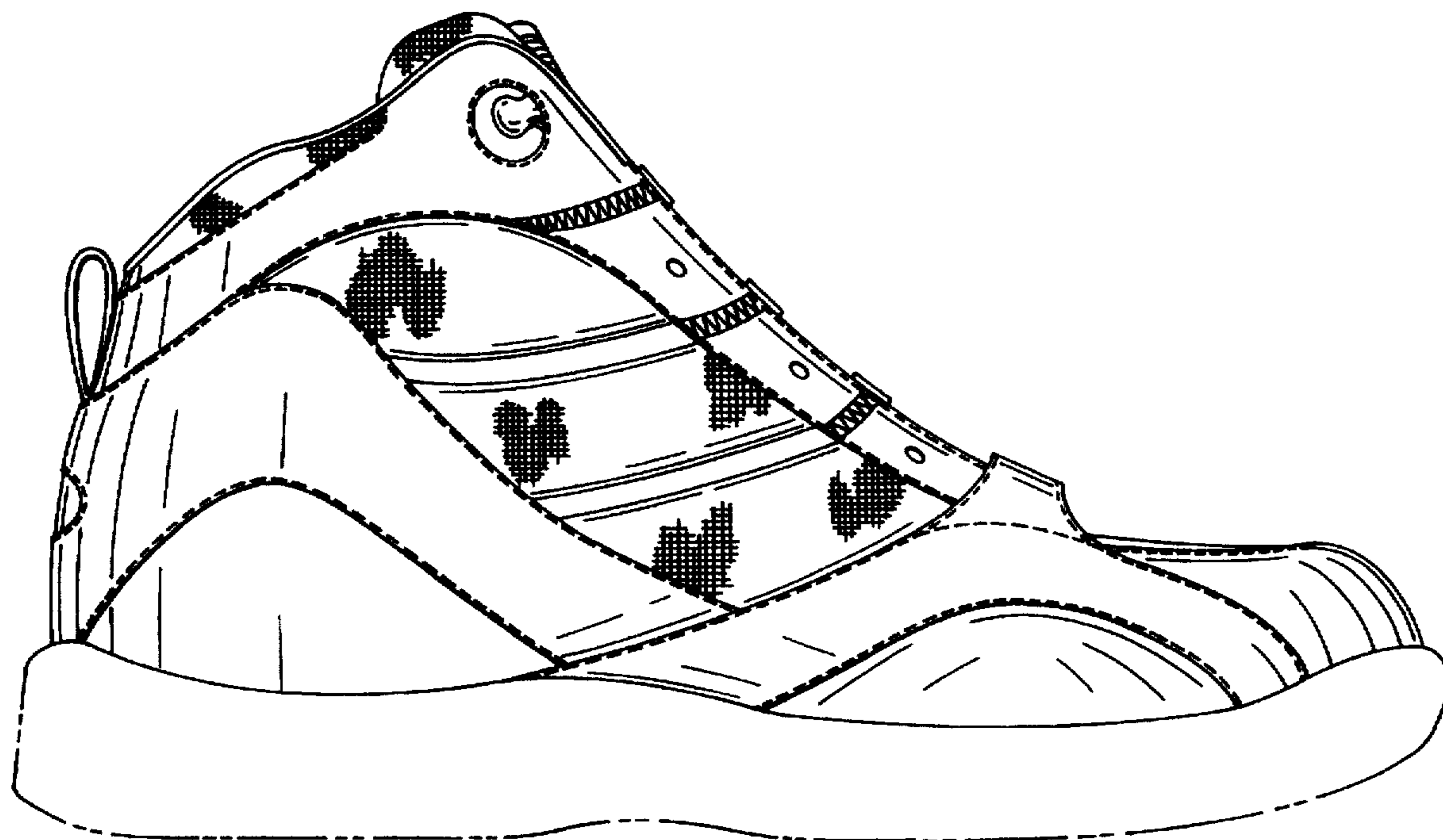
The ornamental design for a sport shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevational view of a sport shoe upper, showing my new design;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof; and,  
FIG. 5 is a top plan view thereof.  
The dashed lines showing a shoe sole in FIGS. 1 -5 are for illustrative purposes only and form no part of the claimed design.

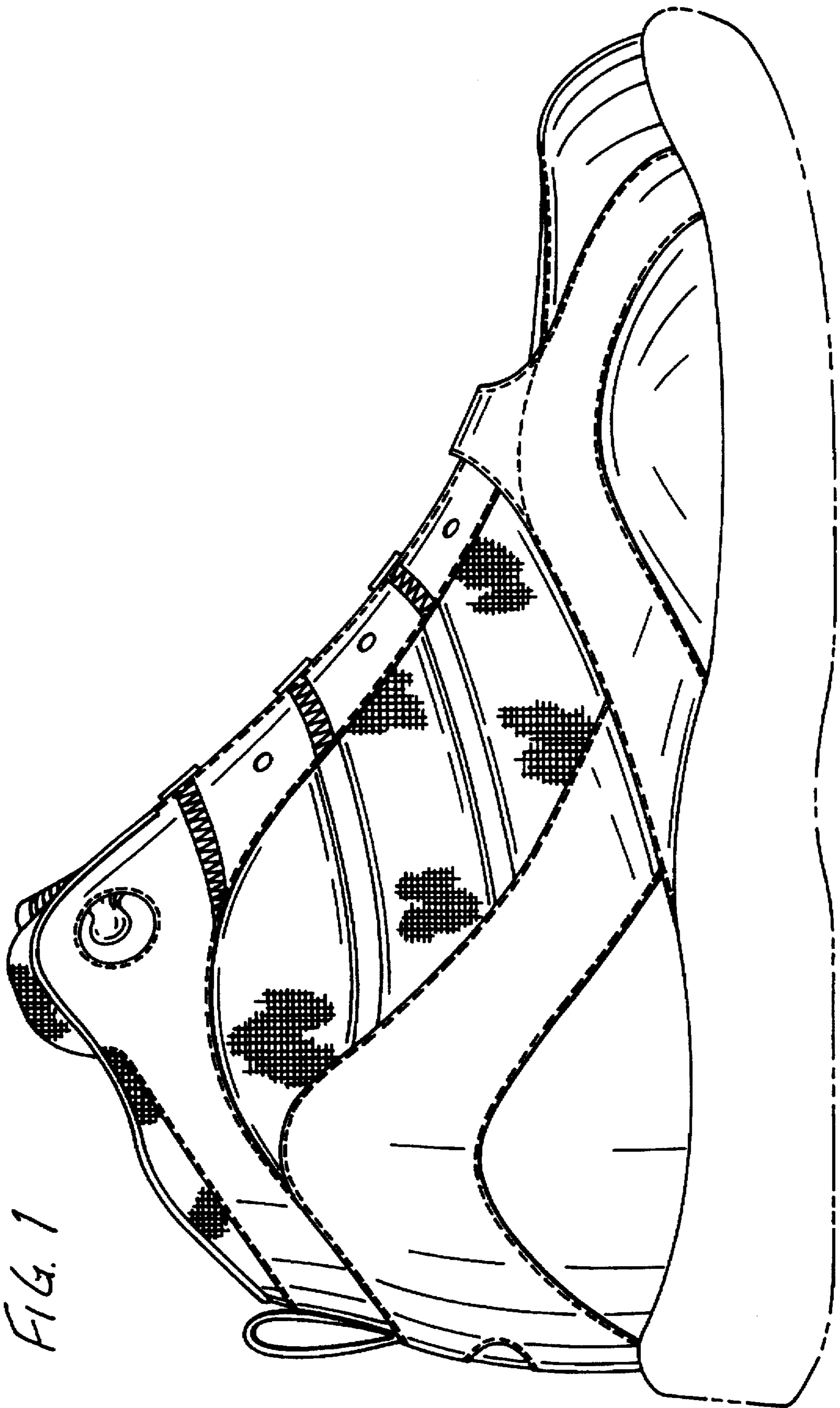

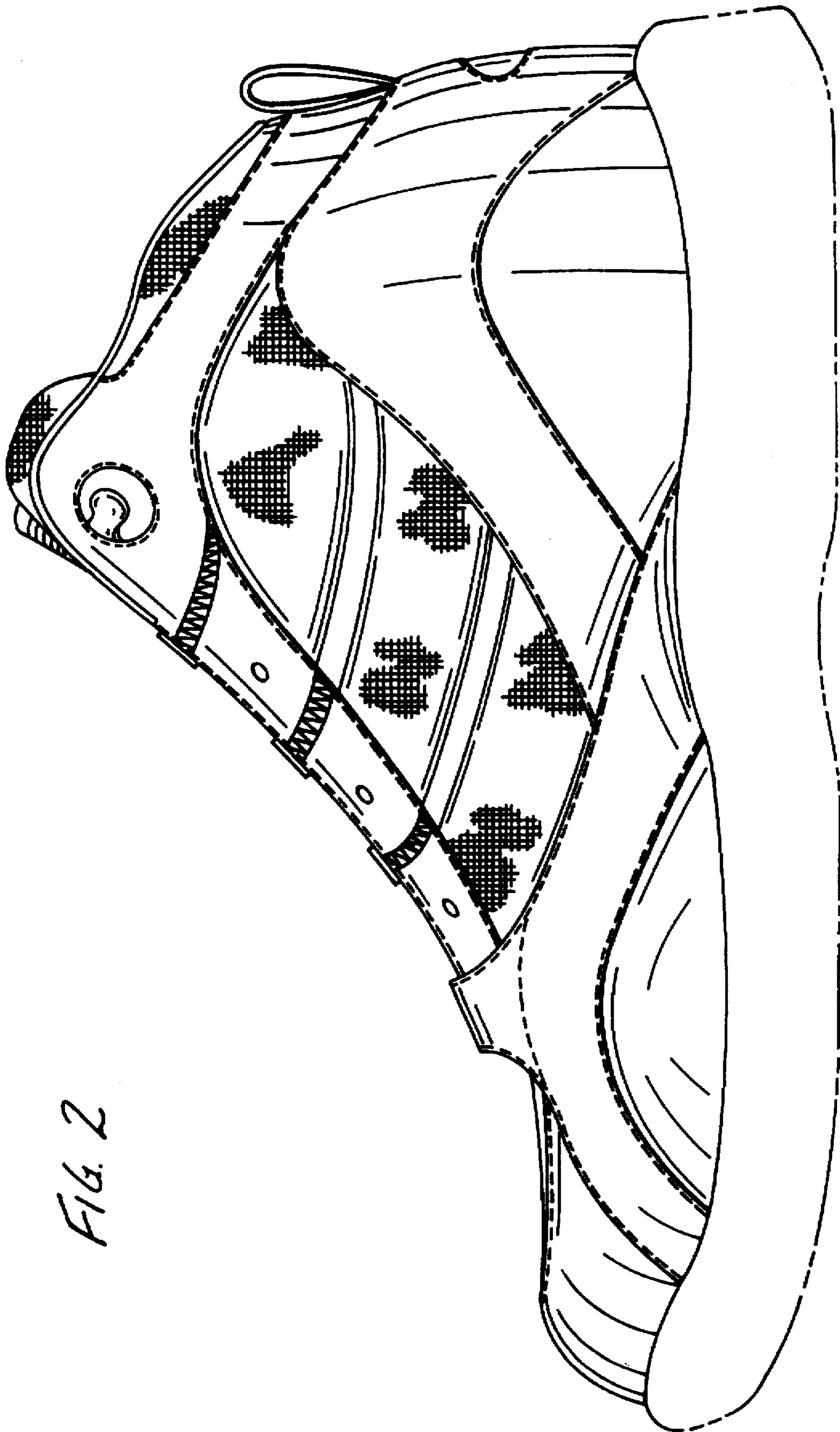

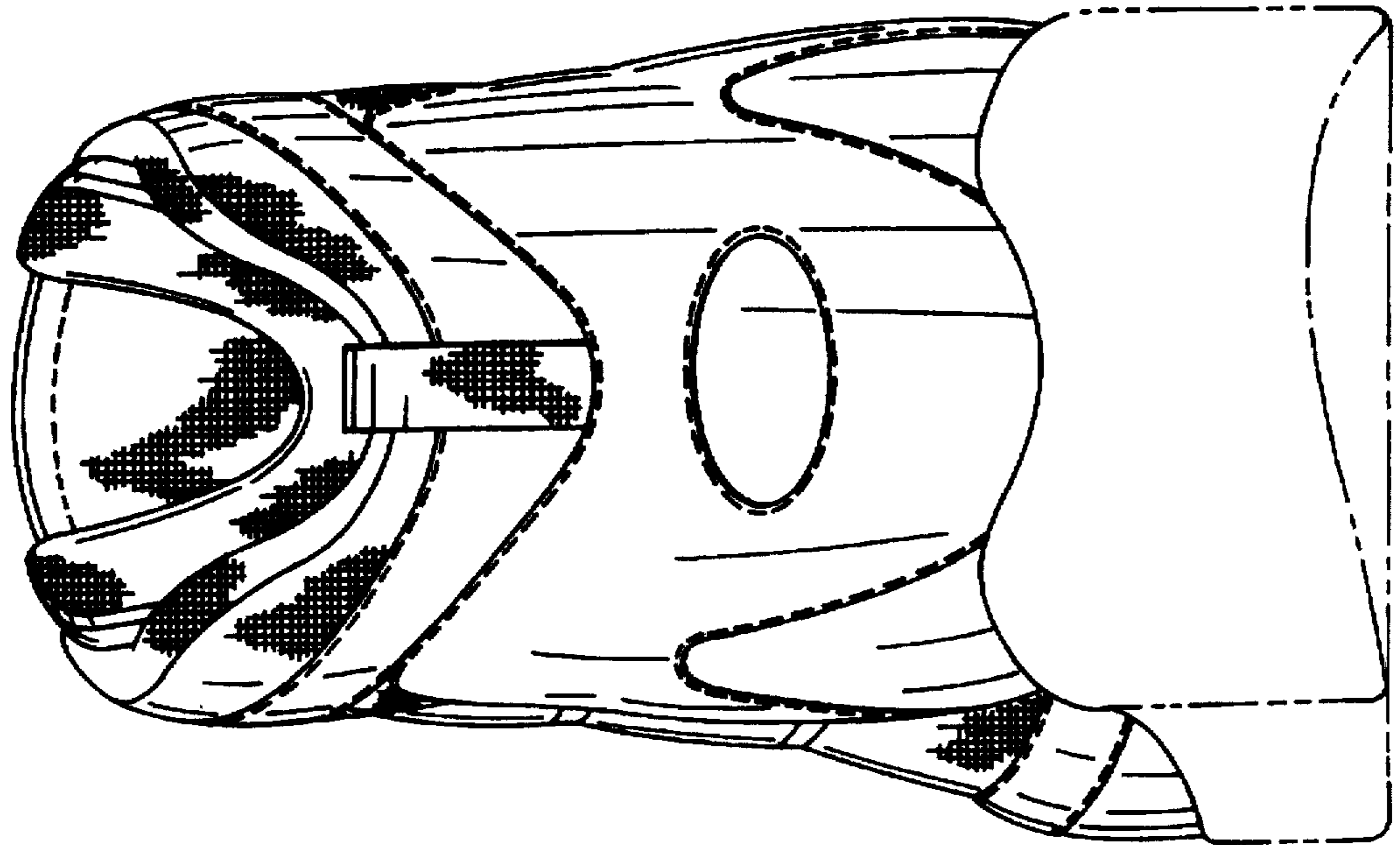
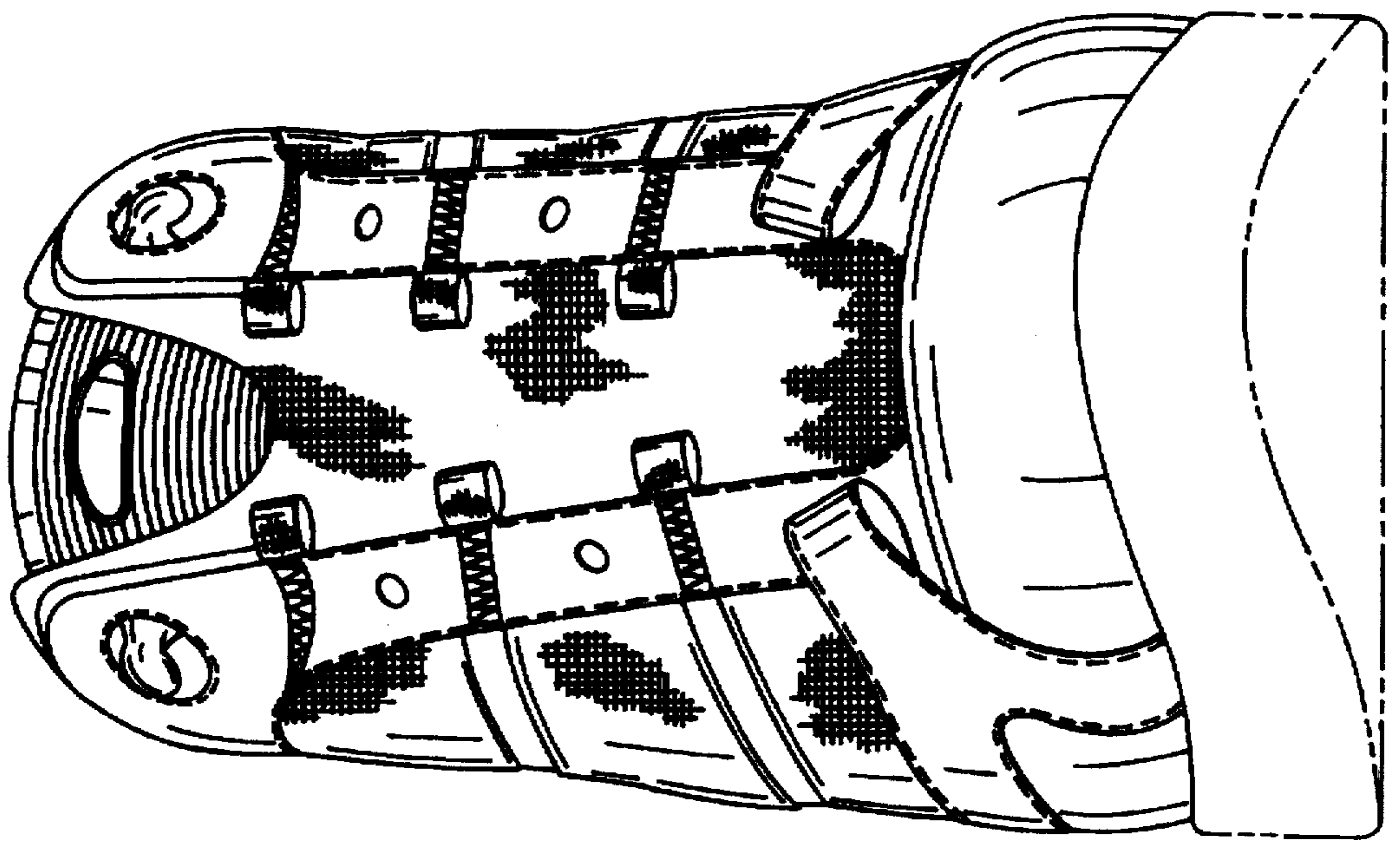

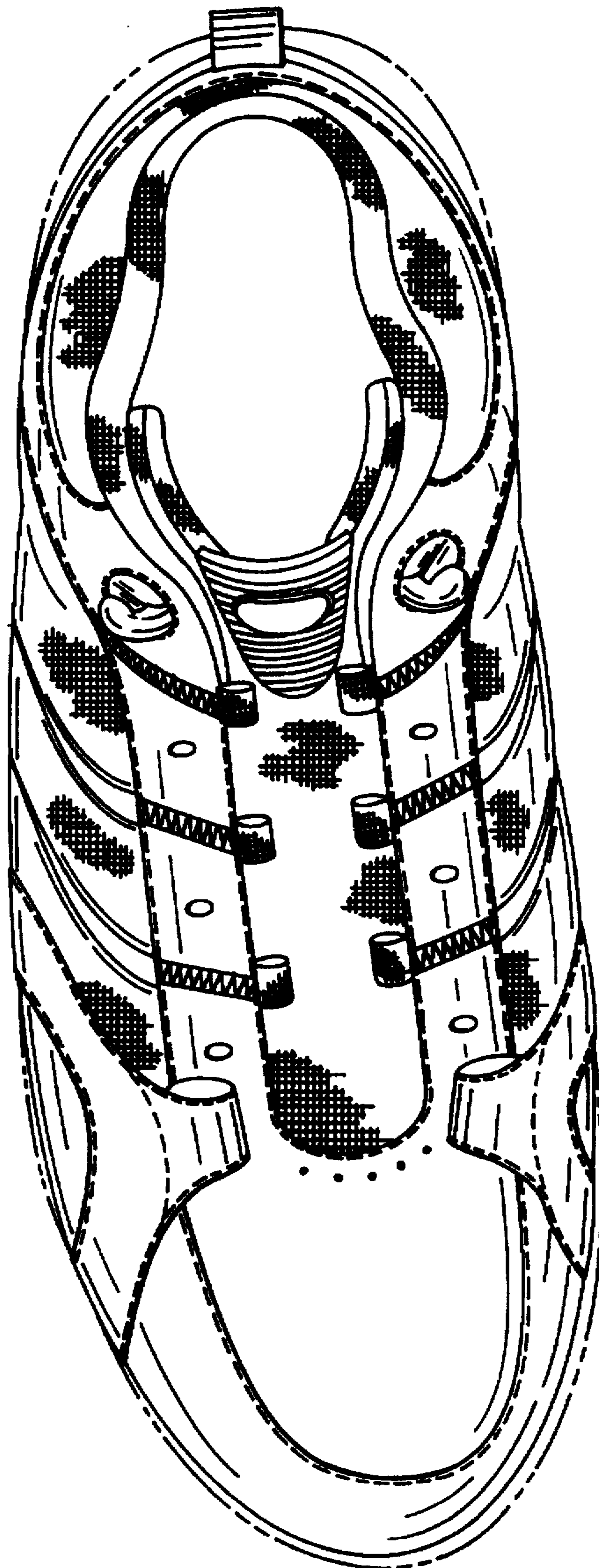
