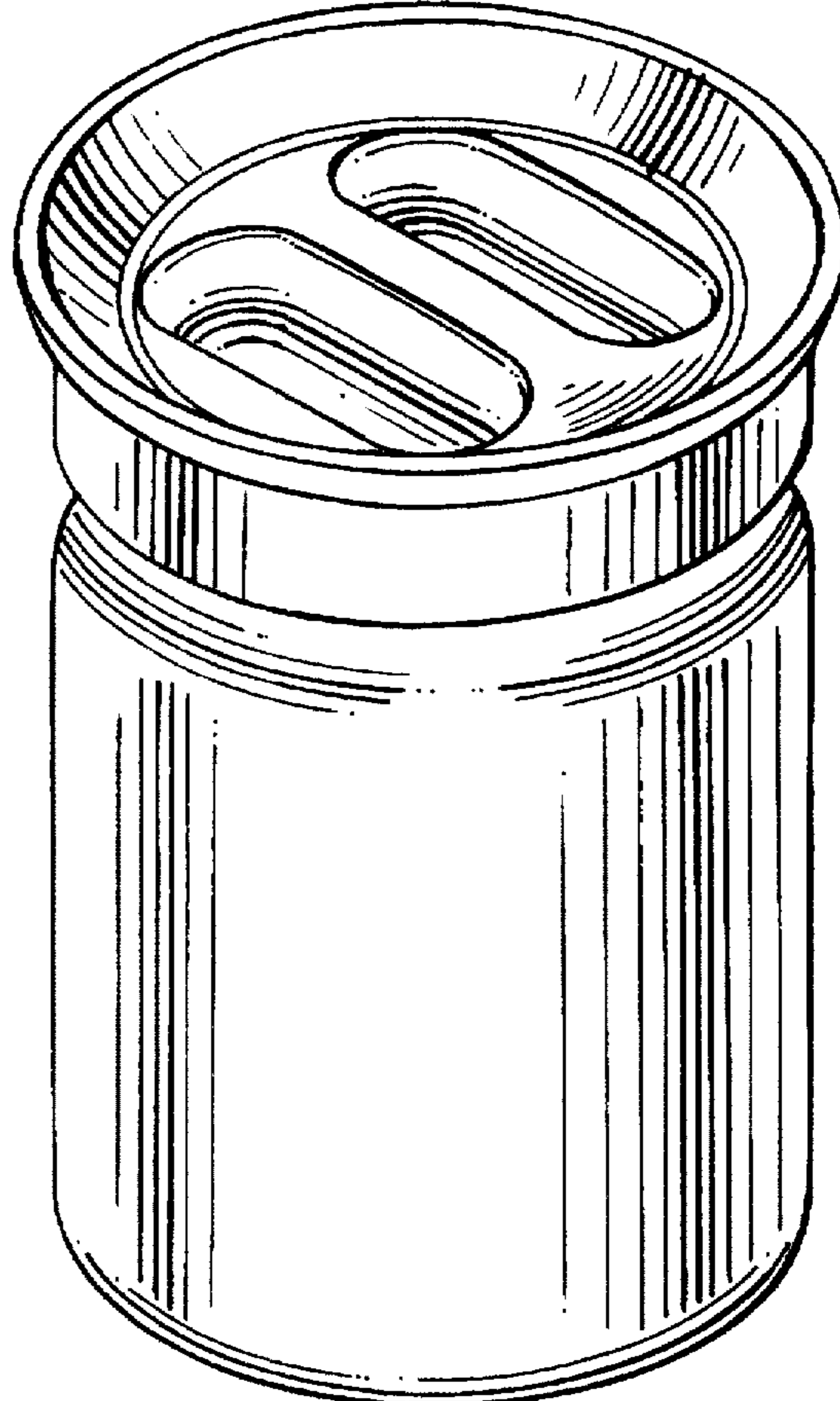
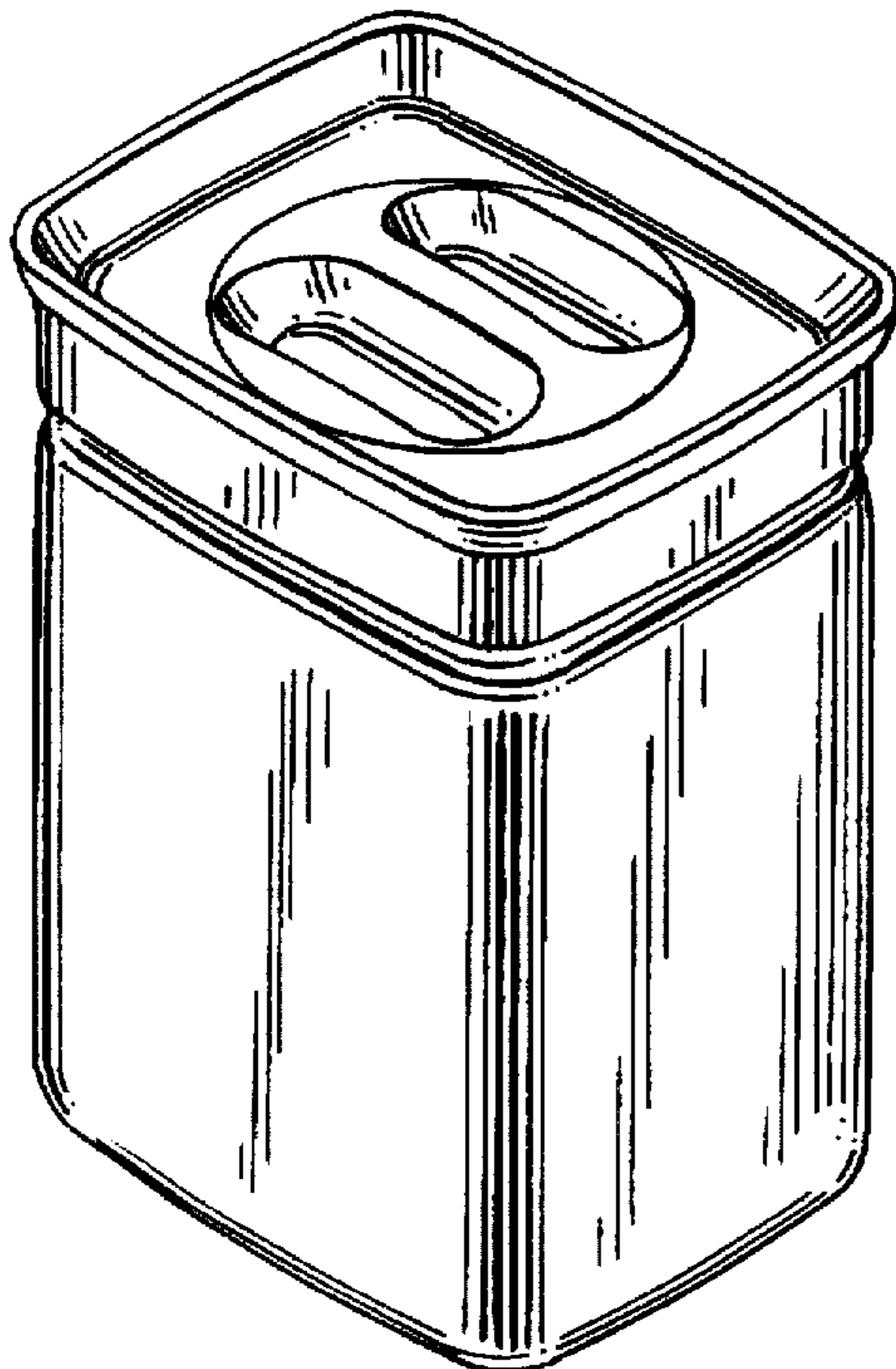
The ornamental design for a stackable container with removable cover member, as shown and described.

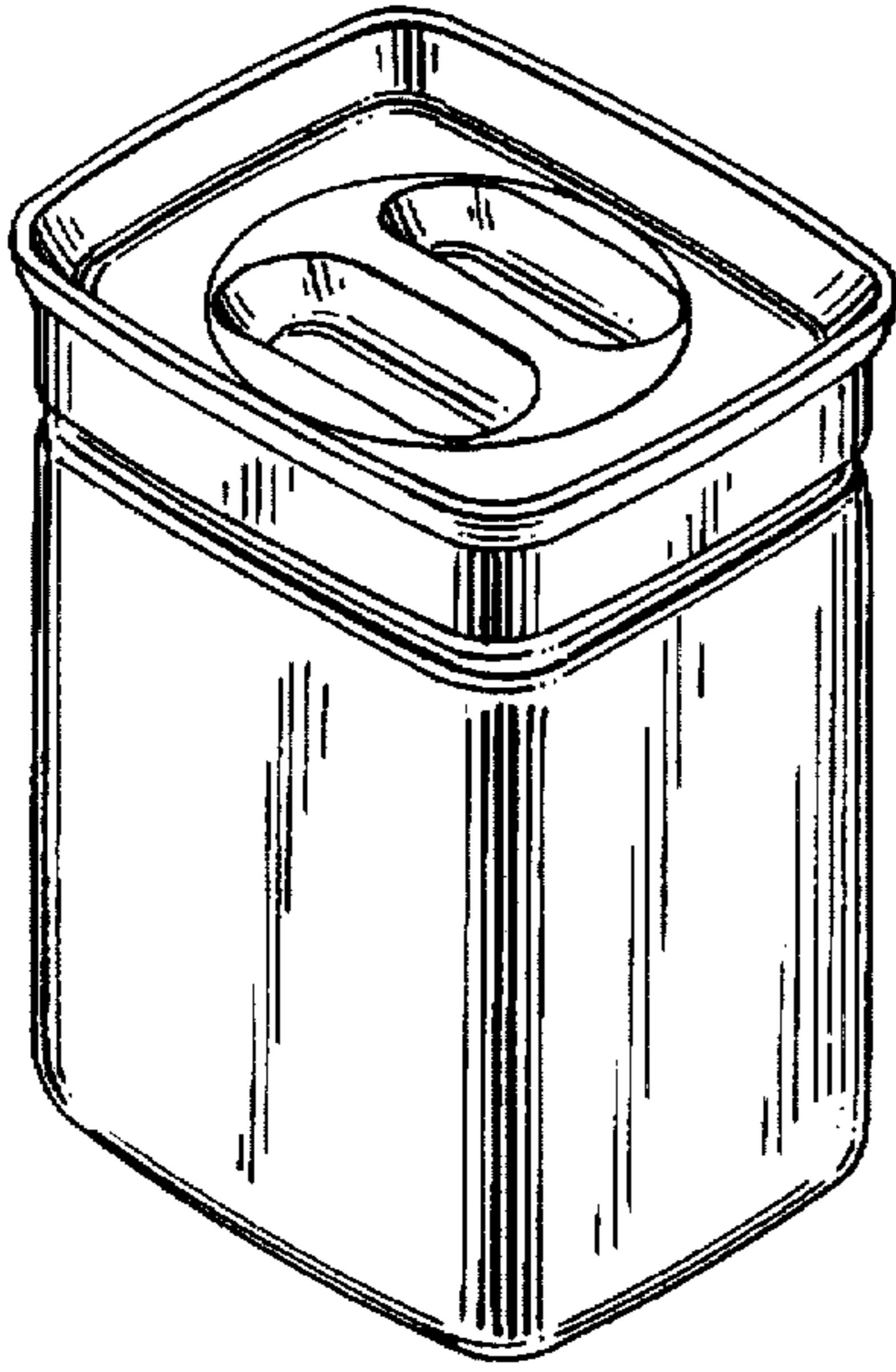

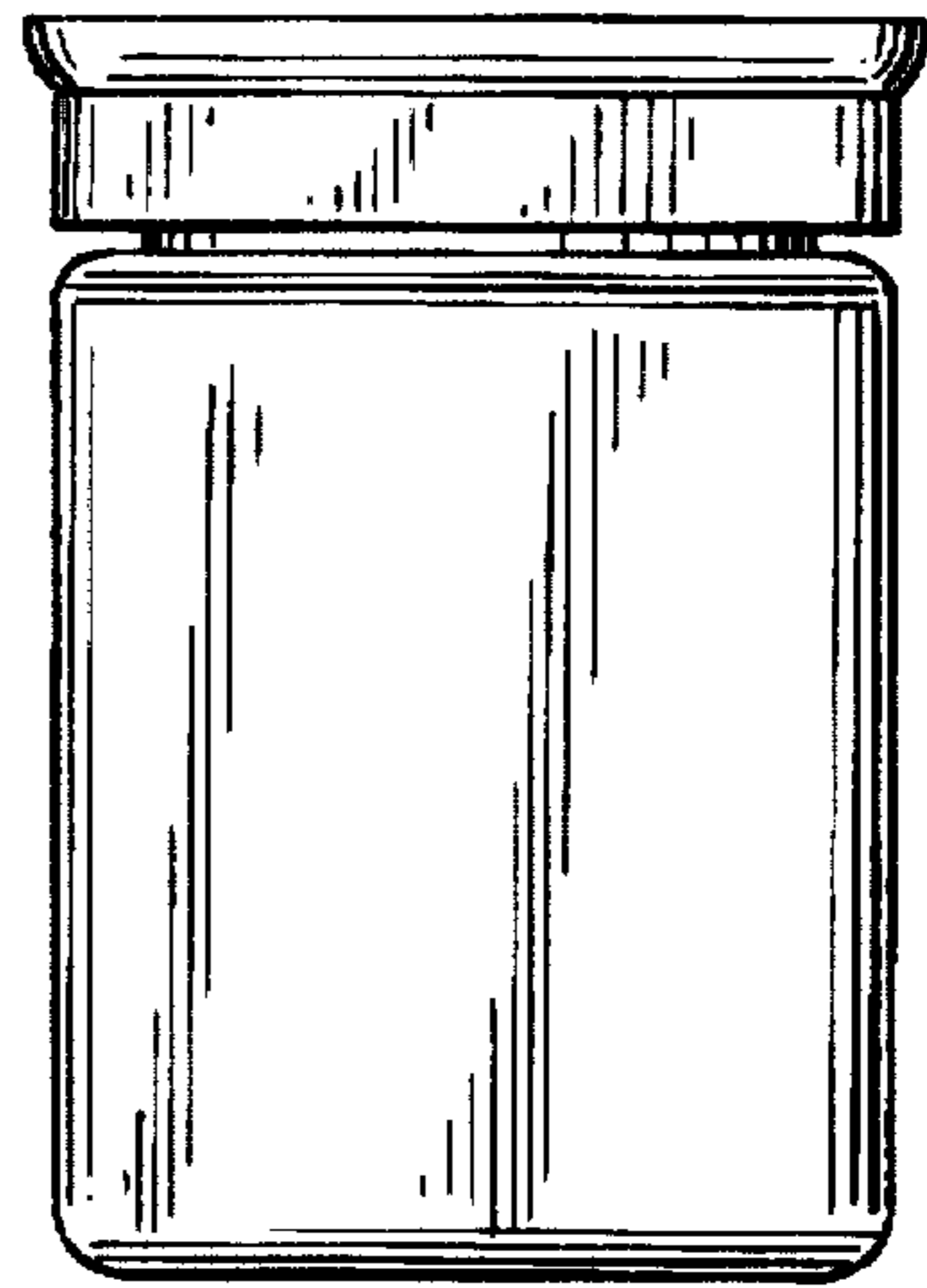

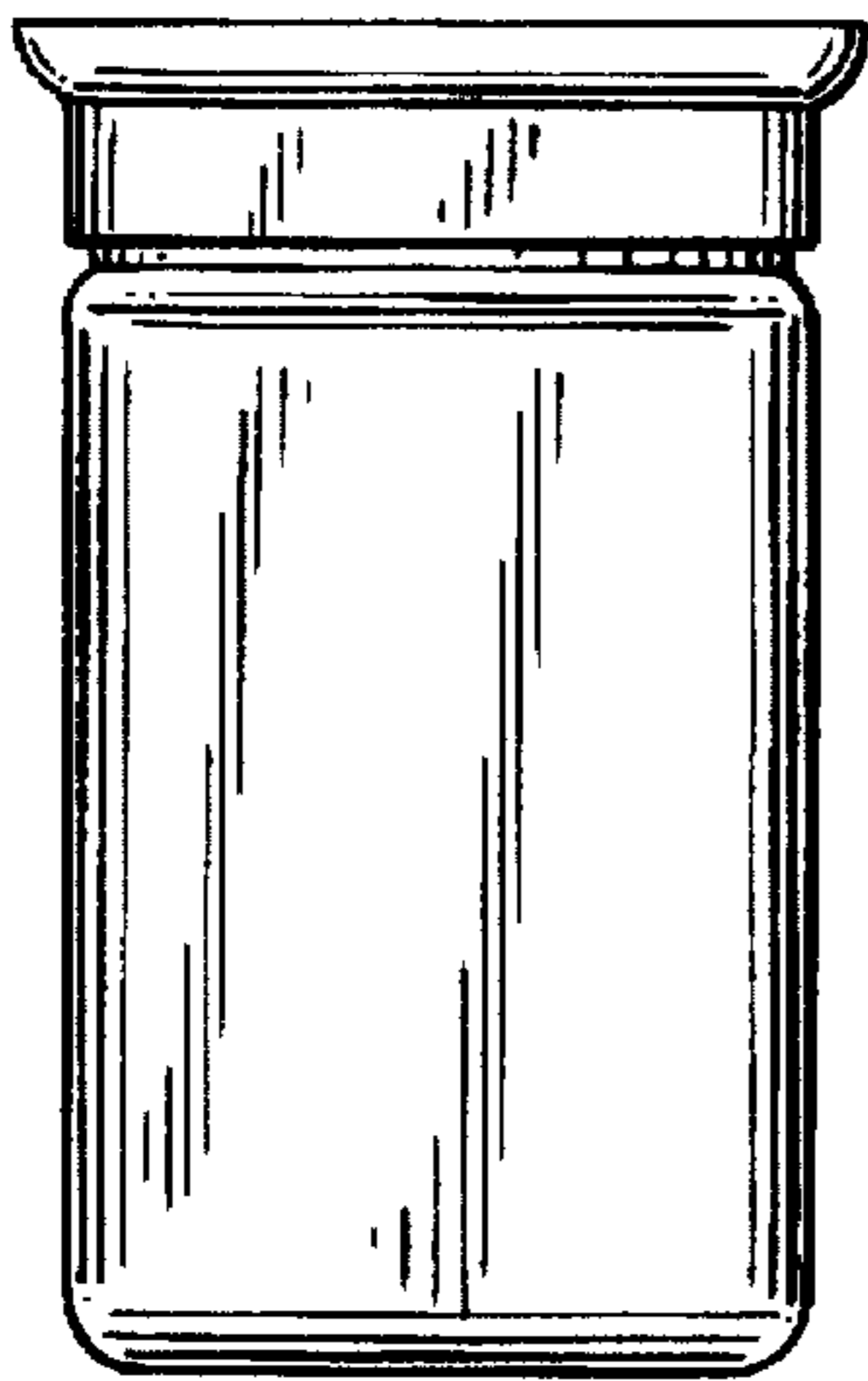

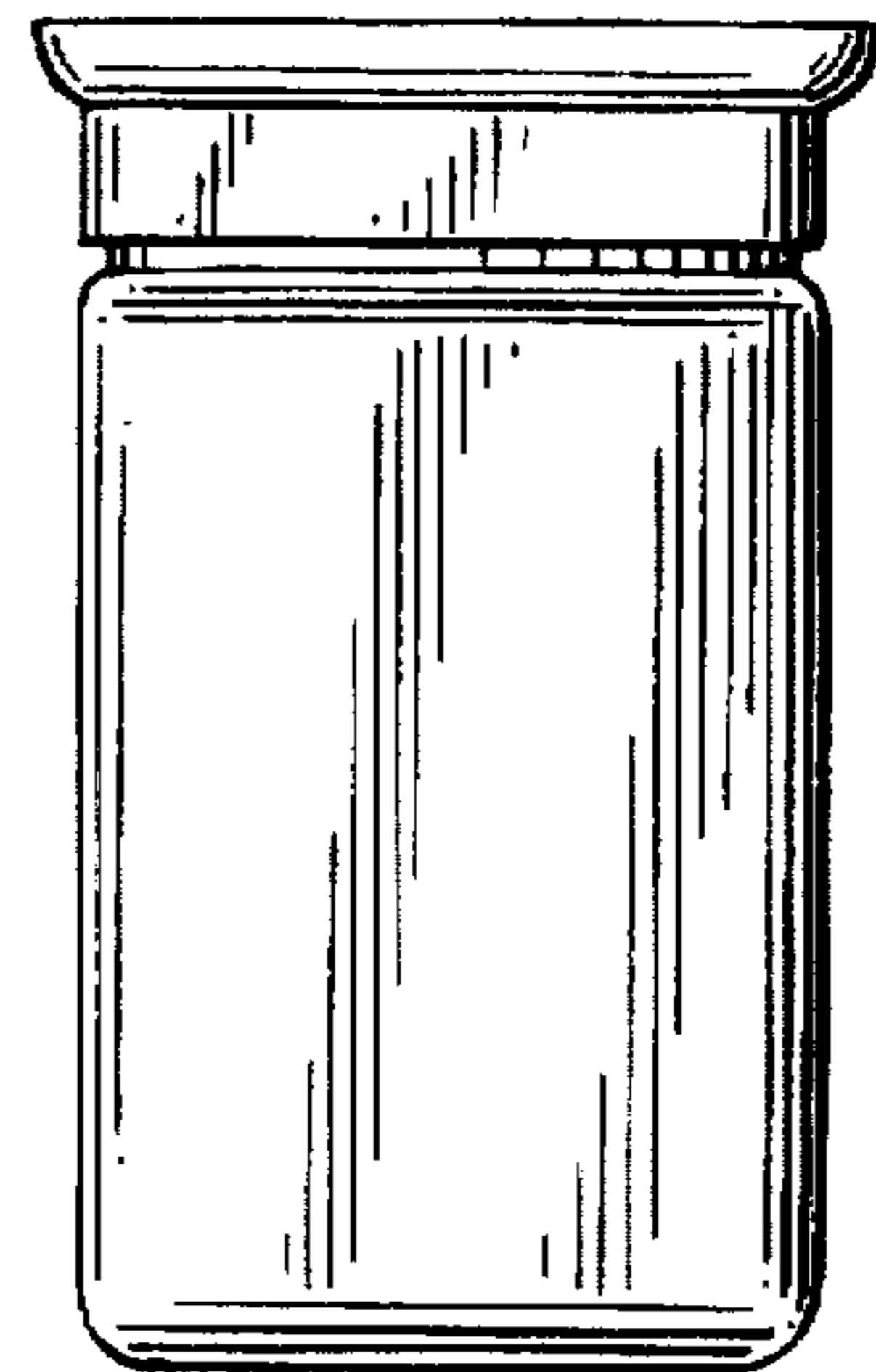

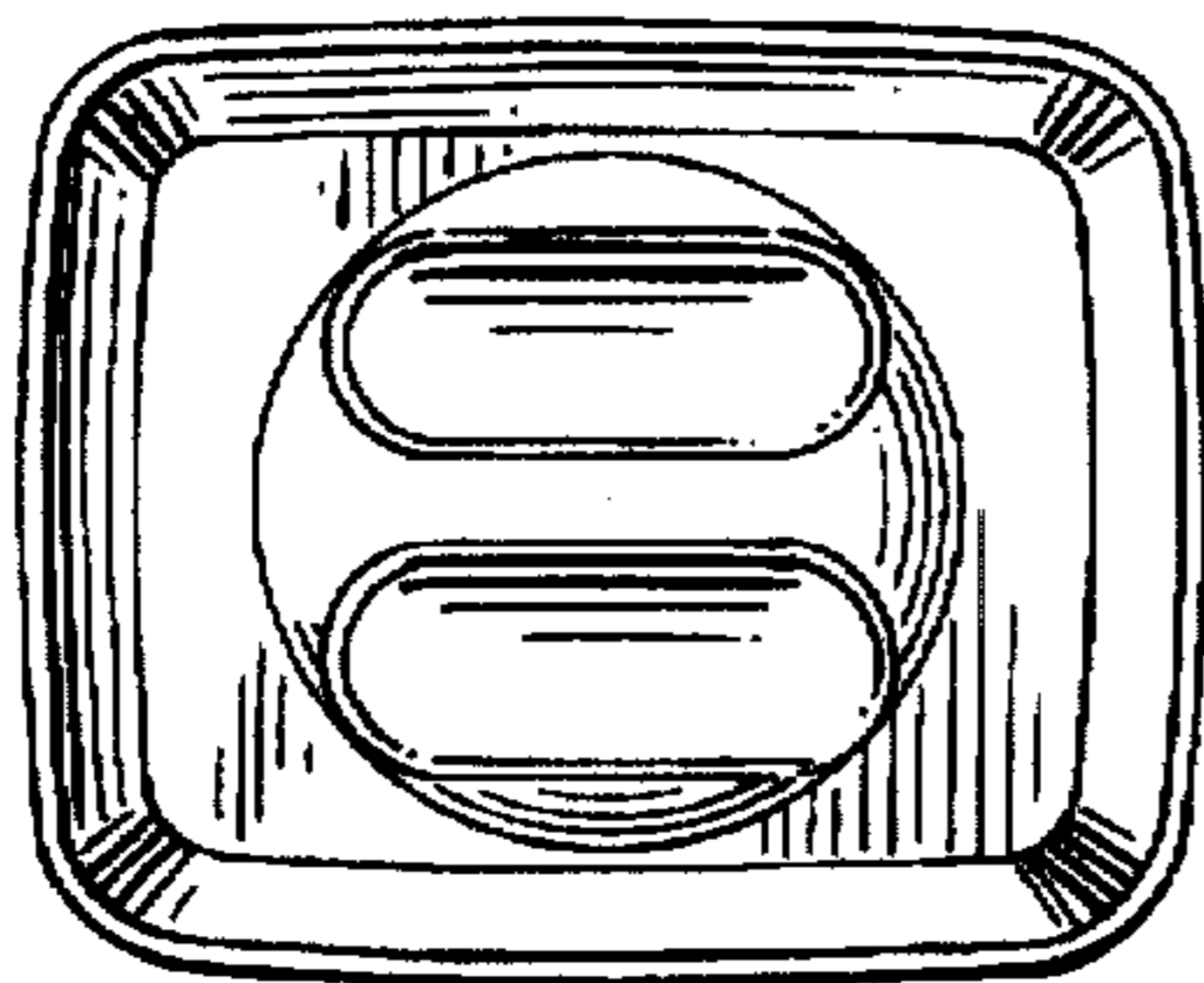

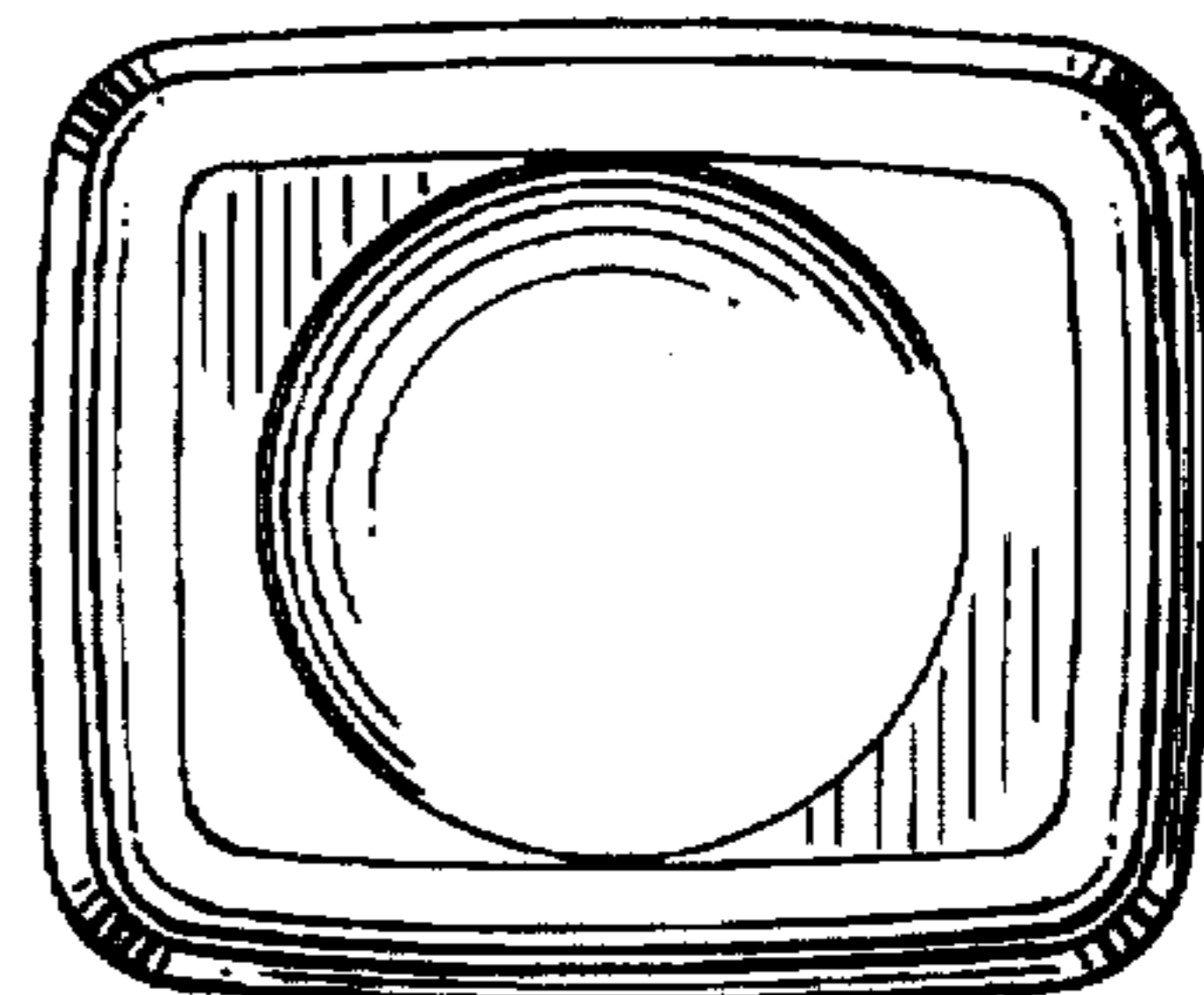

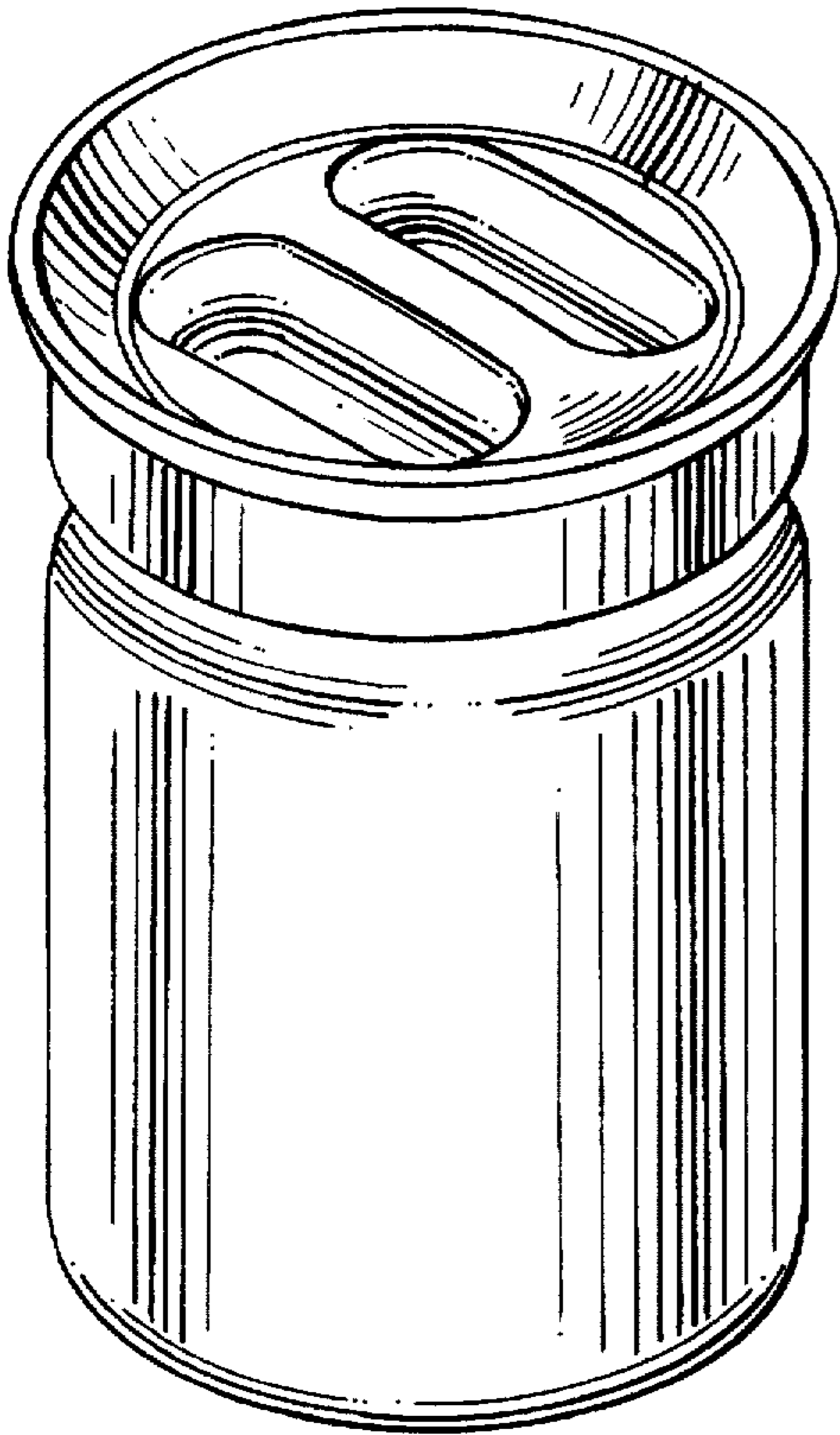

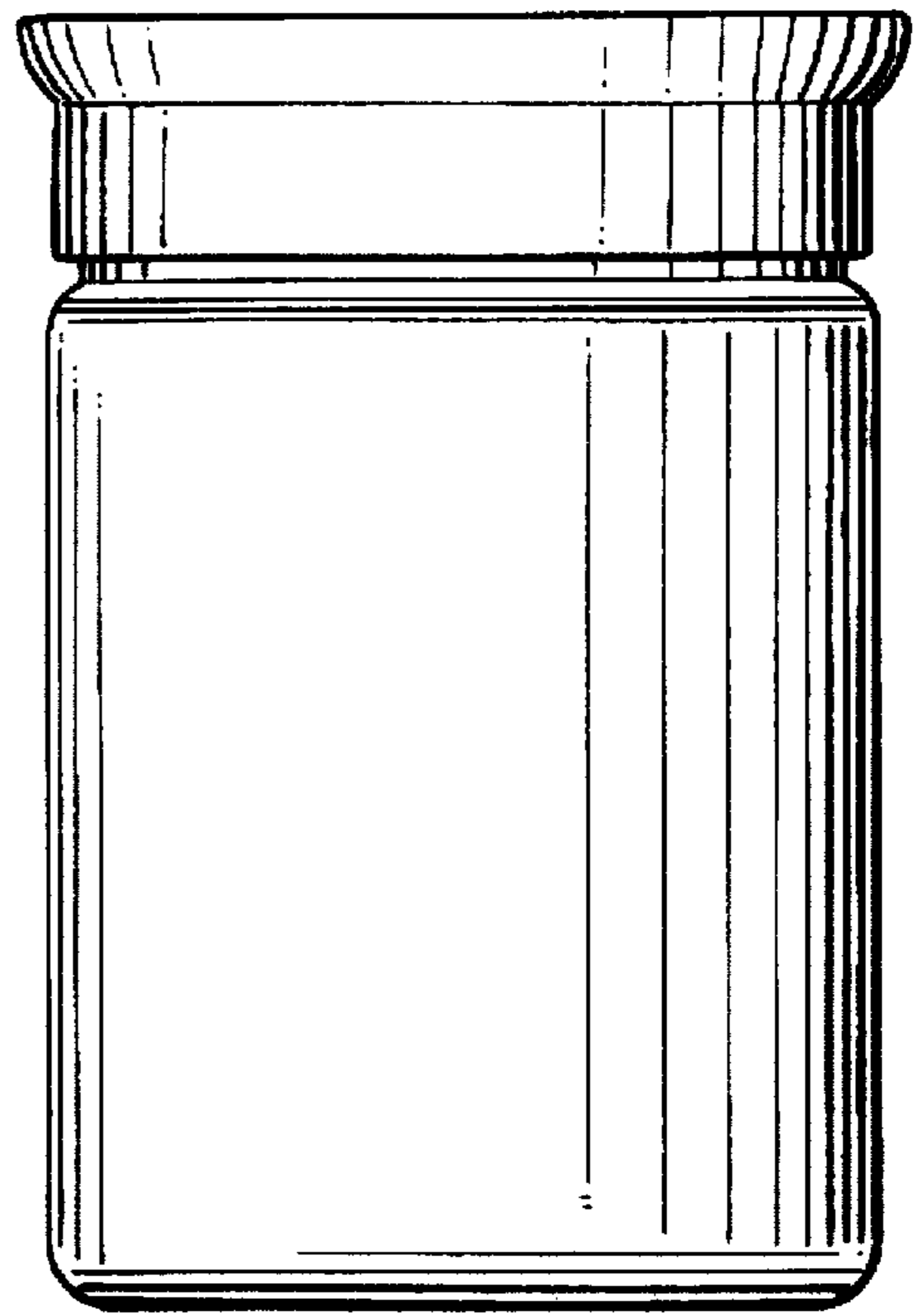

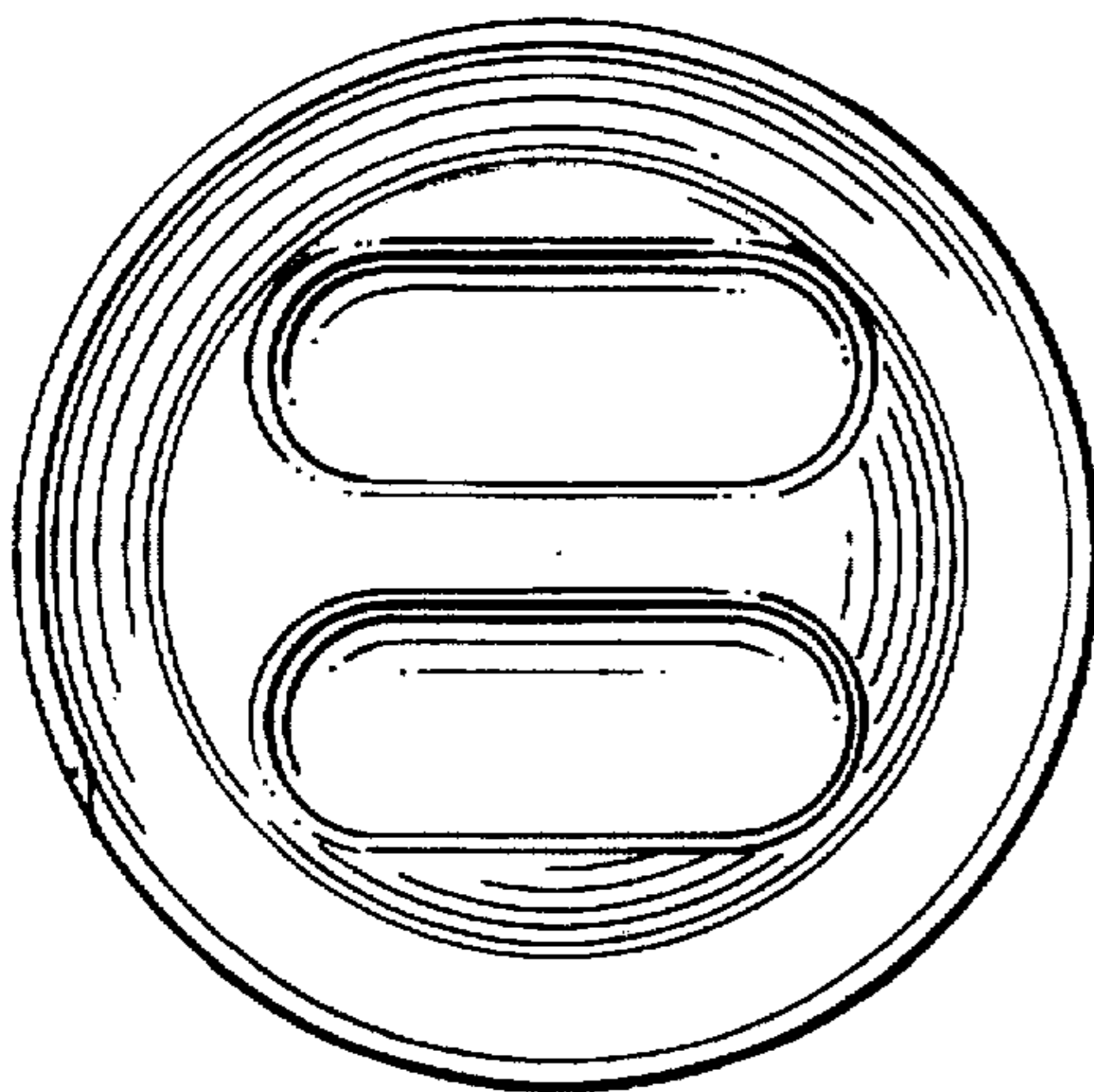

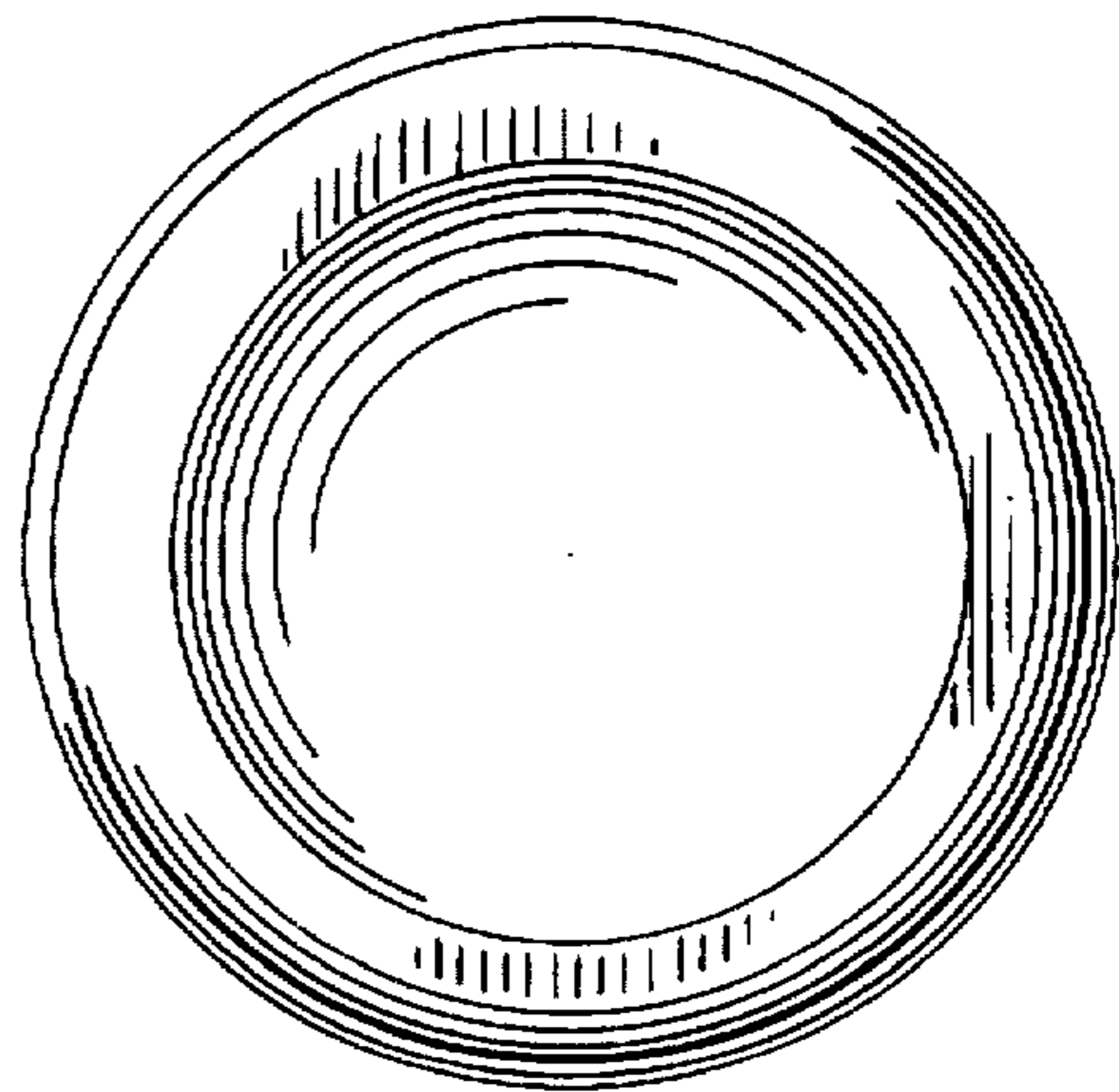
