The ornamental design for a barbecue set, as shown and described.

**DESCRIPTION**

FIG. 27 is a bottom view thereof;

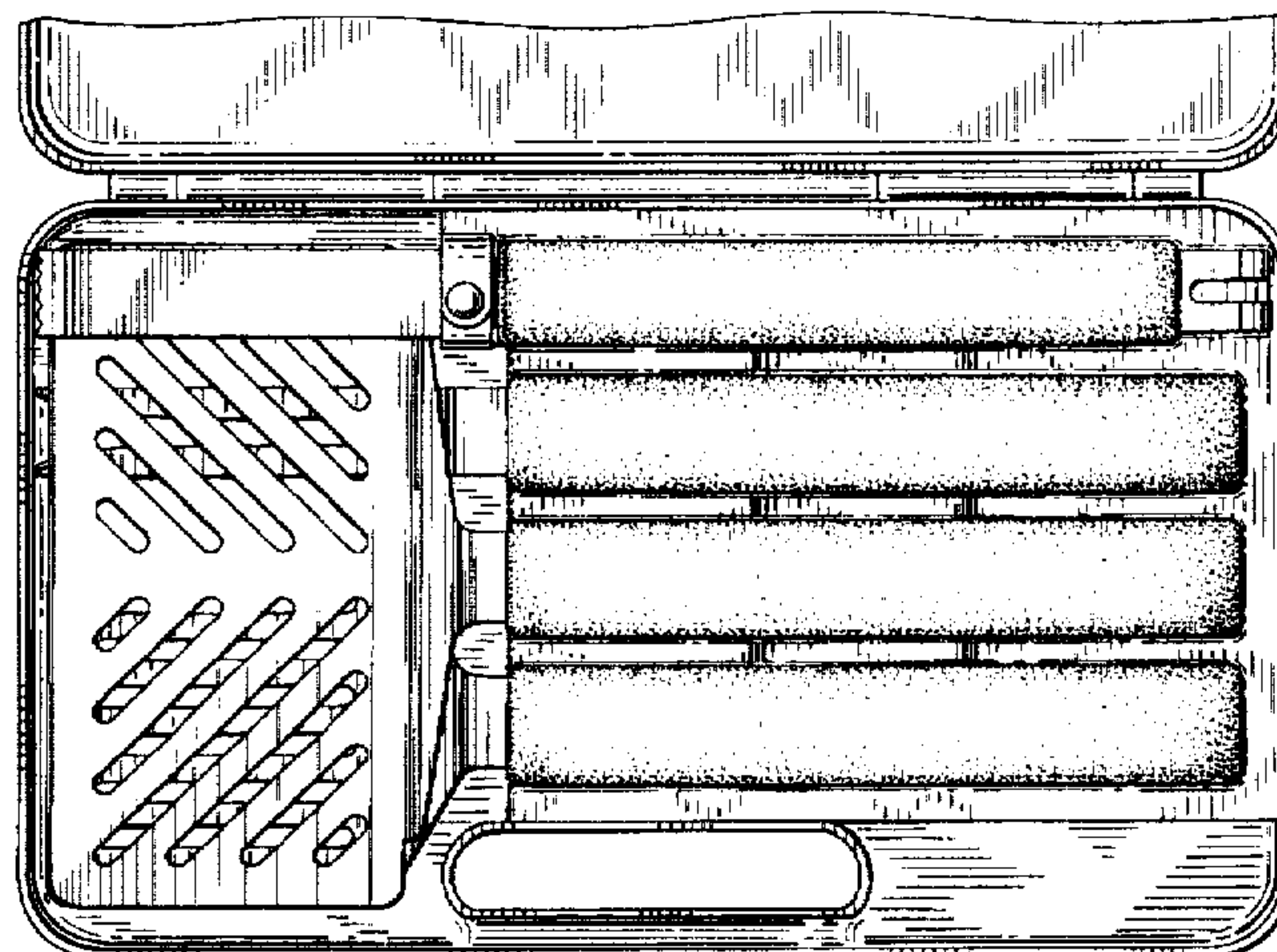
FIG. 28 is a rear view thereof;

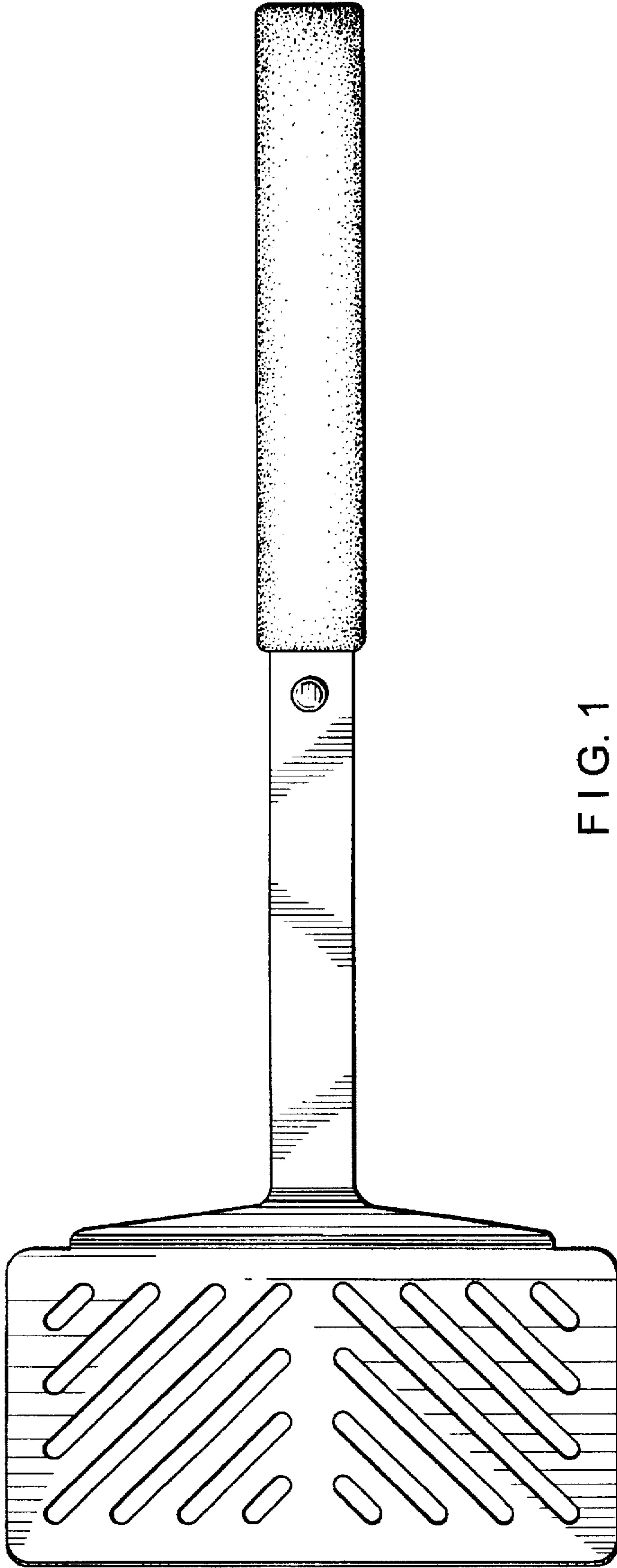

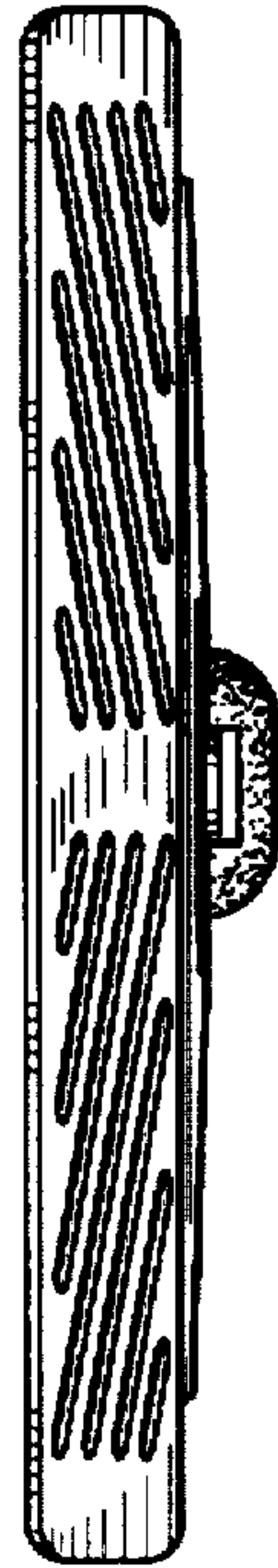

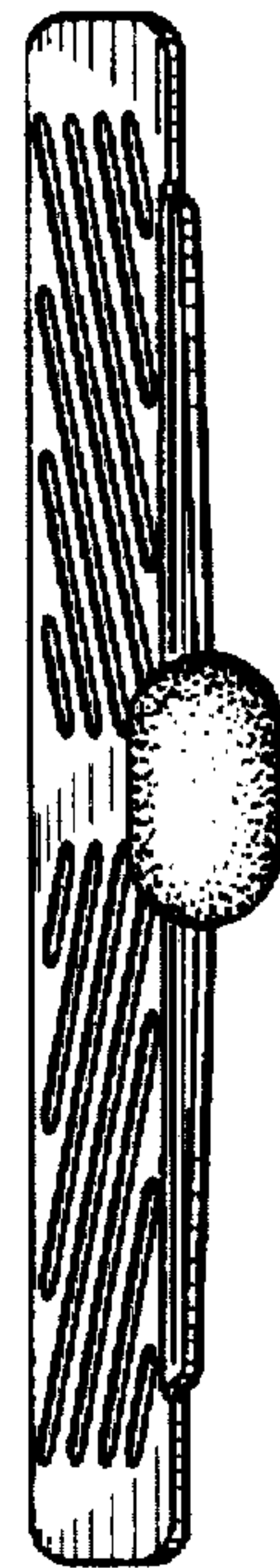

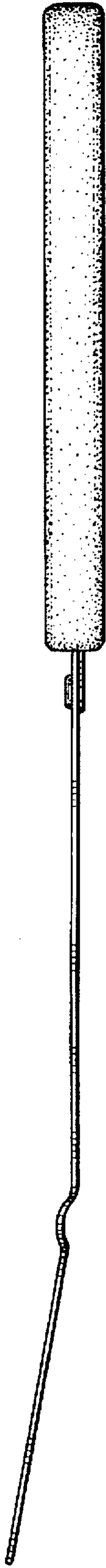

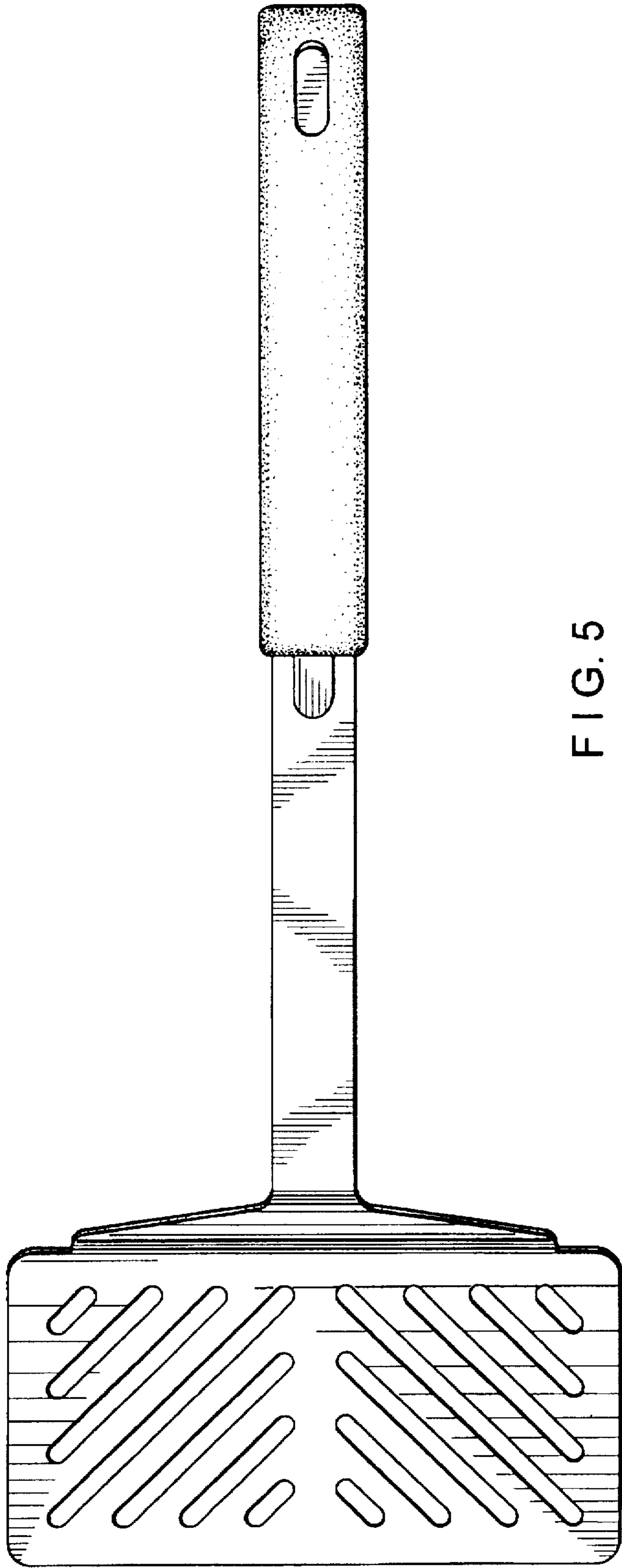

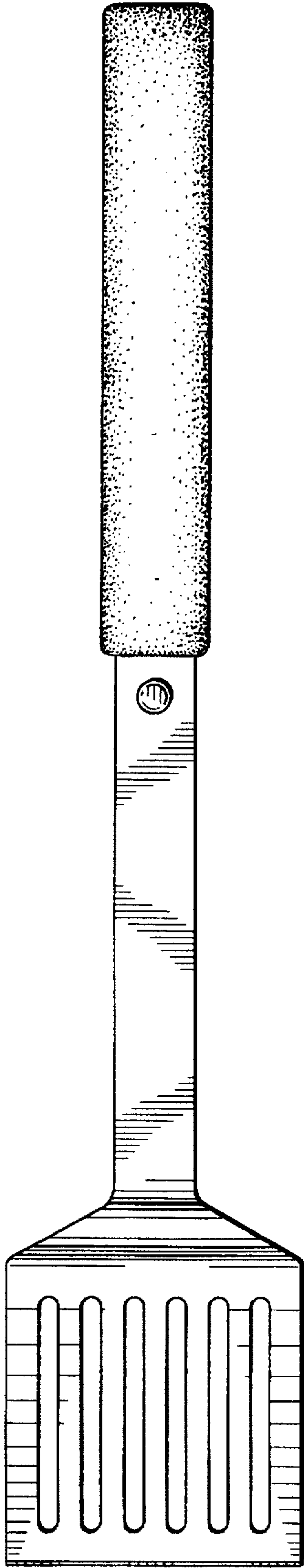

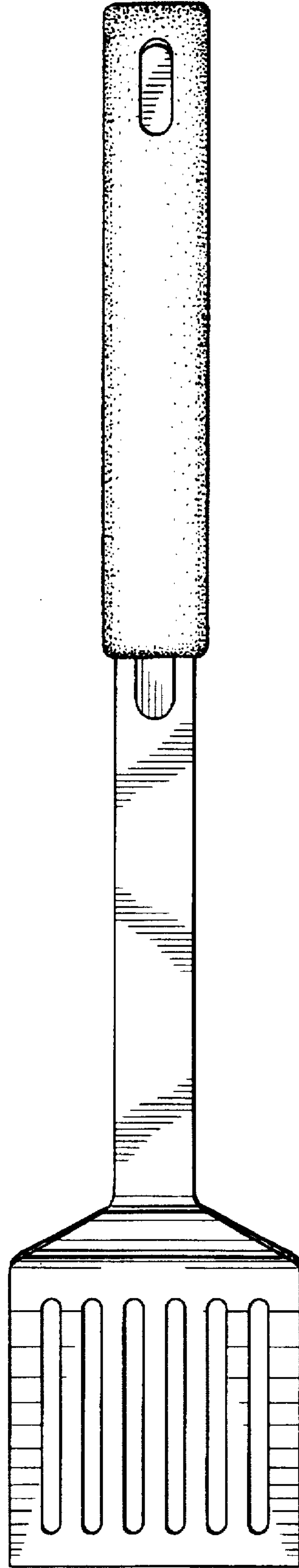

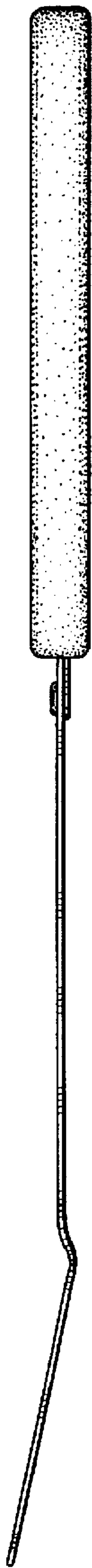

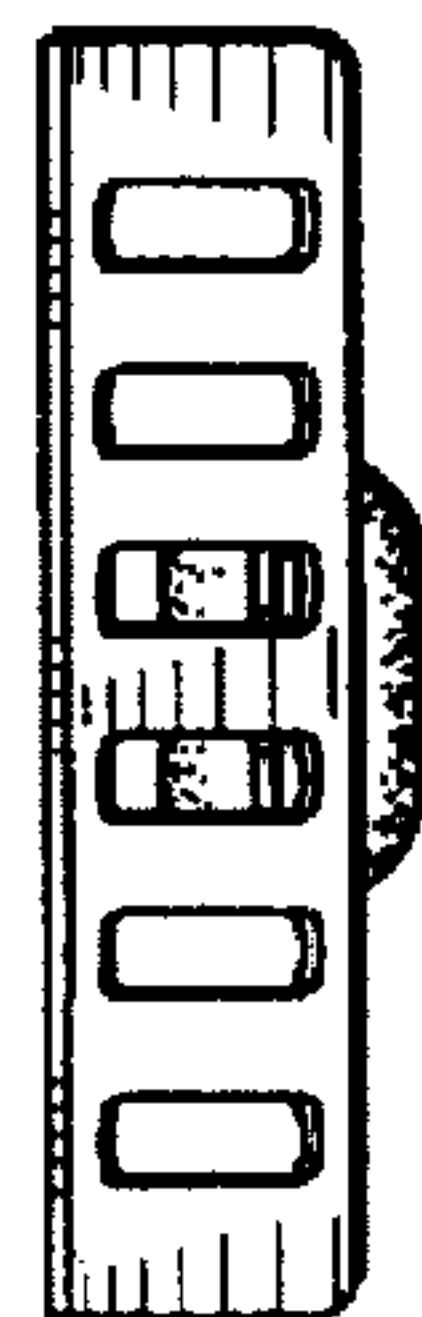

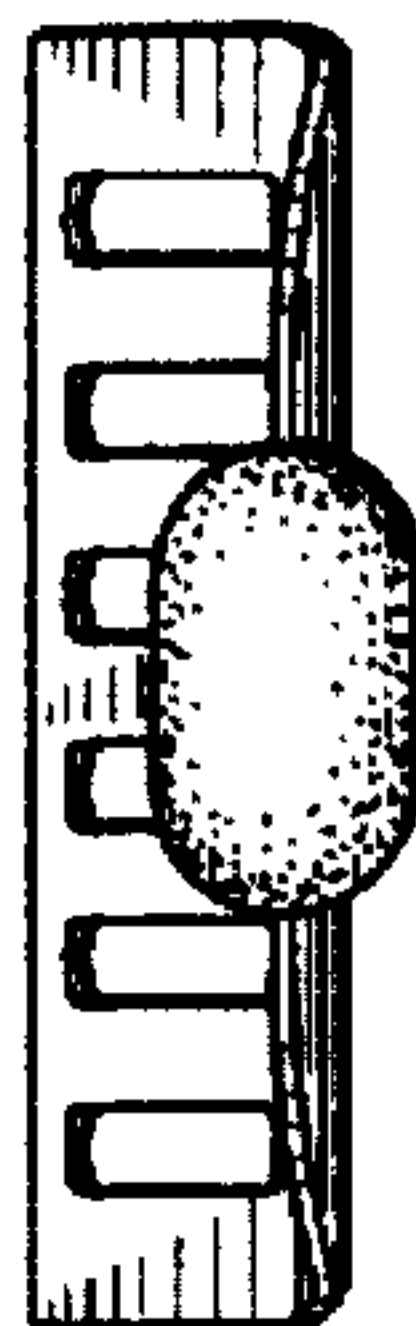

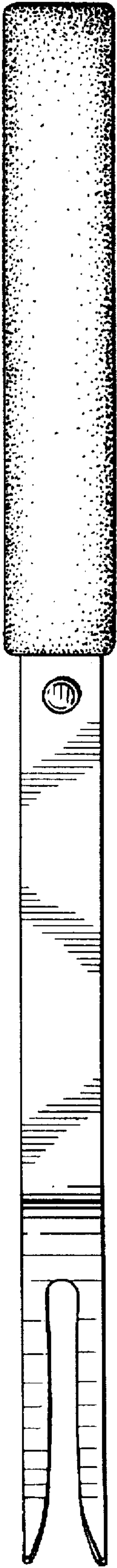

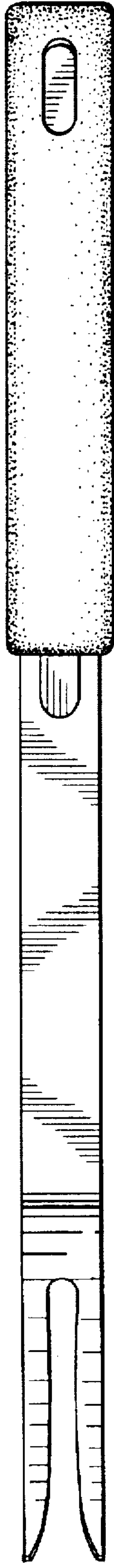

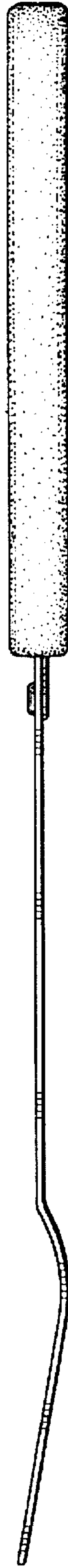

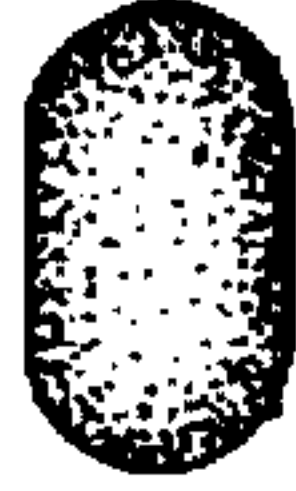

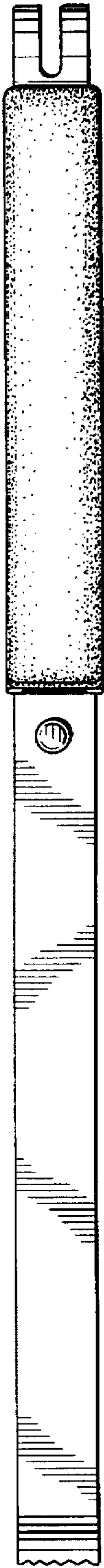

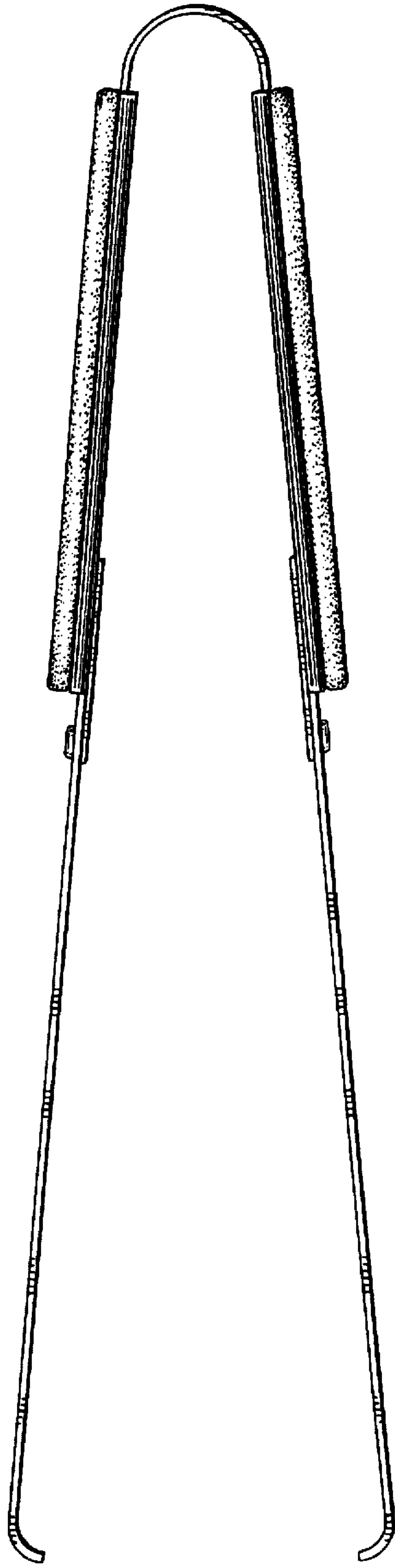

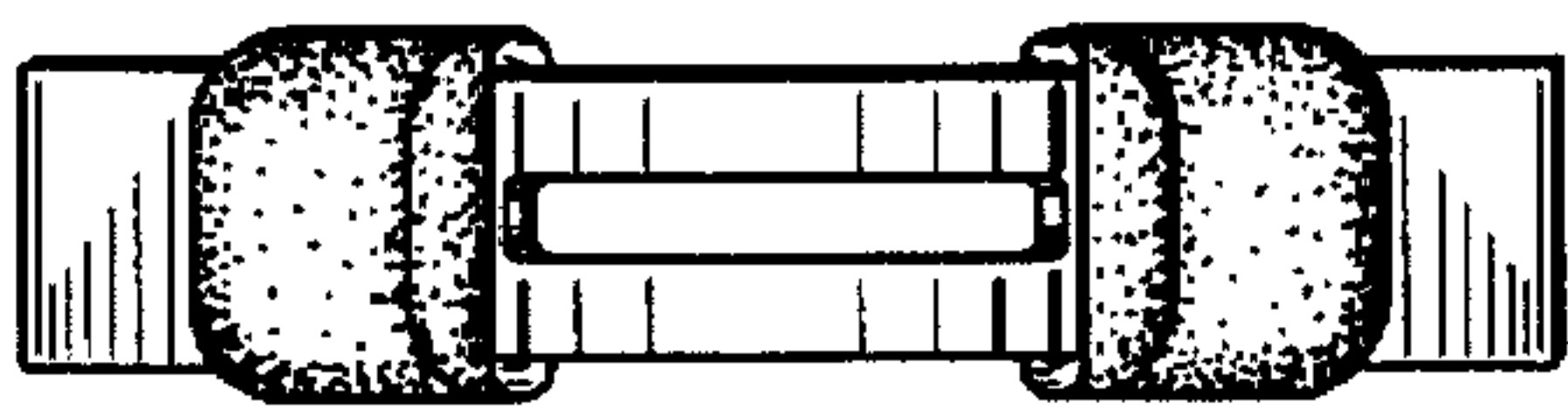

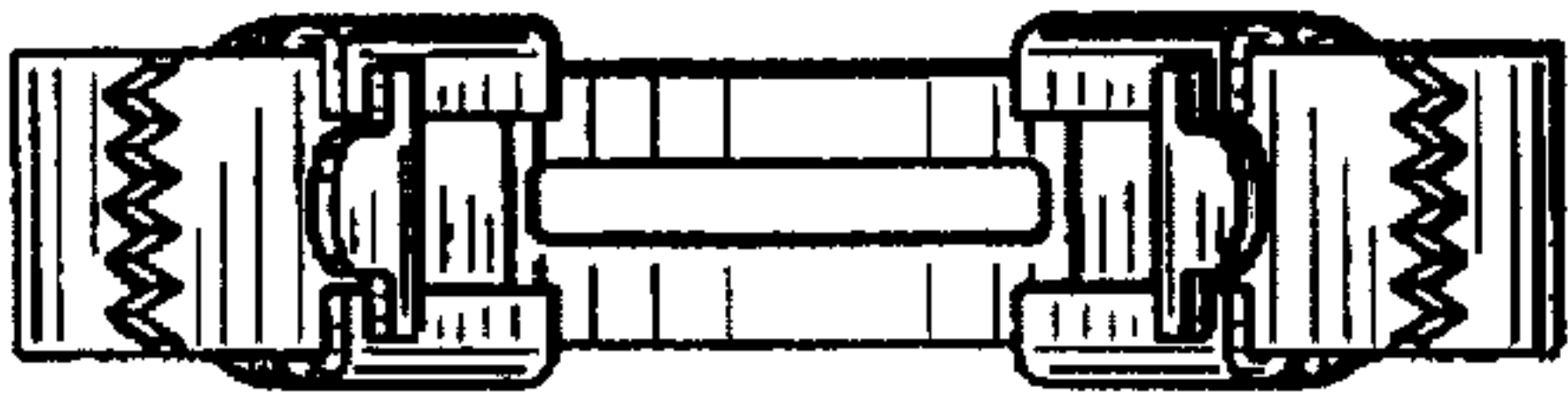

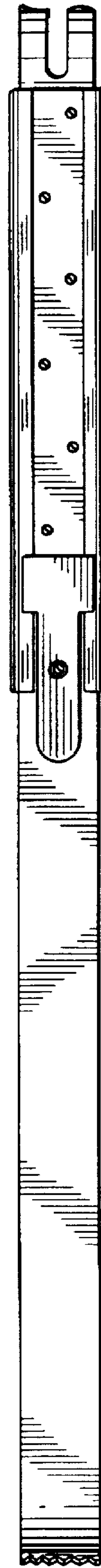

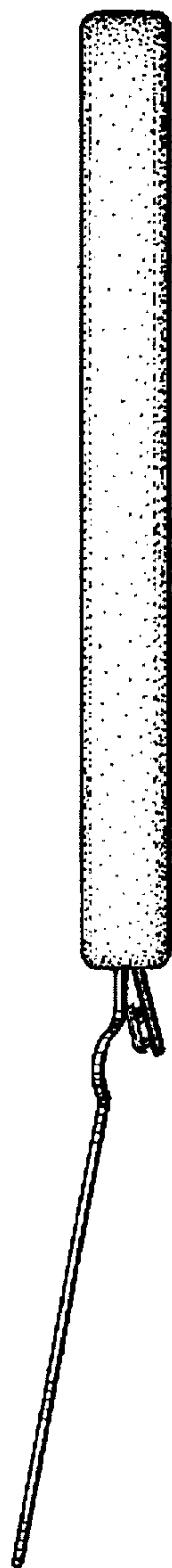

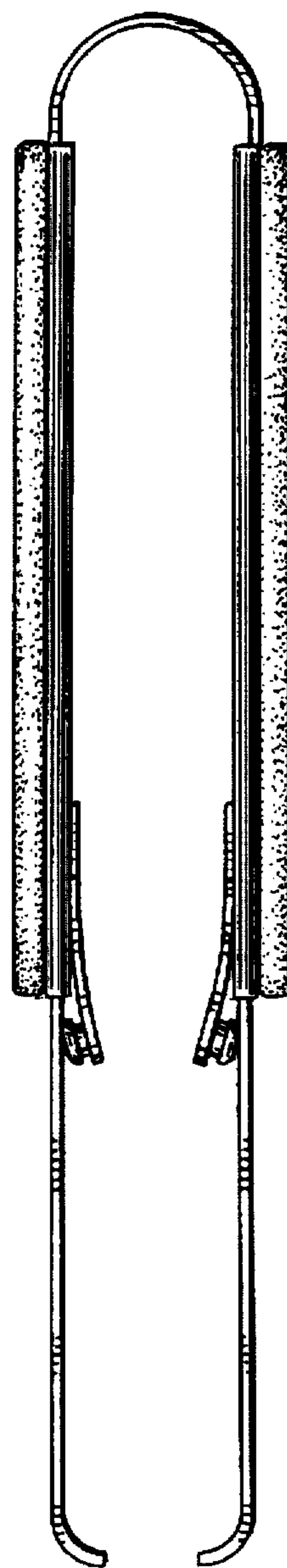

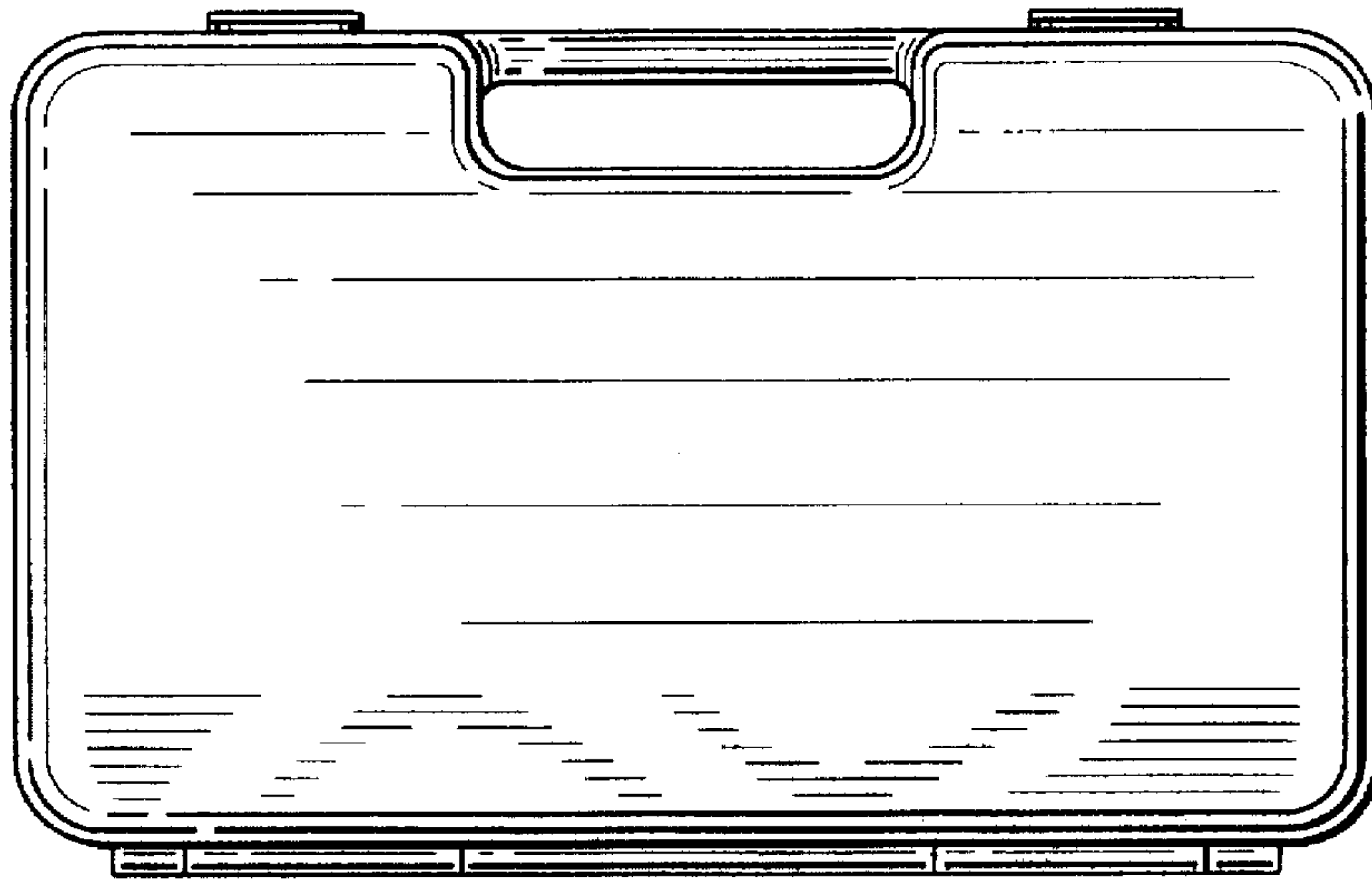

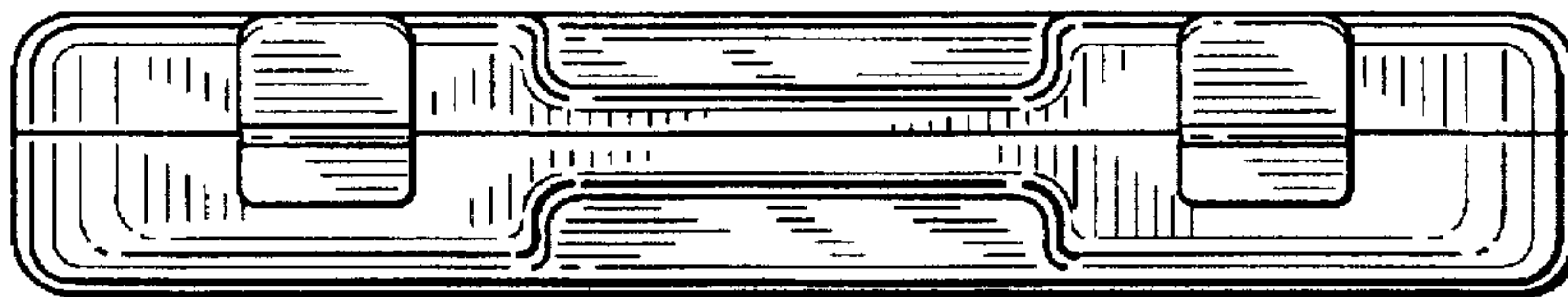

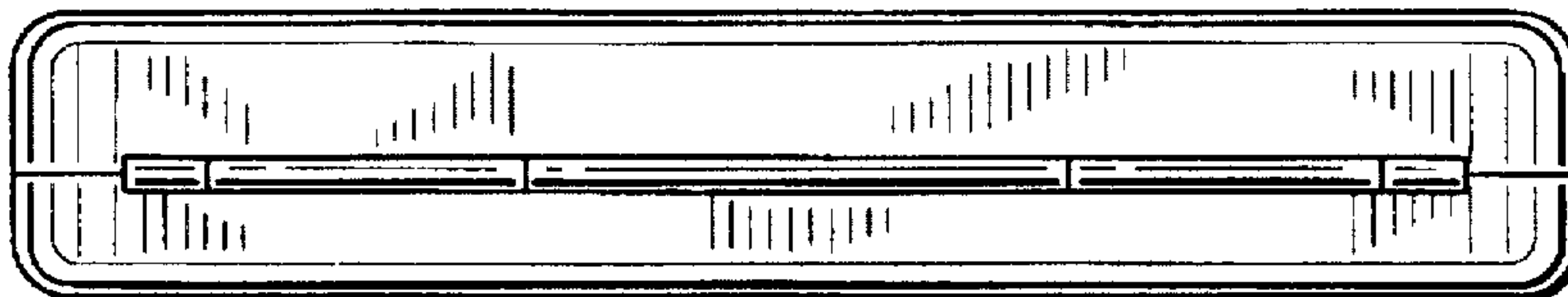

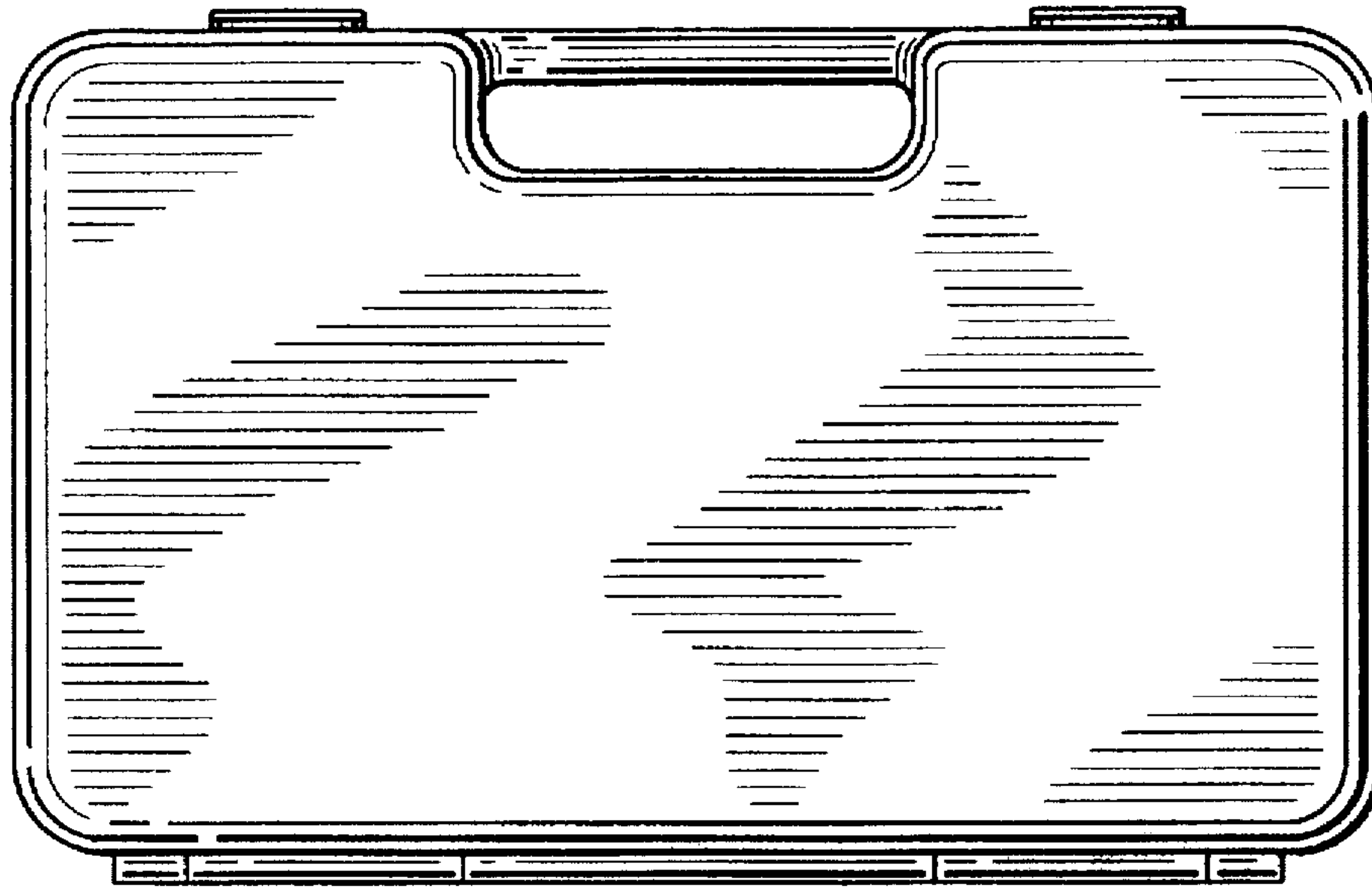

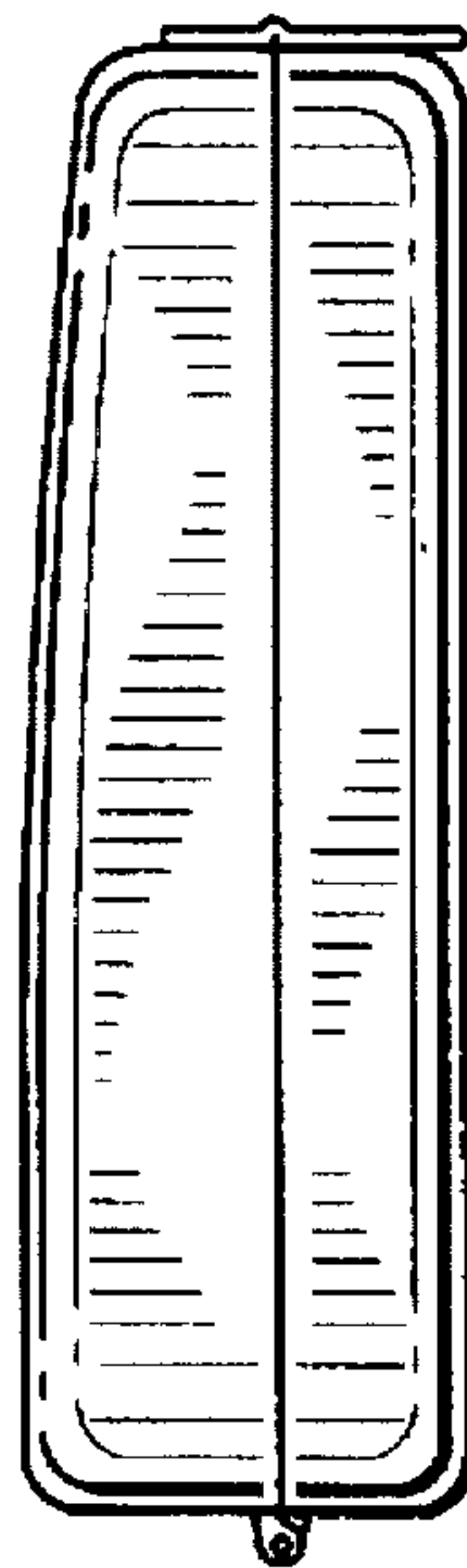

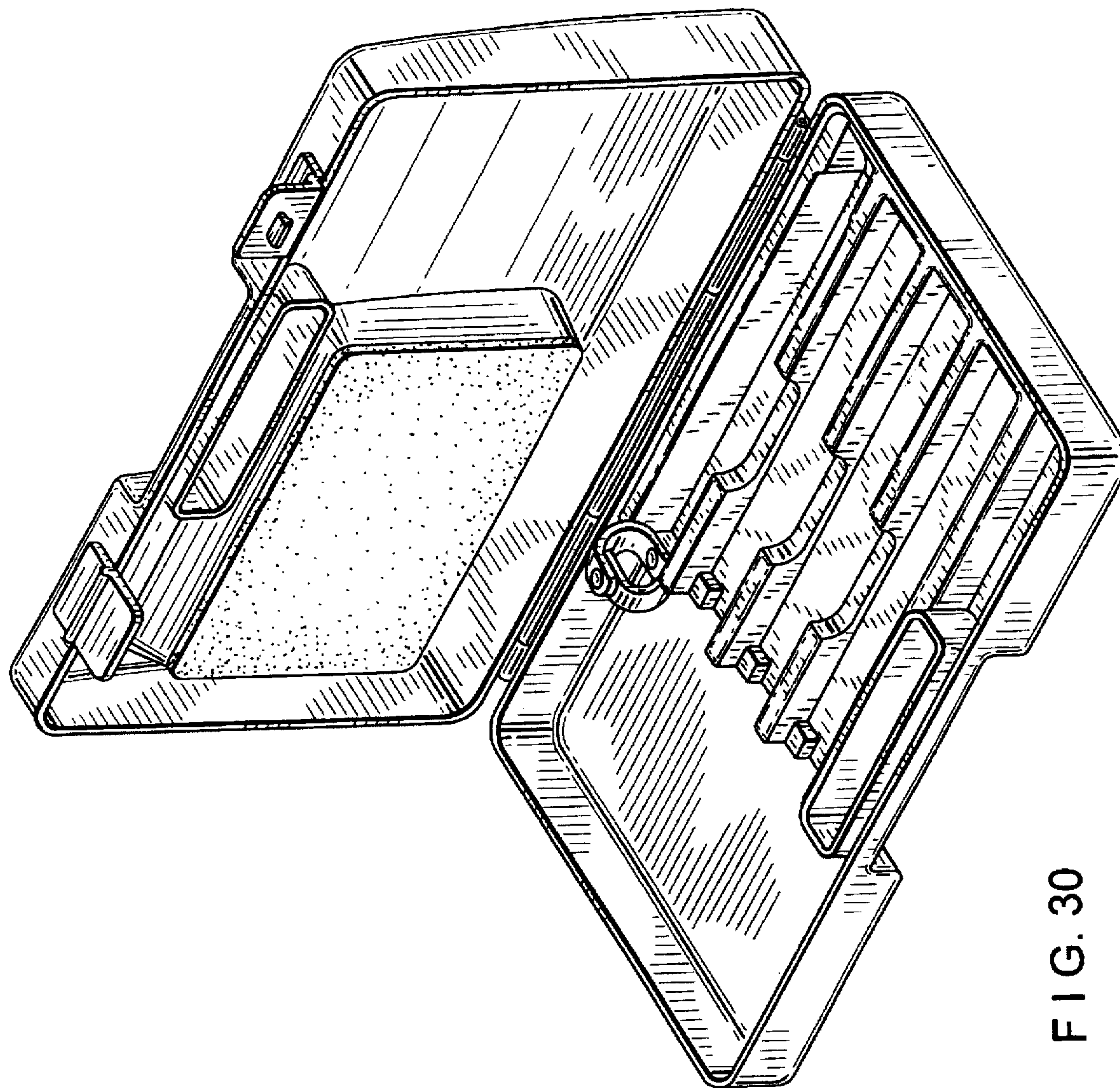

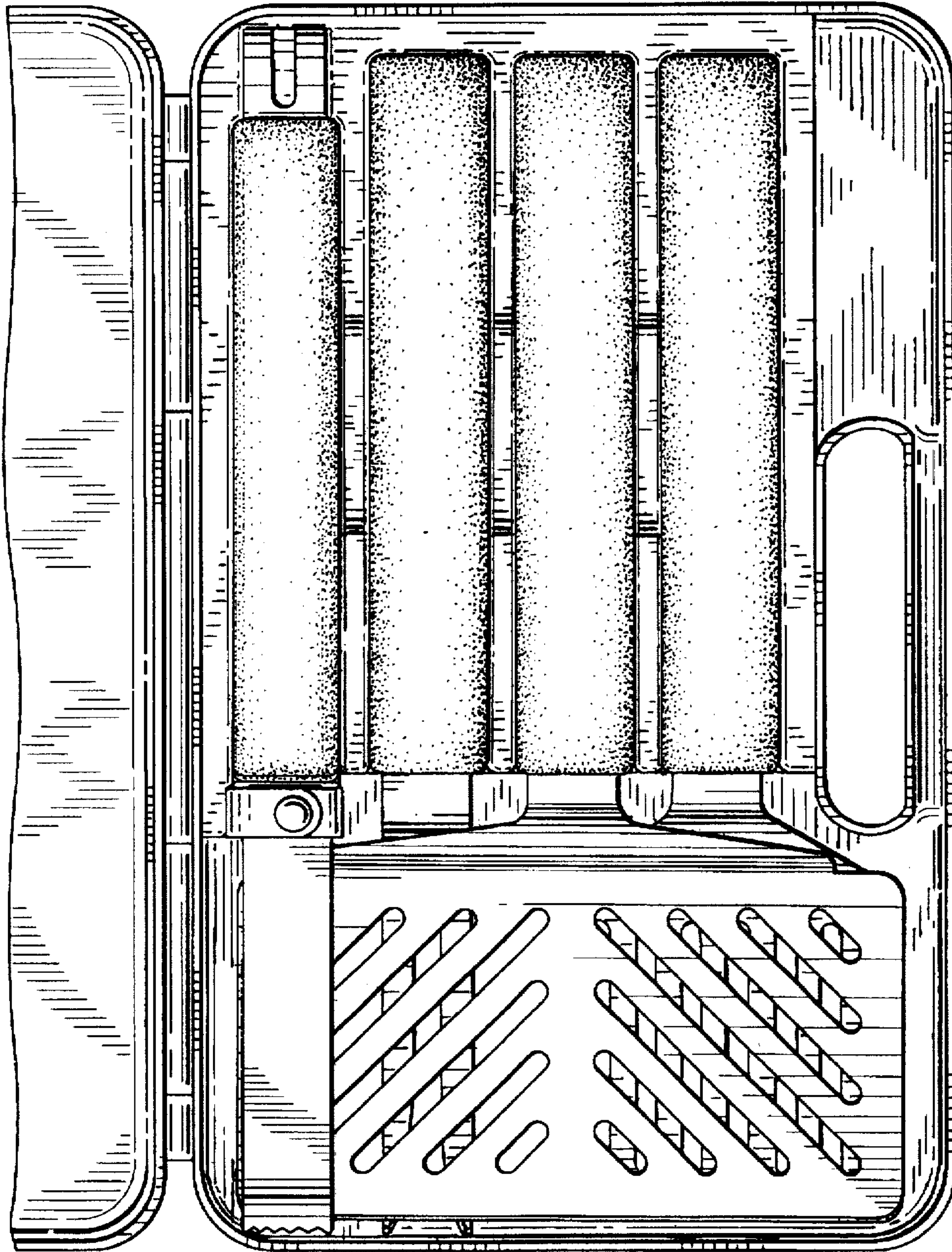
