FIG. 1 is a front perspective view of a palm grip sander showing our new design;

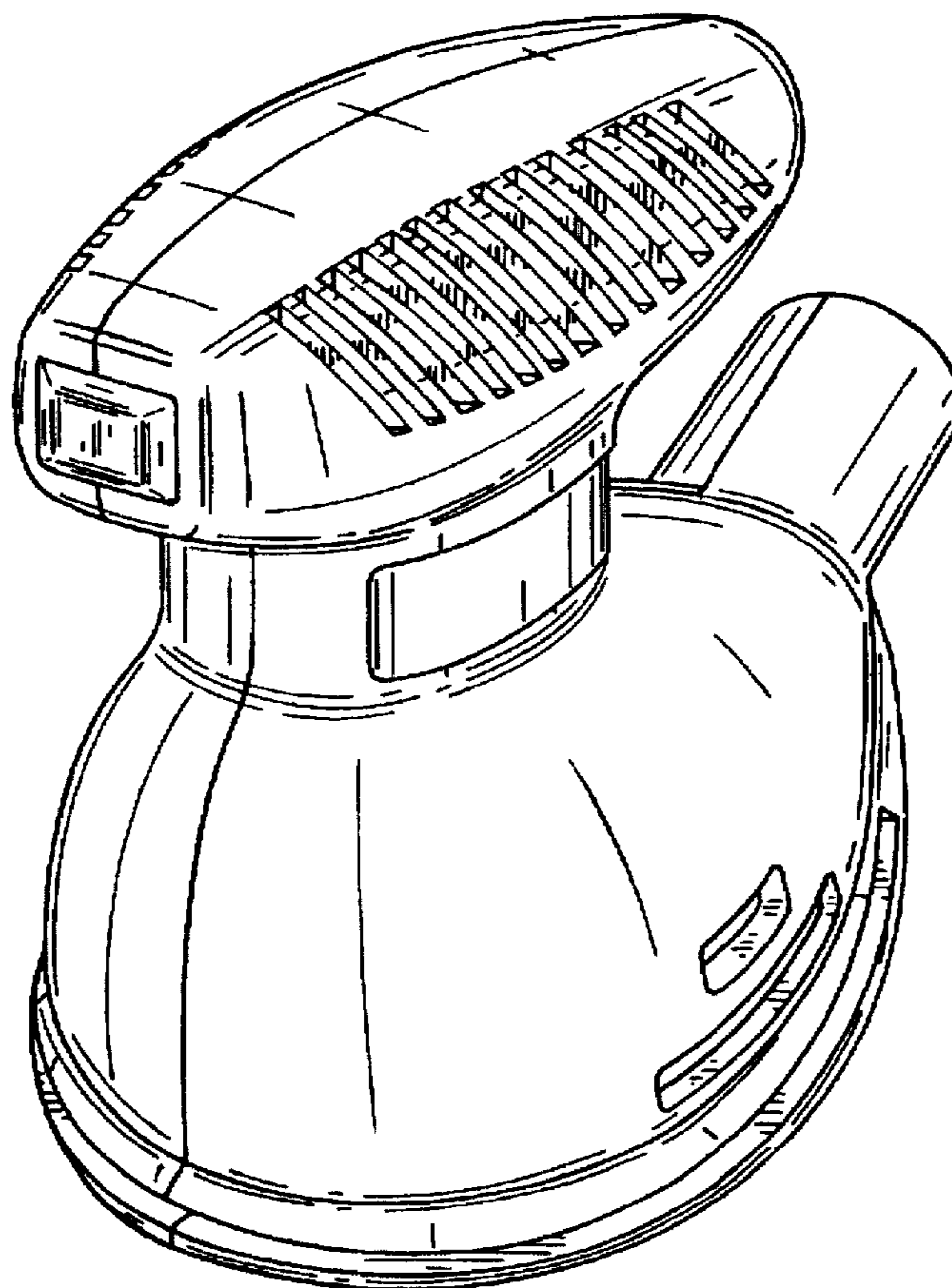

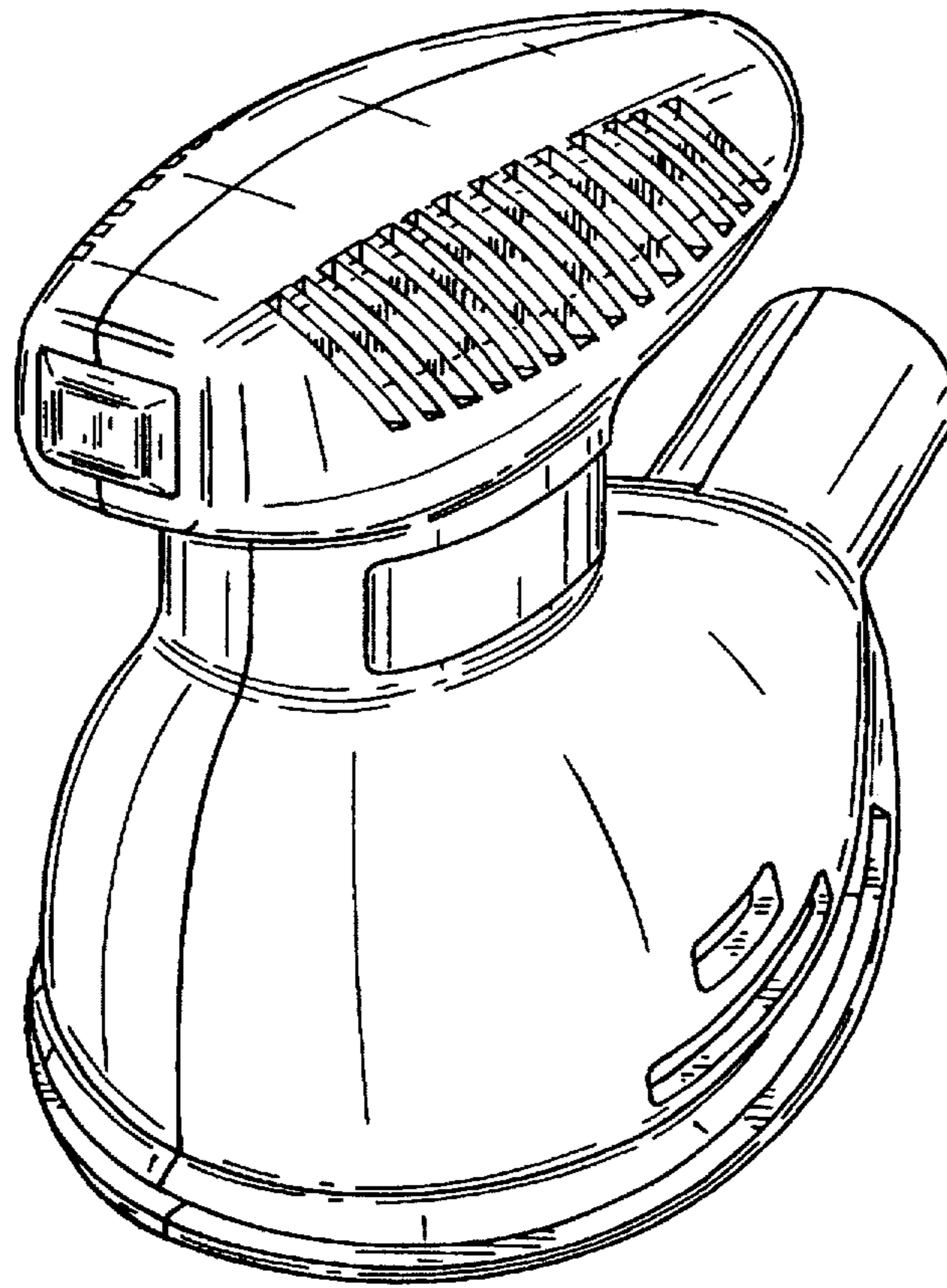

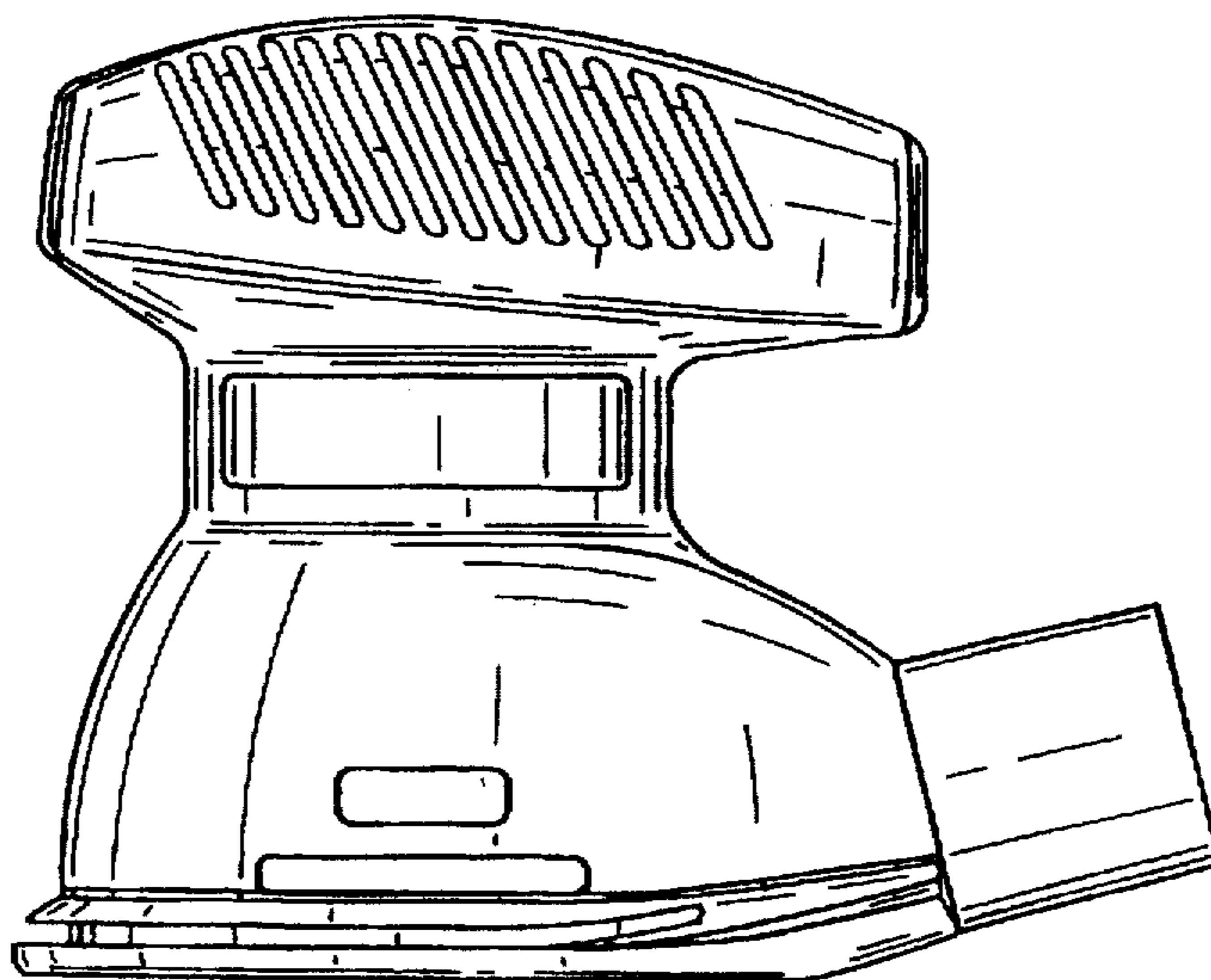

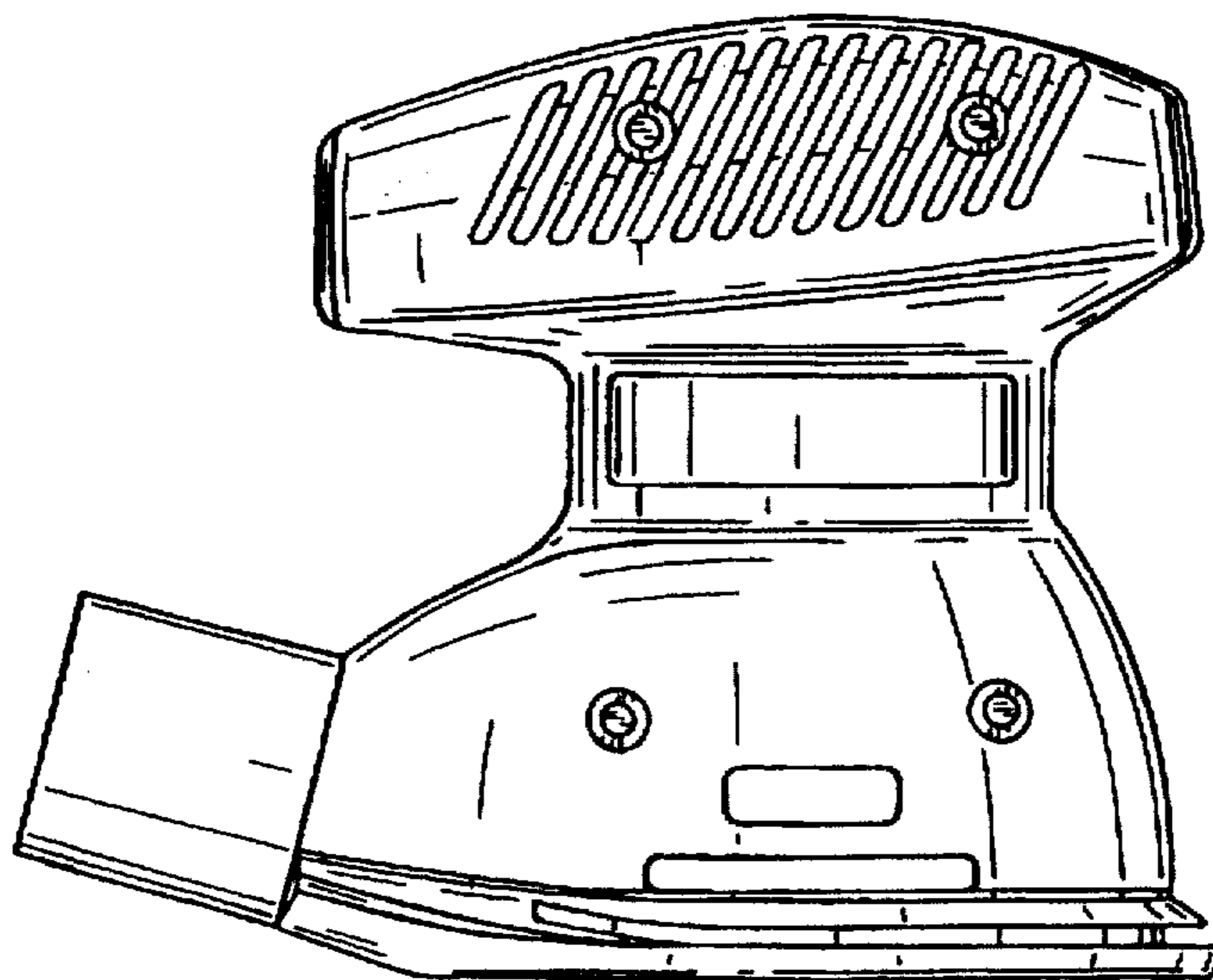

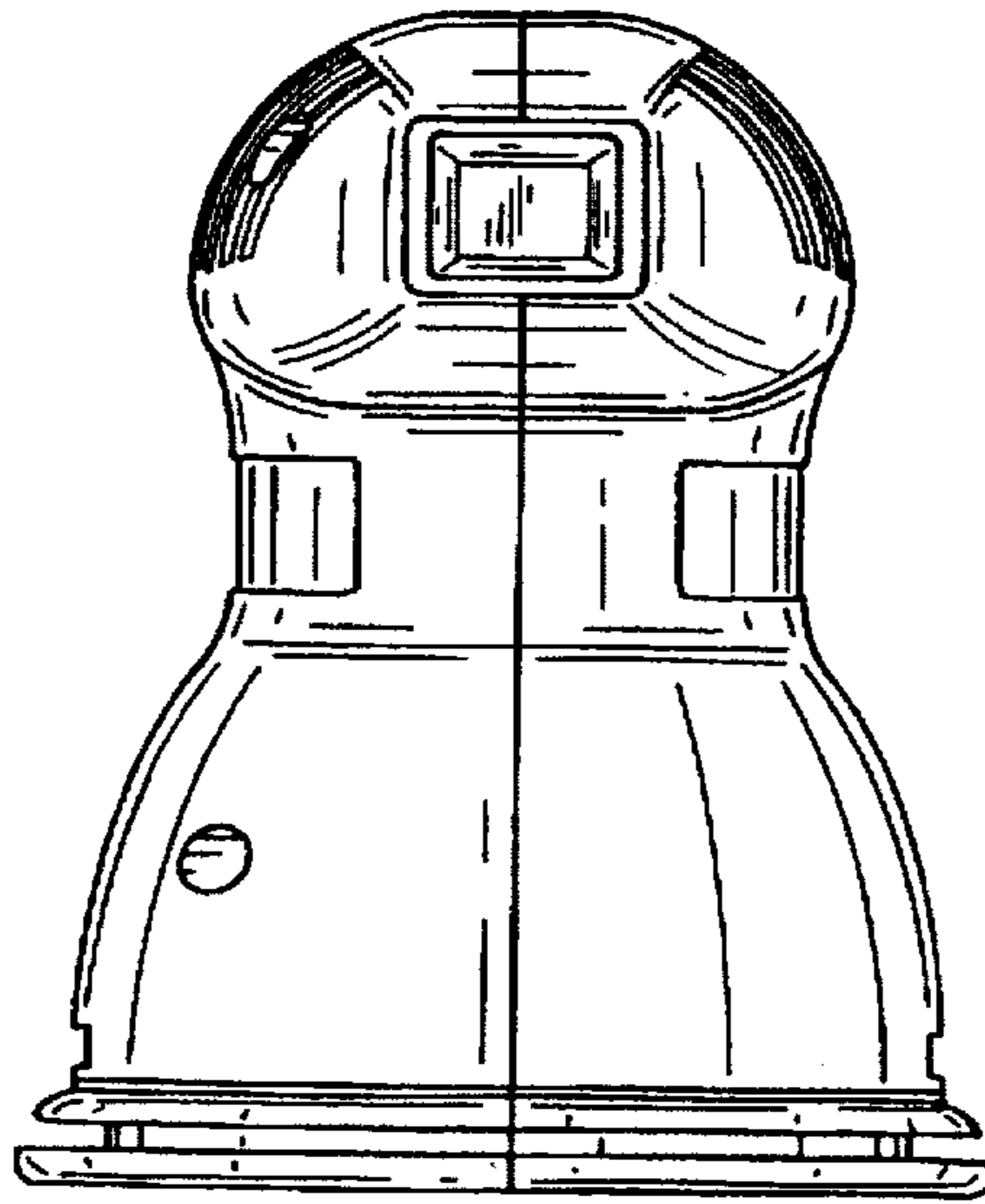

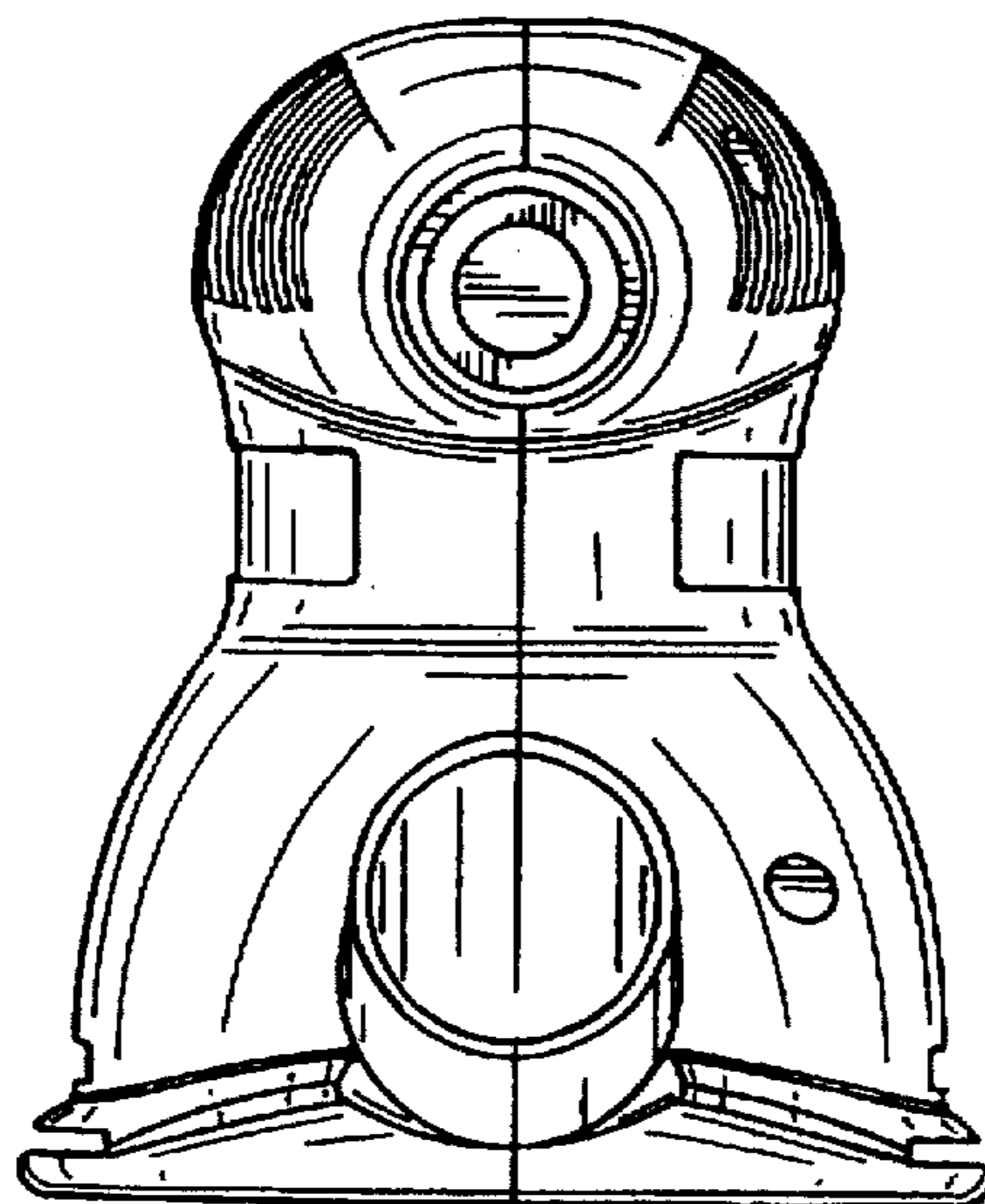

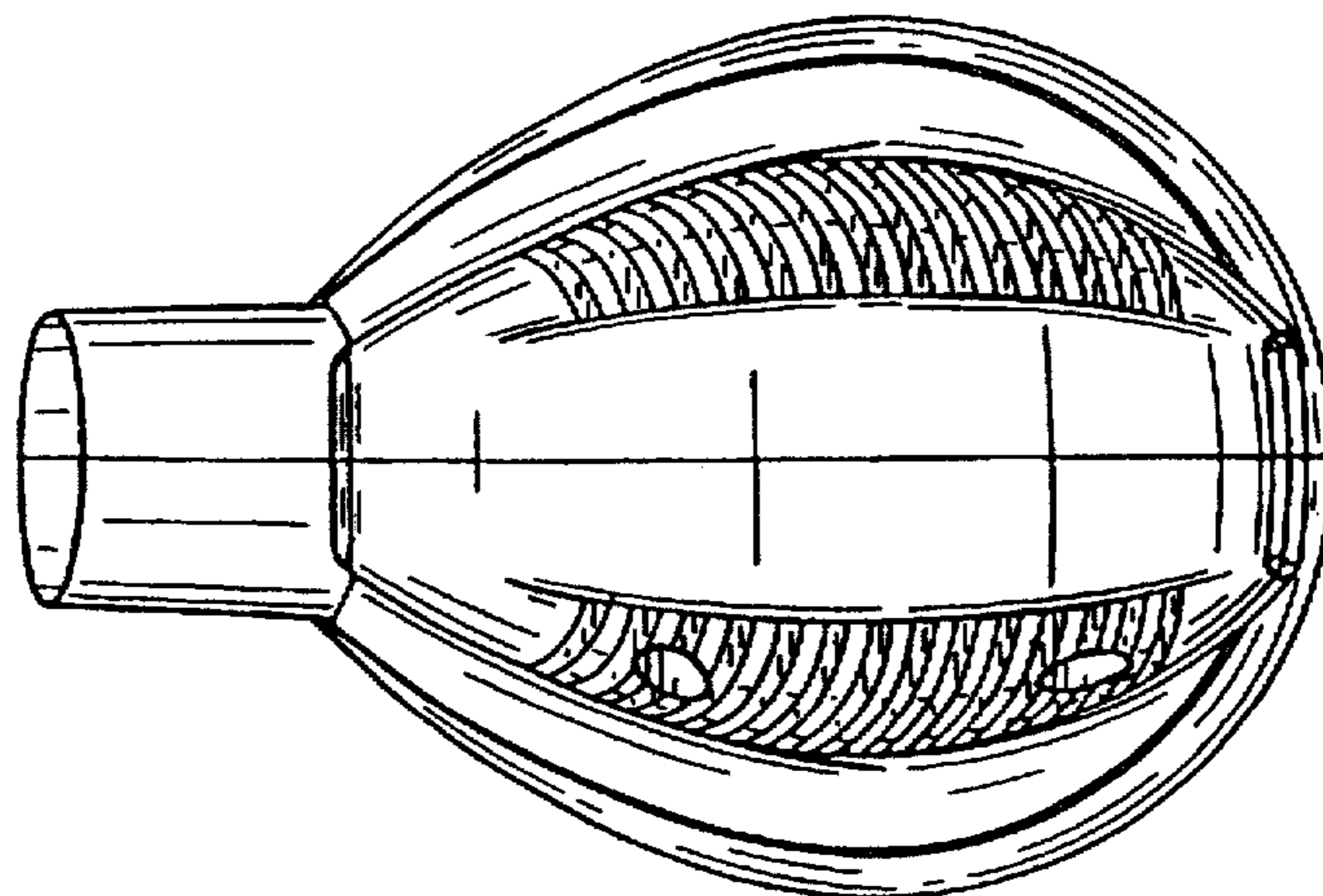
