[57] CLAIM

The ornamental design for a dental patient simulator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dental patient simulator showing our new design;
 FIG. 2 is a rear elevational view;
 FIG. 3 is a left-side elevational view;
 FIG. 4 is a right-side elevational view;
 FIG. 5 is a front elevation view;
 FIG. 6 is a top plan view; and,
 FIG. 7 is a bottom plan view.

The structure depicted by means of broken lines in FIGS. 2, 3, and 5 through 7 has been shown for illustrative purposes only and forms no part of the claimed design.

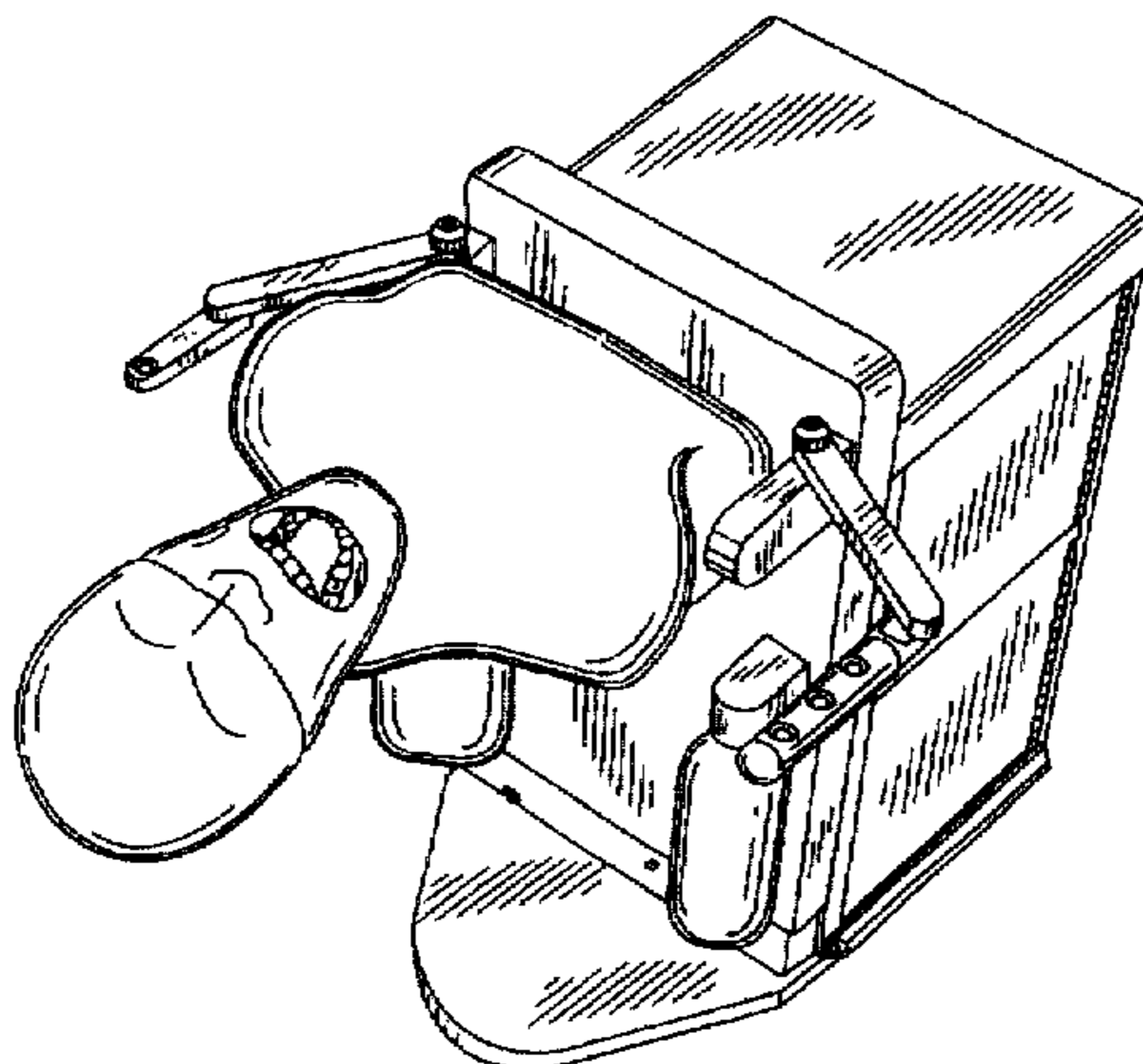

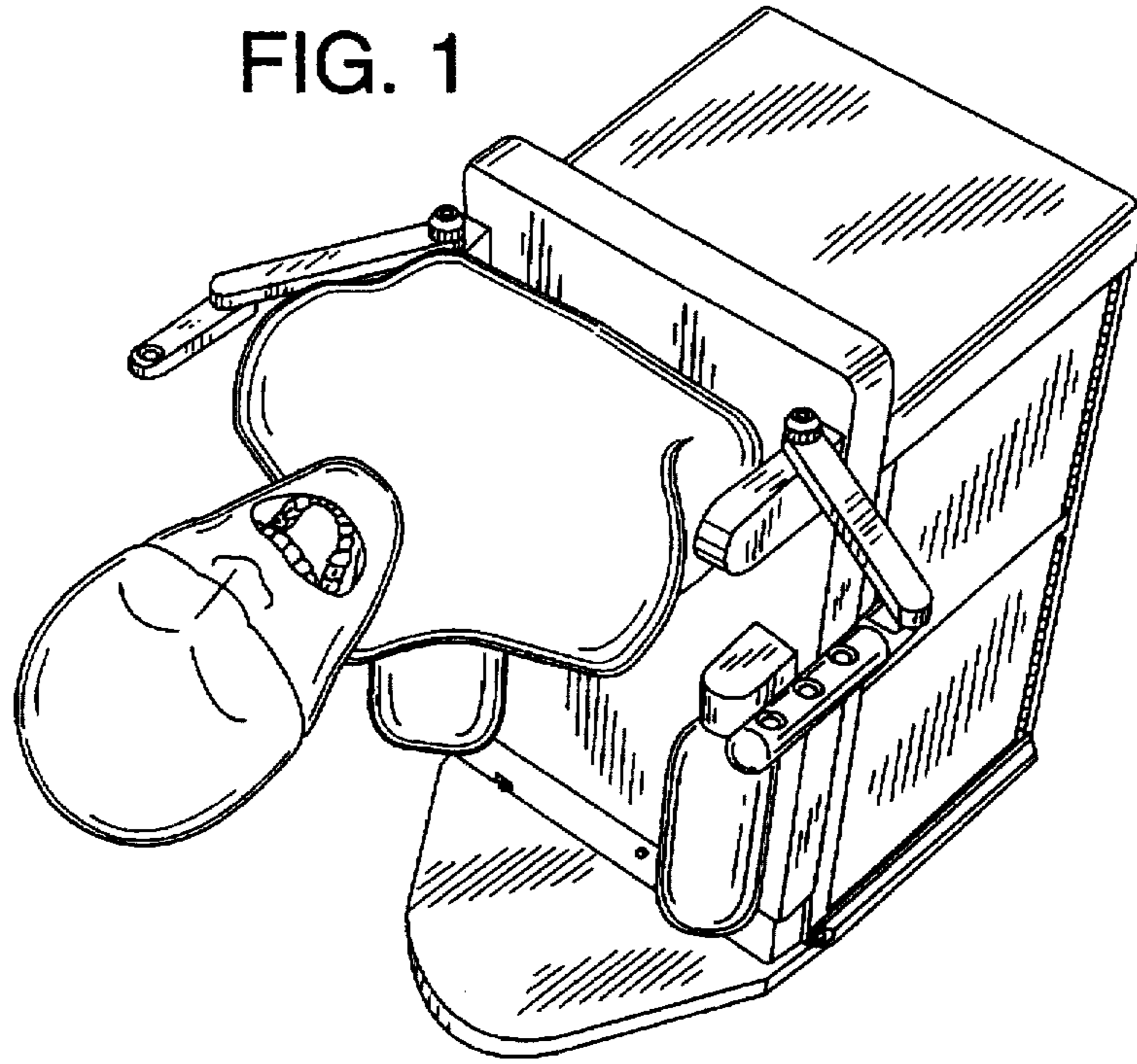
