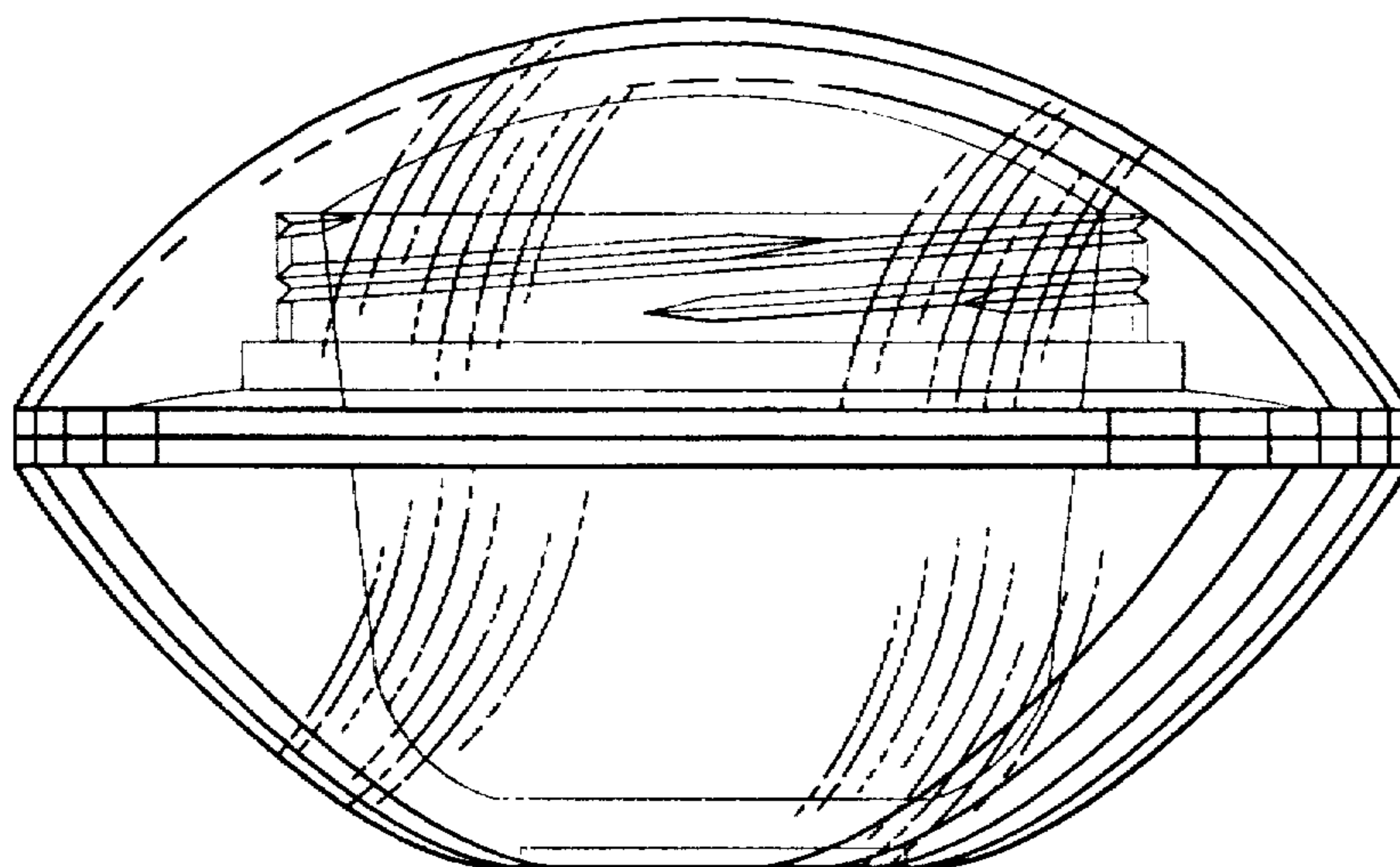

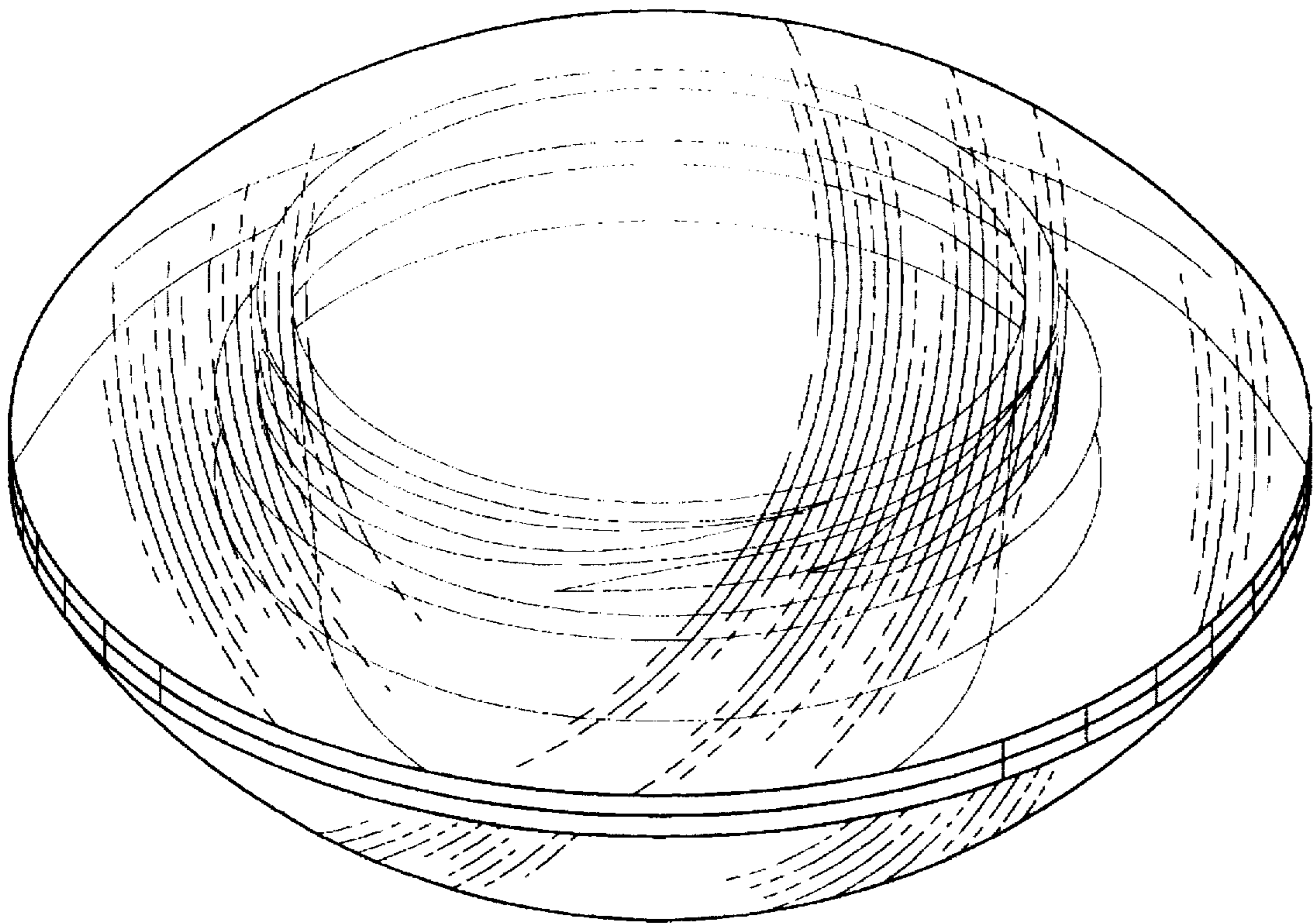
[57] **CLAIM**  
The ornamental design for a combined cosmetic jar and cap, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a combined cosmetic jar and cap of my invention;  
FIG. 2 is a top plan view of FIG. 1;  
FIG. 3 is a front elevational view of FIG. 1;  
FIG. 4 is a bottom view of FIG. 1;  
FIG. 5 is a rear view of FIG. 1;  
FIG. 6 is a perspective view of the cap separated from the body of the jar in FIG. 1;  
FIG. 7 is a top view of the cap of the jar in FIG. 1;  
FIG. 8 is a front elevational view of the cap of the jar in FIG. 1;  
FIG. 9 is a bottom view of the cap of the jar in FIG. 1;  
FIG. 10 is a rear elevation of the cap;  
FIG. 11 is a top plan view of the body of the jar;  
FIG. 12 is a left side view of the body of the jar in FIG. 1;  
FIG. 13 is a bottom view of the body of the jar in FIG. 1; and,  
FIG. 14 is a rear view of the body of the jar in FIG. 1.  
The cap in FIGS. 7 through 10 and the jar in FIGS. 11 through 14 are shown separately for clarity of illustration.

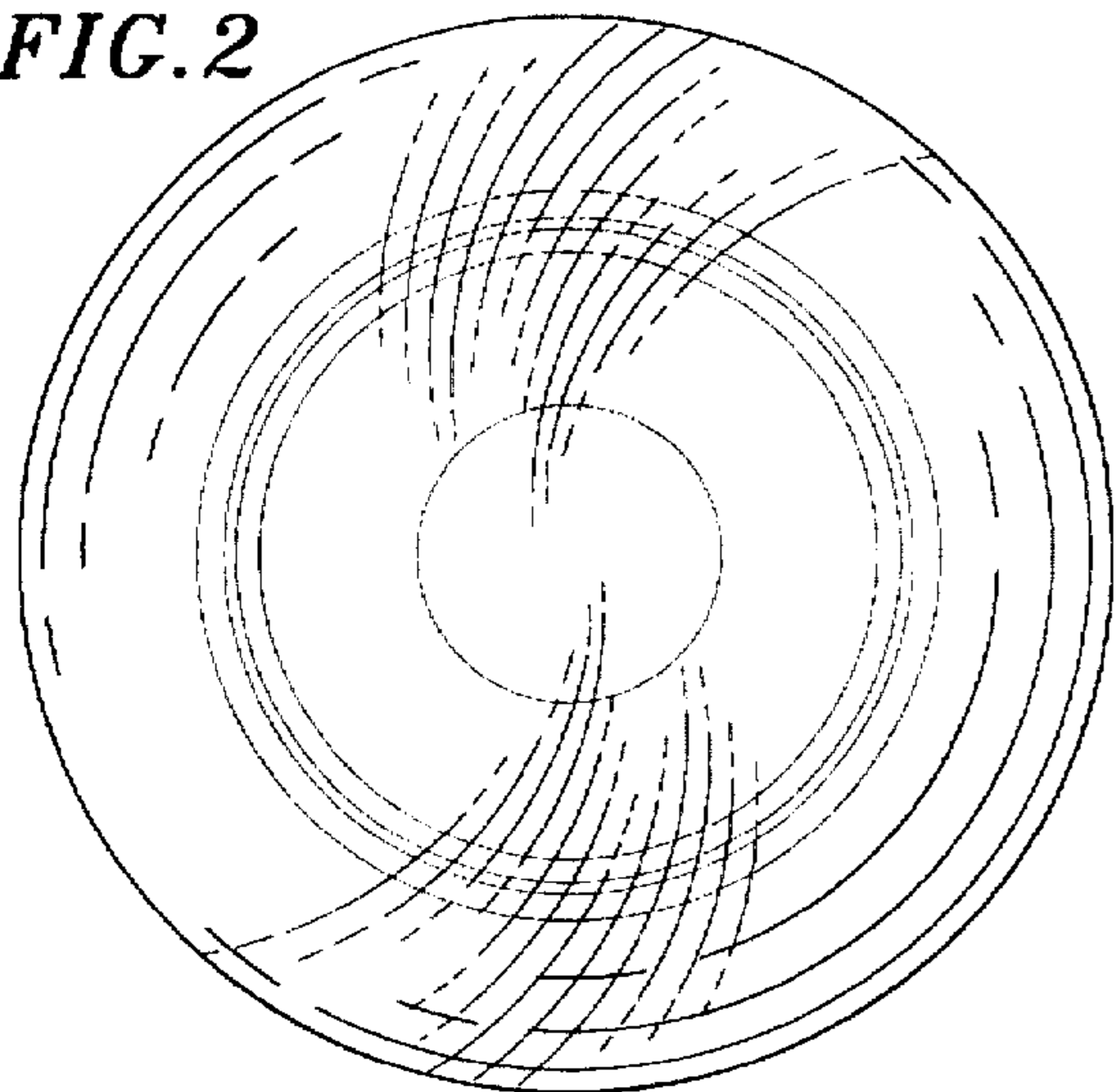

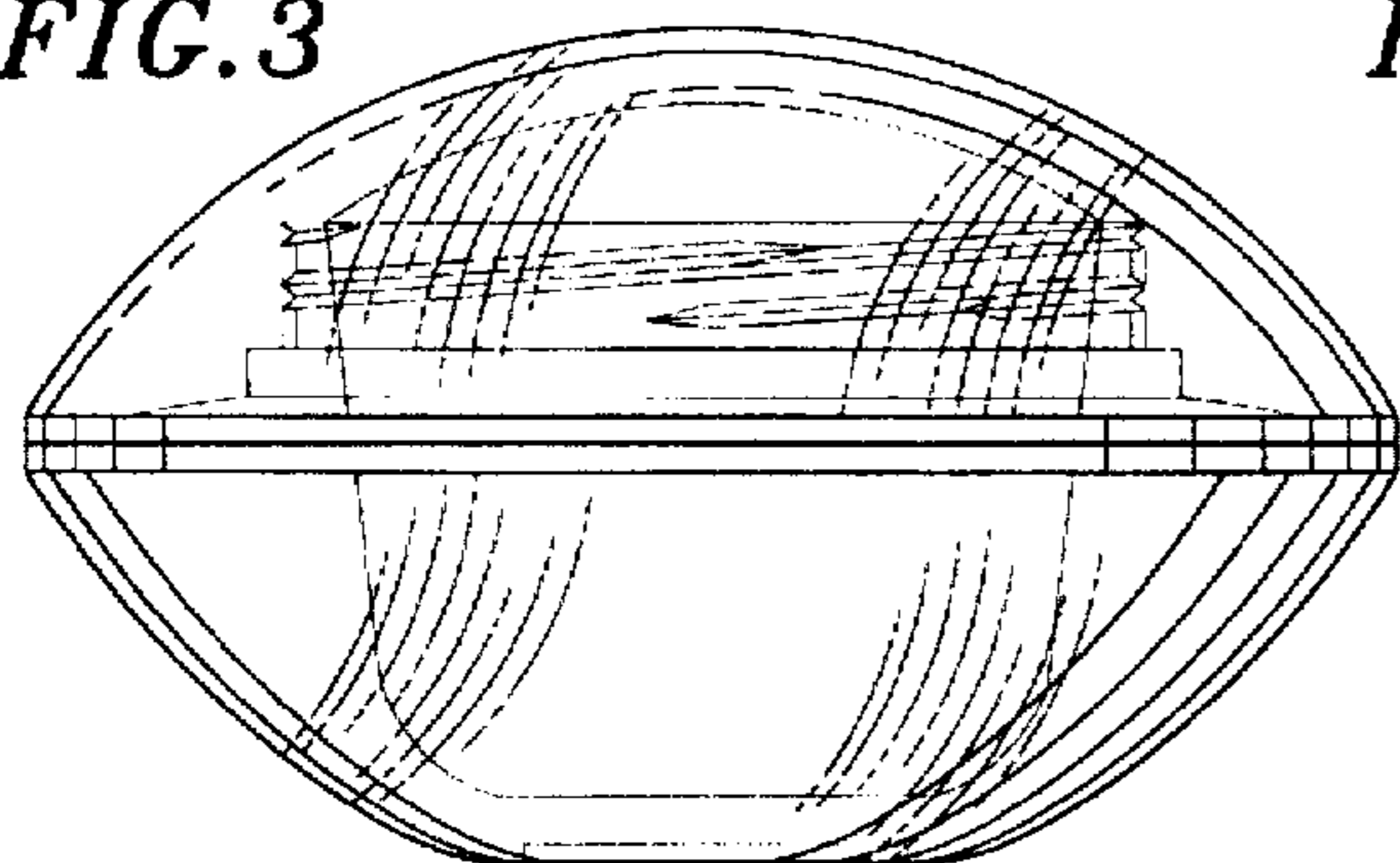

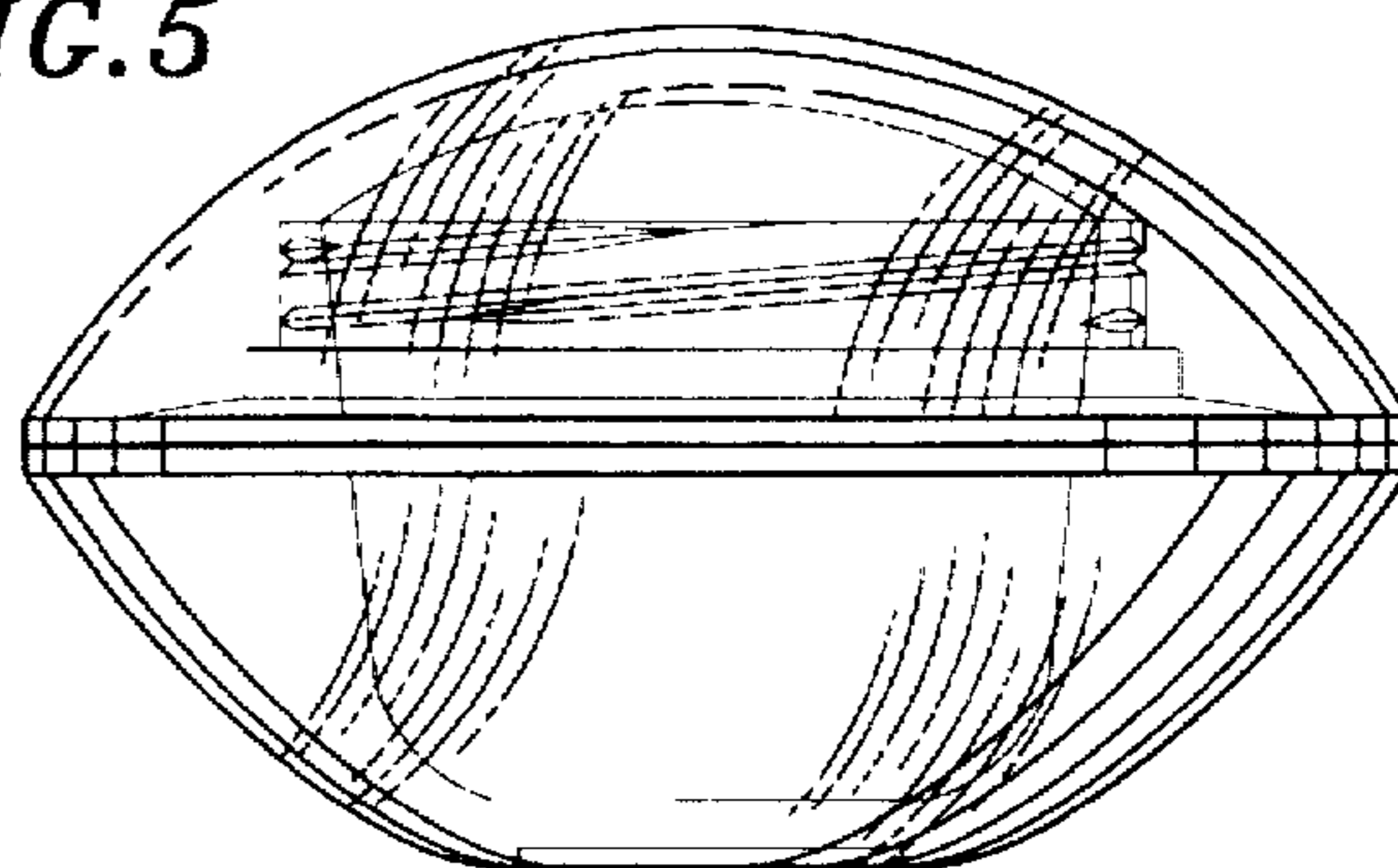

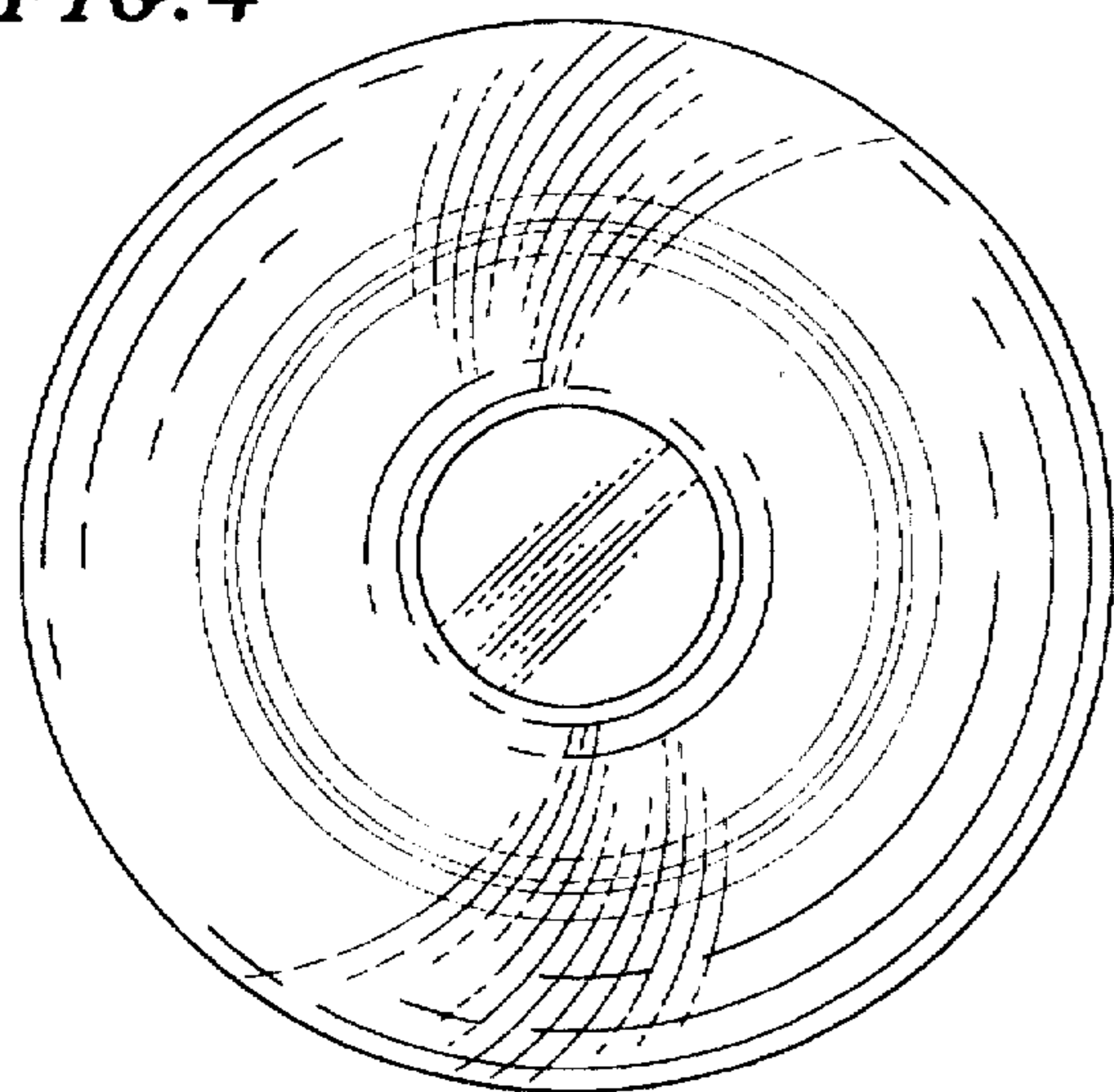

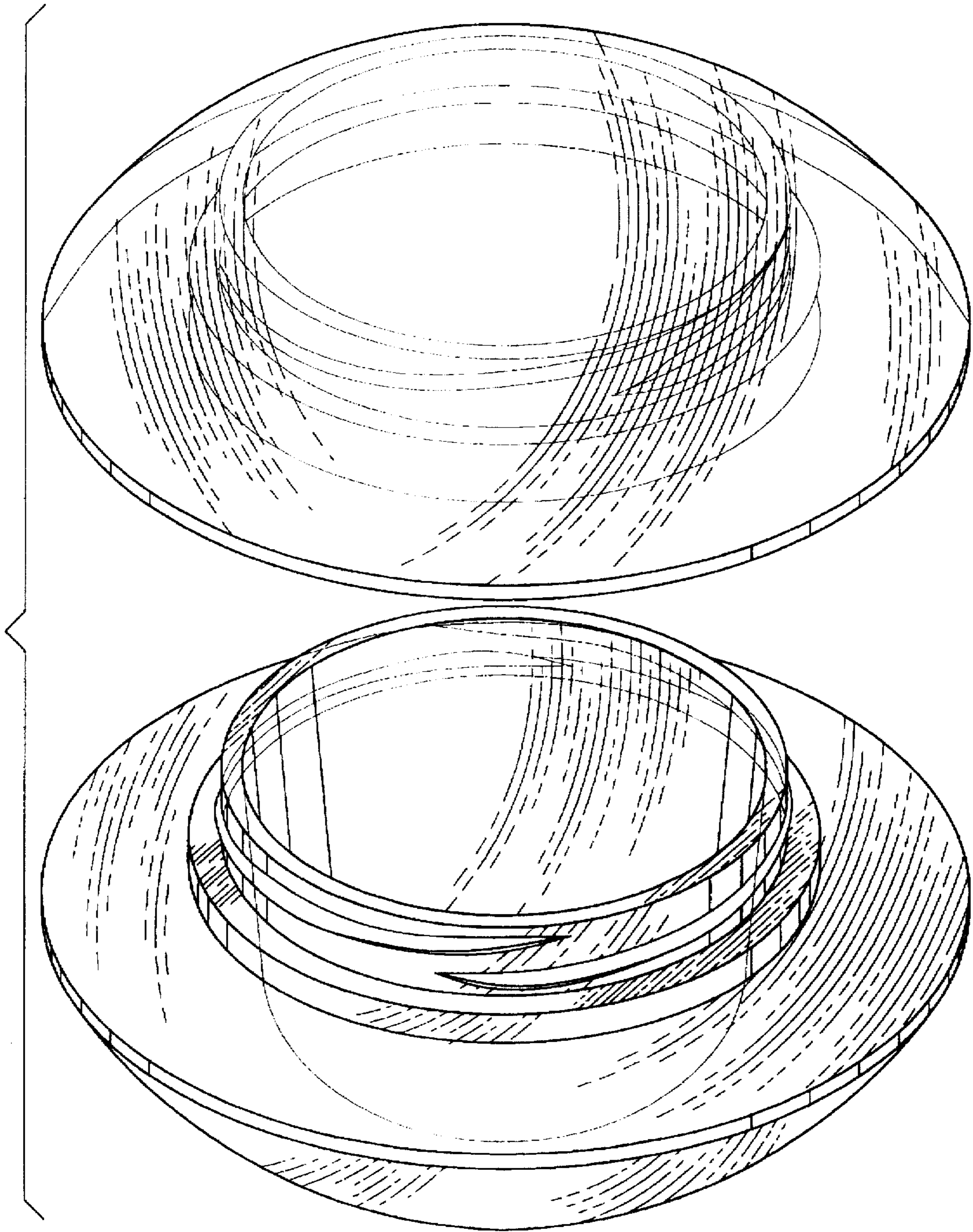

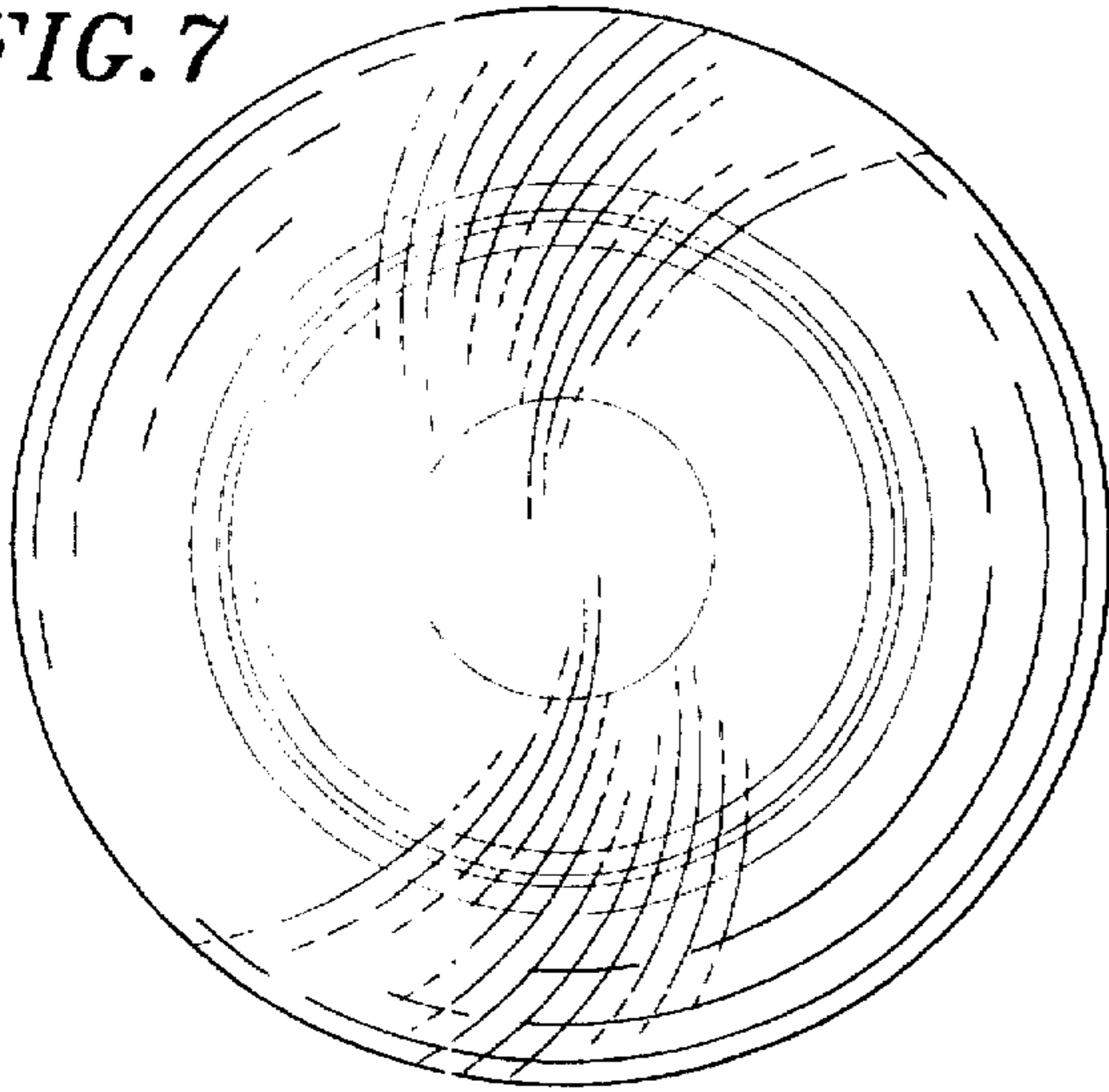

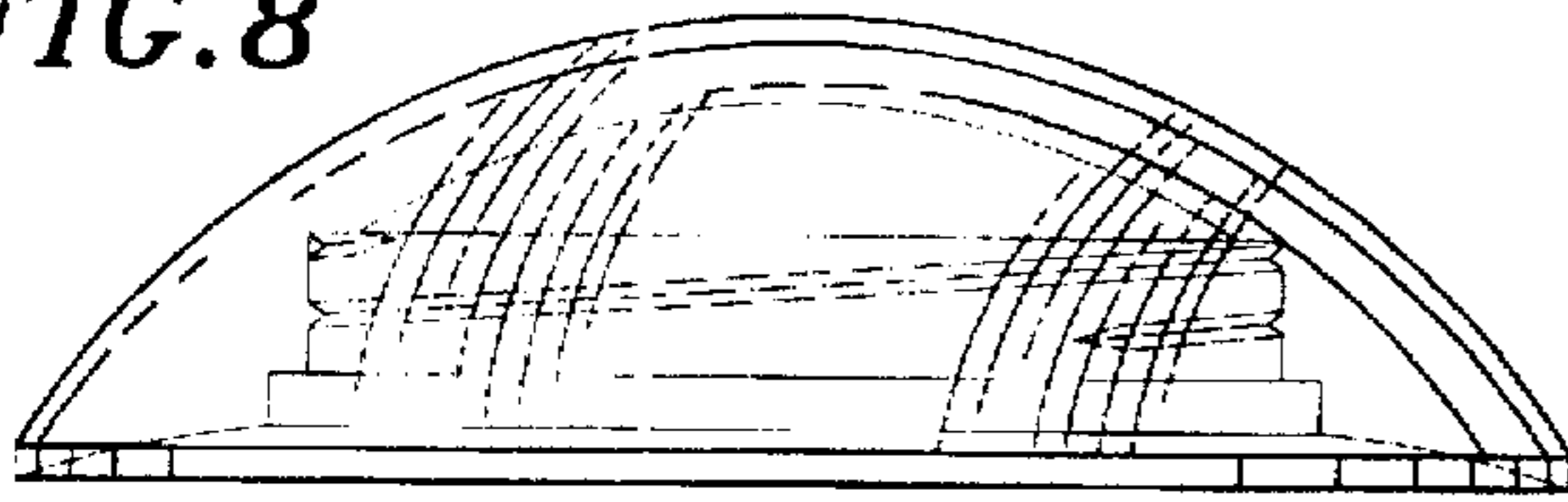

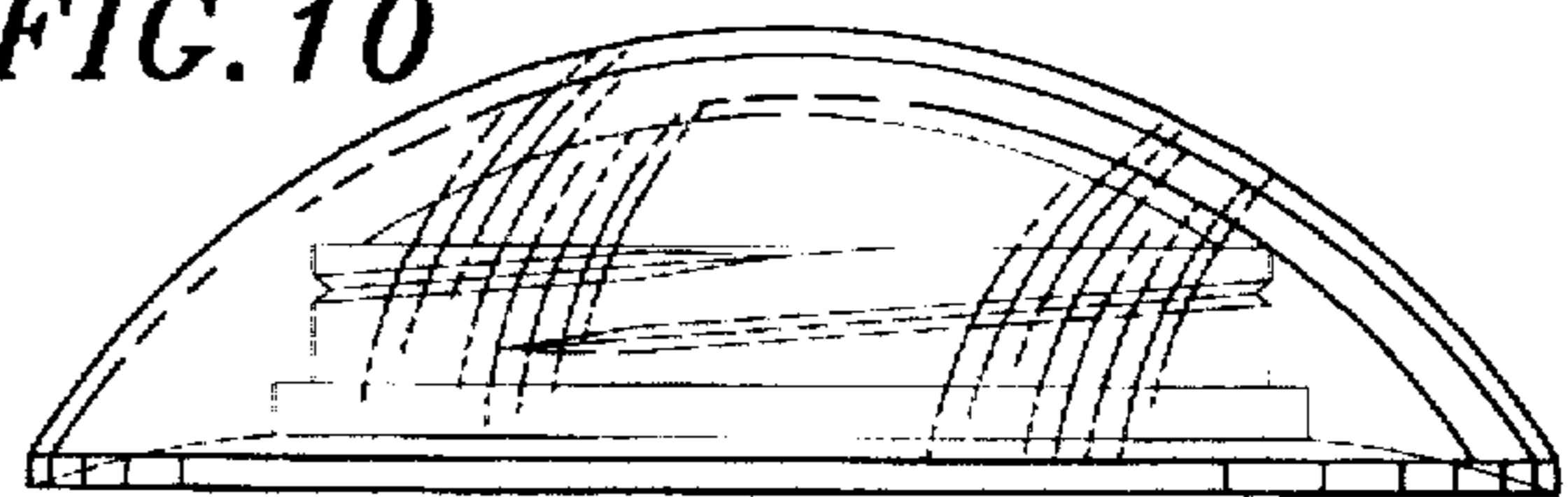

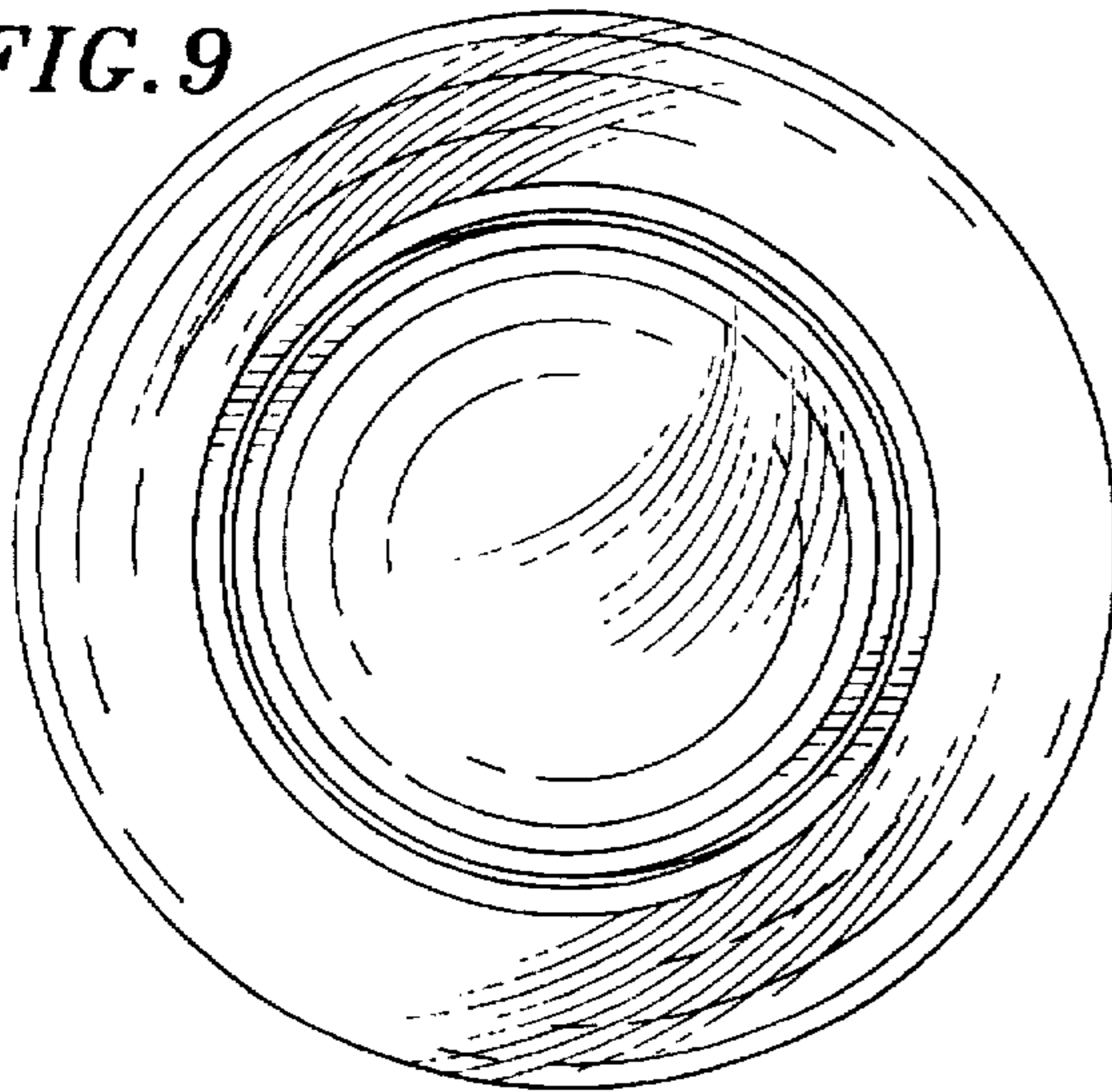

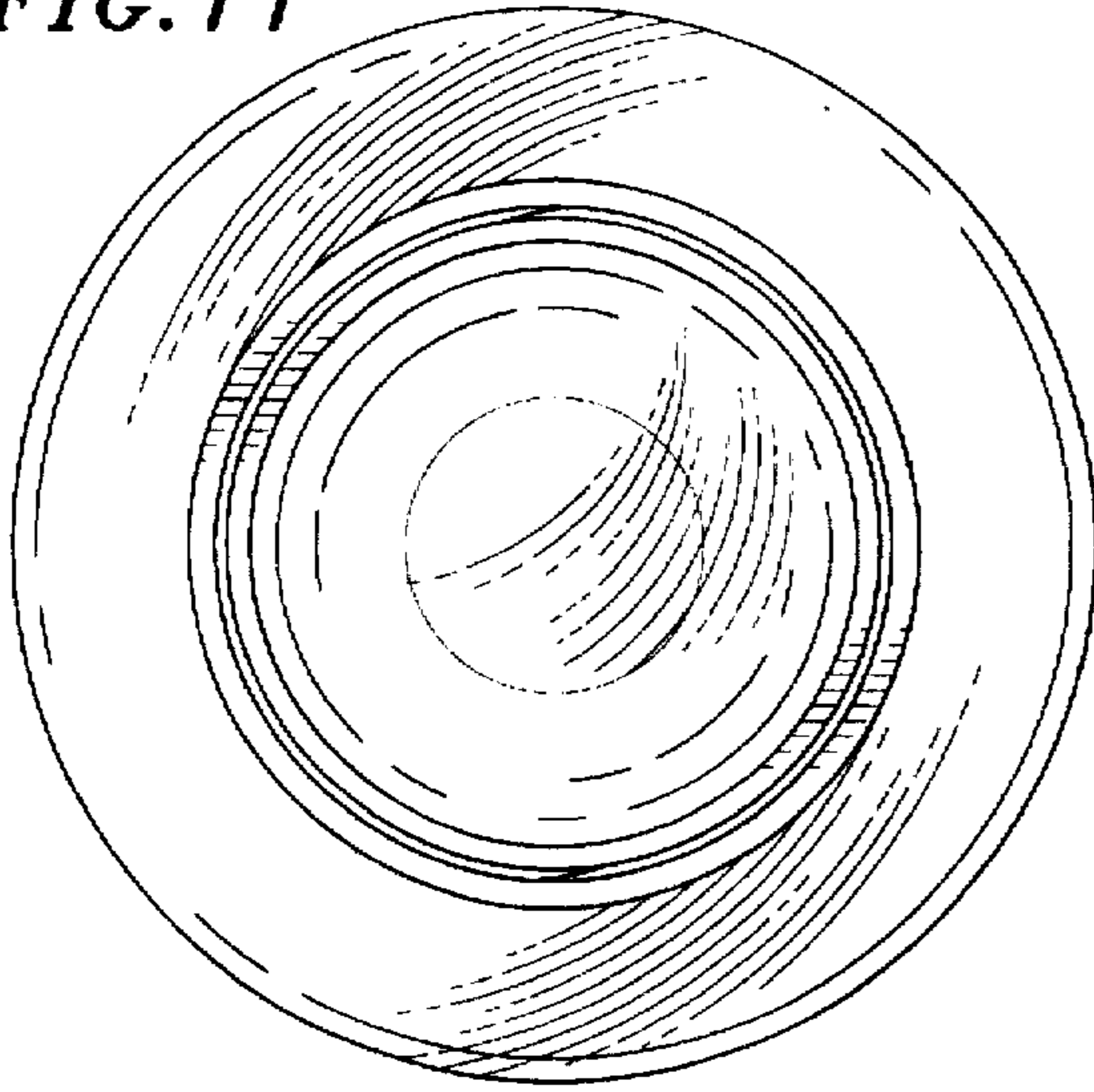

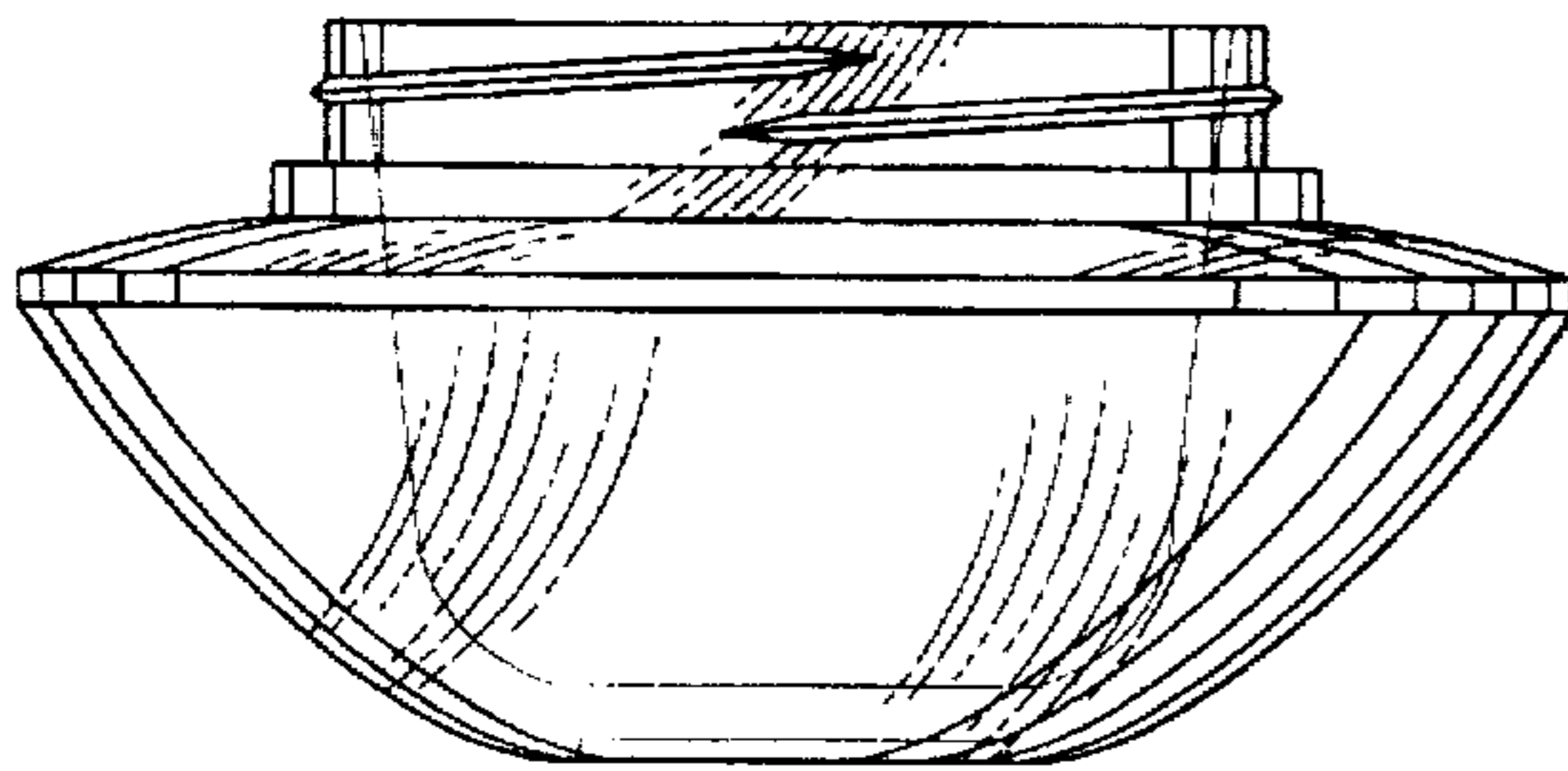

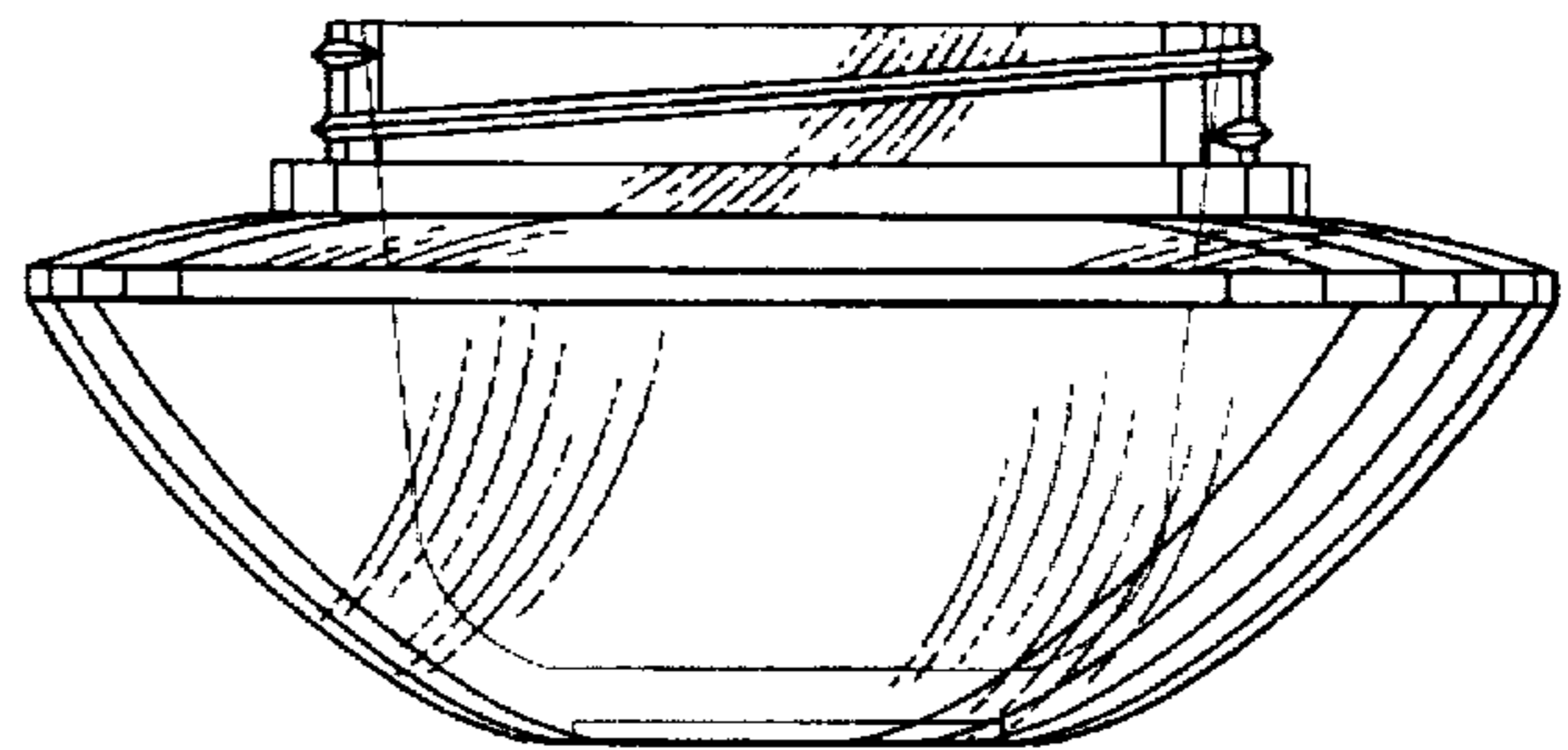
