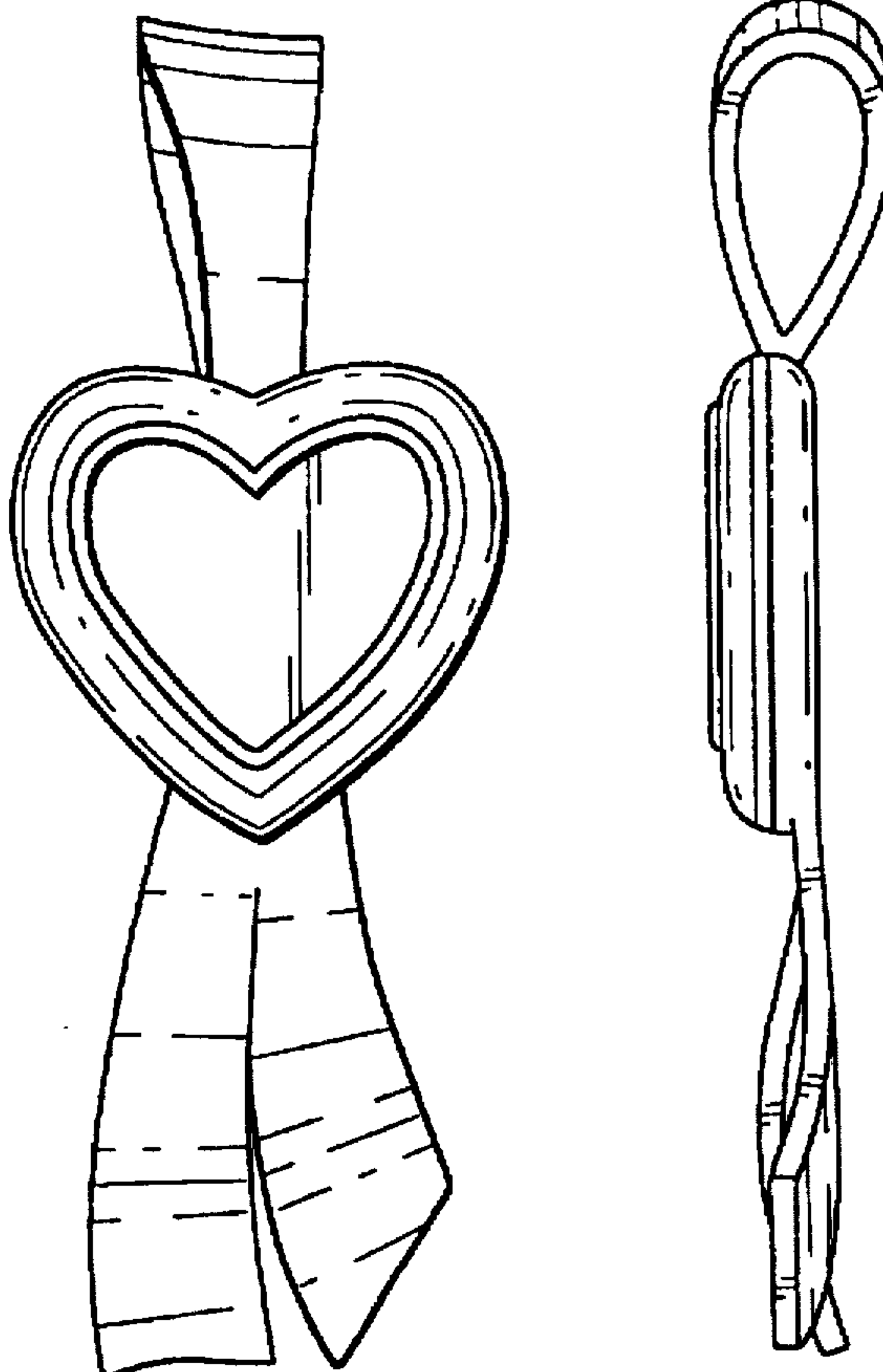

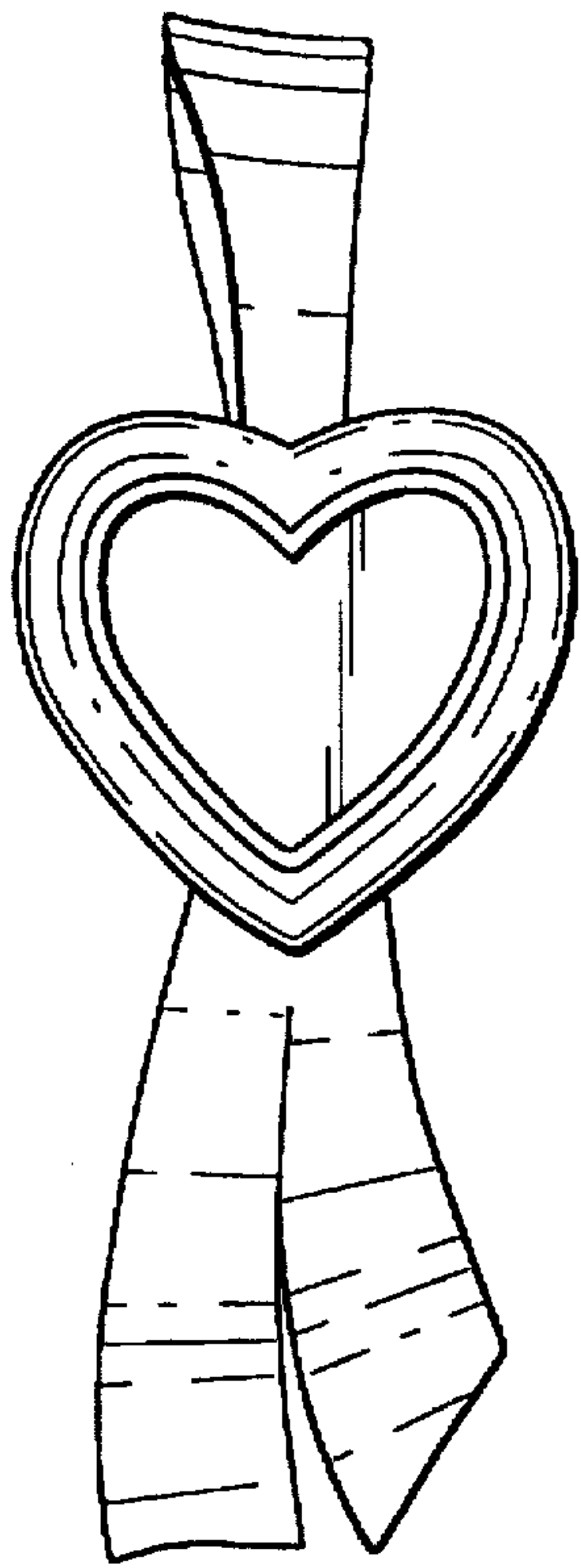
The ornamental design for combined ribbon and picture frame jewelry, as shown and described.

**DESCRIPTION**

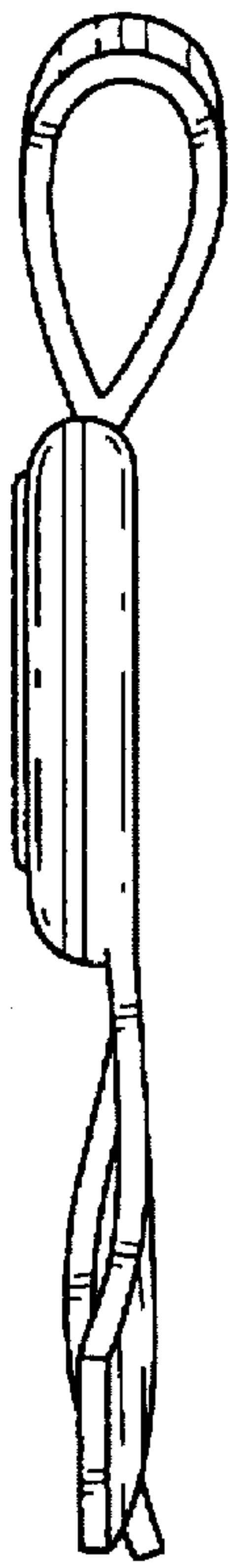

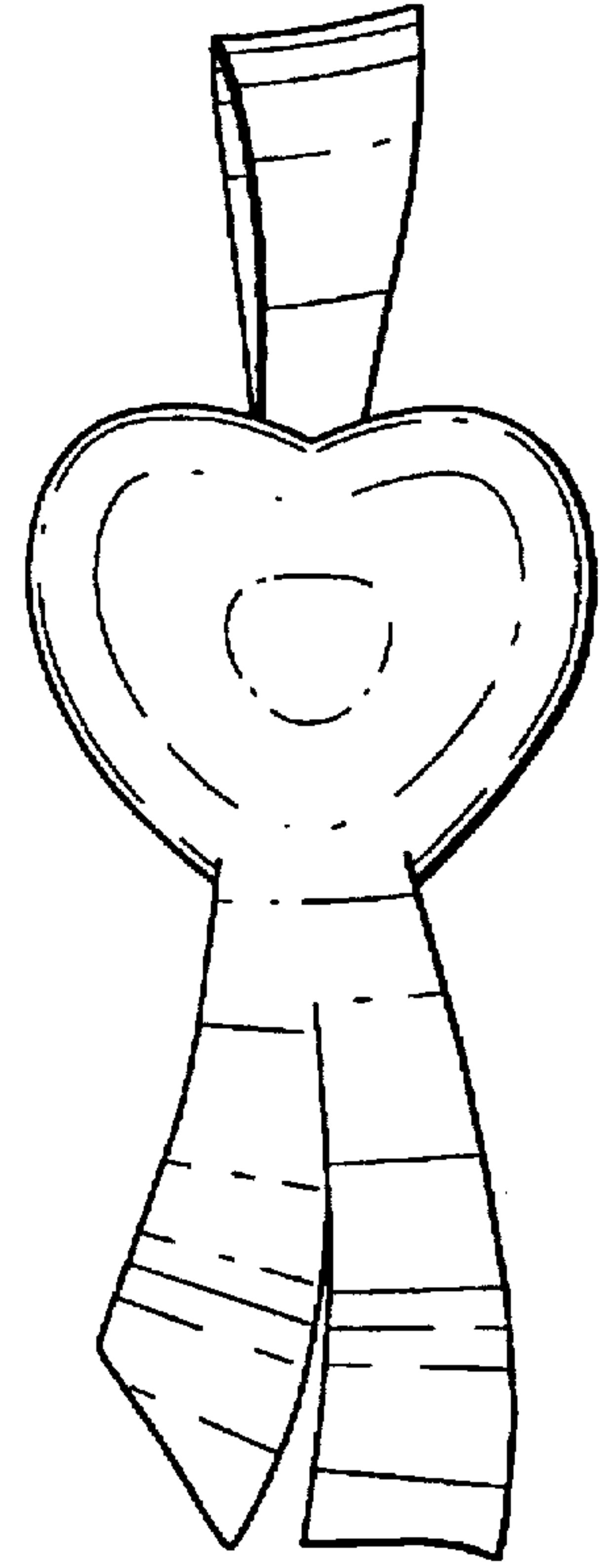

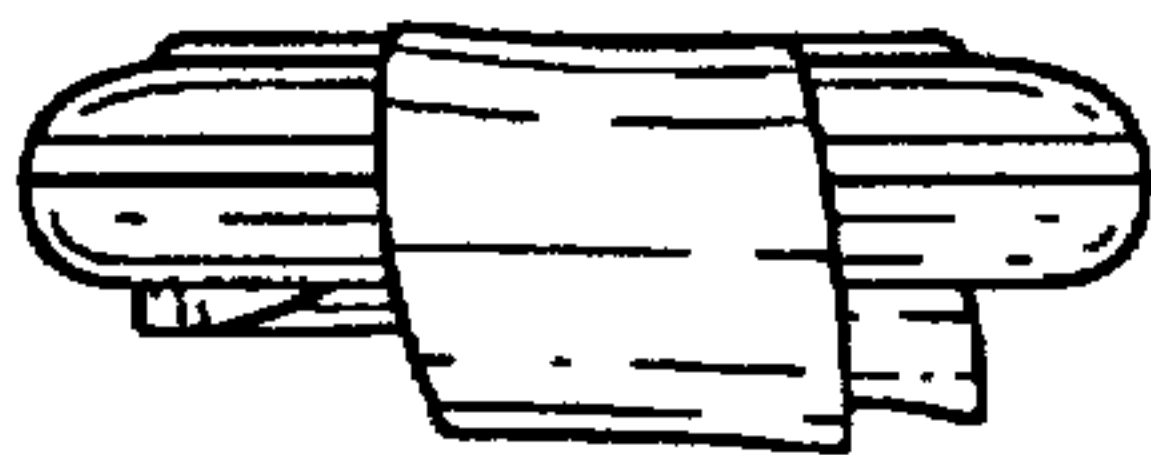

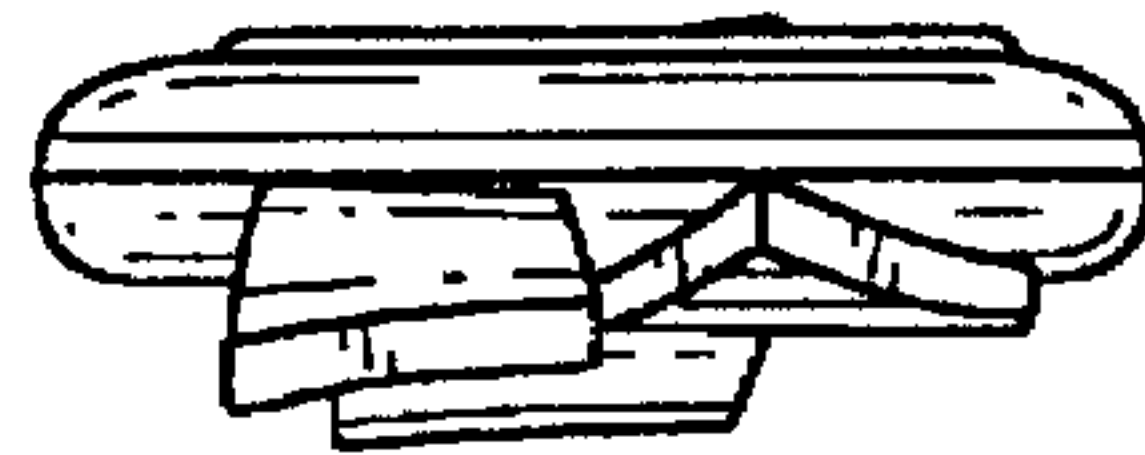
