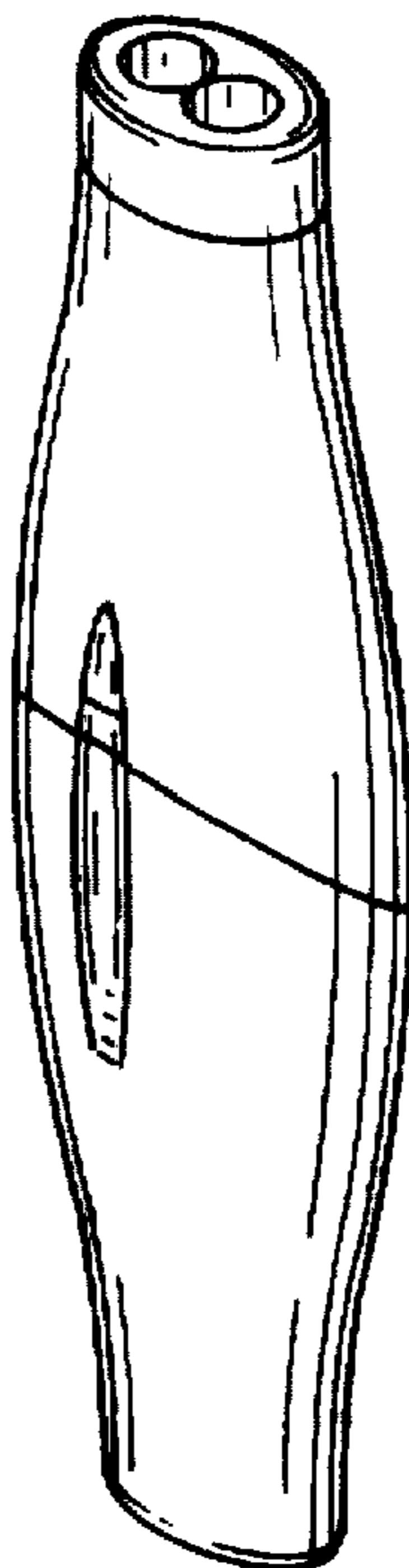
[57] **CLAIM**

FIG. 7 is perspective view thereof.

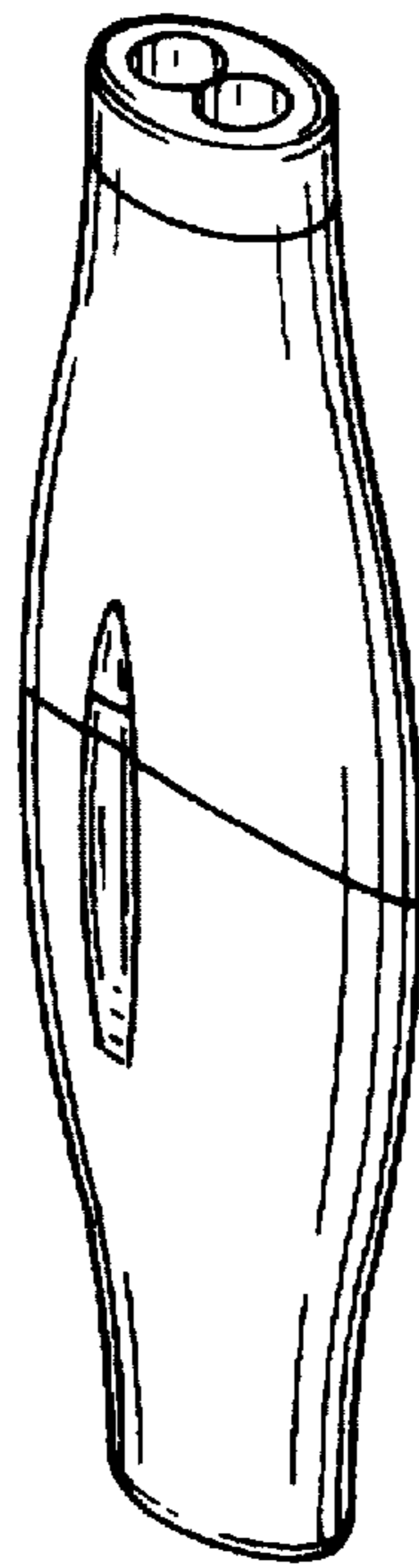
