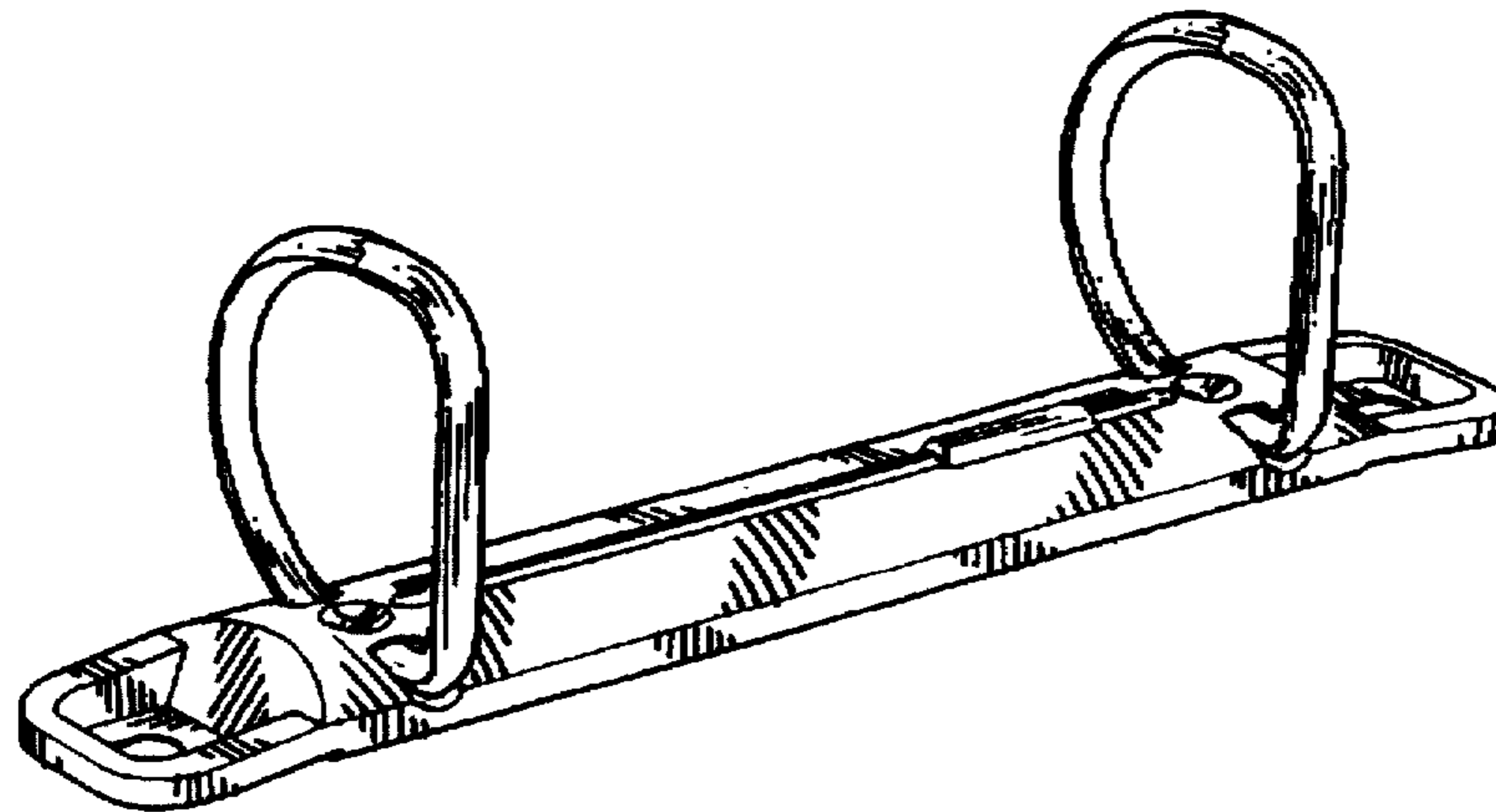
[57] **CLAIM**

The ornamental design of a ring binder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a ring binder showing my new design;  
 FIG. 2 is a perspective view with the rings in an open position;  
 FIG. 3 is a side elevational view of FIG. 1;  
 FIG. 4 is a top plan view of FIG. 1;  
 FIG. 5 is an end elevational view of FIG. 1;  
 FIG. 6 is a side elevational view of the side opposite that shown in FIG. 3;  
 FIG. 7 is a bottom plan view of FIG. 1; and,  
 FIG. 8 is an end elevational view of the end opposite that shown in FIG. 5.

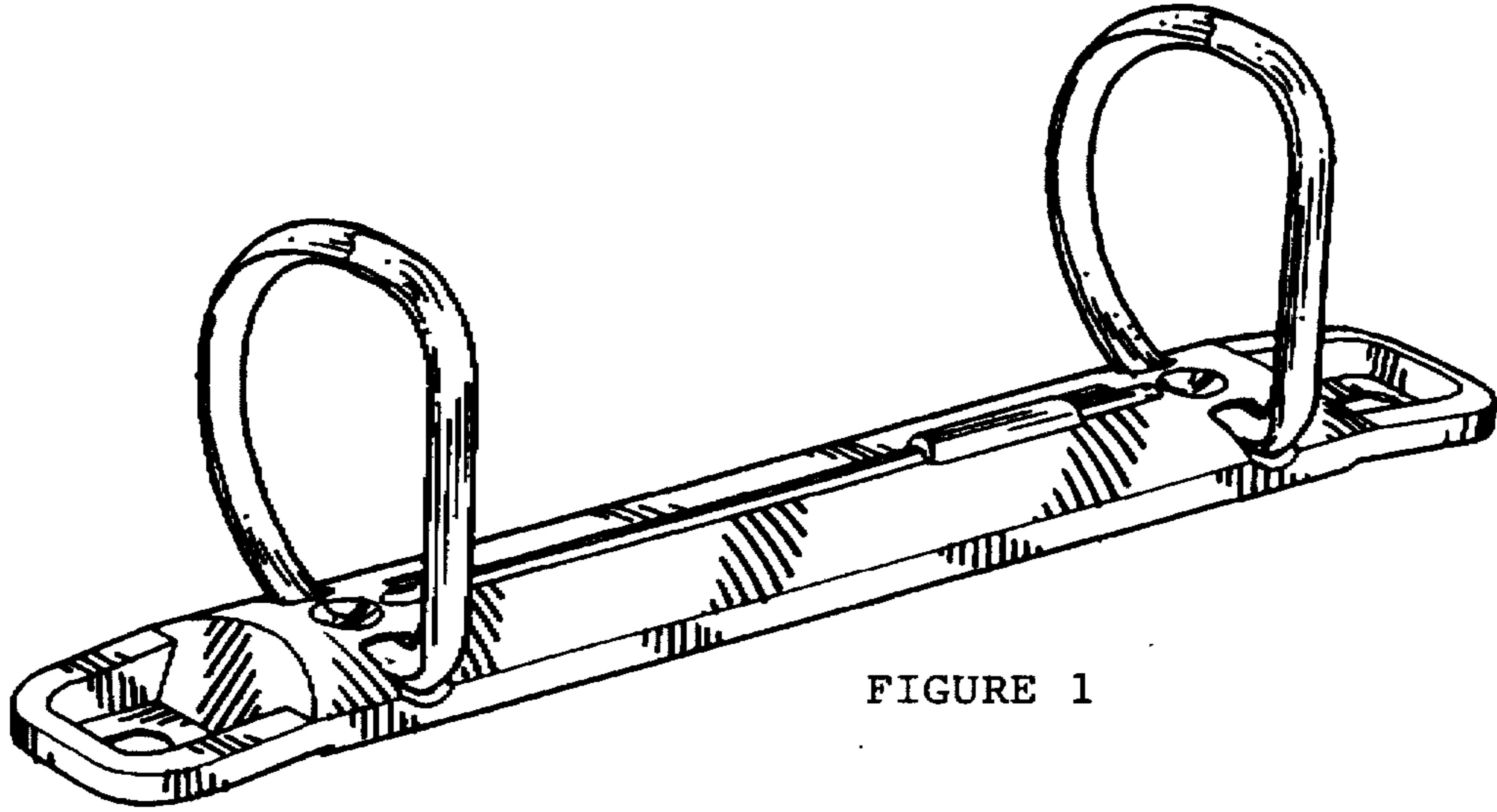

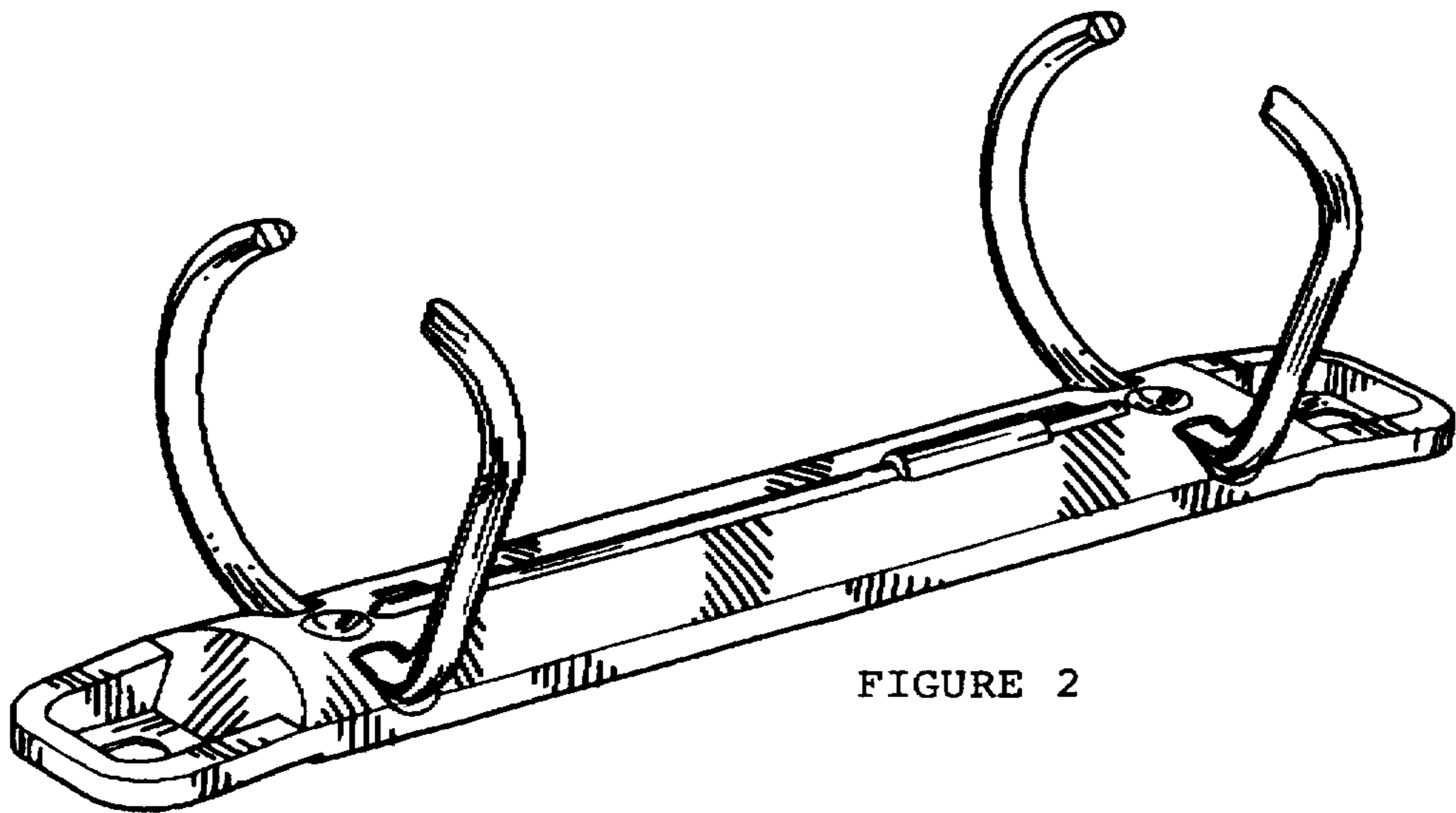

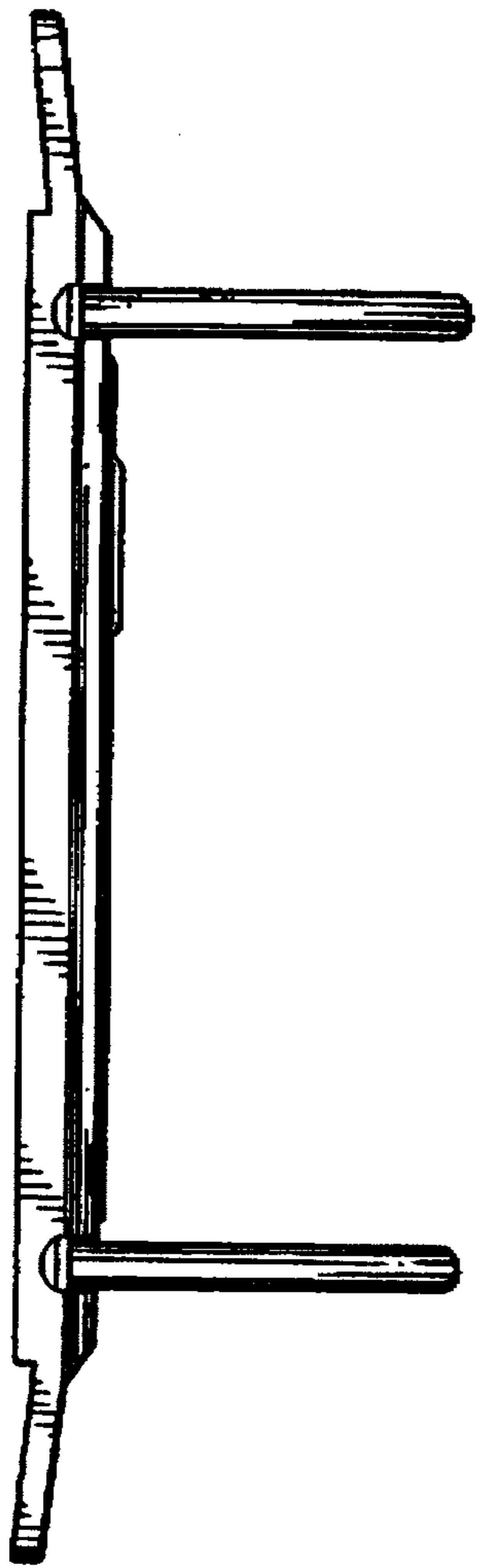

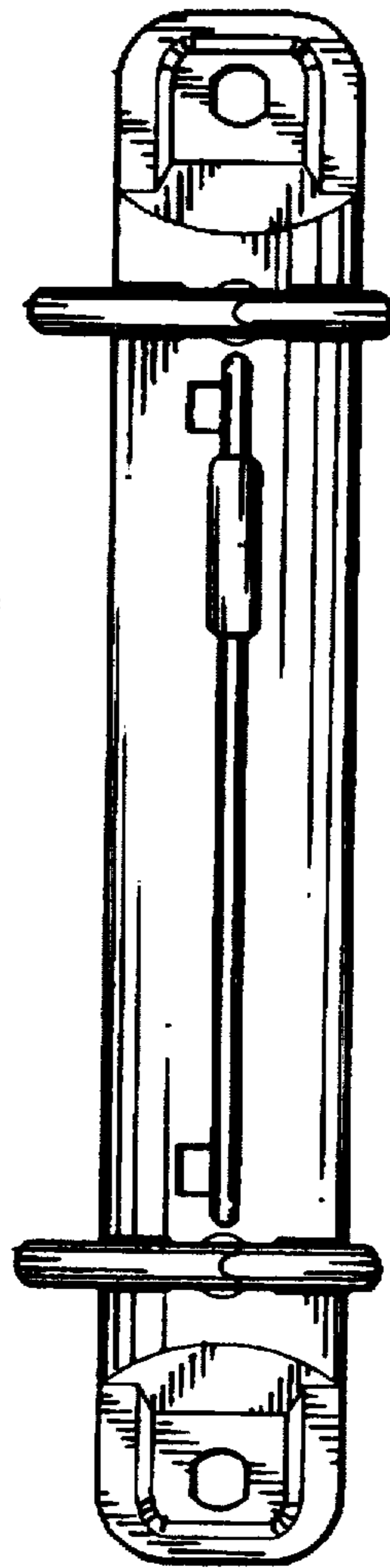
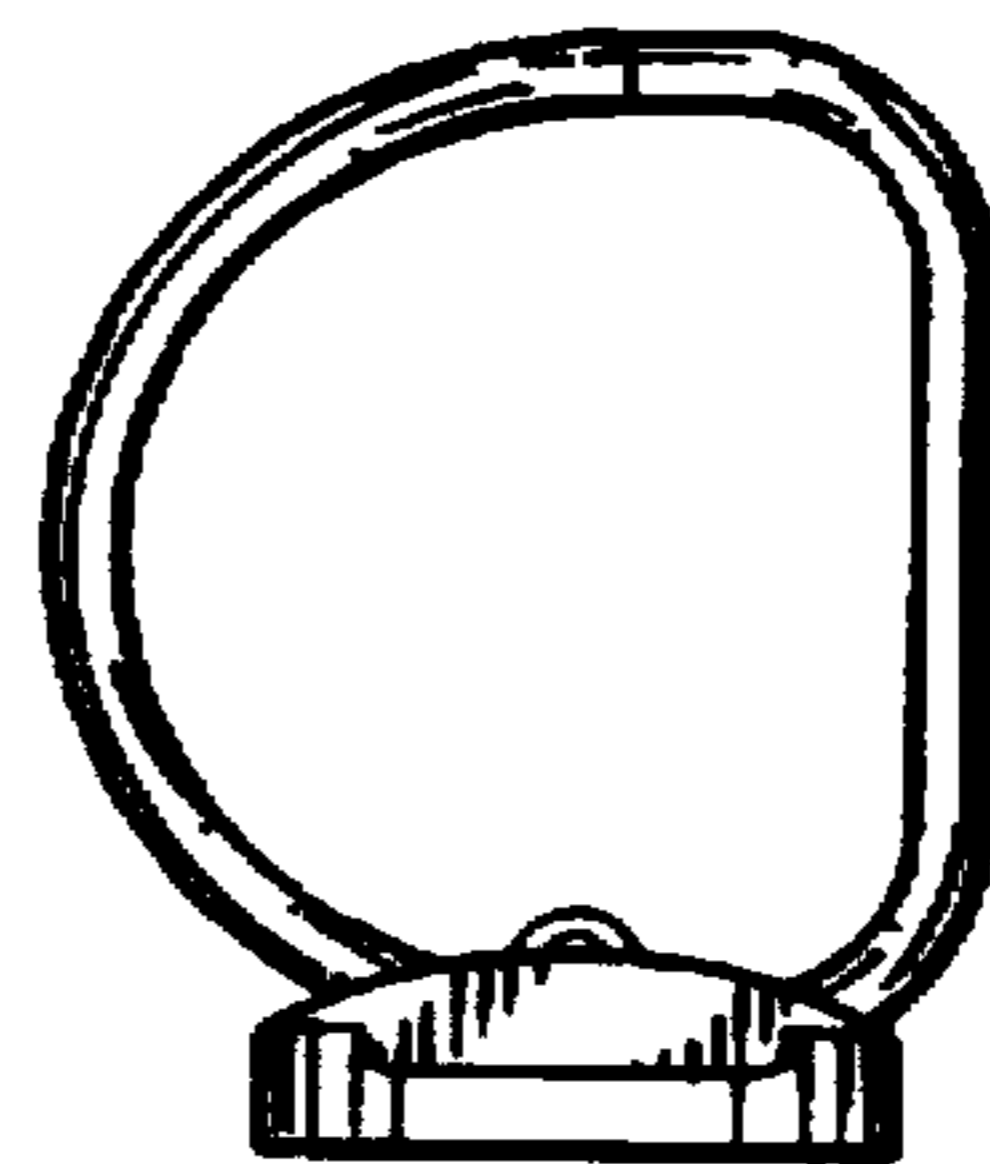

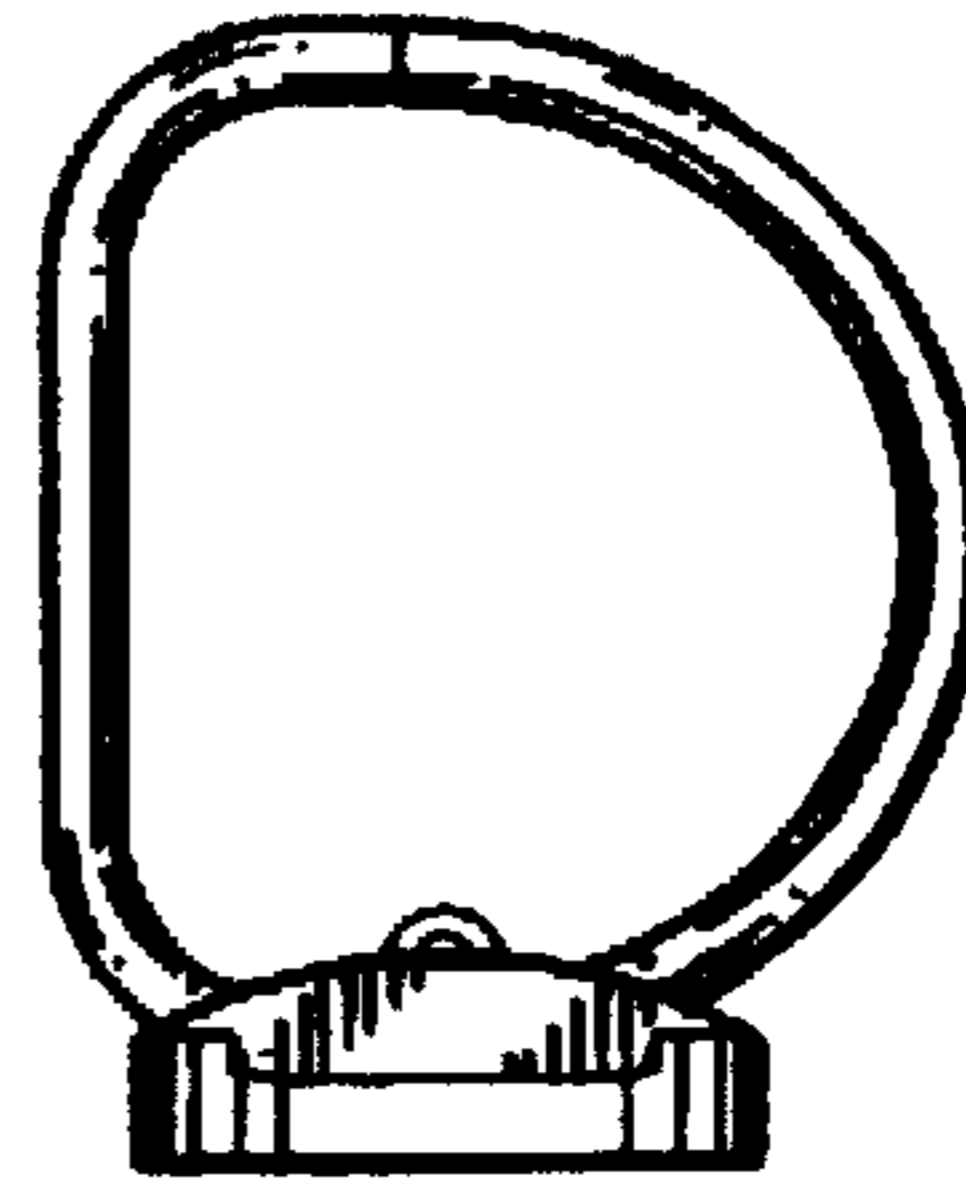

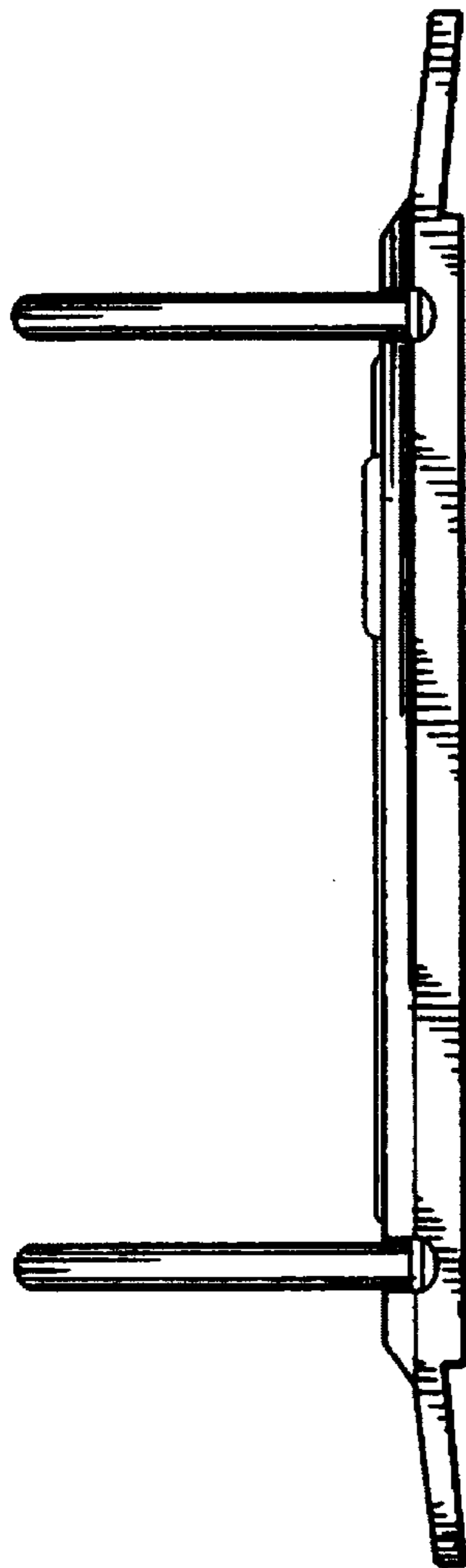

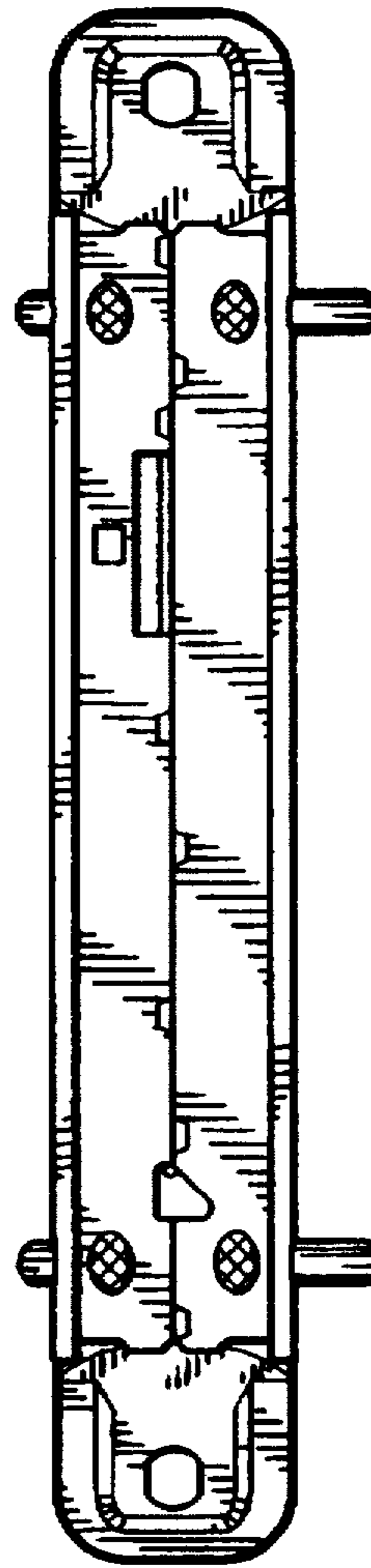
