[57] **CLAIM**

The ornamental design for a combined holder for a note pad, adhesive tape dispenser, and pen, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a combined holder for a note pad, adhesive tape dispenser, and pen showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a right front perspective view of a second embodiment of my design of FIG. 1 wherein the pen and pen support are omitted and the note paper tray is in a raised position, the note paper being removed for clarity of illustration;

FIG. 8 is a right front perspective view of the second embodiment with the note paper tray in the closed position;

FIG. 9 is a top plan view of the second embodiment;

FIG. 10 is a left side elevational view of the second embodiment;

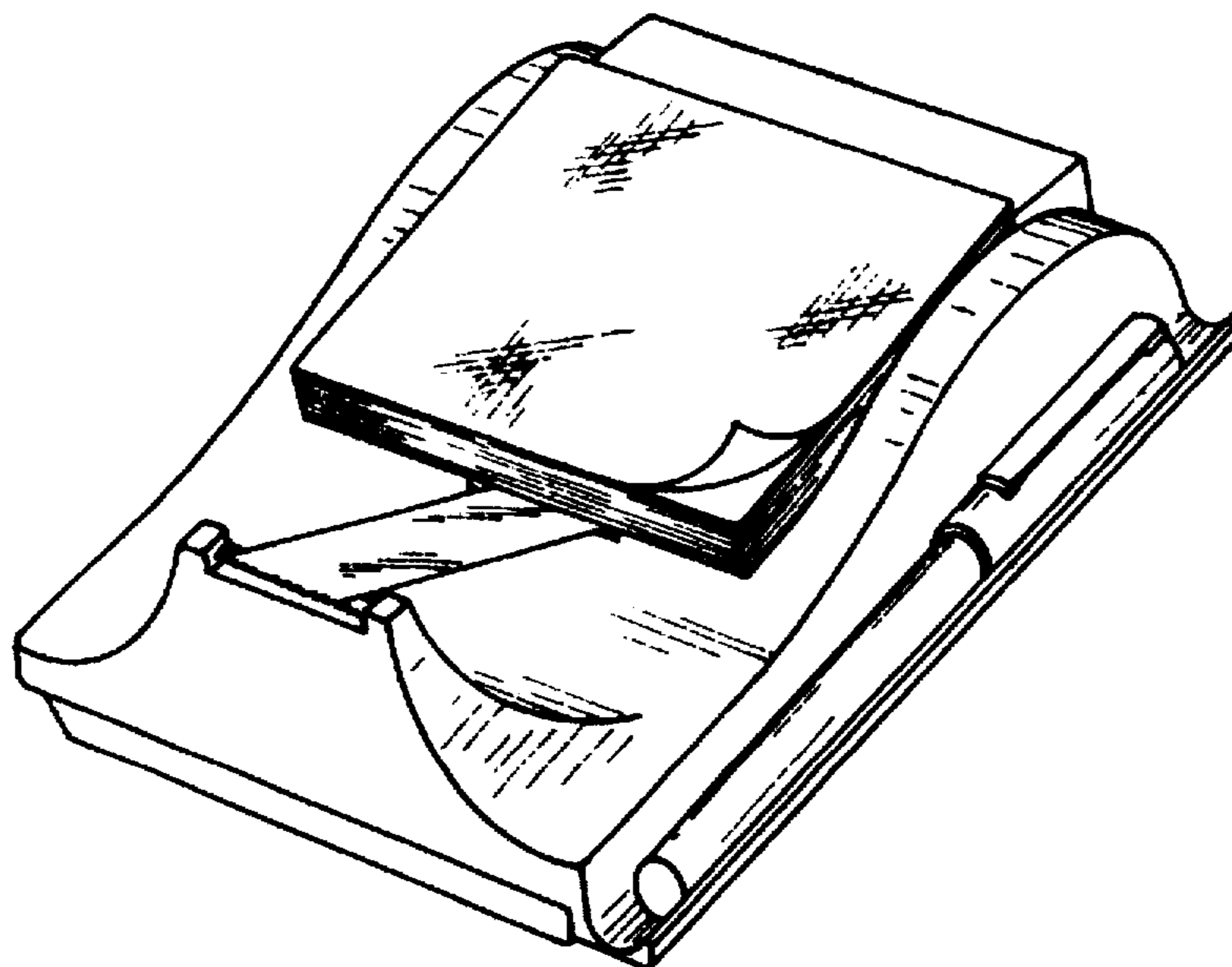
FIG. 11 is a bottom plan view of the second embodiment;

FIG. 12 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 13 is a front elevational view of the second embodiment; and,

FIG. 14 is a rear elevational view of the second embodiment.

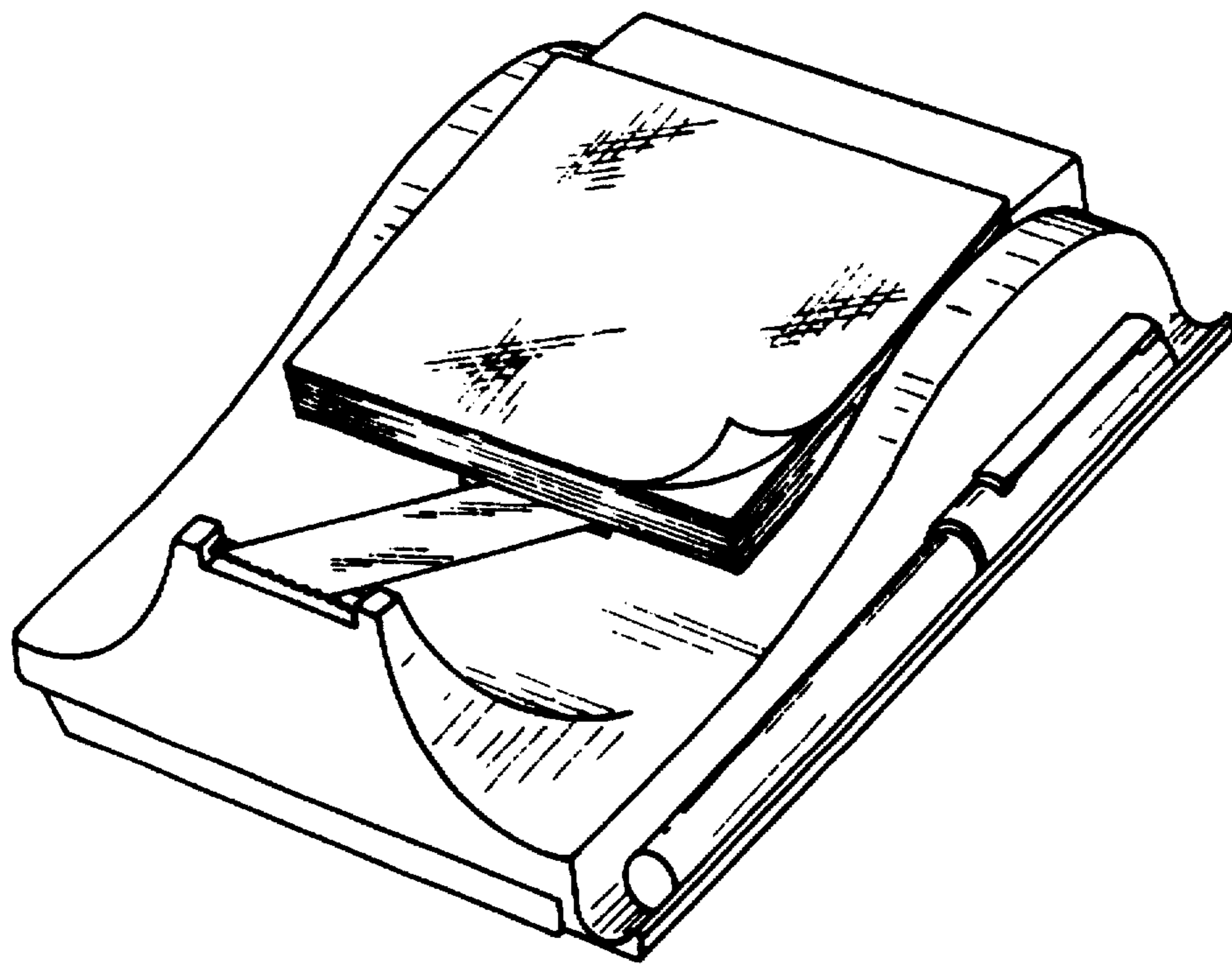

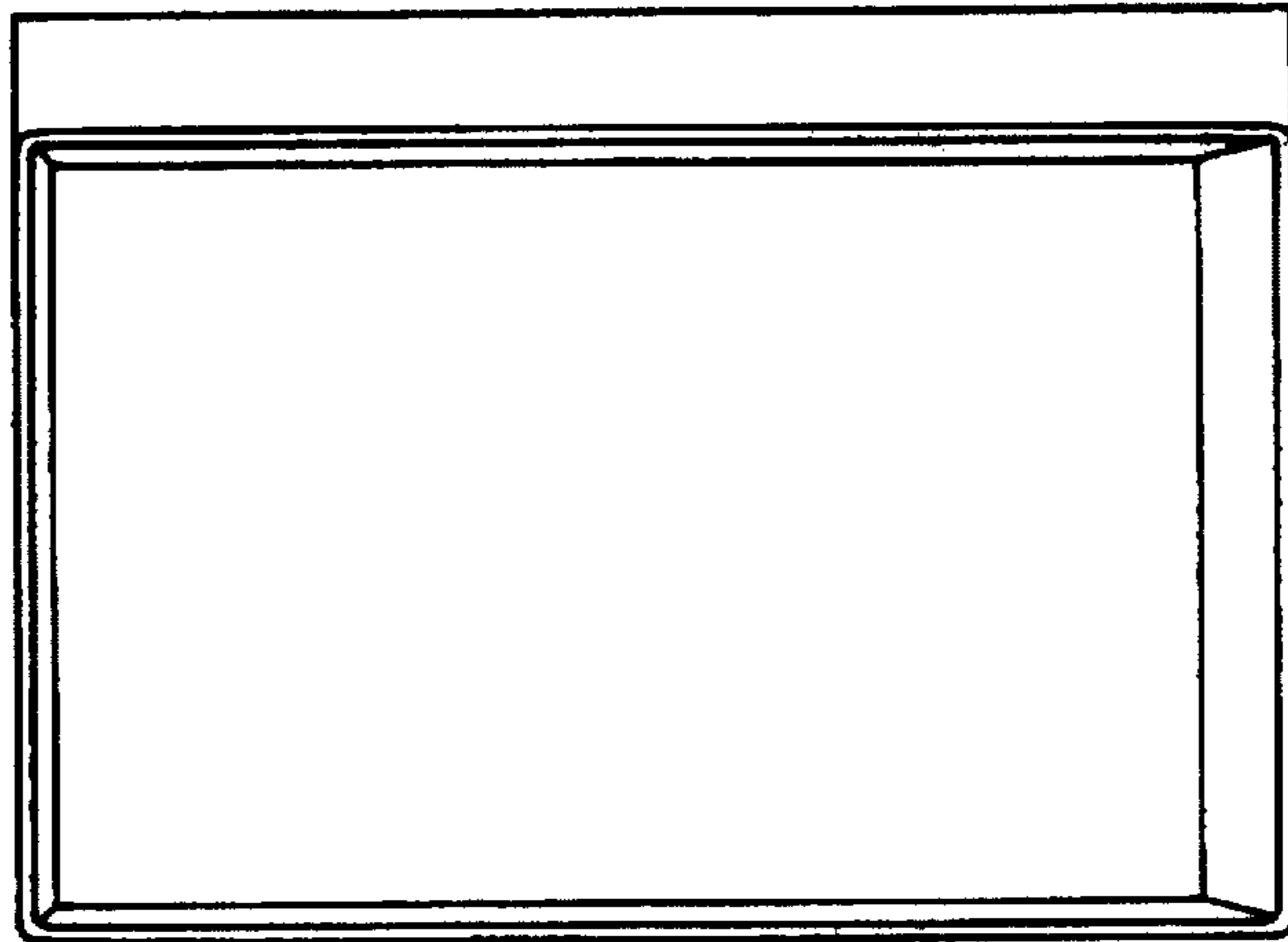

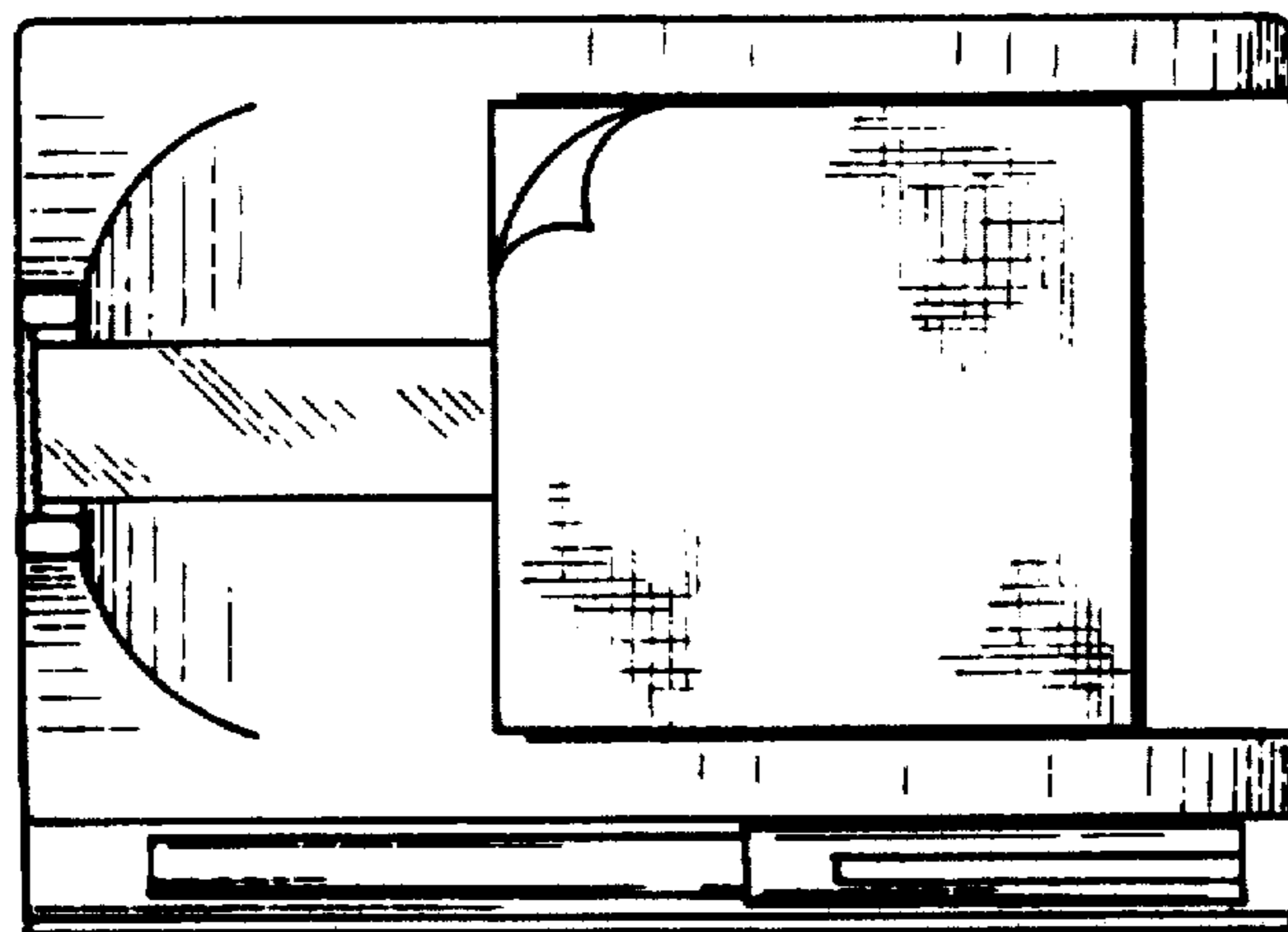

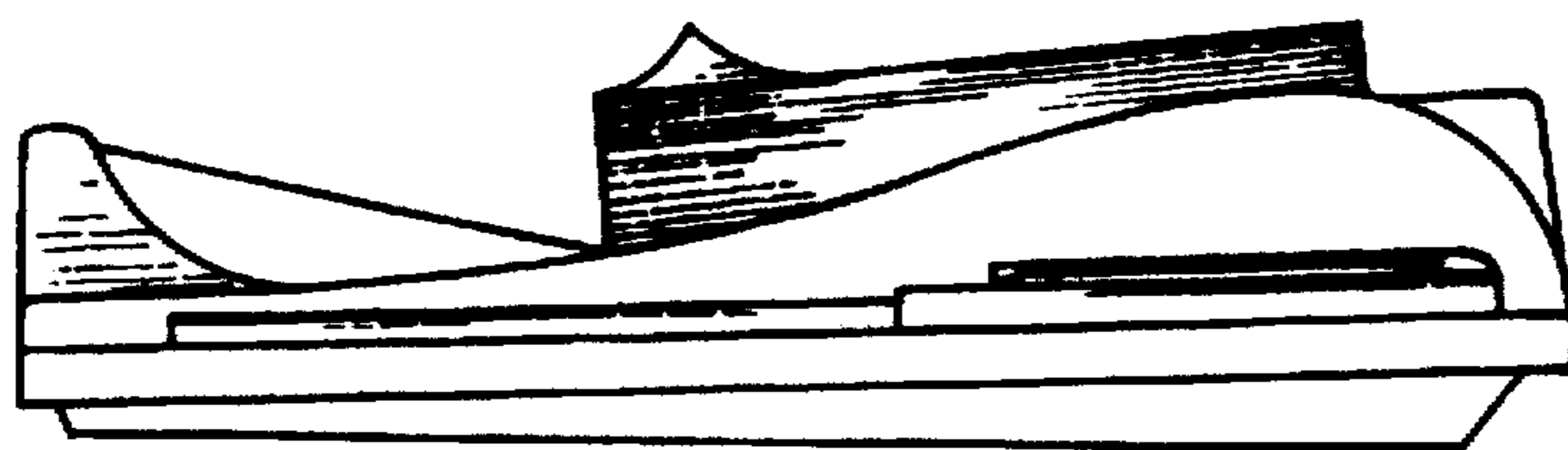

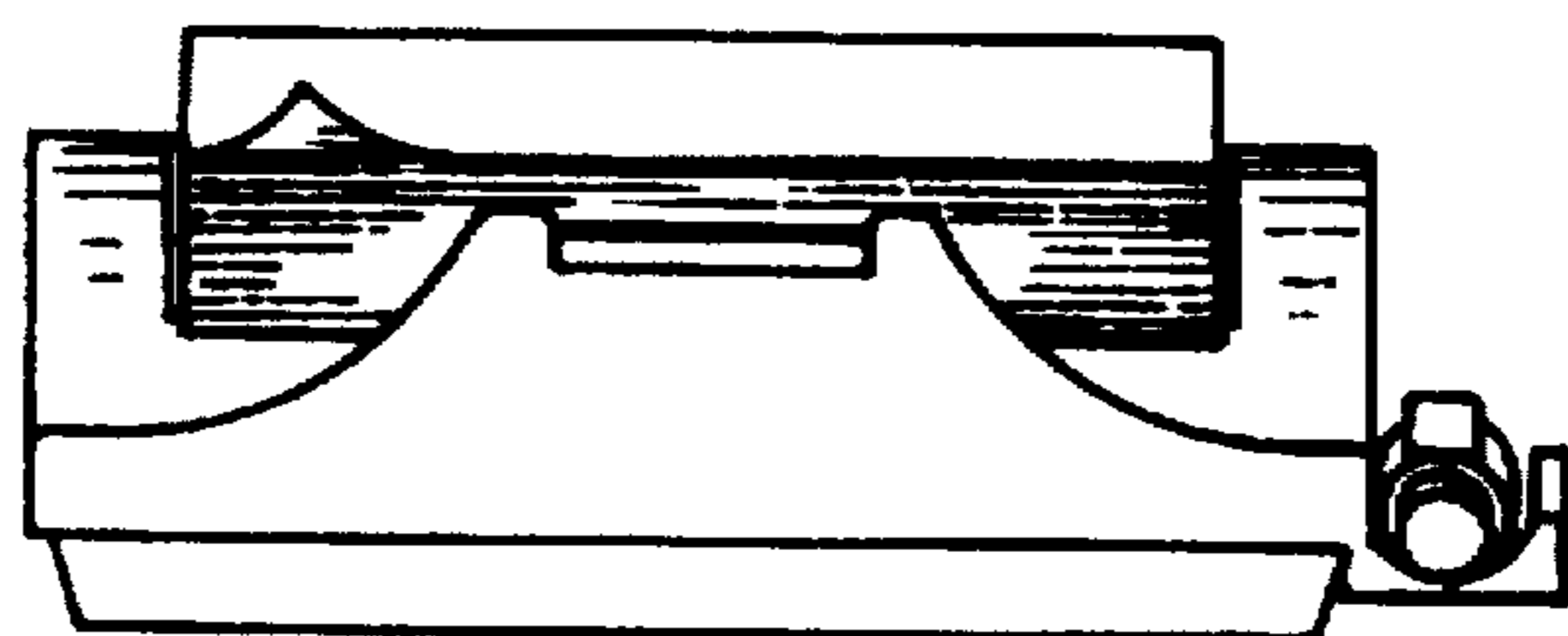

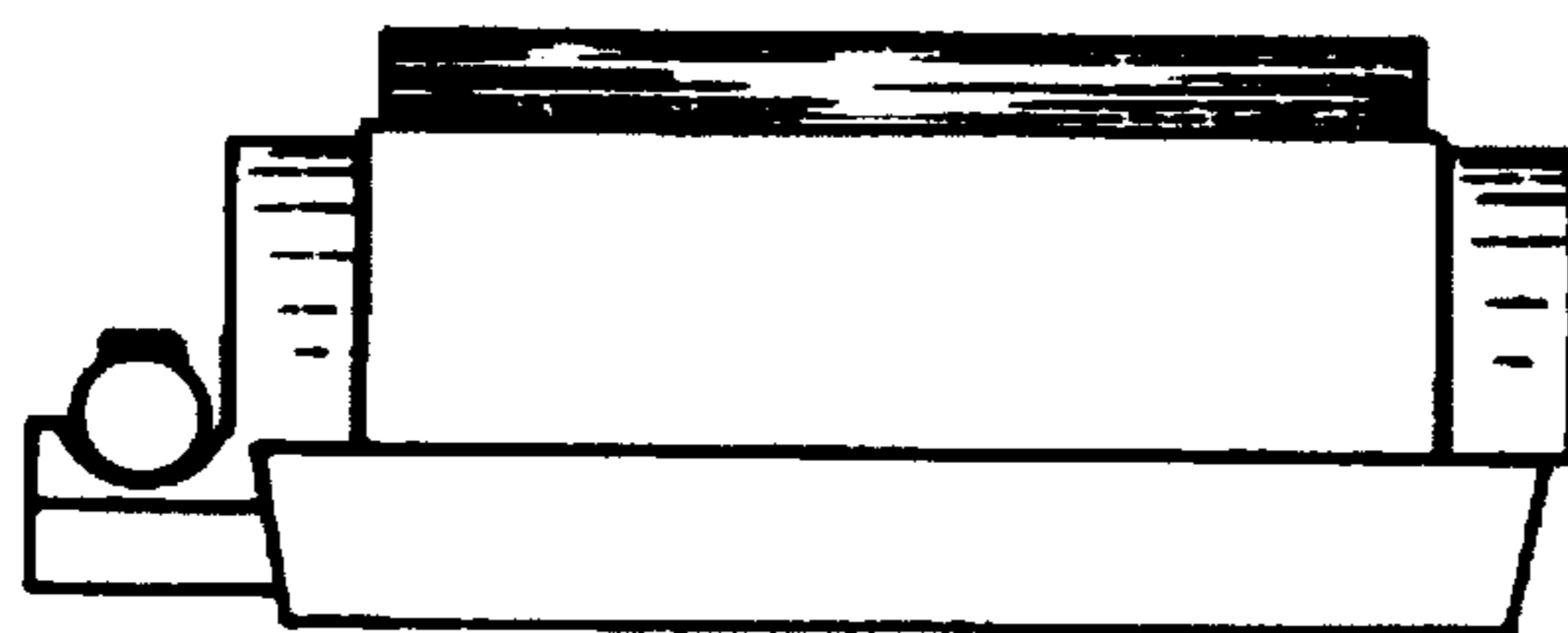

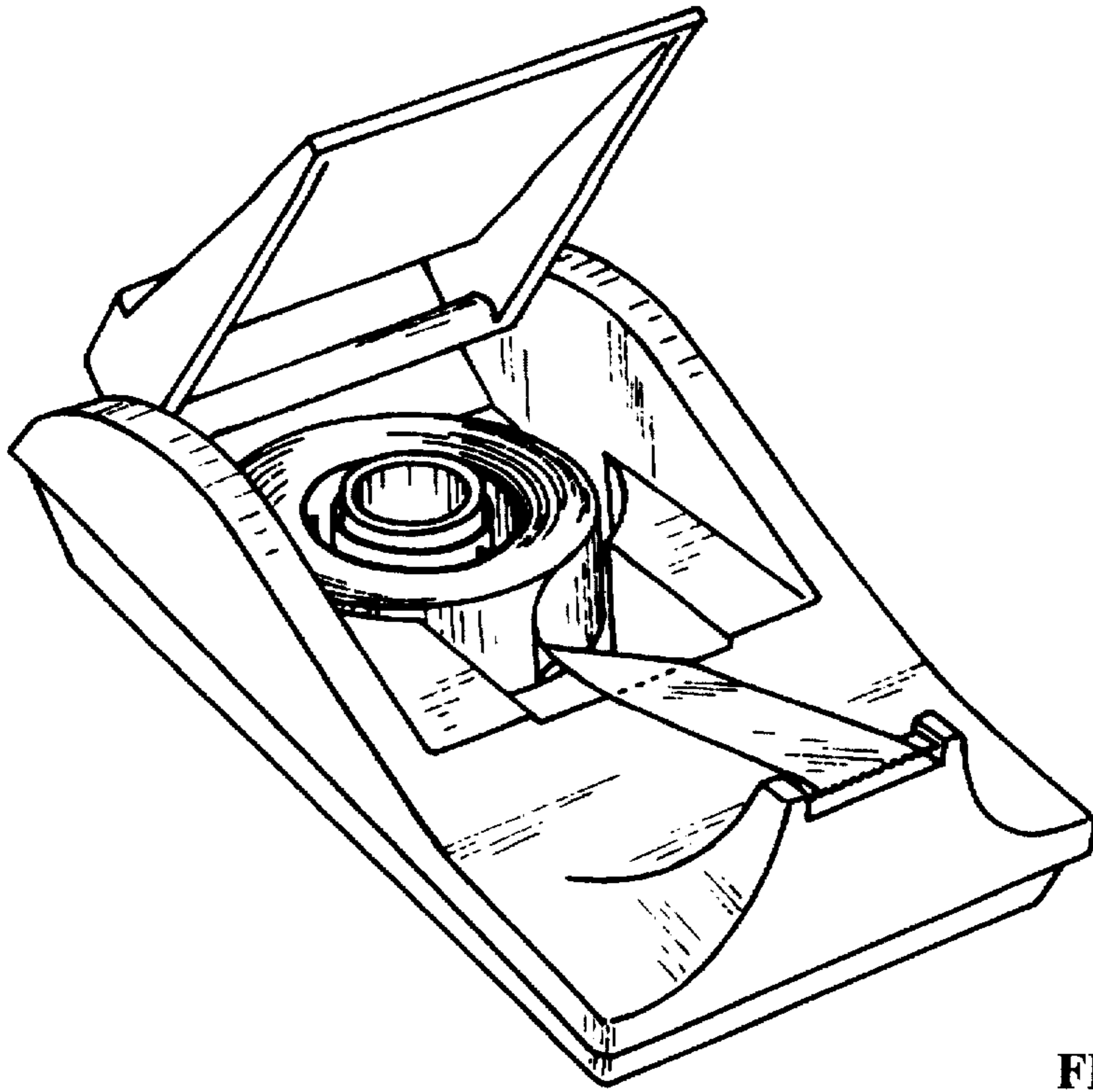

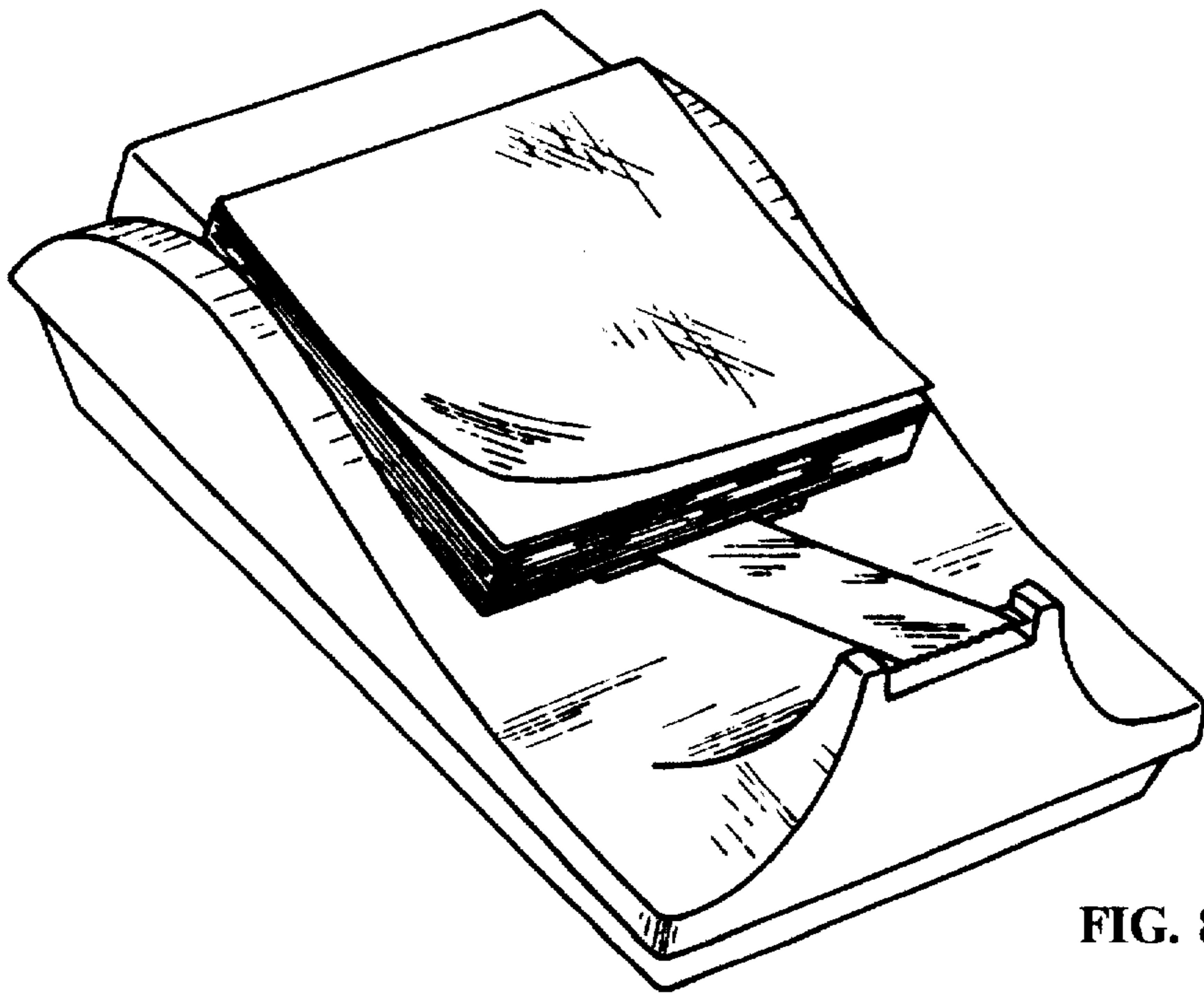

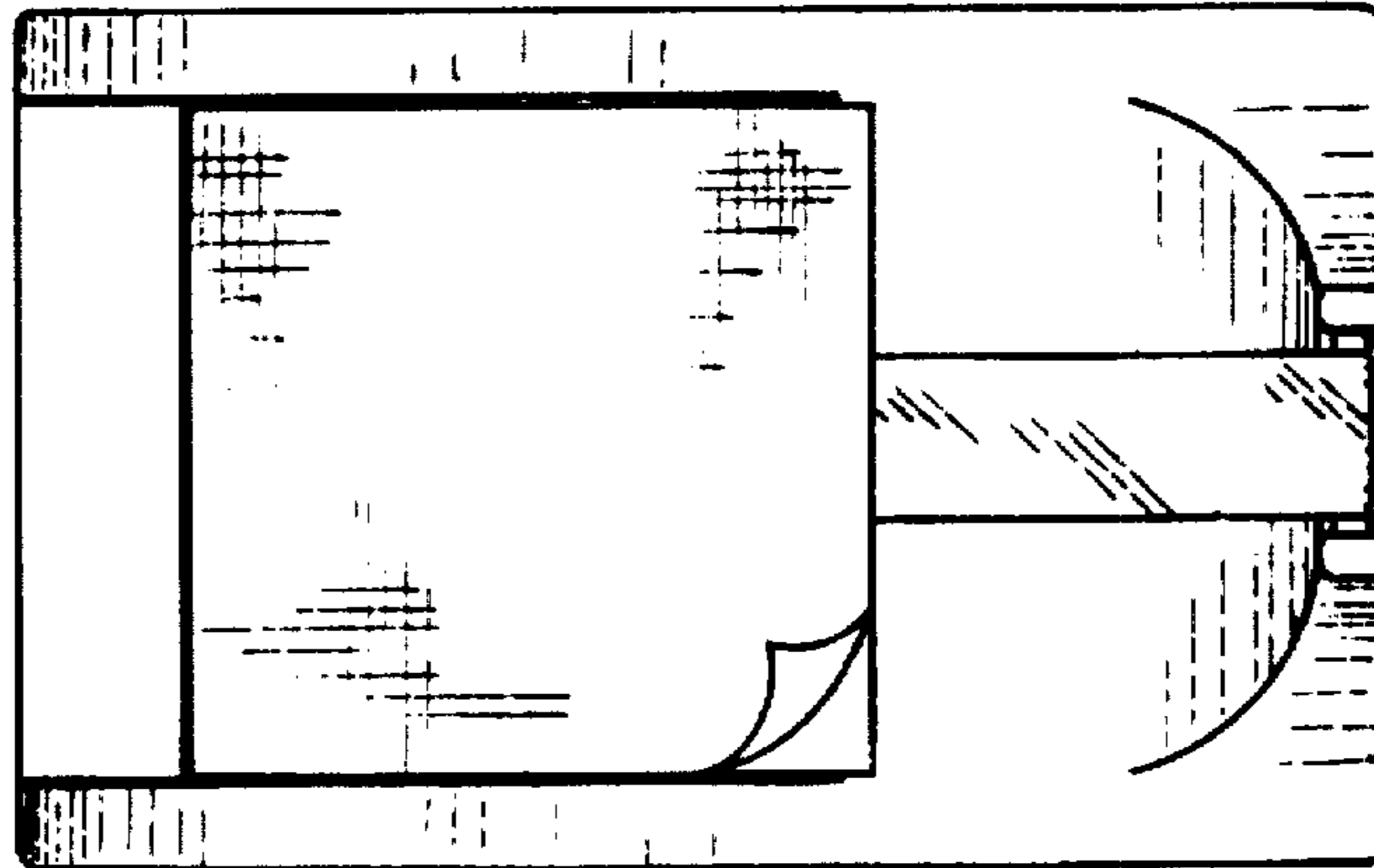

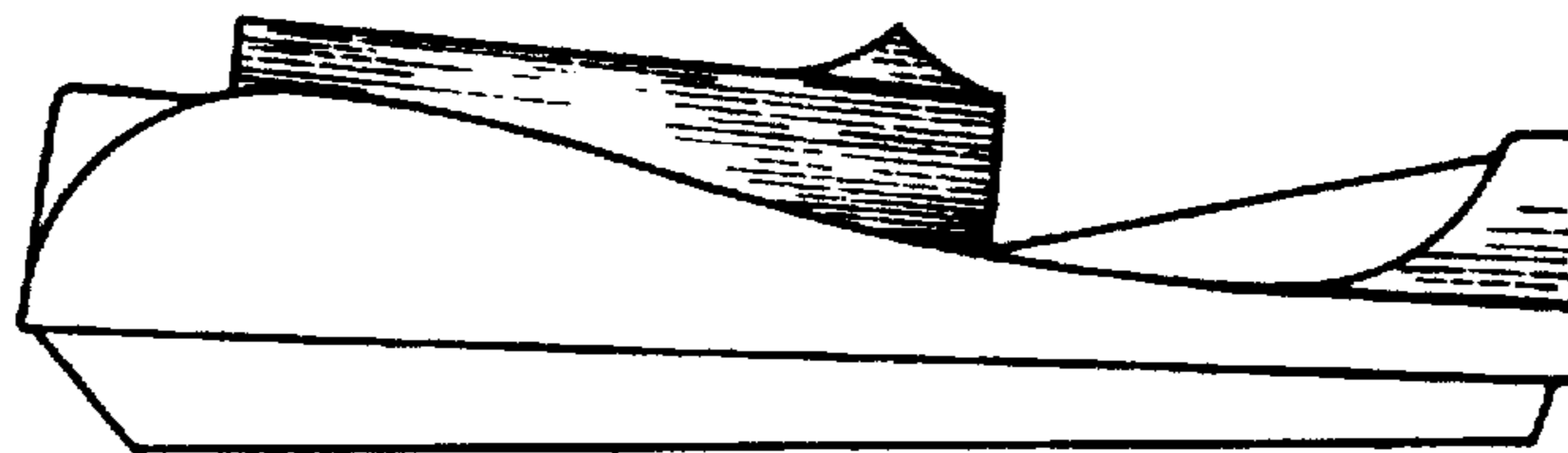

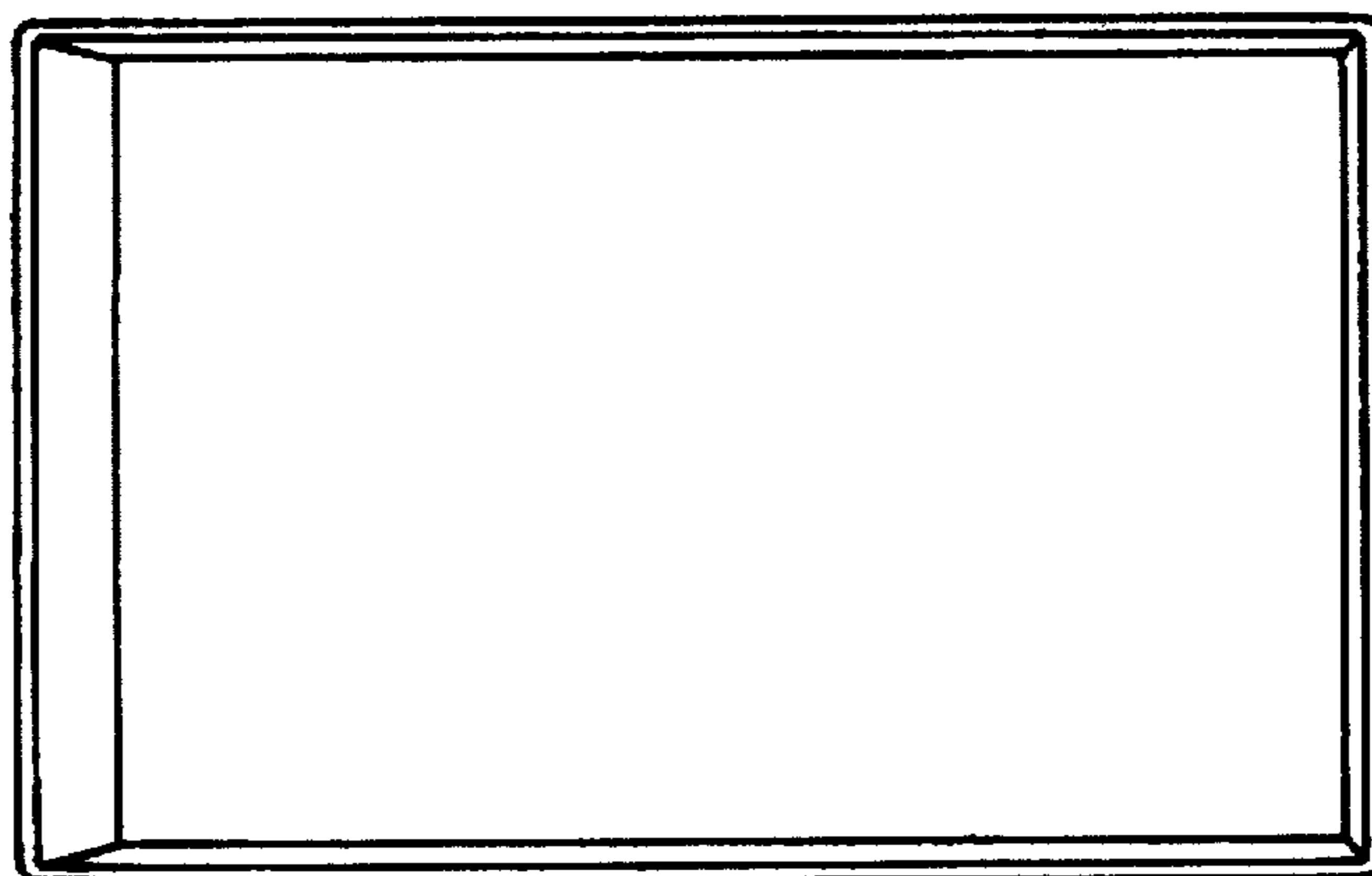

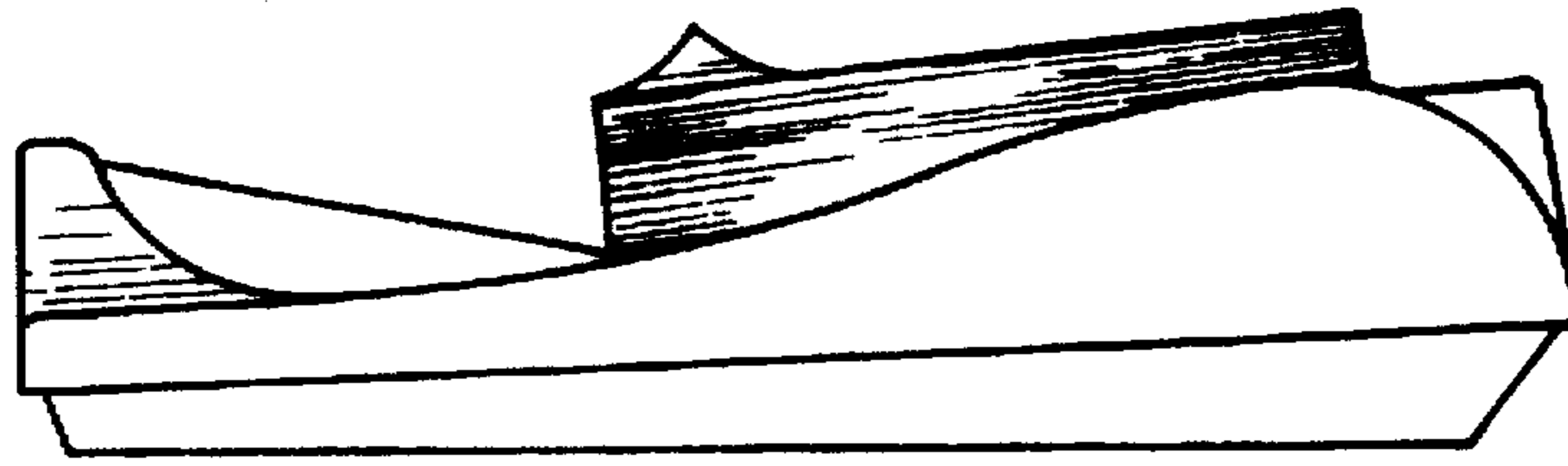

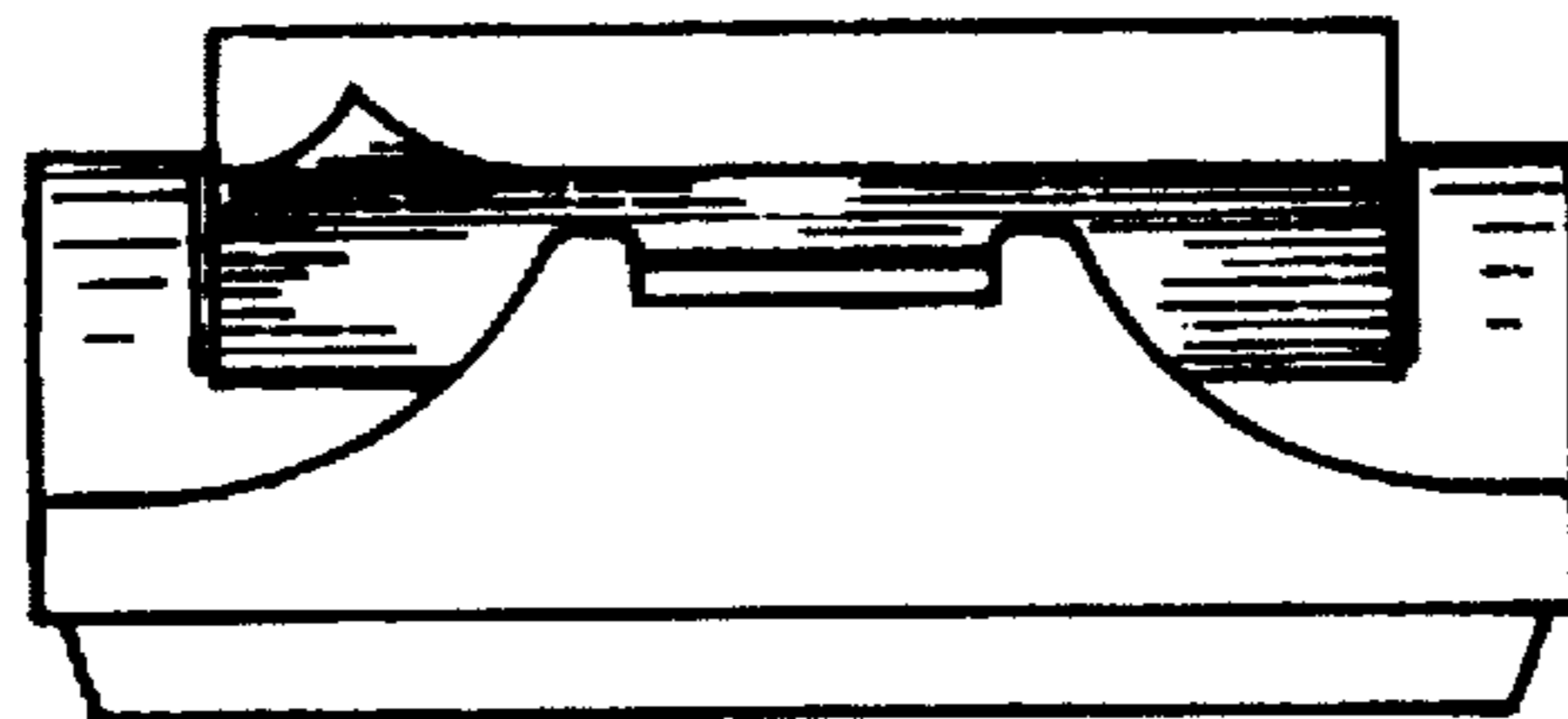

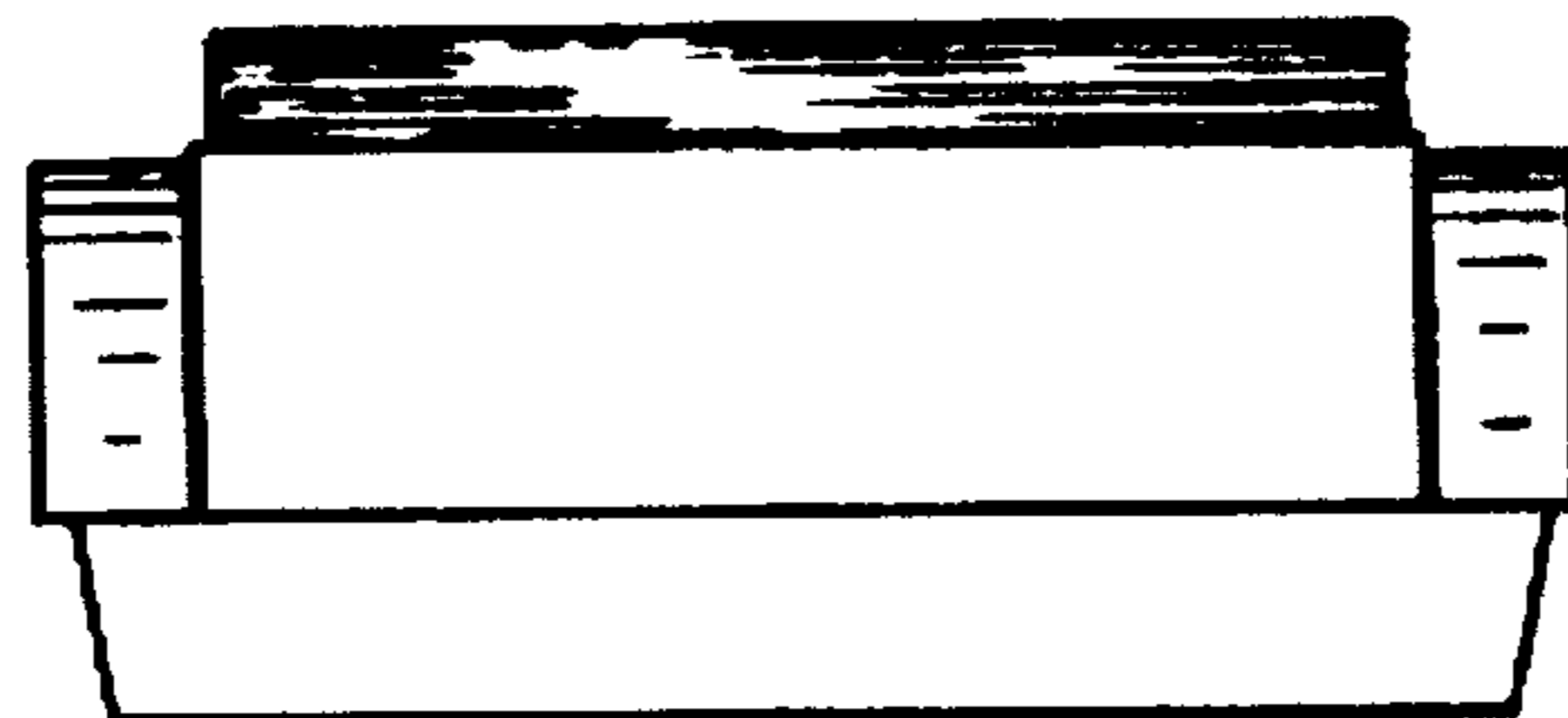
