FIG. 6 is a front elevational view of the hand held electronic game of FIG. 1; and,

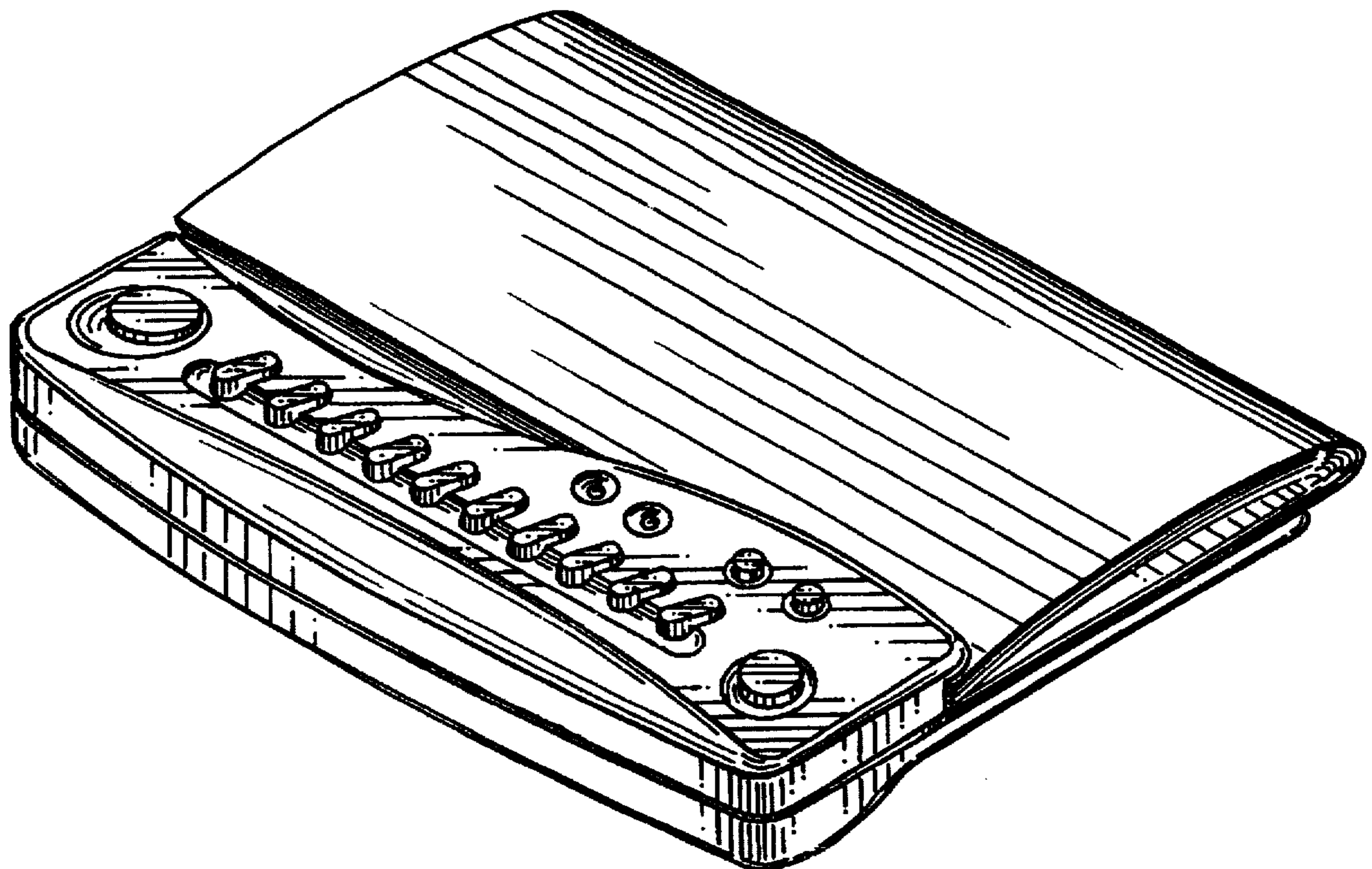
FIG. 7 is a right side elevational view of the hand held electronic game of FIG. 1.

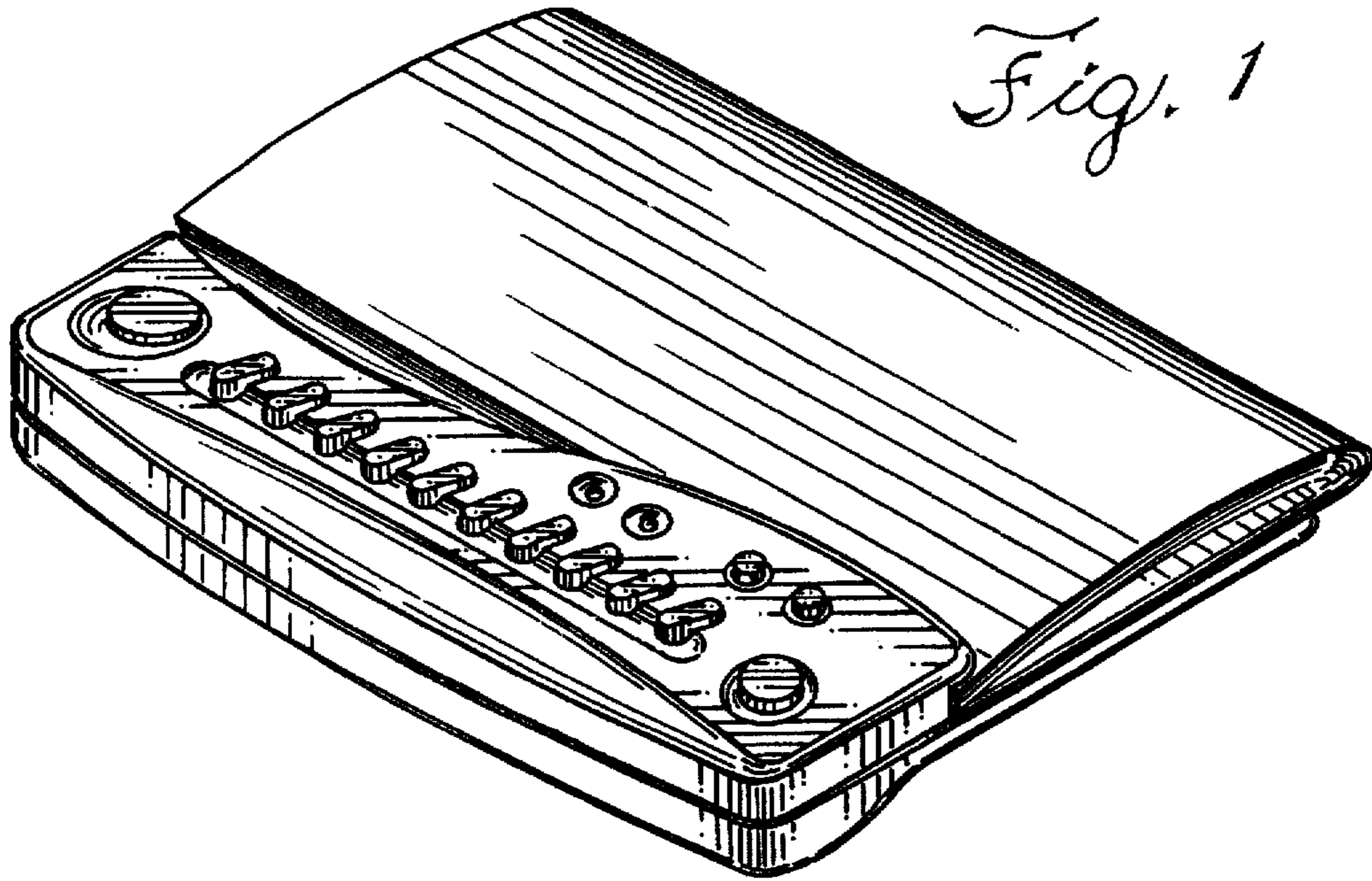

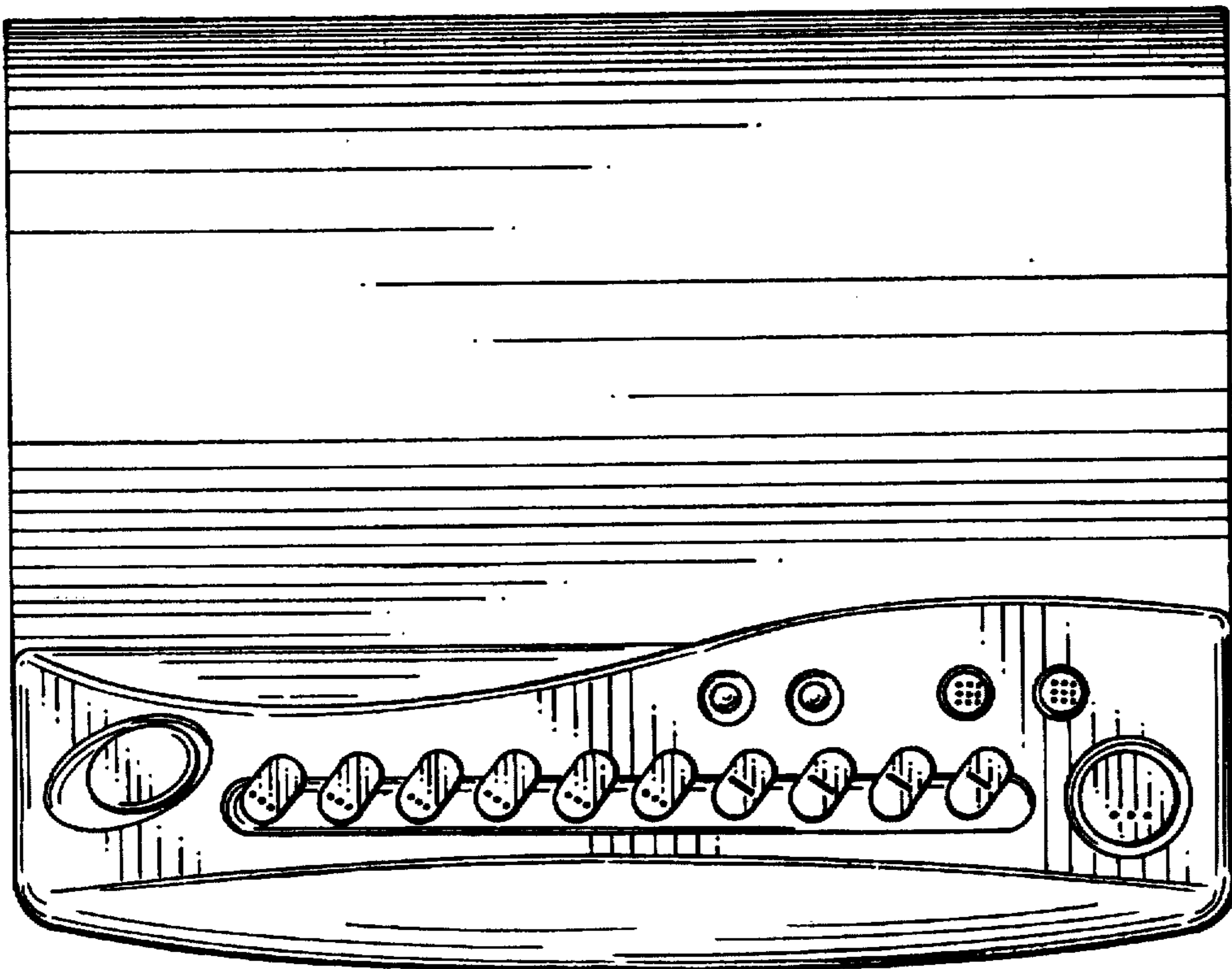

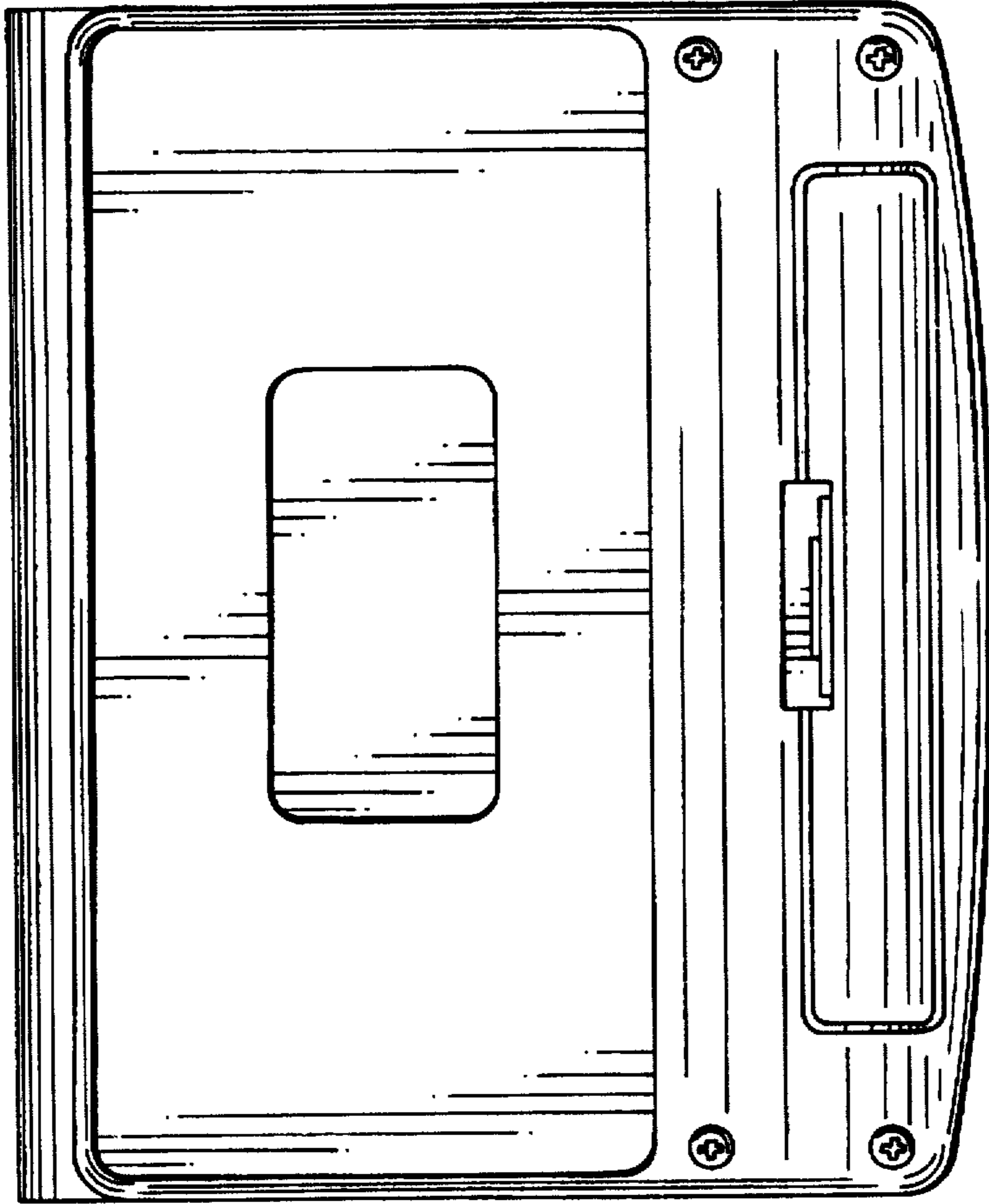

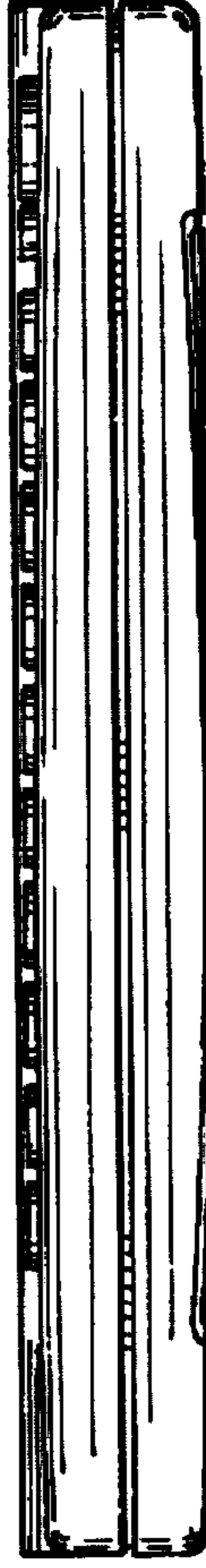
