[57] **CLAIM**

The ornamental design for a iron-type golf club head, as shown and descibed.

DESCRIPTION

FIG. 1 is a front elevation view of a iron type golf club head embodying the new design;

FIG. 2 is a rear elevation view of the club head of FIG. 1; FIG. 3 is a toe end elevation view of the club head of FIG. 1;

FIG. 4 is a heel end elevation view of the club head of FIG. 1;

FIG. 5 is a top view of the club head of FIG. 1;

FIG. 6 is a bottom view of the club head of FIG. 1;

FIG. 7 is a frontal perspective view of the FIG. 1 club head; and,

FIG. 8 is a rear perspective view of the FIG. 1 club head.

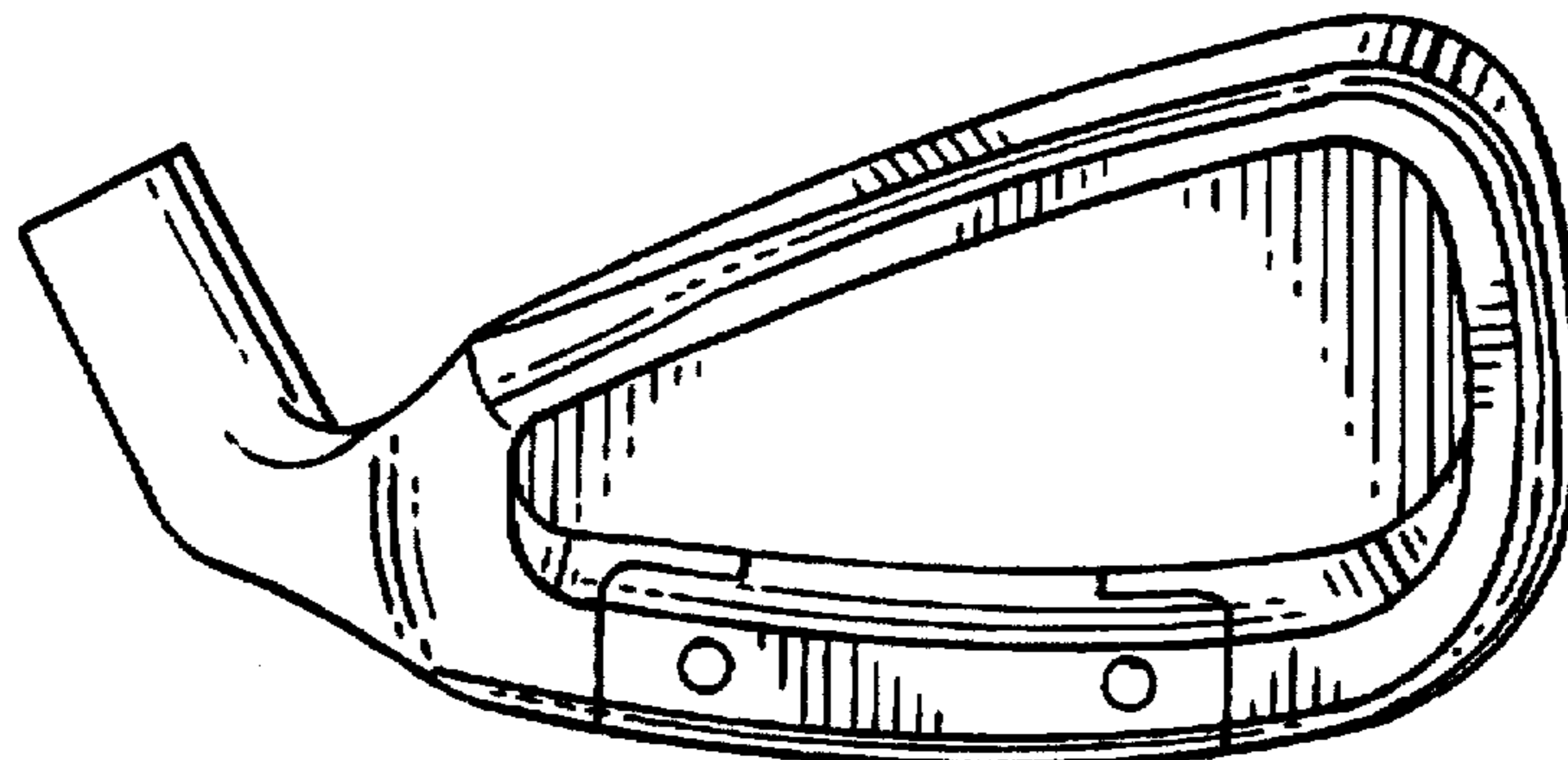
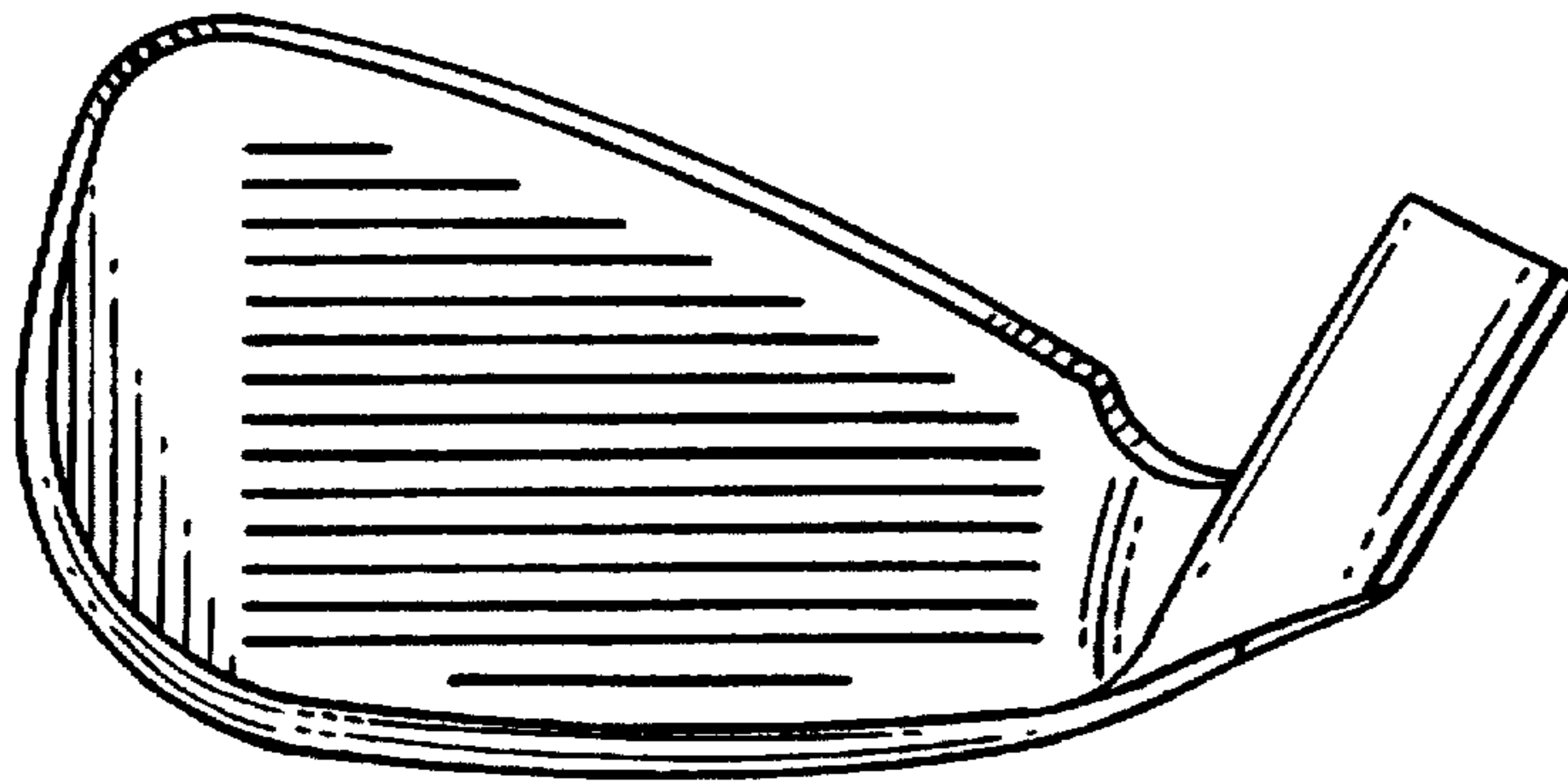

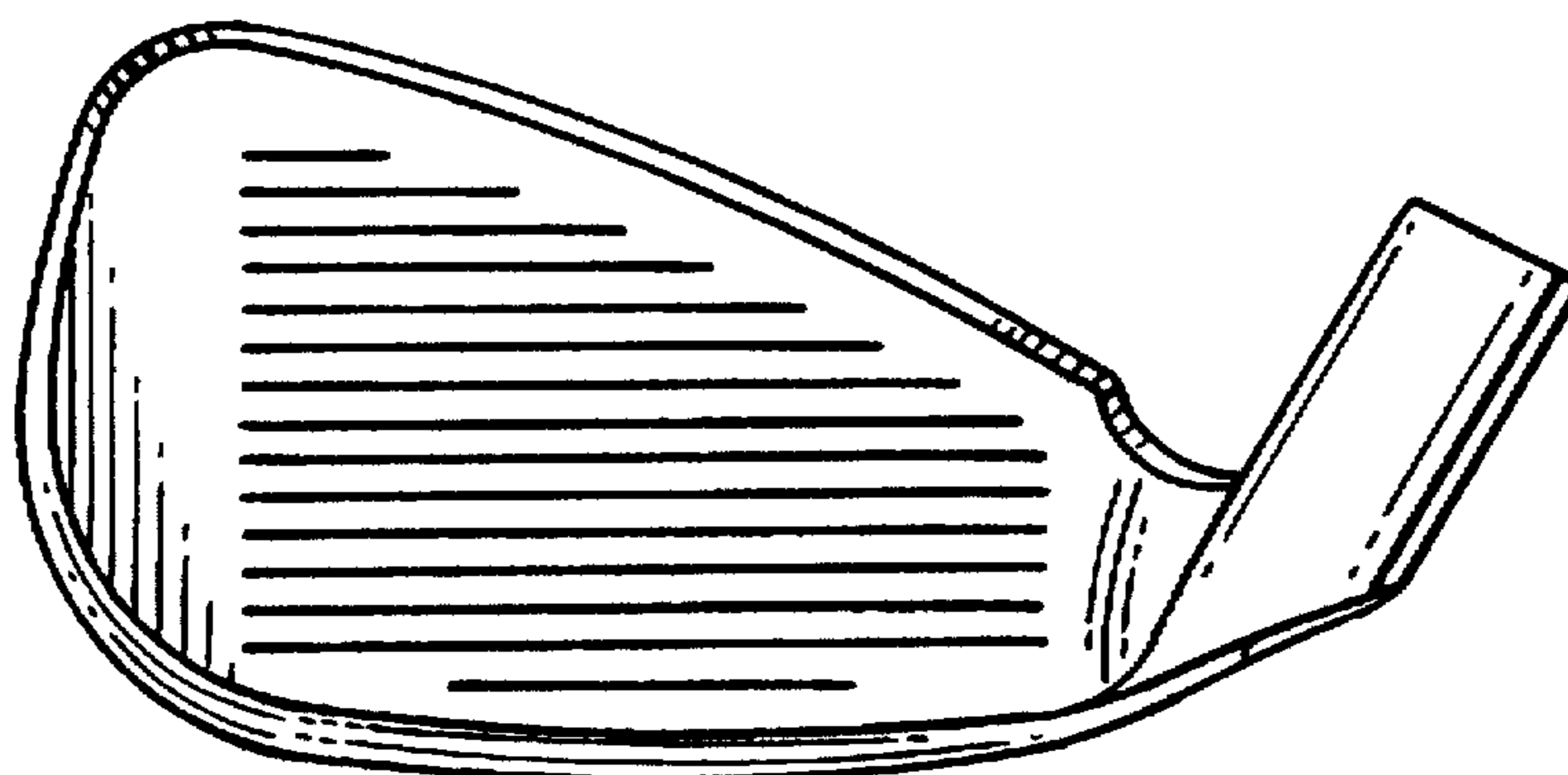

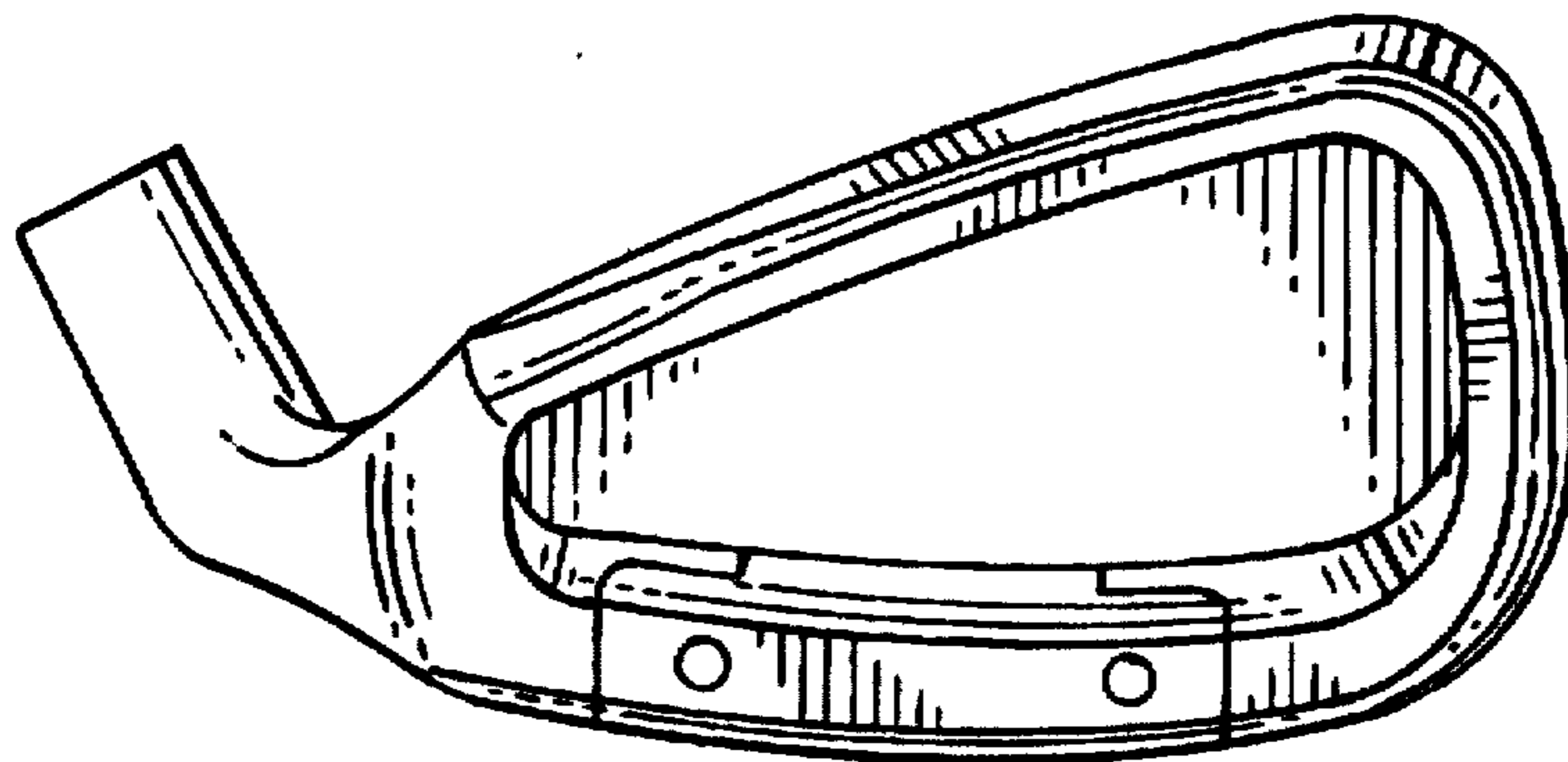

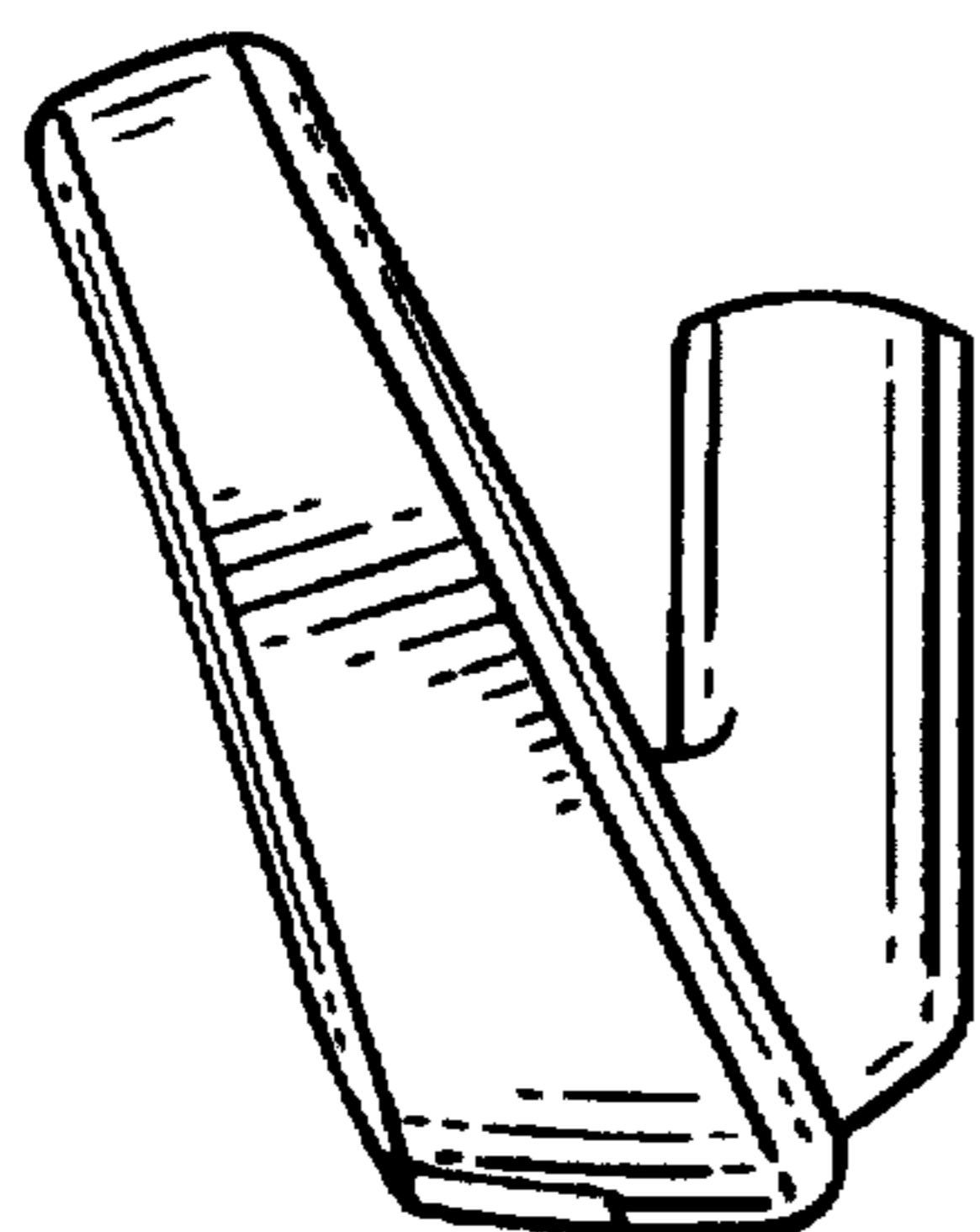

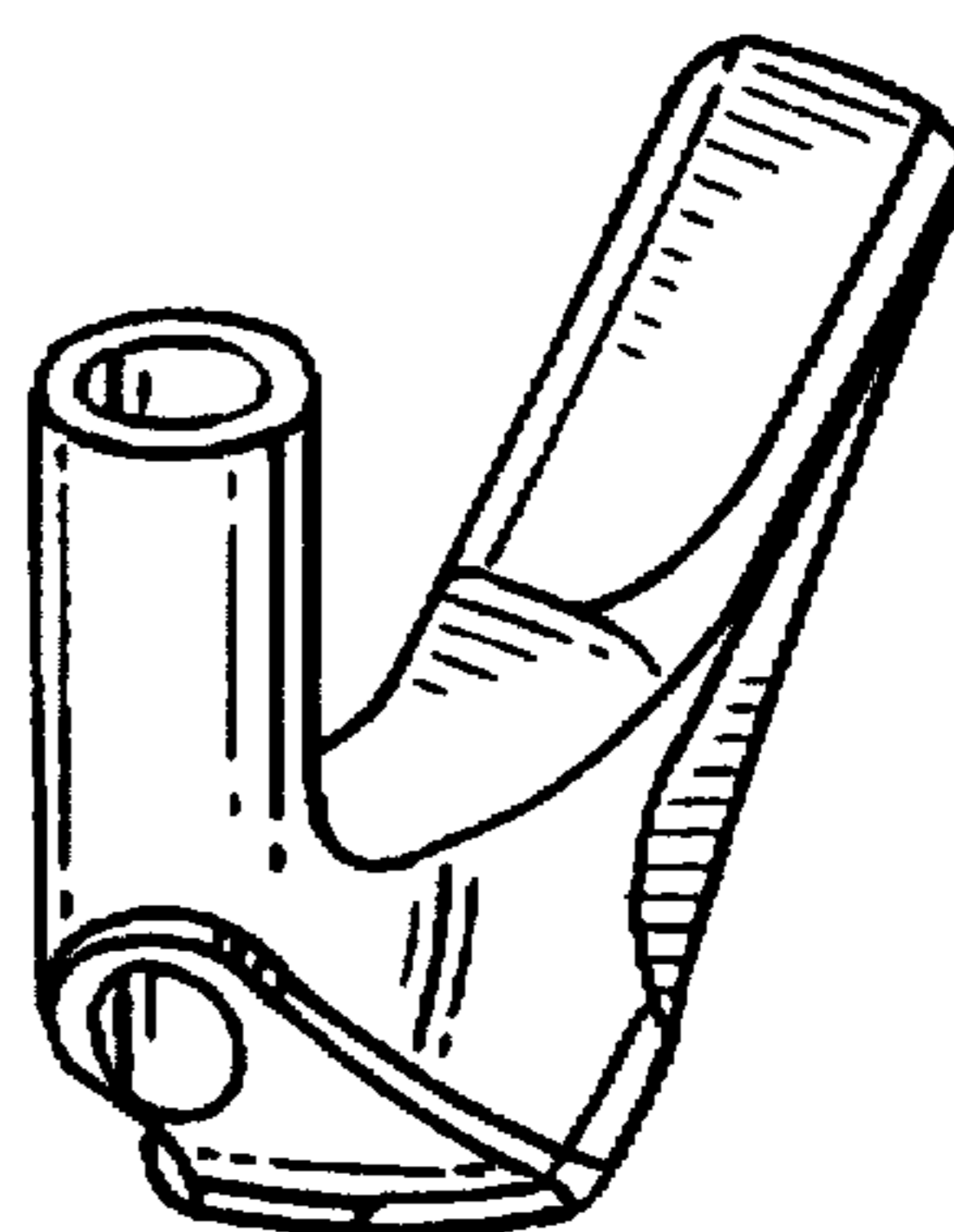

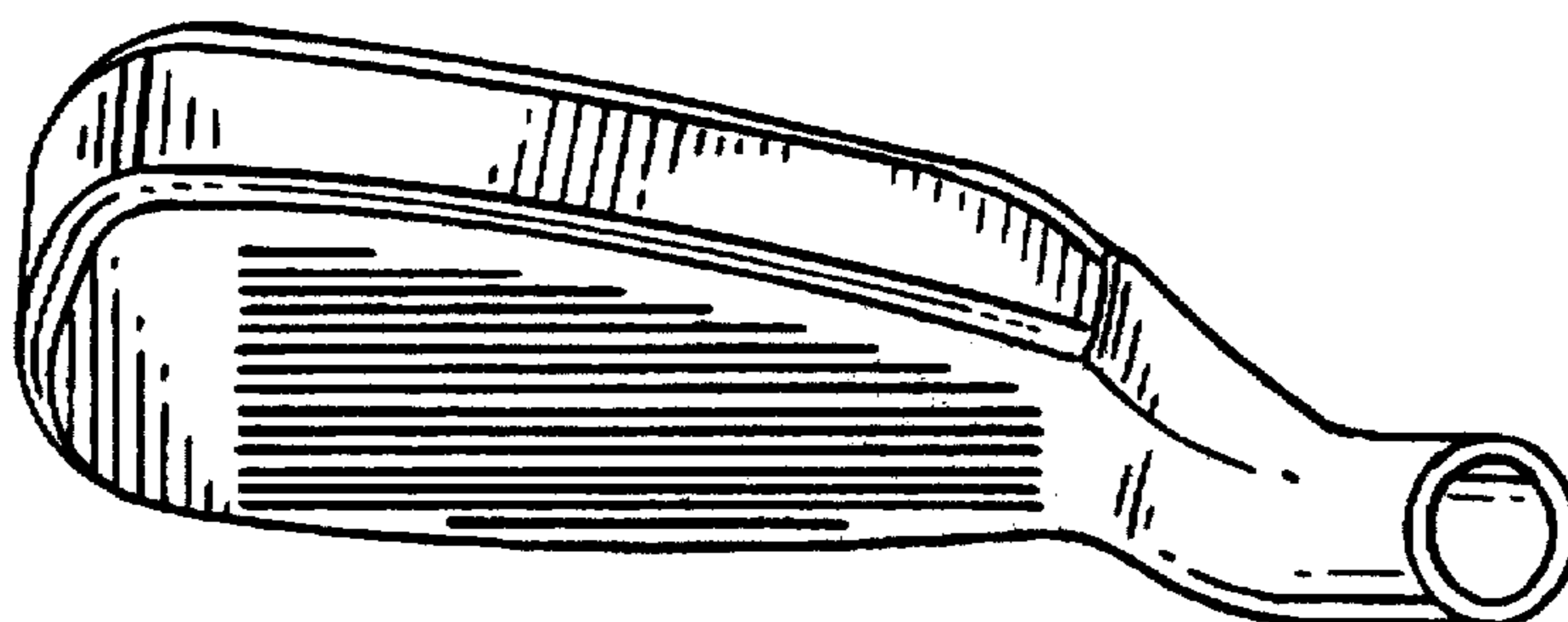

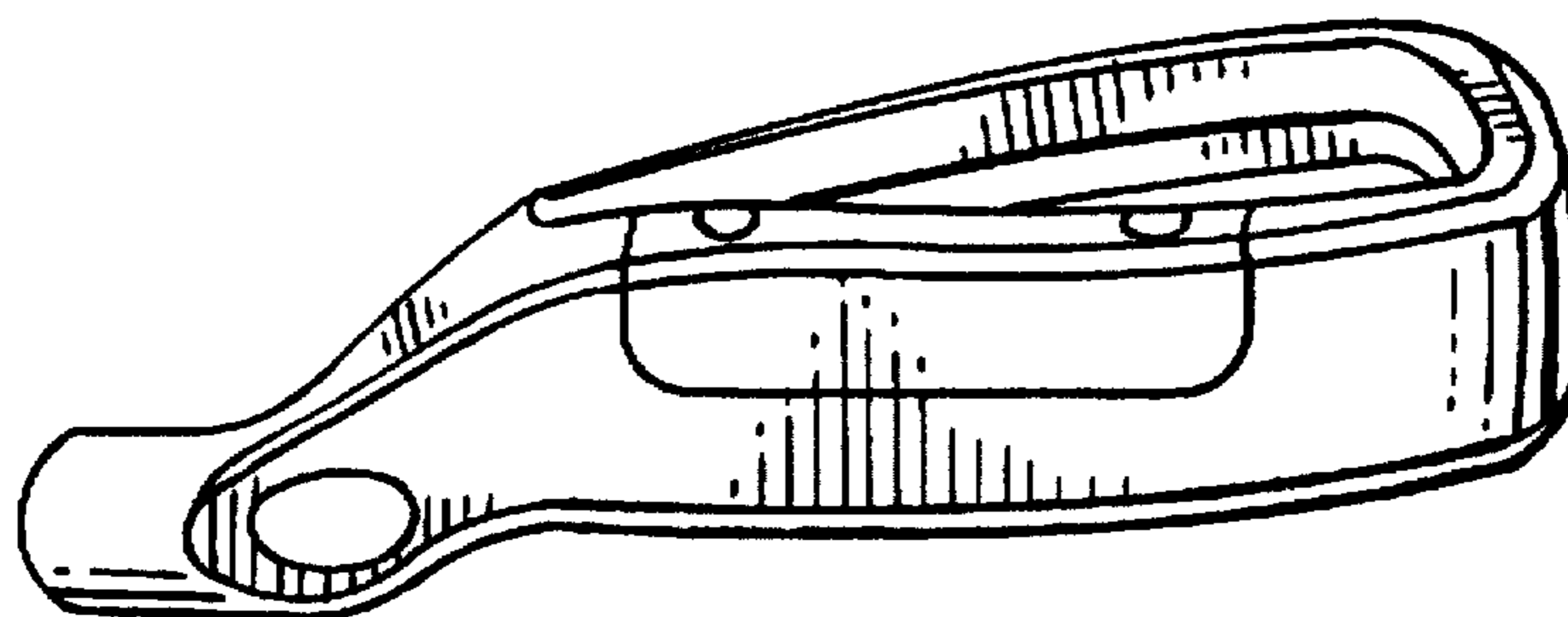

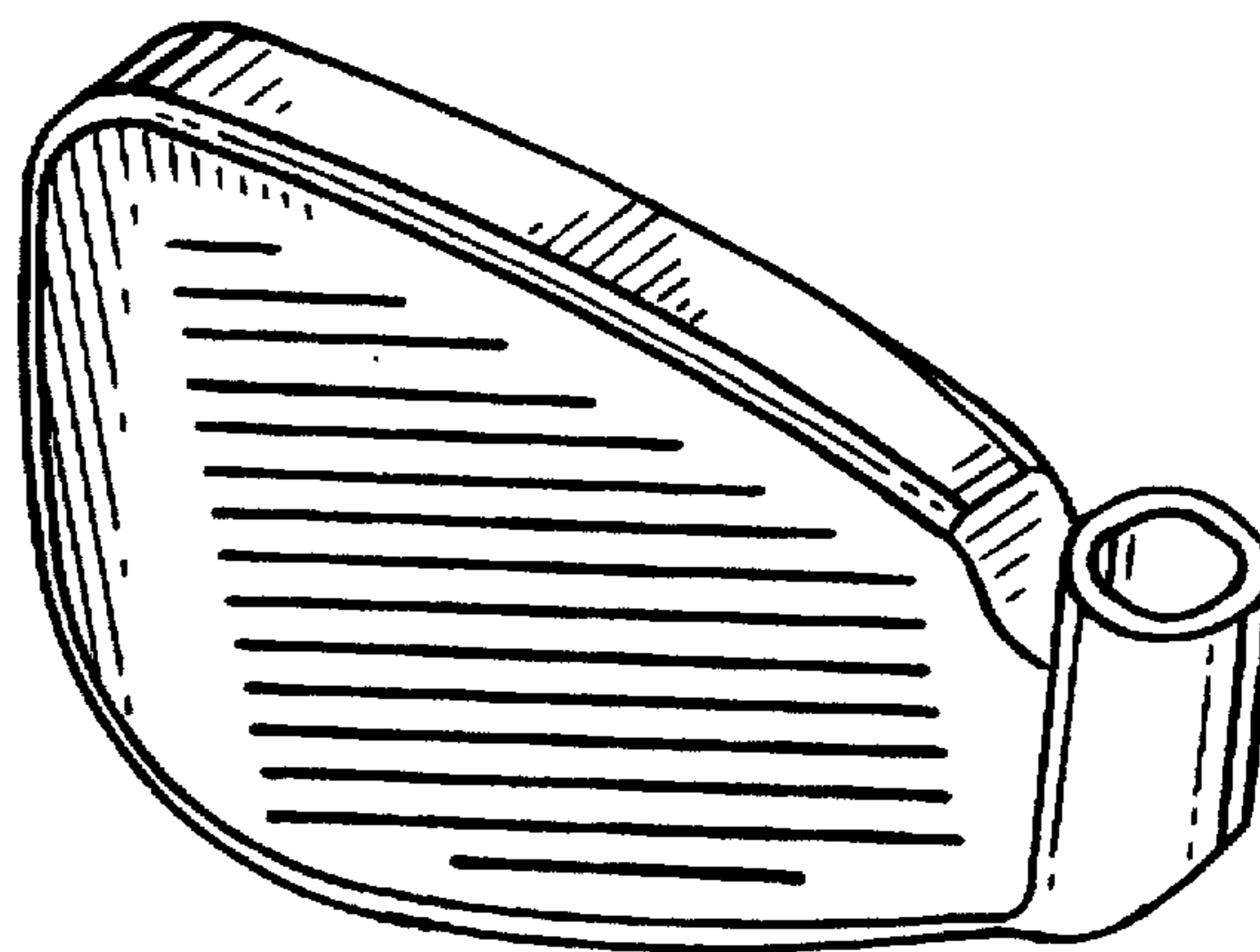
