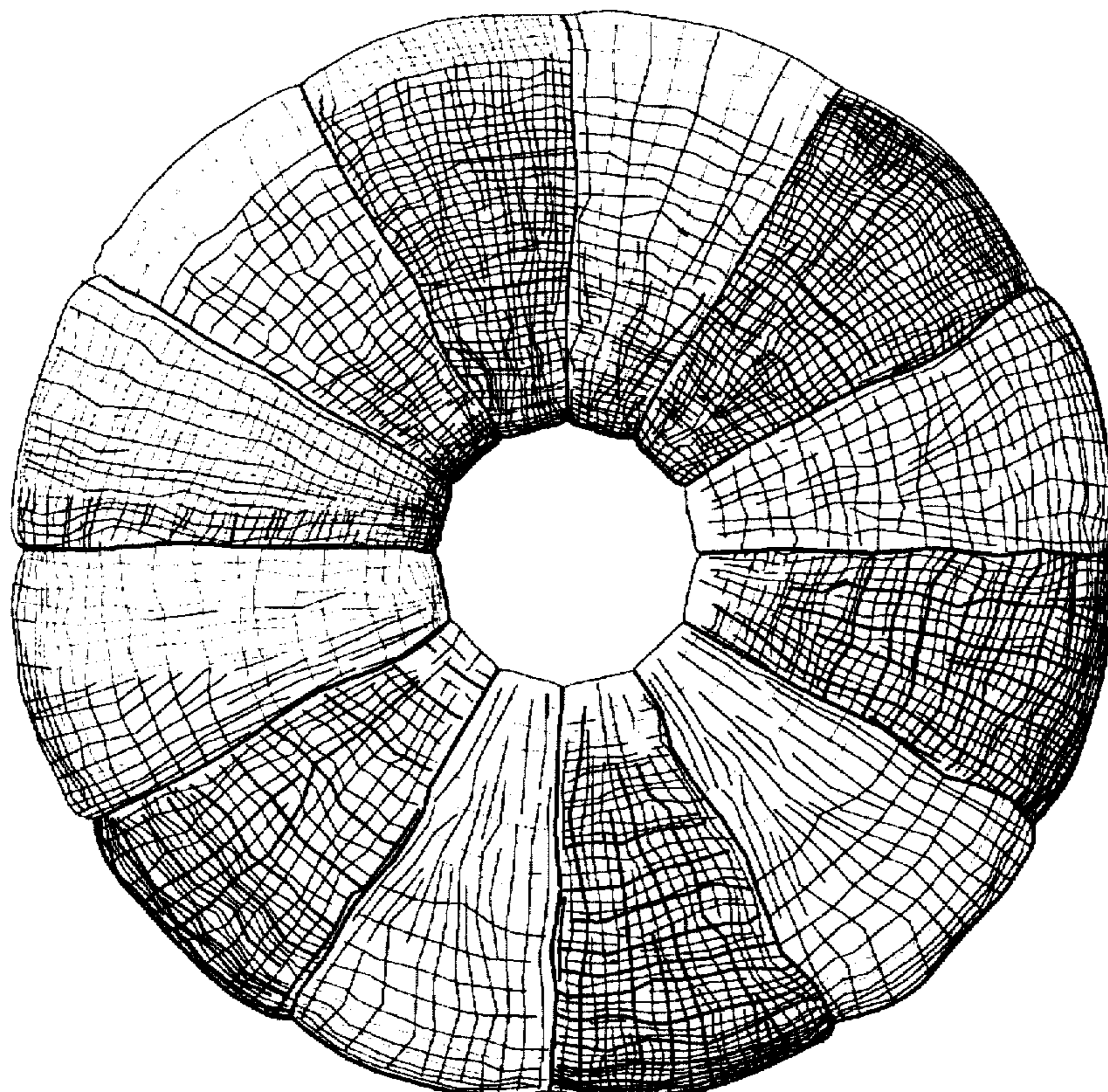
[57] CLAIM

The ornamental design for a stuffed fabric appliqué, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the stuffed fabric appliqué, the bottom plan view being identical thereto; and, FIG. 2 is a side elevational view the stuffed fabric appliqué and is to be understood that all side elevational views are substantially the same.

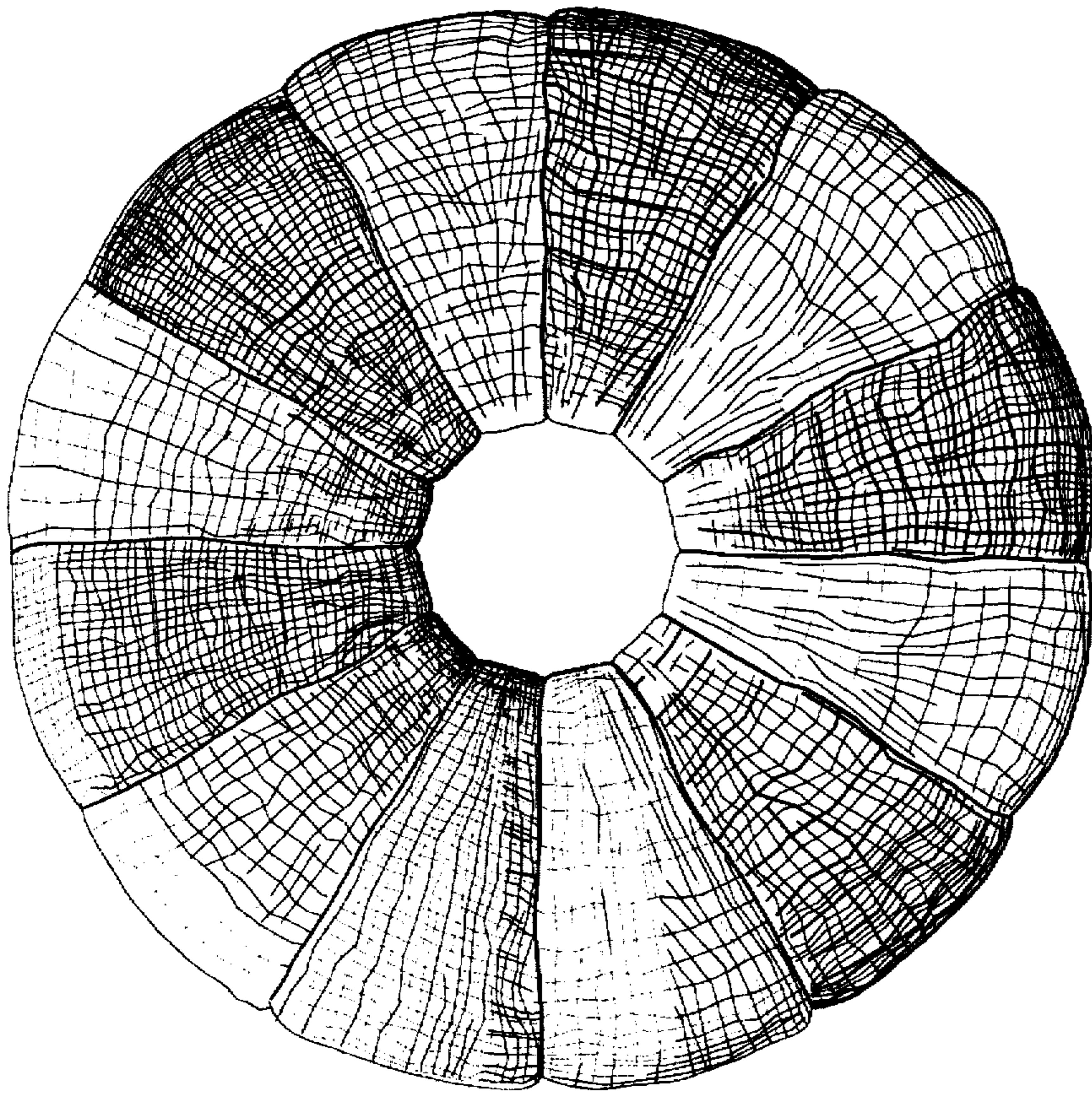

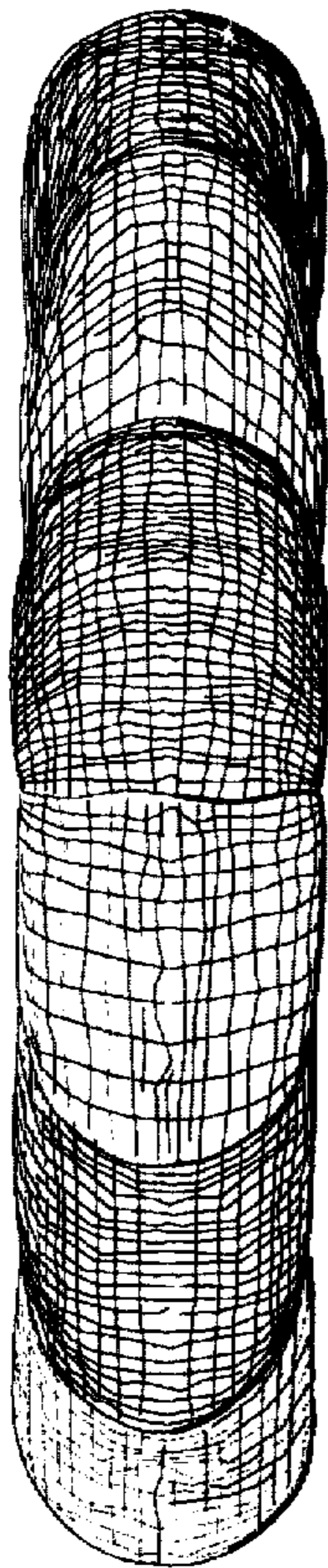
