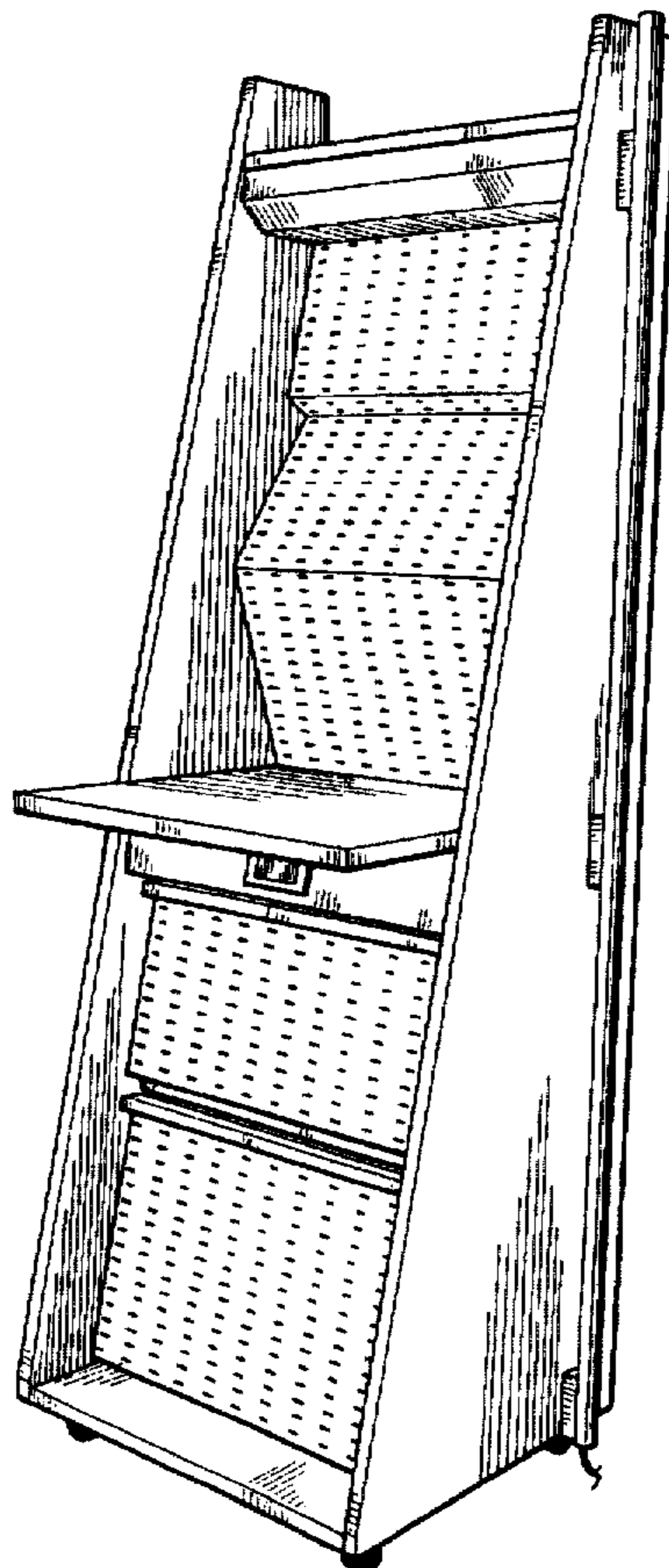
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a display stand embodying the new and ornamental design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side elevational view thereof;

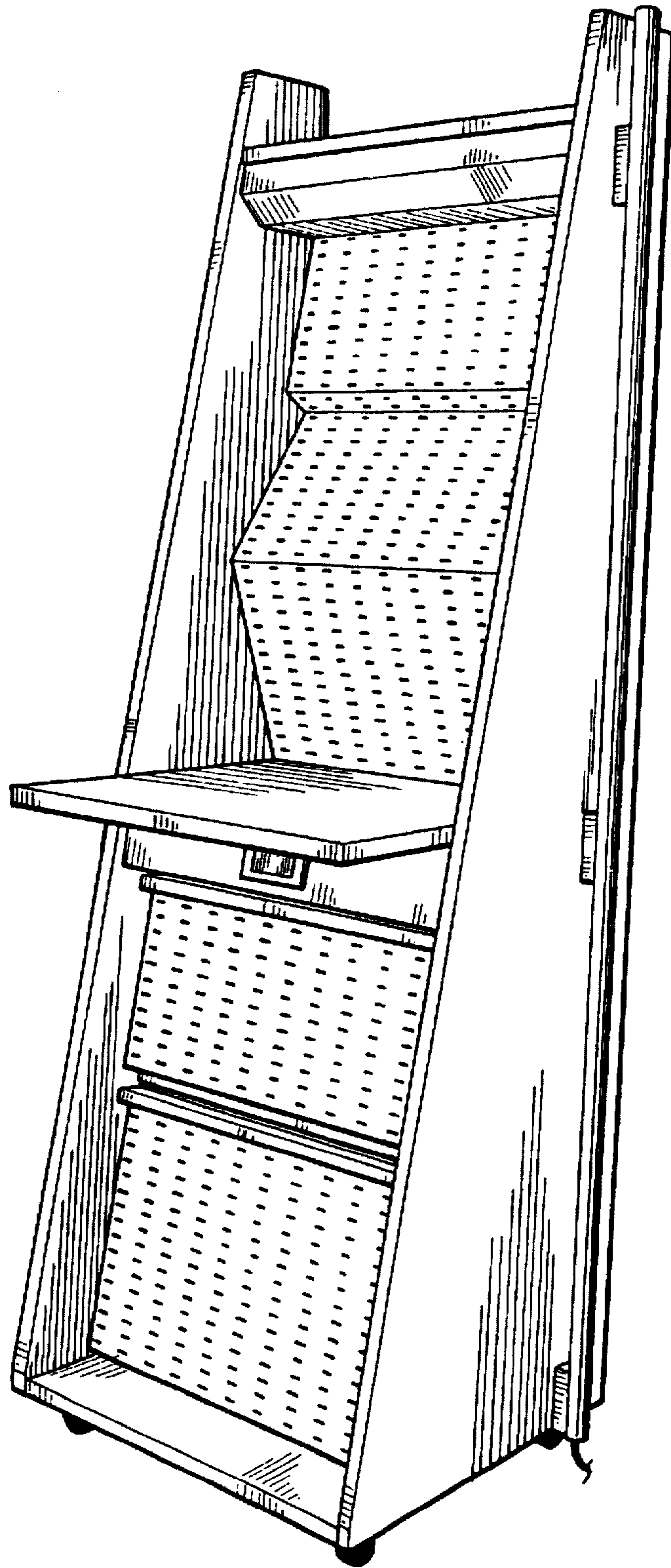

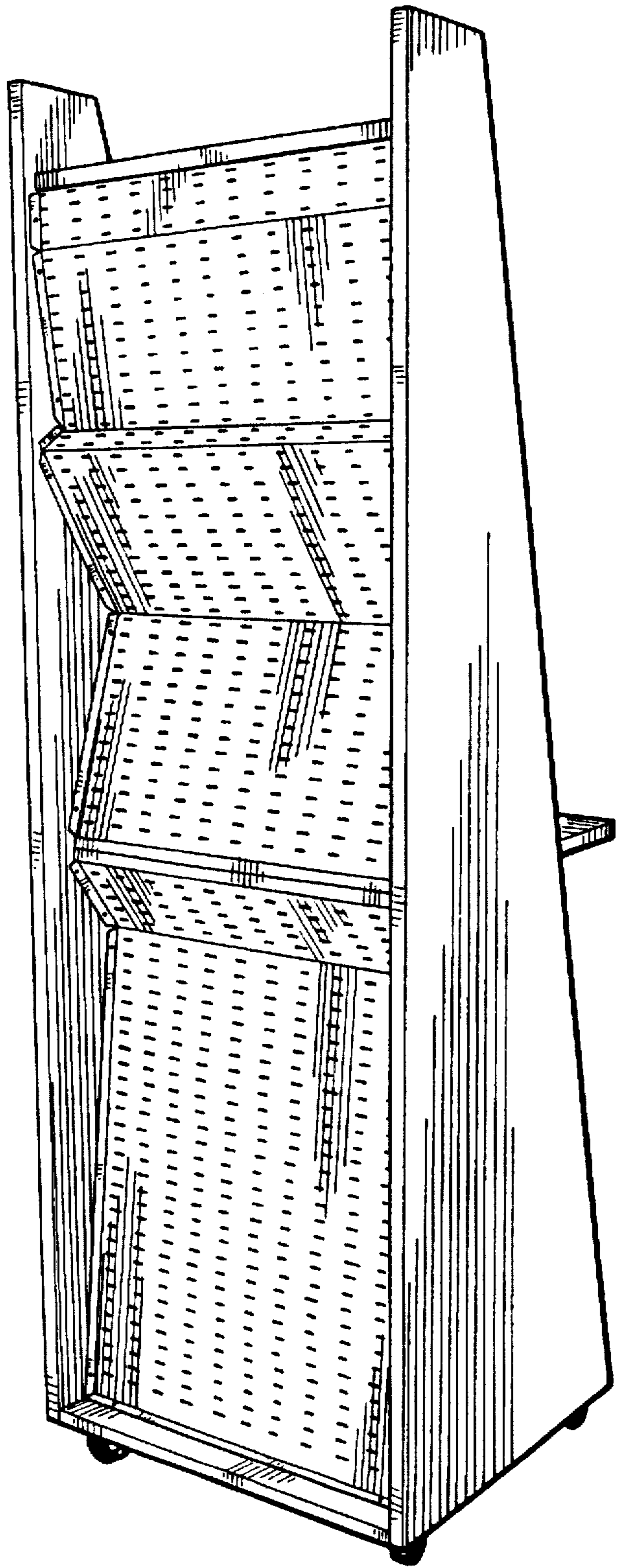

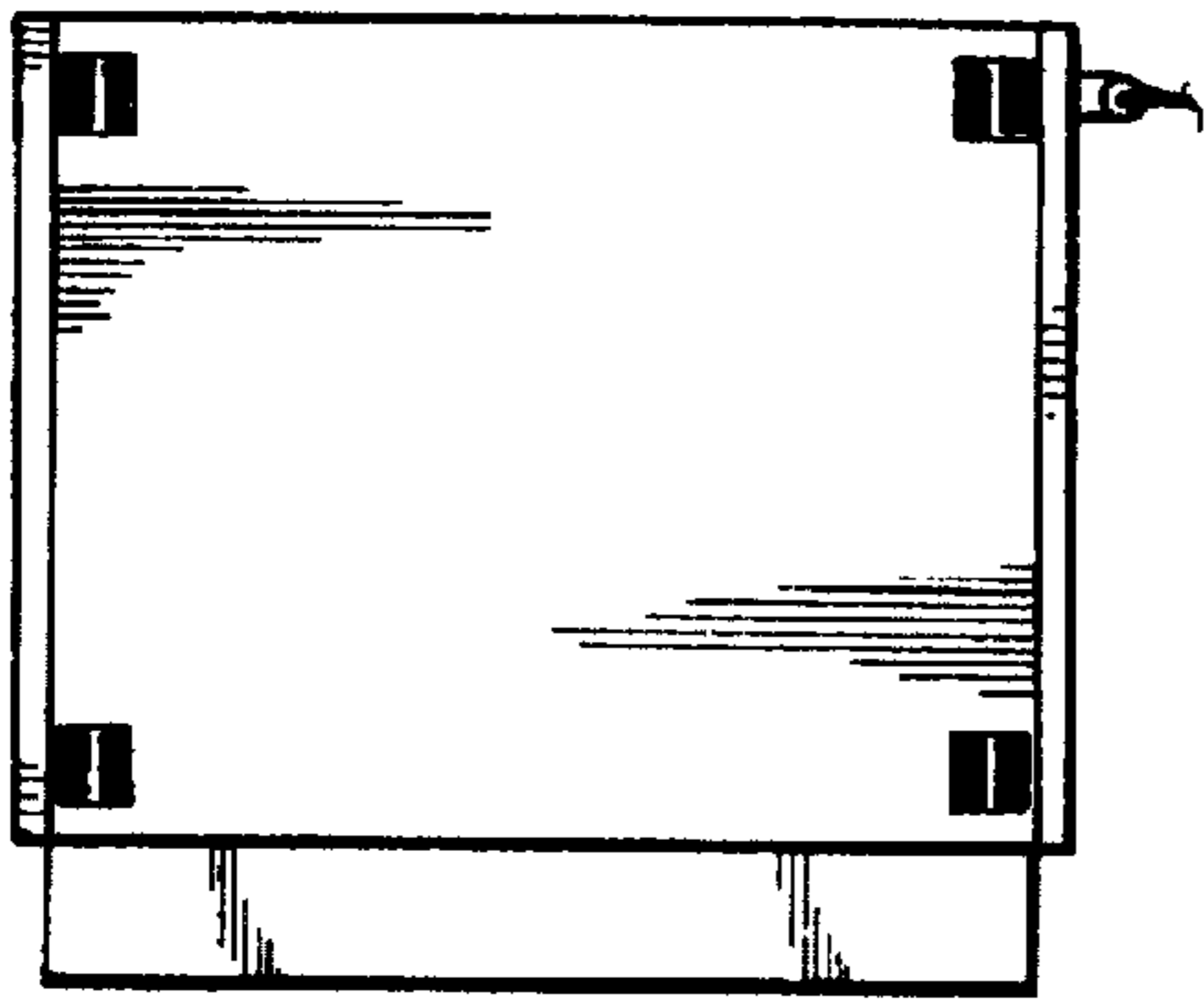

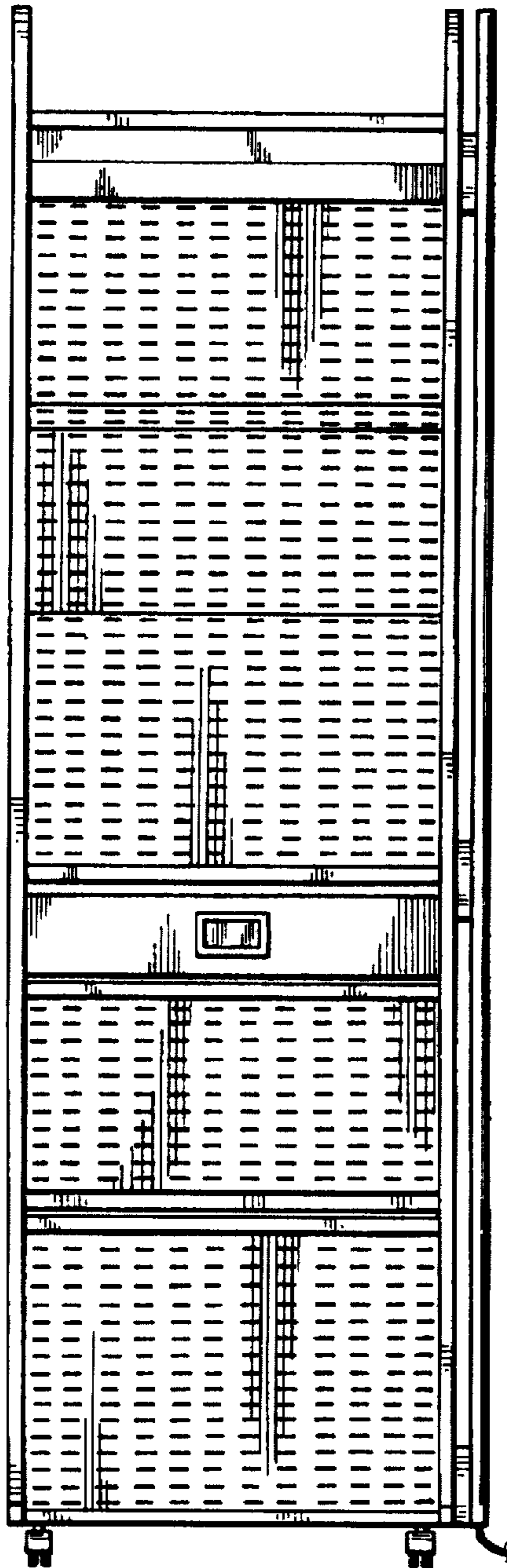

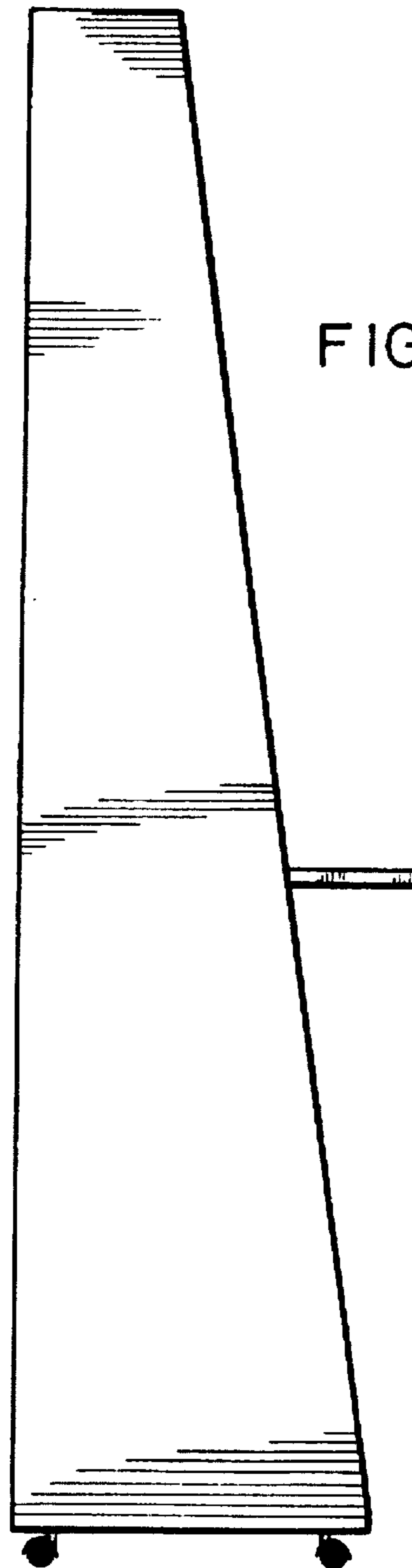

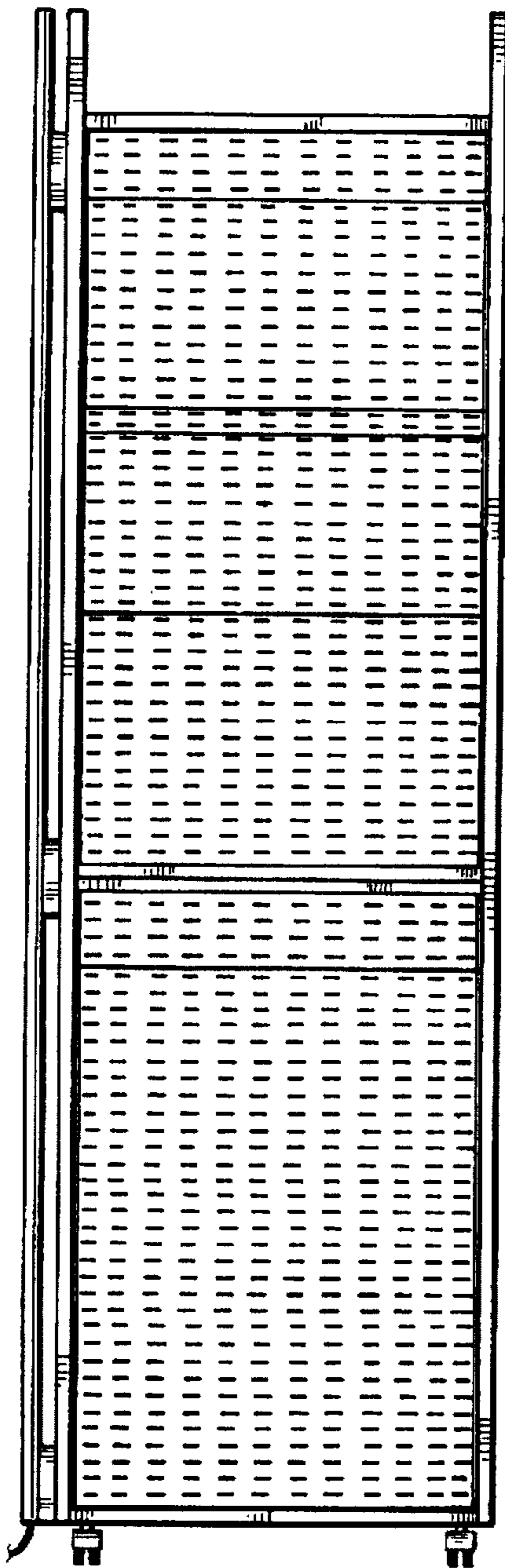

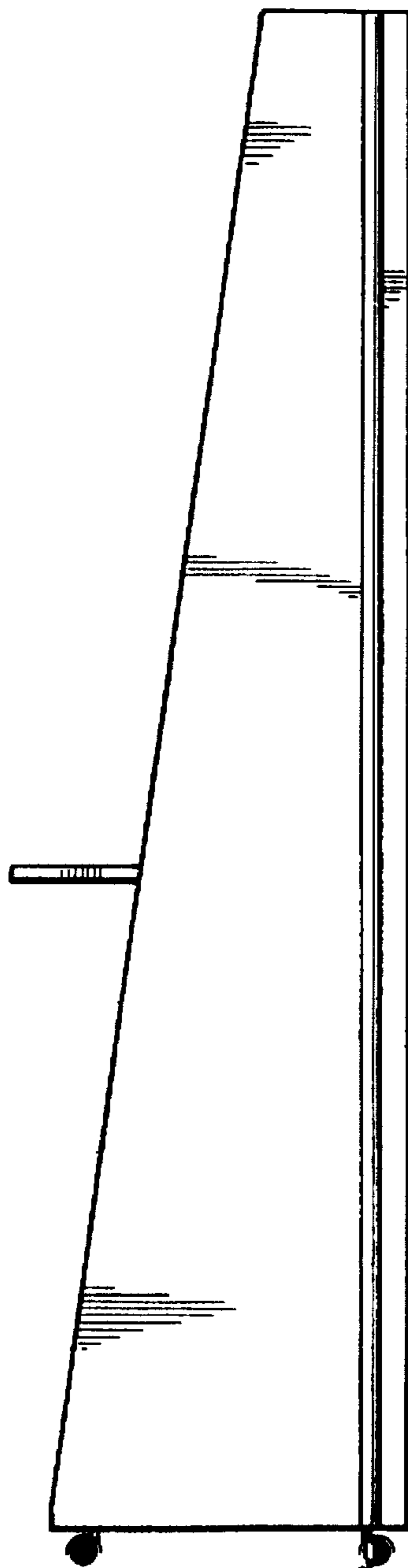

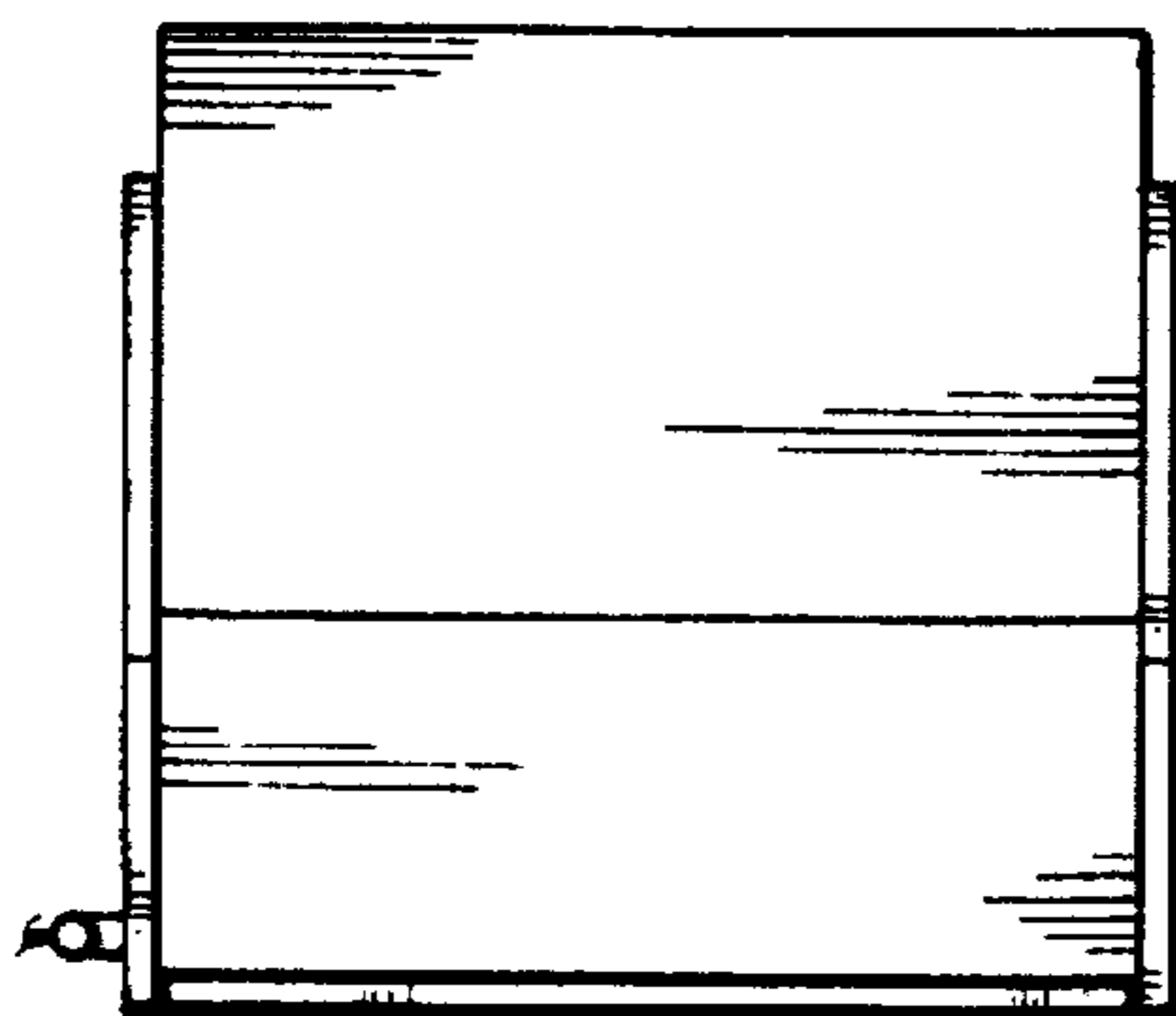
