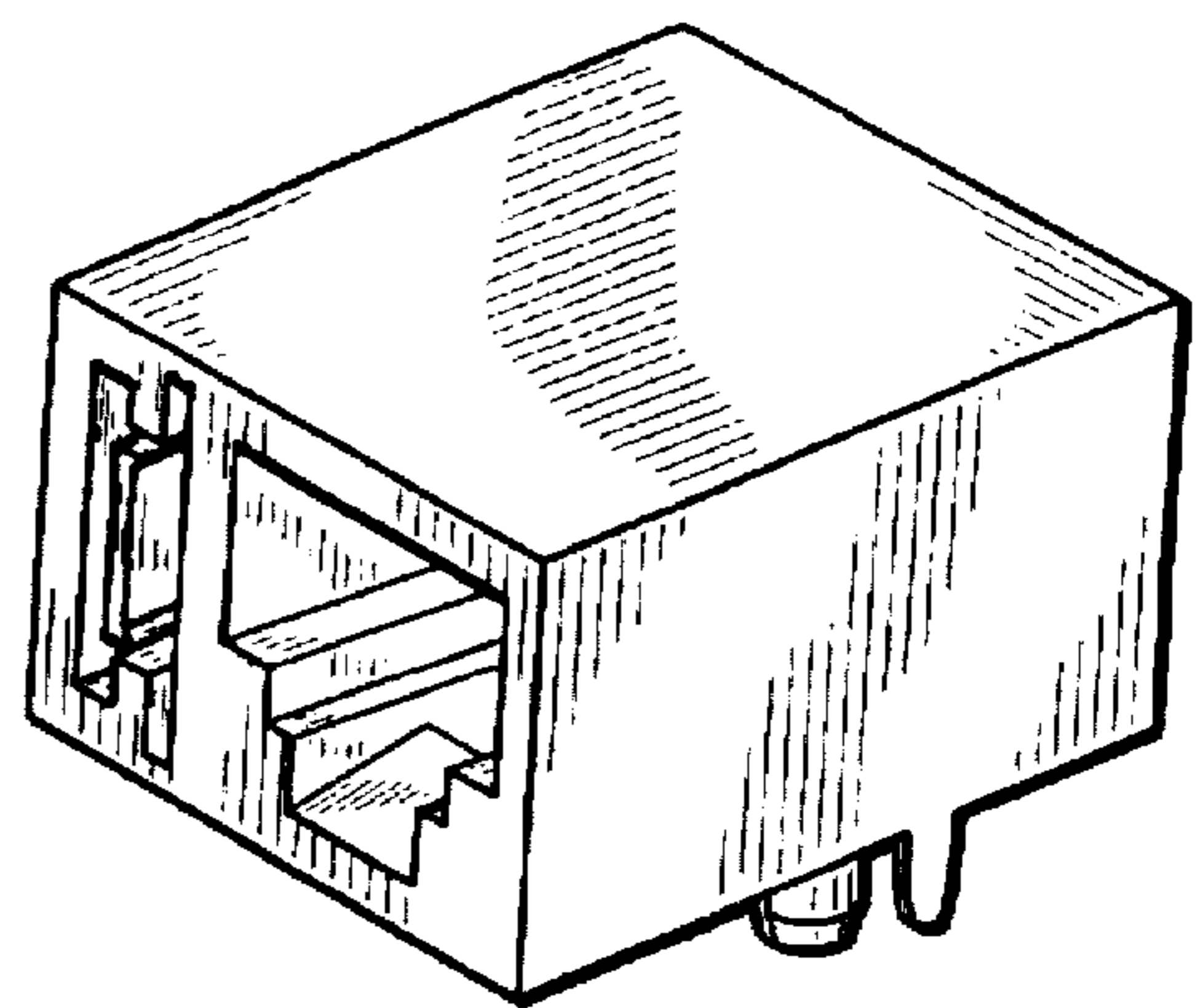
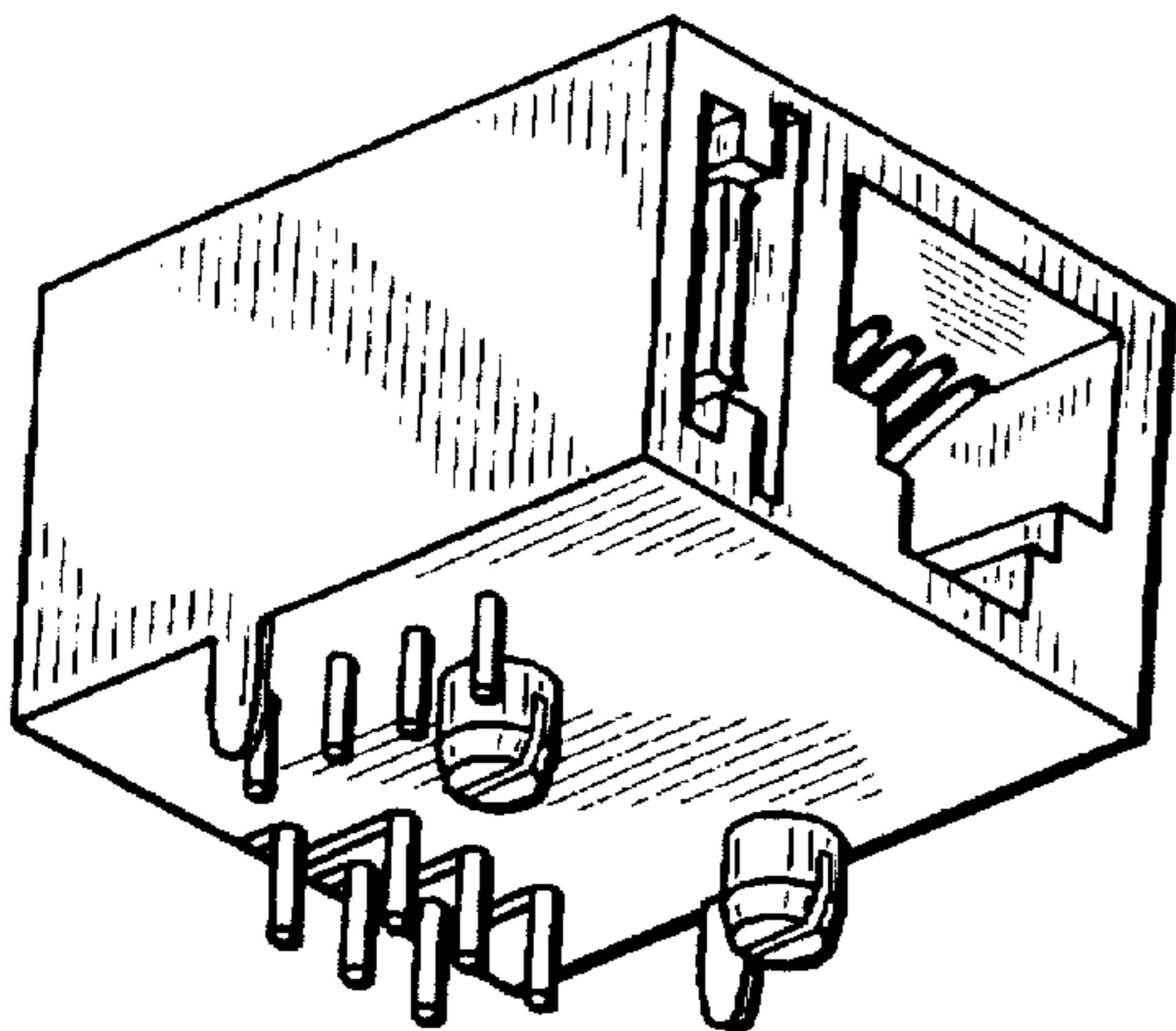
The ornamental design for a connector receptacle, as shown and described.

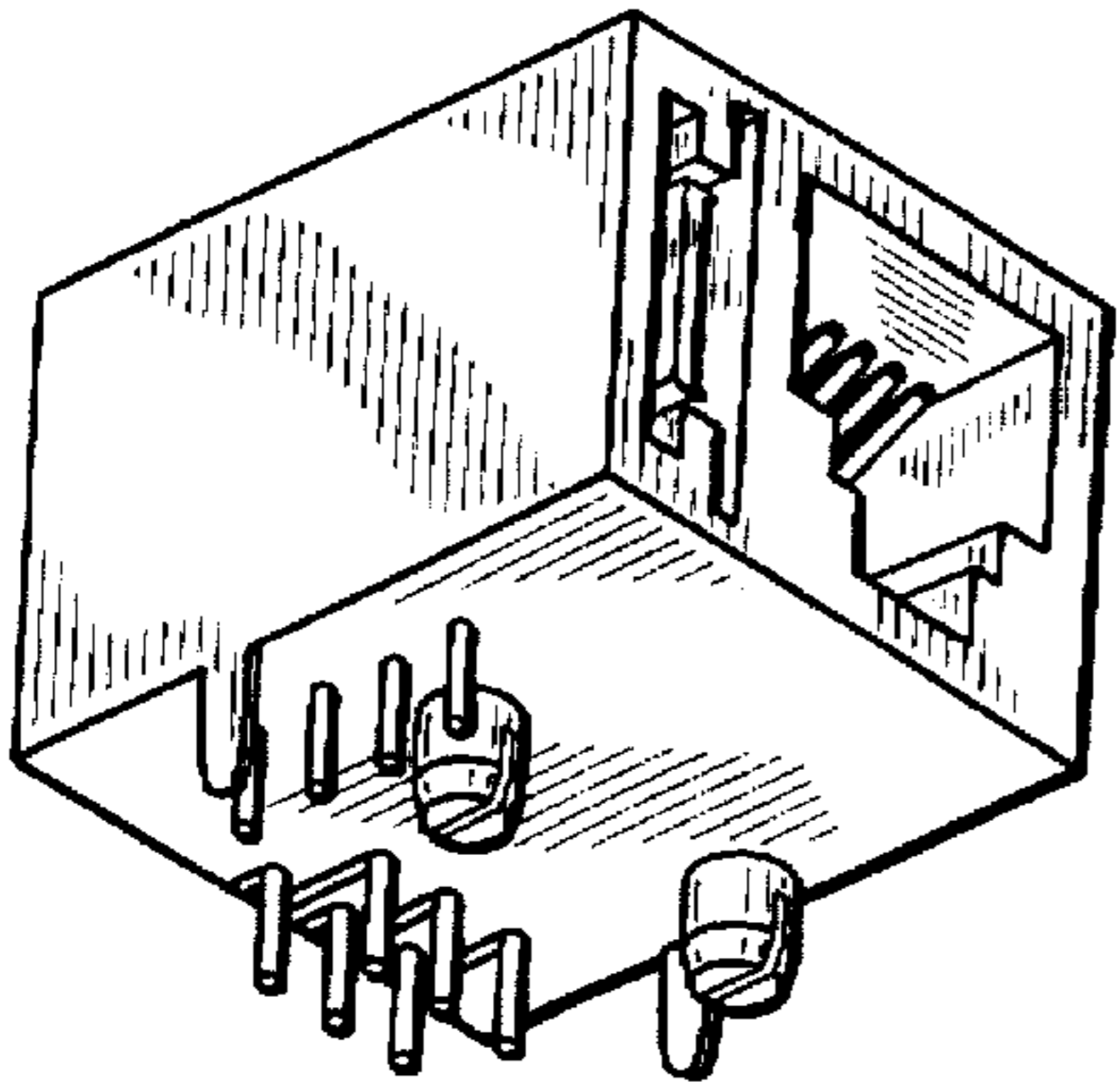

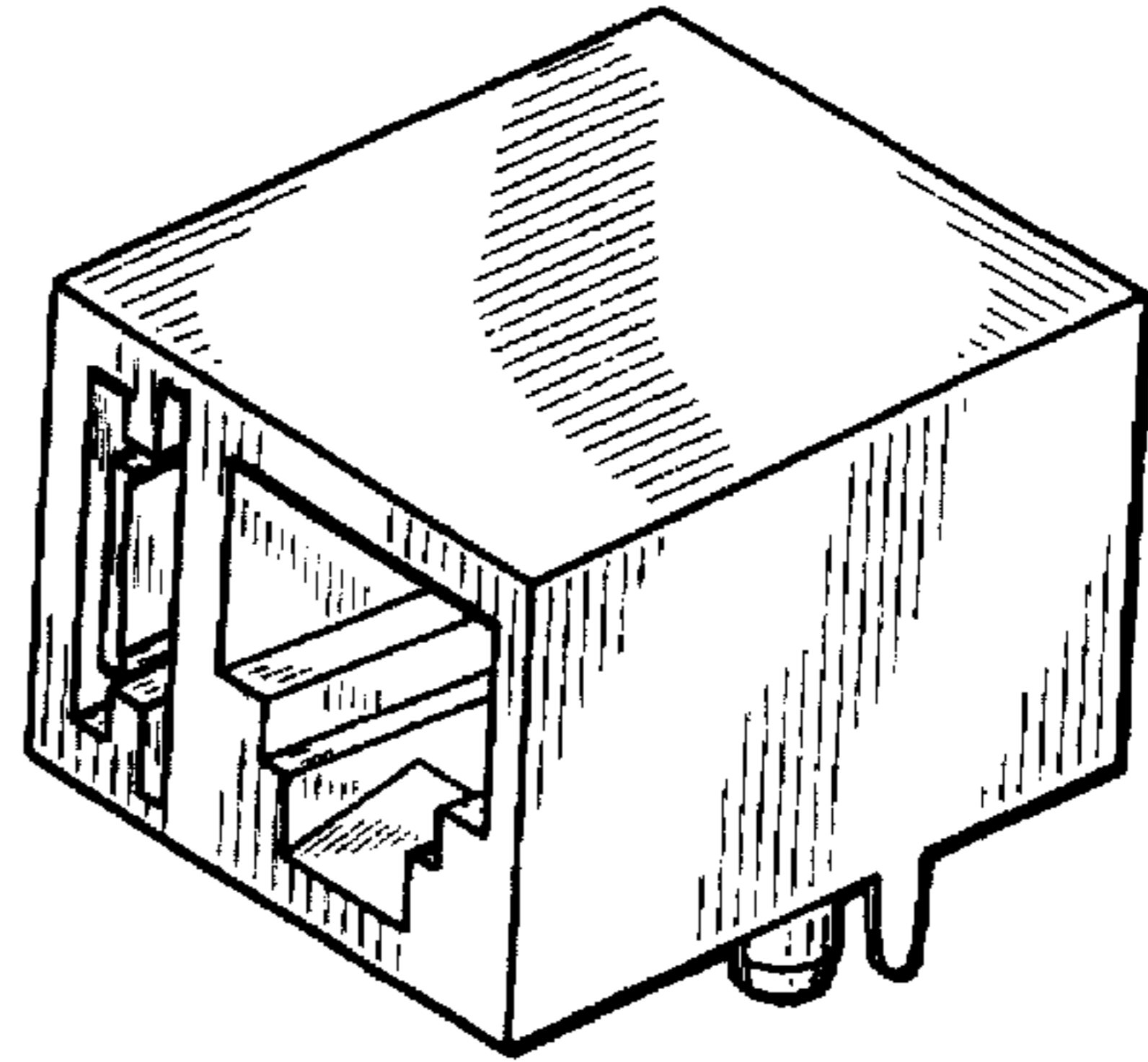

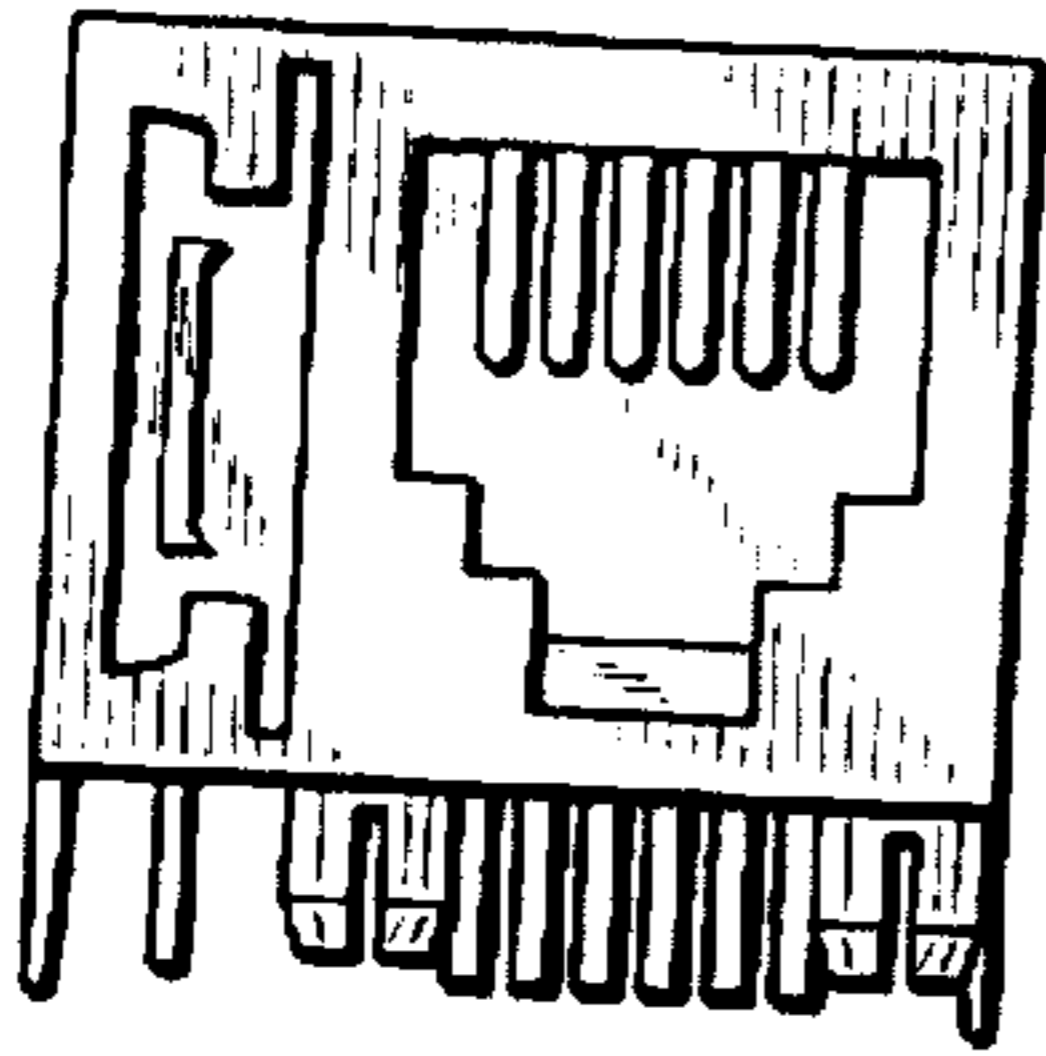

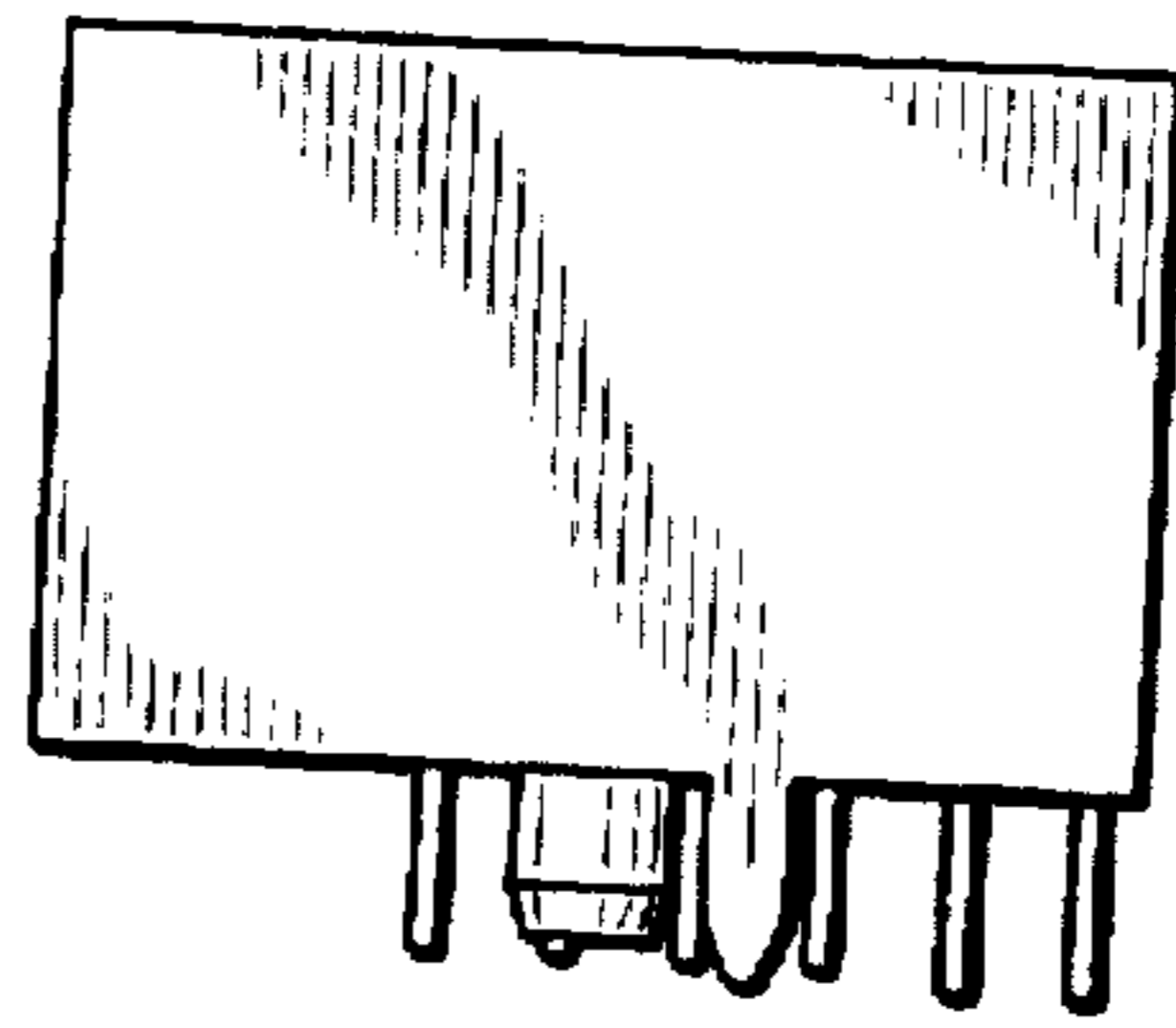

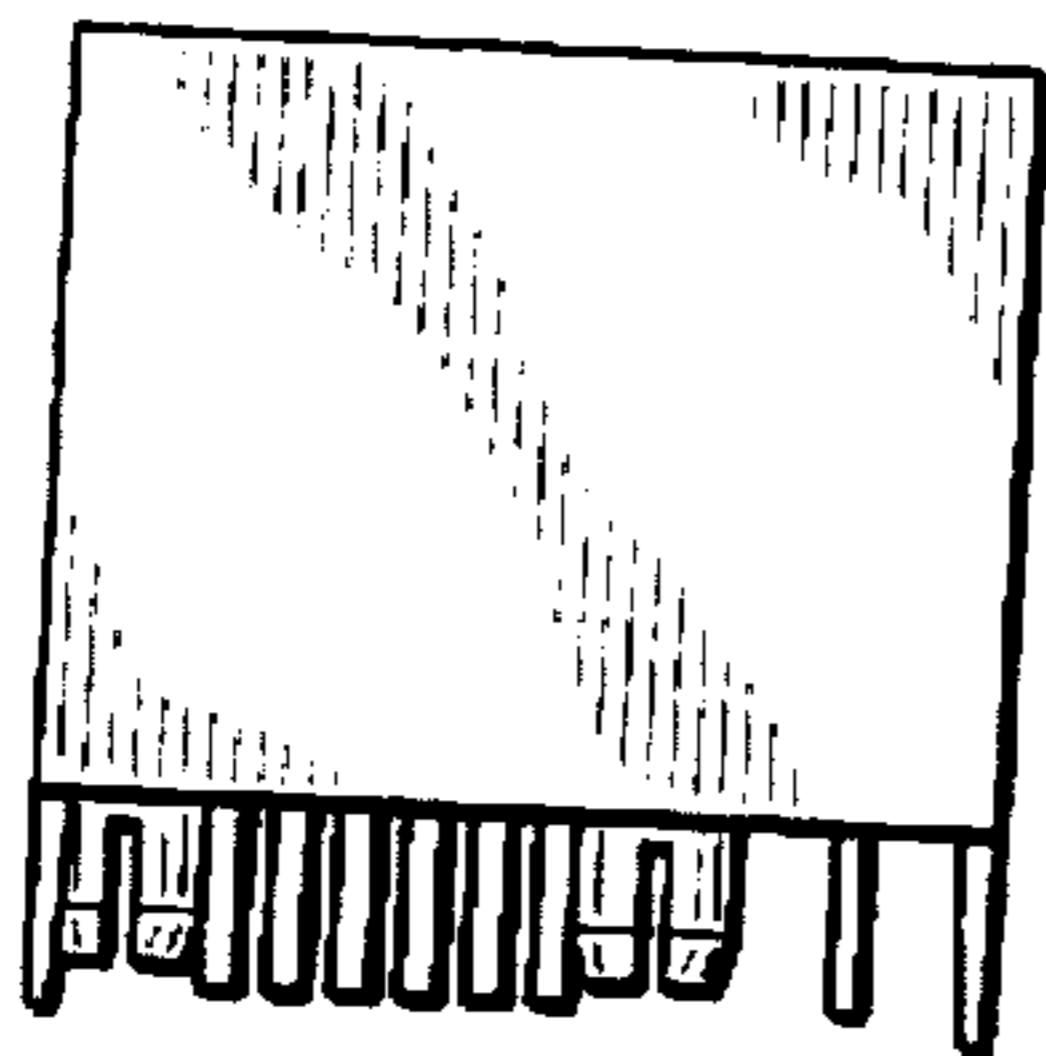

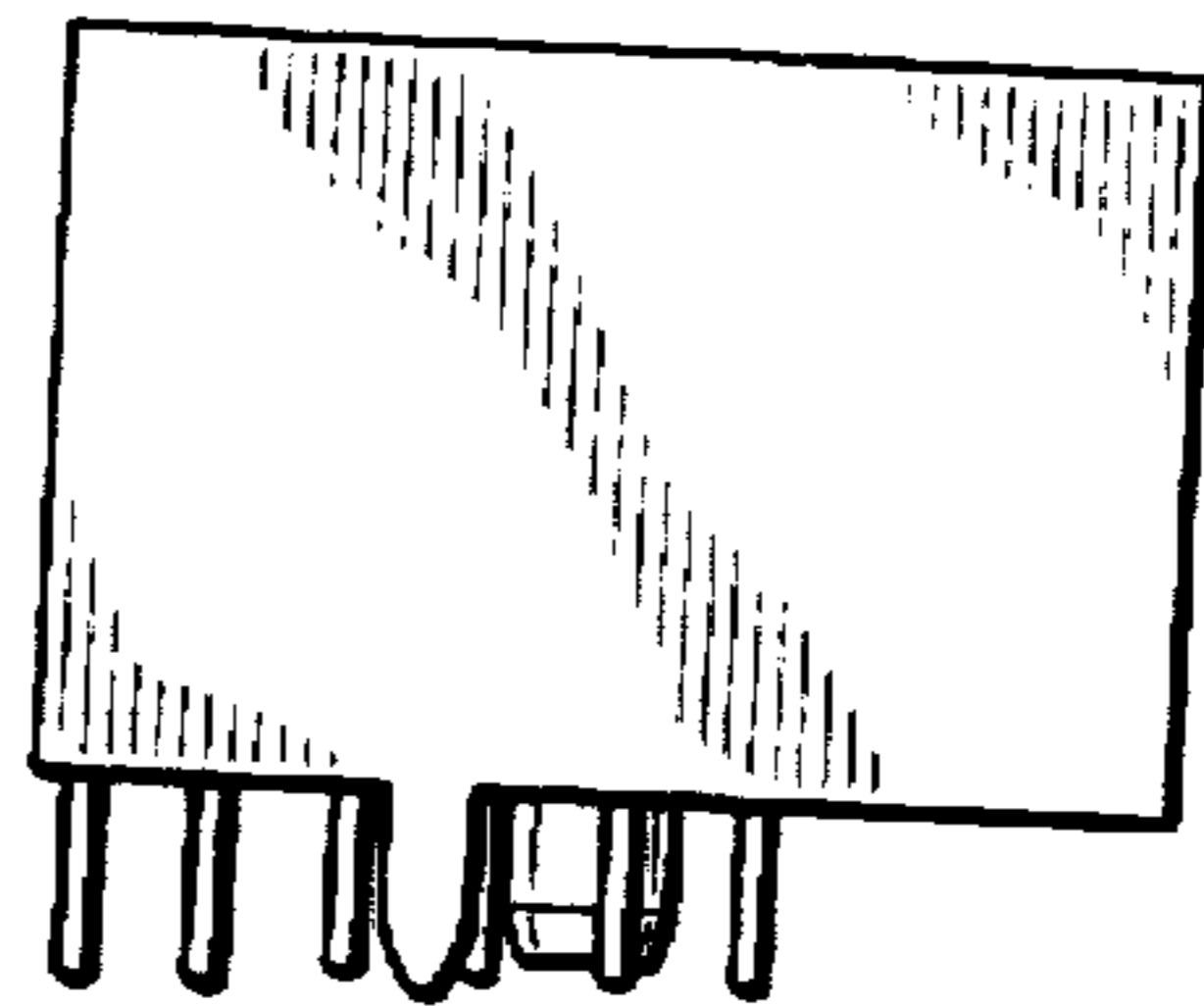

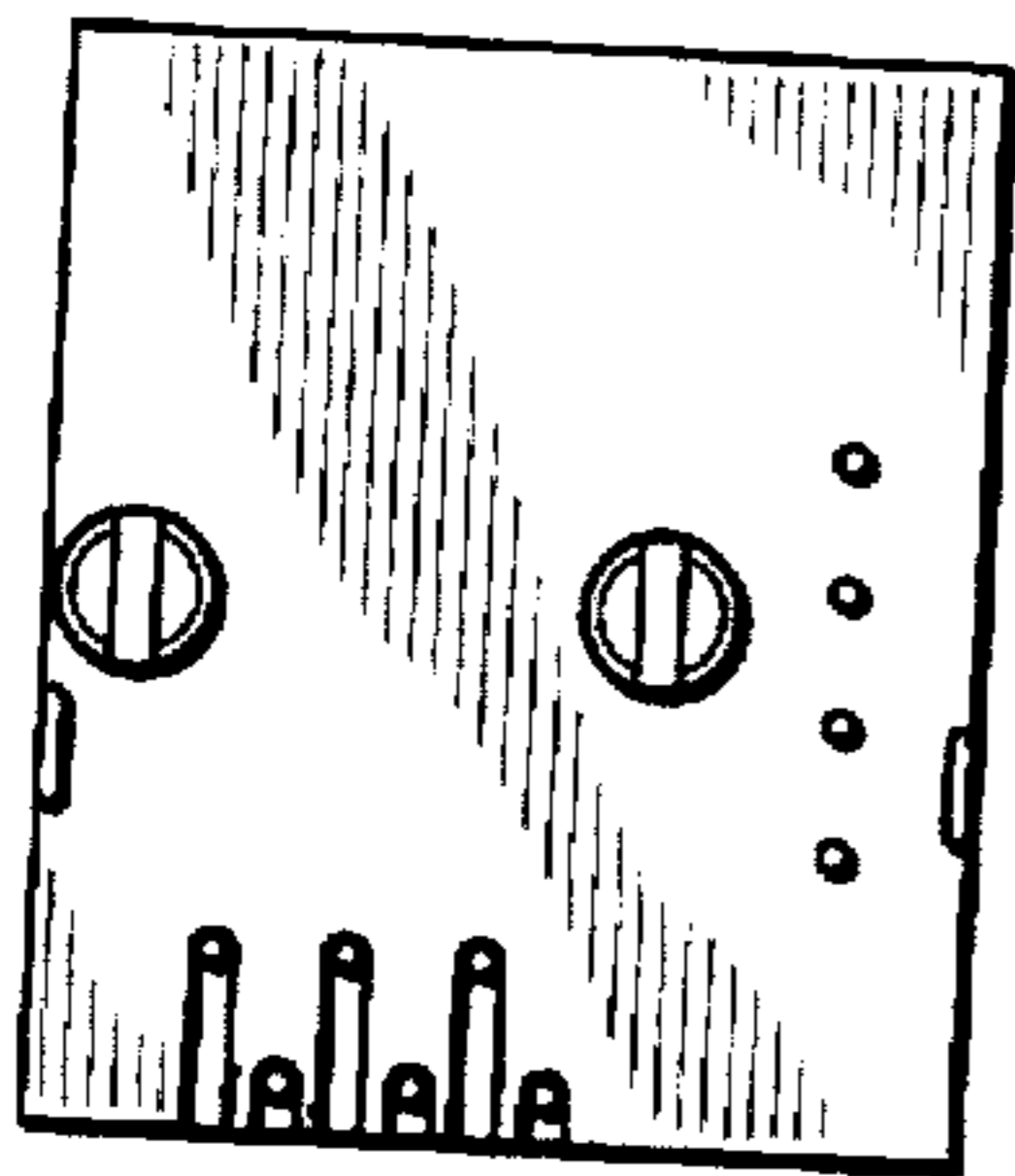

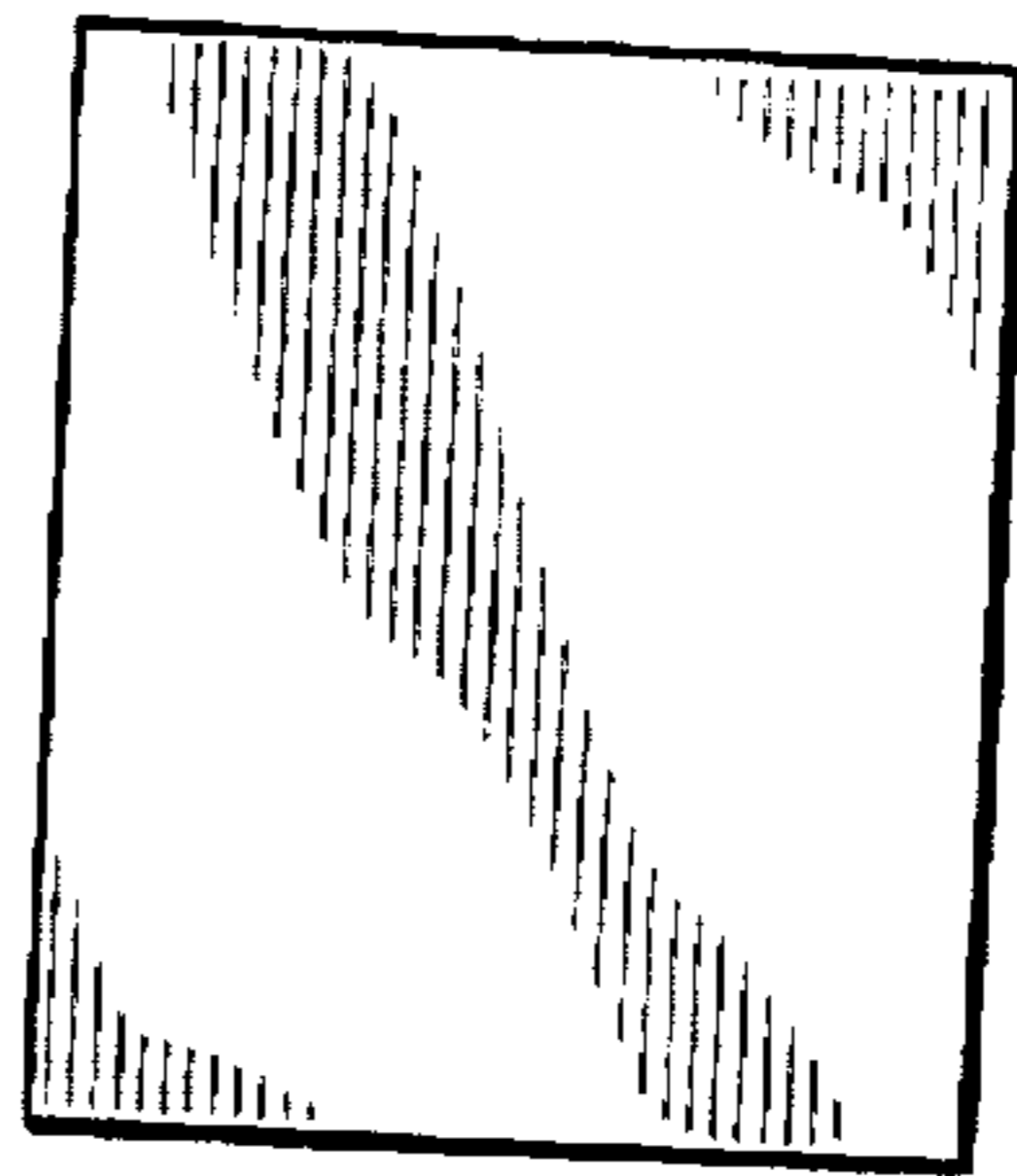
