 FIG. 13 is a top end elevation thereof.

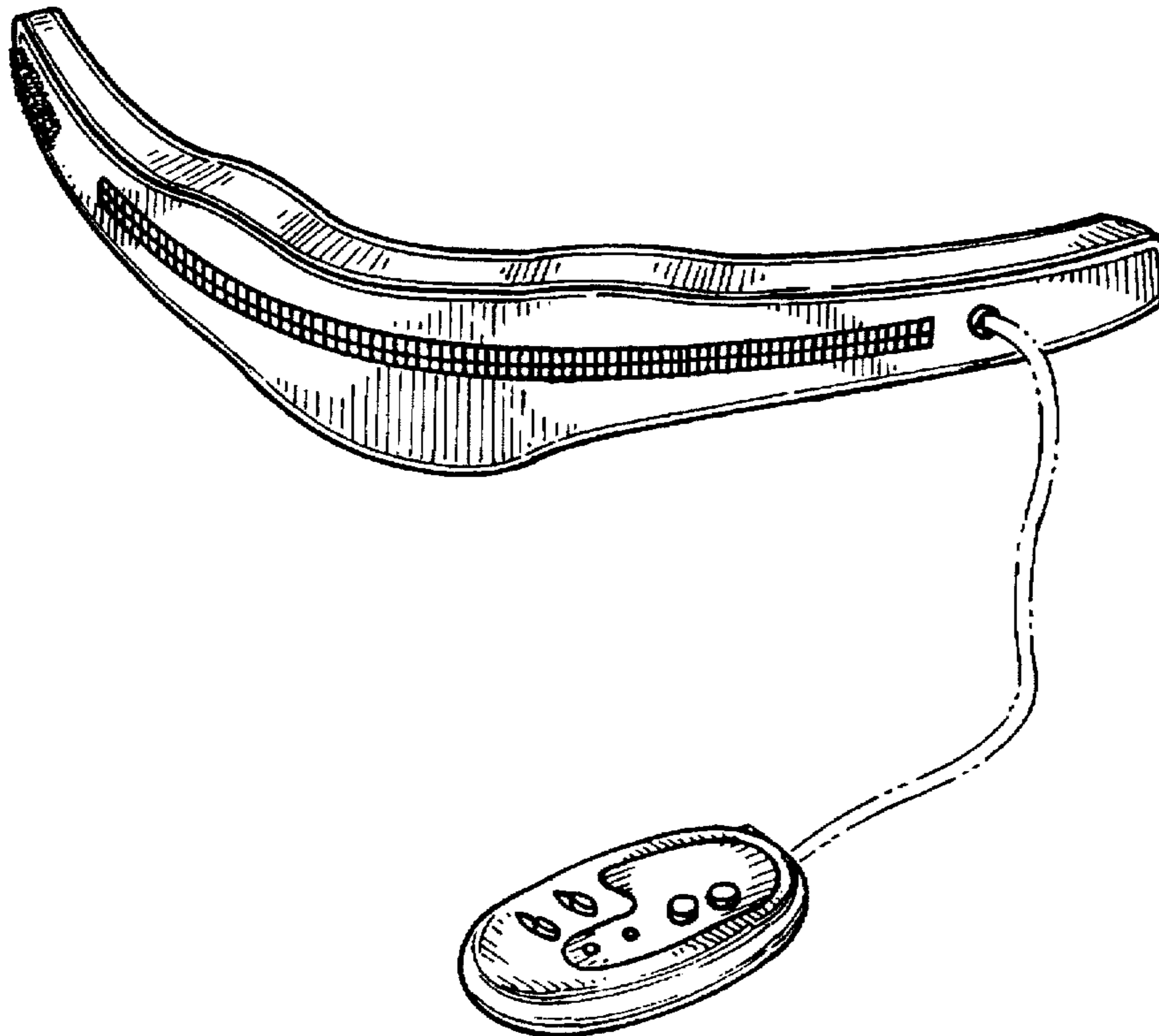

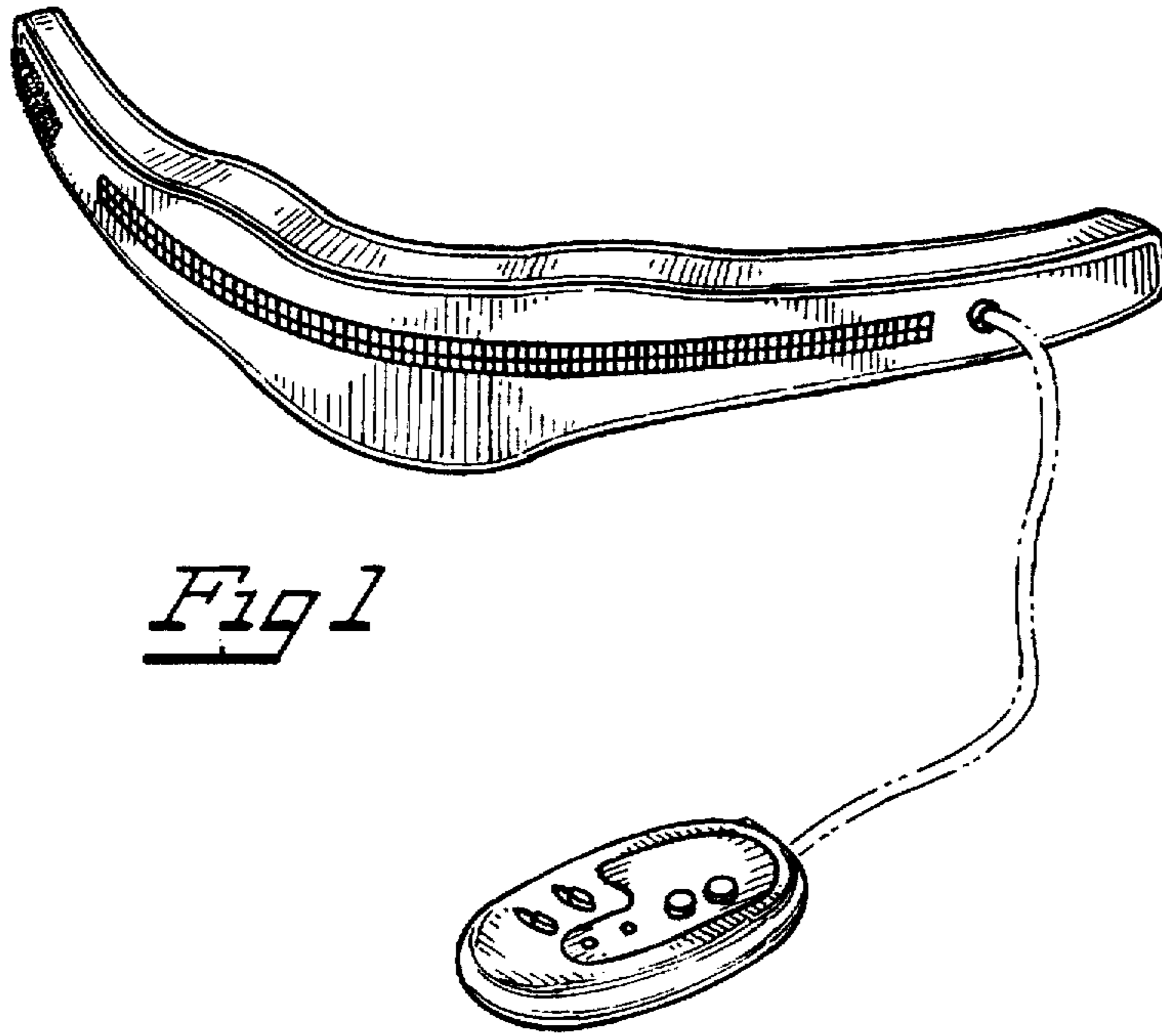

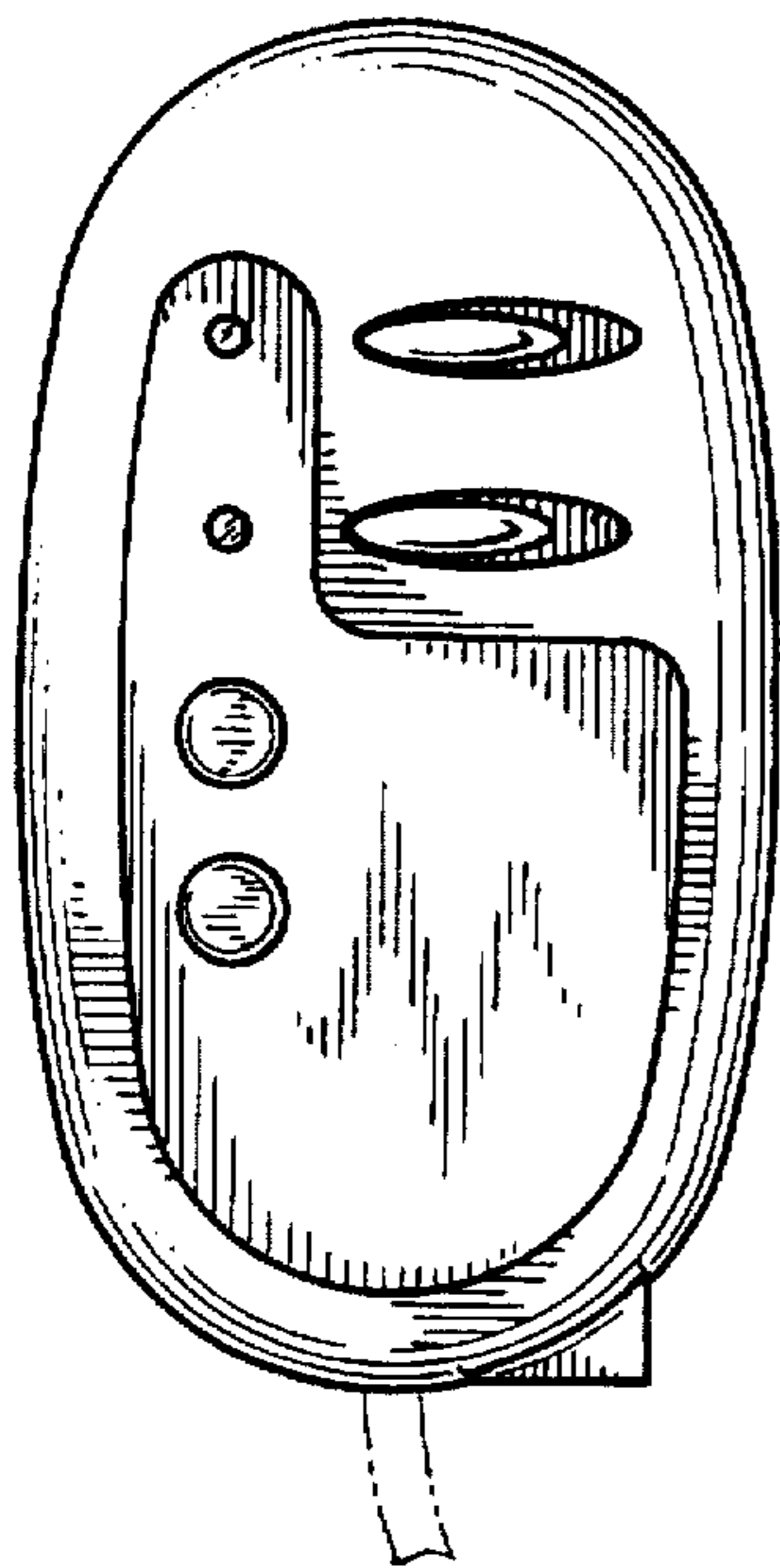

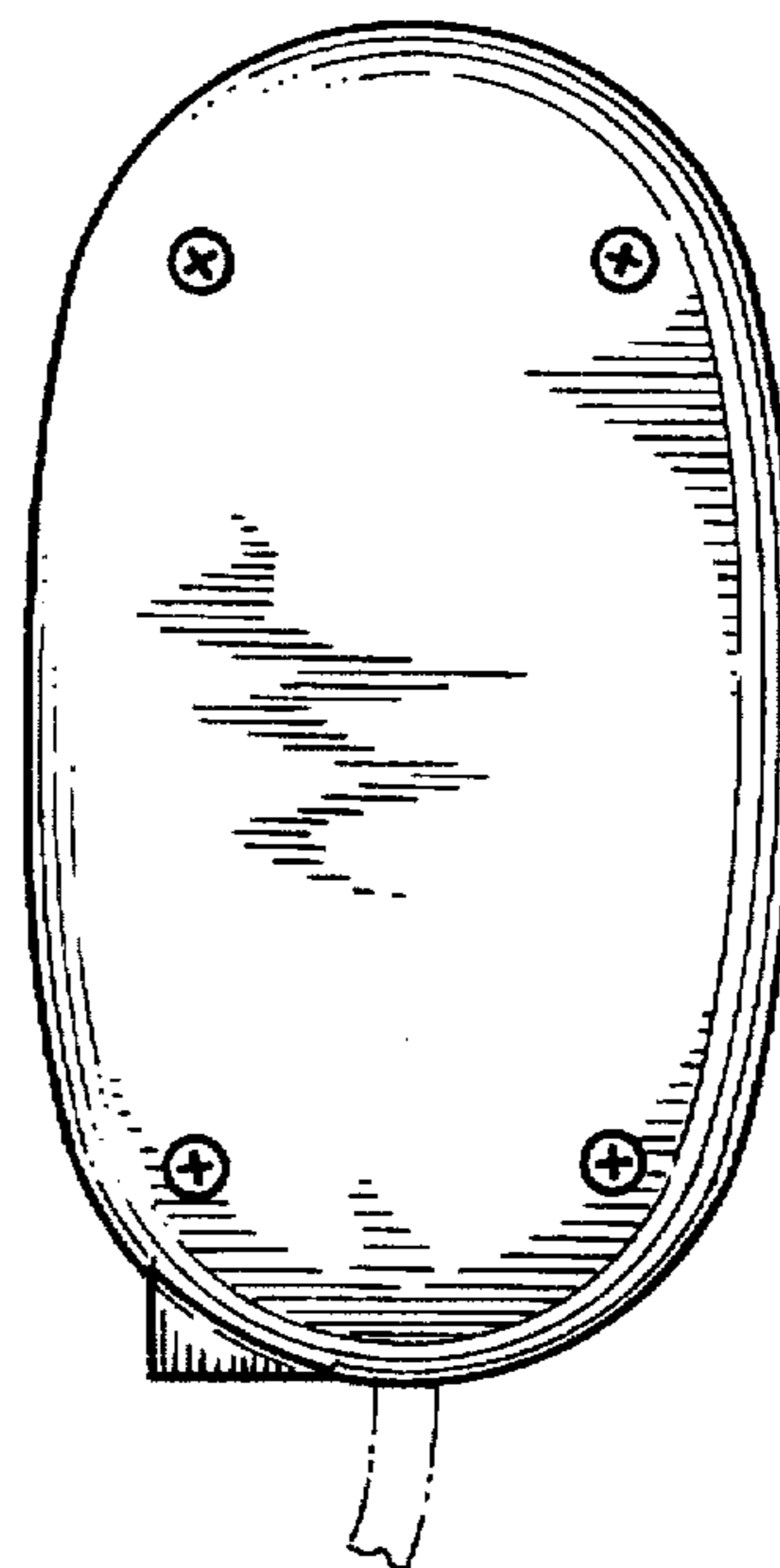

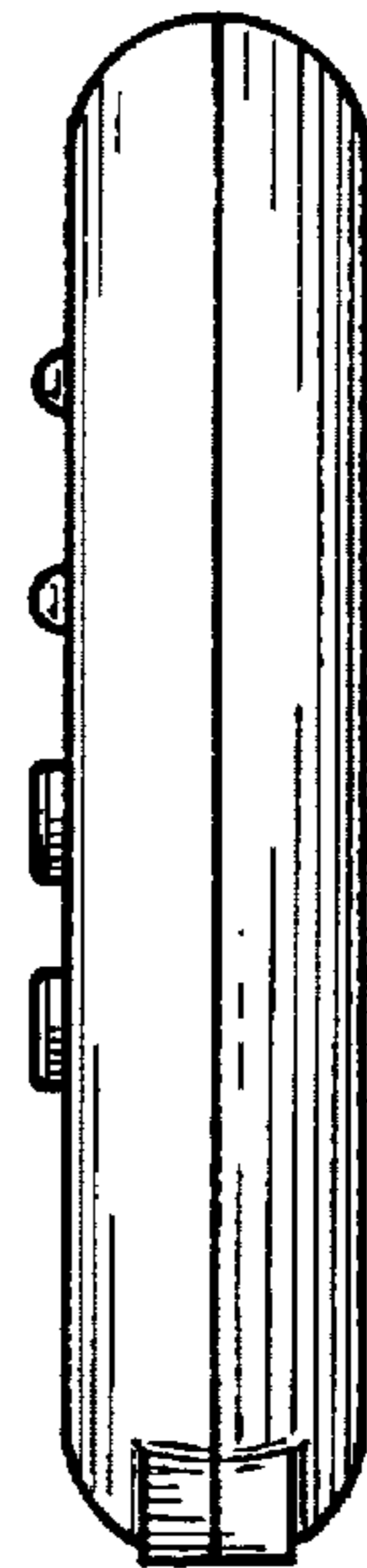

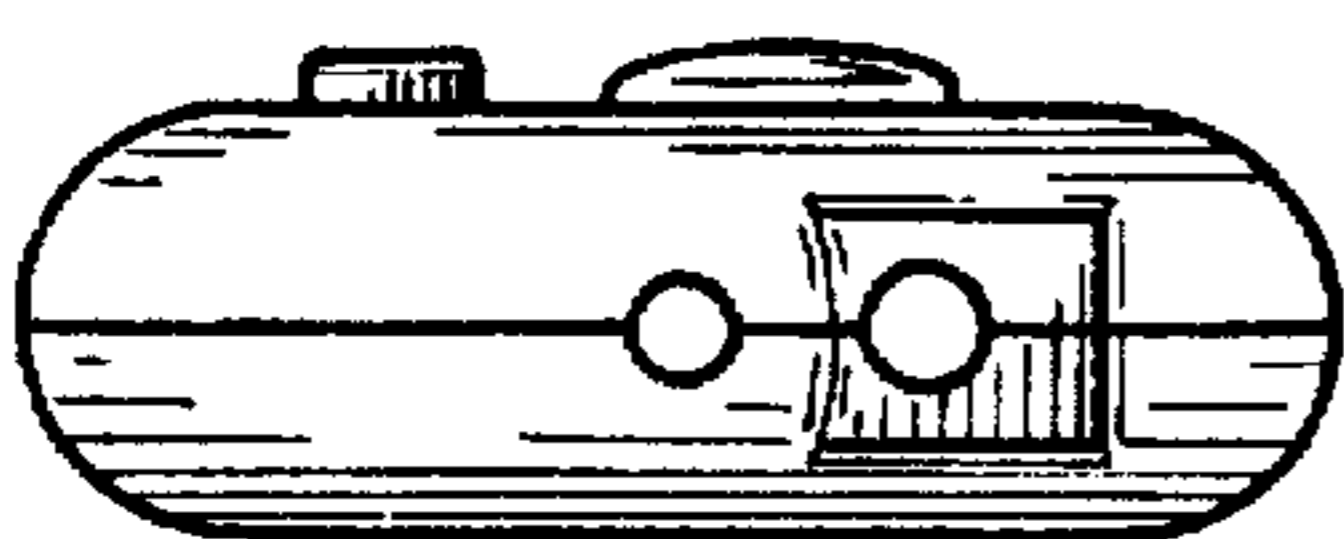

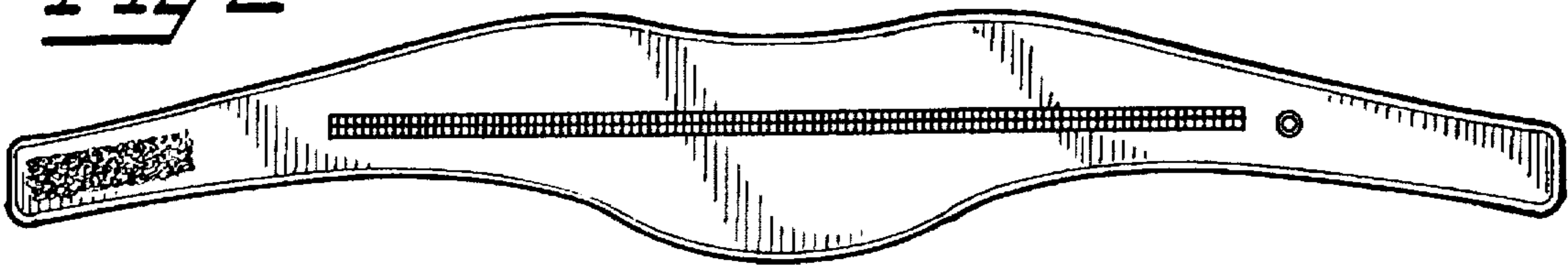

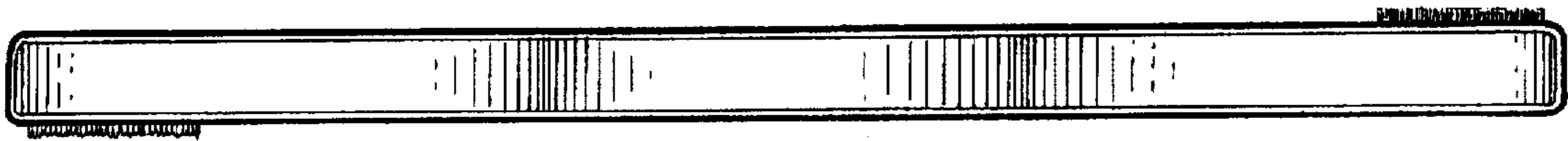

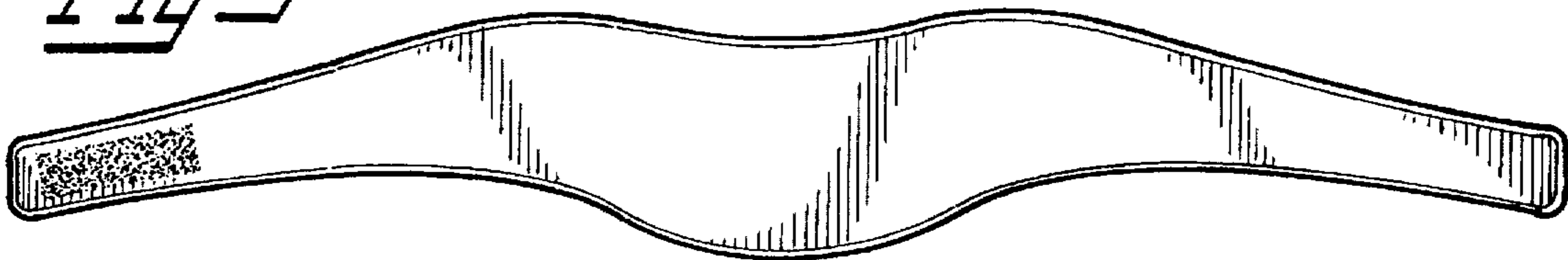

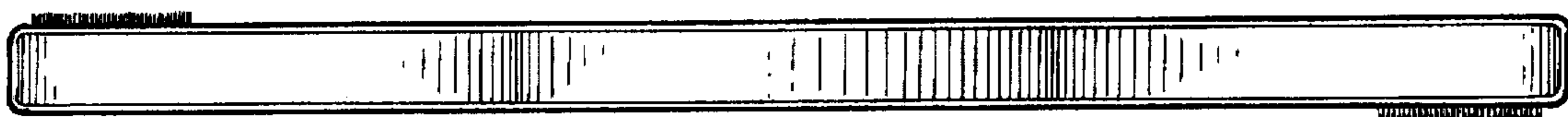
