FIG. 1 is a side elevational view of a side portion of a shoe showing my new design;

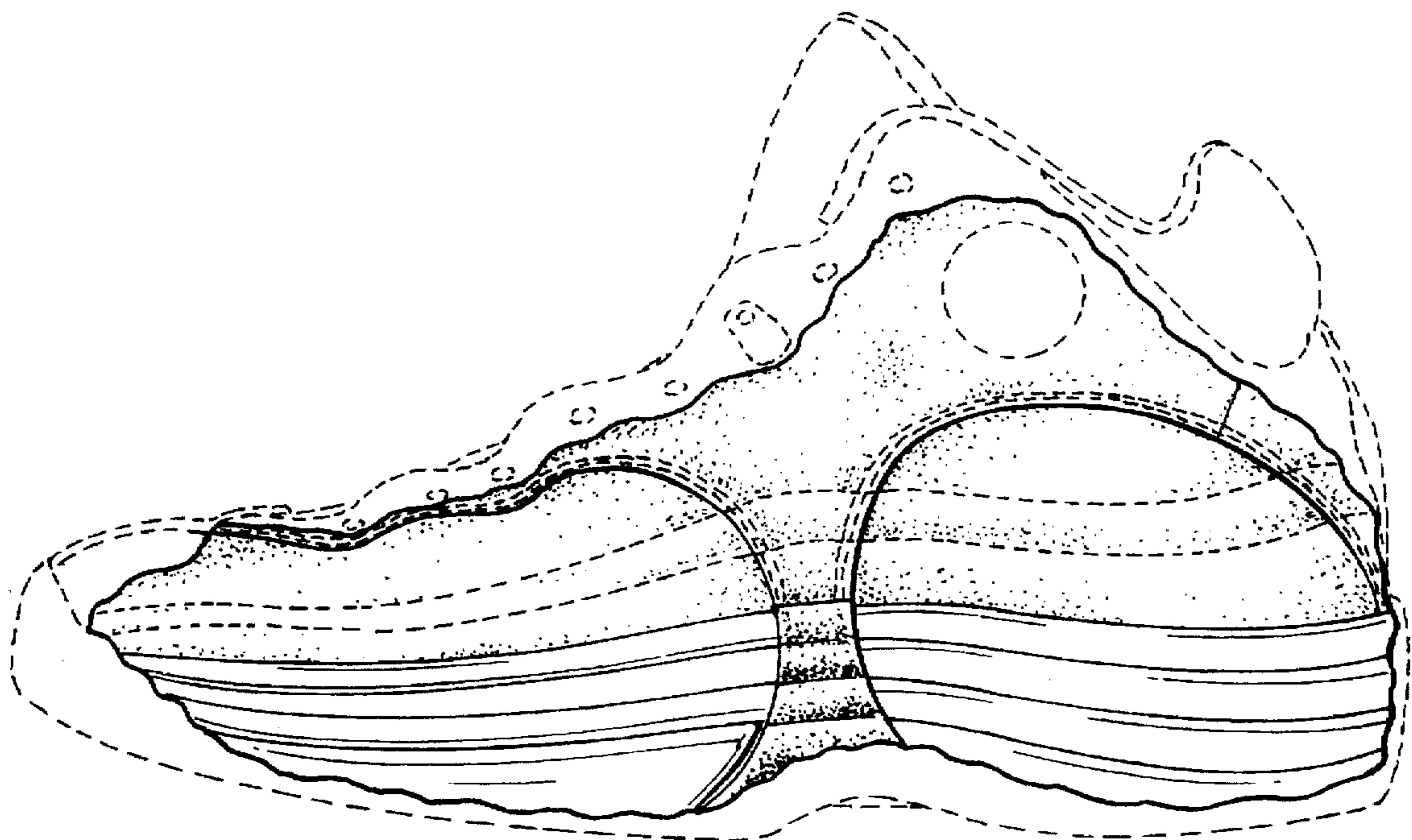
FIG. 2 is a front elevational view of the side portion of a shoe shown in FIG. 1;

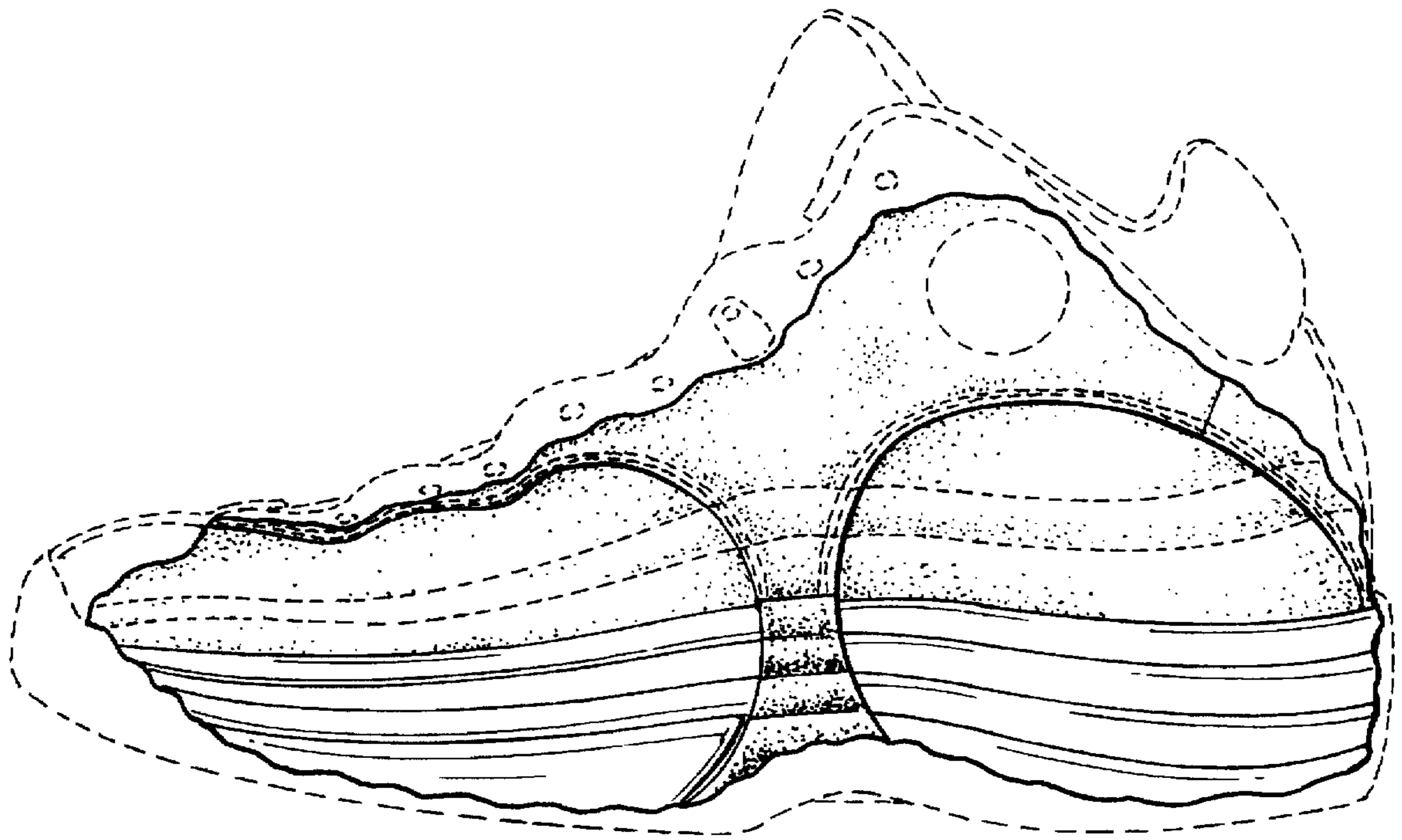

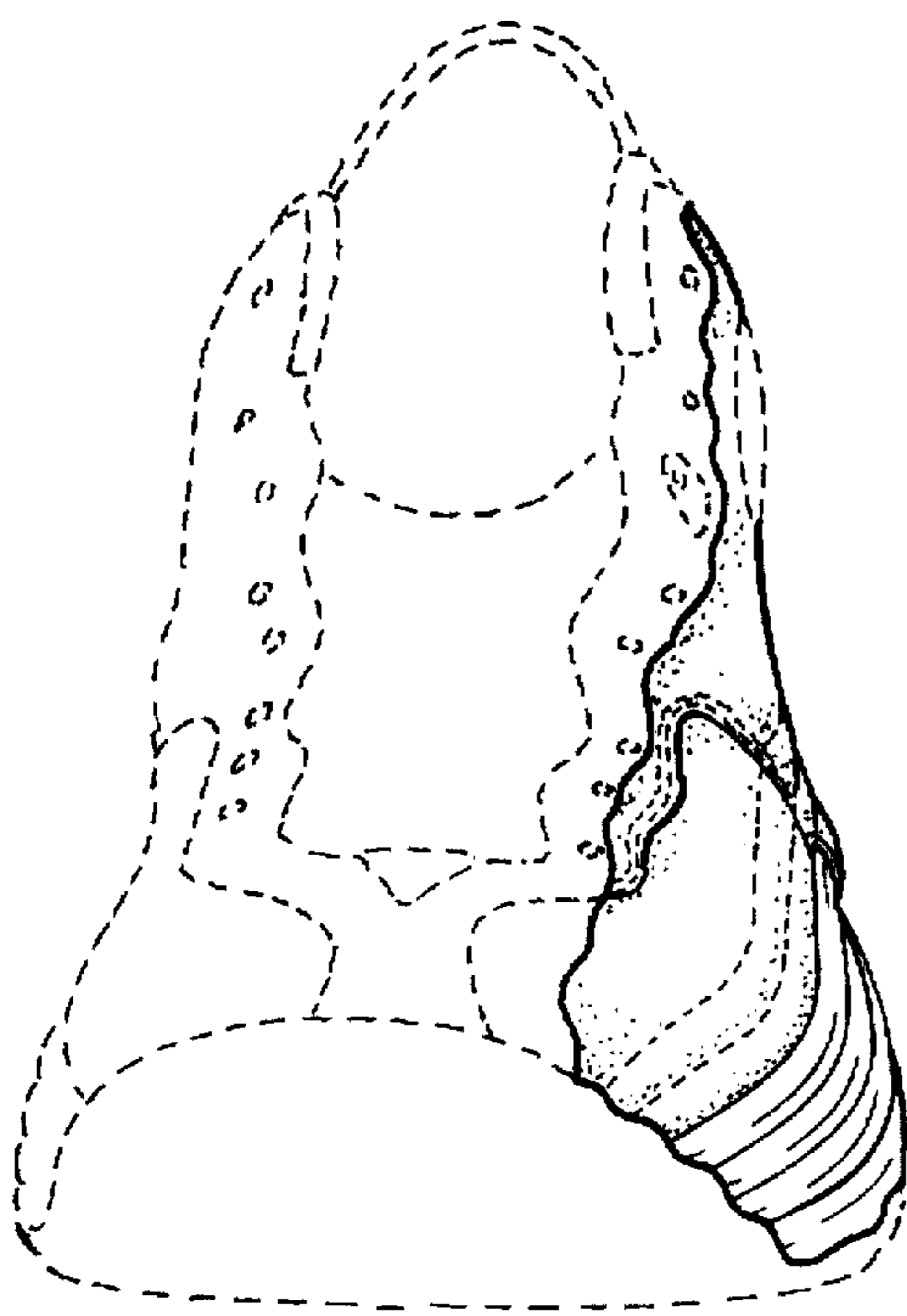

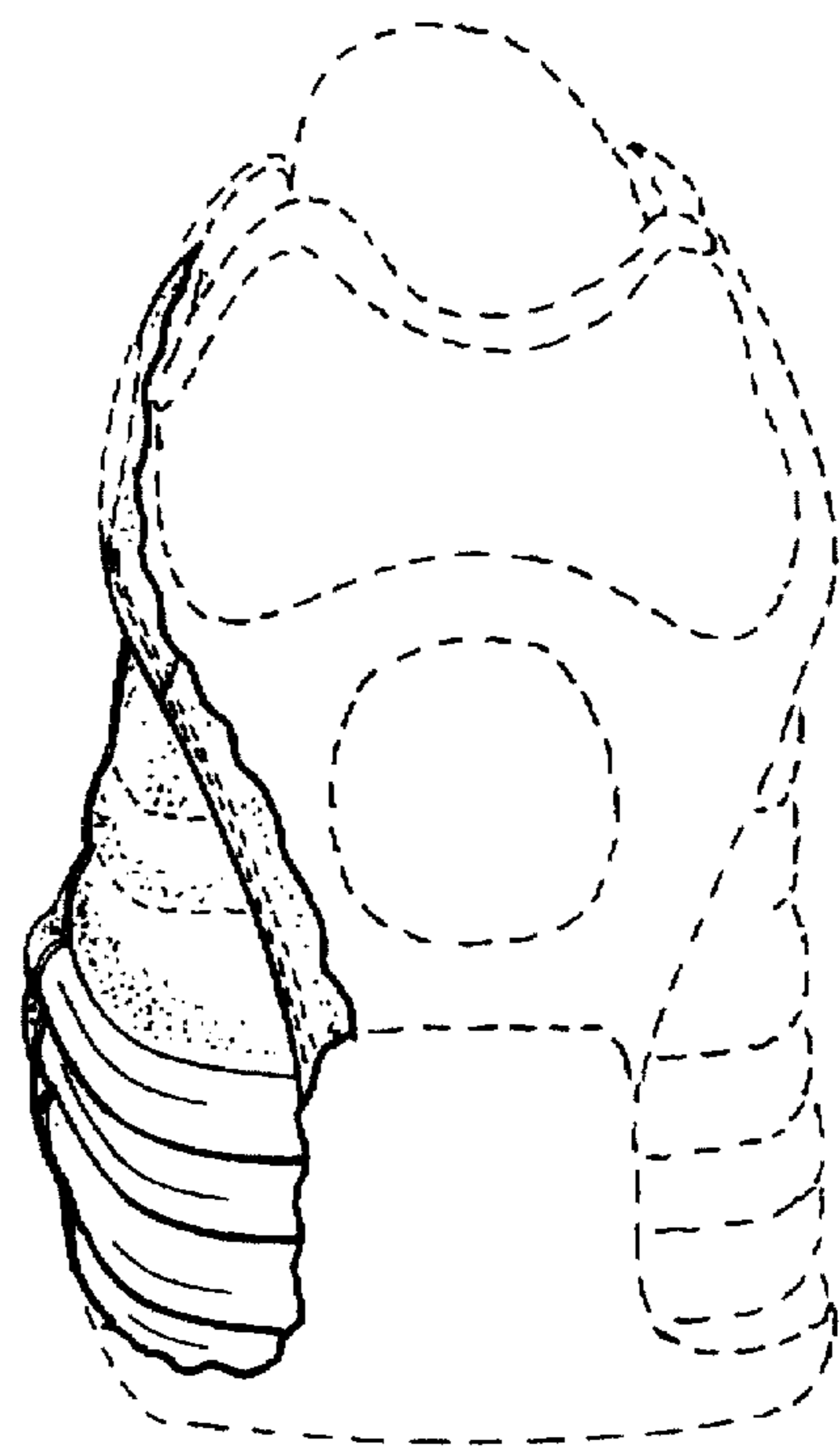

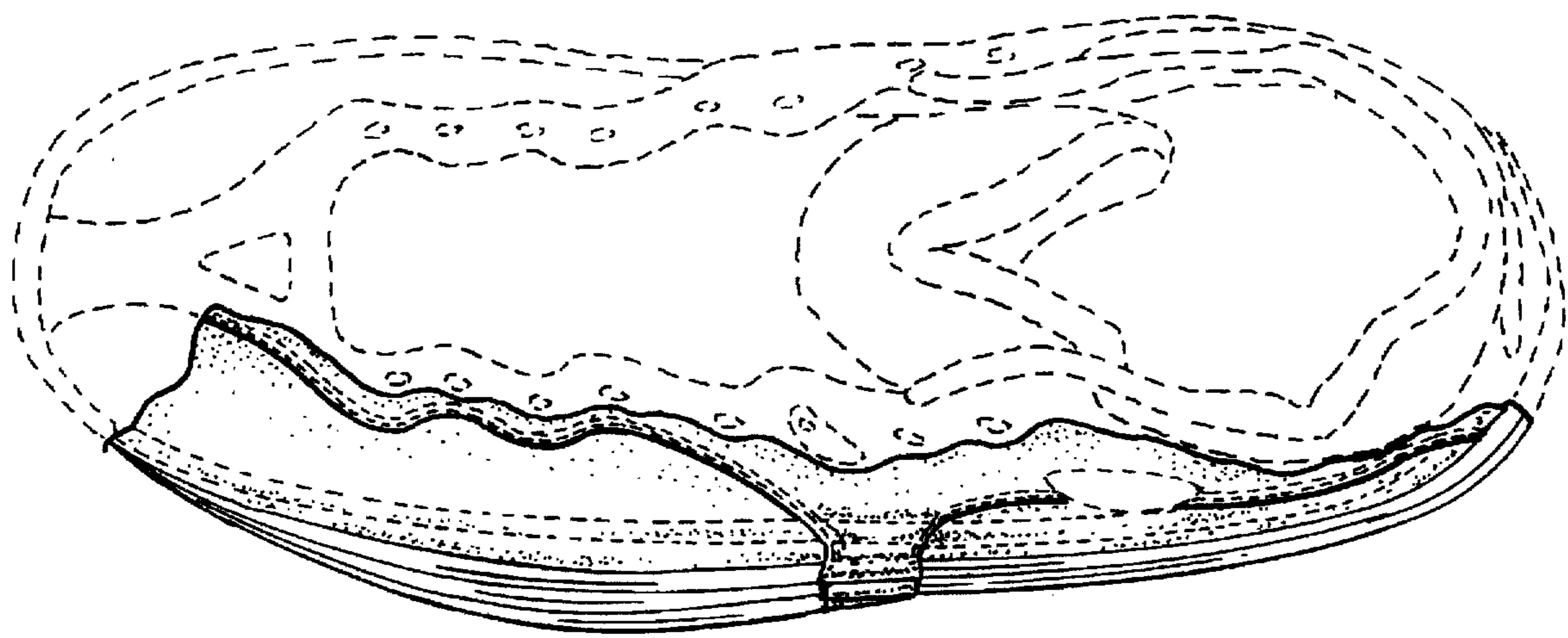
