[57] **CLAIM**

The ornamental design for an element of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of an element of a shoe upper showing my new design;

FIG. 2 is a side elevational view of the element of a shoe upper shown in FIG. 1;

FIG. 3 is a front elevational view of the element of a shoe upper shown in FIG. 1;

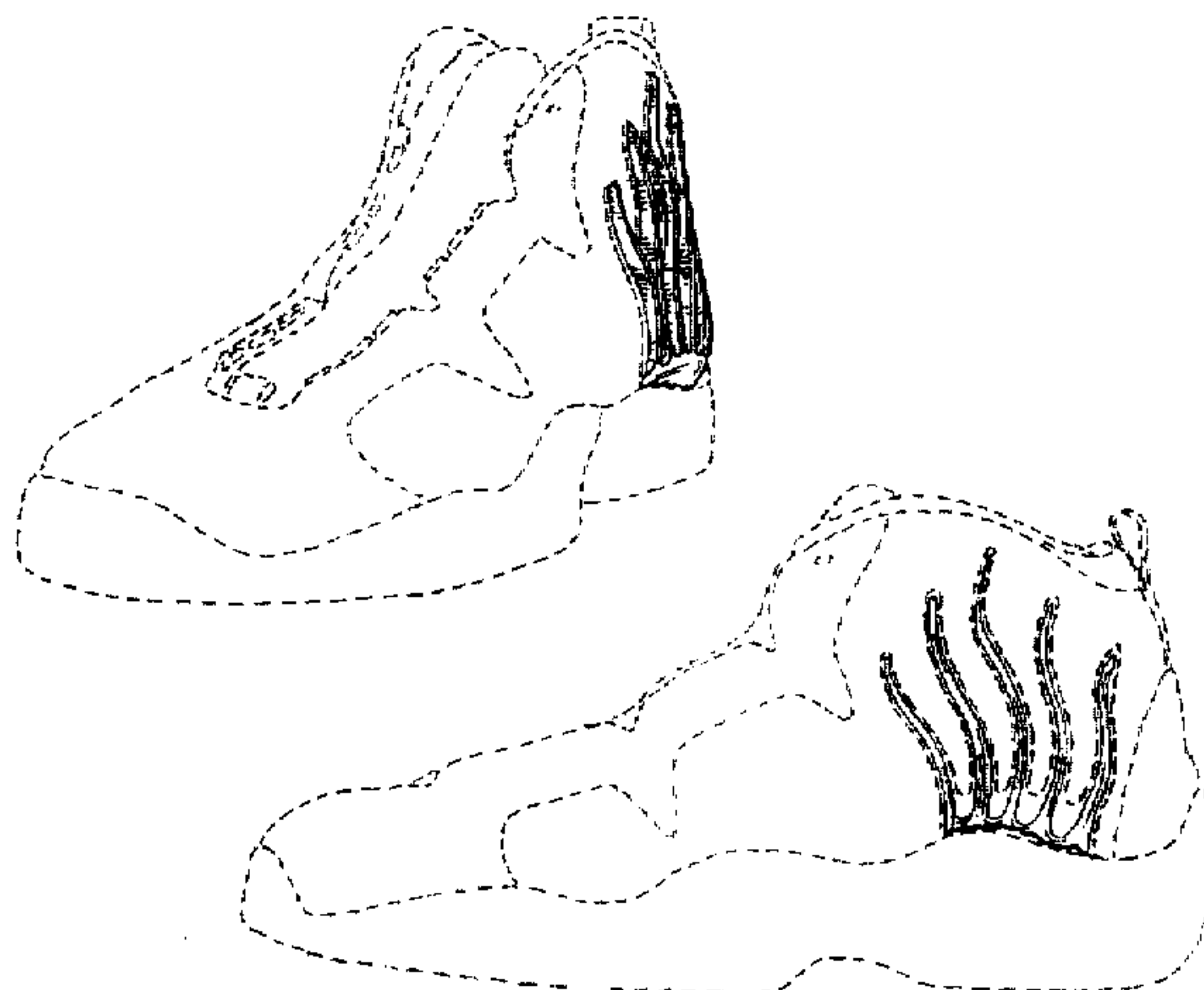


FIG. 4 is a rear elevational view of the element of a shoe upper shown in FIG. 1; and,

FIG. 5 is a top plan view of the element of a shoe upper shown in FIG. 1.

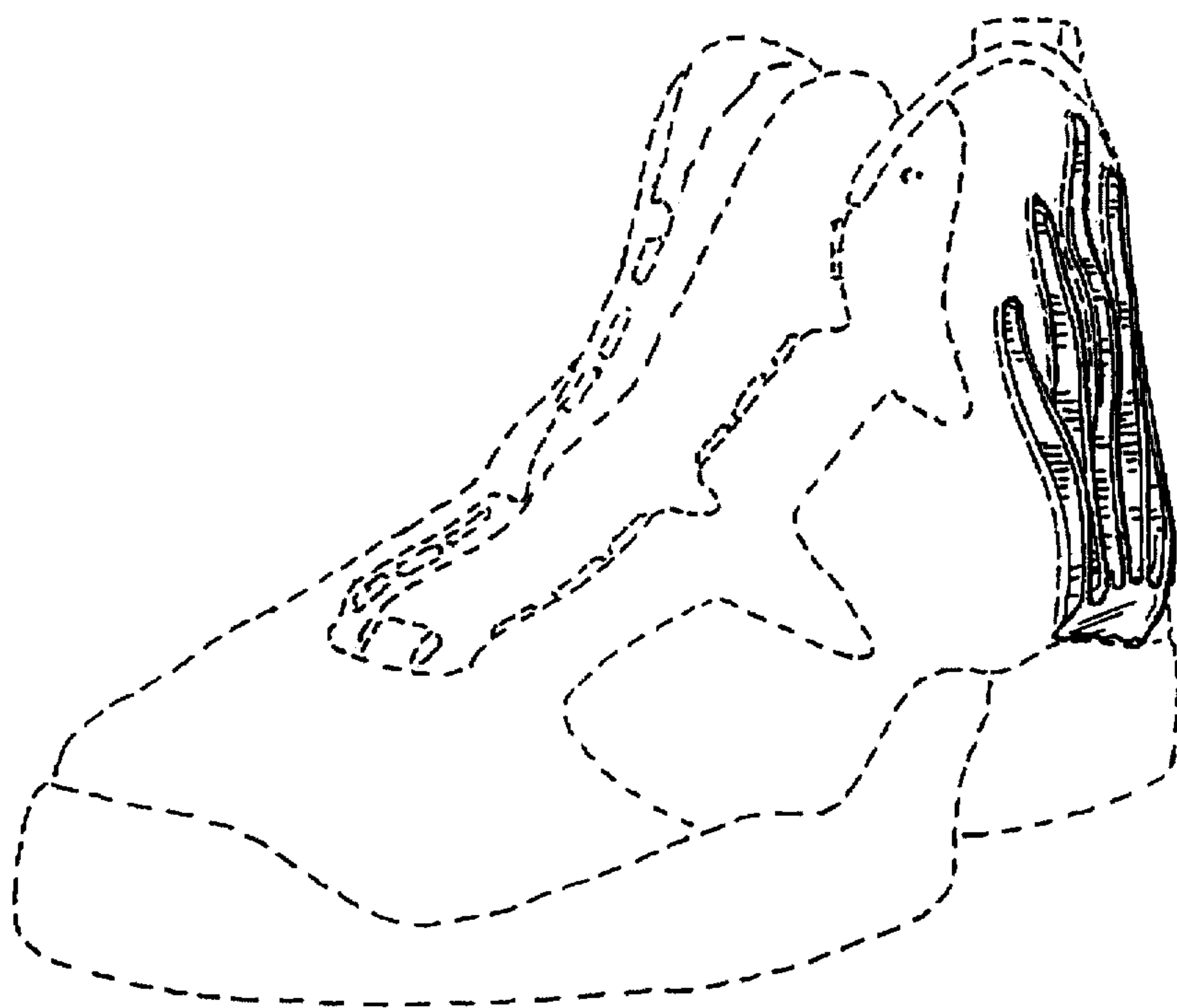

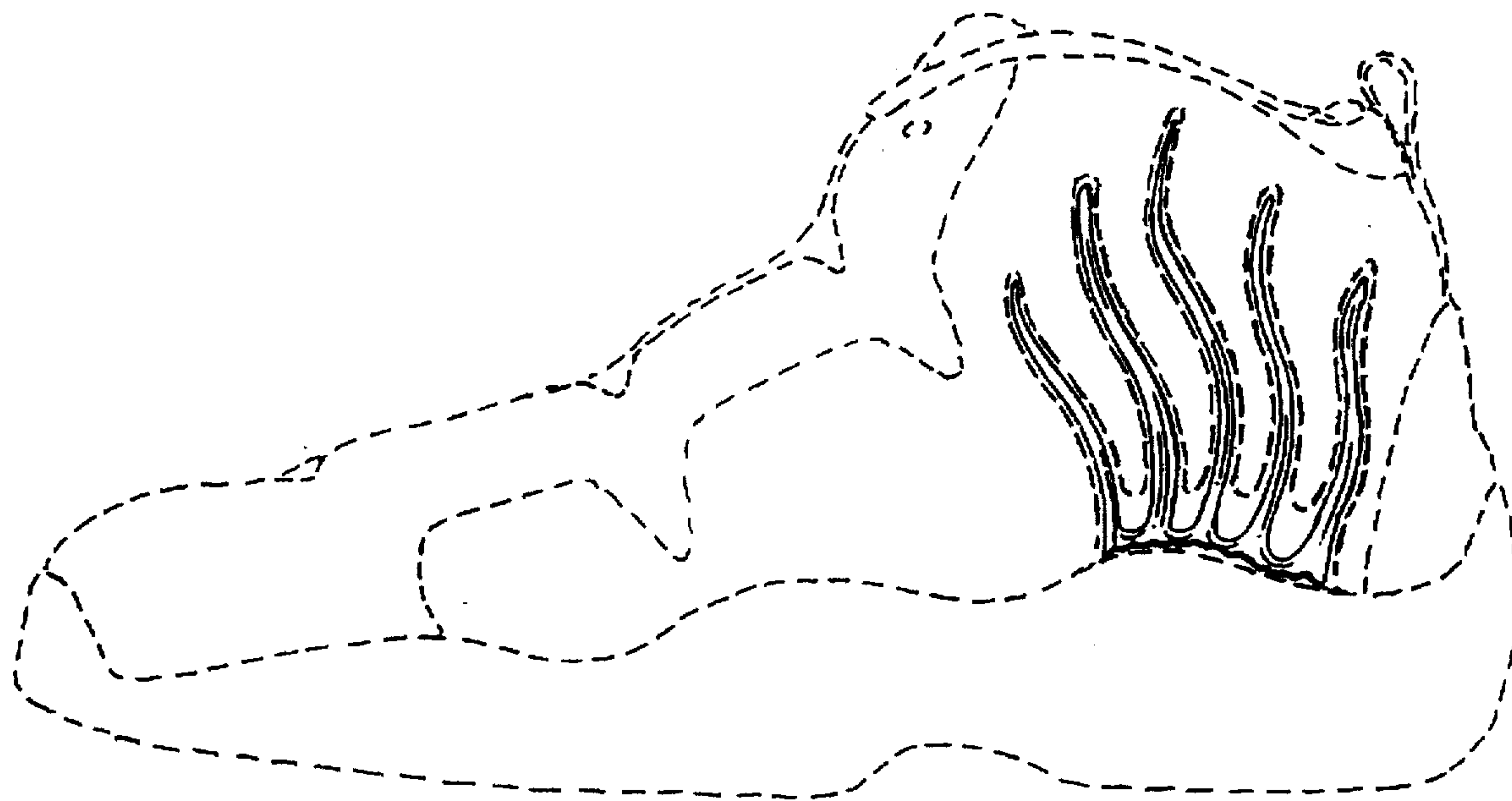

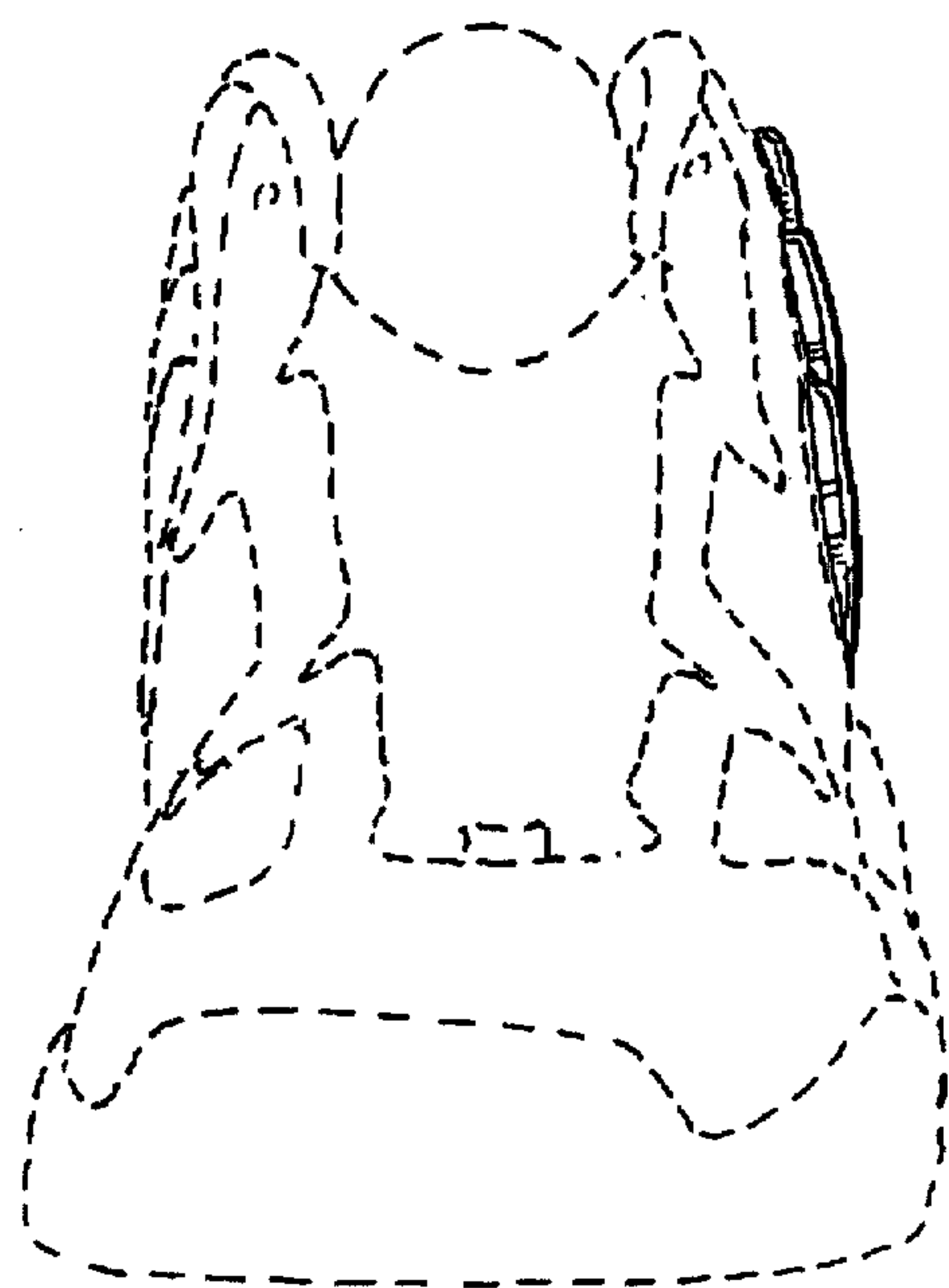

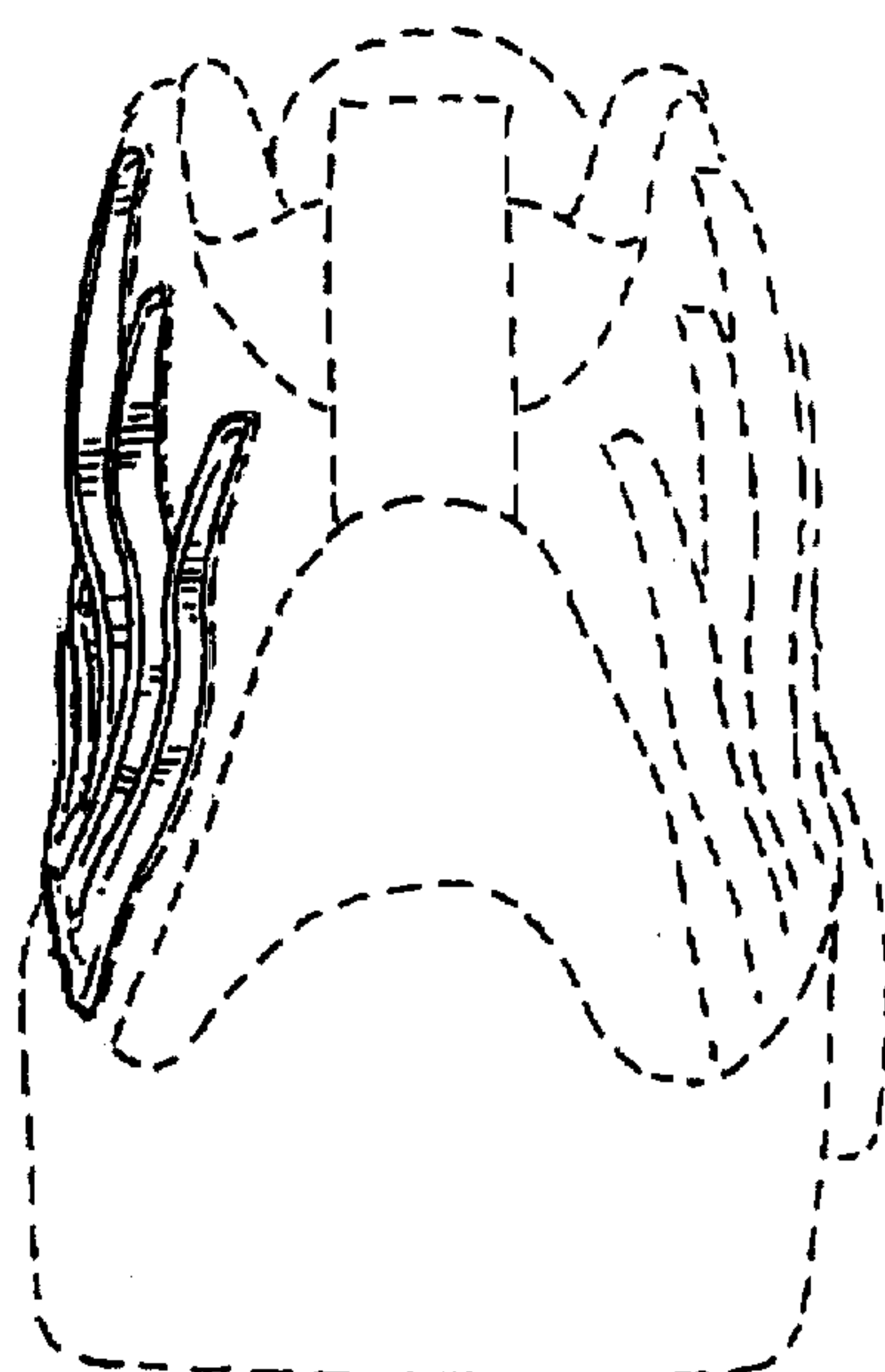

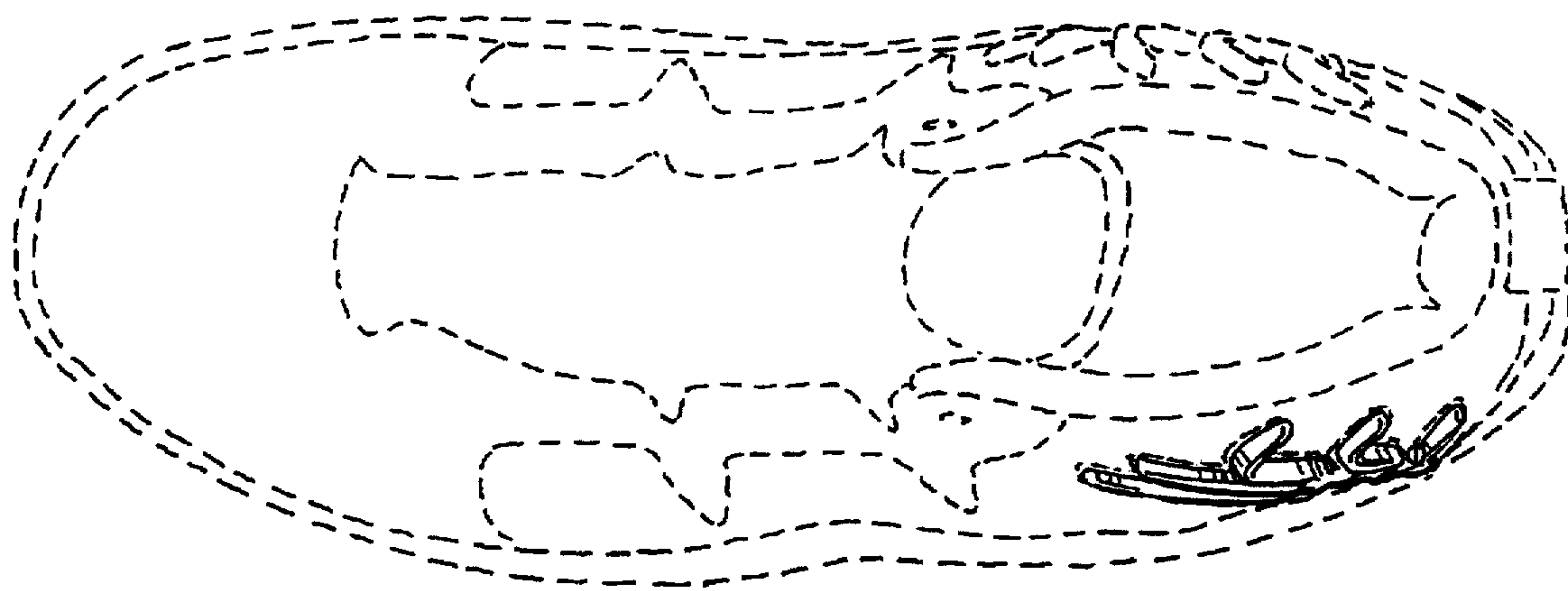
