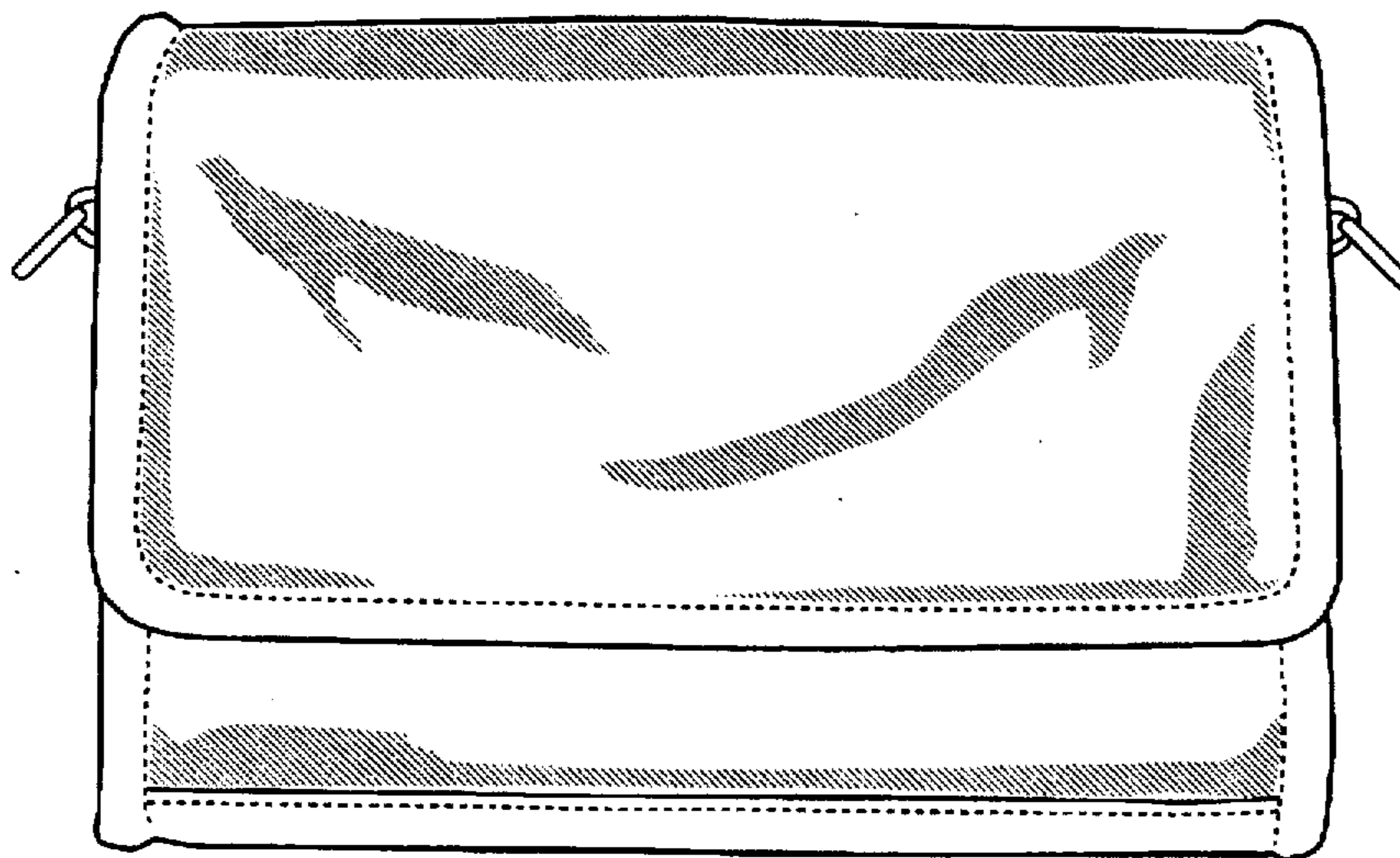
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a bottom elevational view of a combined purse and organizer showing my new design;

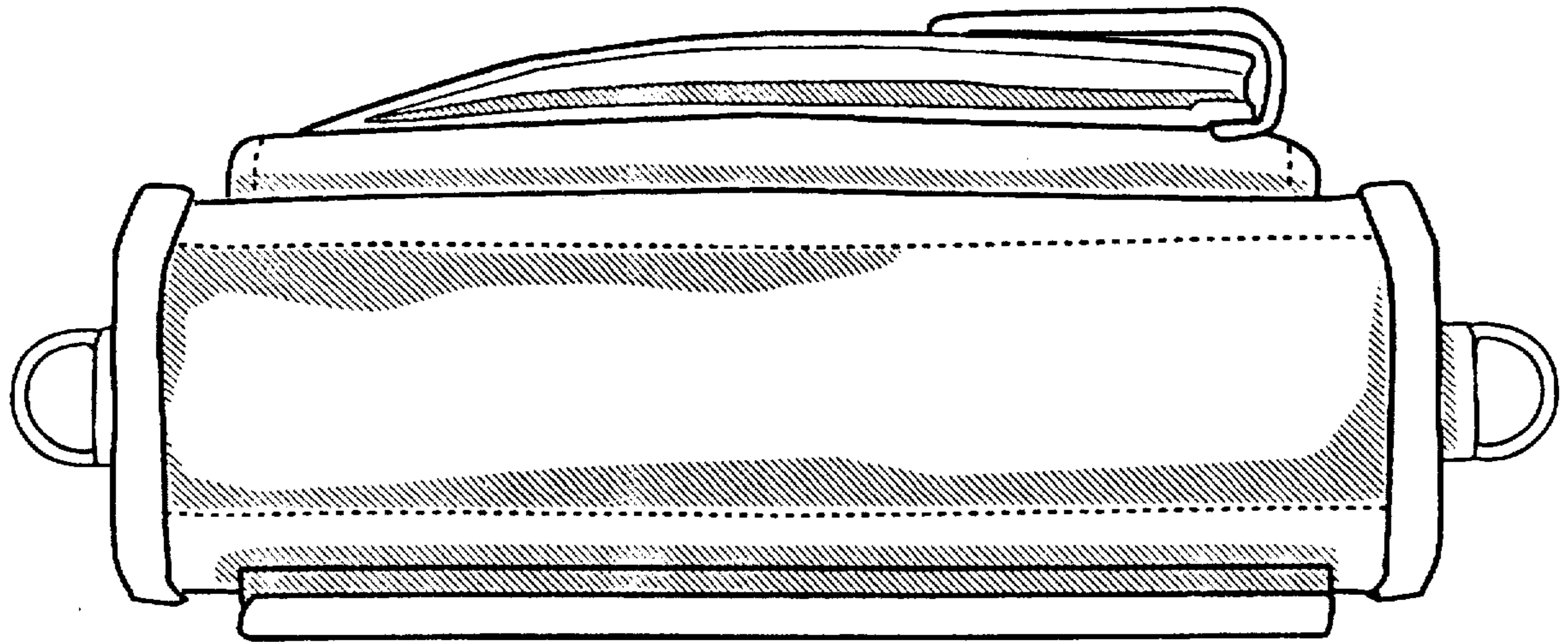

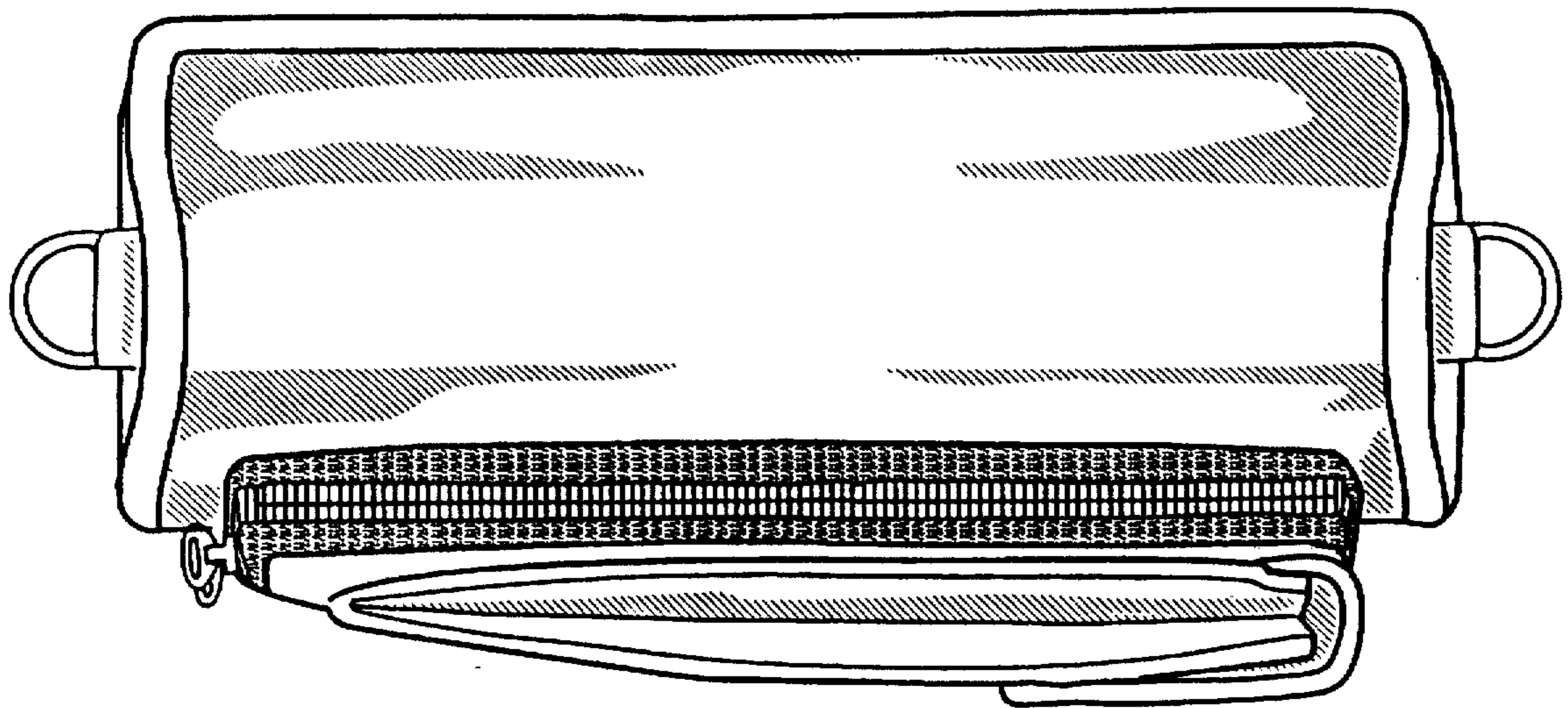

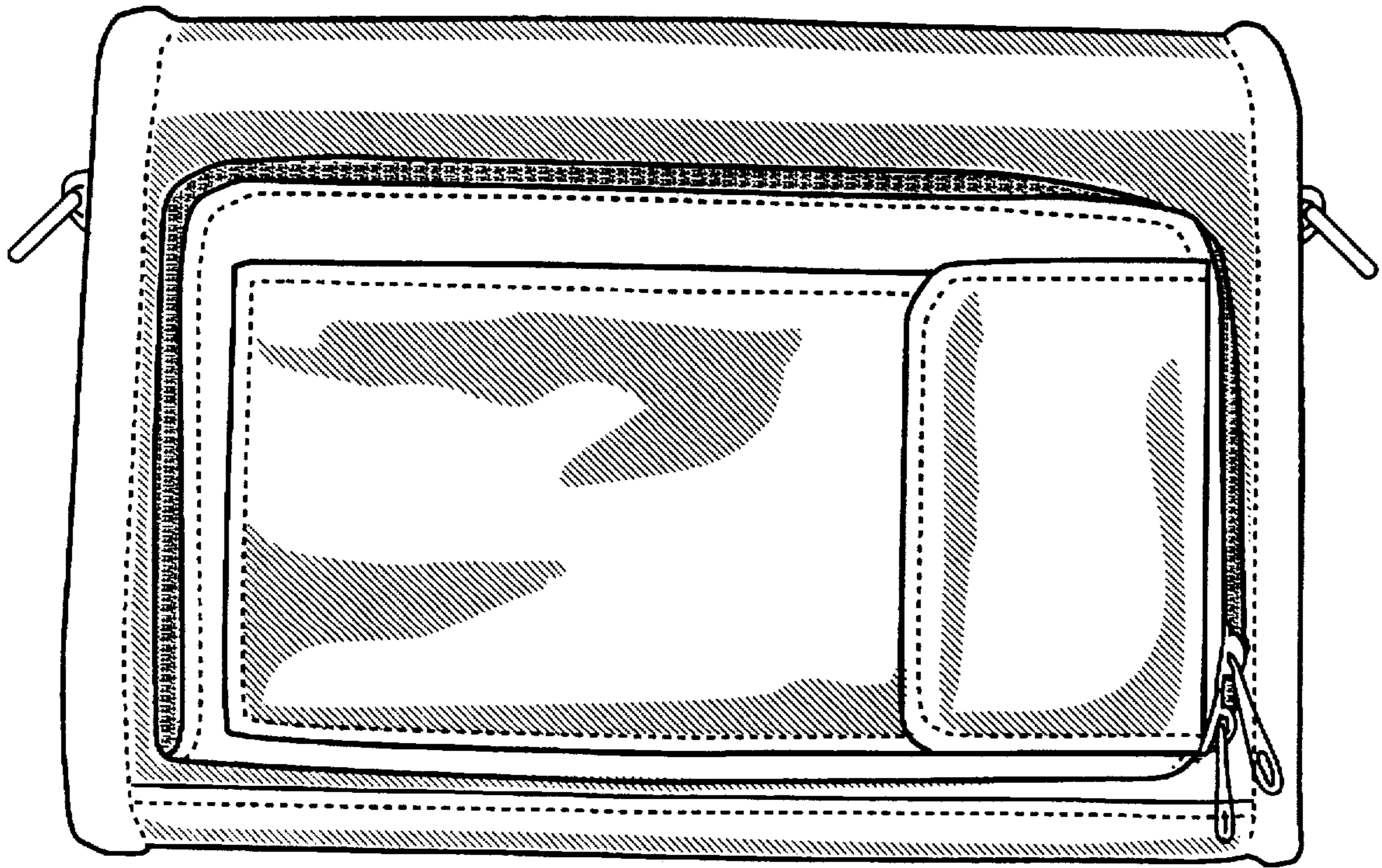

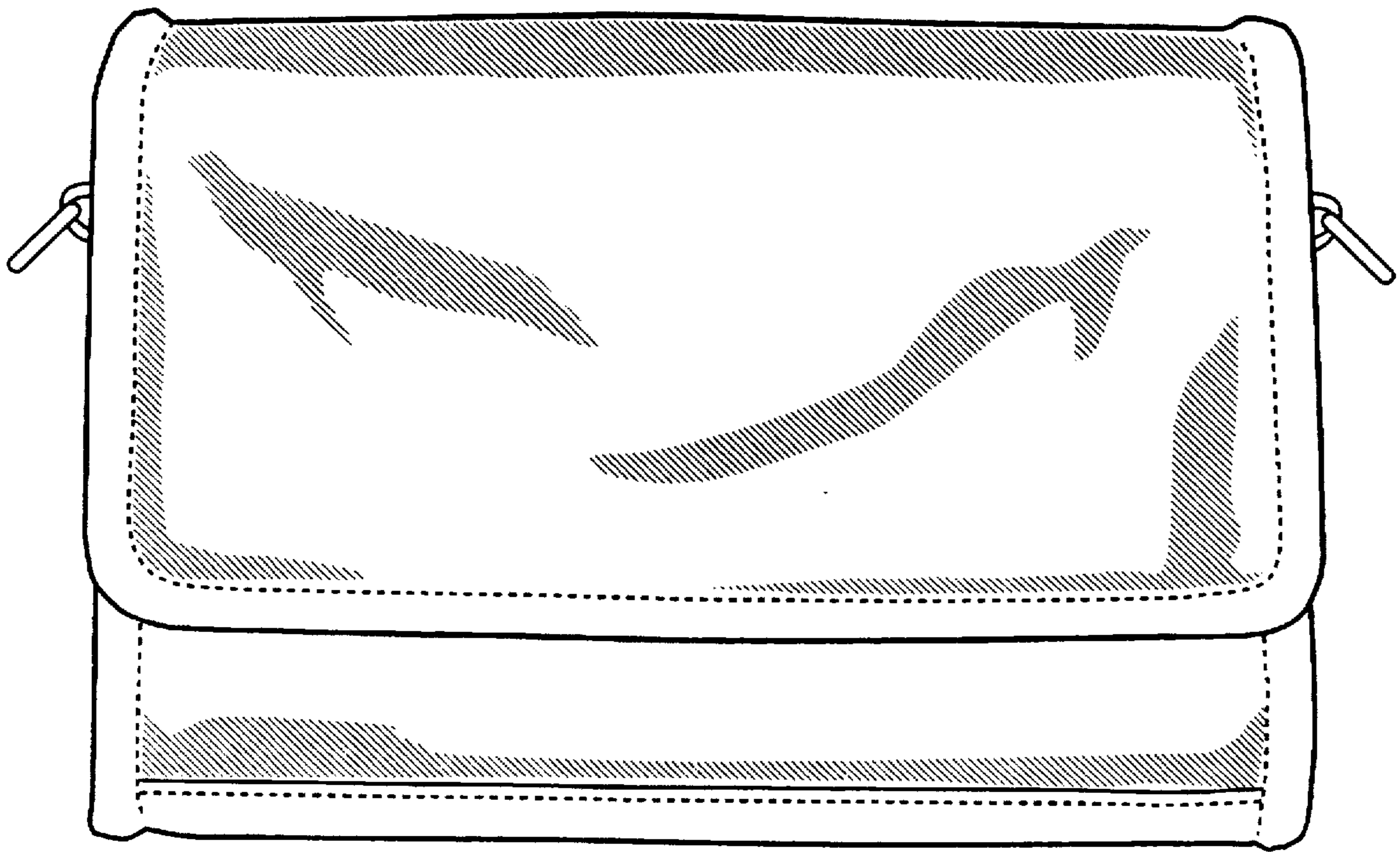

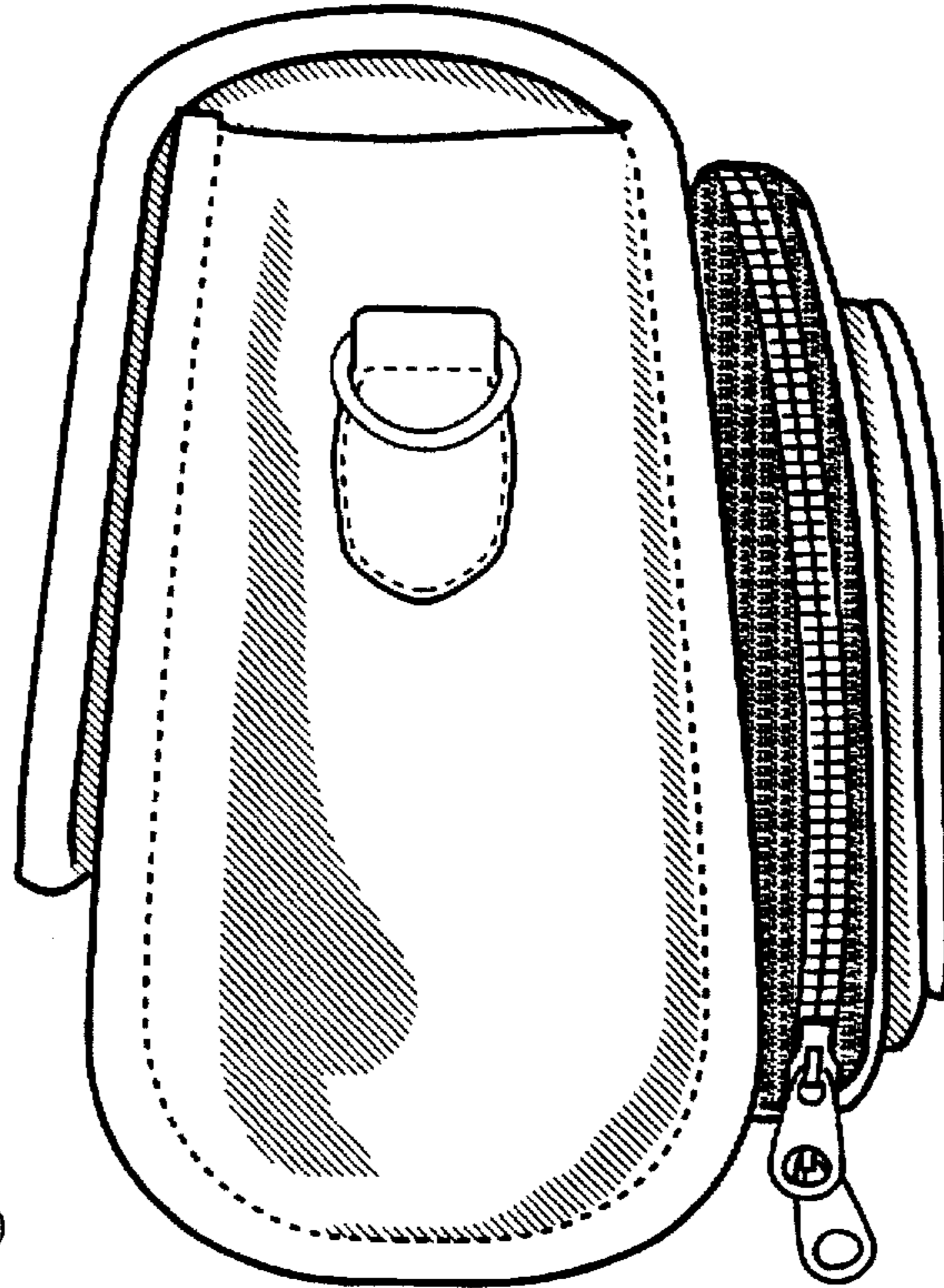

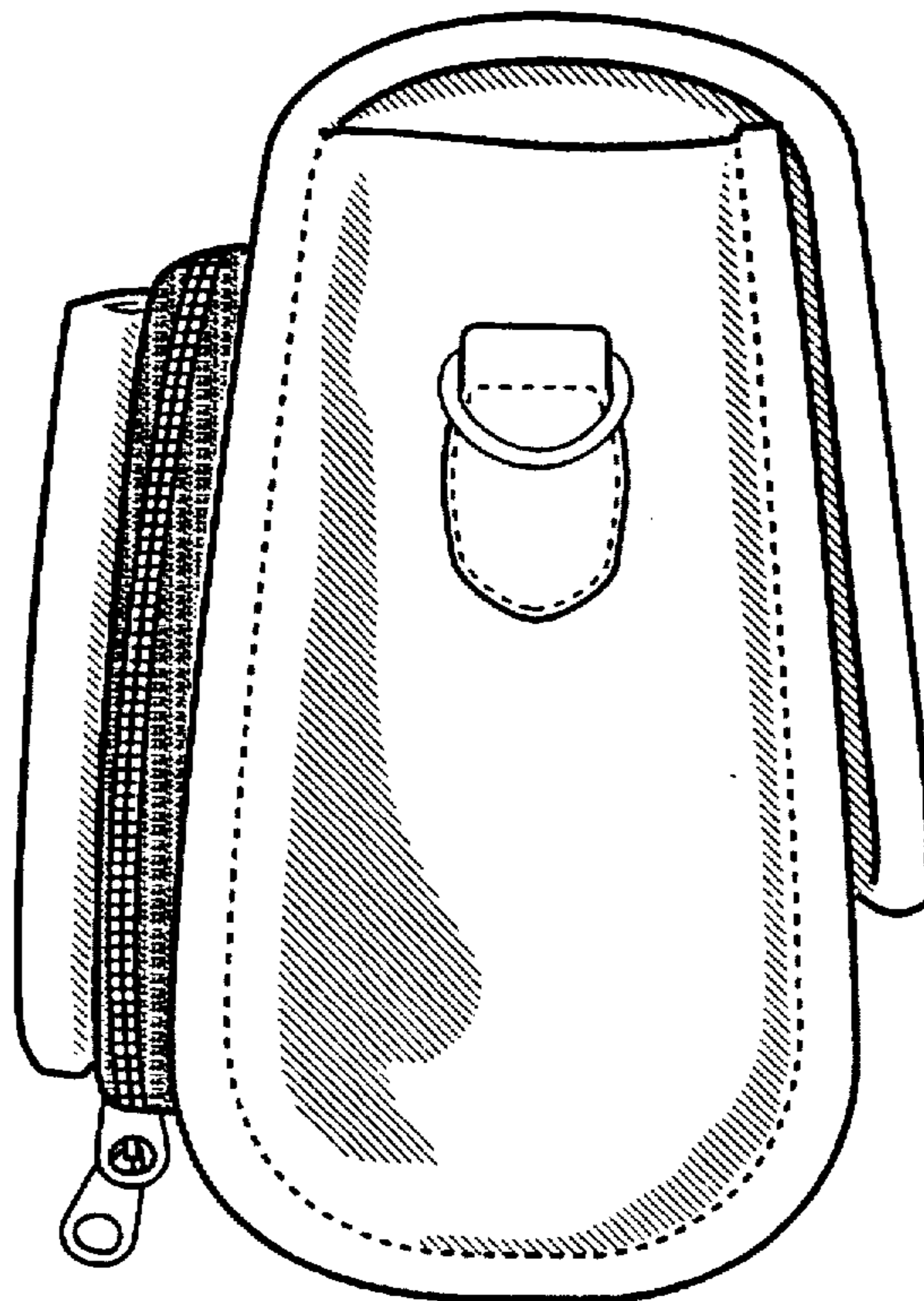
