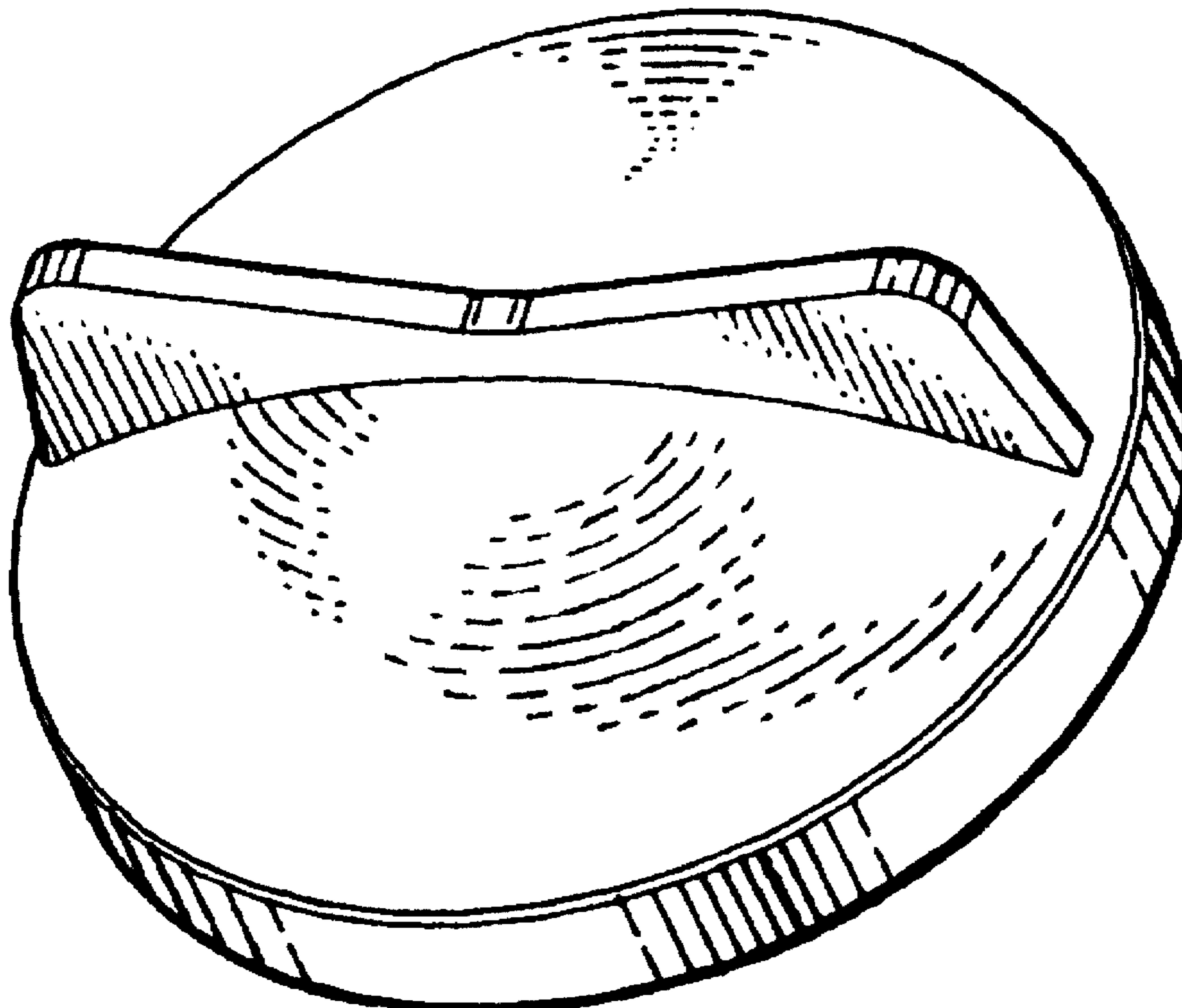

FIG. 1 is a front elevational view of a vehicle hub cap showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a rear elevational view thereof;

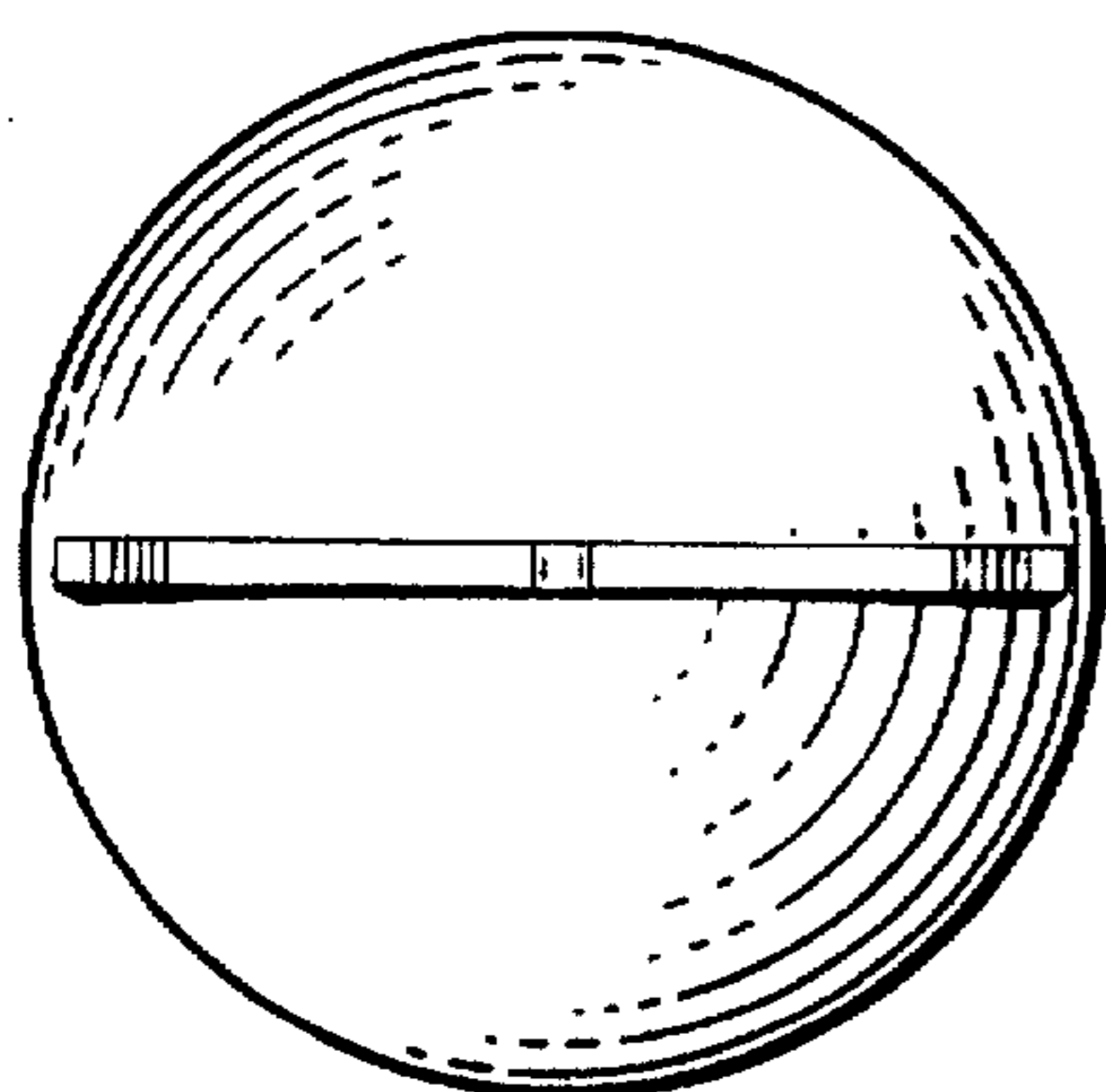

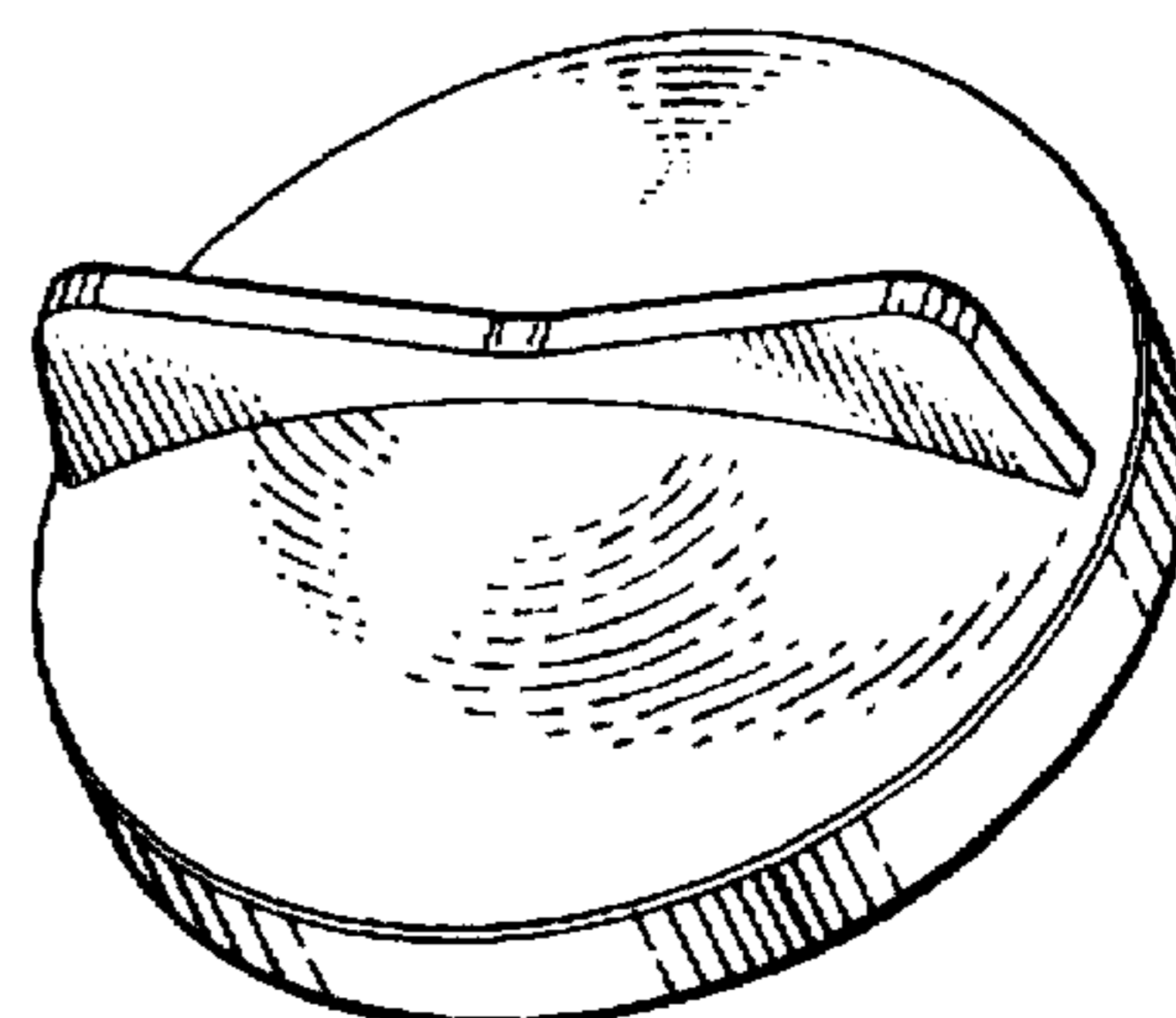

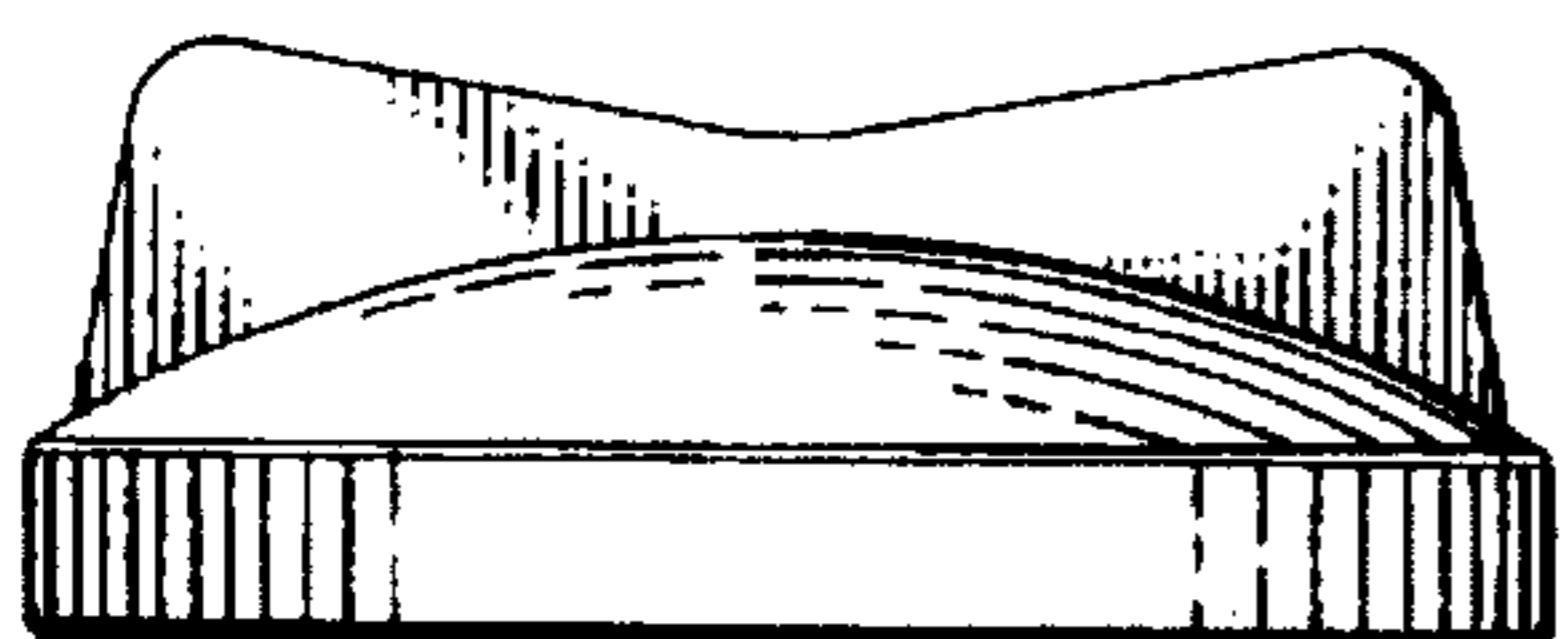

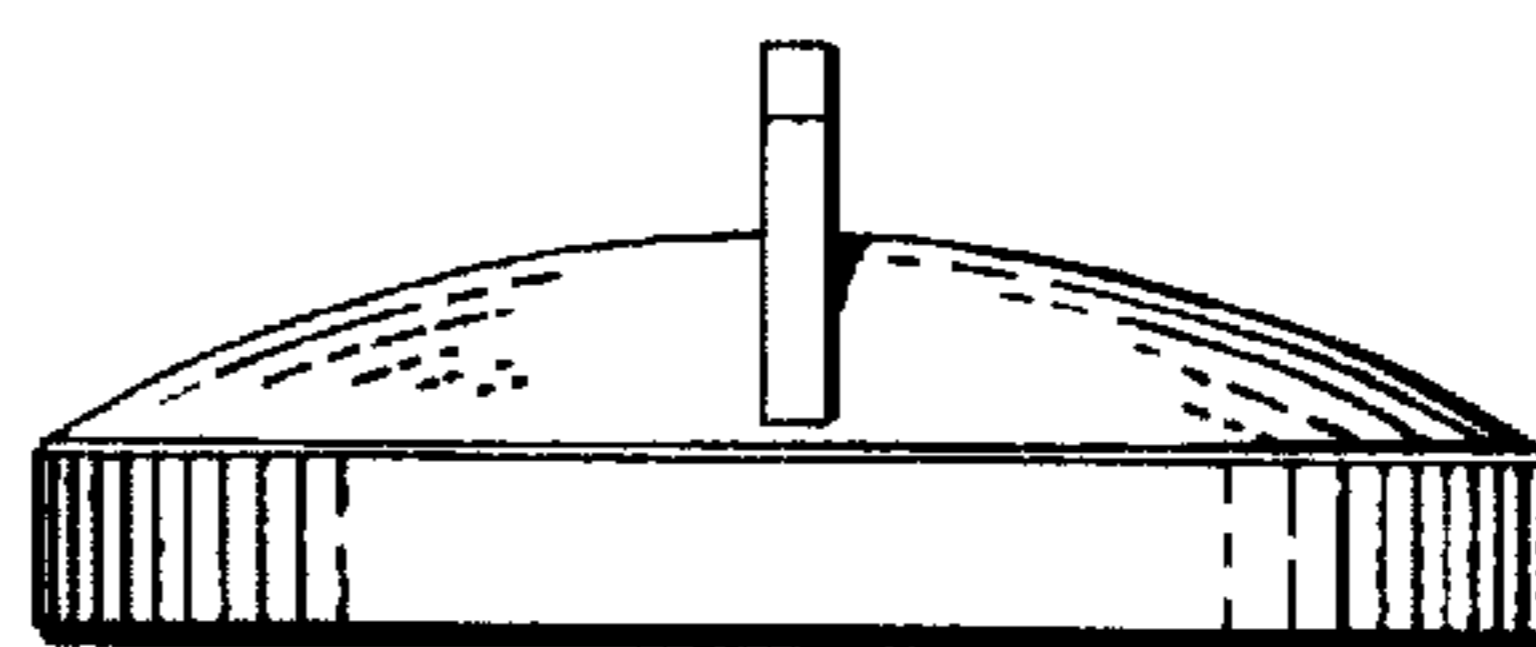

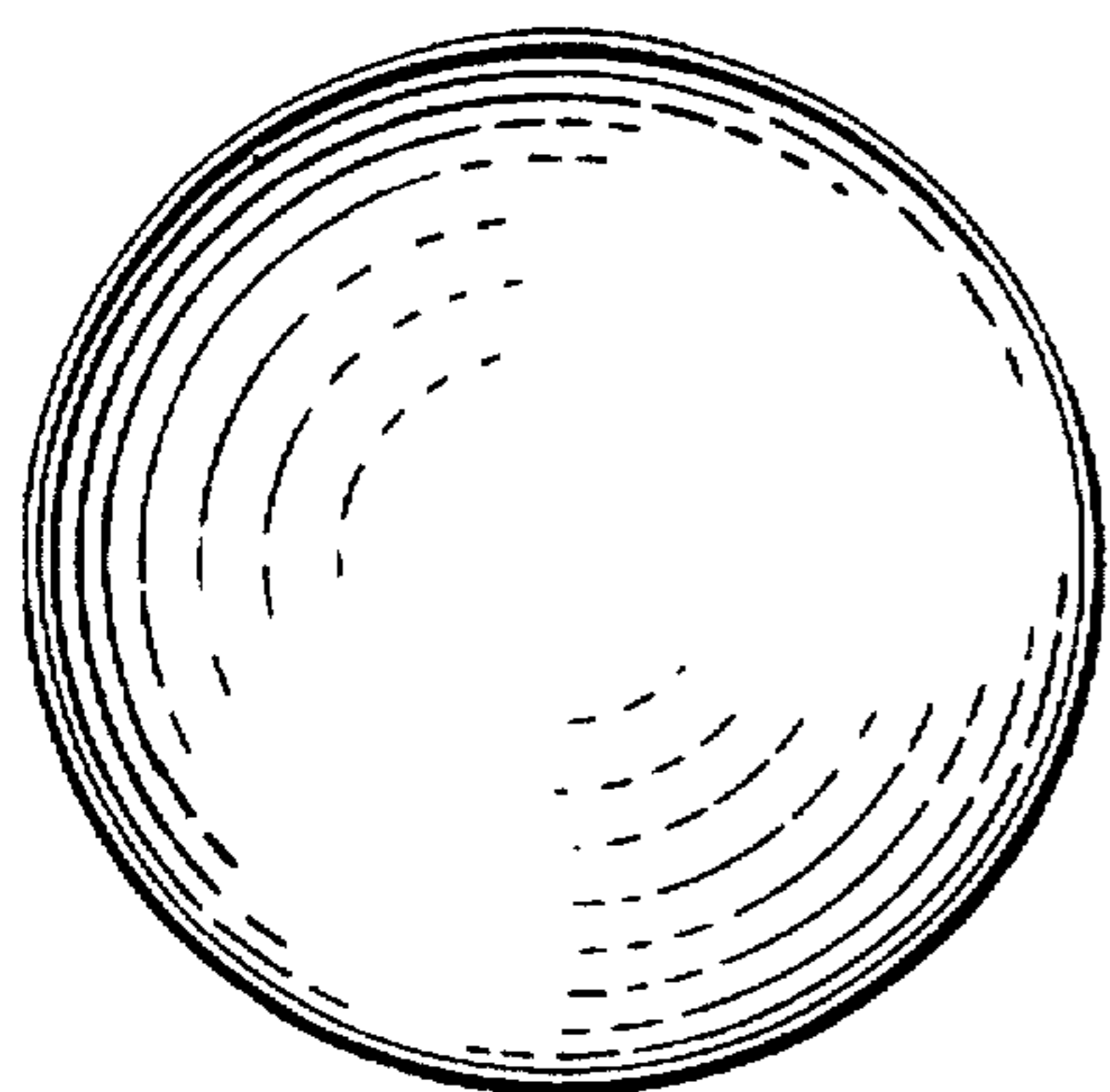

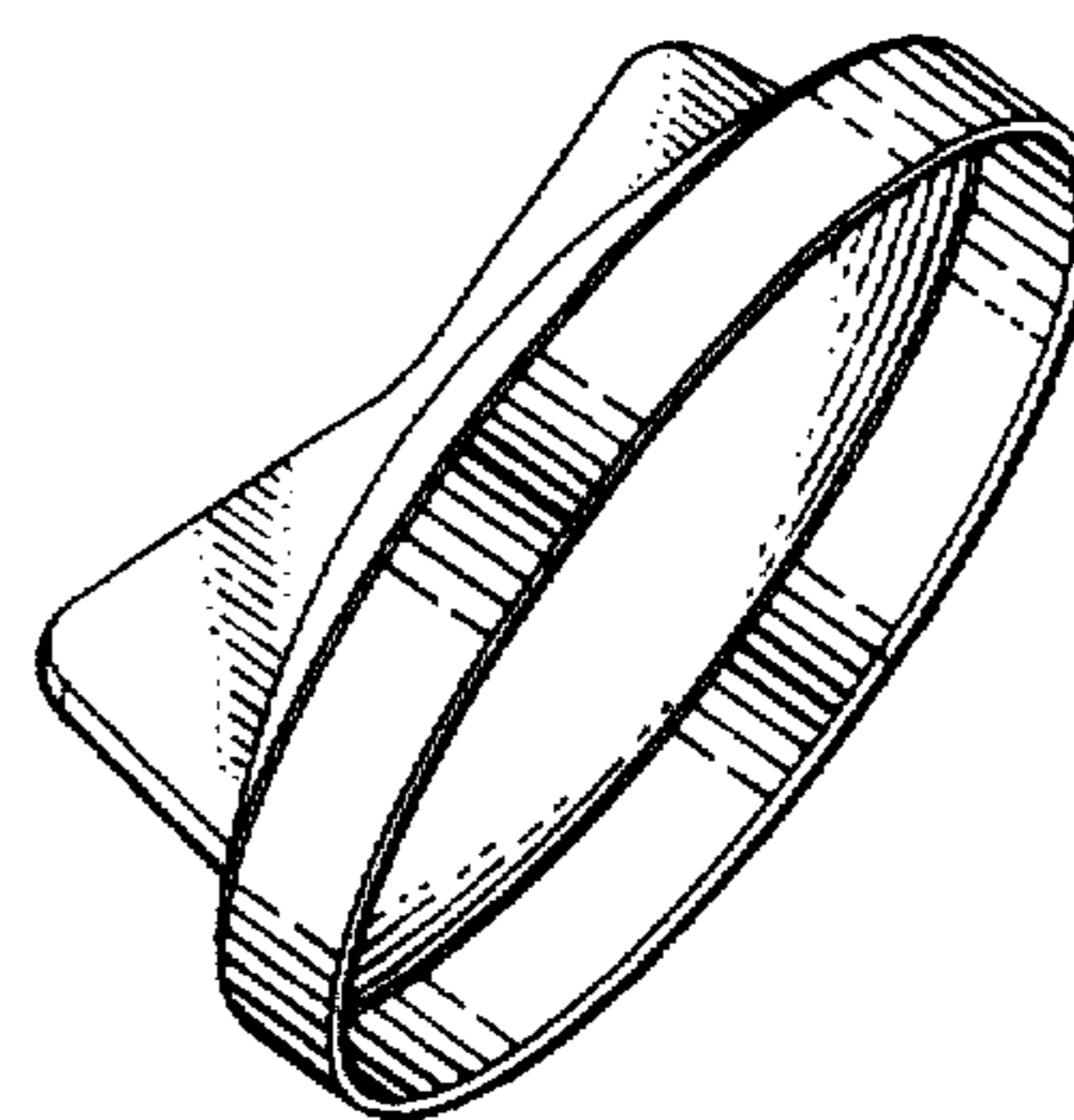
