[57] **CLAIM**

The ornamental design for a combined window wash and trash receptacle, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a combined window wash and trash receptacle showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a side elevation view thereof looking from the left of FIG. 3;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a perspective view of another embodiment of a combined window wash and trash receptacle showing my new design;

FIG. 7 is a top plan view of FIG. 6;

FIG. 8 is a front elevation view of FIG. 6; and,

FIG. 9 is a side elevation view of FIG. 6.

The side elevation looking from the right of FIG. 3 is a mirror image of FIG. 4. The bottom of the receptacle of FIG. 1 is plain.

The rear elevation of the receptacle of FIG. 6 is identical to FIG. 8. The side elevation of the receptacle of FIG. 6 is identical from all sides. The bottom of the receptacle of FIG. 6 is plain.

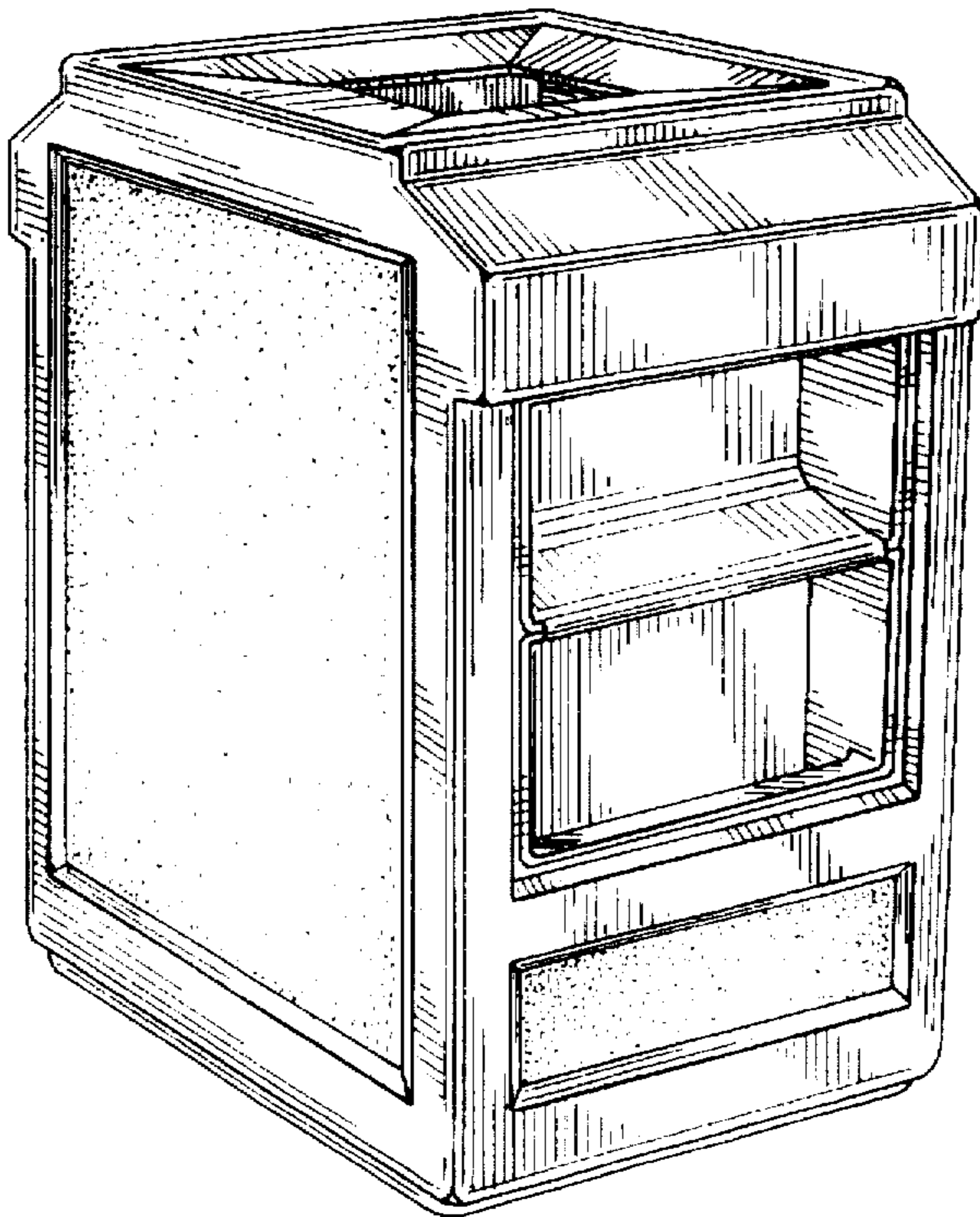
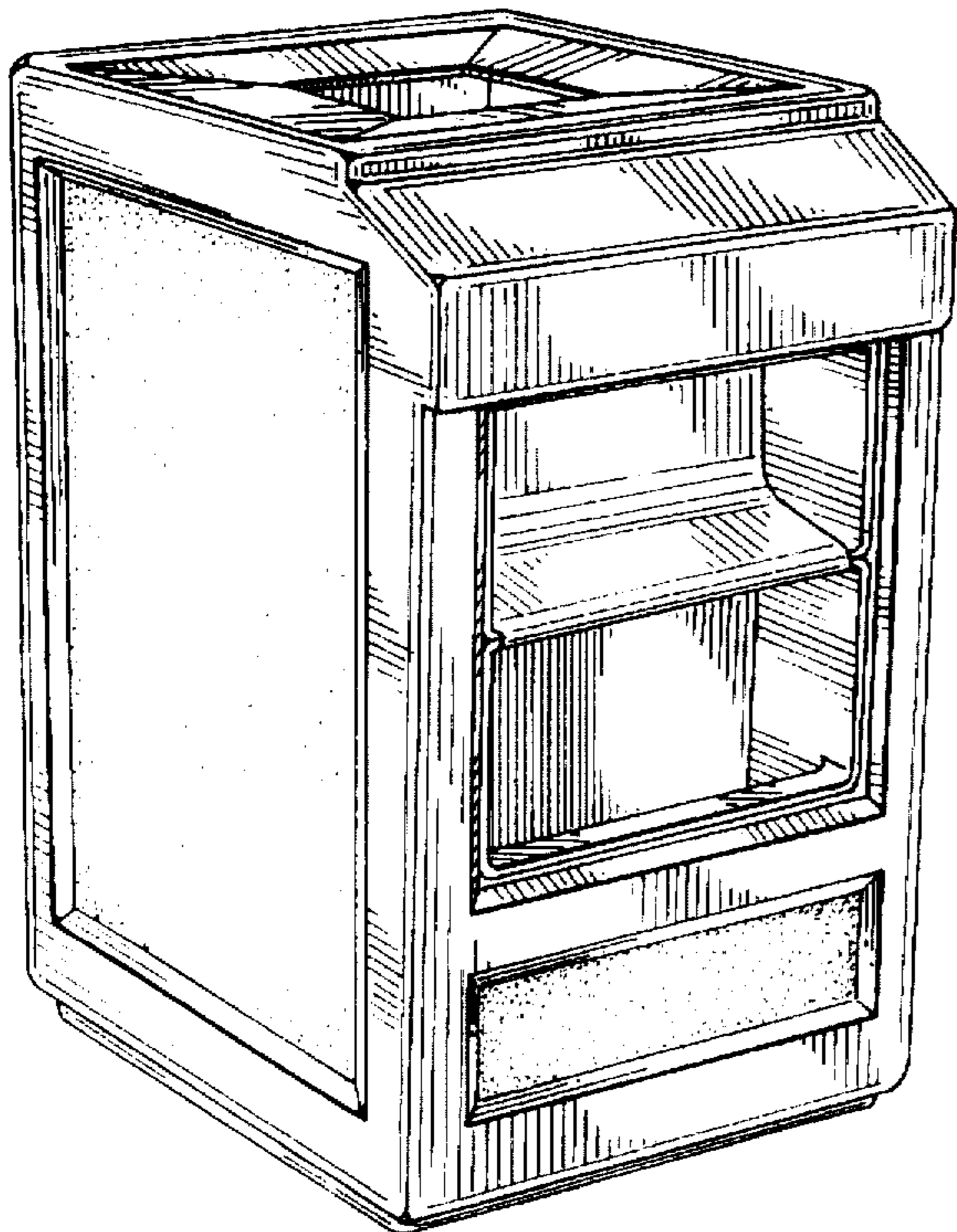

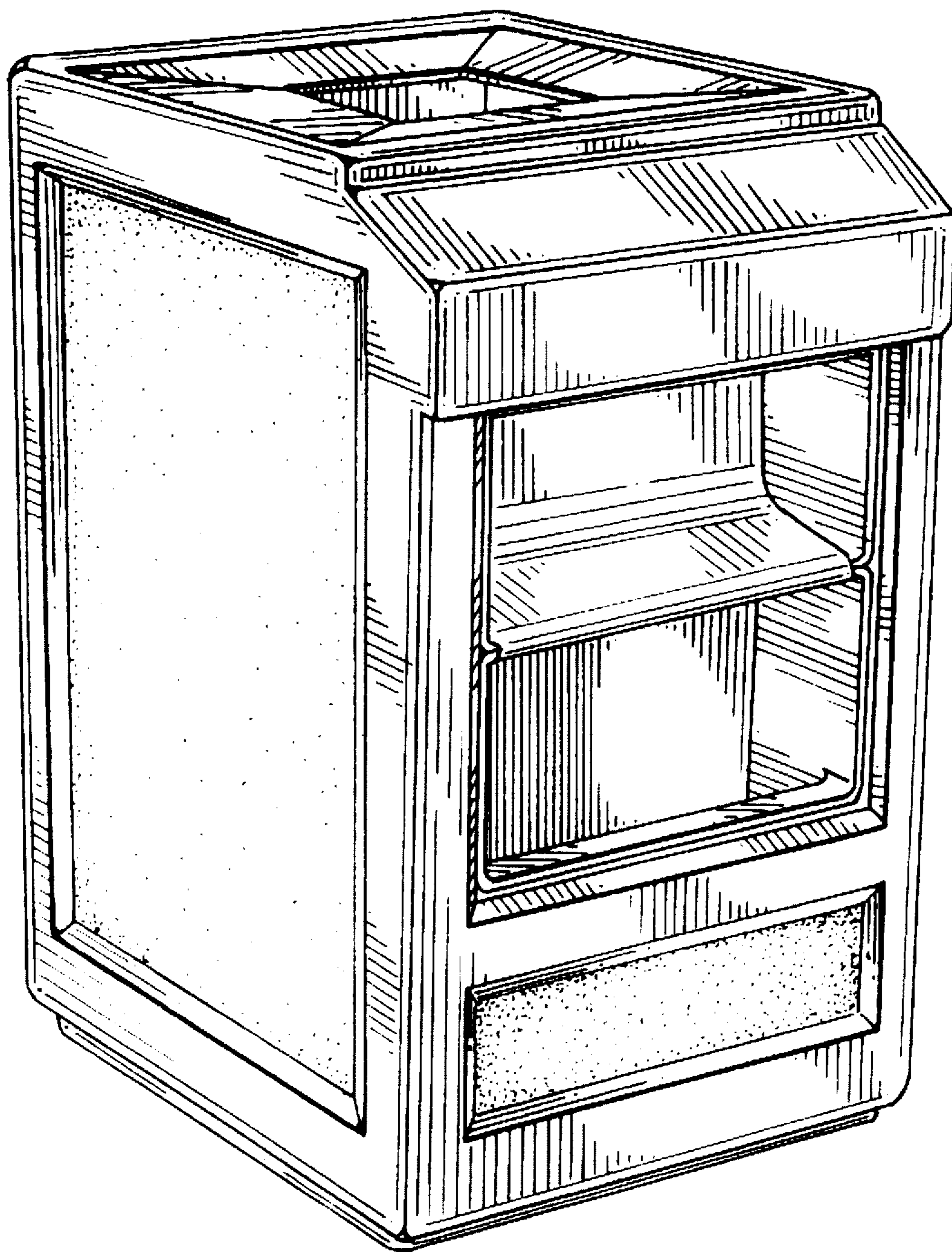

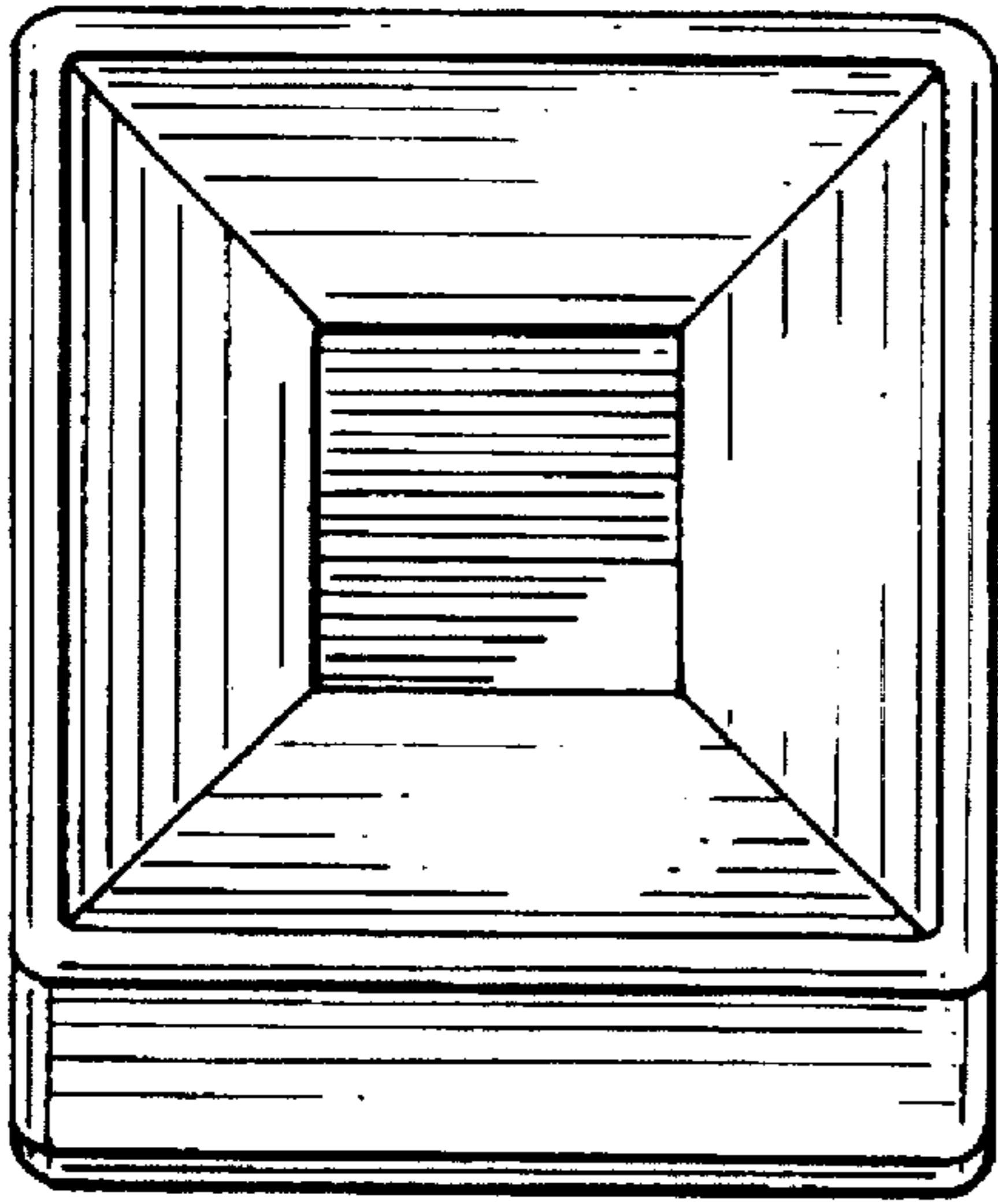

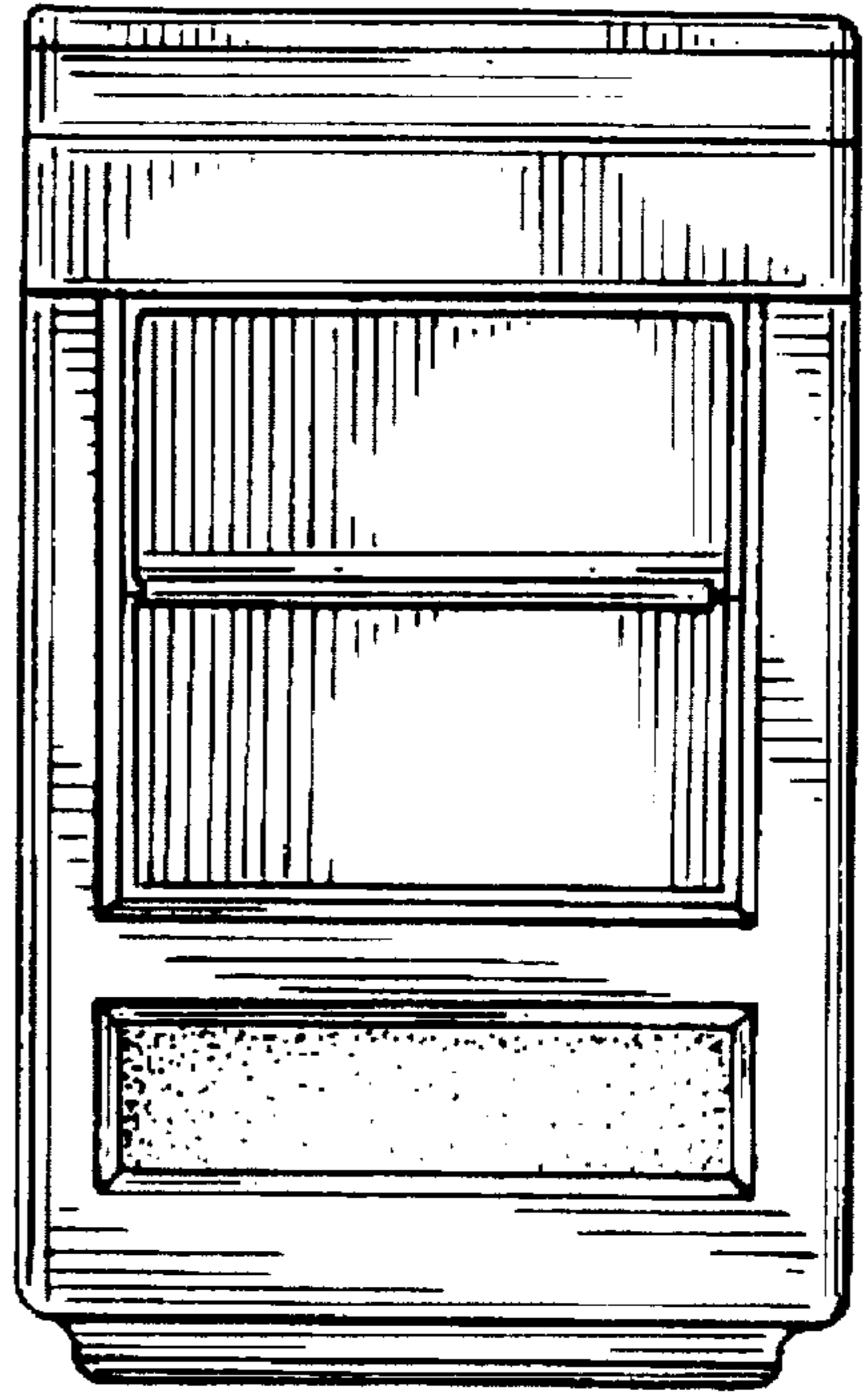

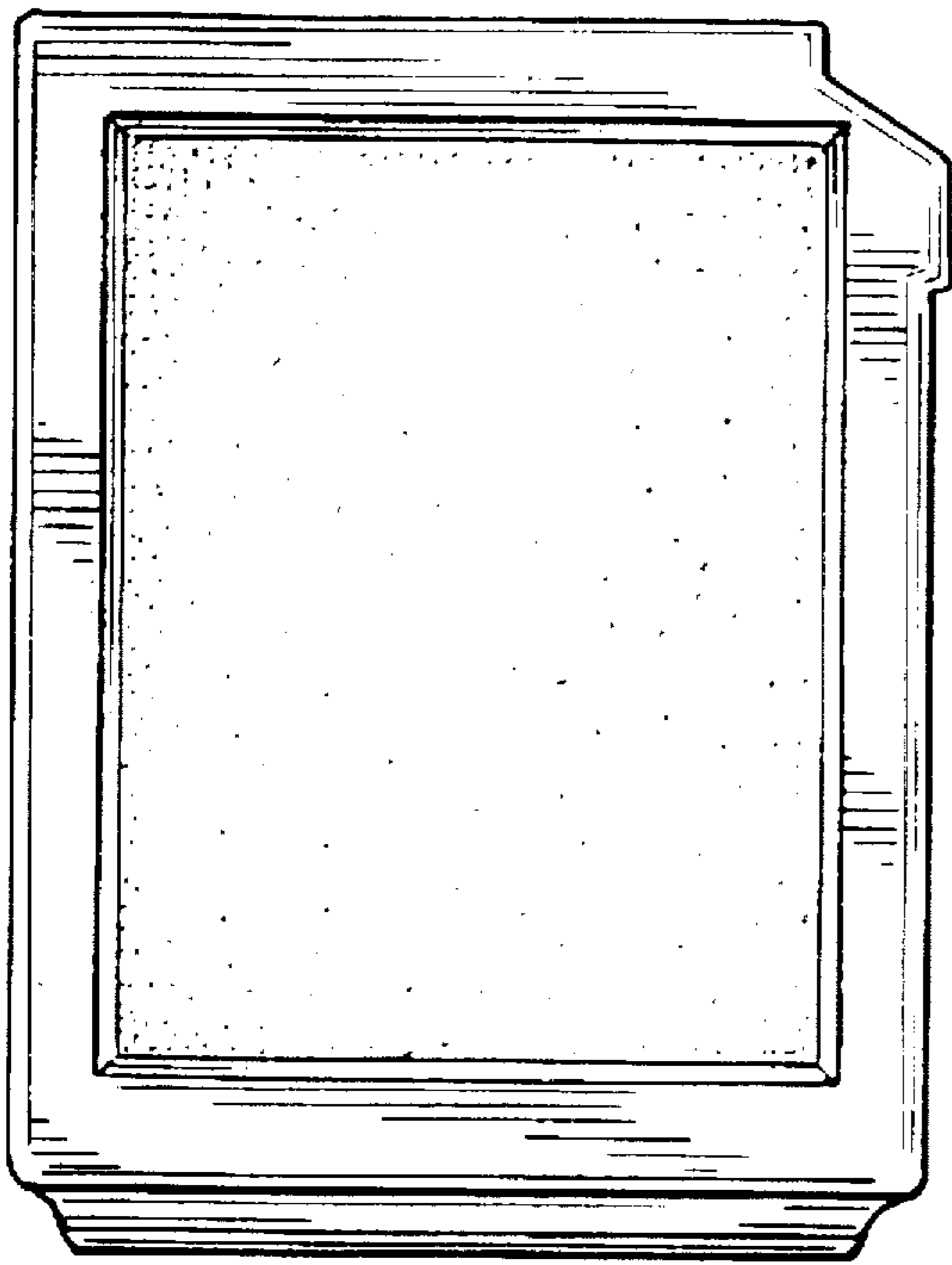

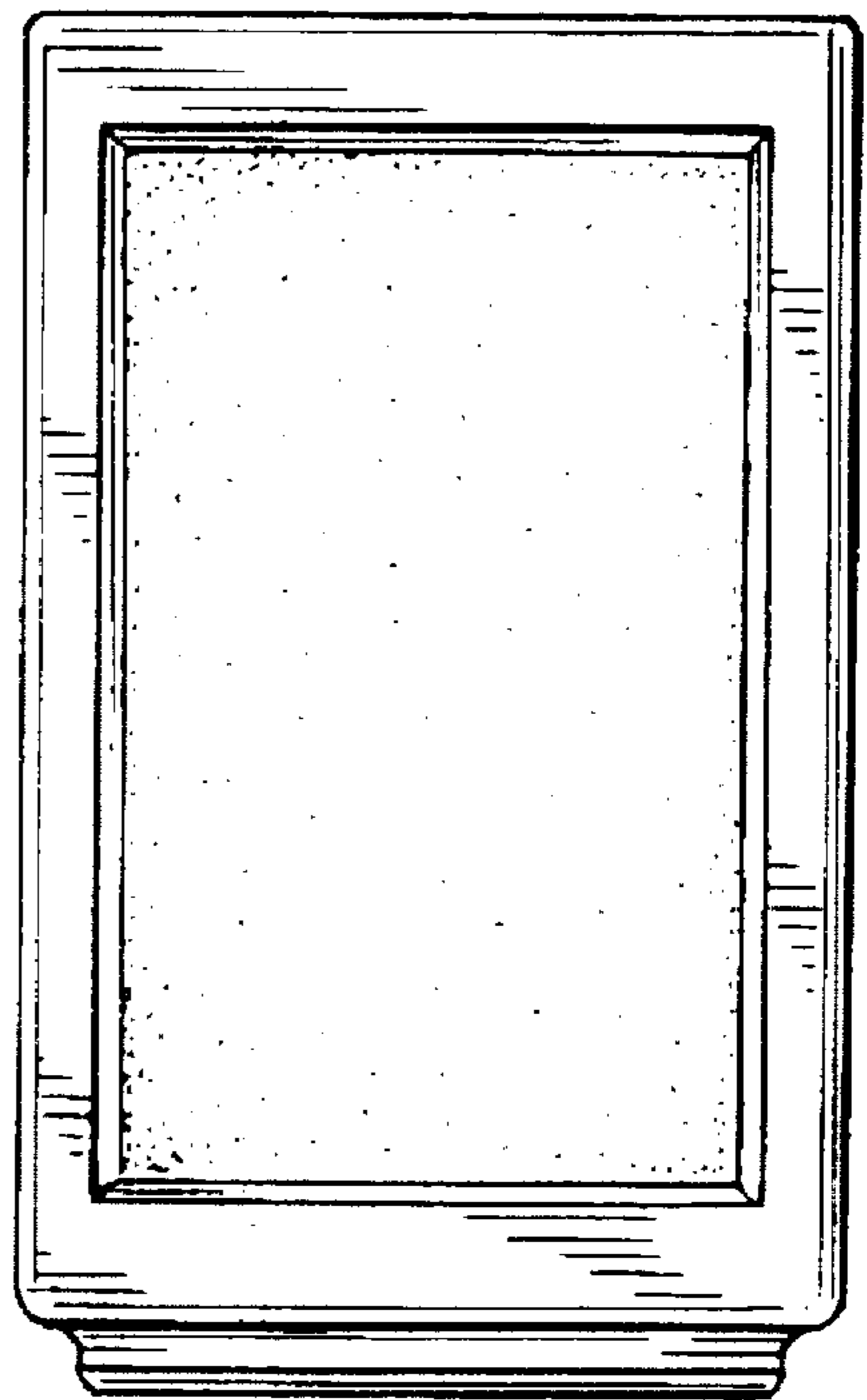

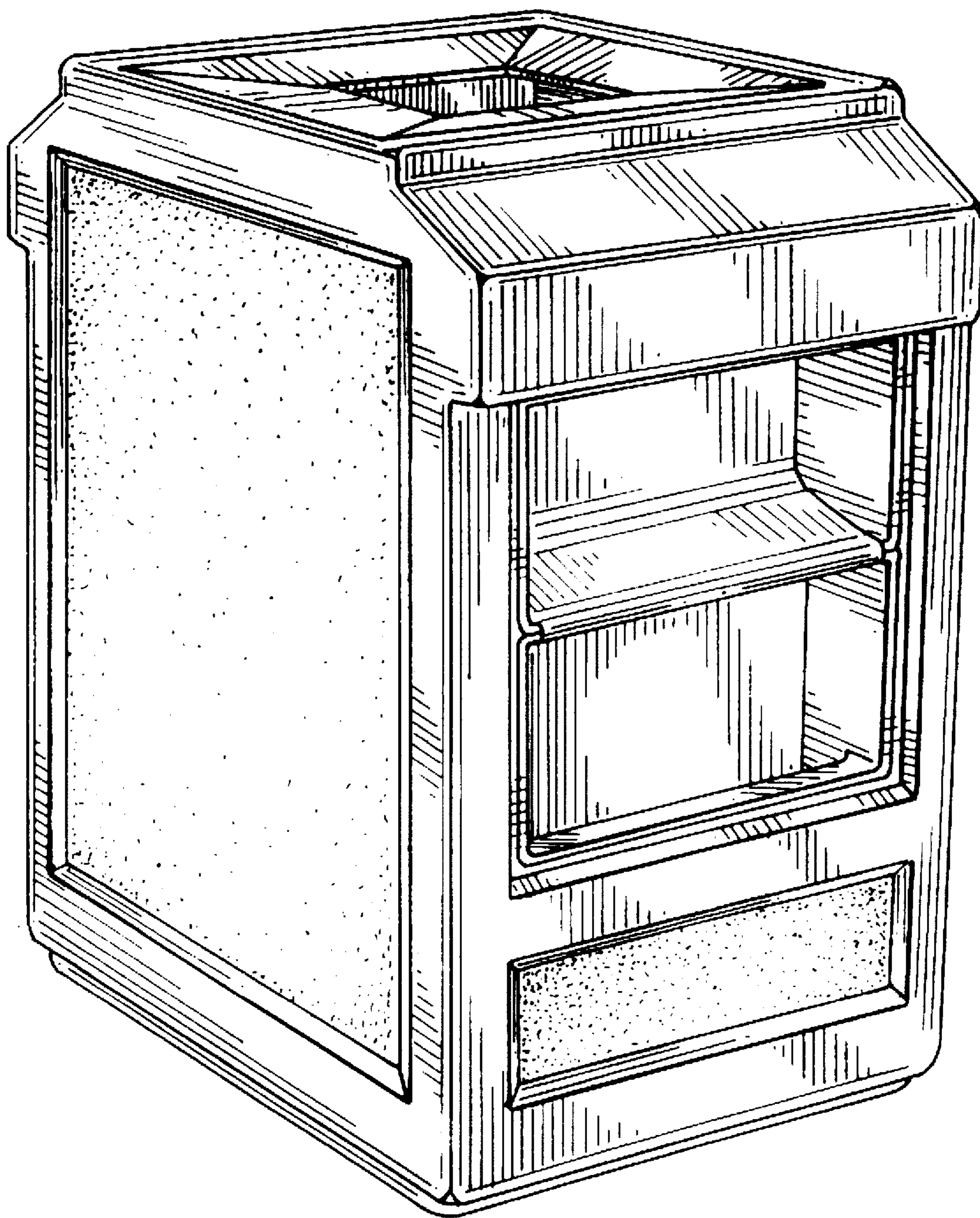

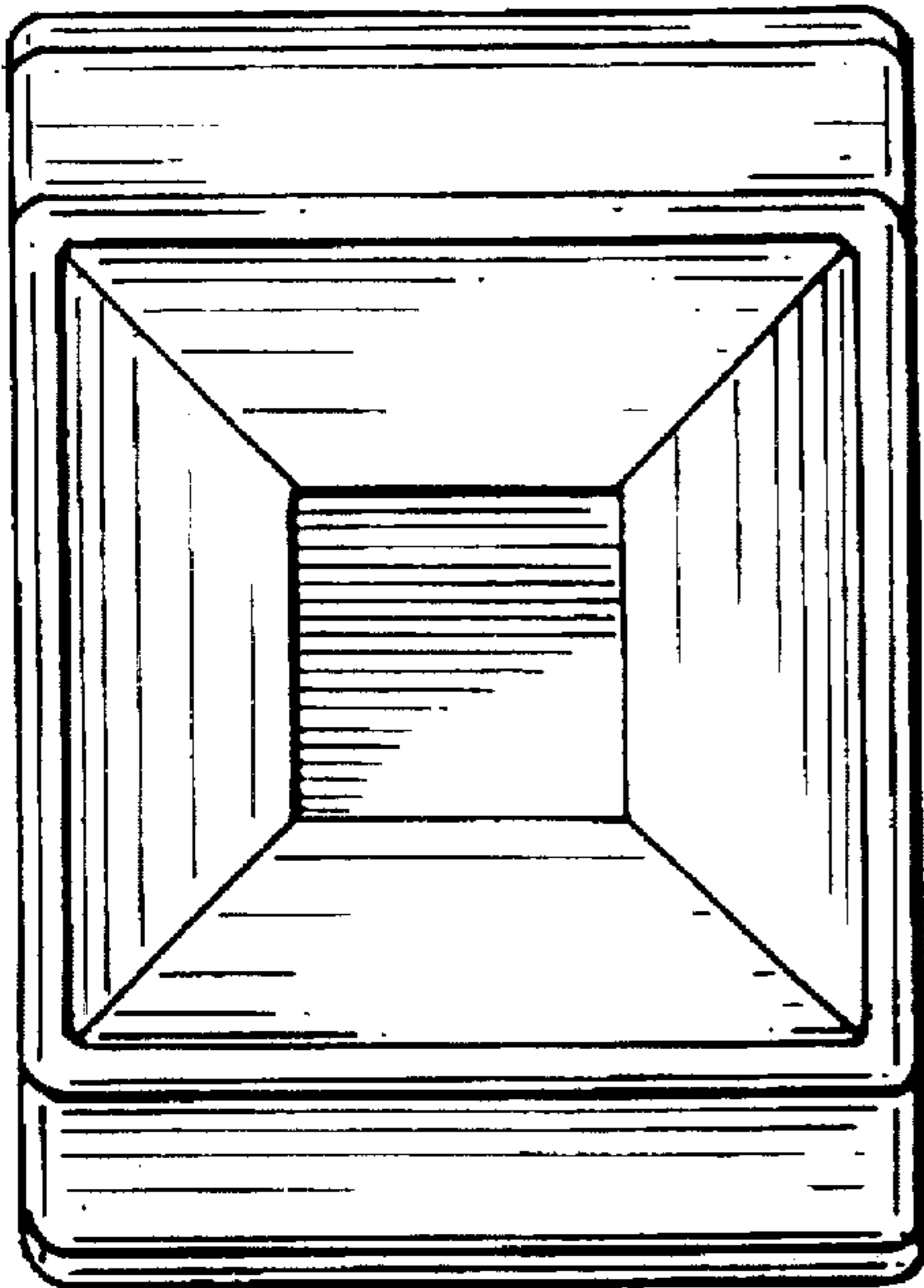

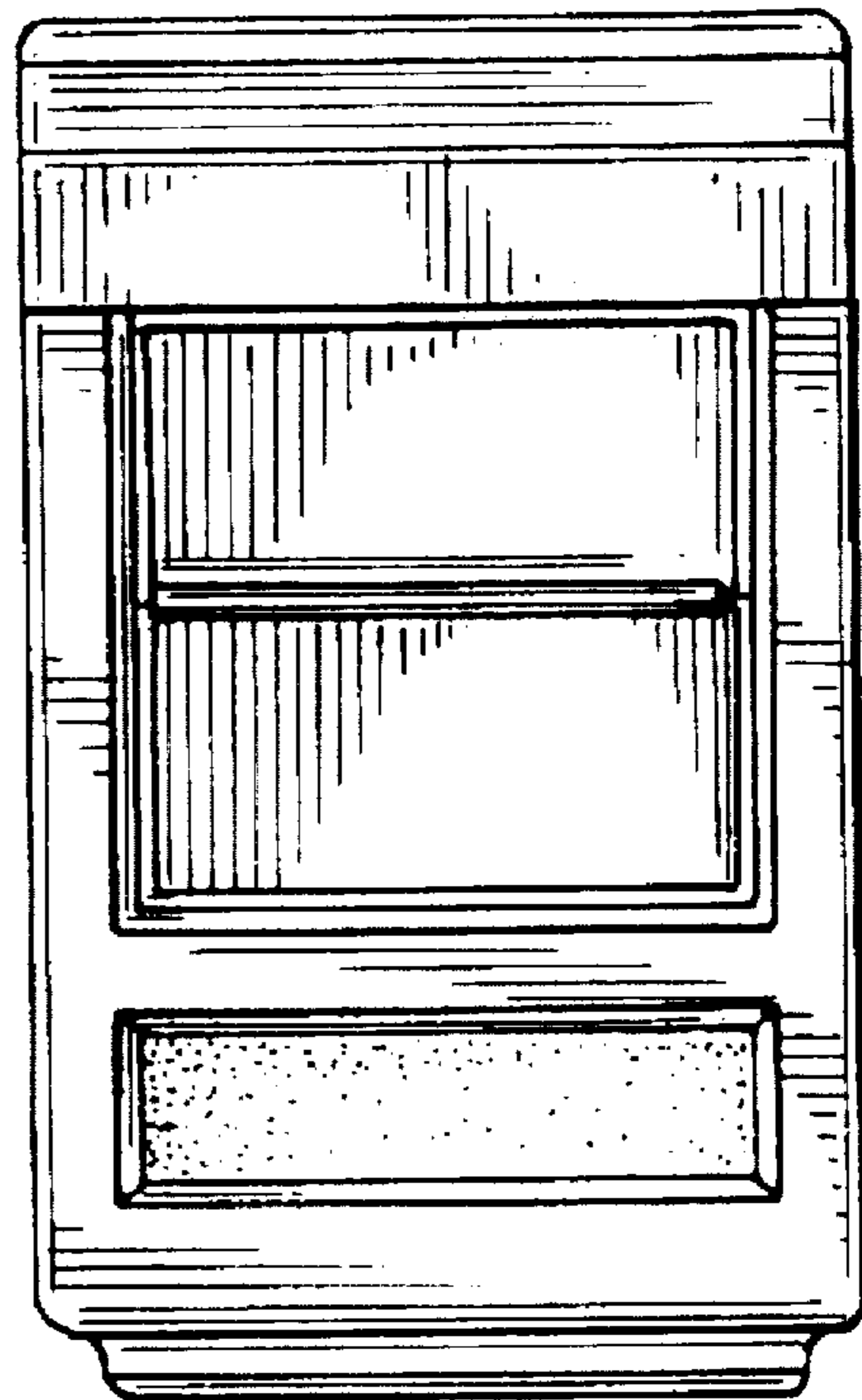
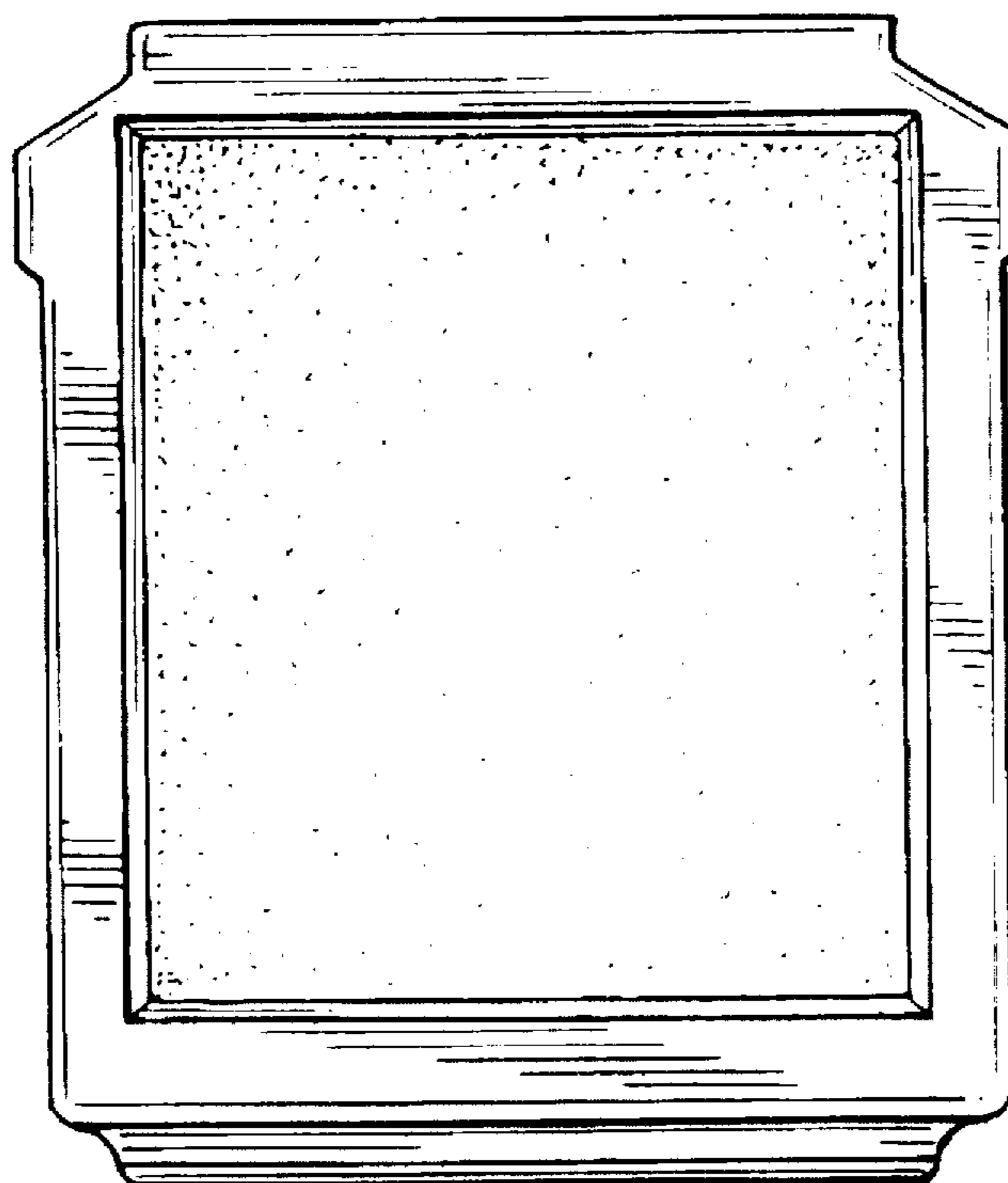
