[57] **CLAIM**

The ornamental design for a pallet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from above one corner of the pallet according to my design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a left elevational view thereof;

FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 2 showing contours of a portion of the interior of the pallet;

FIG. 9 is an enlarged elevational view of an exterior rib that is shown in FIG. 8 of the drawing;

FIG. 10 is a cross-sectional view taken along line 10—10 of FIG. 2 showing contours of another portion of the interior of the pallet;

FIG. 11 is a perspective view taken from above one corner of a second embodiment of a pallet according to my design;

FIG. 12 is a top plan view of the second embodiment;

FIG. 13 is a bottom plan view of the second embodiment;

FIG. 14 is a front elevational view of the second embodiment;

FIG. 15 is a right elevational view of the second embodiment;

FIG. 16 is a rear elevational view of the second embodiment;

FIG. 17 is a left elevational view of the second embodiment;

and,

FIG. 18 is a cross-sectional view taken along line 18—18 of FIG. 12 showing contours of a portion of the interior of the second embodiment.

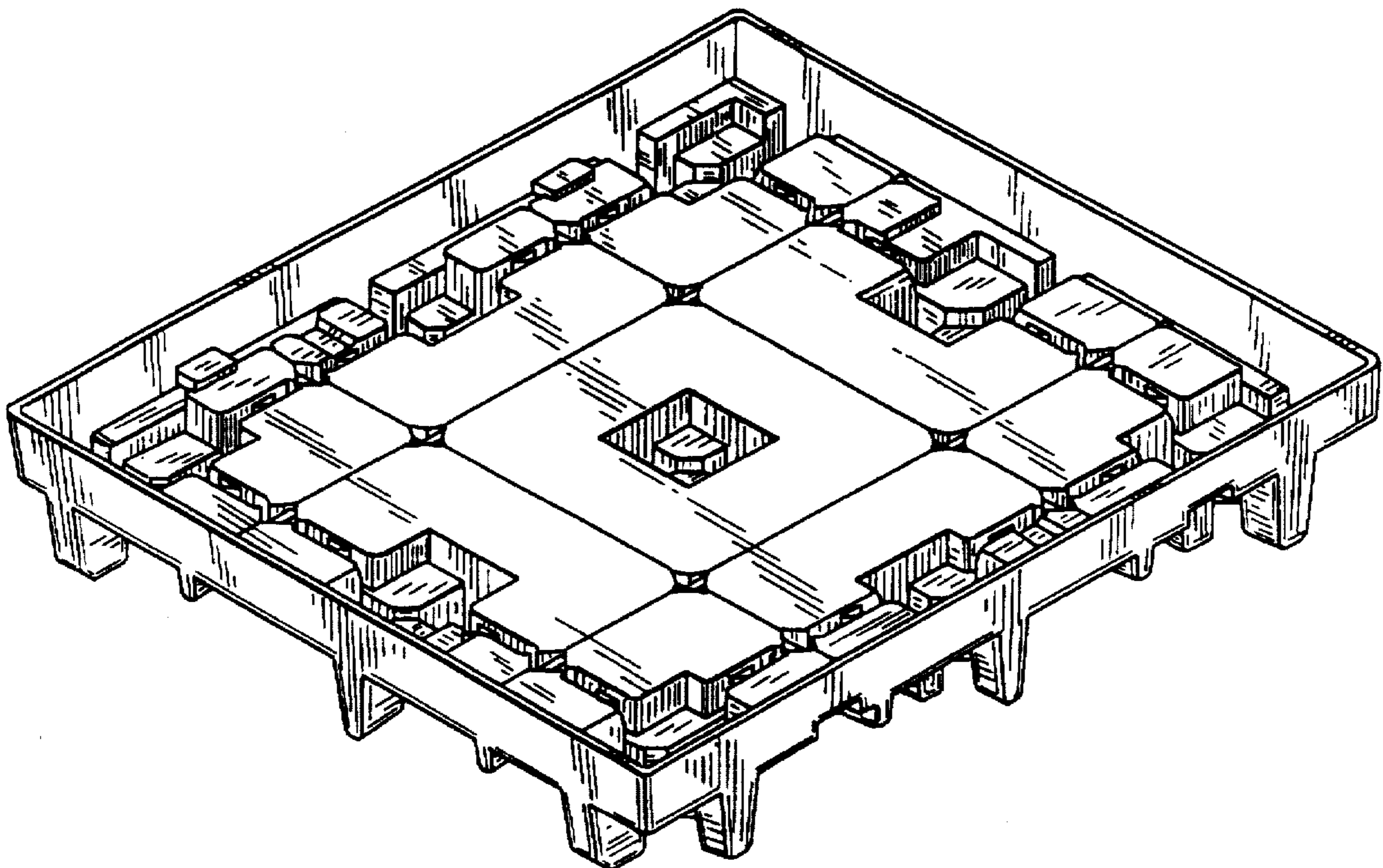

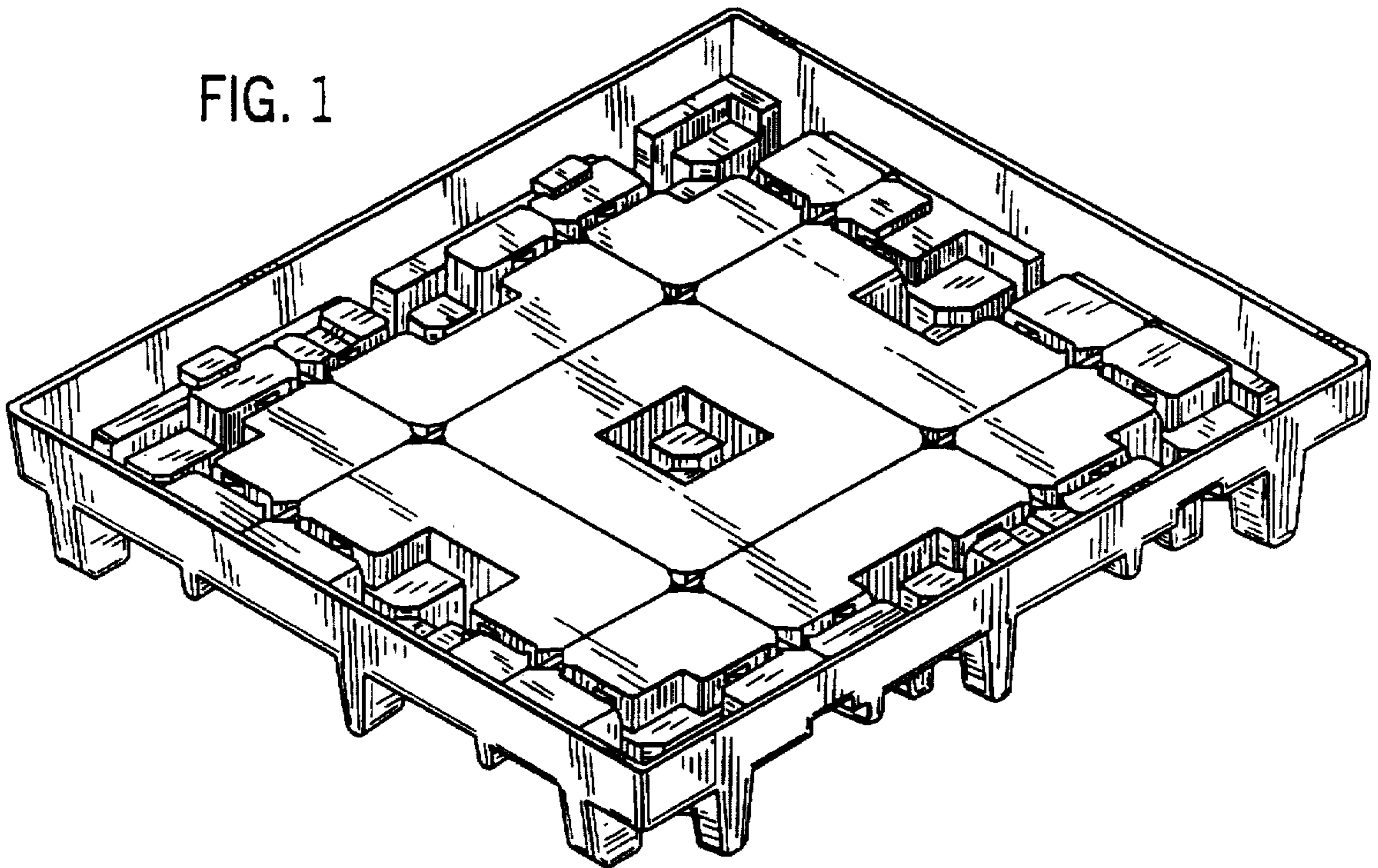

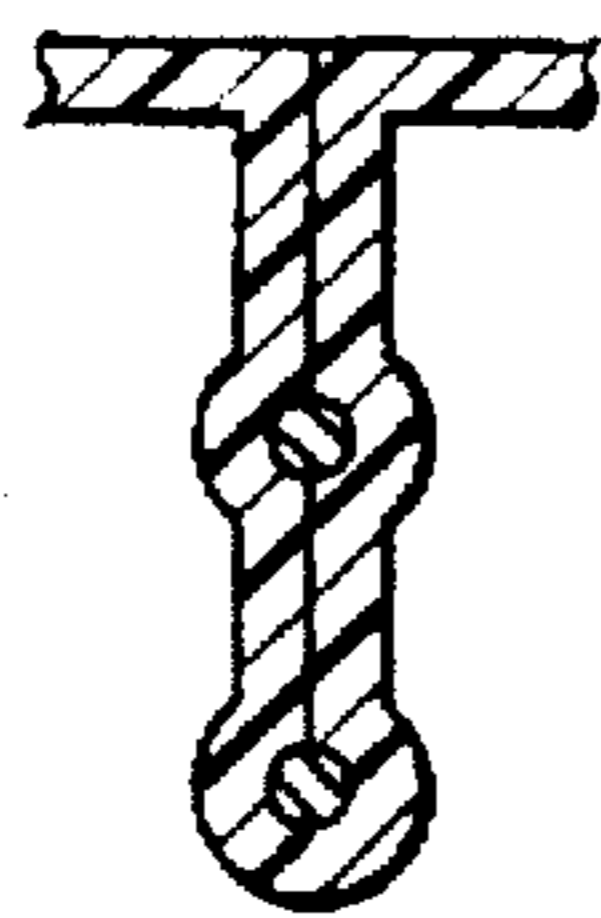

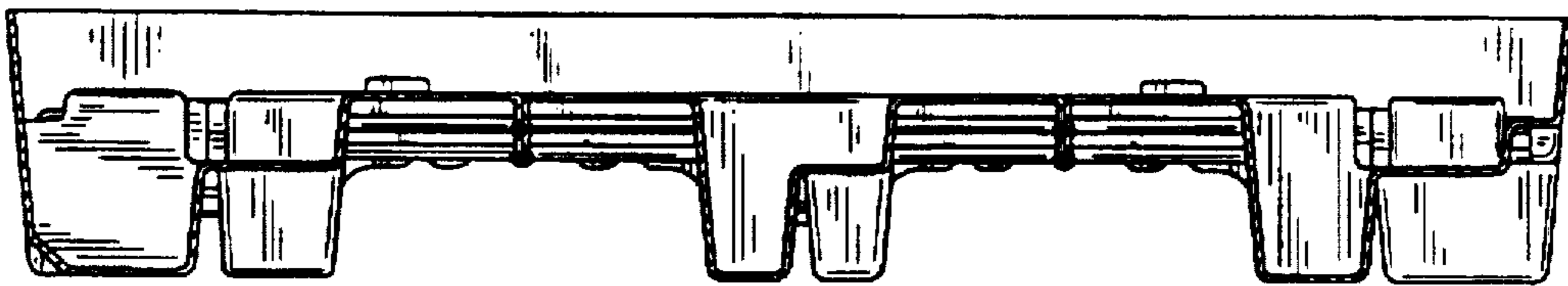

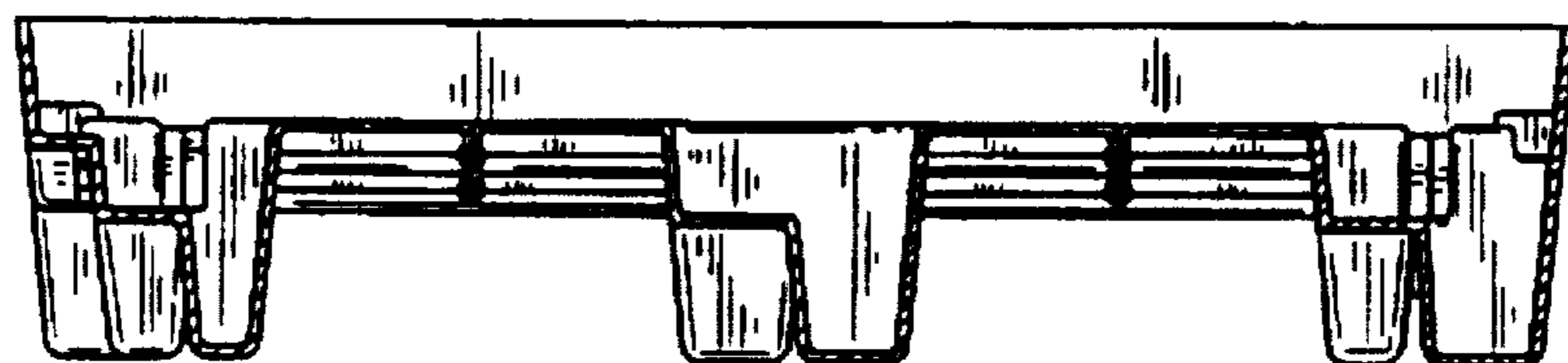

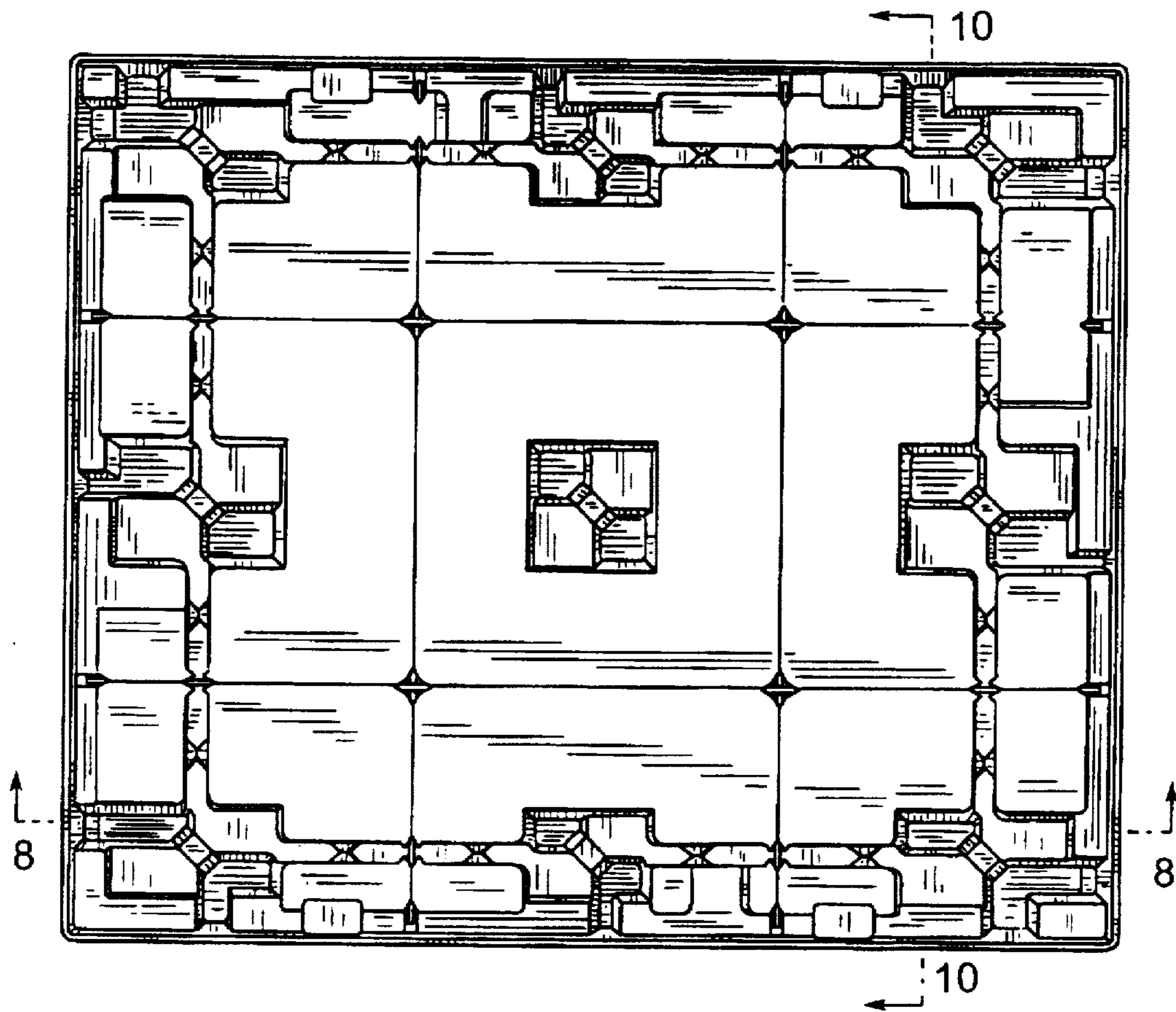

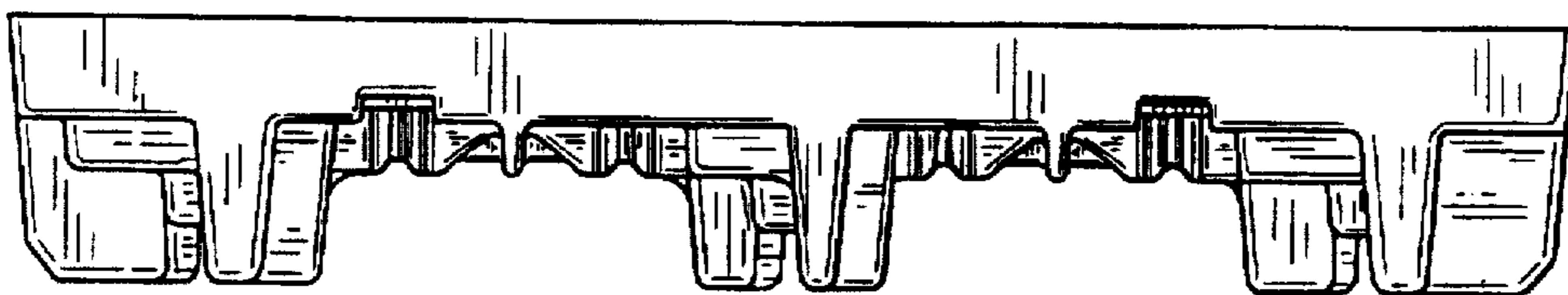

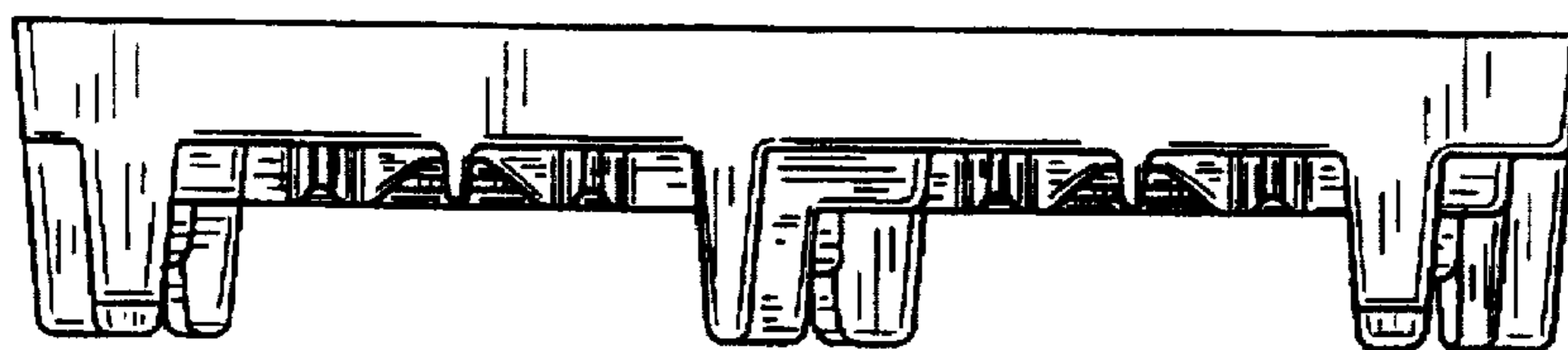

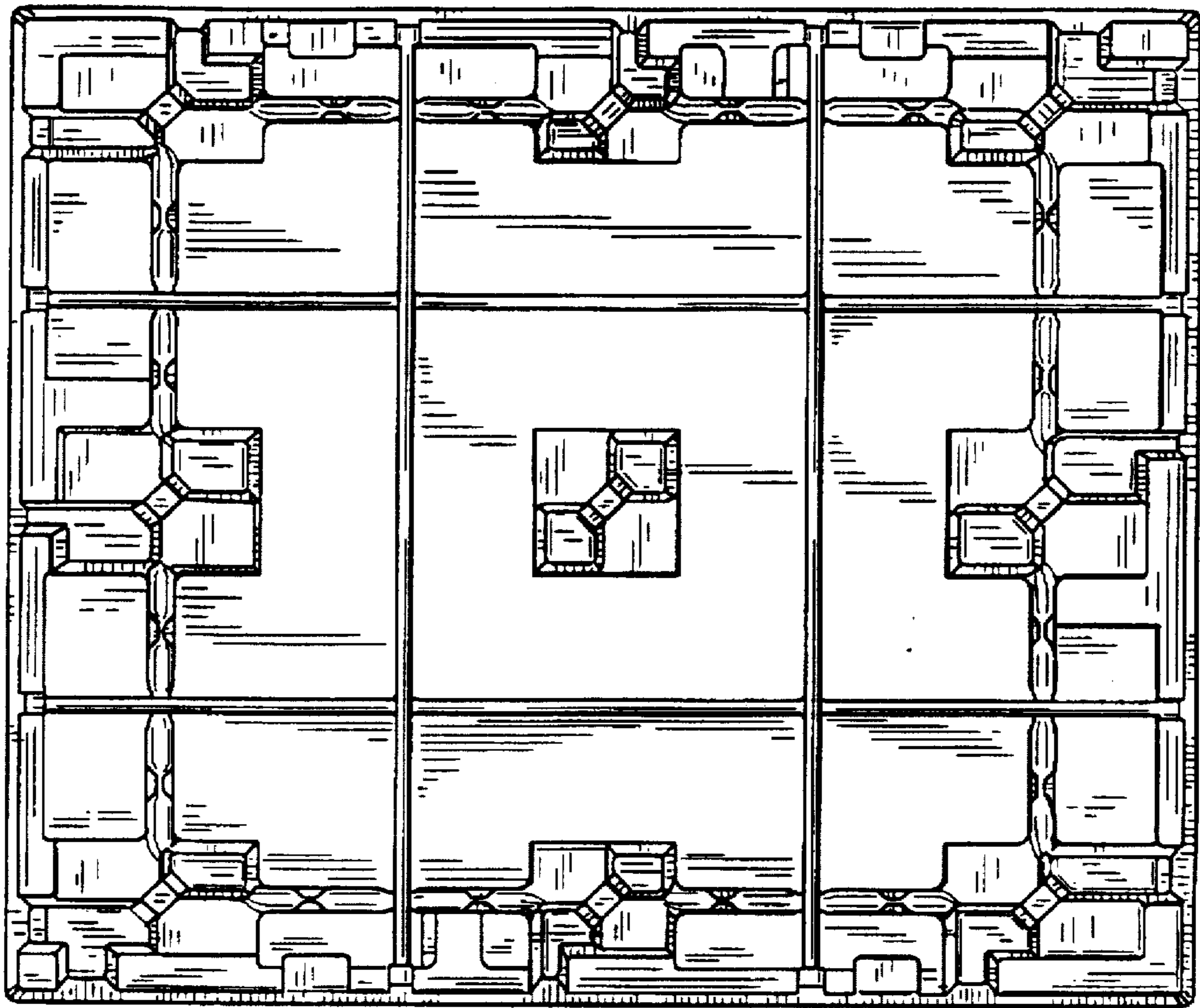

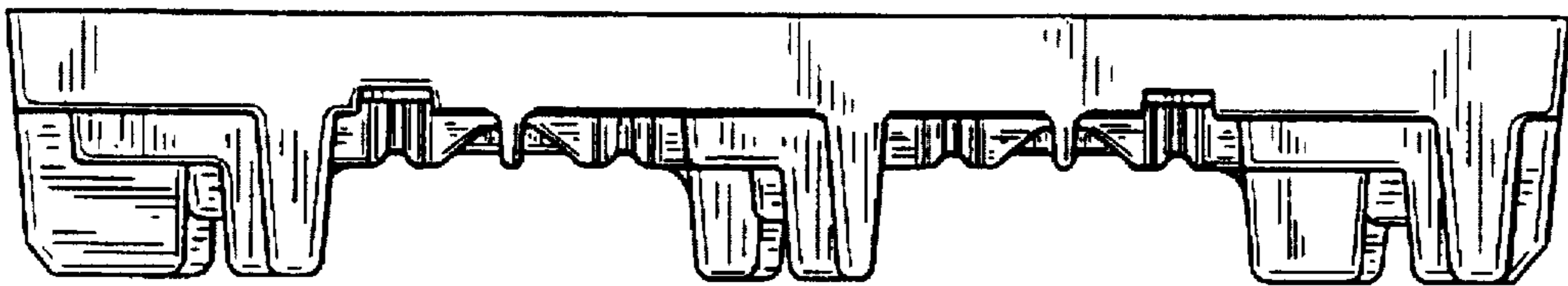

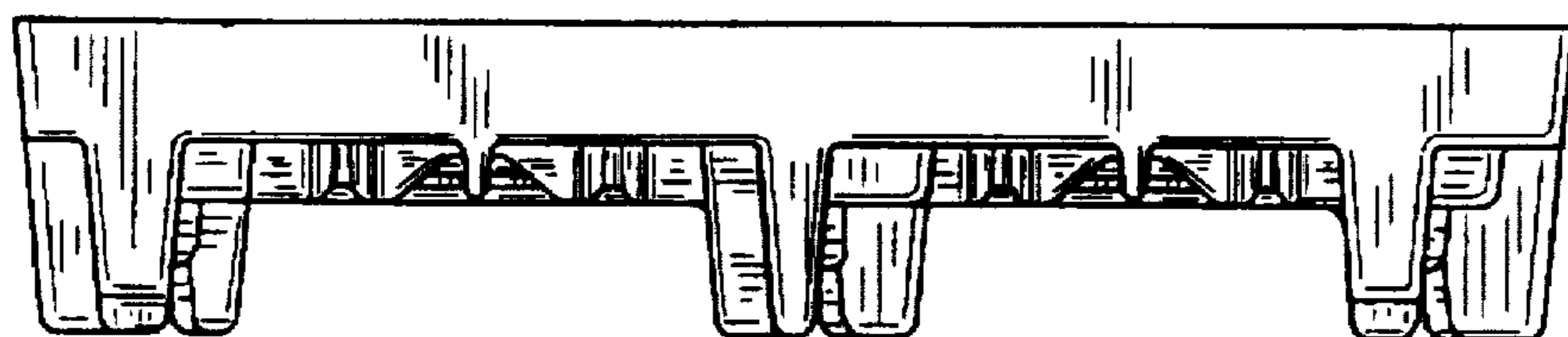

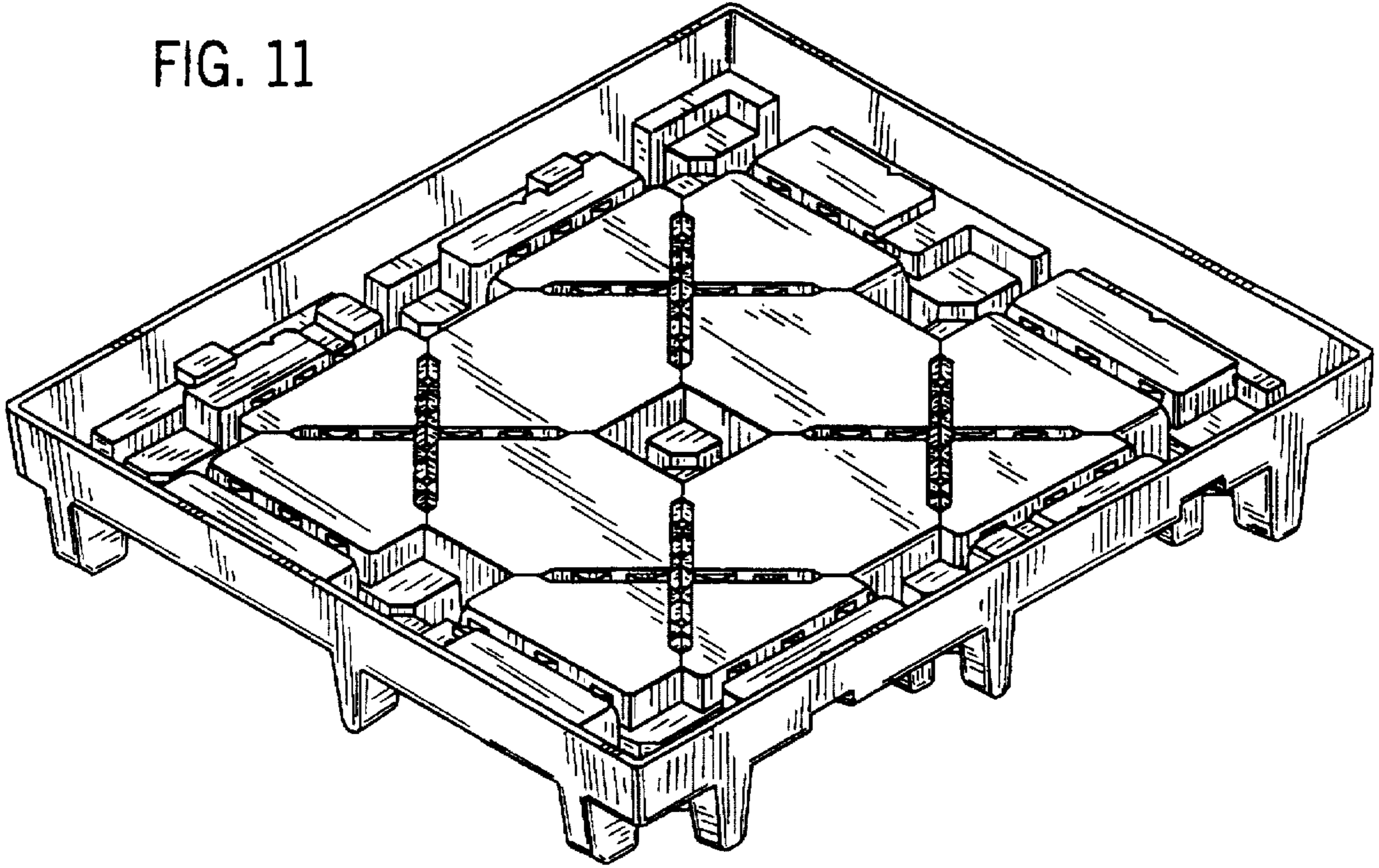

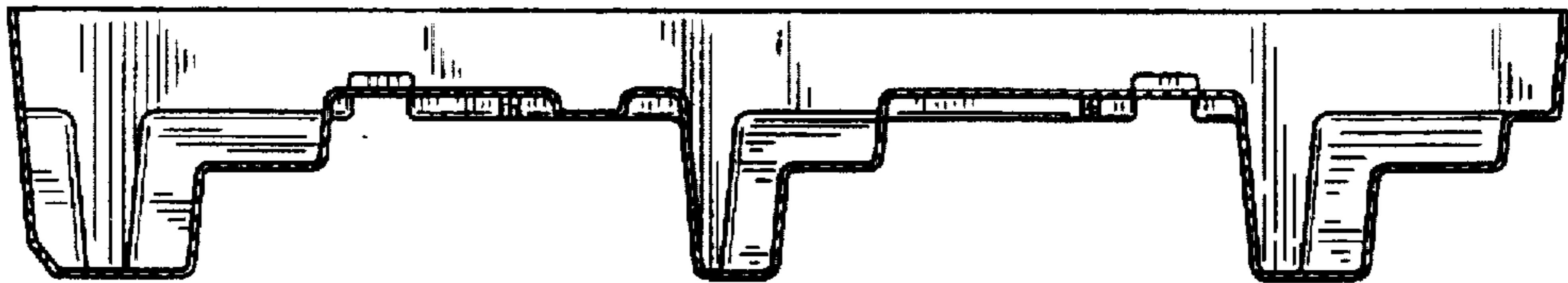

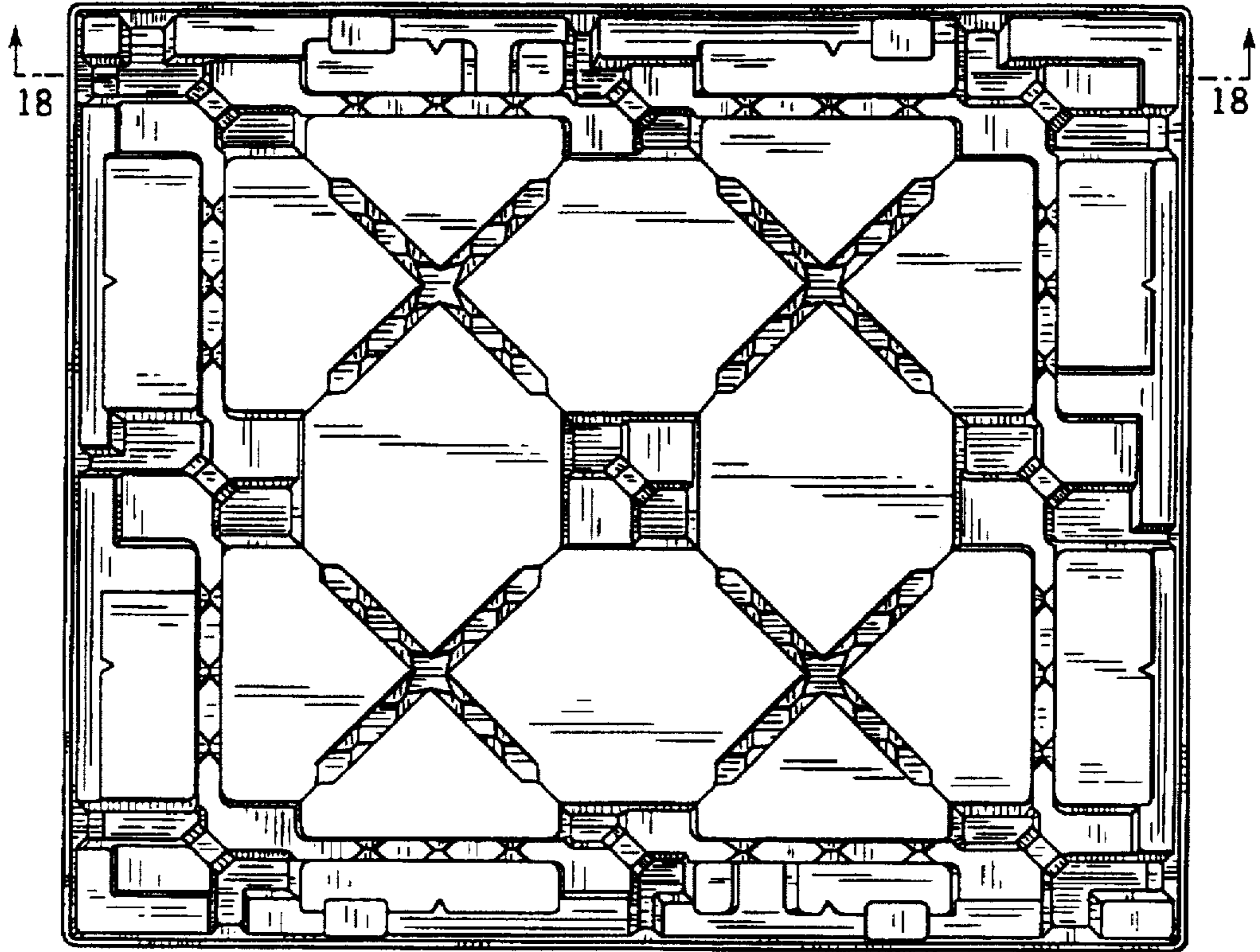

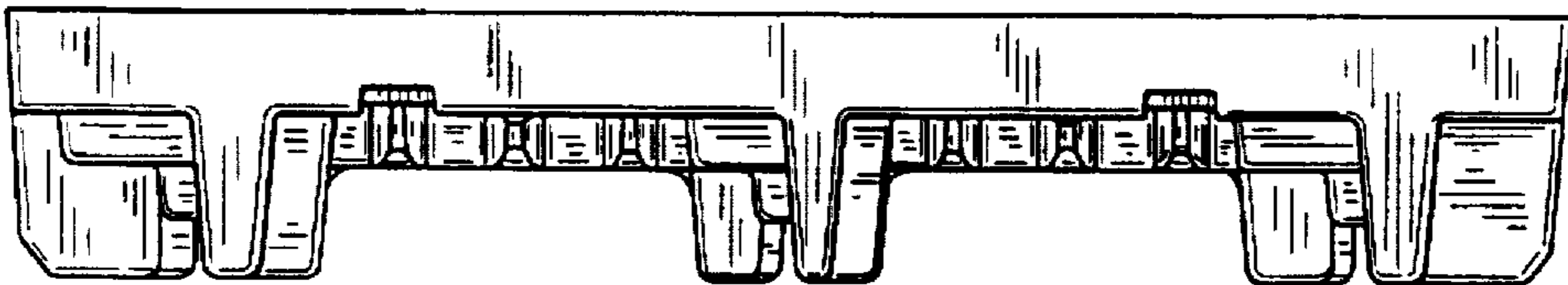

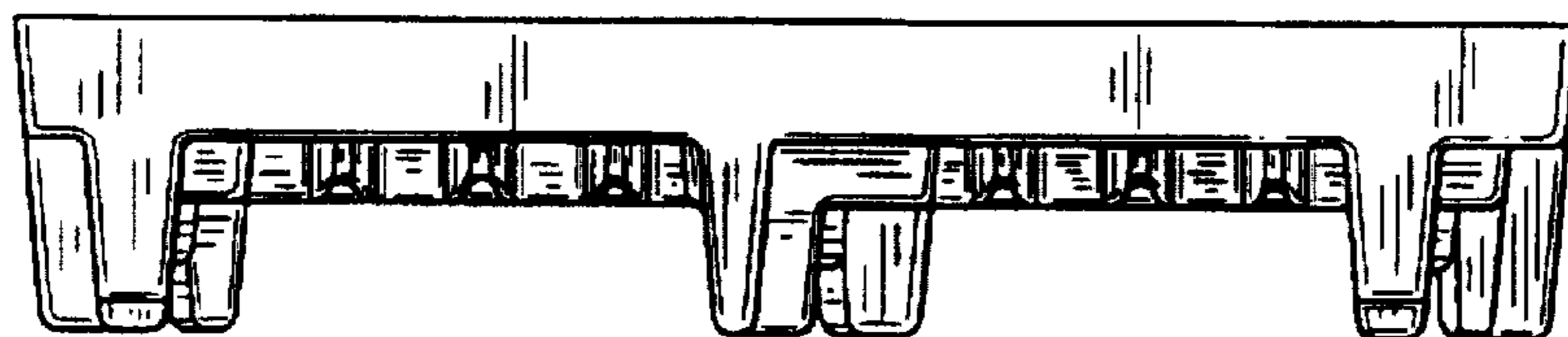

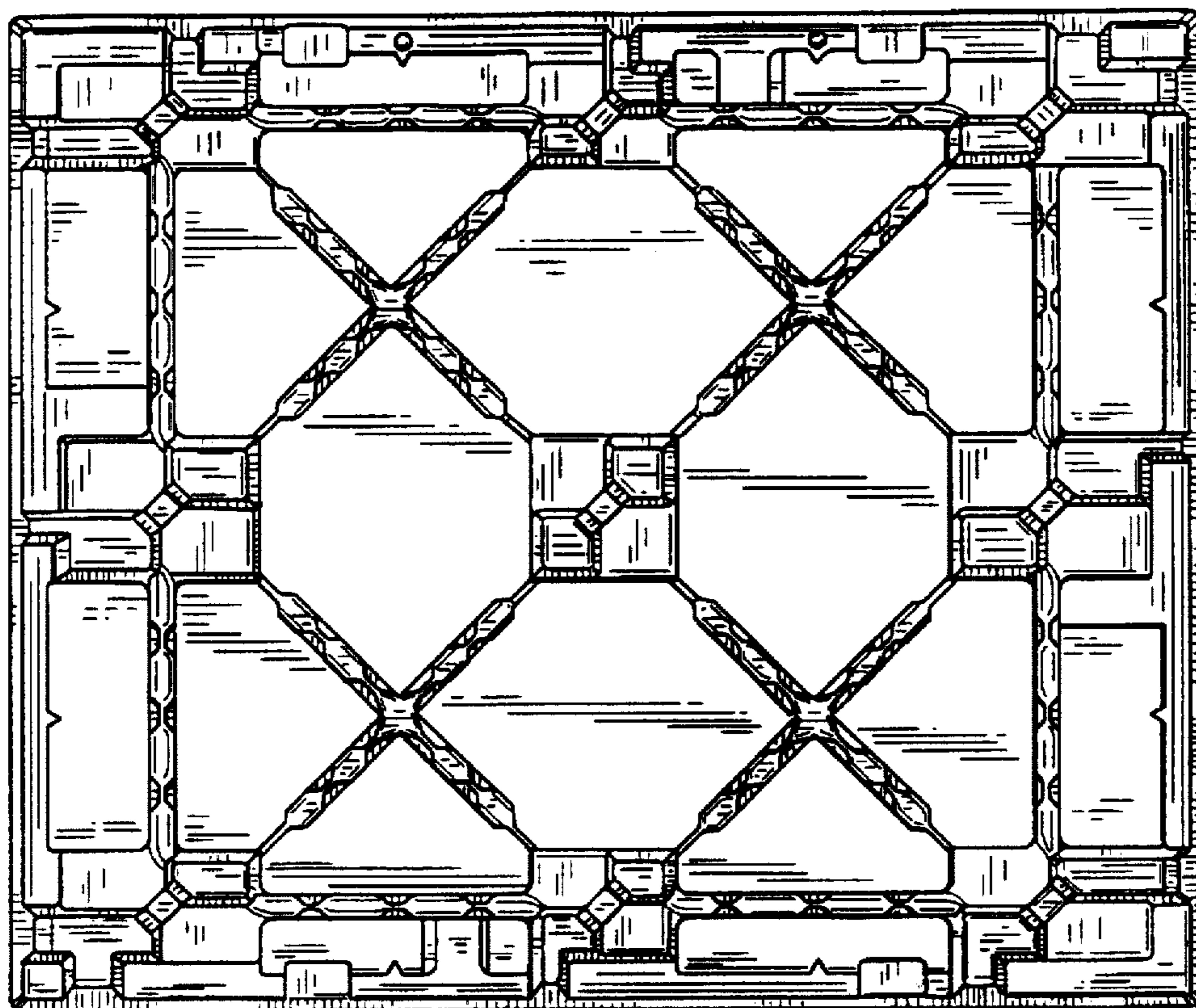

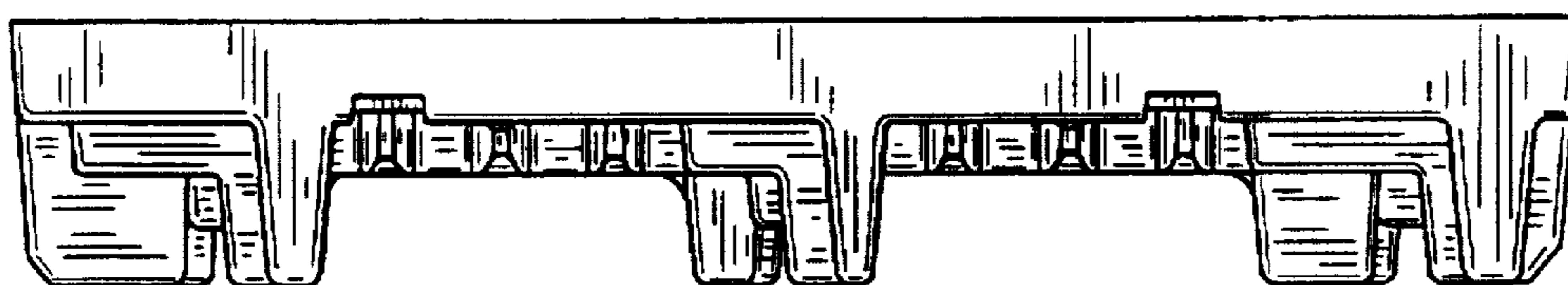
