### DESCRIPTION

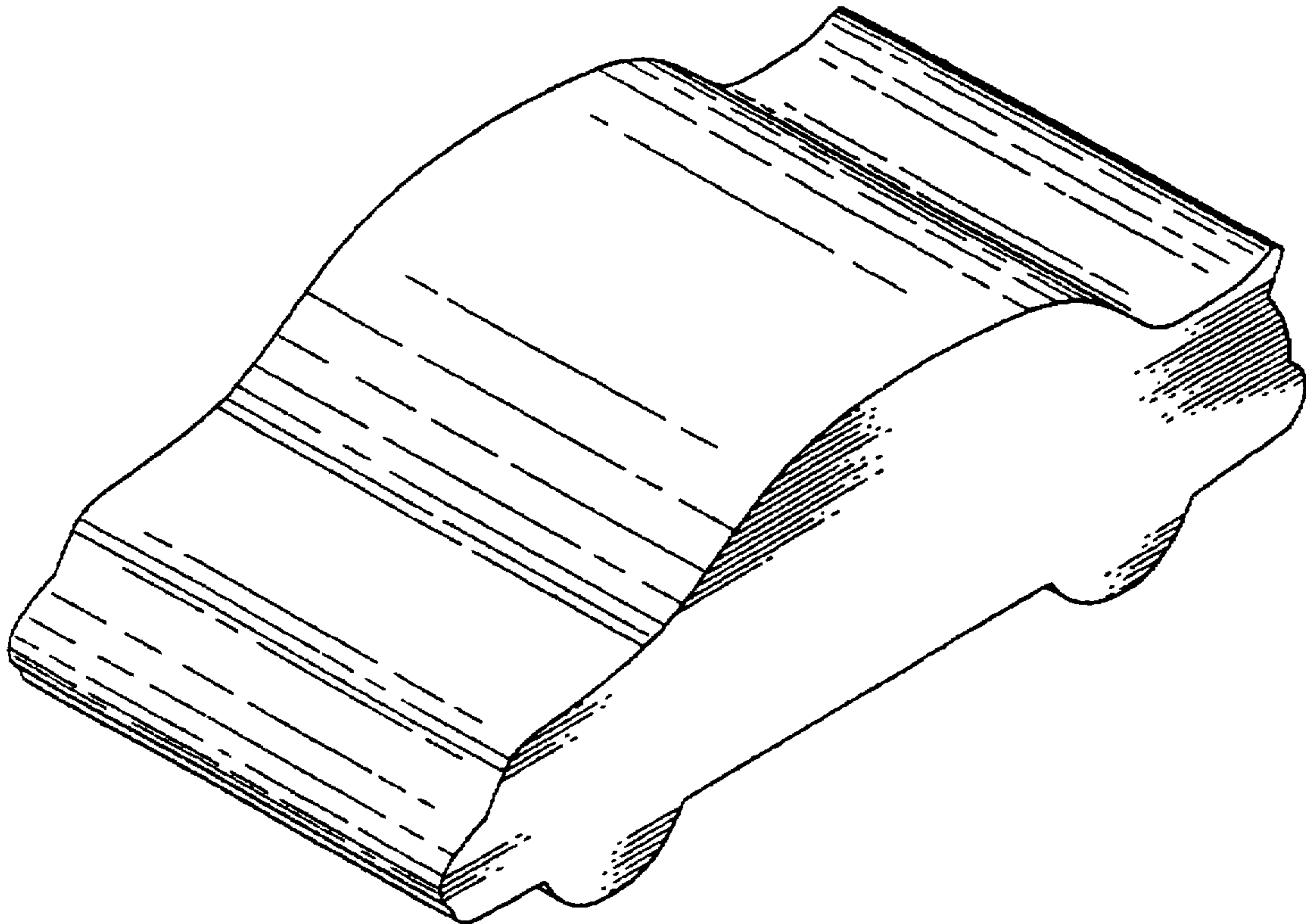

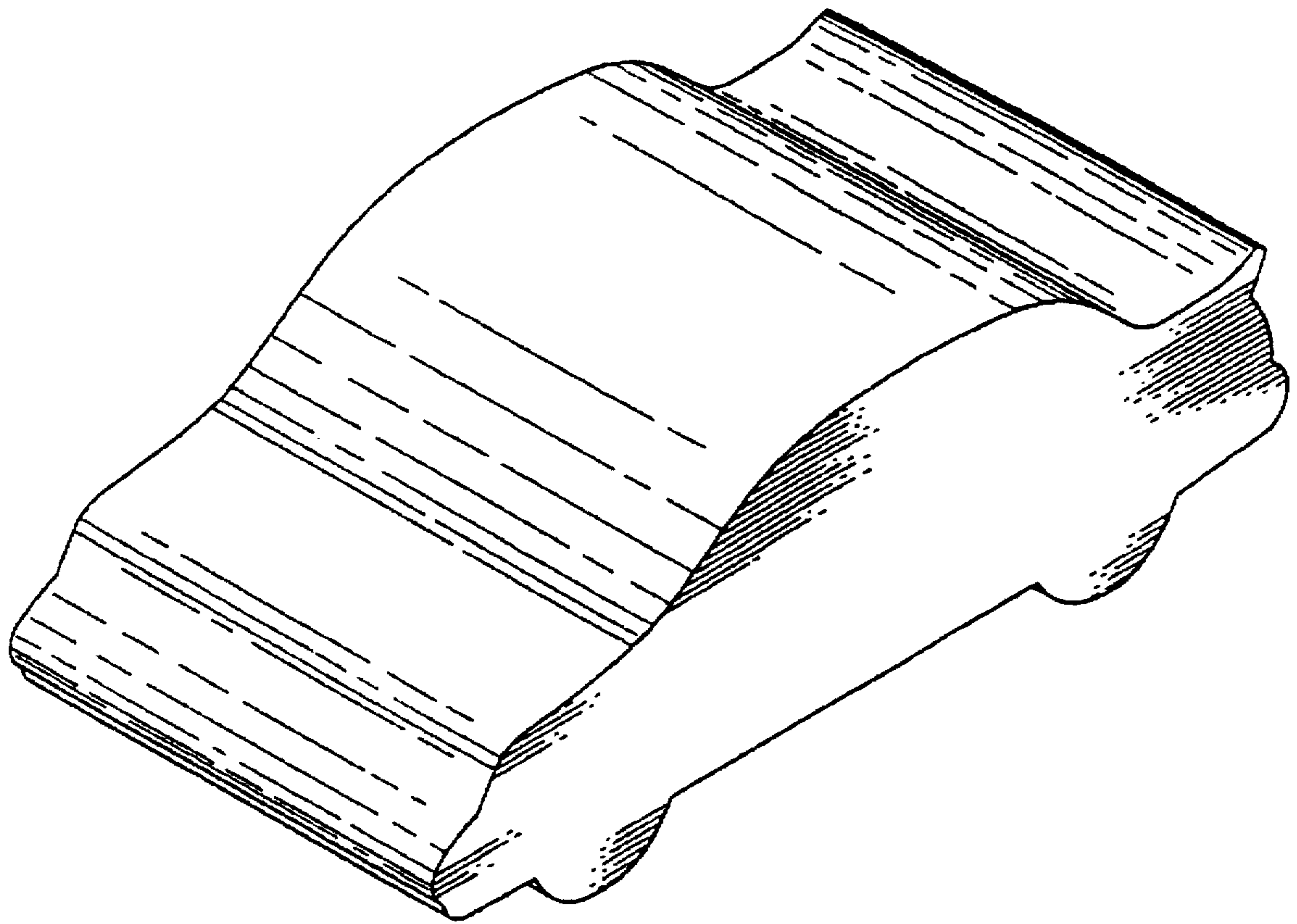

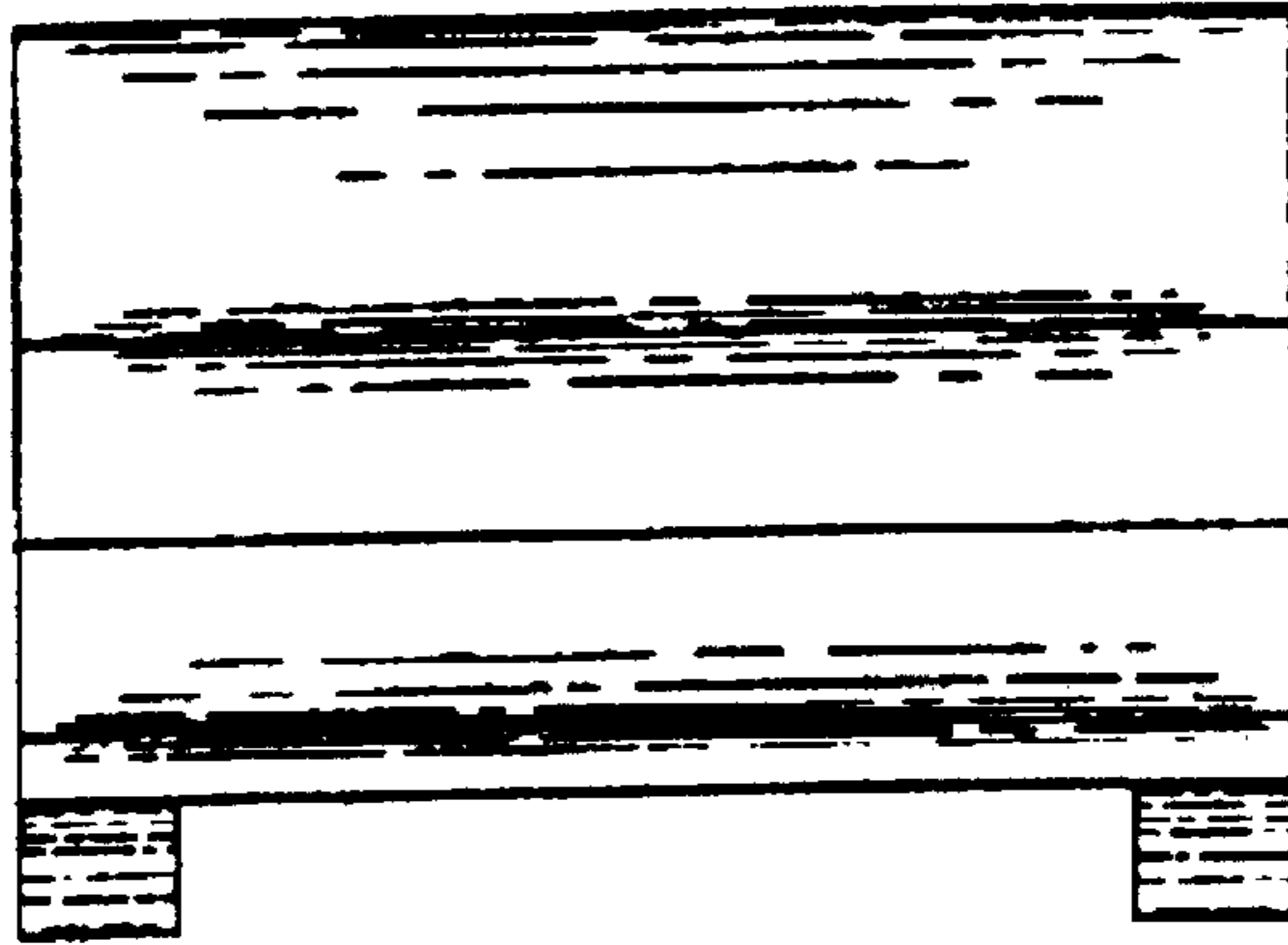

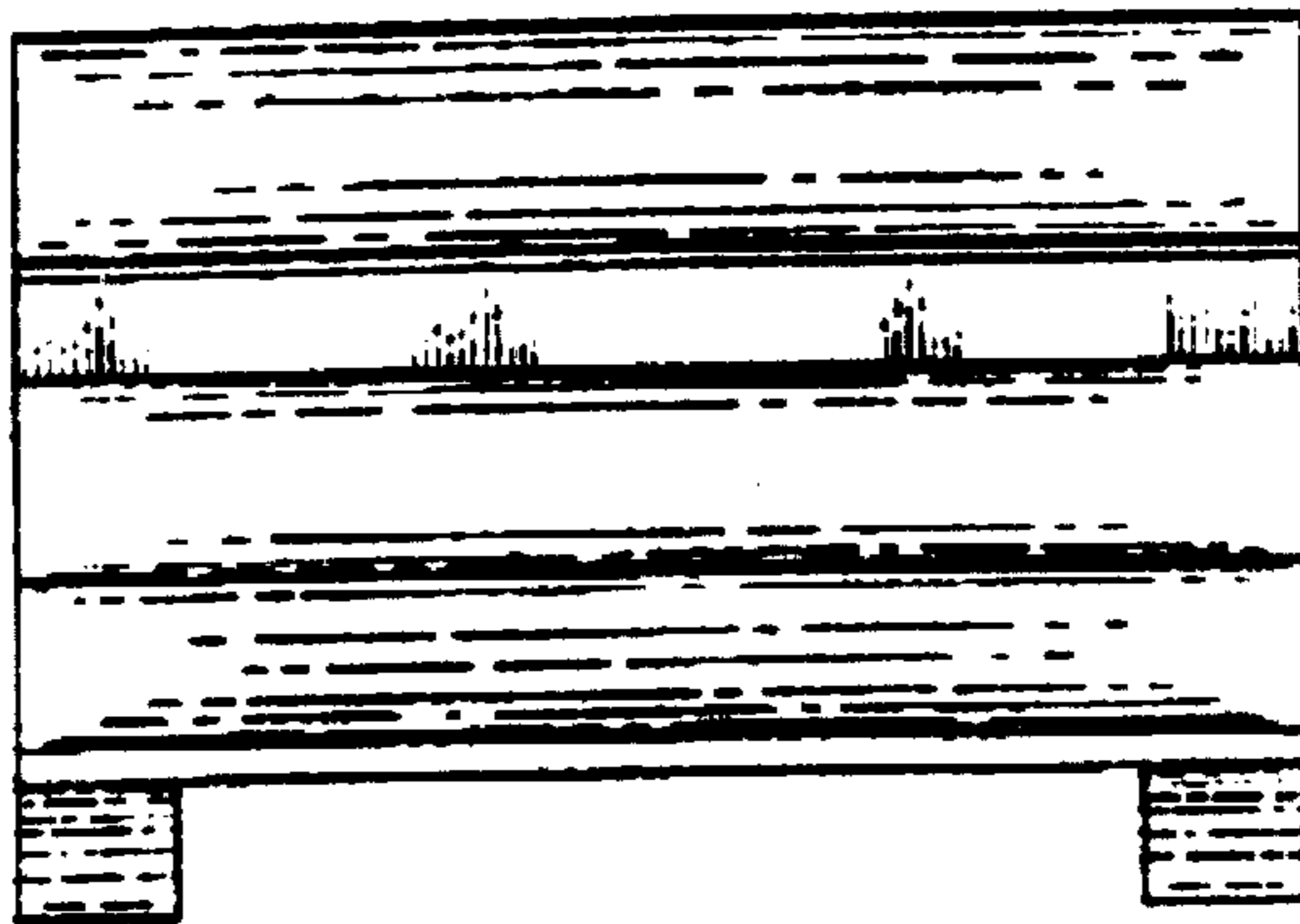




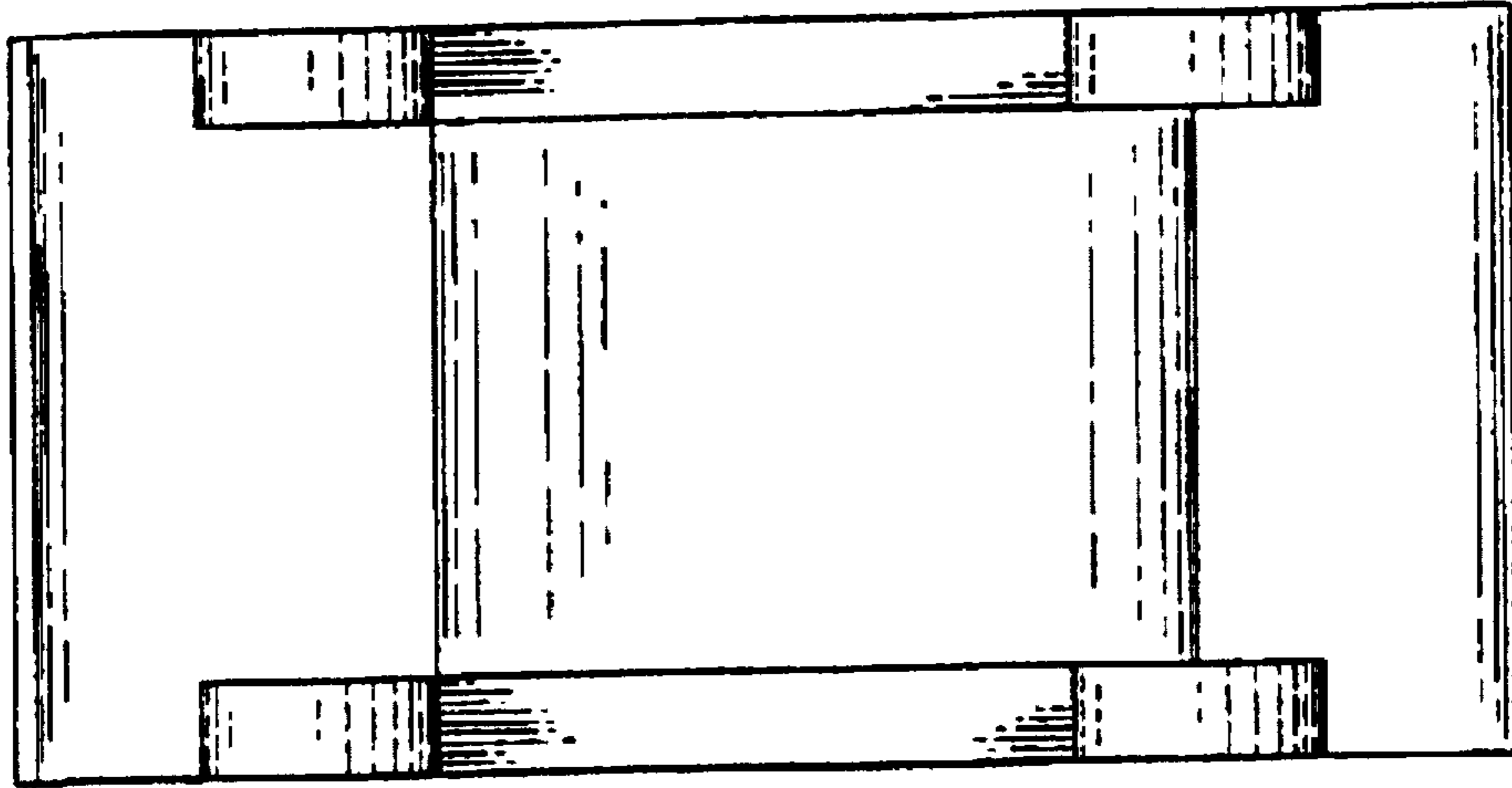

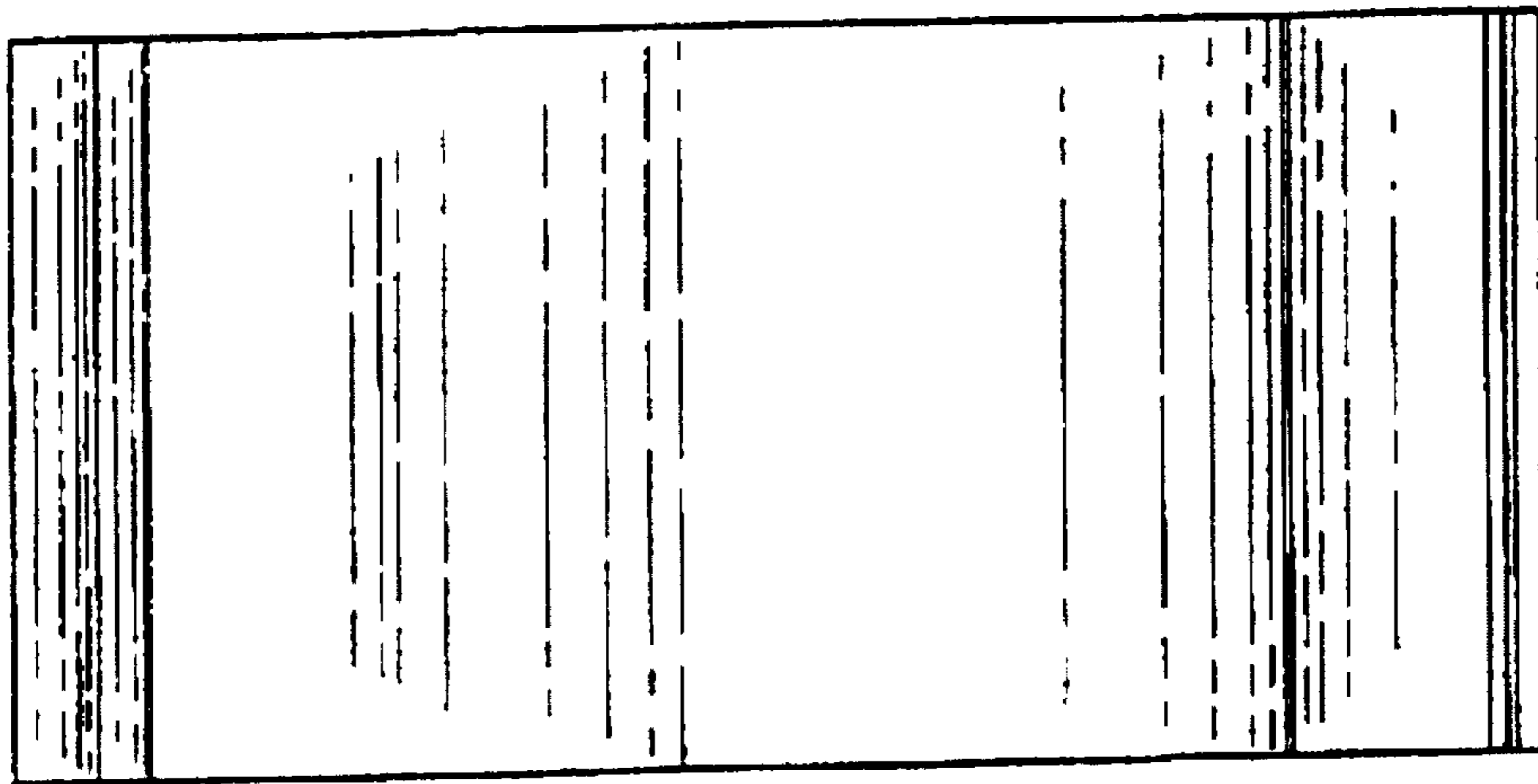

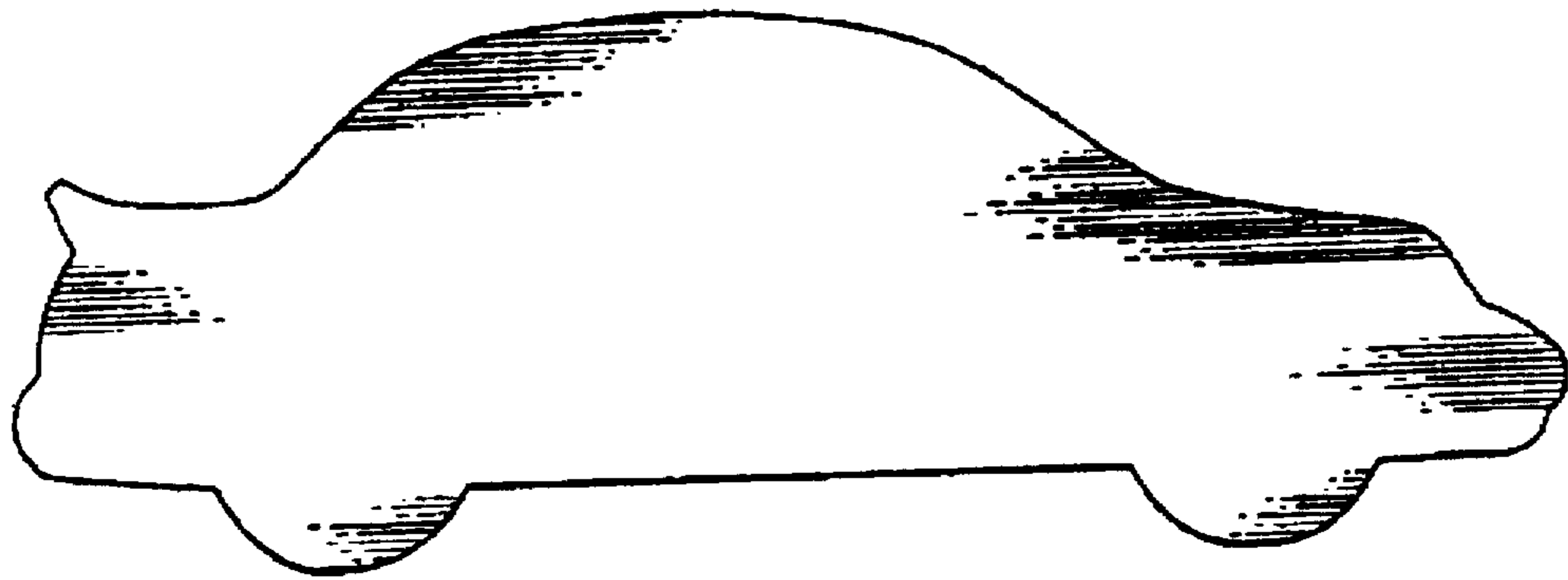

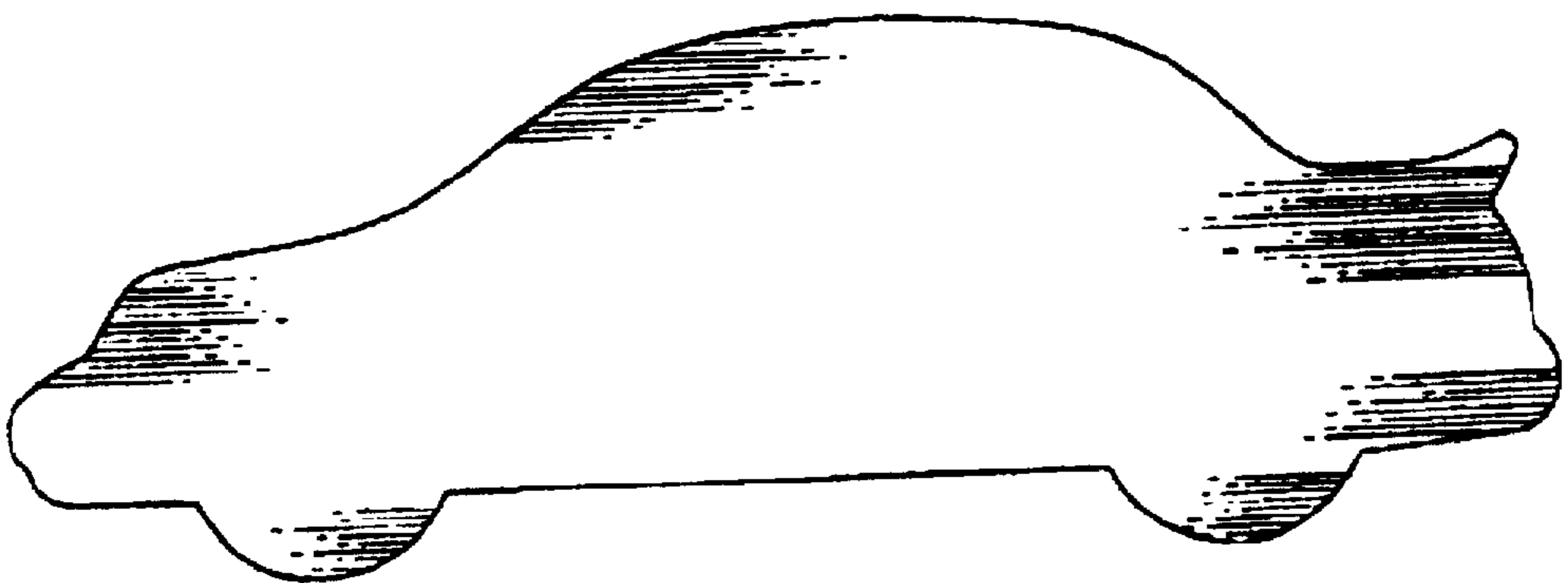
