The ornamental design for a chest of parts drawer, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a chest of parts drawer showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image;
 FIG. 5 is a rear elevational view thereof; and,
 FIG. 6 is a bottom plan view thereof.

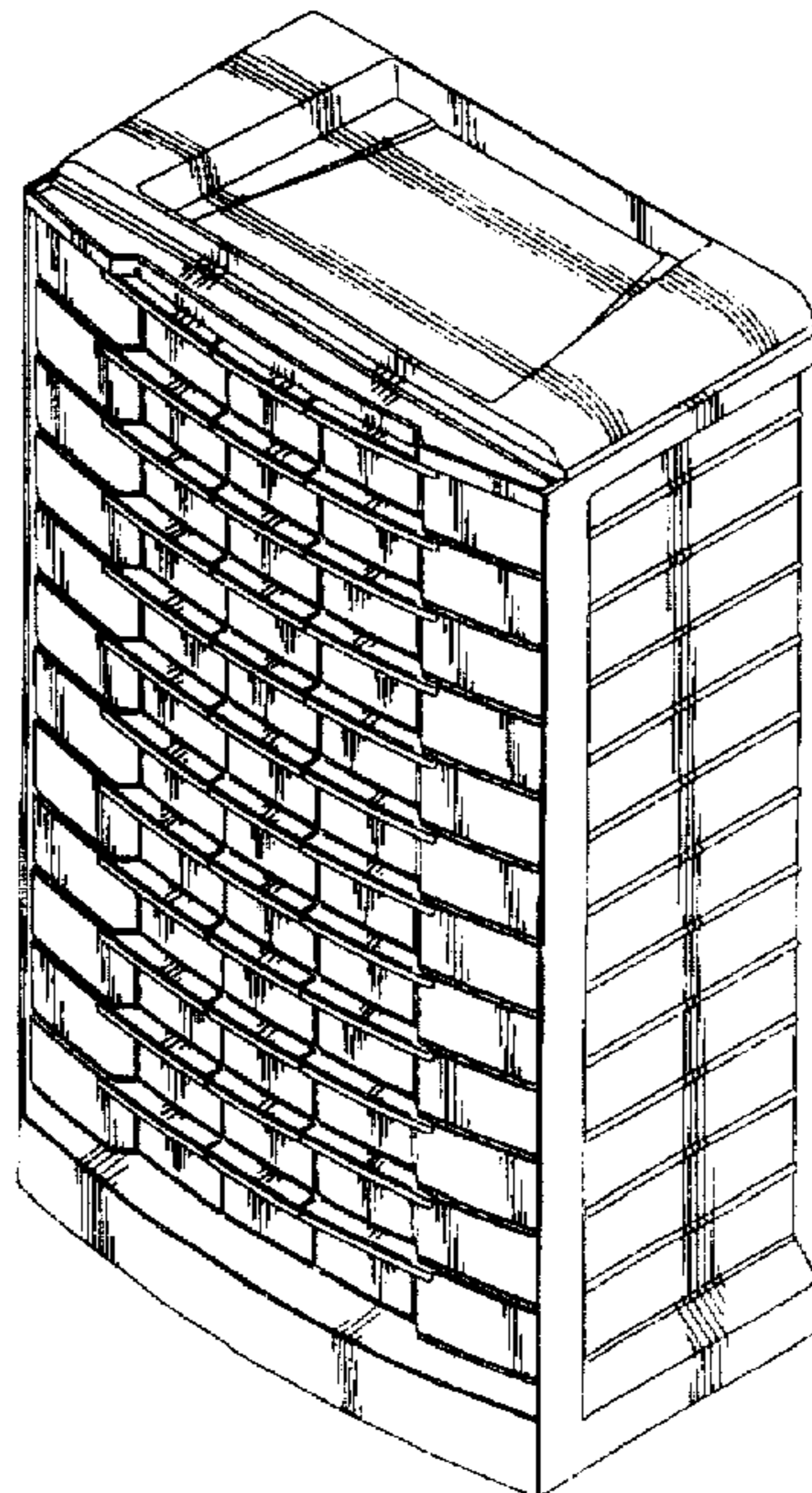

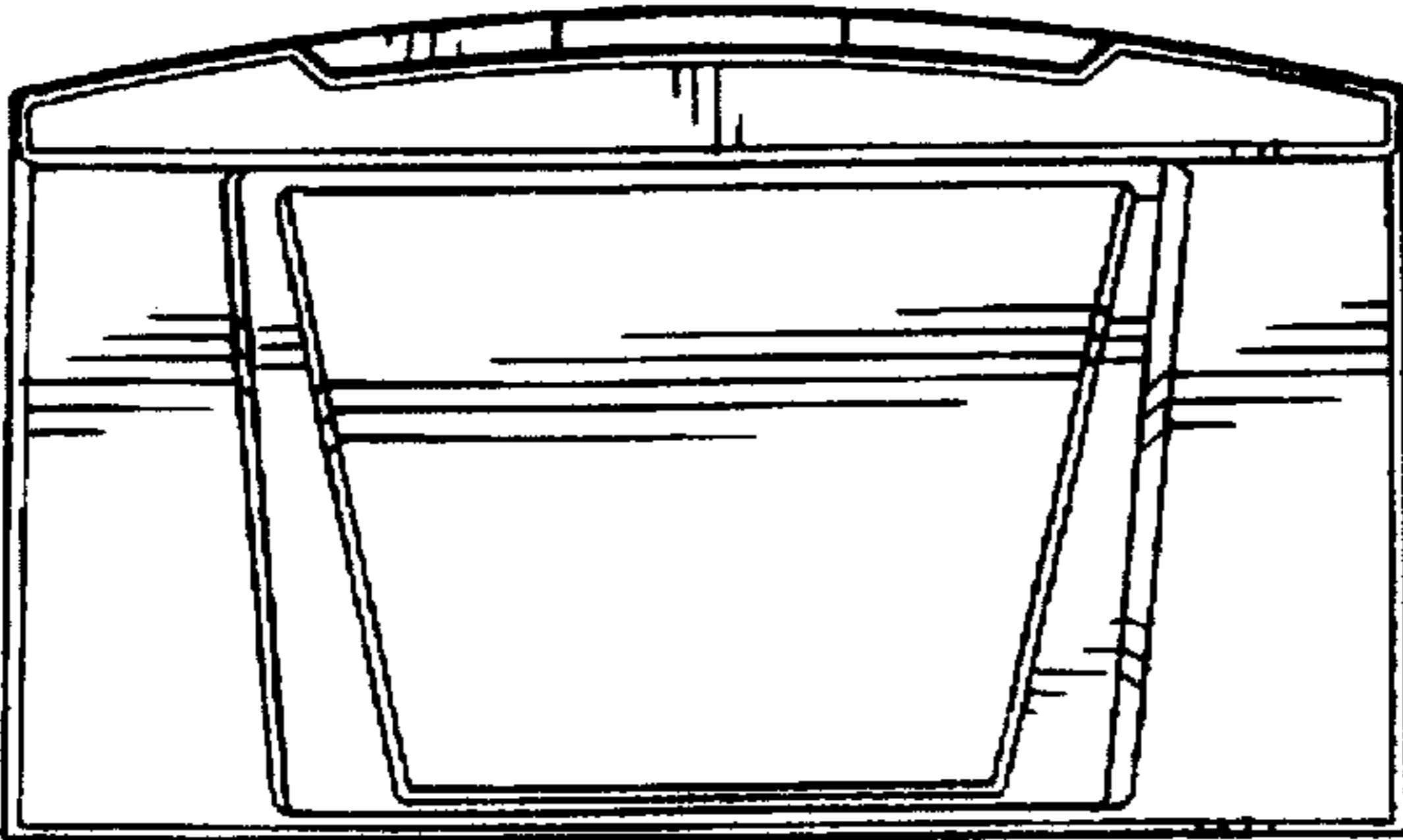
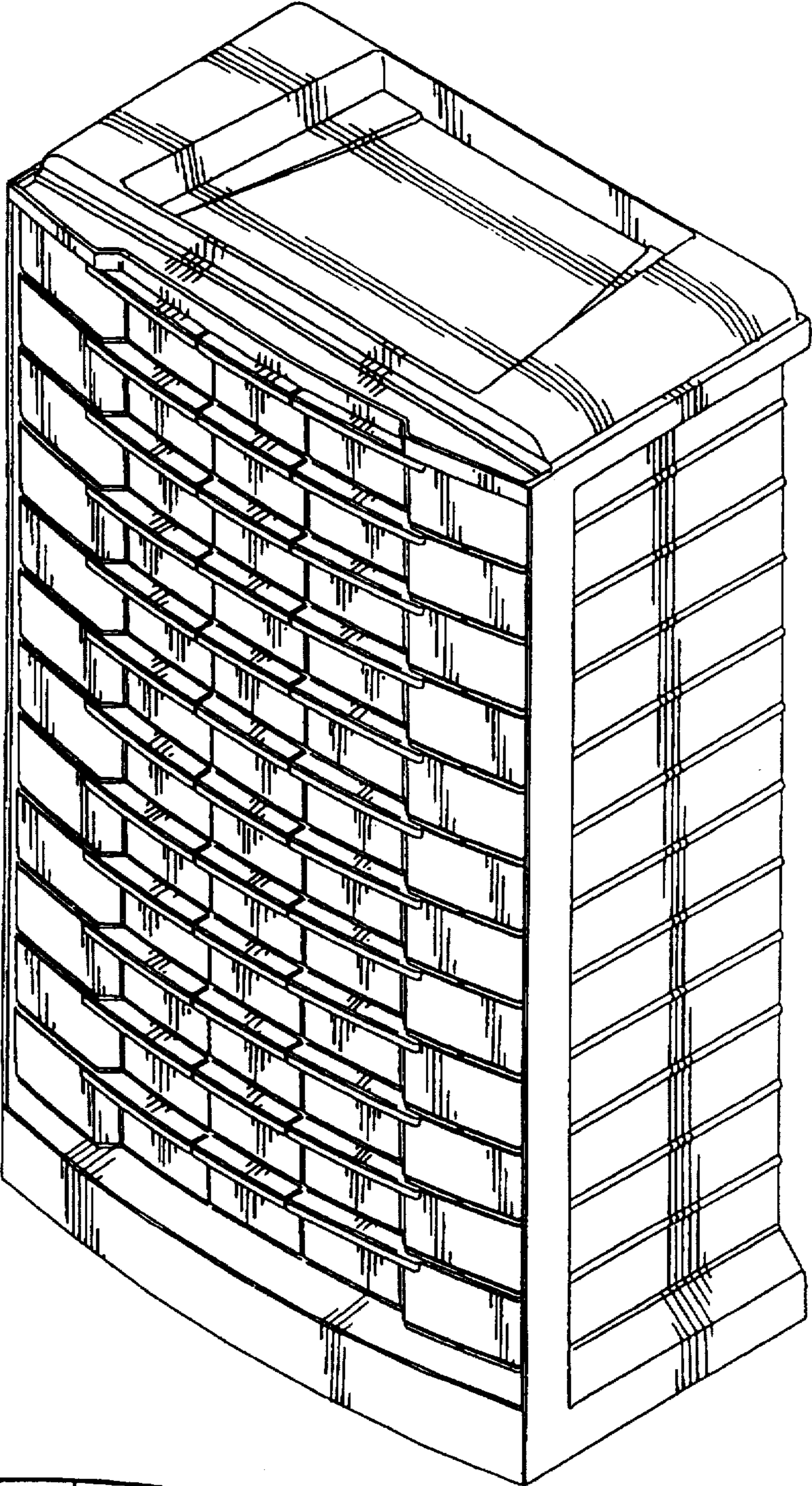

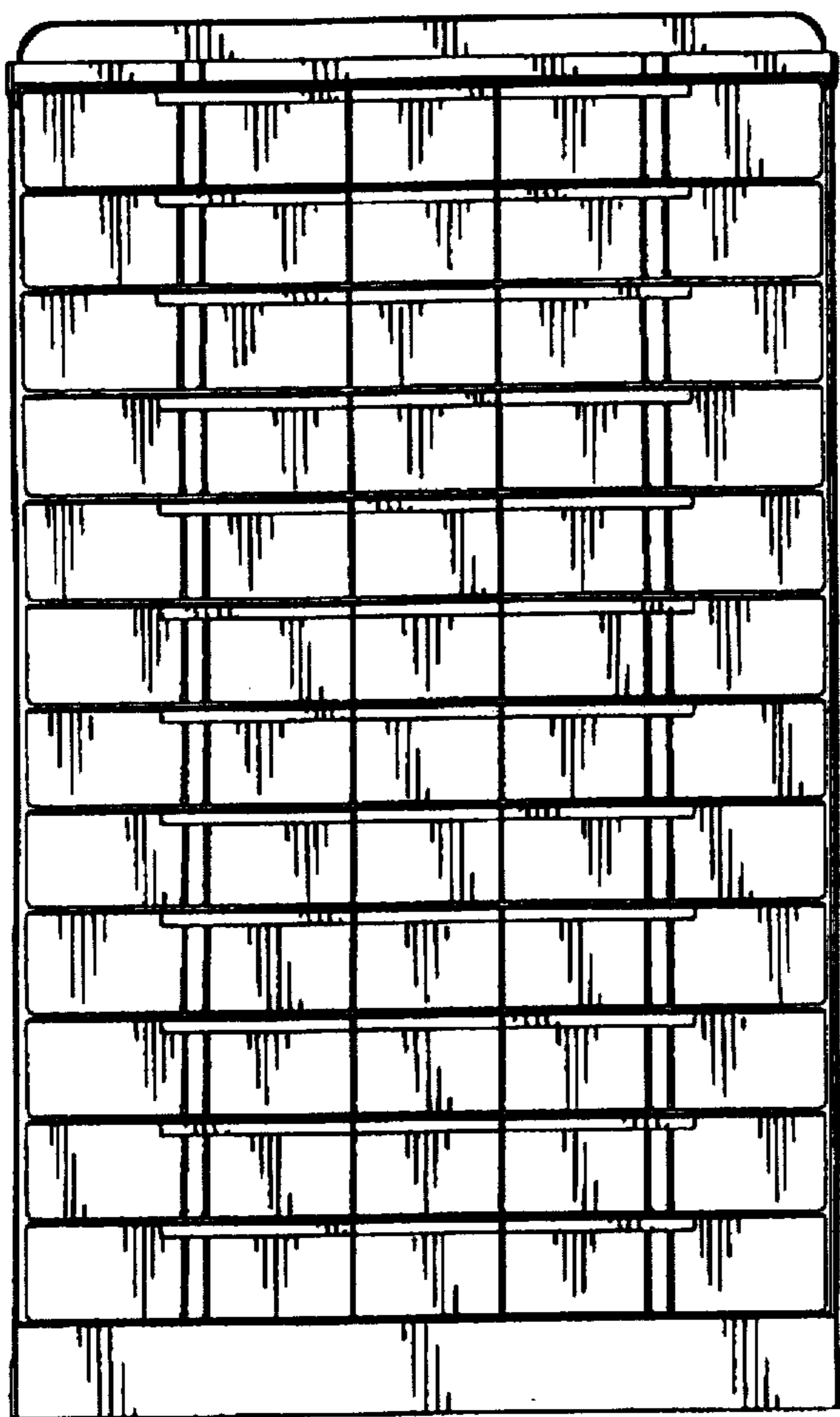
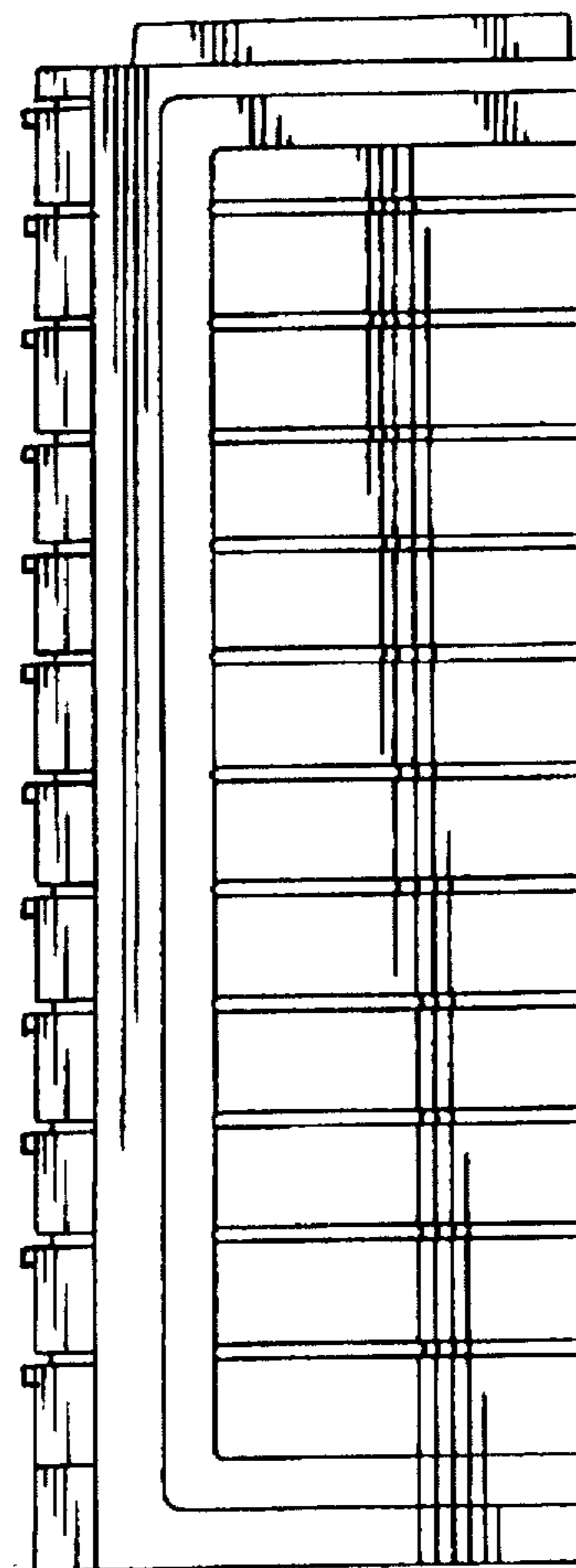

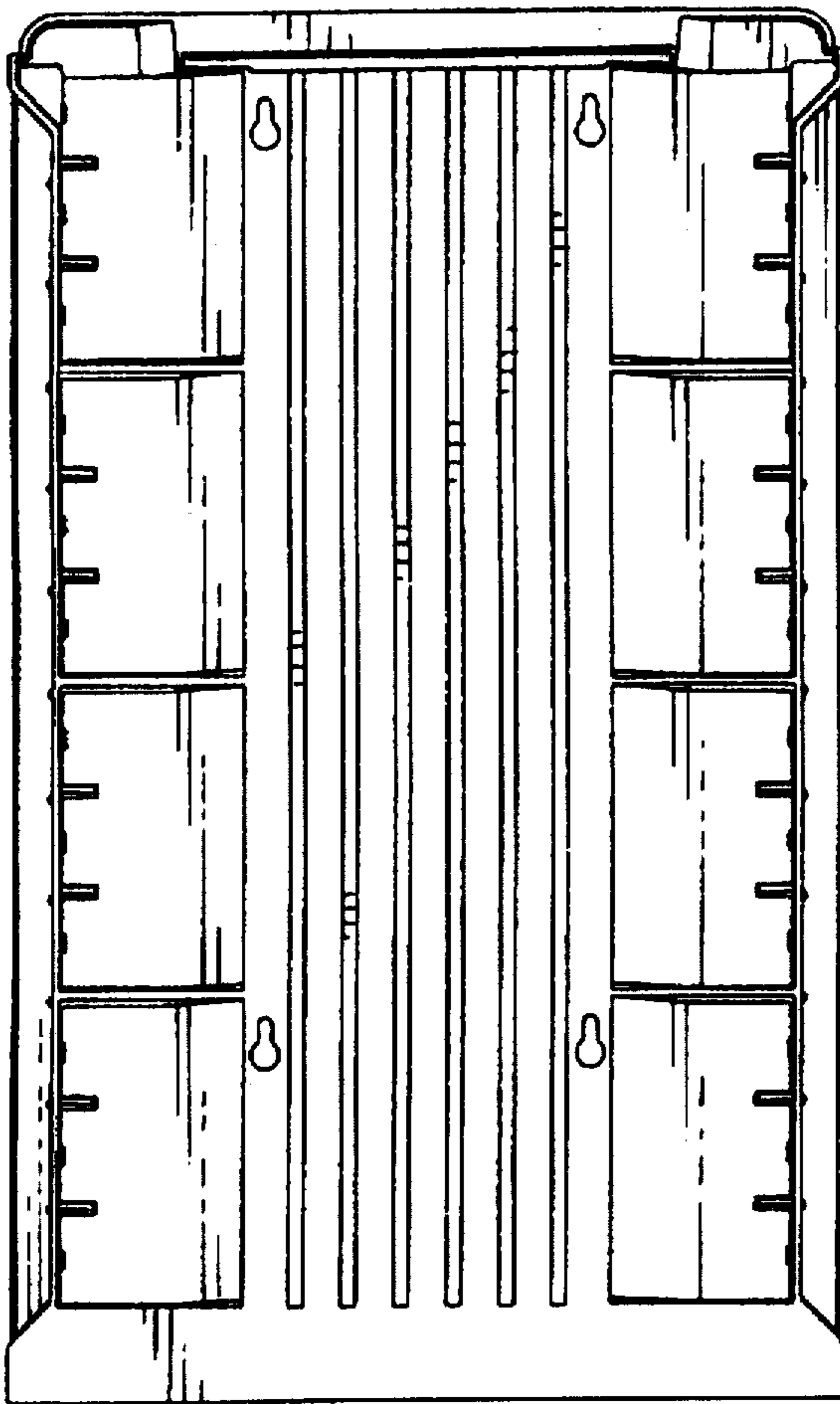

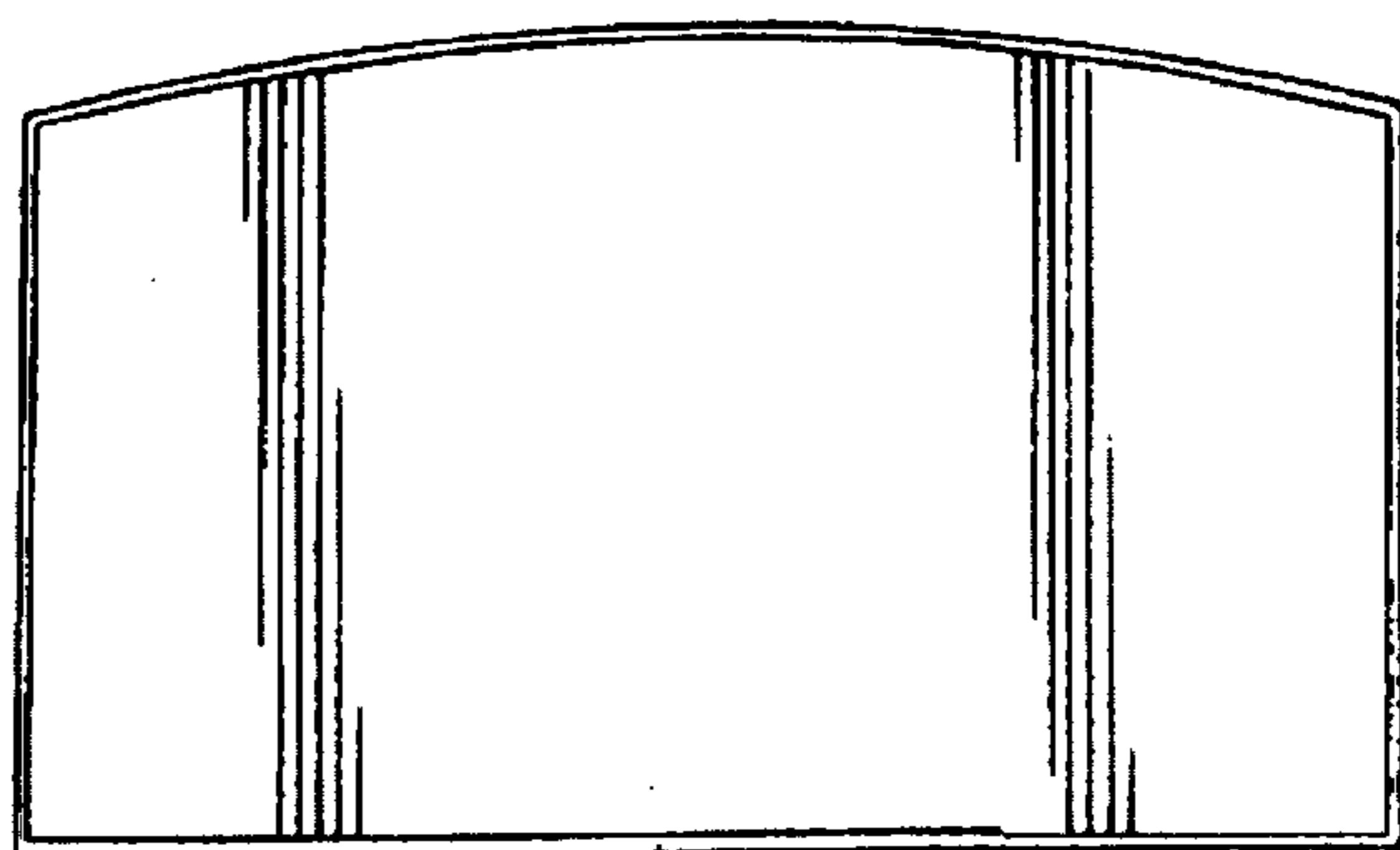
