[57] **CLAIM**

The ornamental design for a insulated vessel cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of the insulated vessel cover showing the design, with a lid and zipper pull shown in broken line throughout FIGS. 1-8 for illustrative purposes only and form not part of the claimed design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a top, front, left side perspective view of an alternate embodiment of the insulated vessel cover design having generally the same features as shown in FIGS. 1-7, and in which design accommodates a greater volume than the embodiment of FIGS. 1-7.

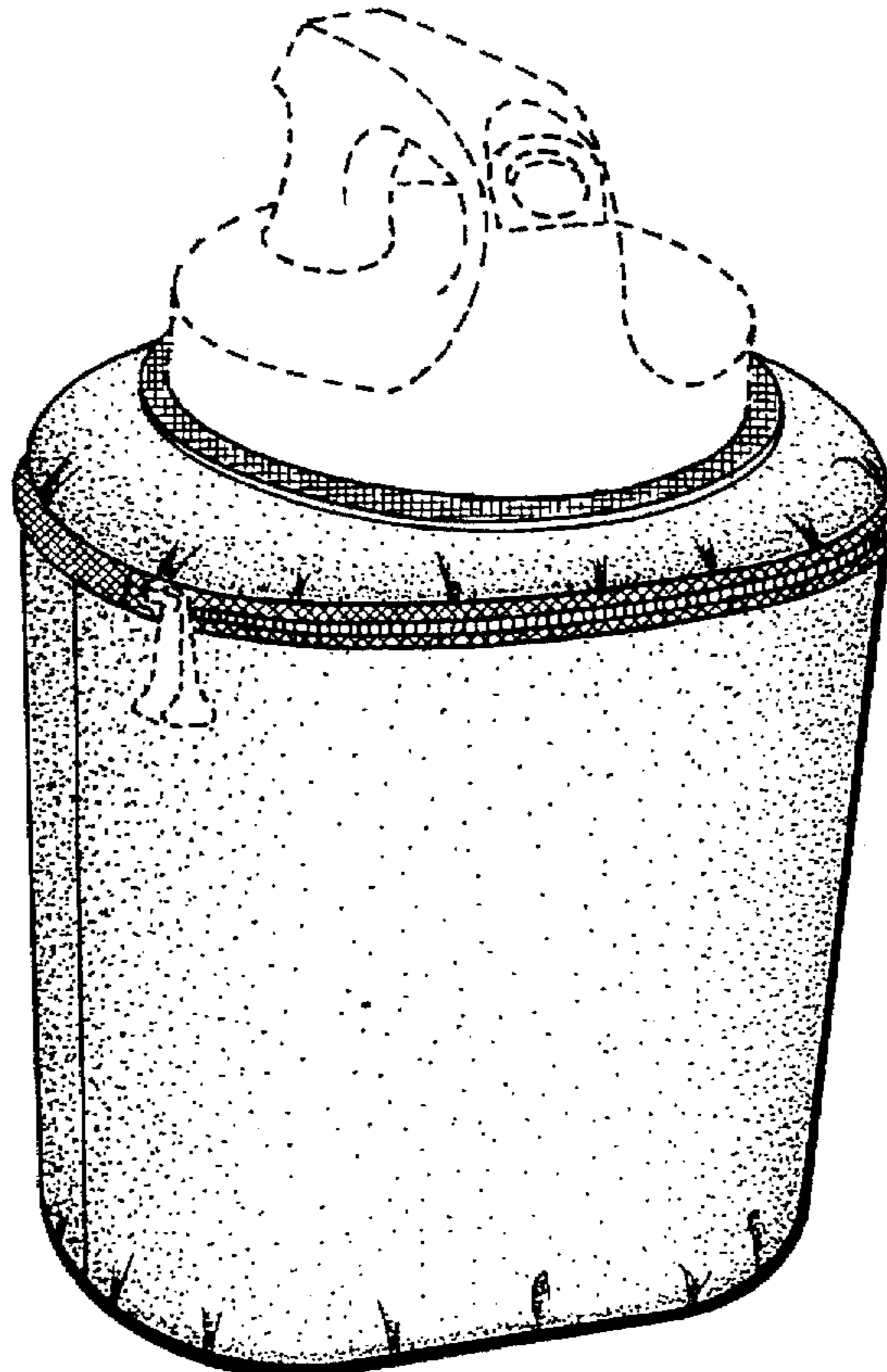

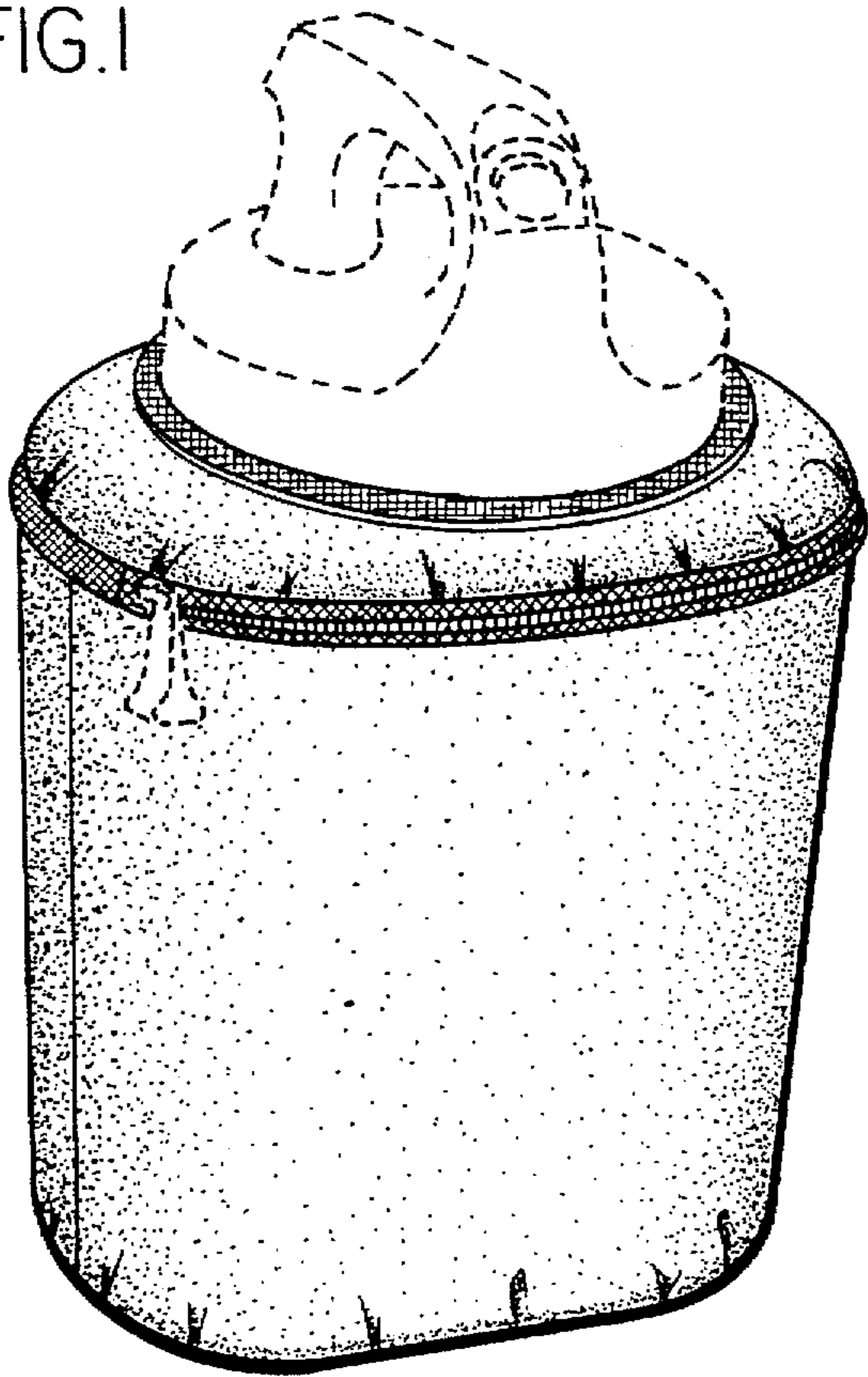

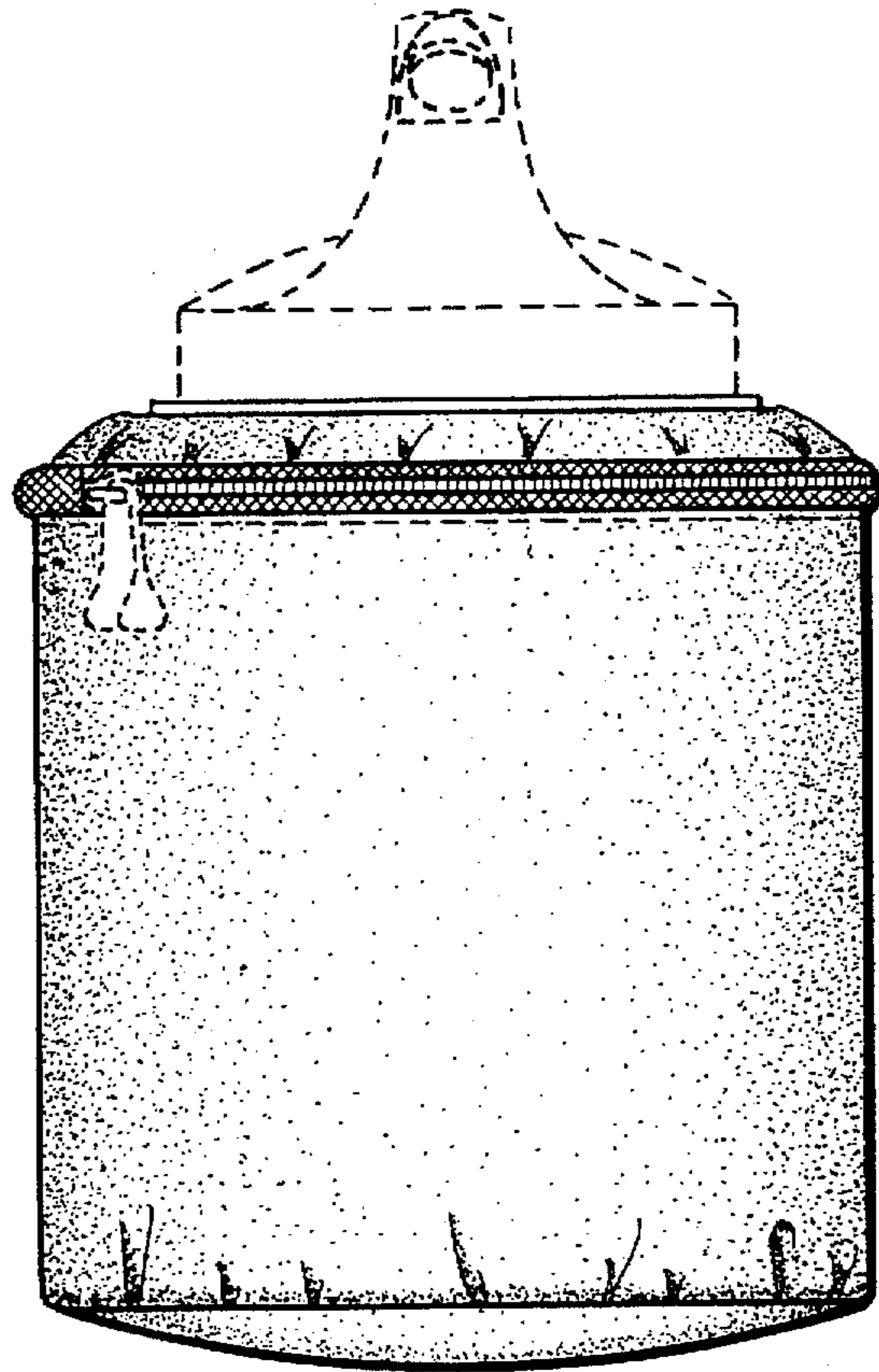

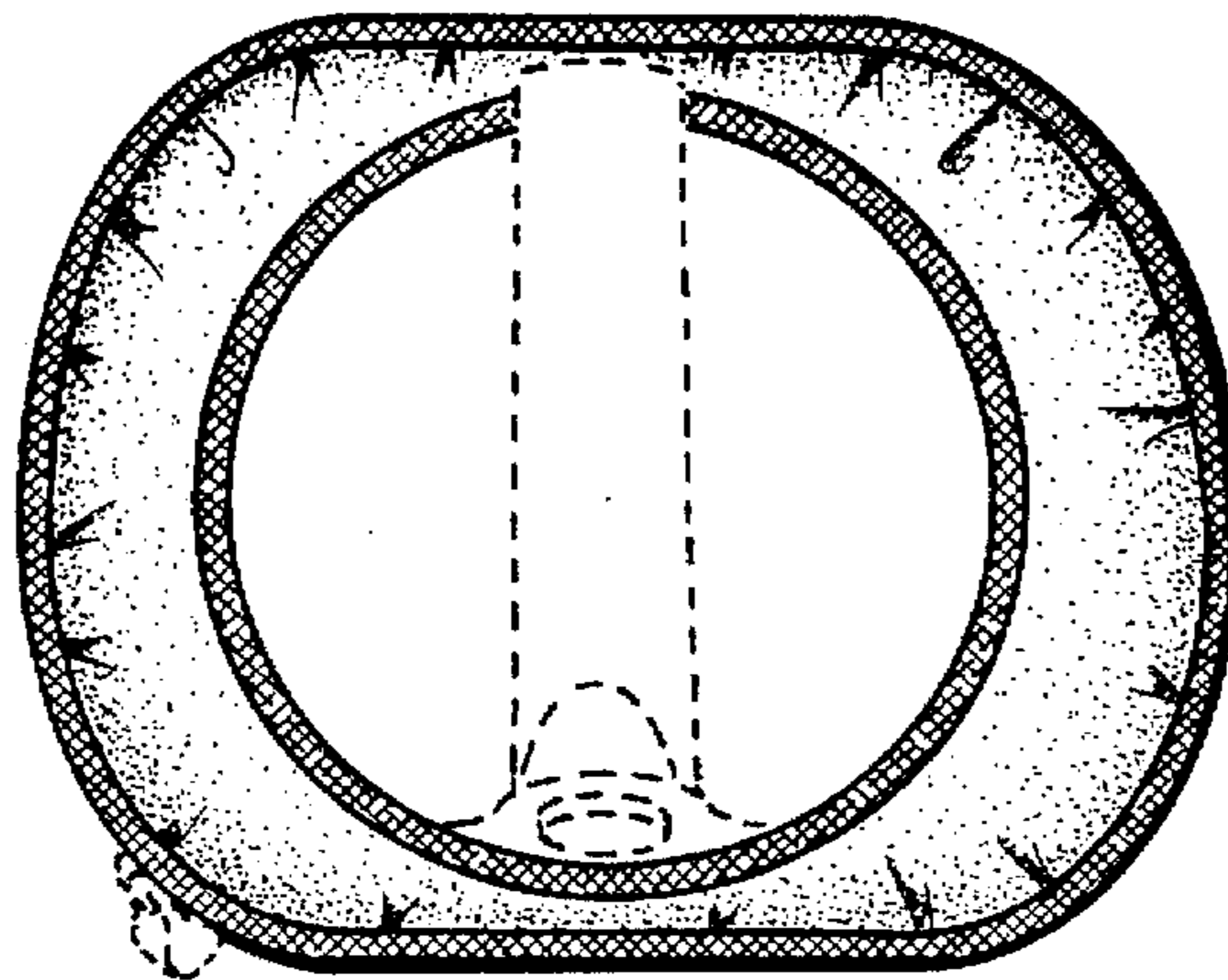

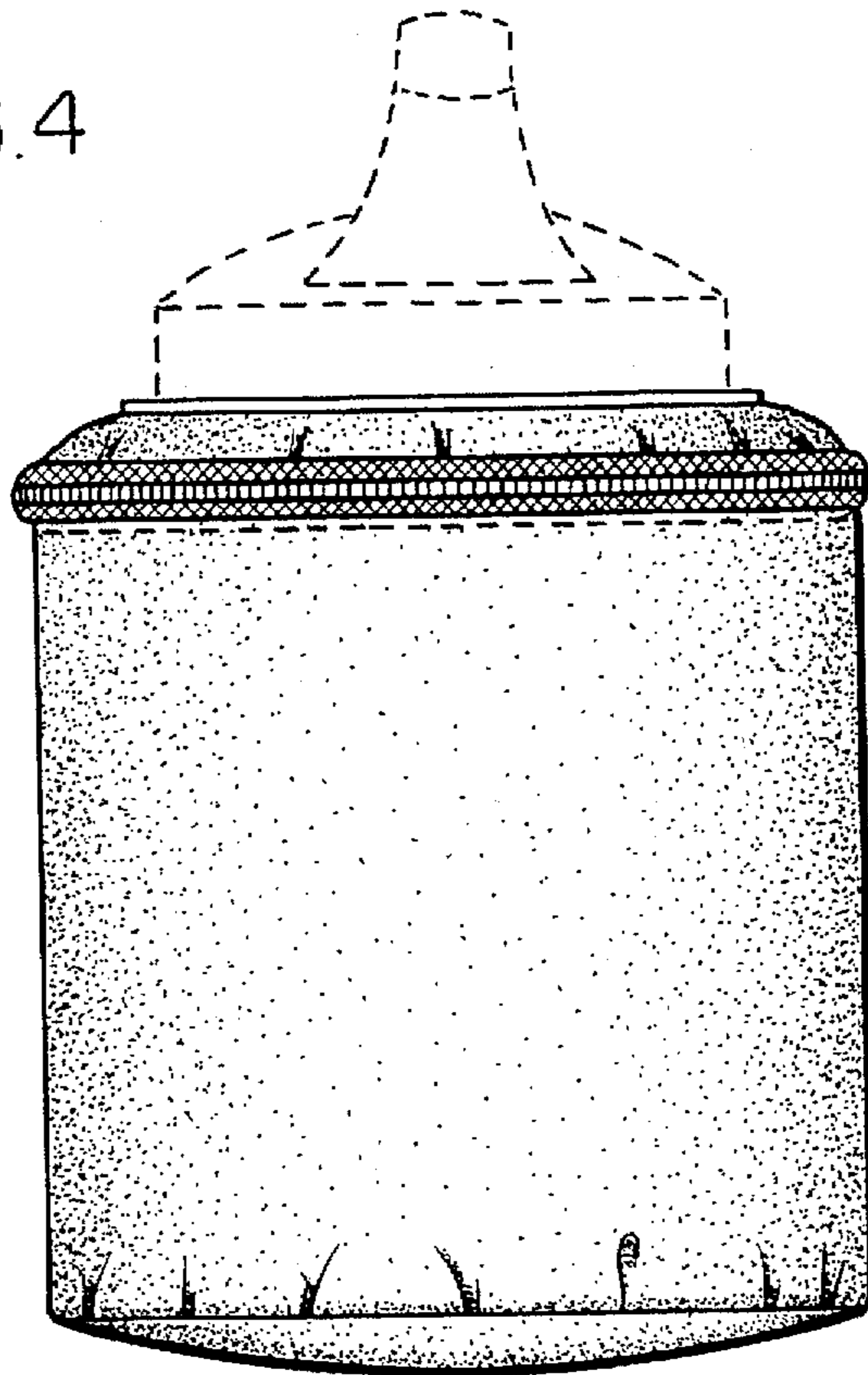

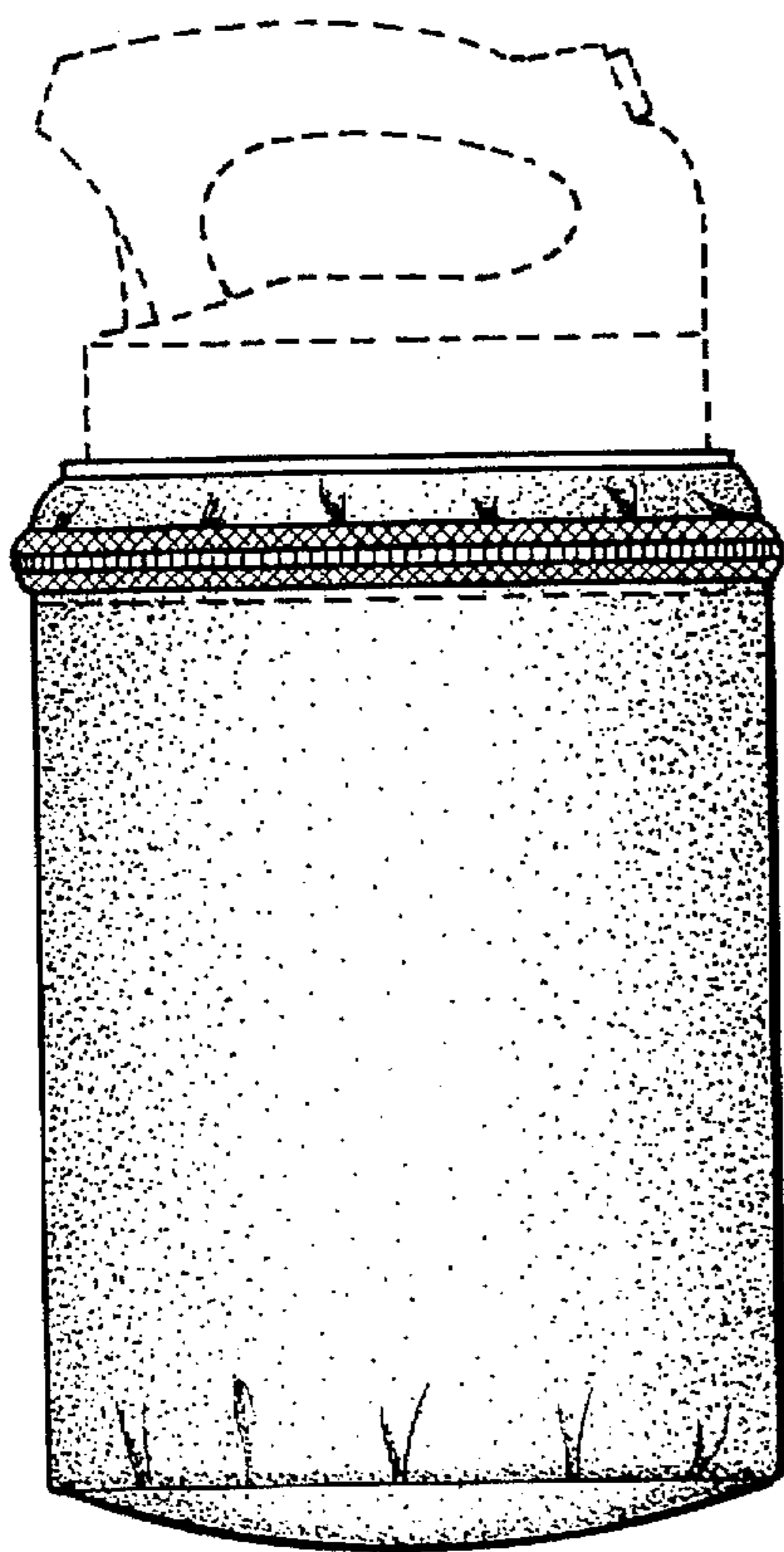

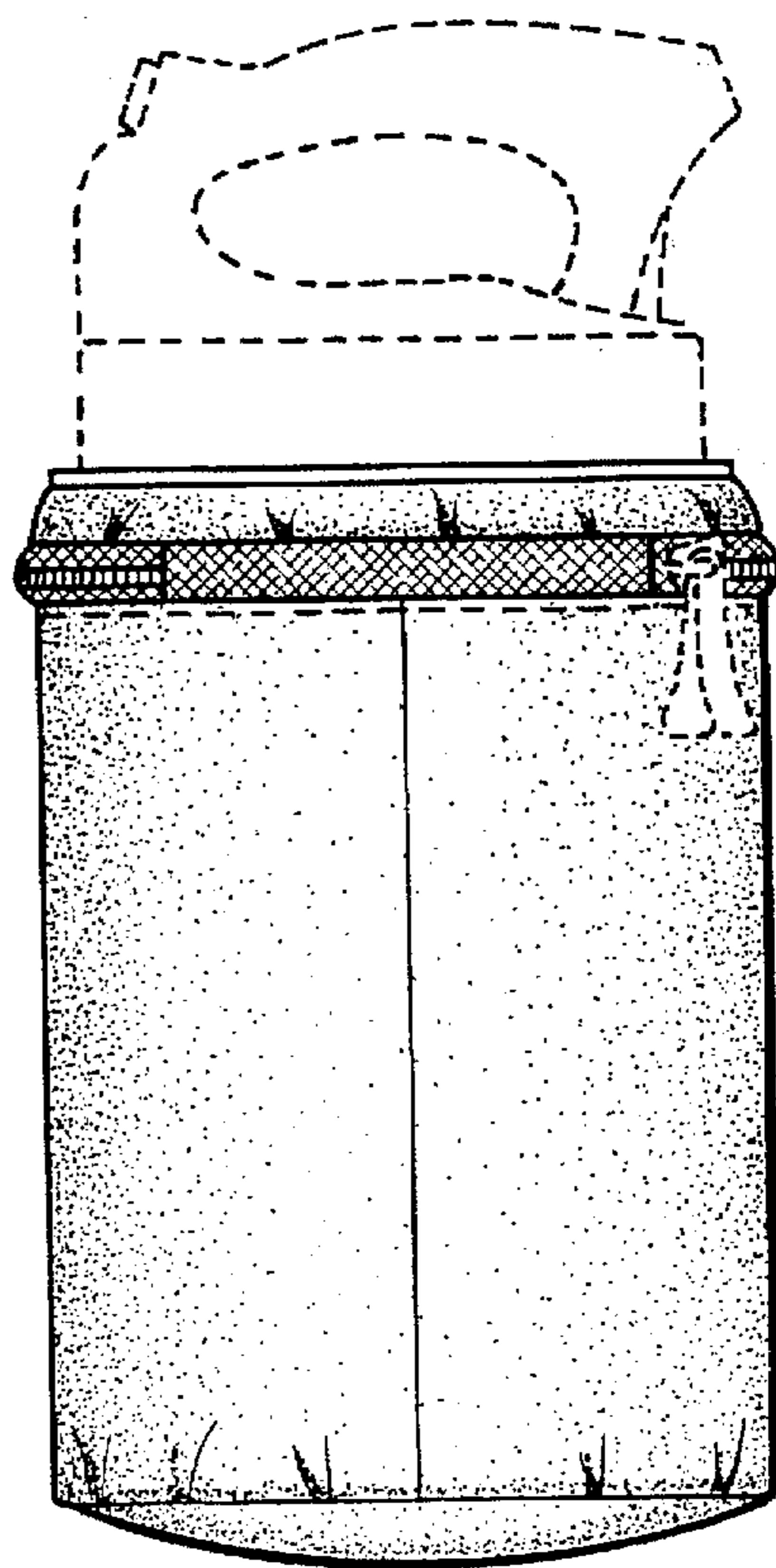

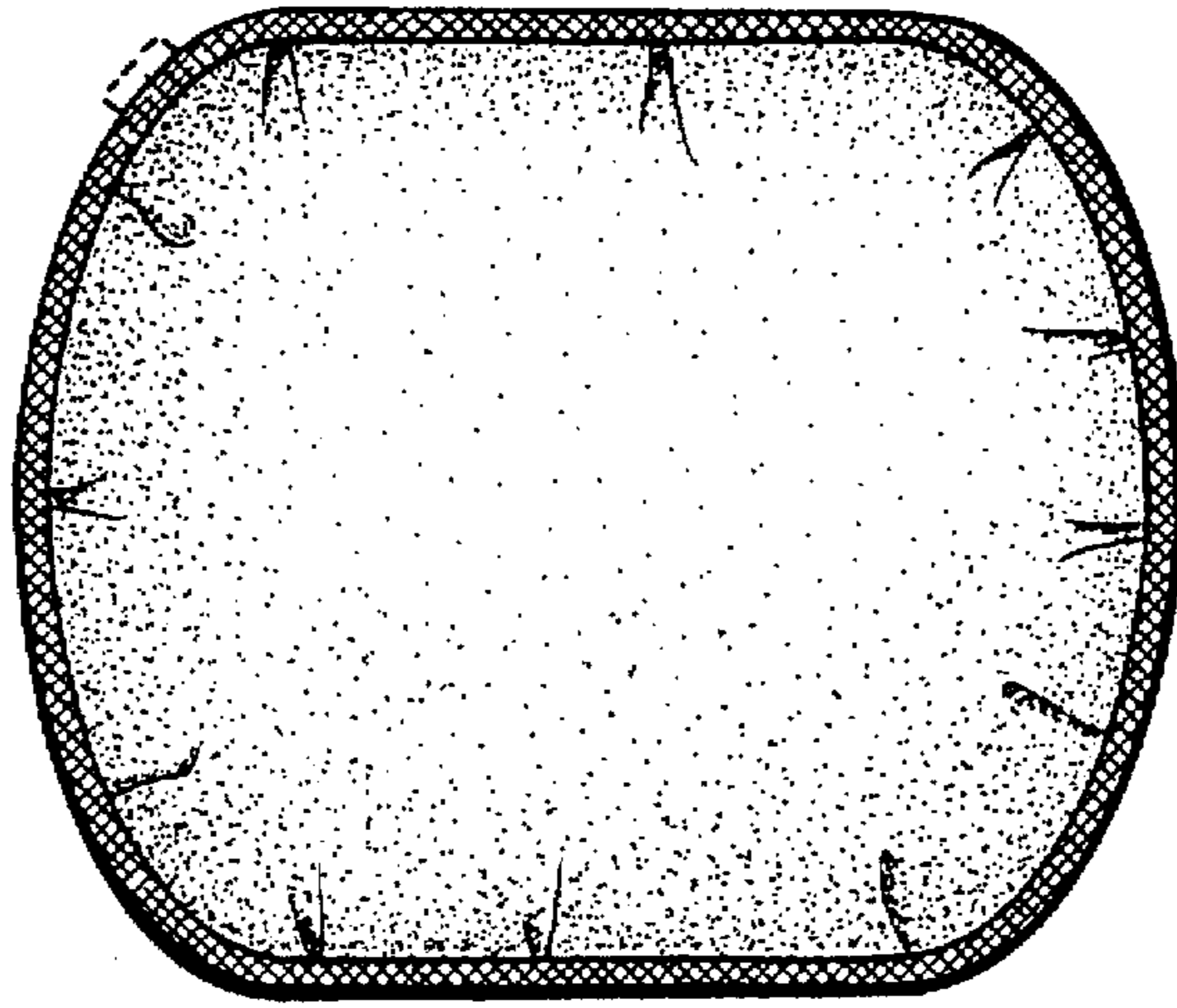
