[57] **CLAIM**

The ornamental design for a vehicle ornament, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and left side perspective view of a vehicle ornament showing my new design;

FIG. 2 is a front view of the vehicle ornament of FIG. 1;

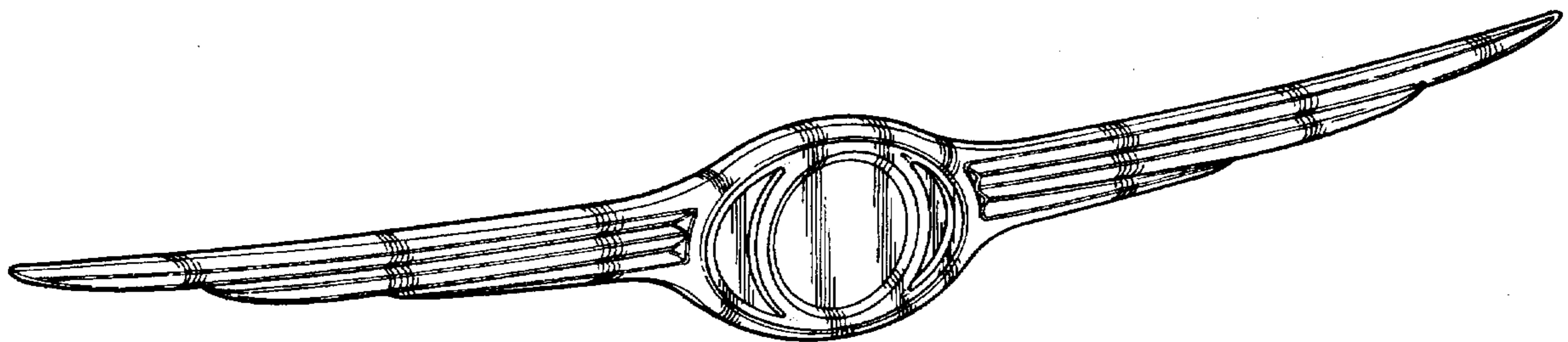
FIG. 3 is a top view of the vehicle ornament of FIG. 1; and,

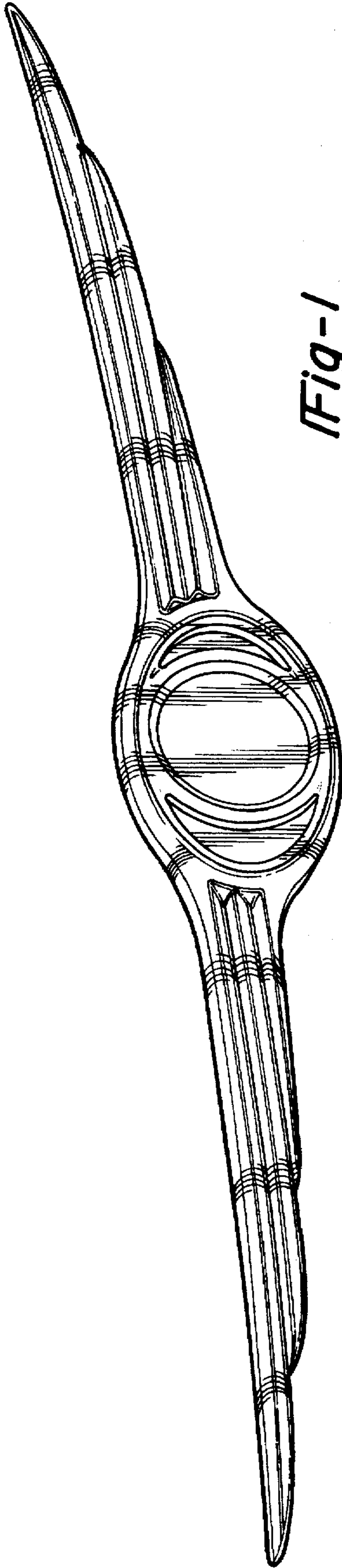

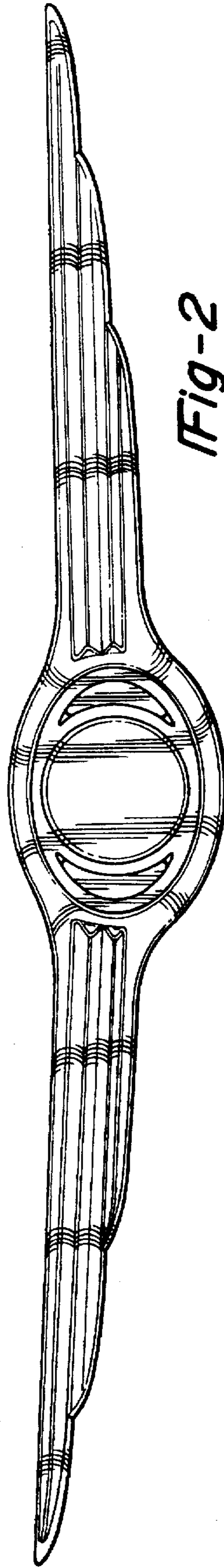

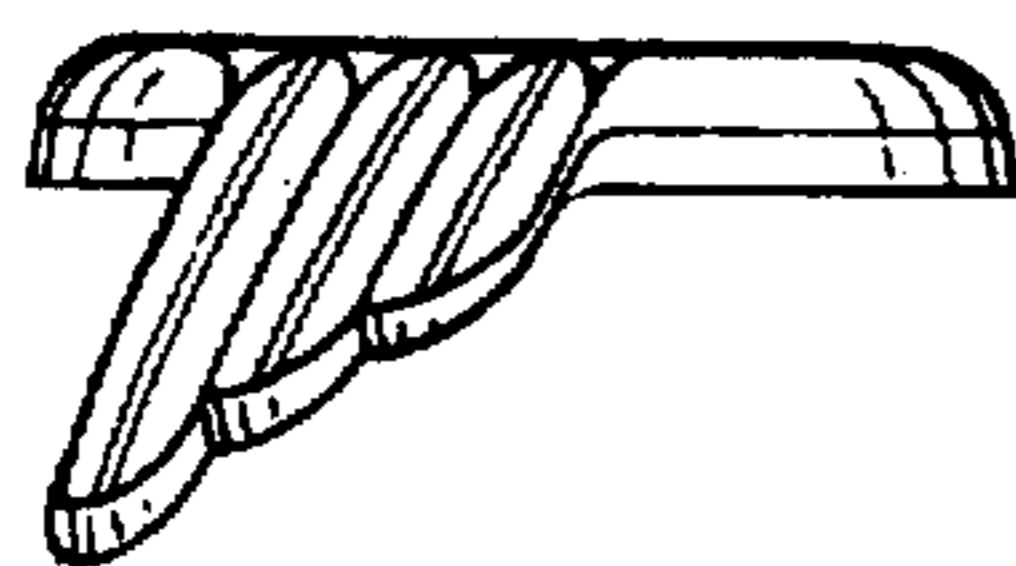

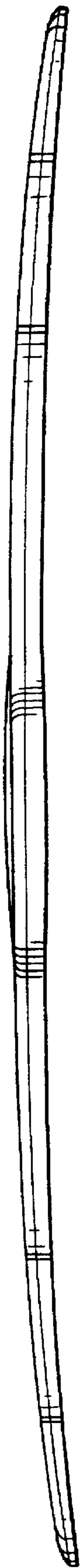

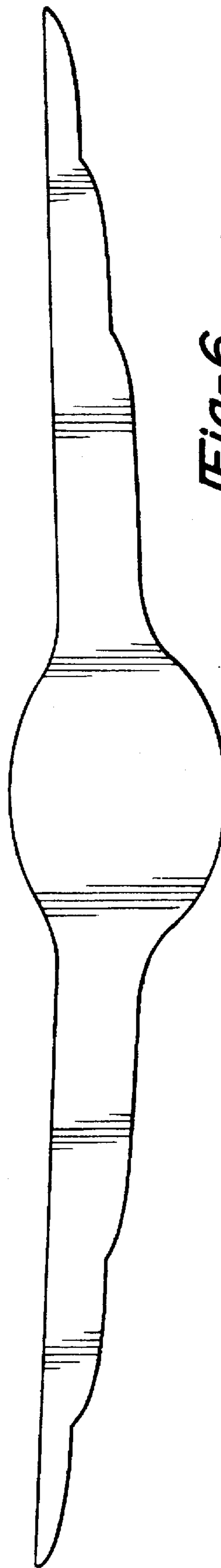
