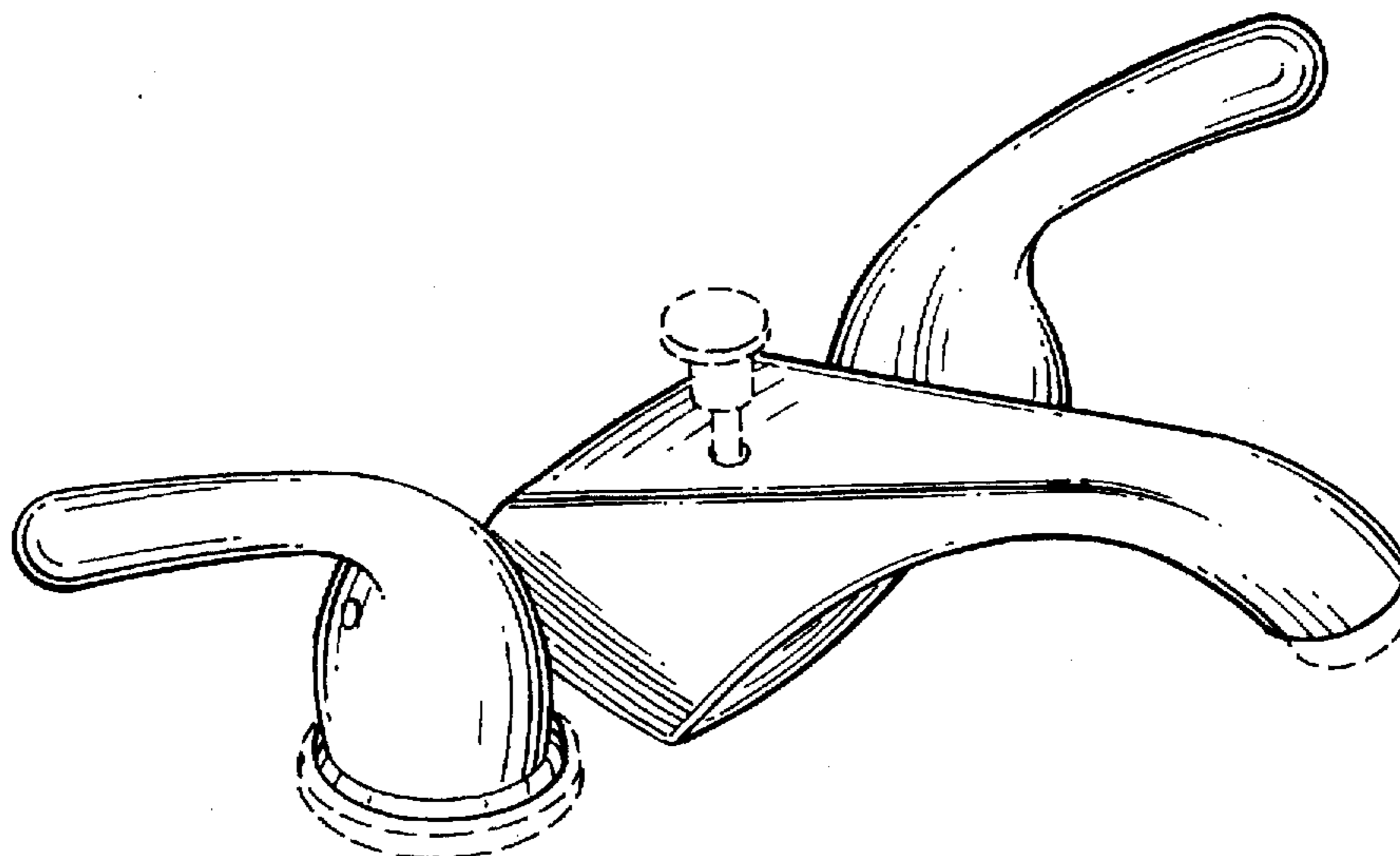
[57] CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a faucet set according to my invention;
FIG. 2 is a front view of the faucet set of FIG. 1;
FIG. 3 is a rear view of the faucet set of FIG. 1;
FIG. 4 is a left side view of the faucet set of FIG. 1;
FIG. 5 is a right side view of the faucet set of FIG. 1; and,
FIG. 6 is a top view of the faucet set of FIG. 1.
The portions of the figures shown in broken lines are for illustrative purposes only with respect to the environment of which the faucet set is used and form no part of the claimed design.

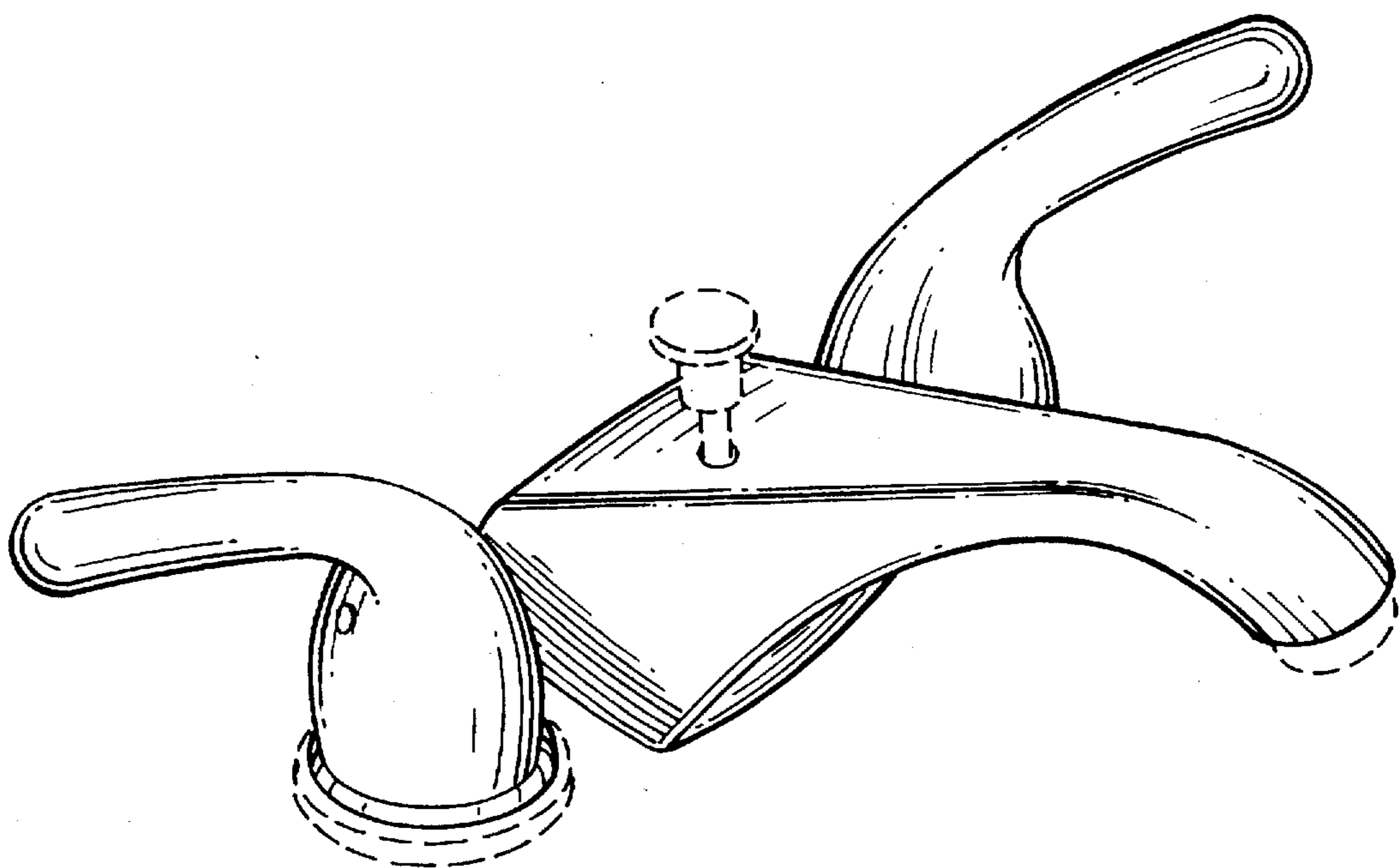

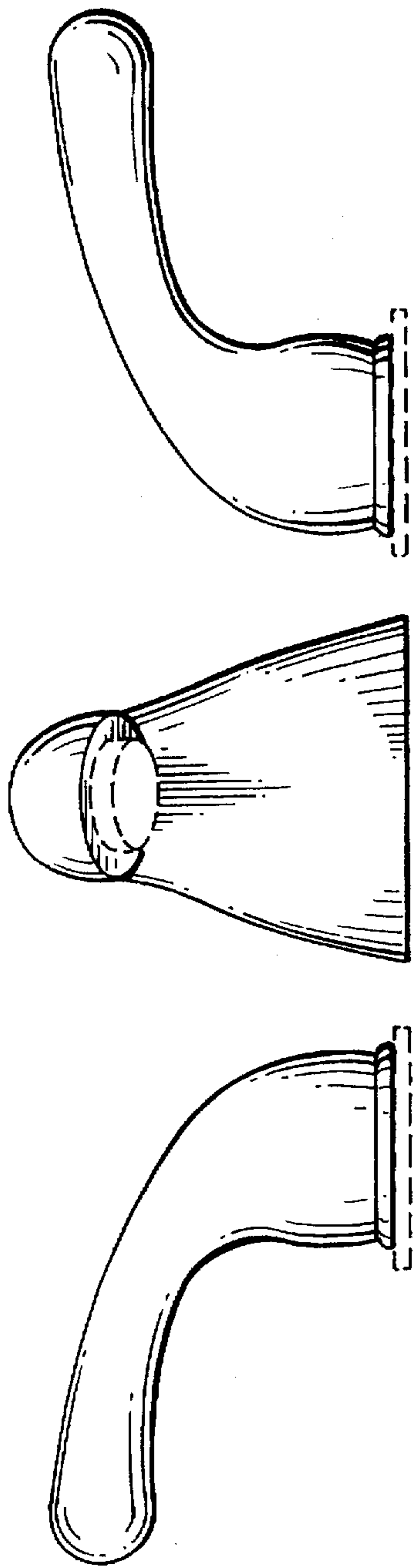

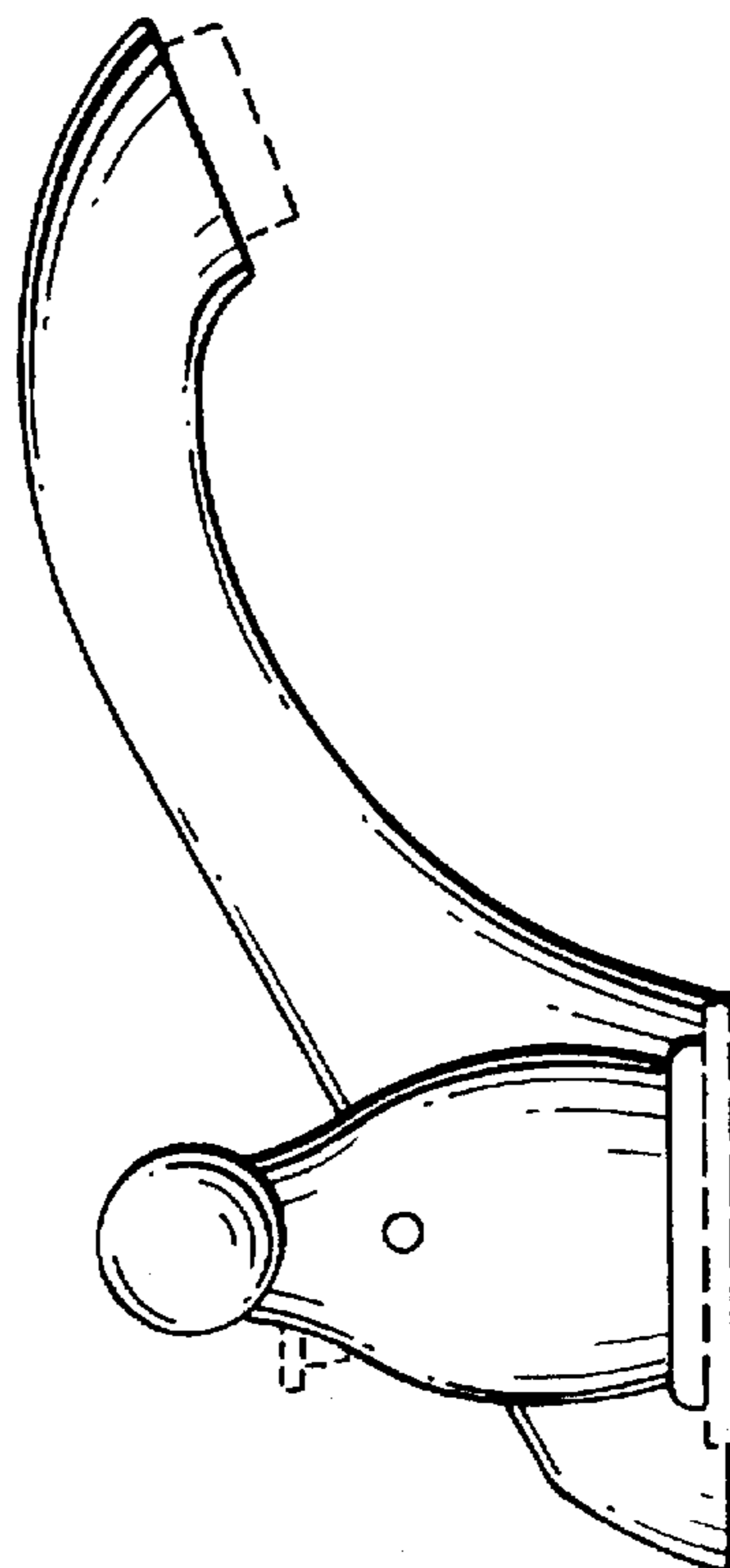

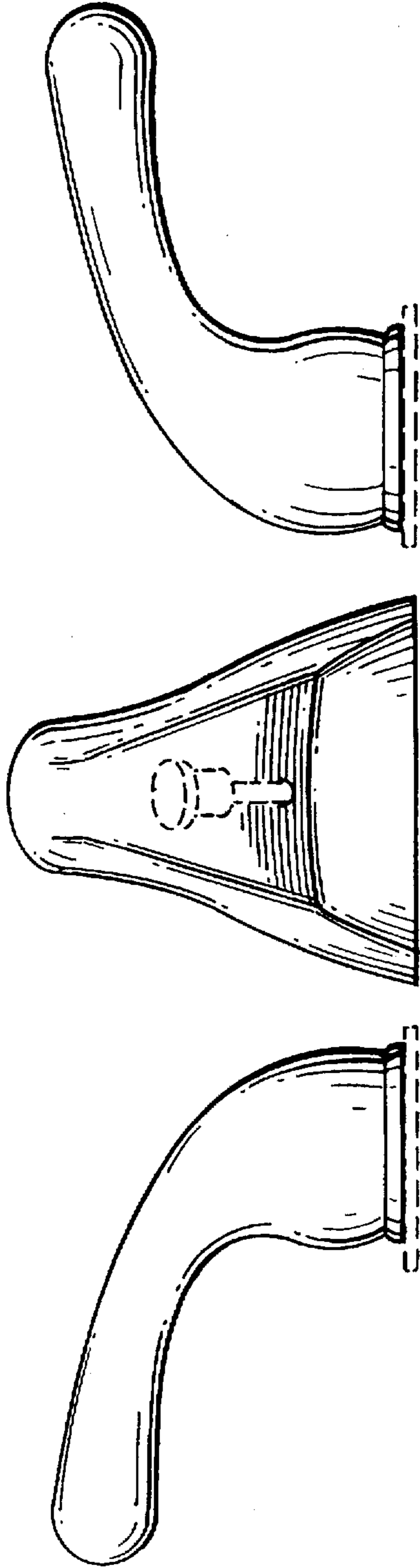

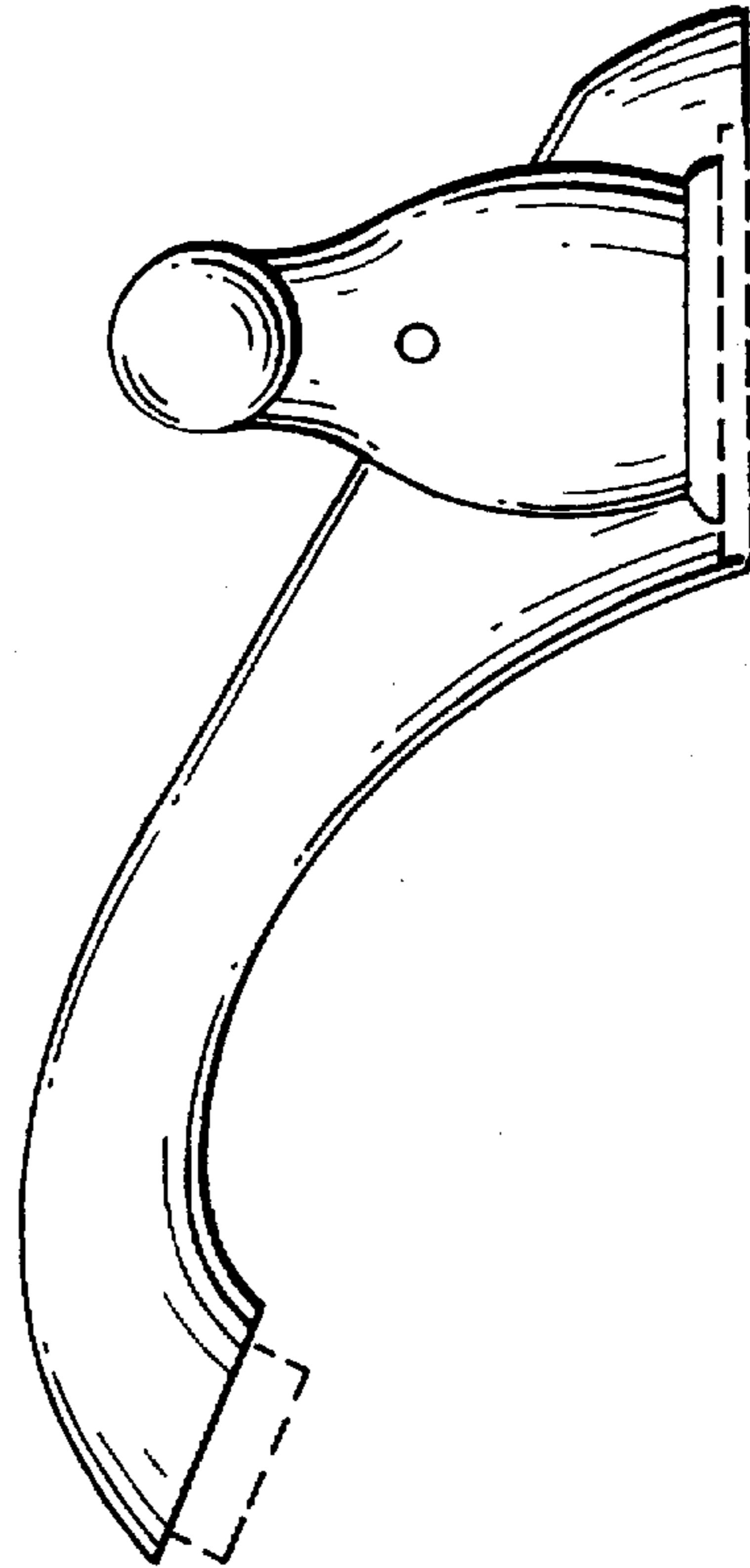

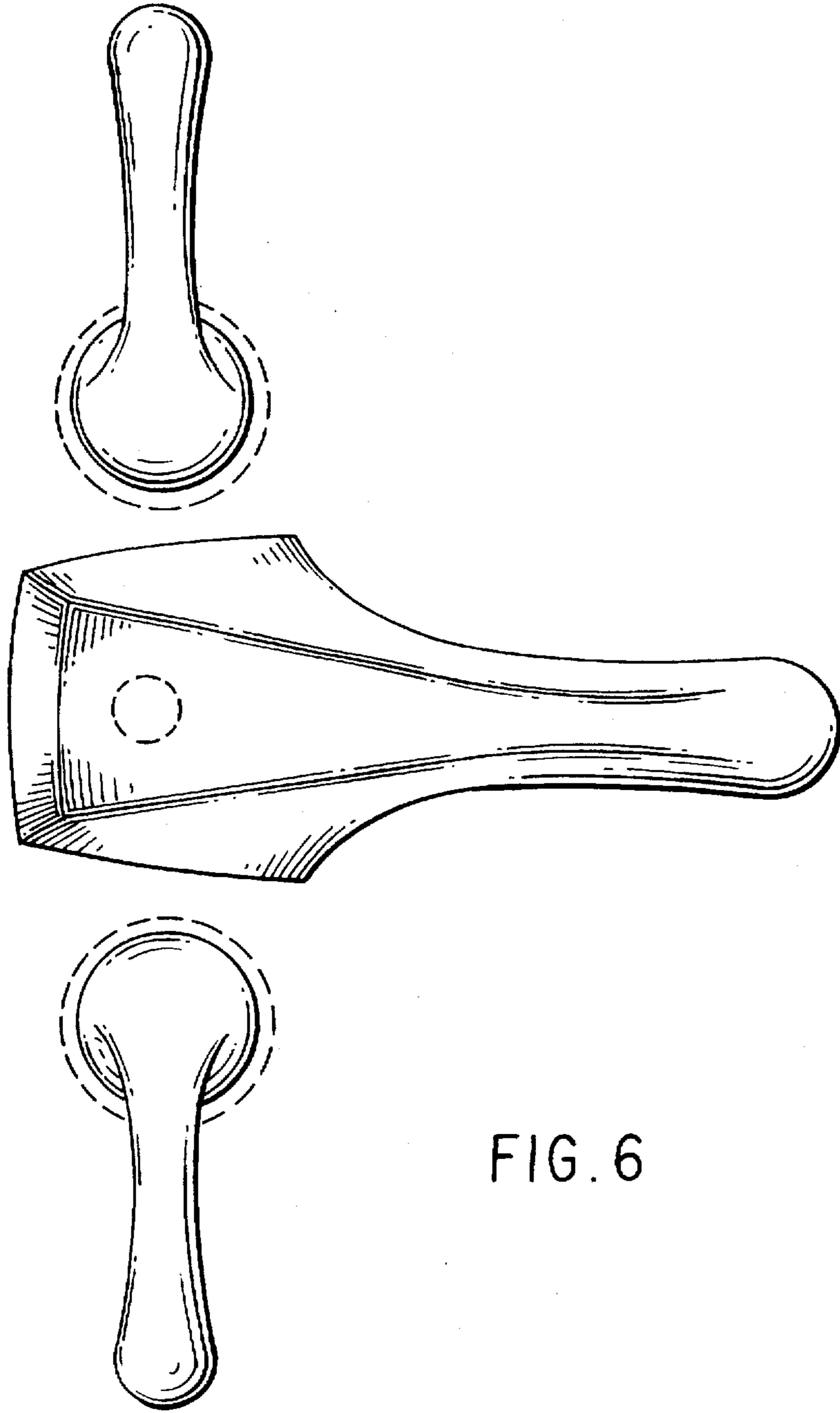
