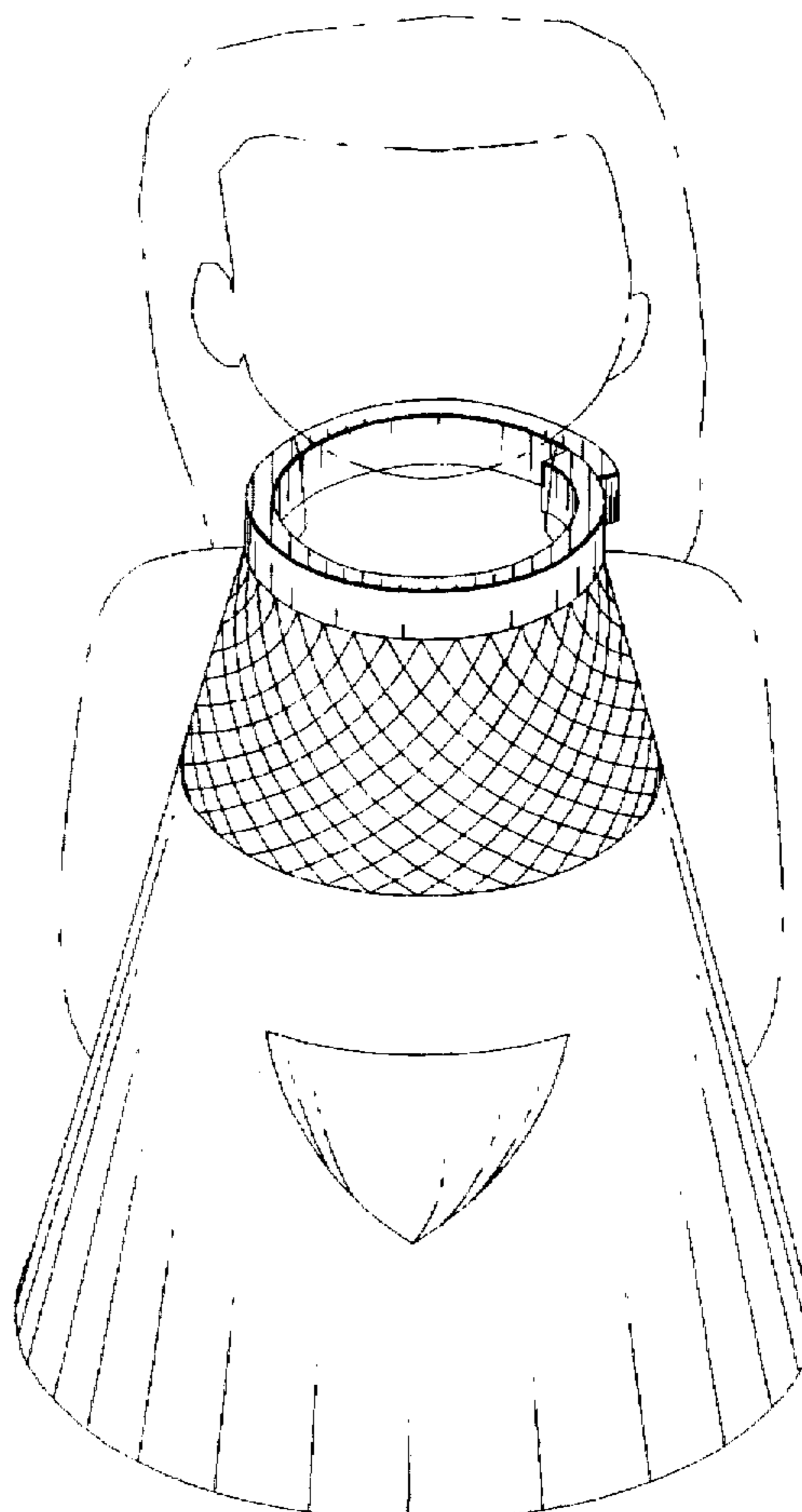
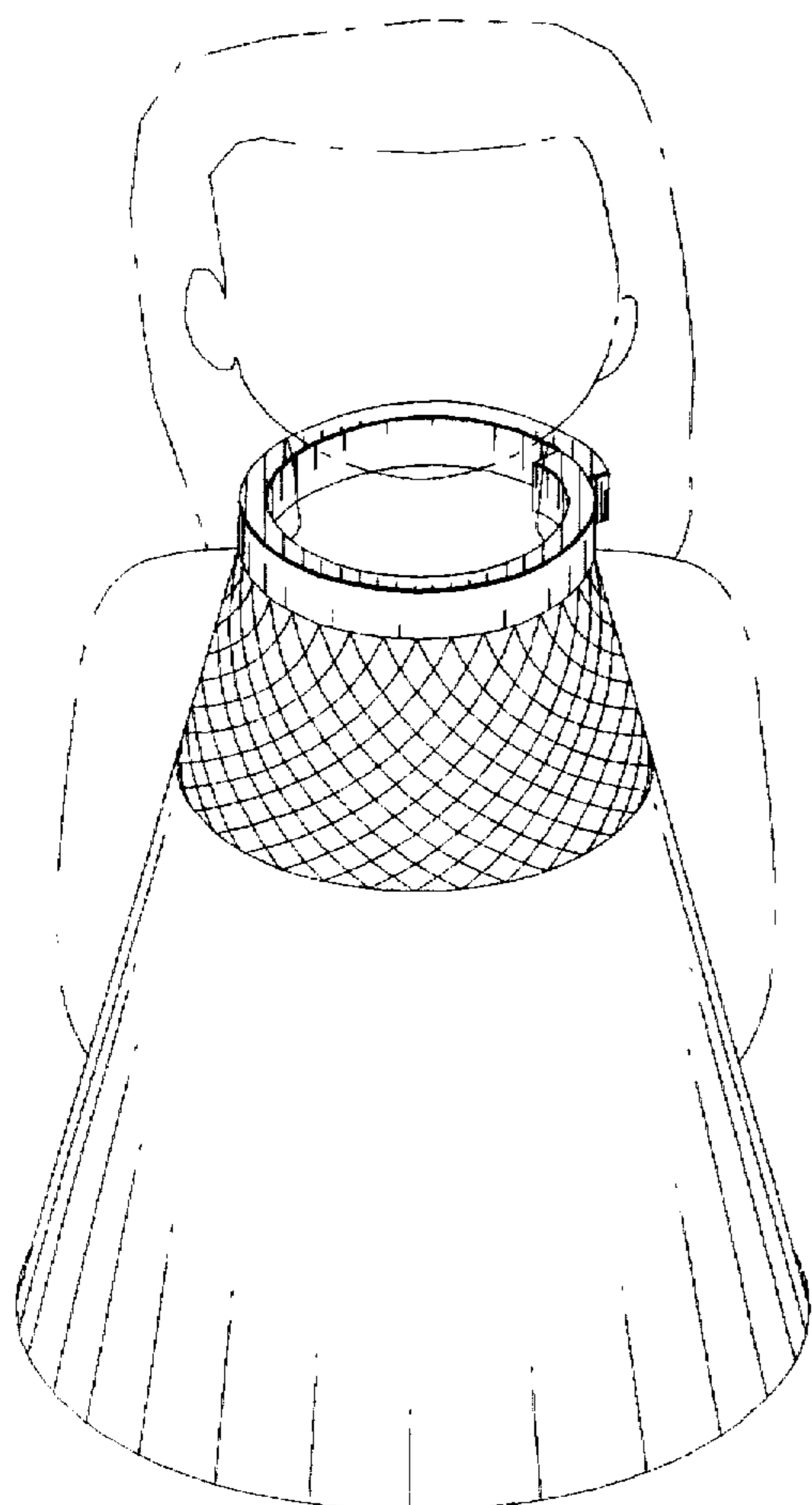
The ornamental design for a nursing blanket, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a nursing blanket showing my new design;

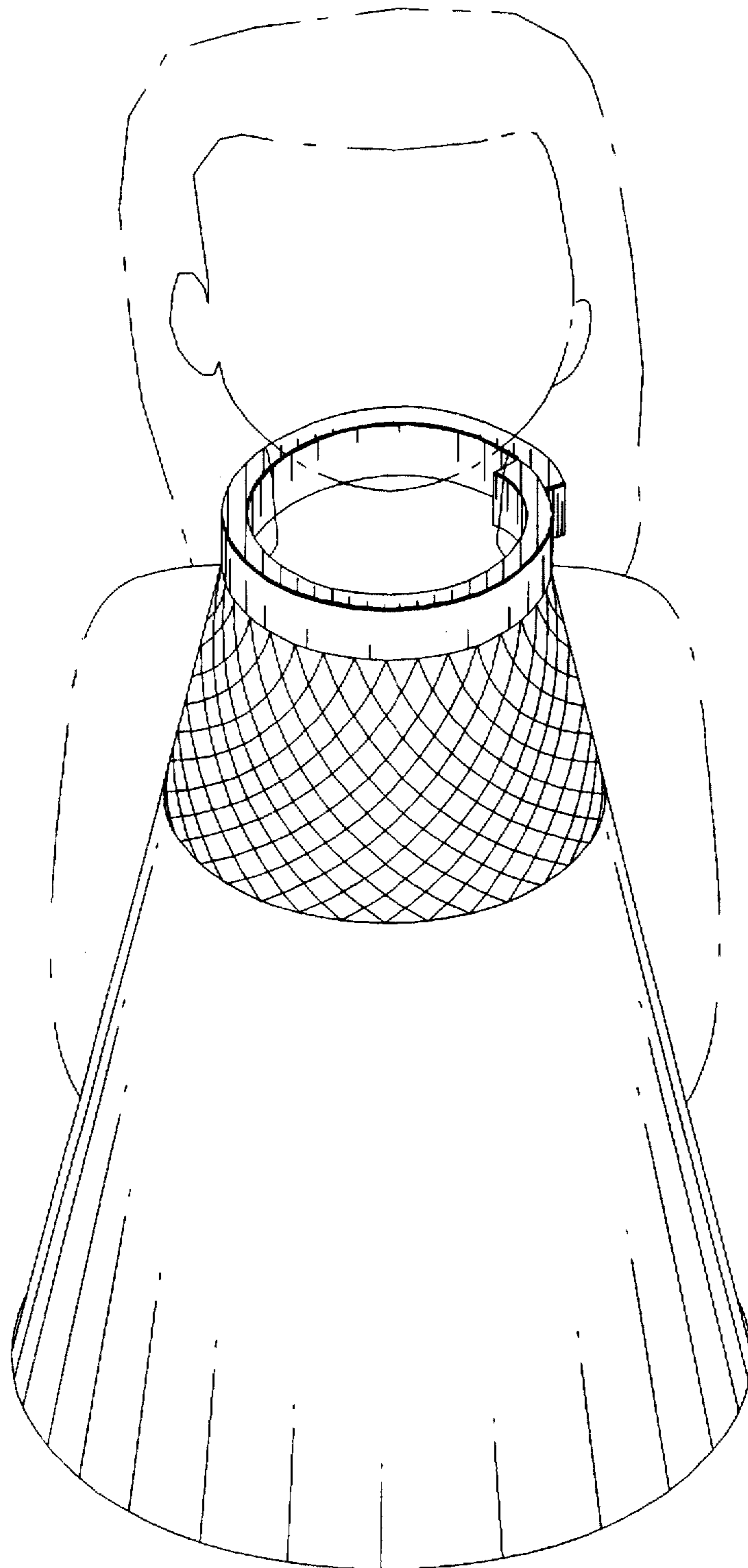

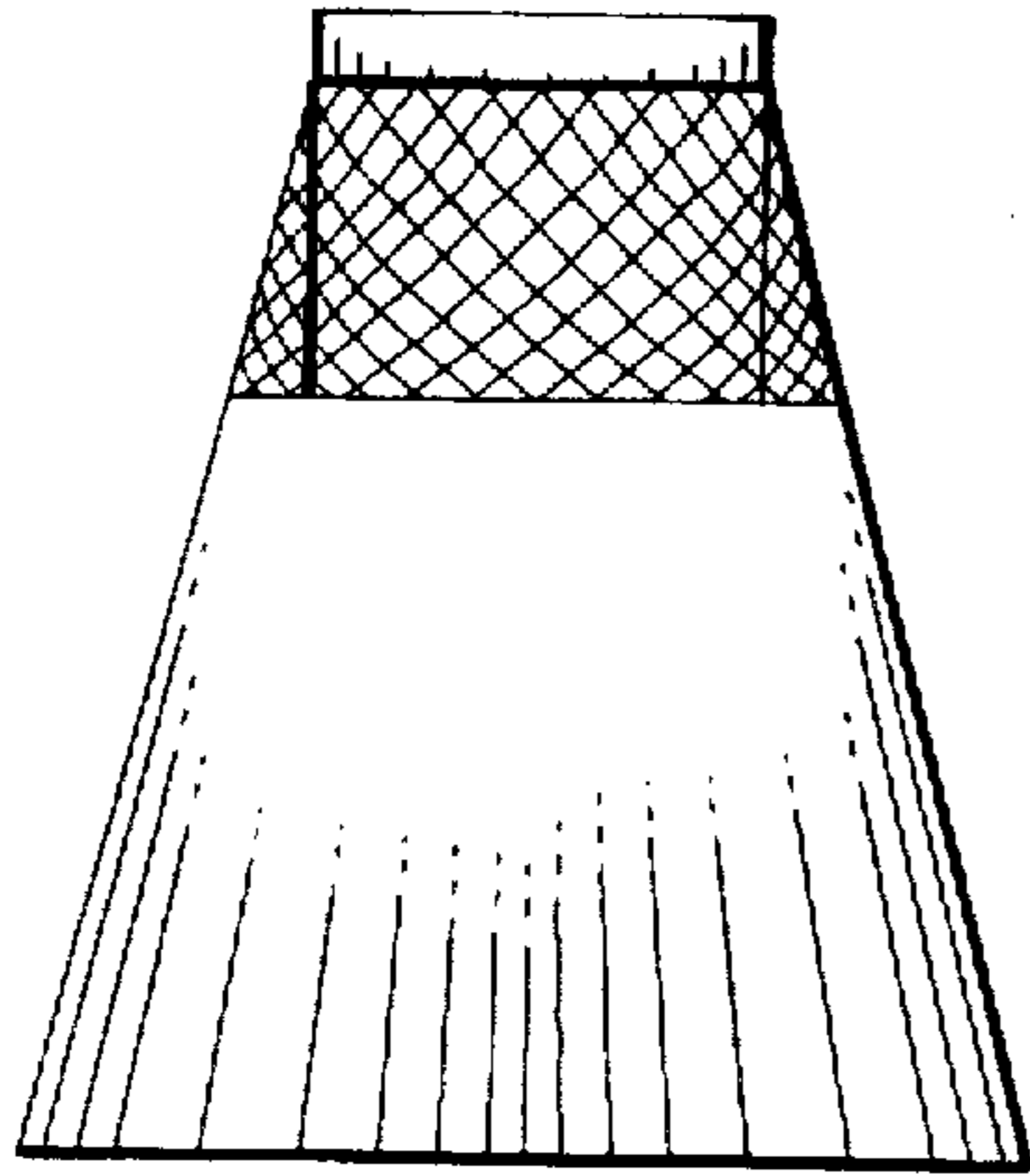

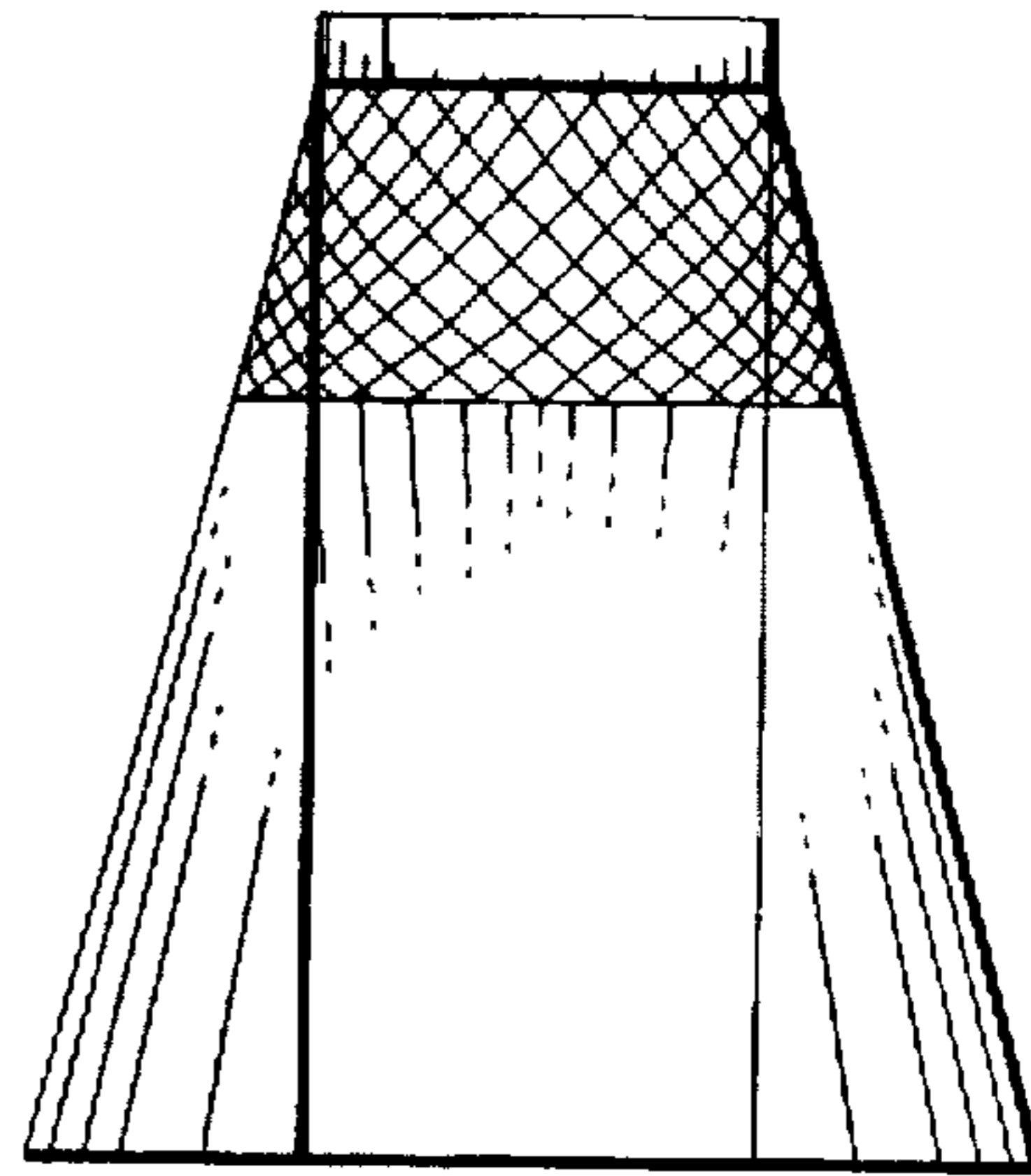

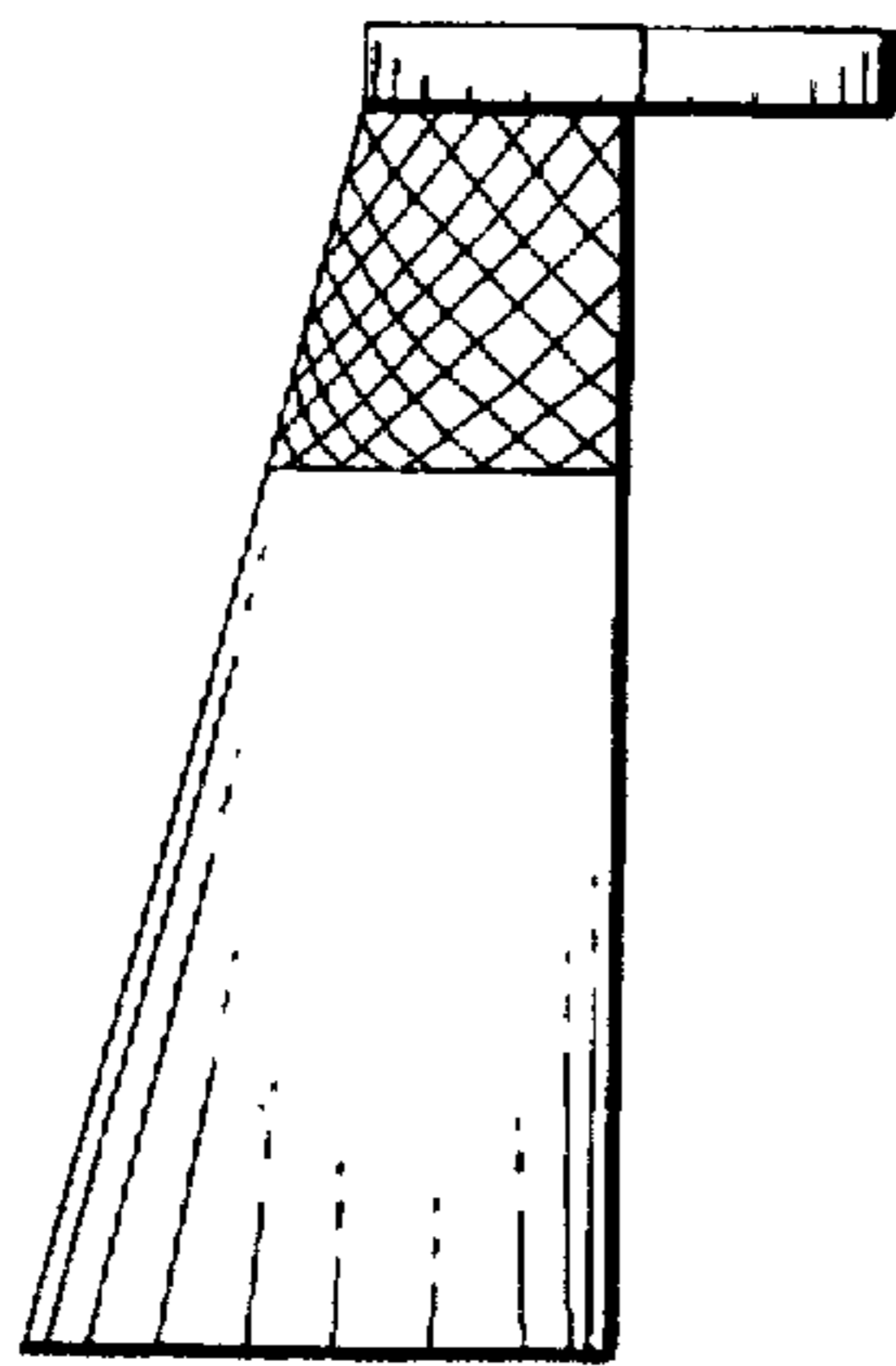

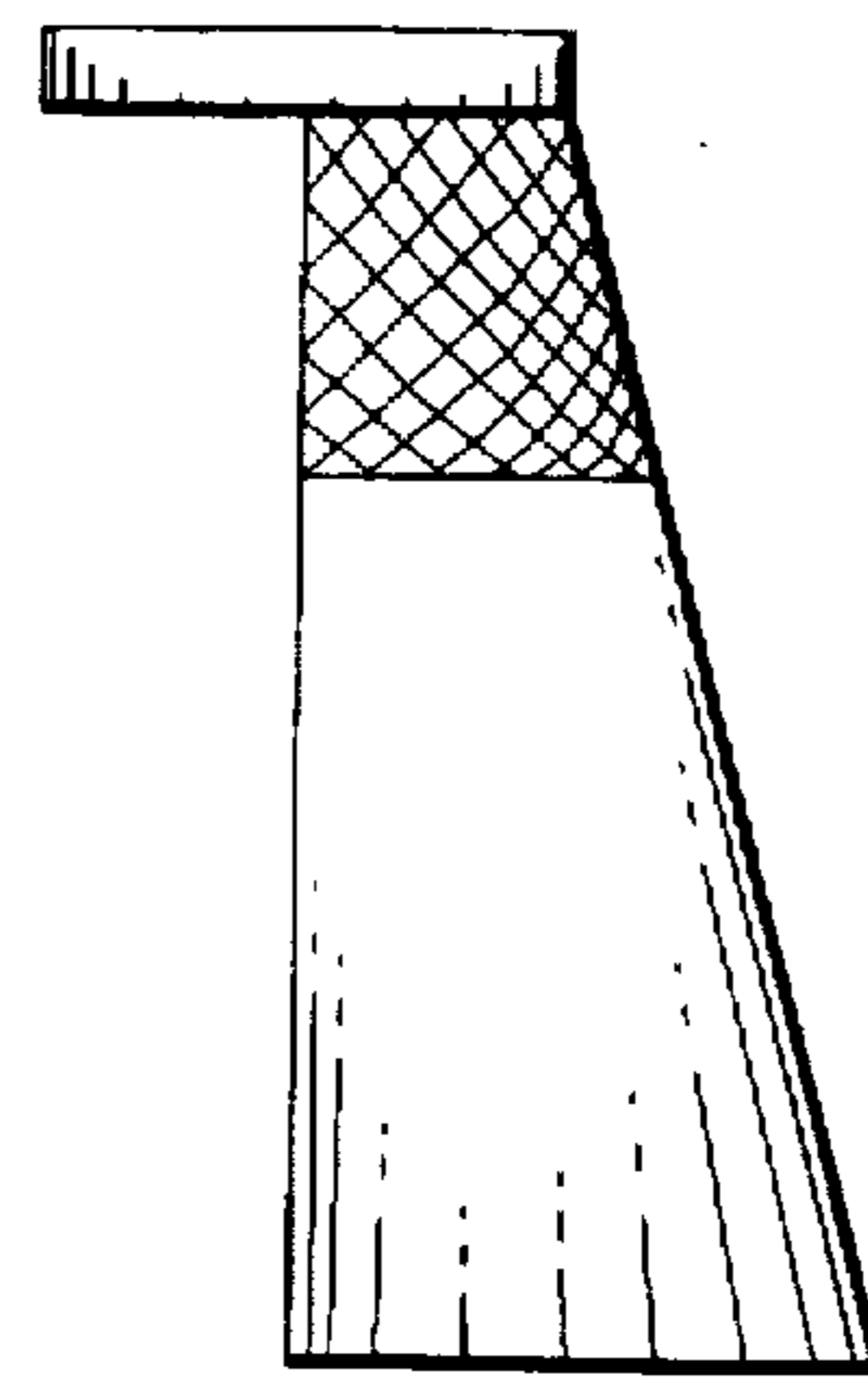

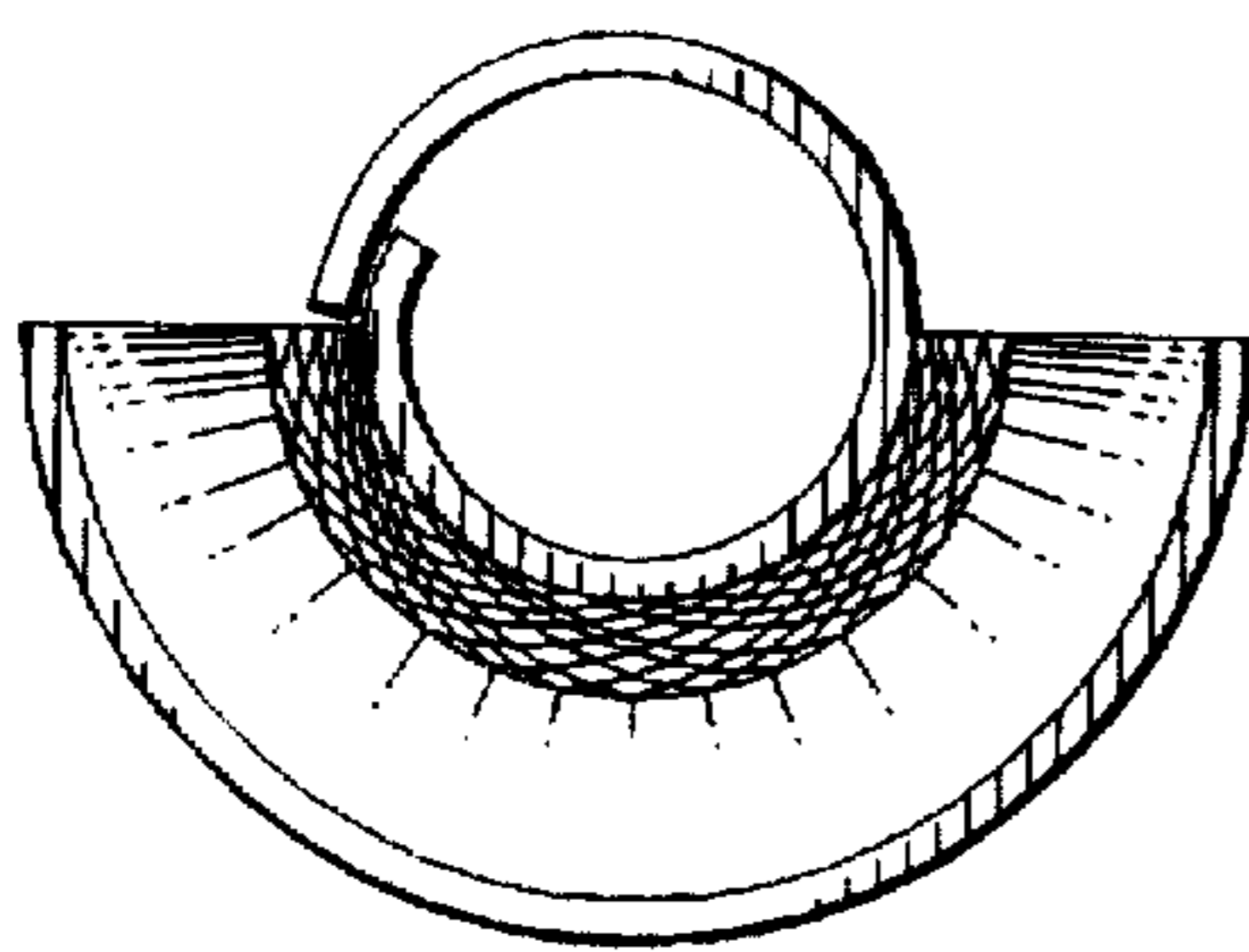

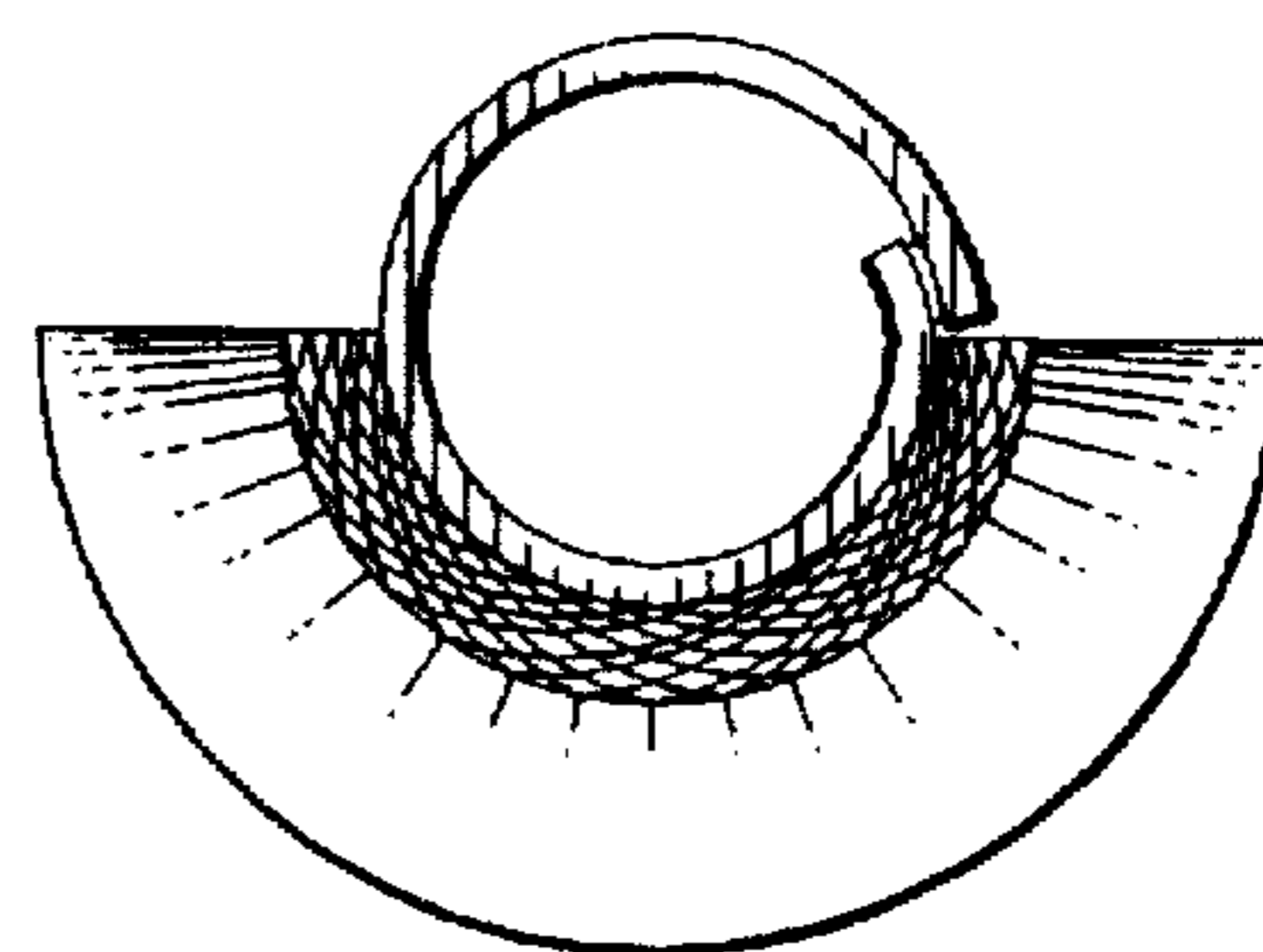

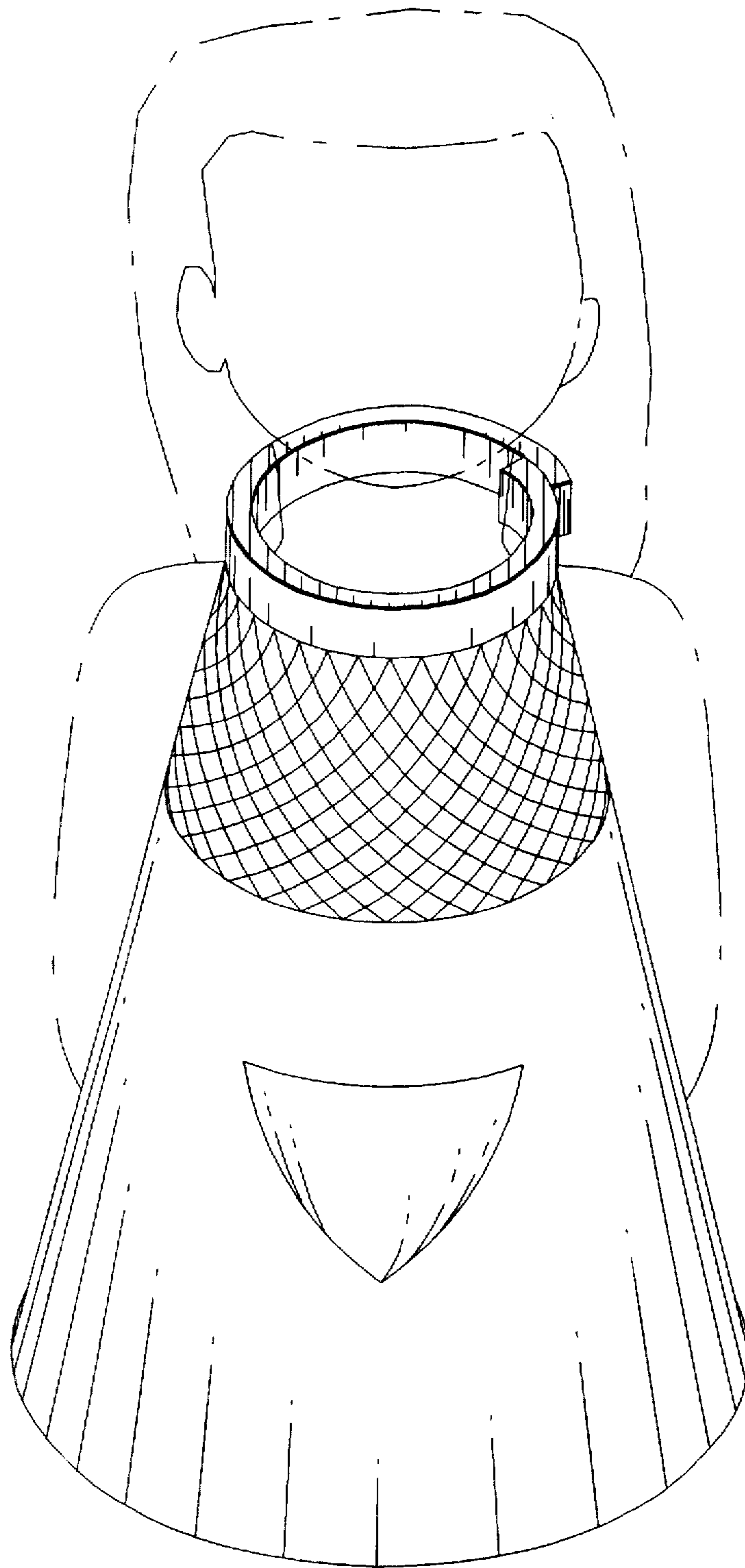

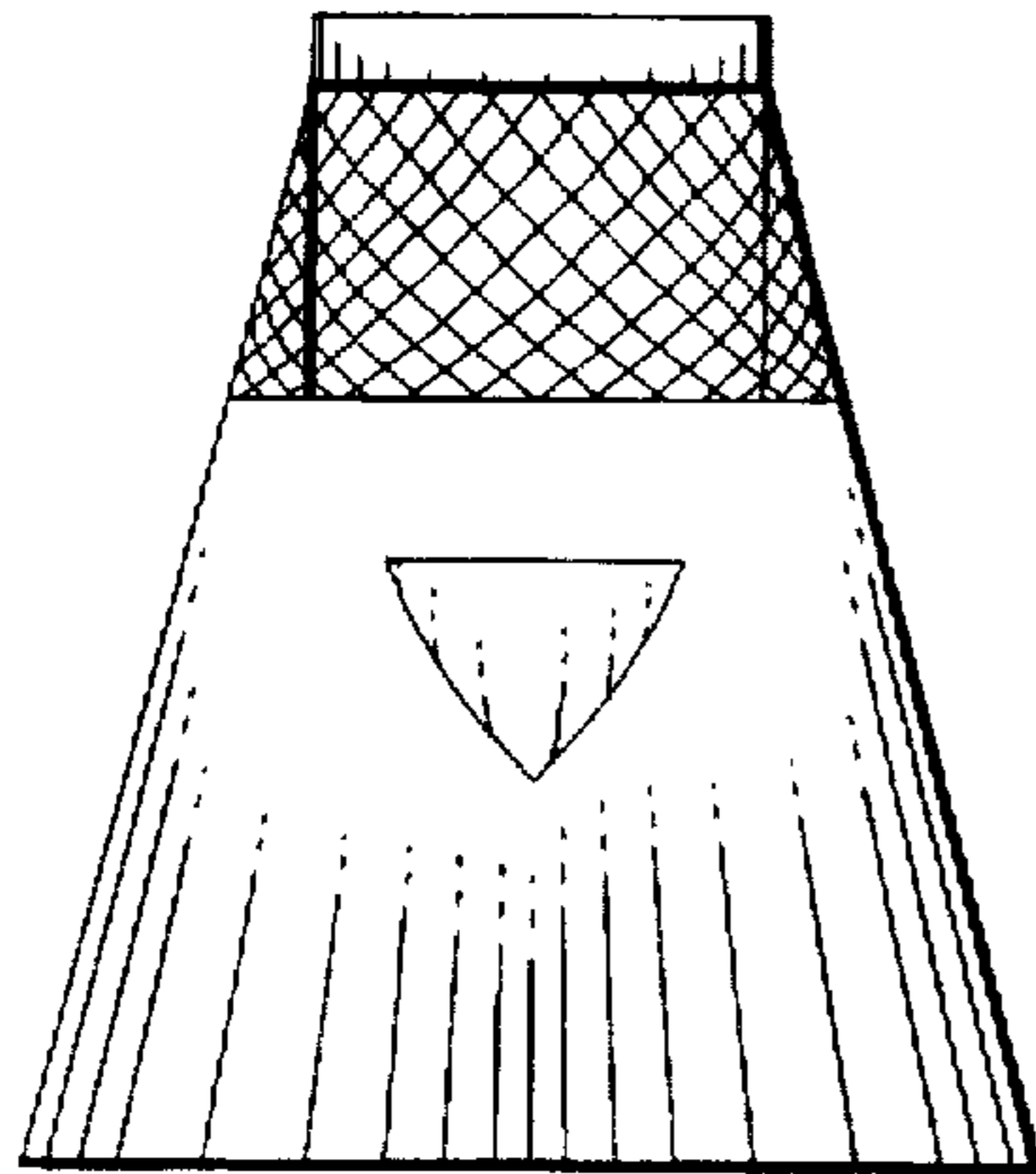

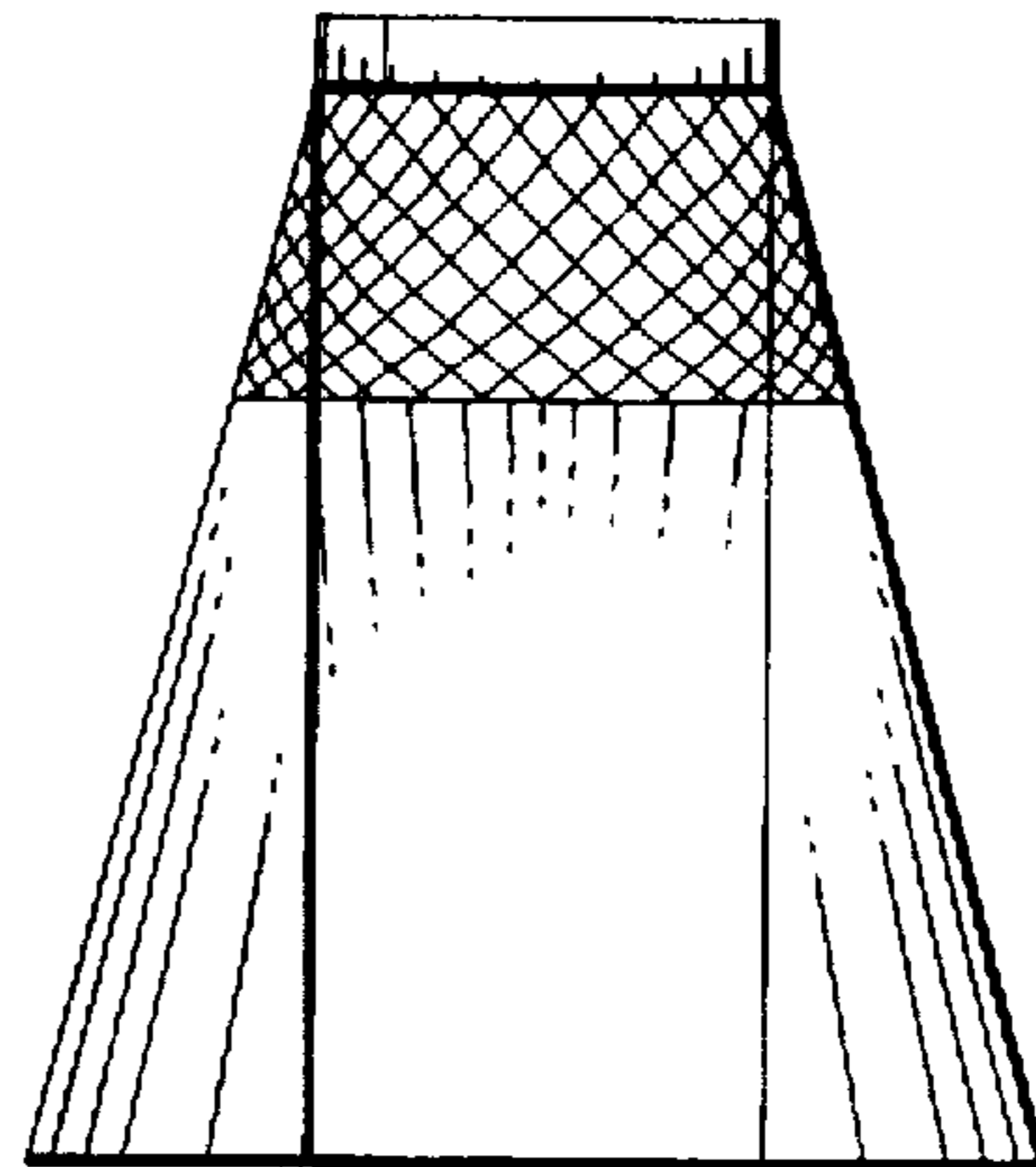

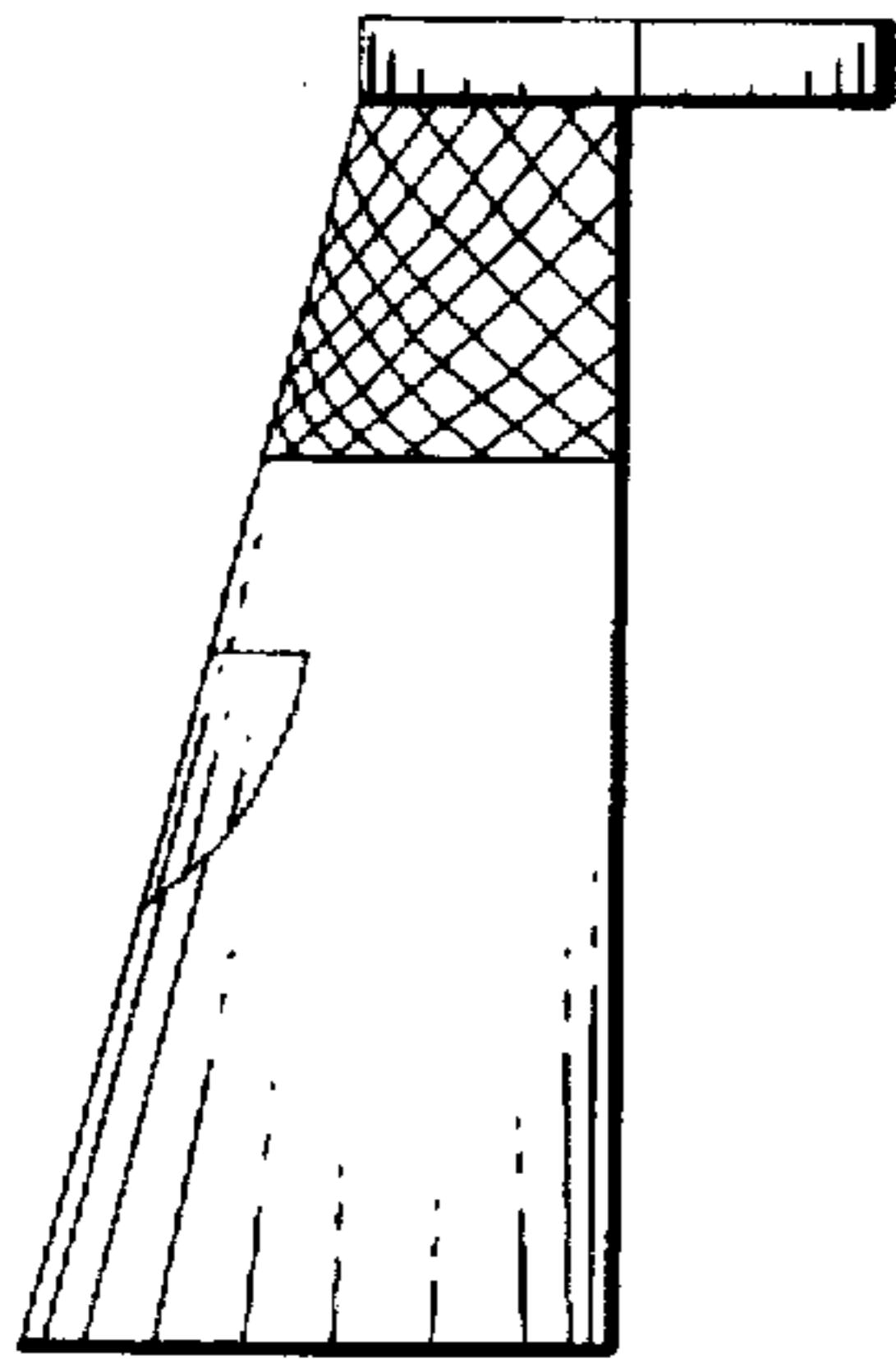

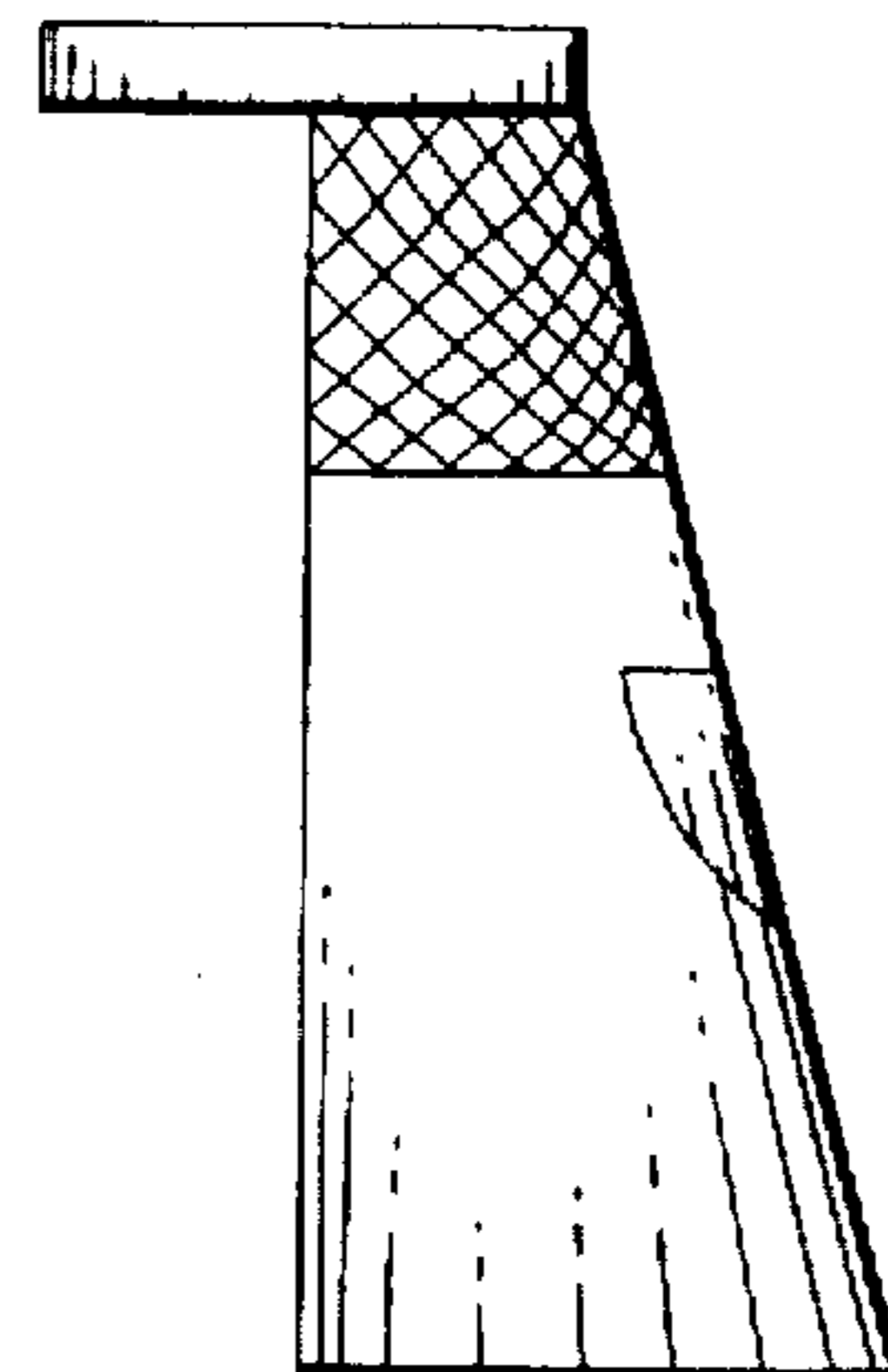

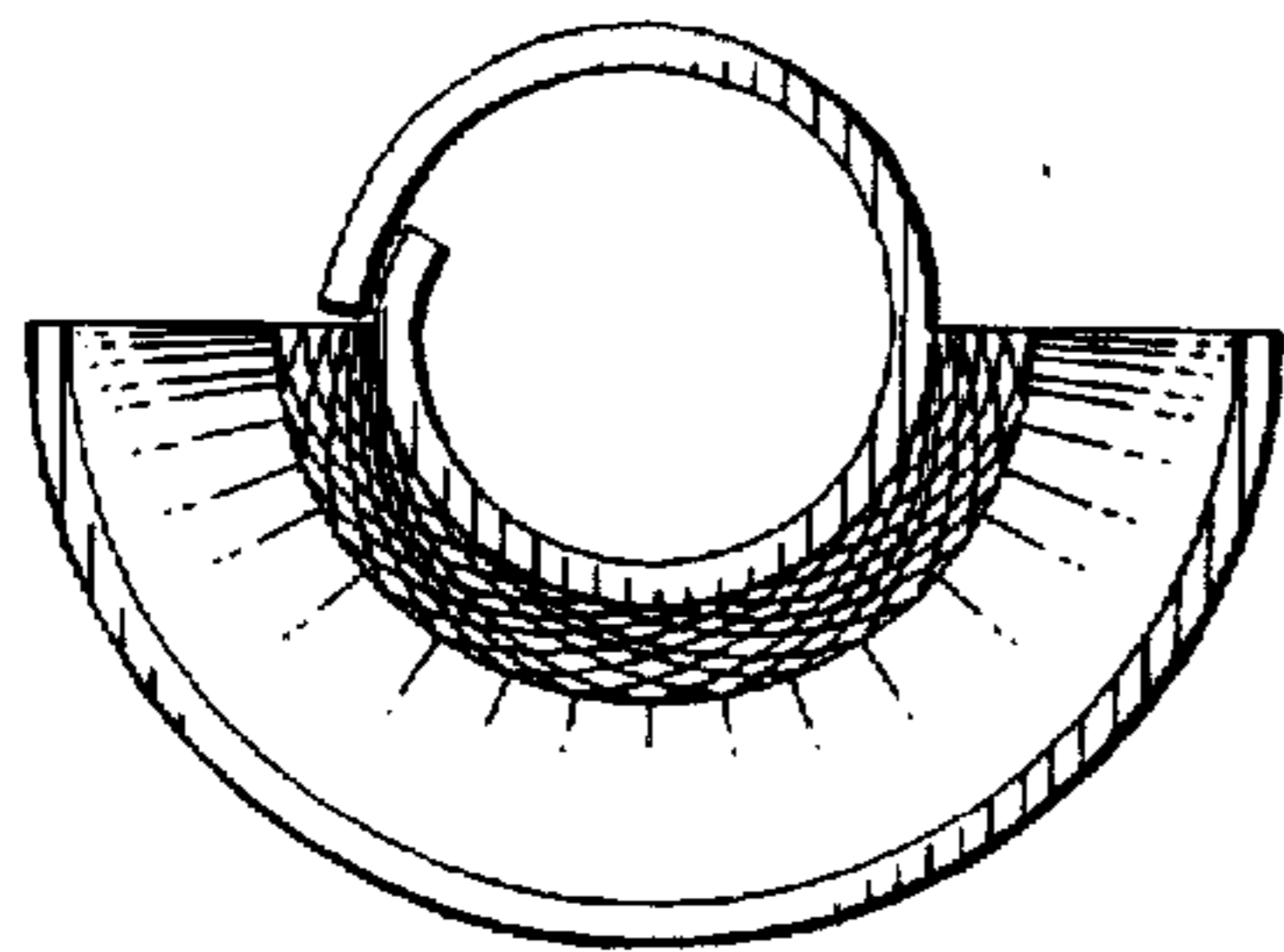

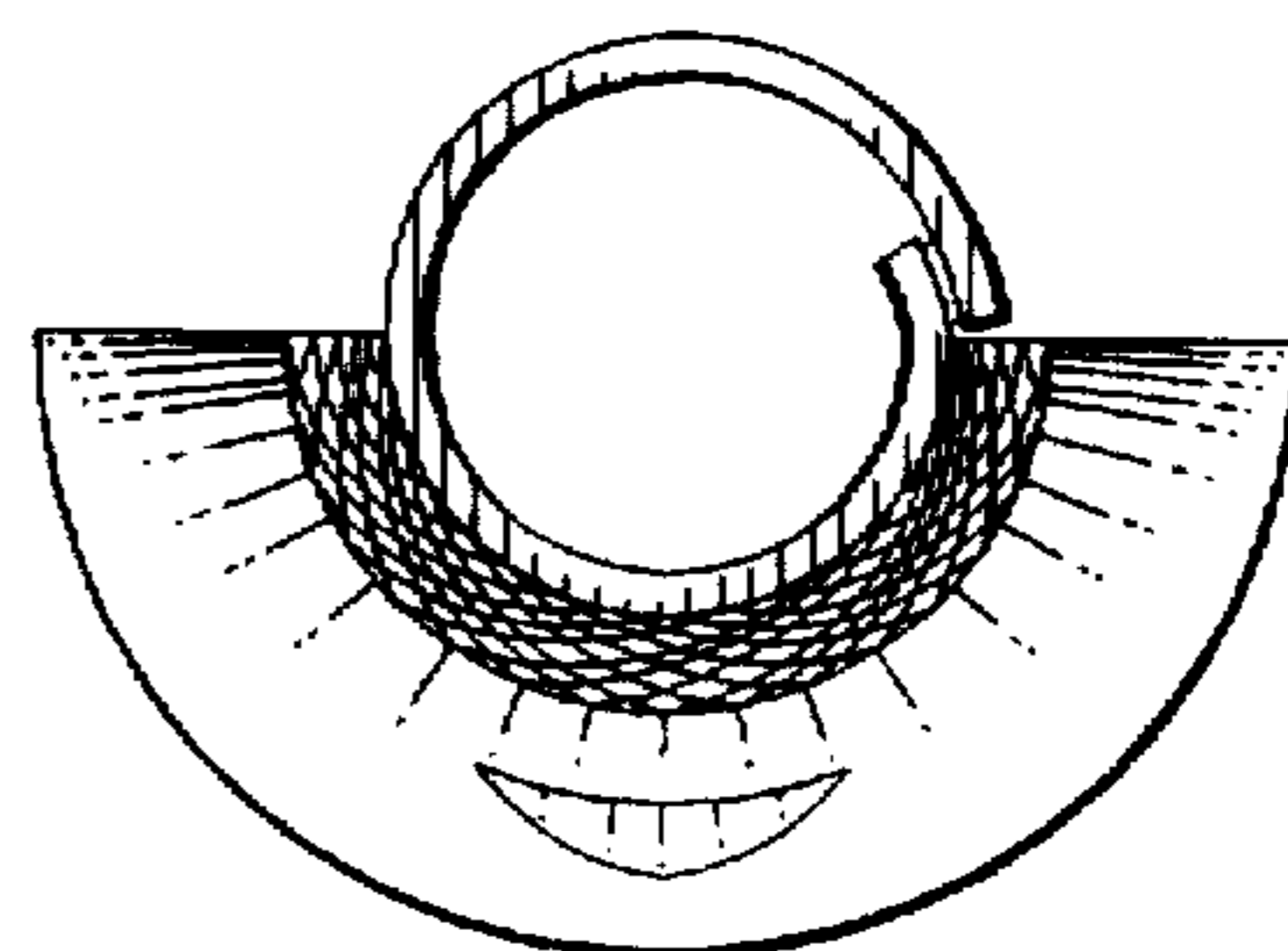
