[57] **CLAIM**

The ornamental design for a patient cable connector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top and one side of a patient cable connector showing our new design, with the broken lines showing a sensor tab and a cord being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a perspective view of the bottom and opposite side of the patient cable connector;

FIG. 3 is a top plan view thereof;

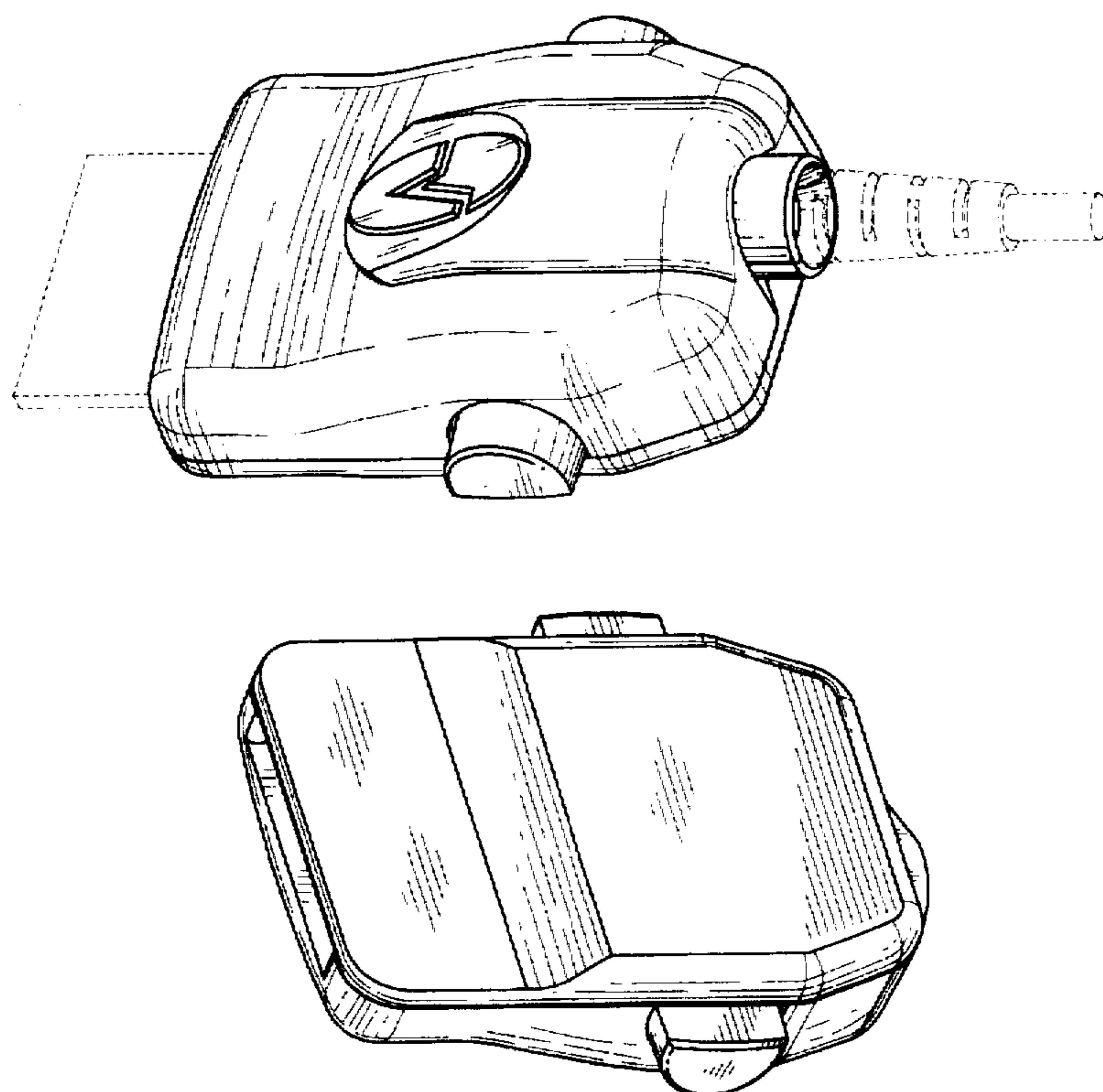
FIG. 4 is a front elevational view thereof;

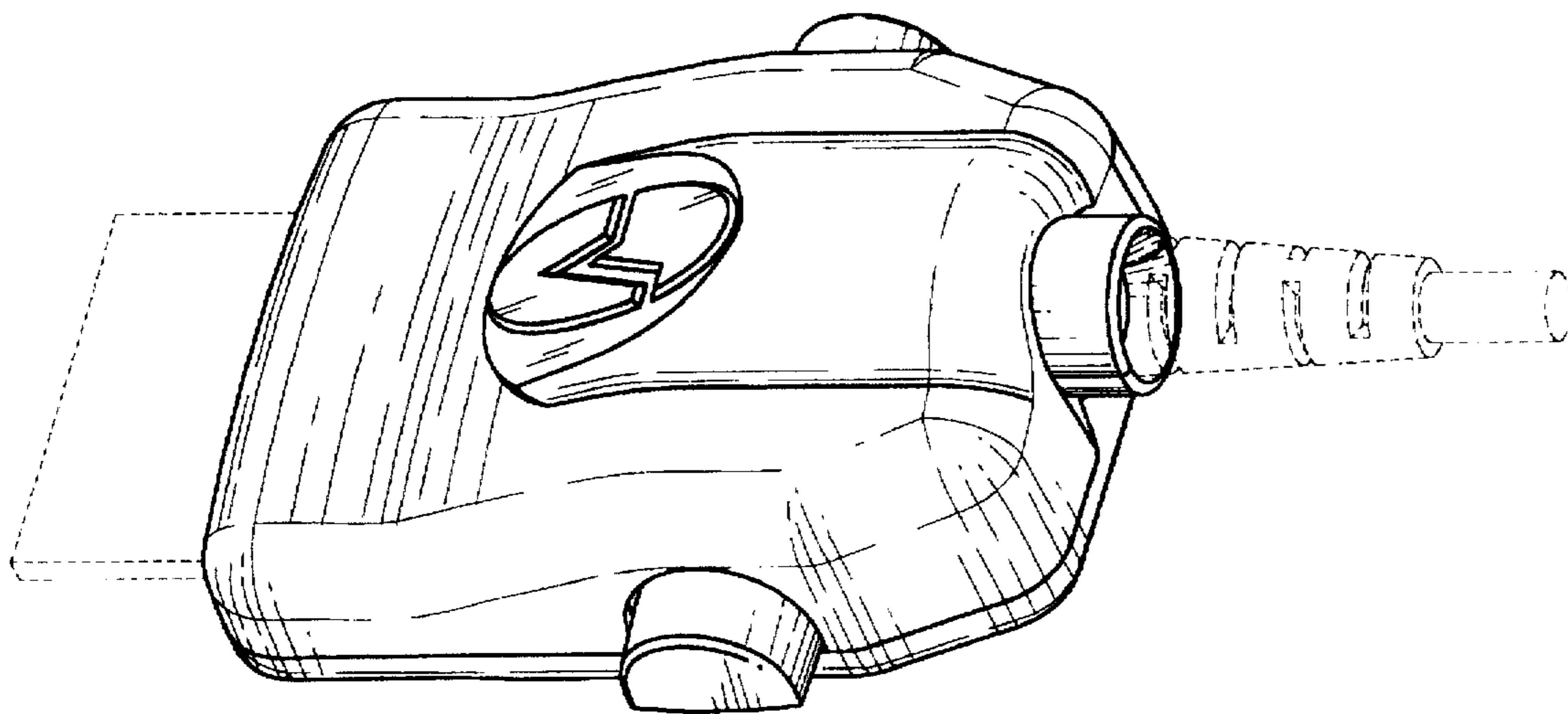

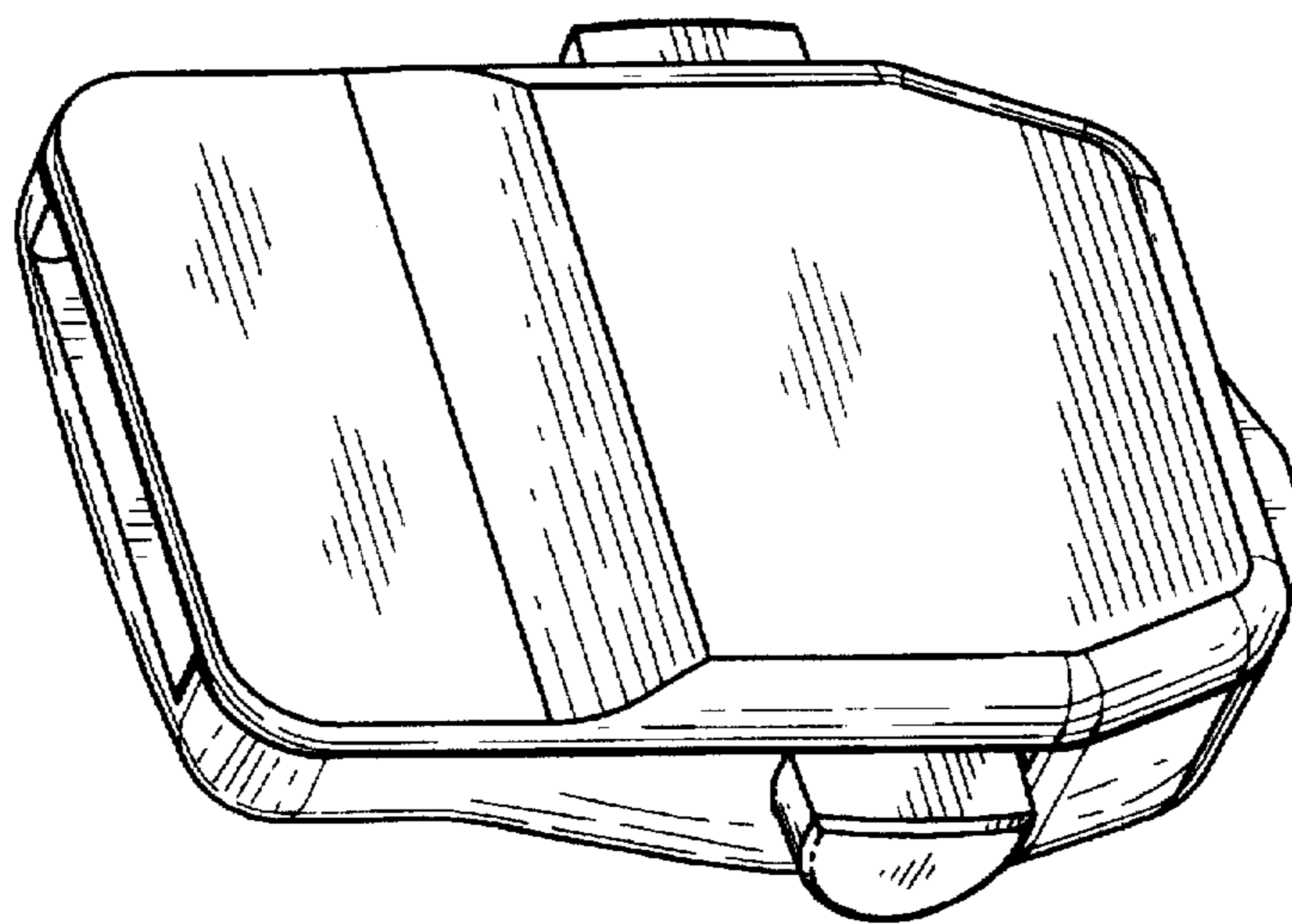

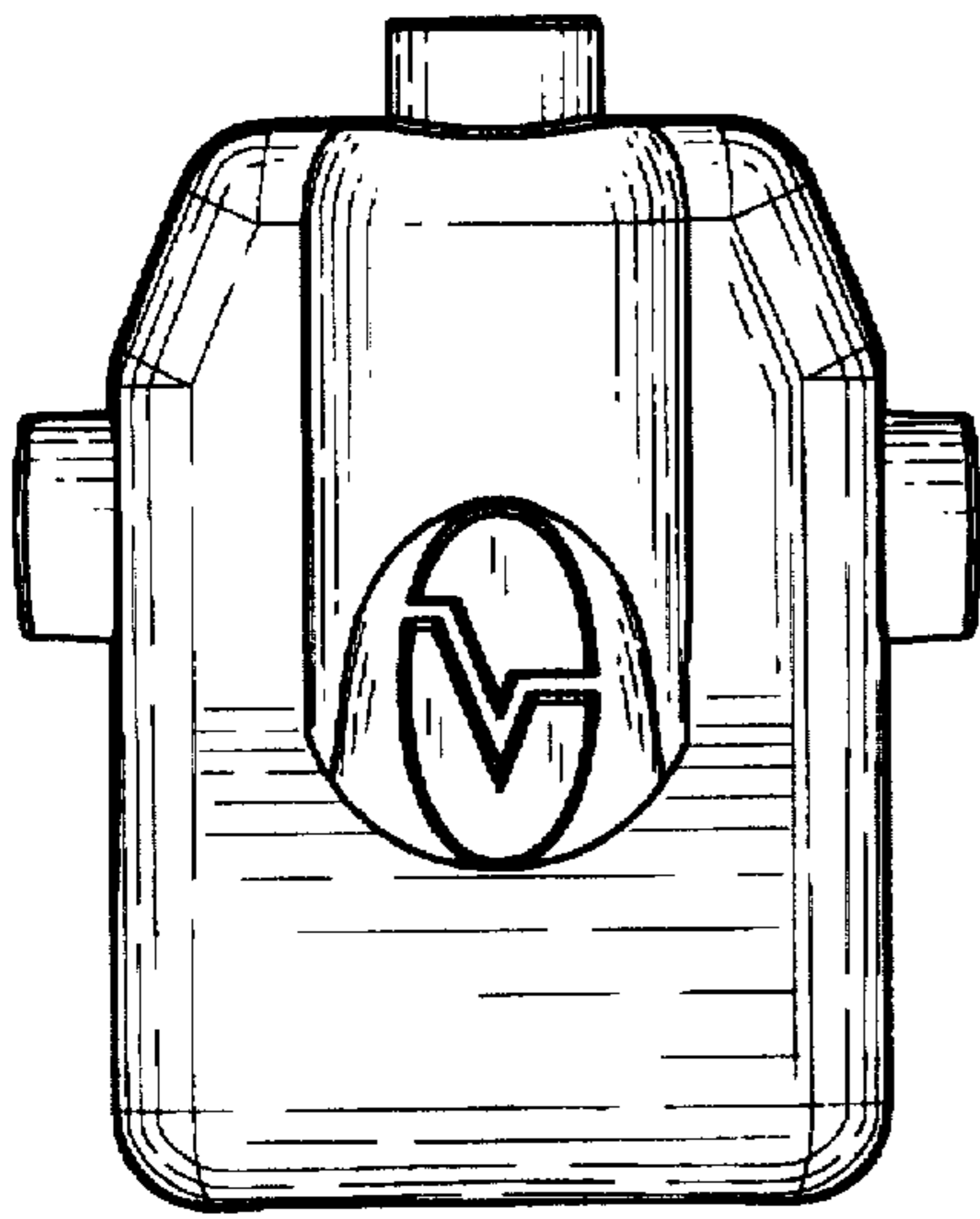

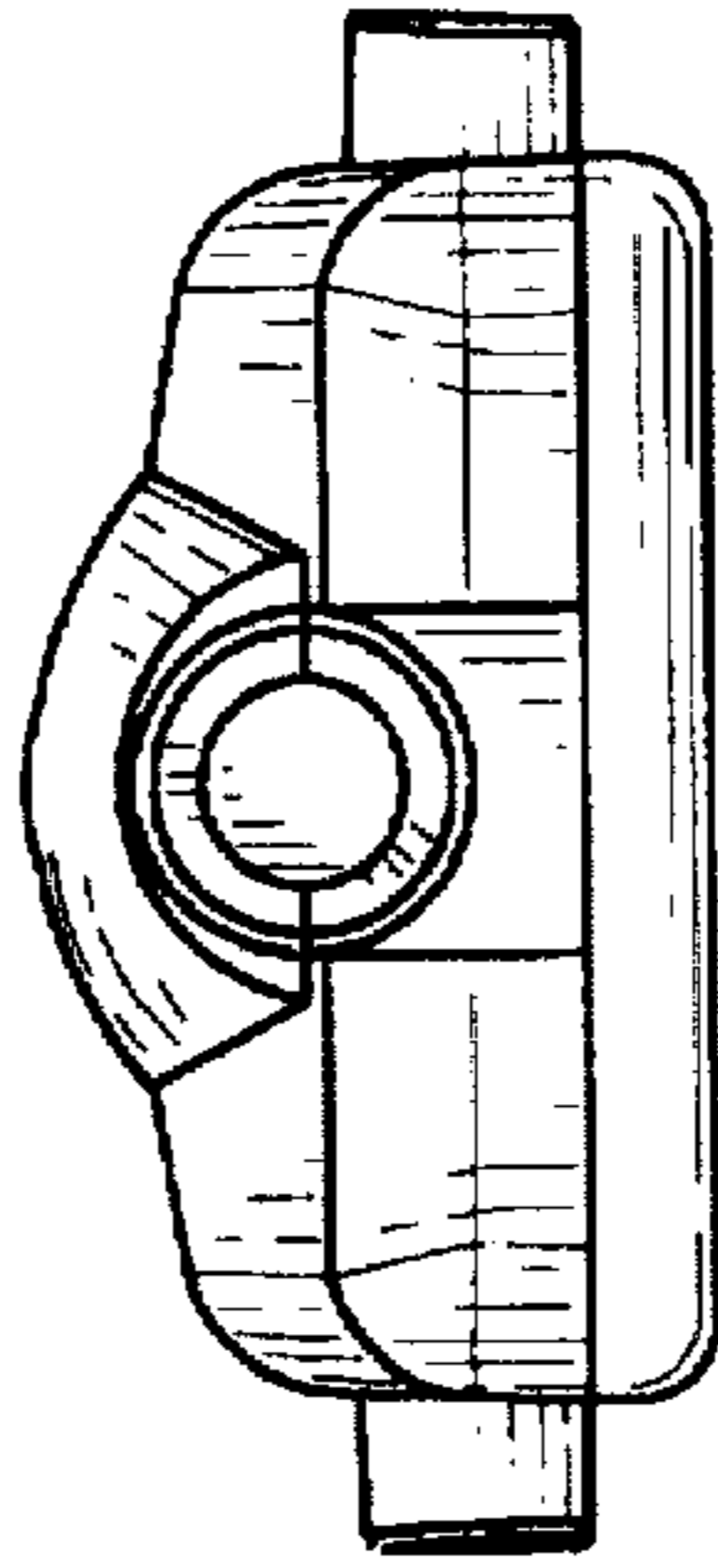

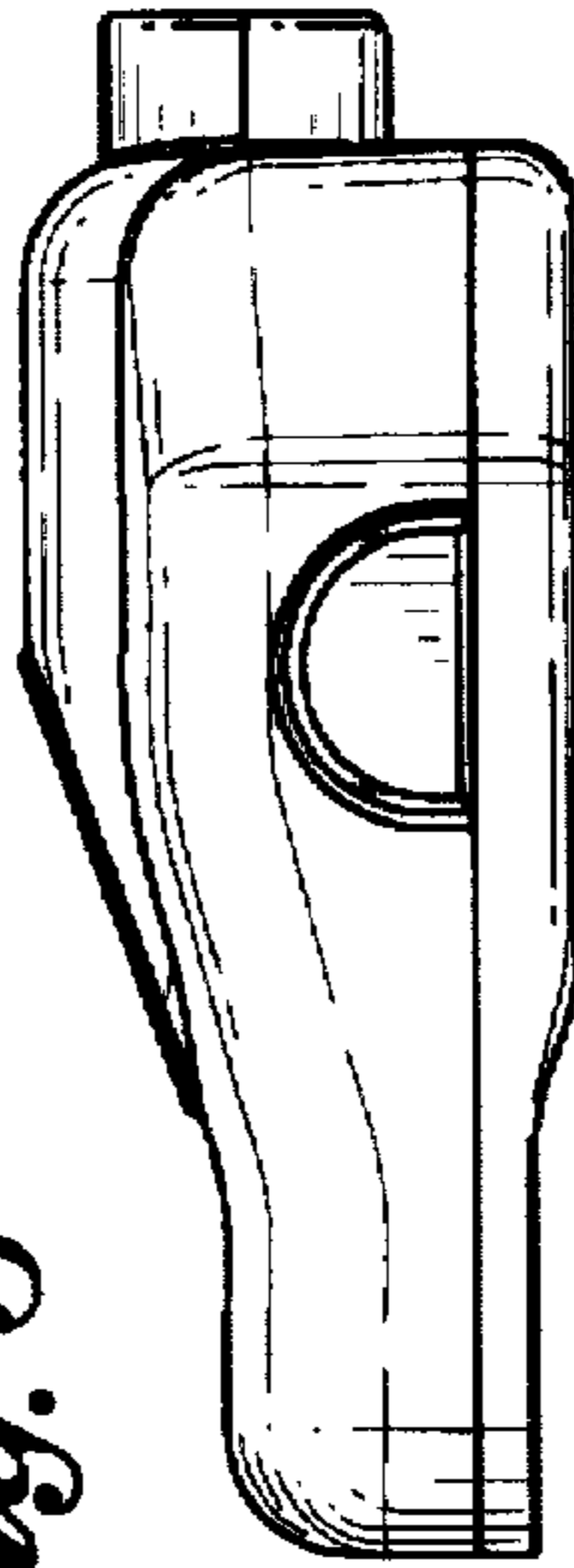

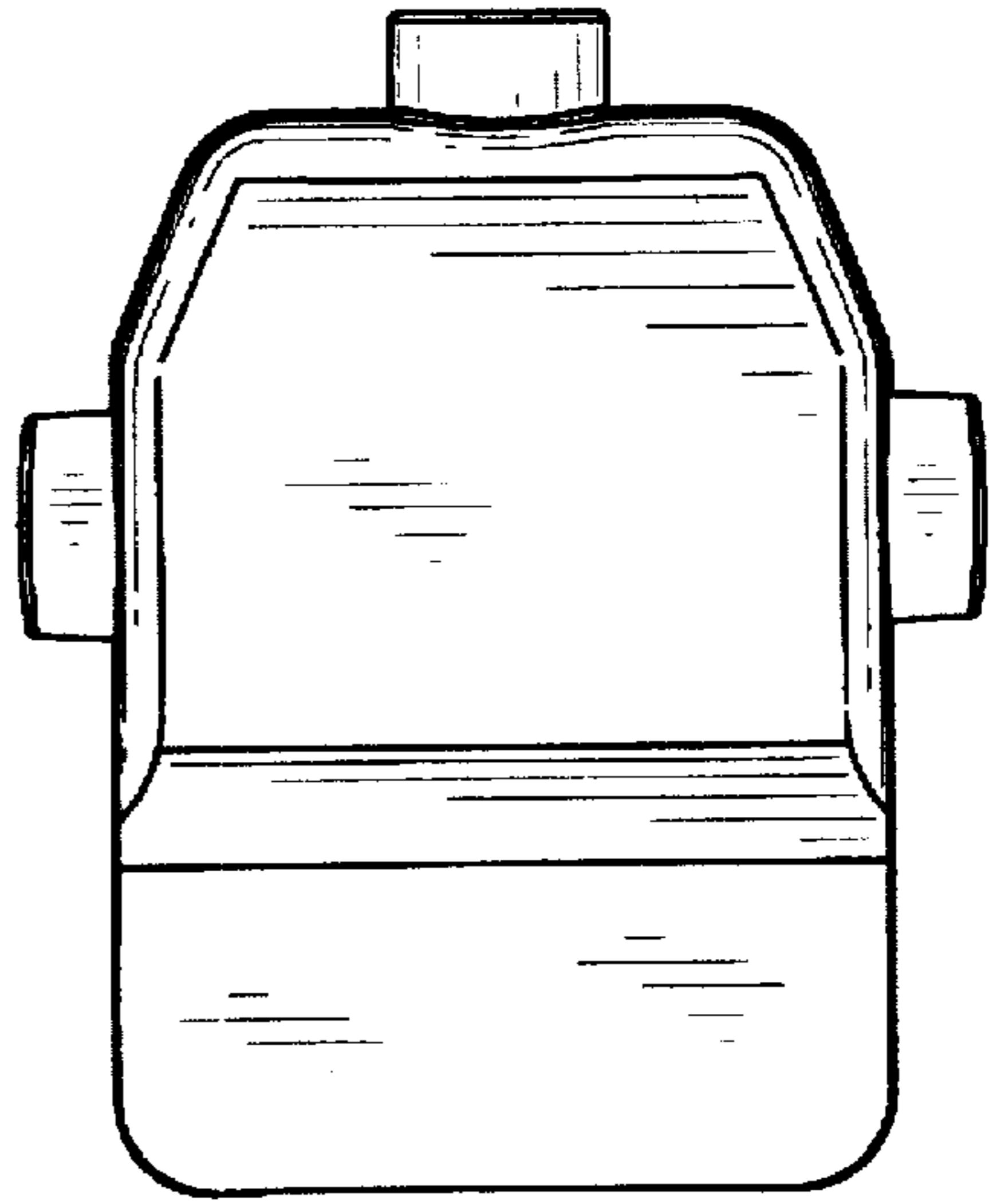

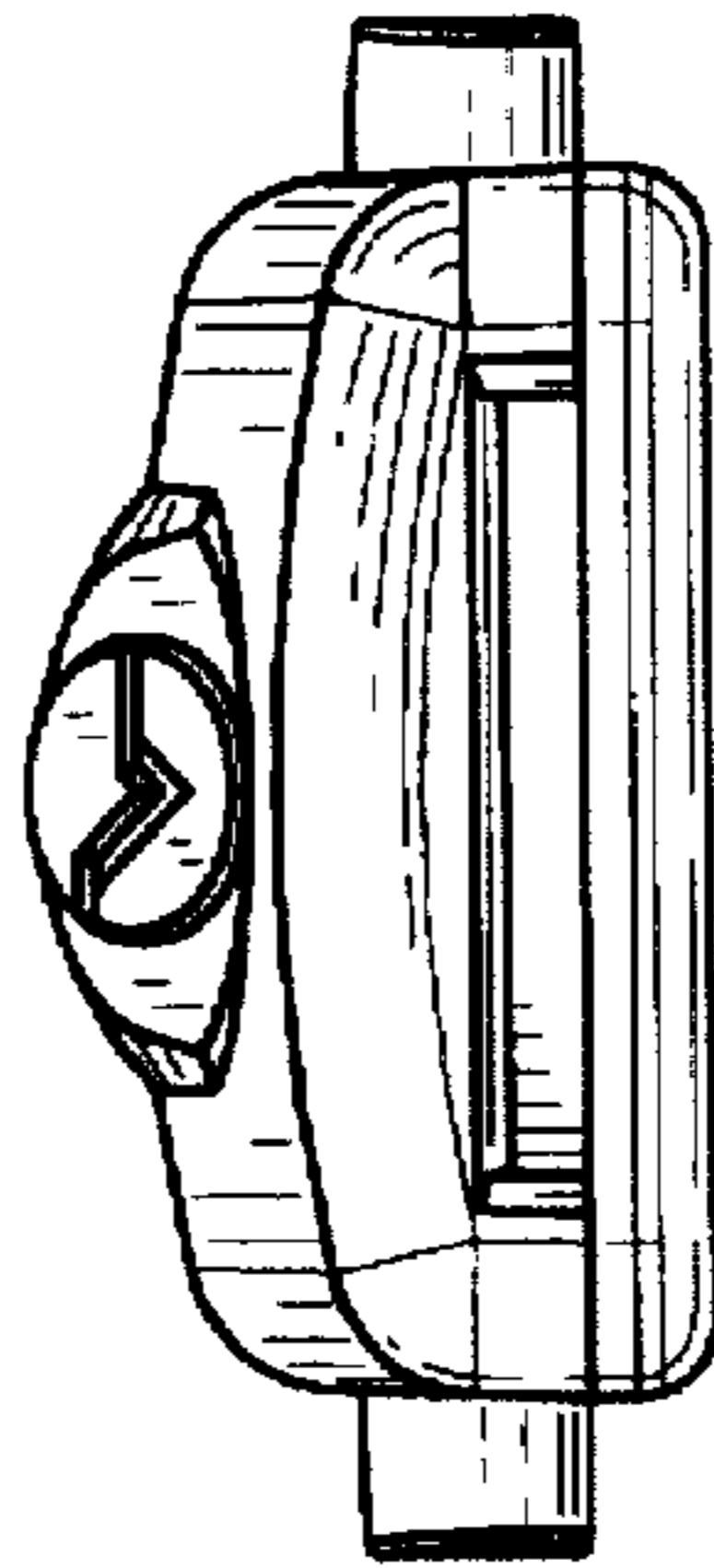
