[57] **CLAIM**

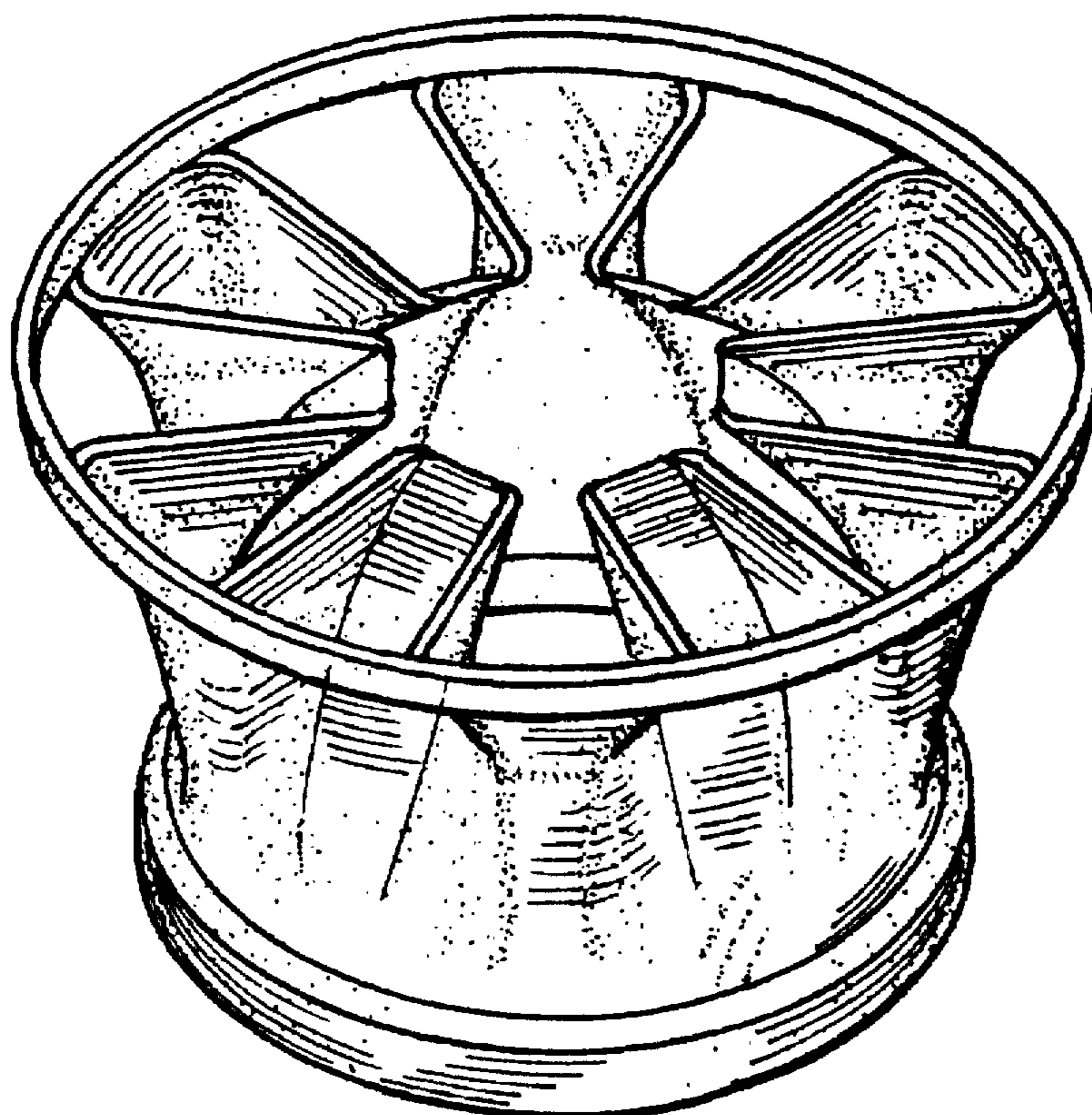
The ornamental design for a hair dryer attachment, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a hair dryer attachment, showing my design;  
FIG. 2 is a front view of FIG. 1;  
FIG. 3 is a right-side view of FIG. 6;  
FIG. 4 is a left-side view of FIG. 6;  
FIG. 5 is a rear view of FIG. 2 shown in an inverted position;  
FIG. 6 is a top plan view of FIG. 2; and,  
FIG. 7 is a bottom plan view of FIG. 2.

The stippling represents a translucent surface; and the horizontal lines representing a striated surface texture are understood to extend continuously throughout the surface of the design.

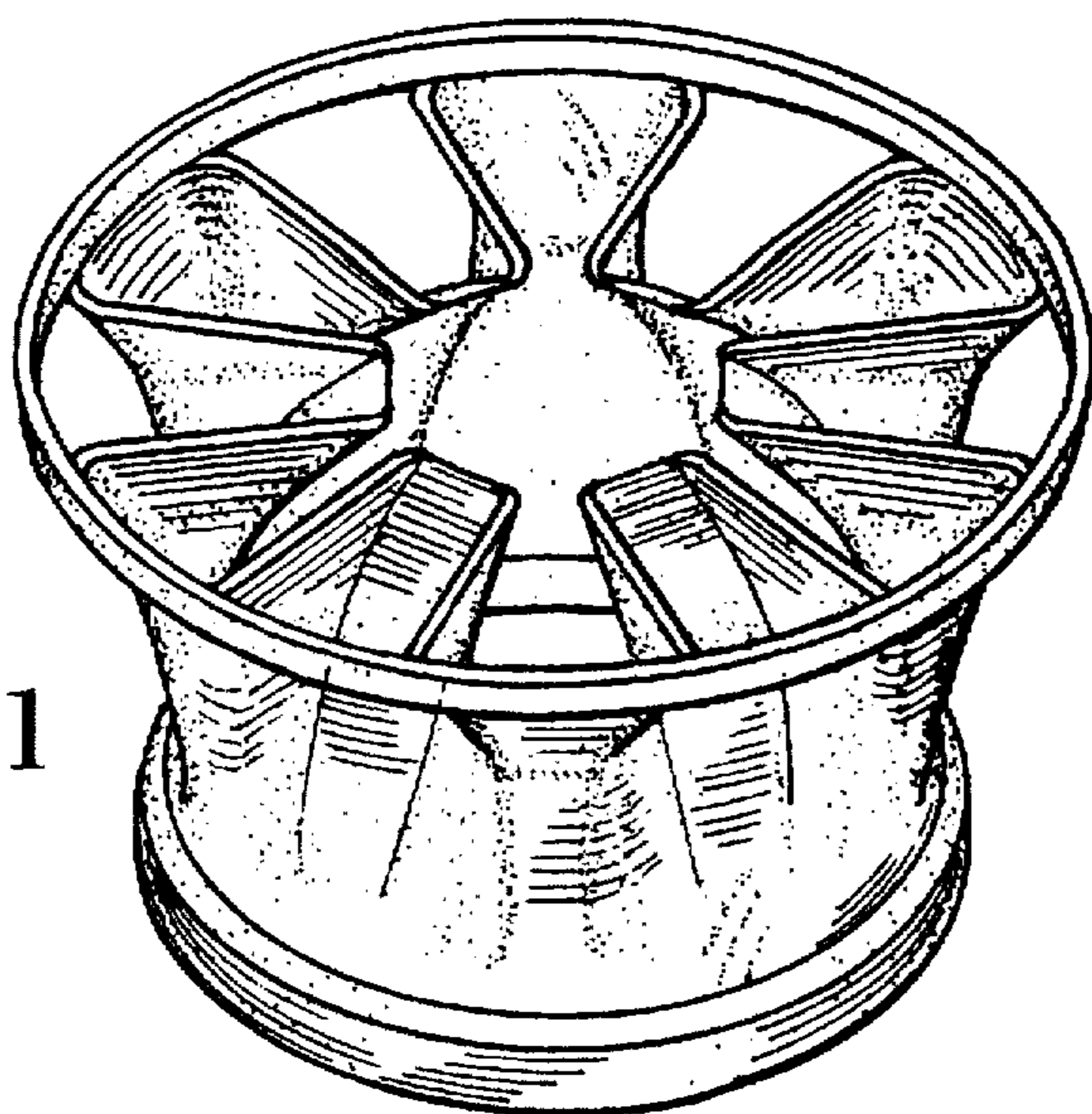

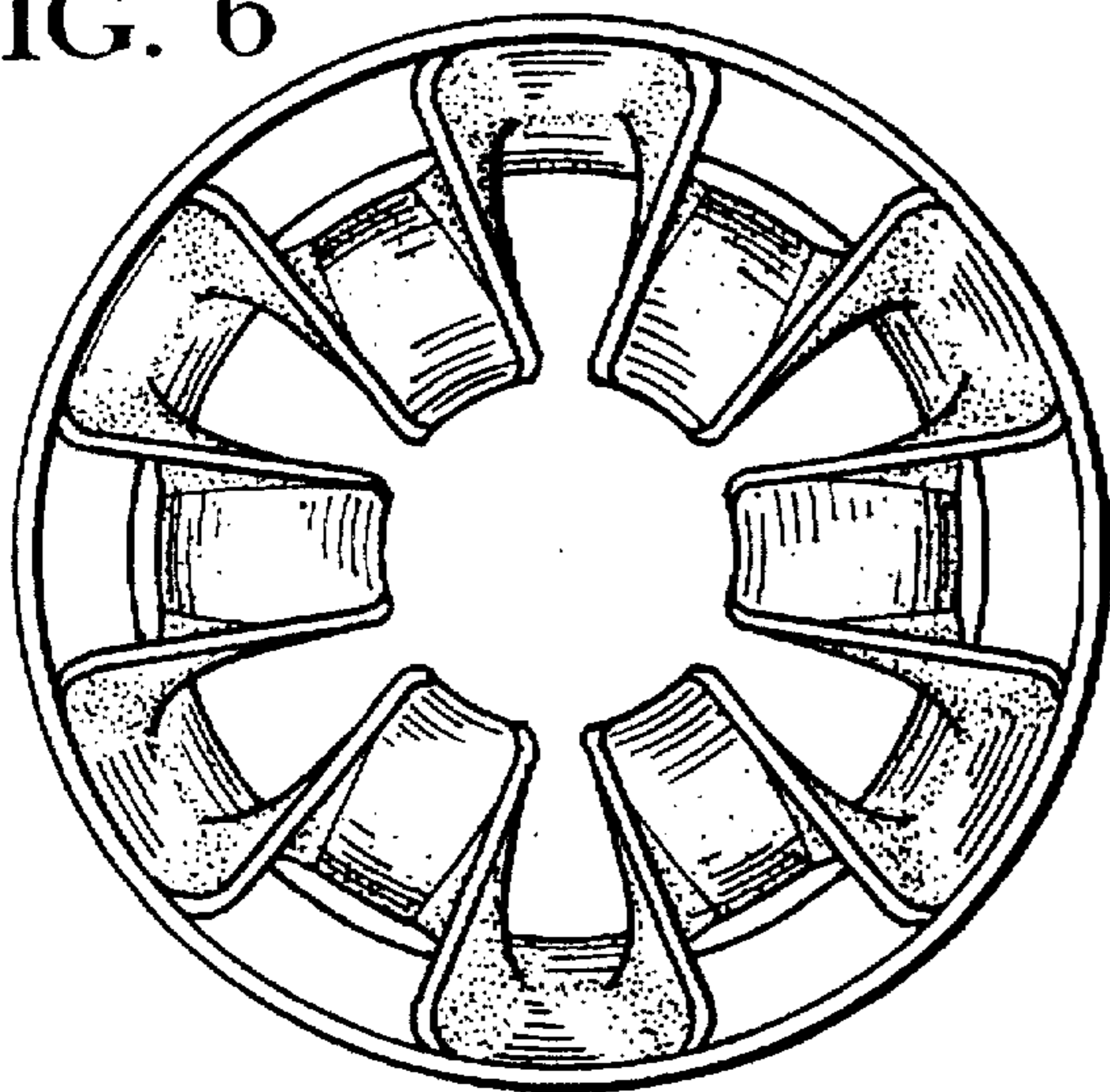

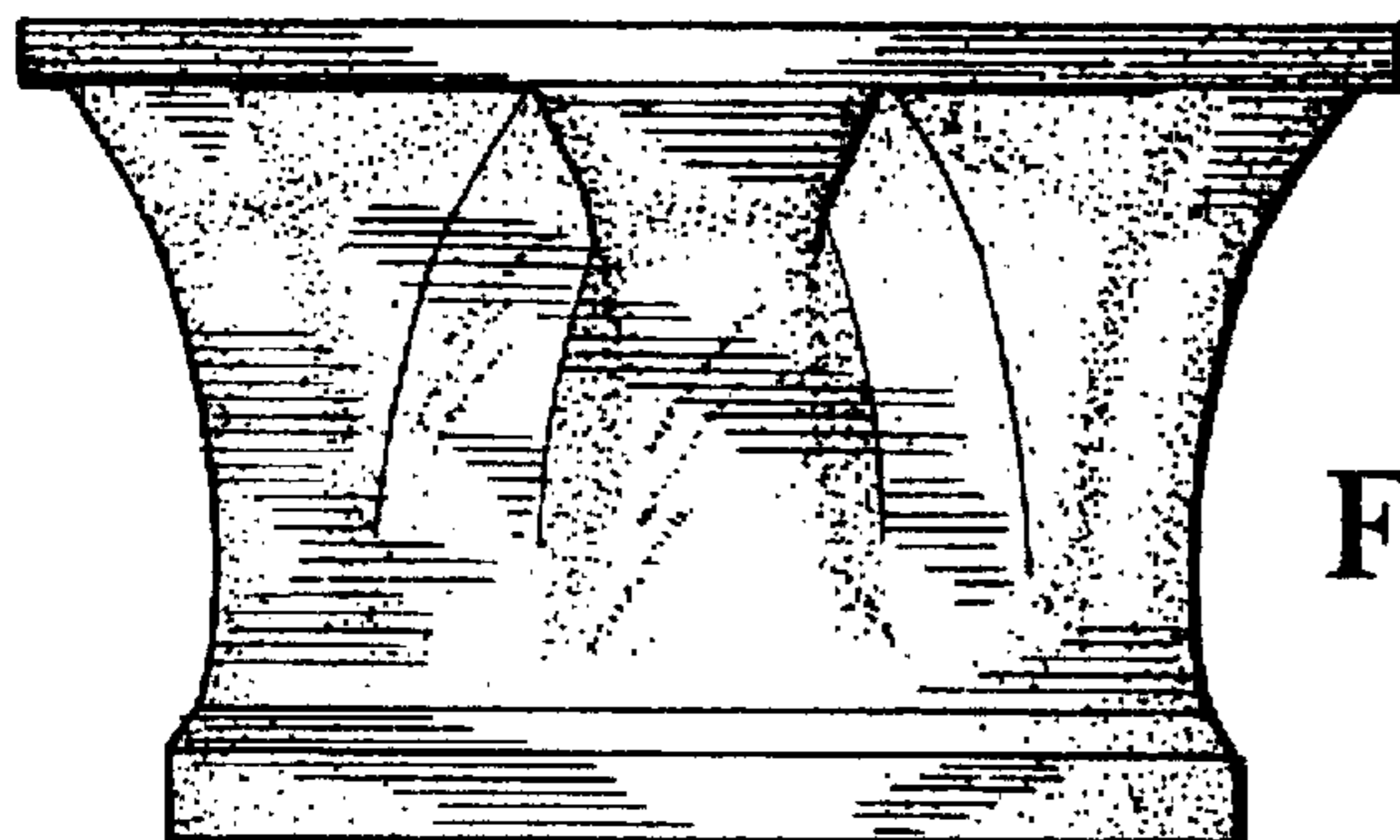

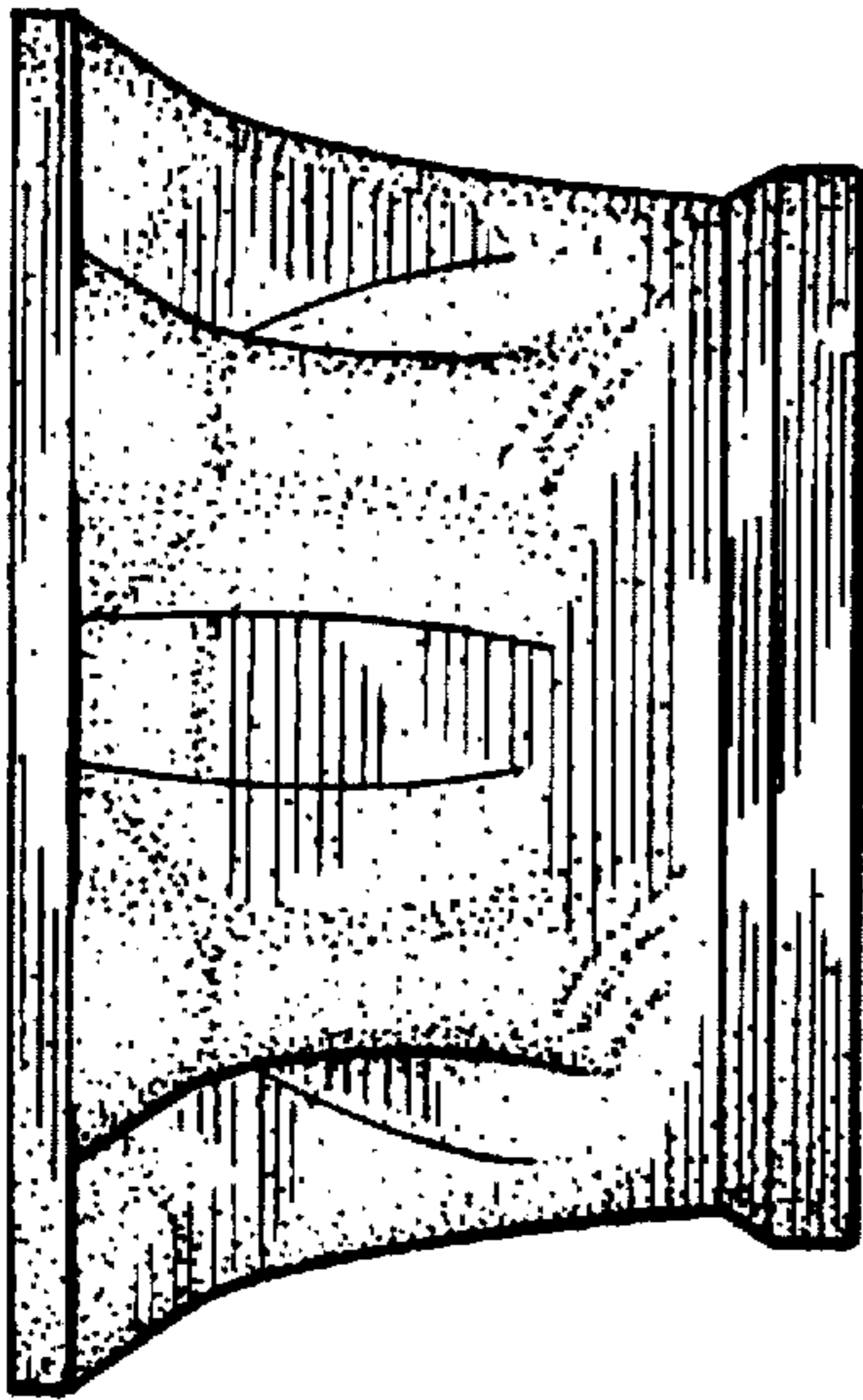

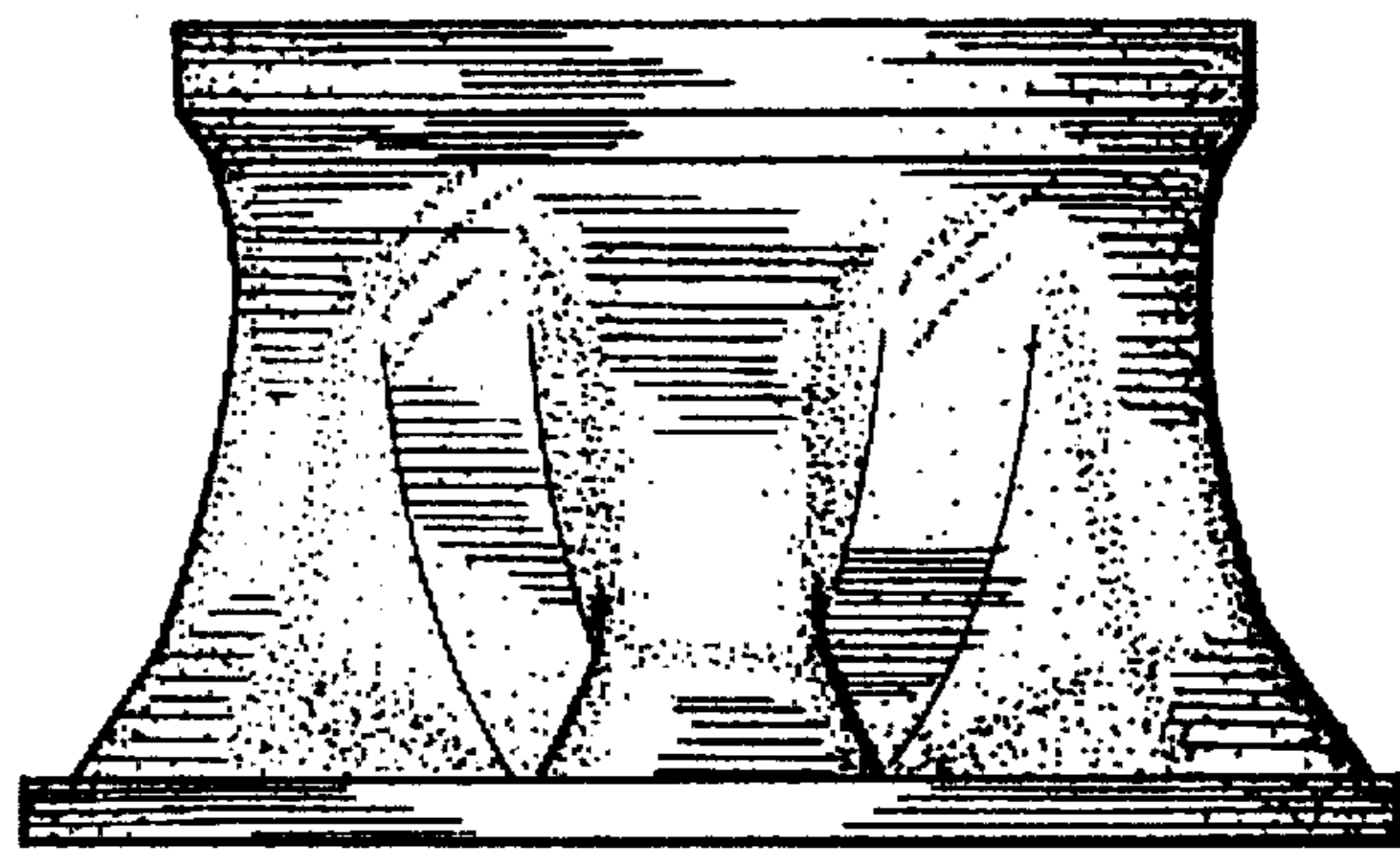
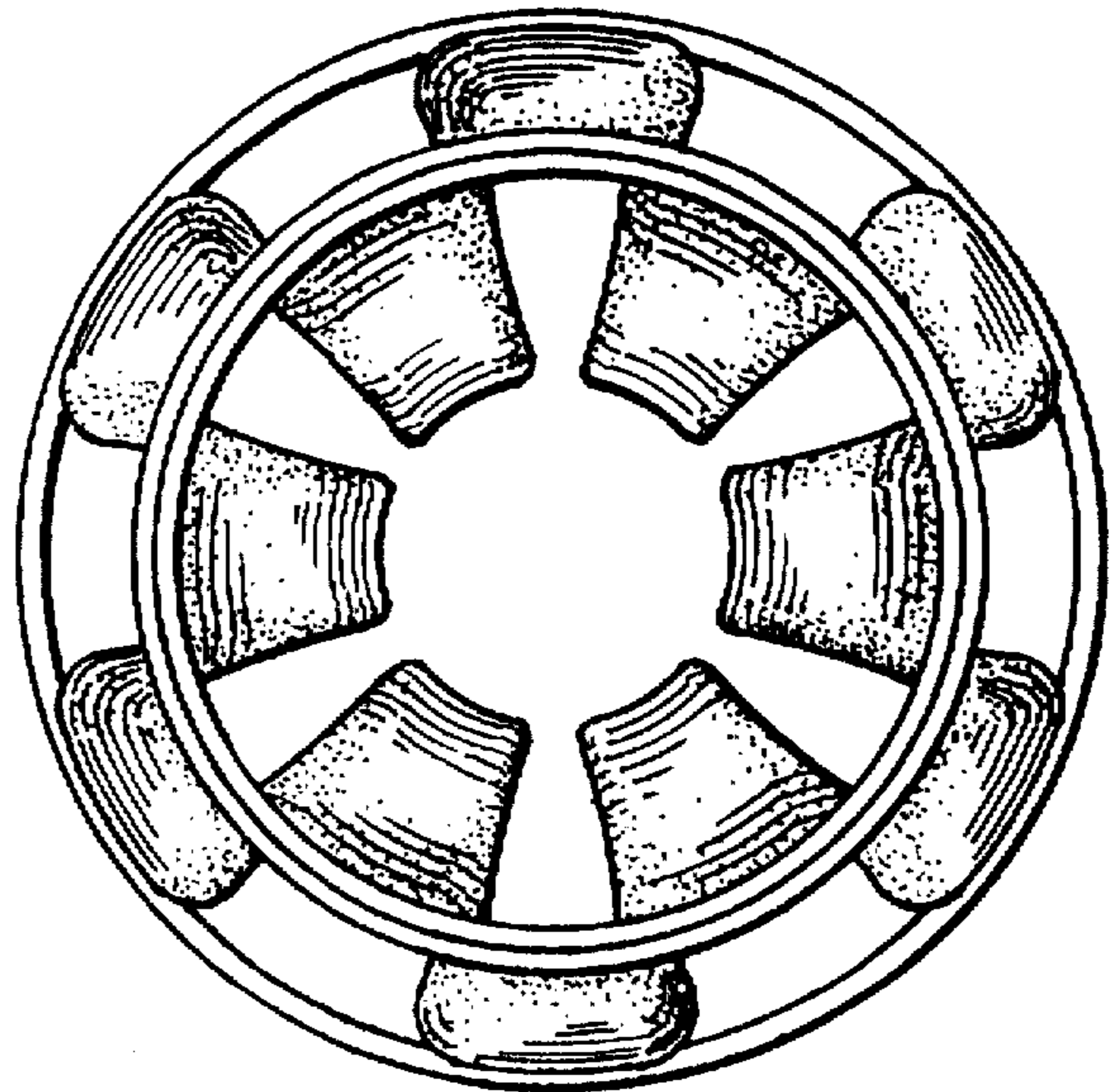
