The ornamental design for a dry shaver, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a dry shaver showing my design;

FIG. 2 is a front view of the appliance of FIG. 1;

FIG. 3 is a right side view of the appliance of FIG. 1;

FIG. 4 is a left side view of the appliance of FIG. 1;

FIG. 5 is a rear view of the appliance of FIG. 1;

FIG. 6 is a top plan view of the appliance of FIG. 1; and,

FIG. 7 is a bottom plan view of the appliance of FIG. 1.

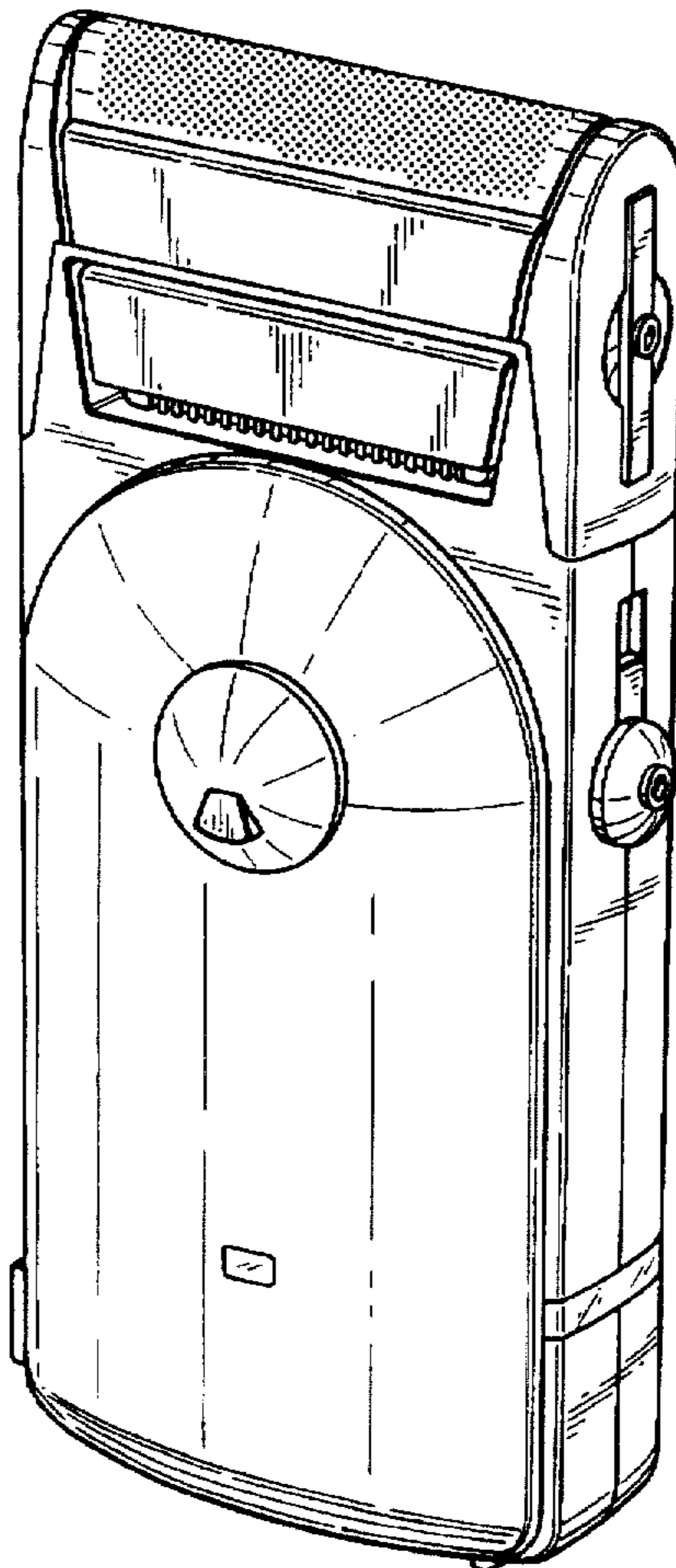

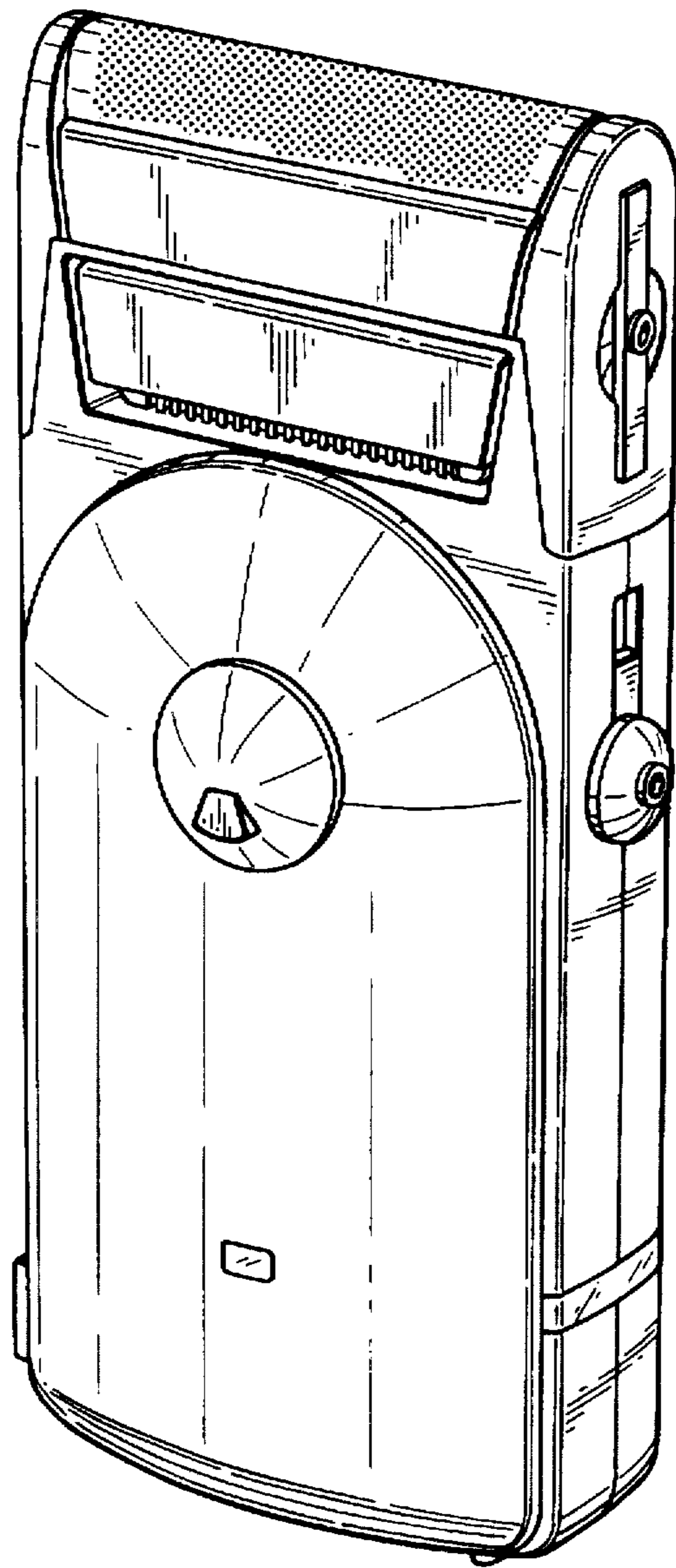

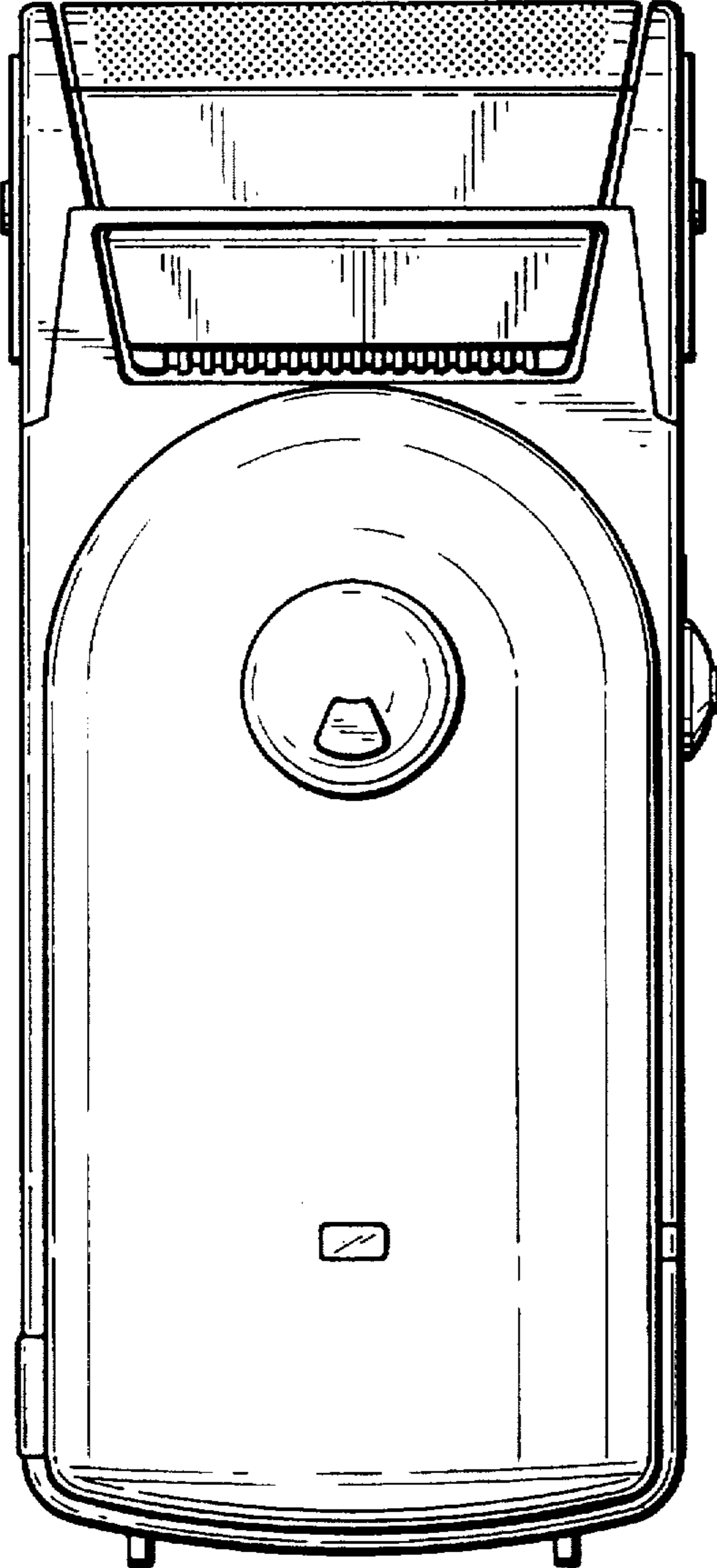

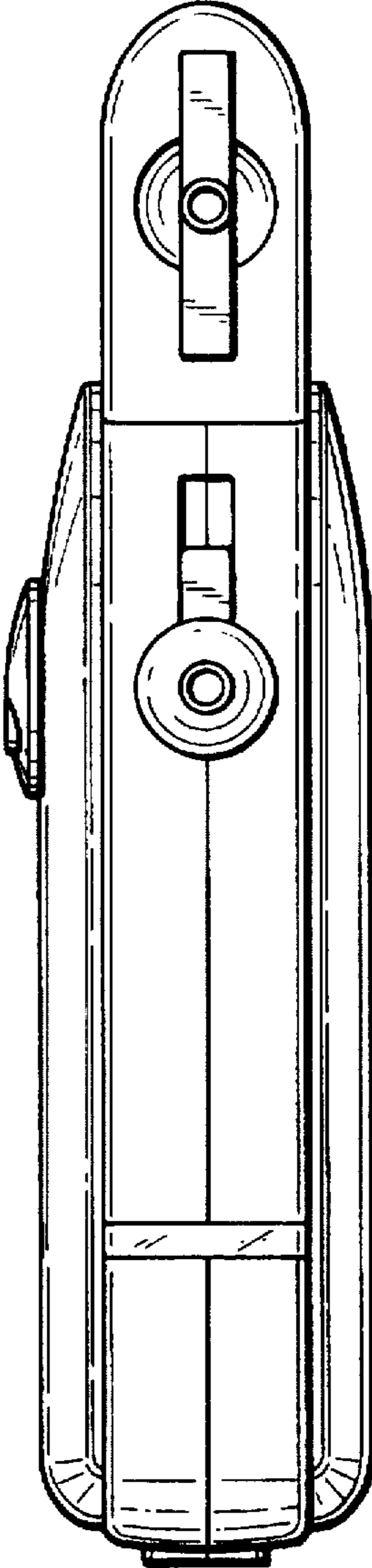

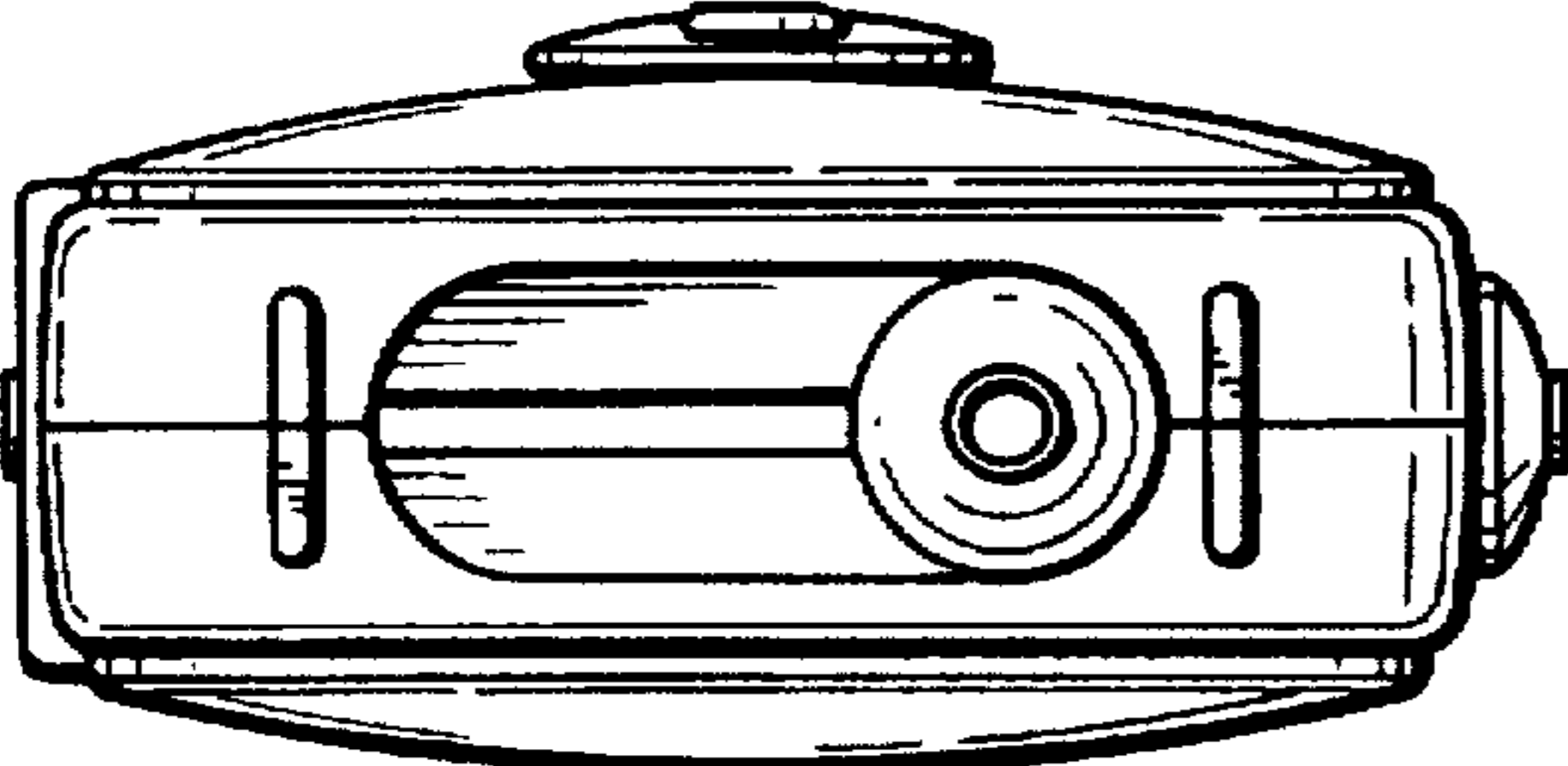

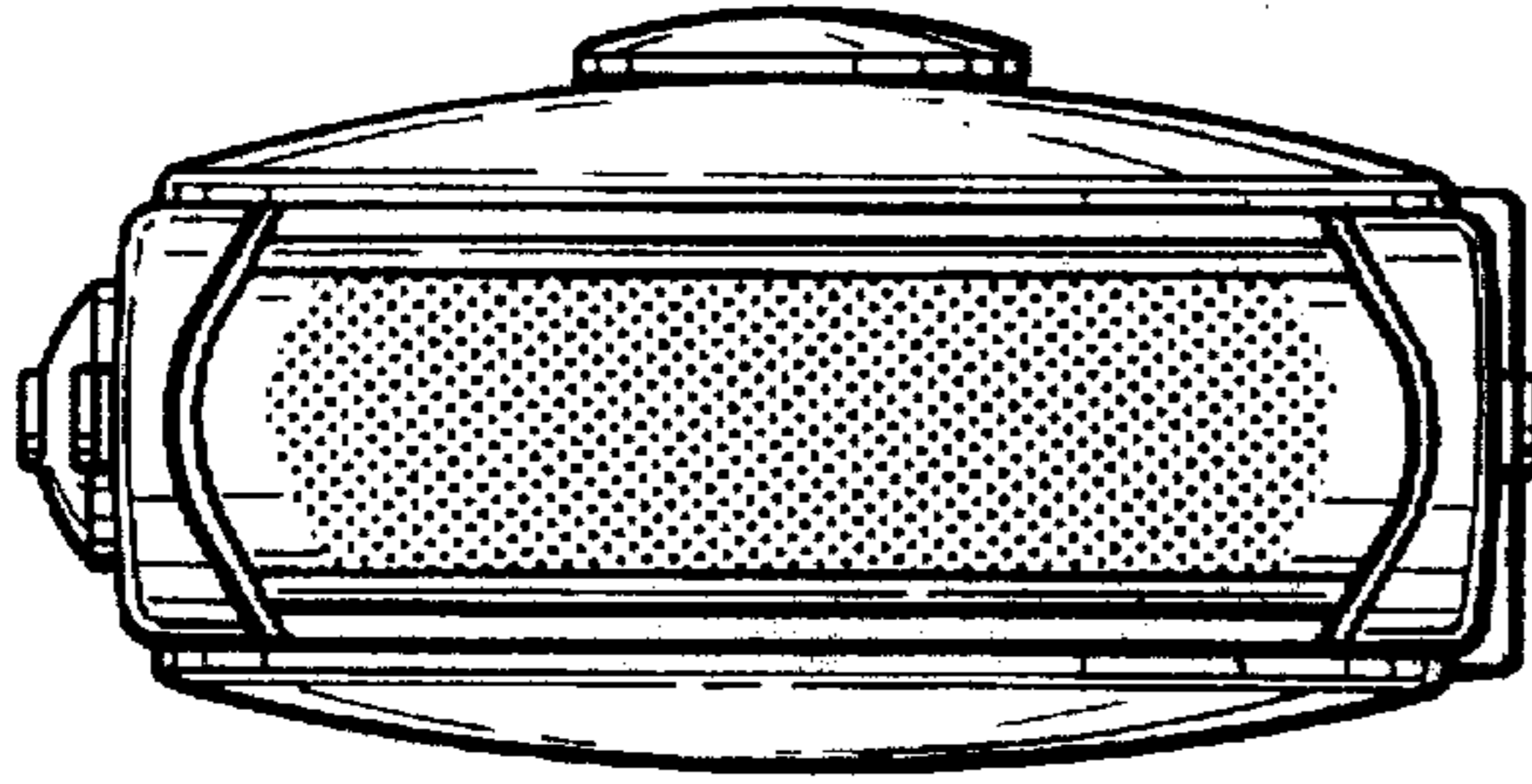

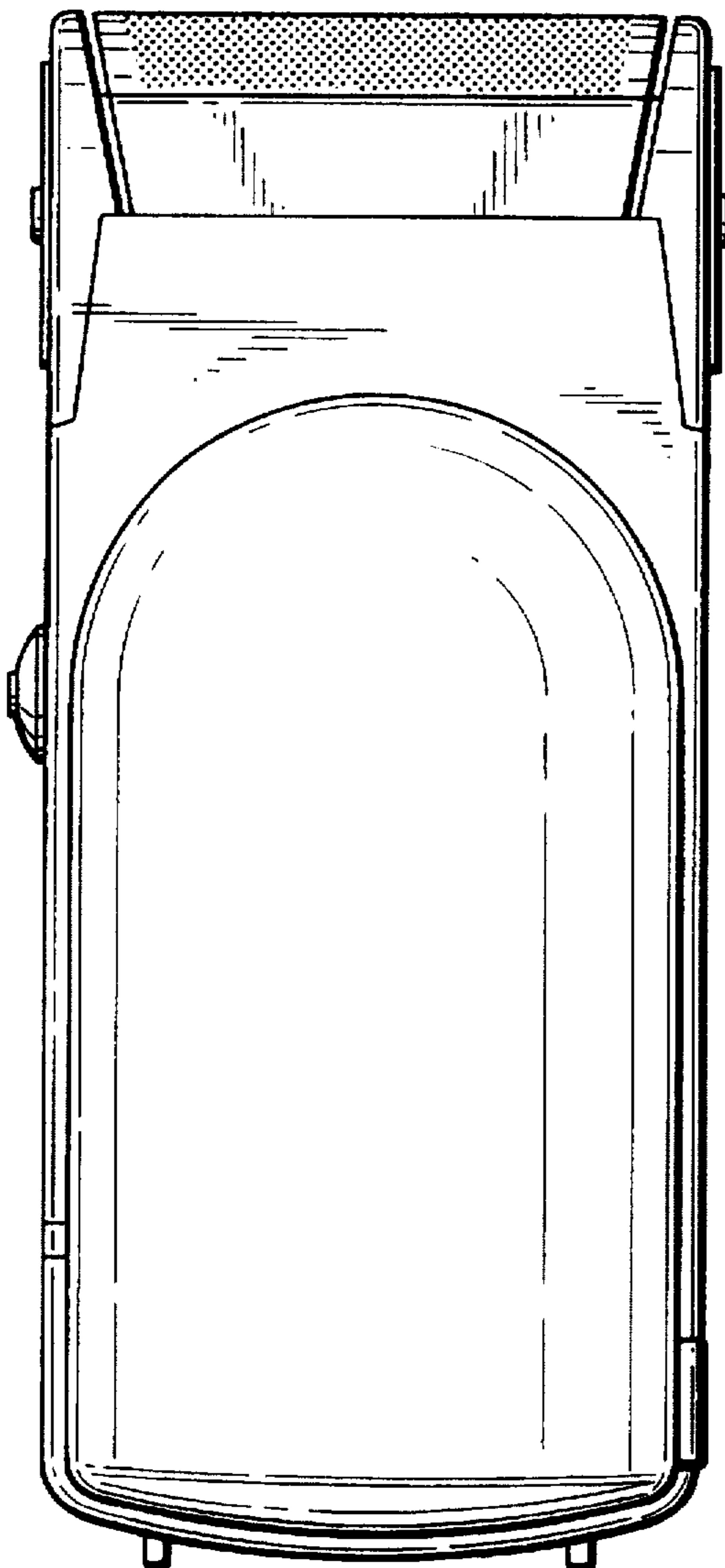
